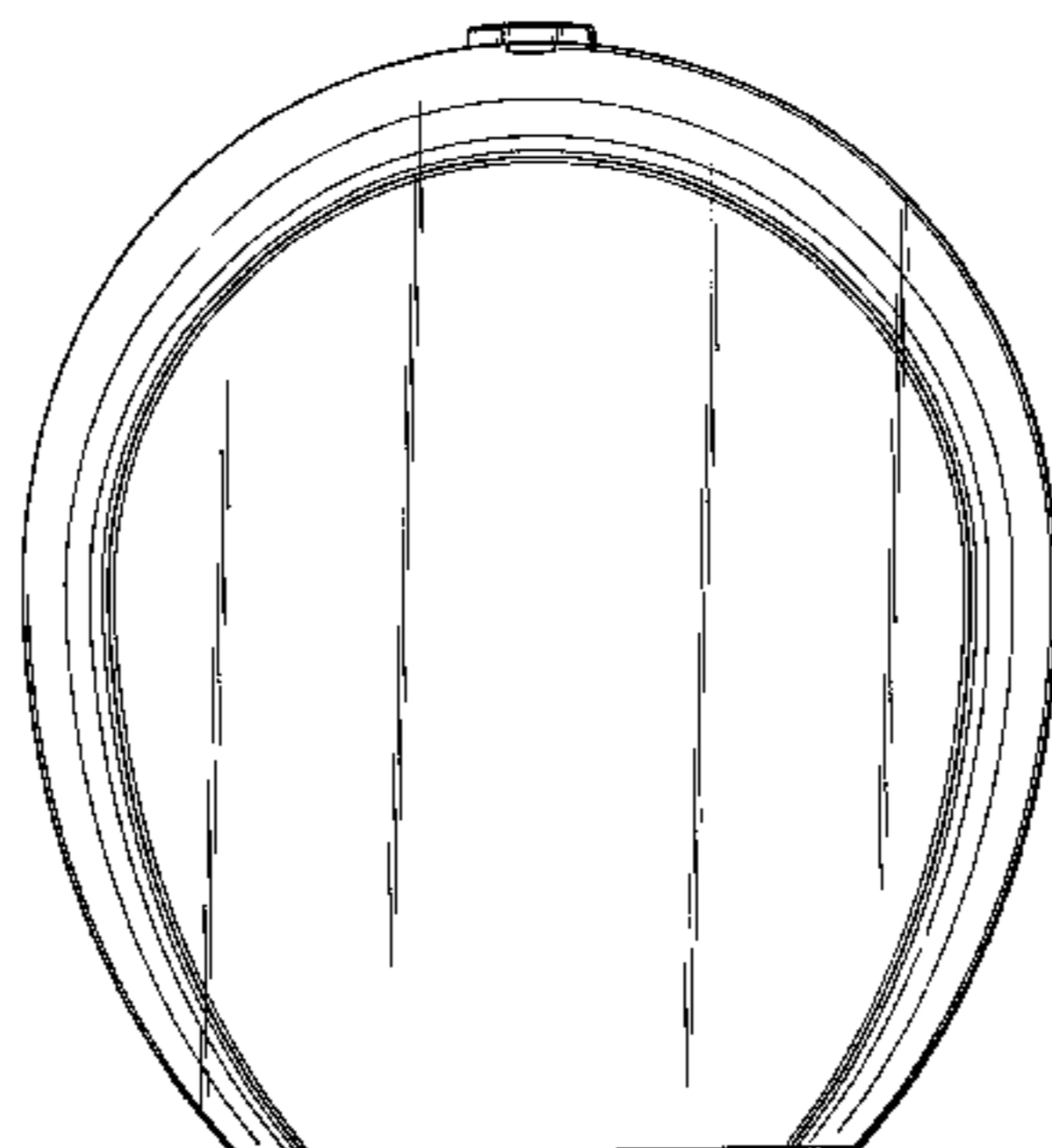
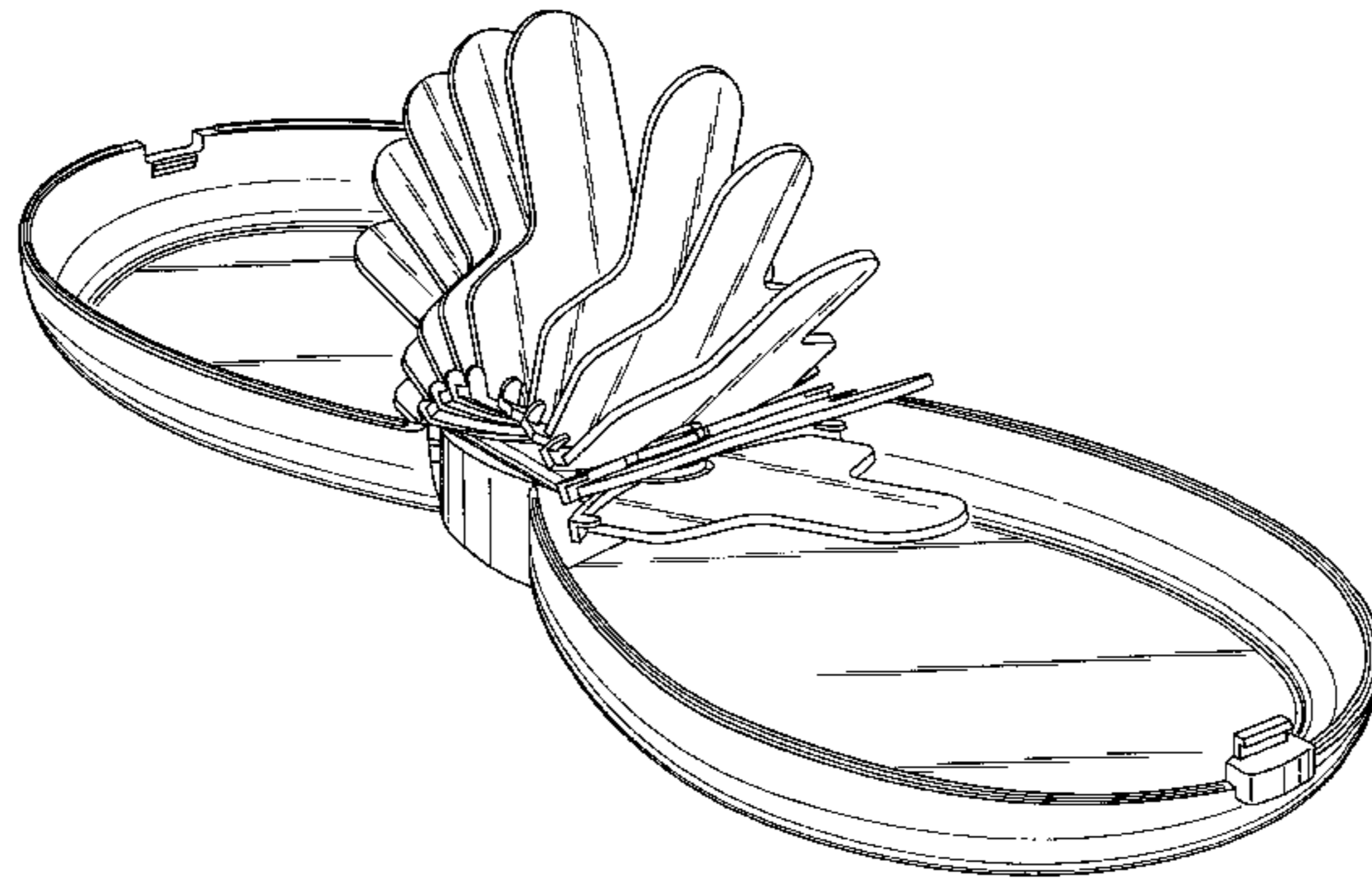
(57) **CLAIM**

FIG. 1 is a perspective view of a CD box showing my new design;

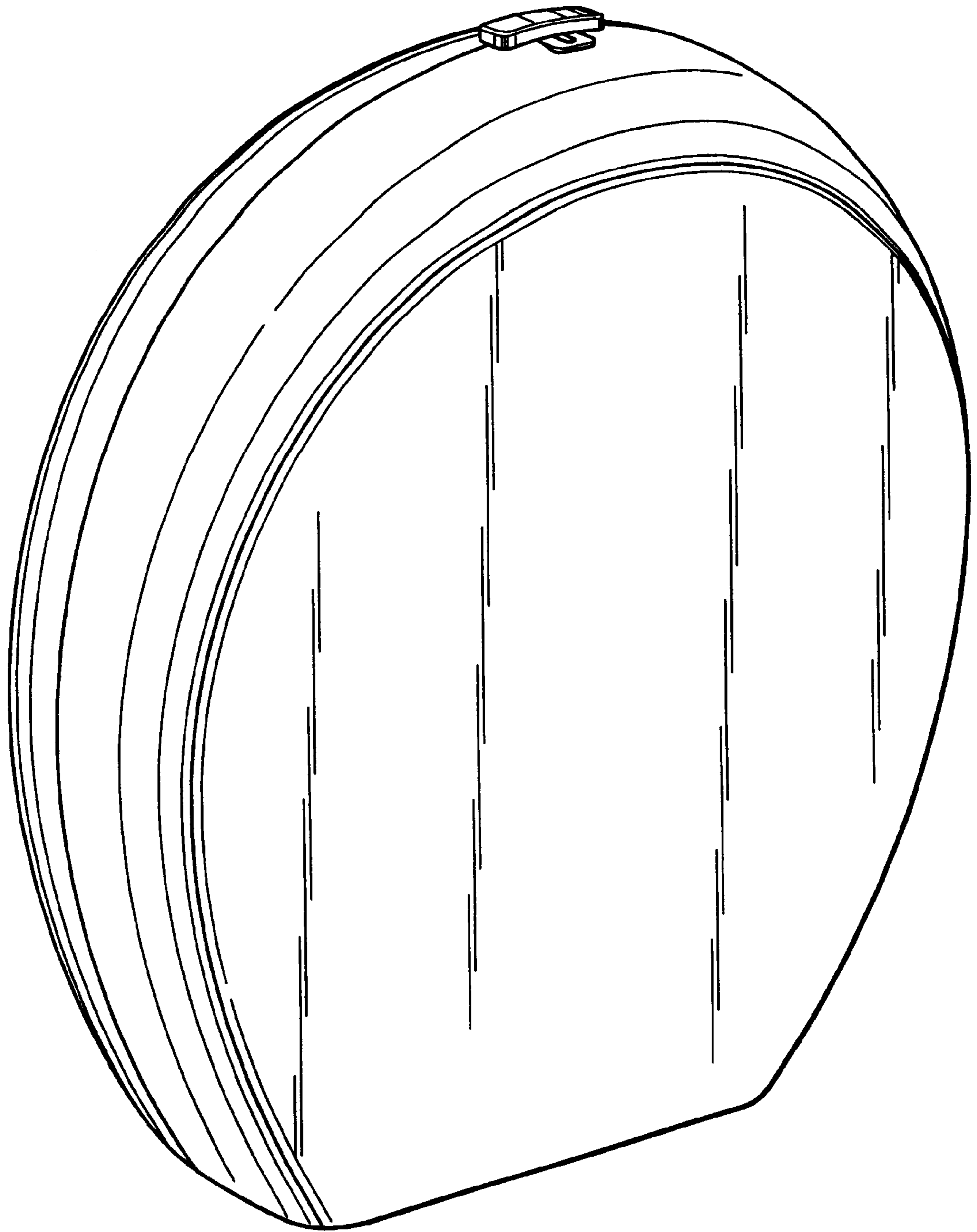

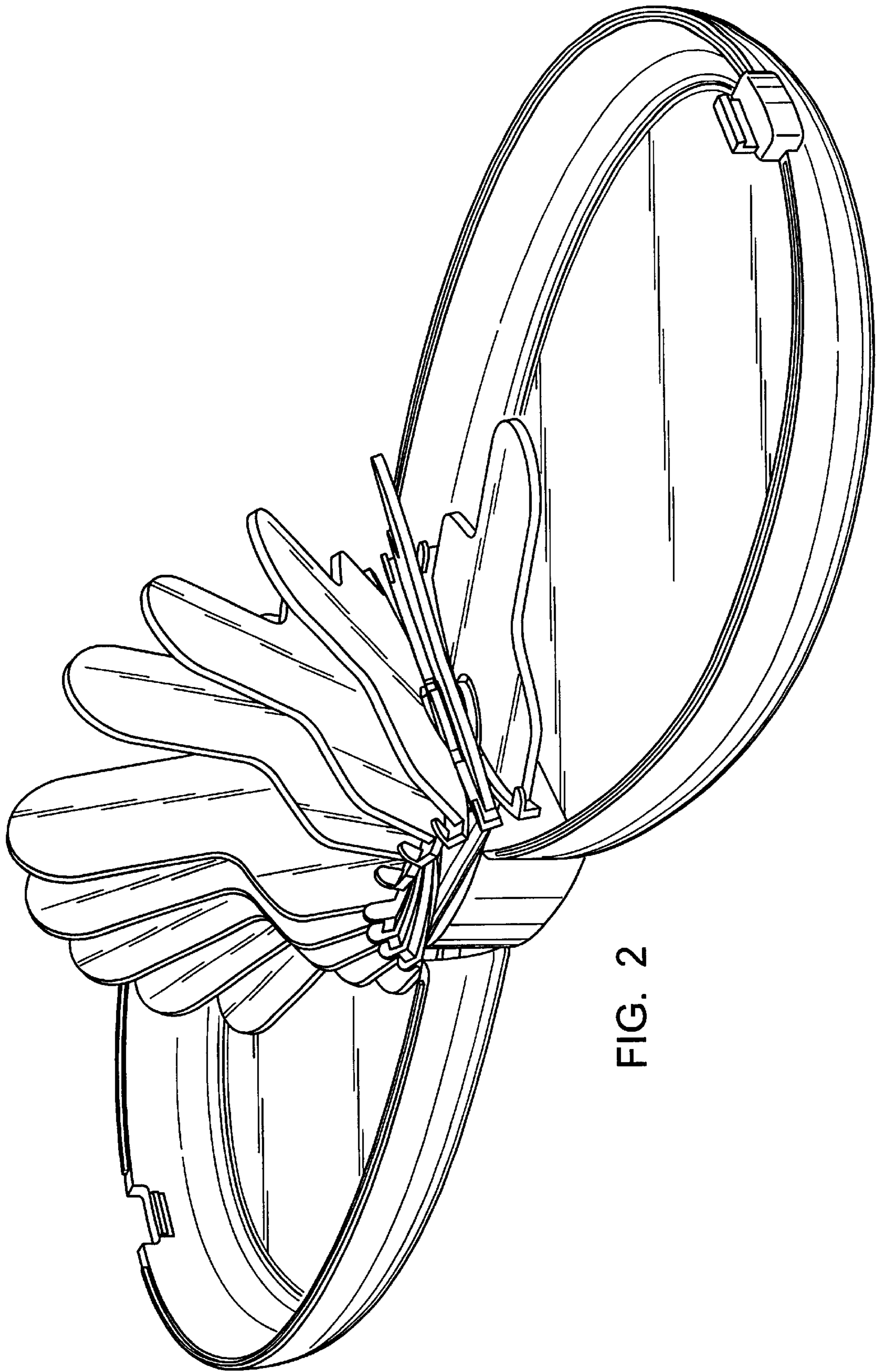

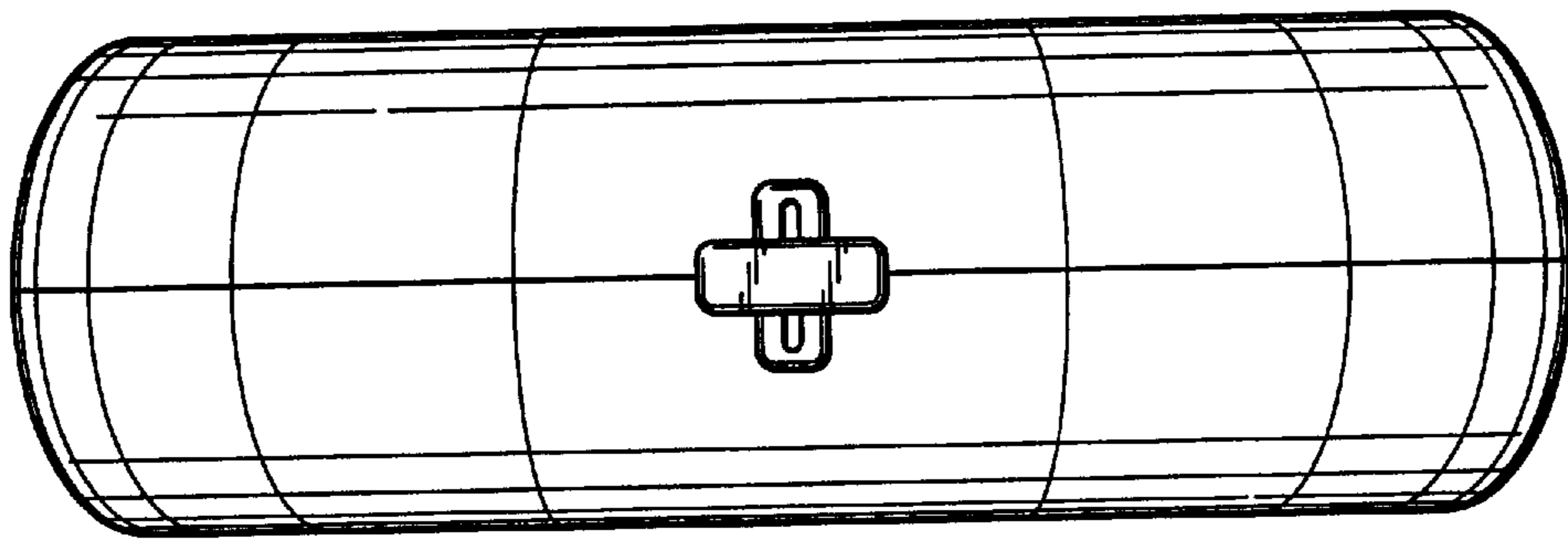

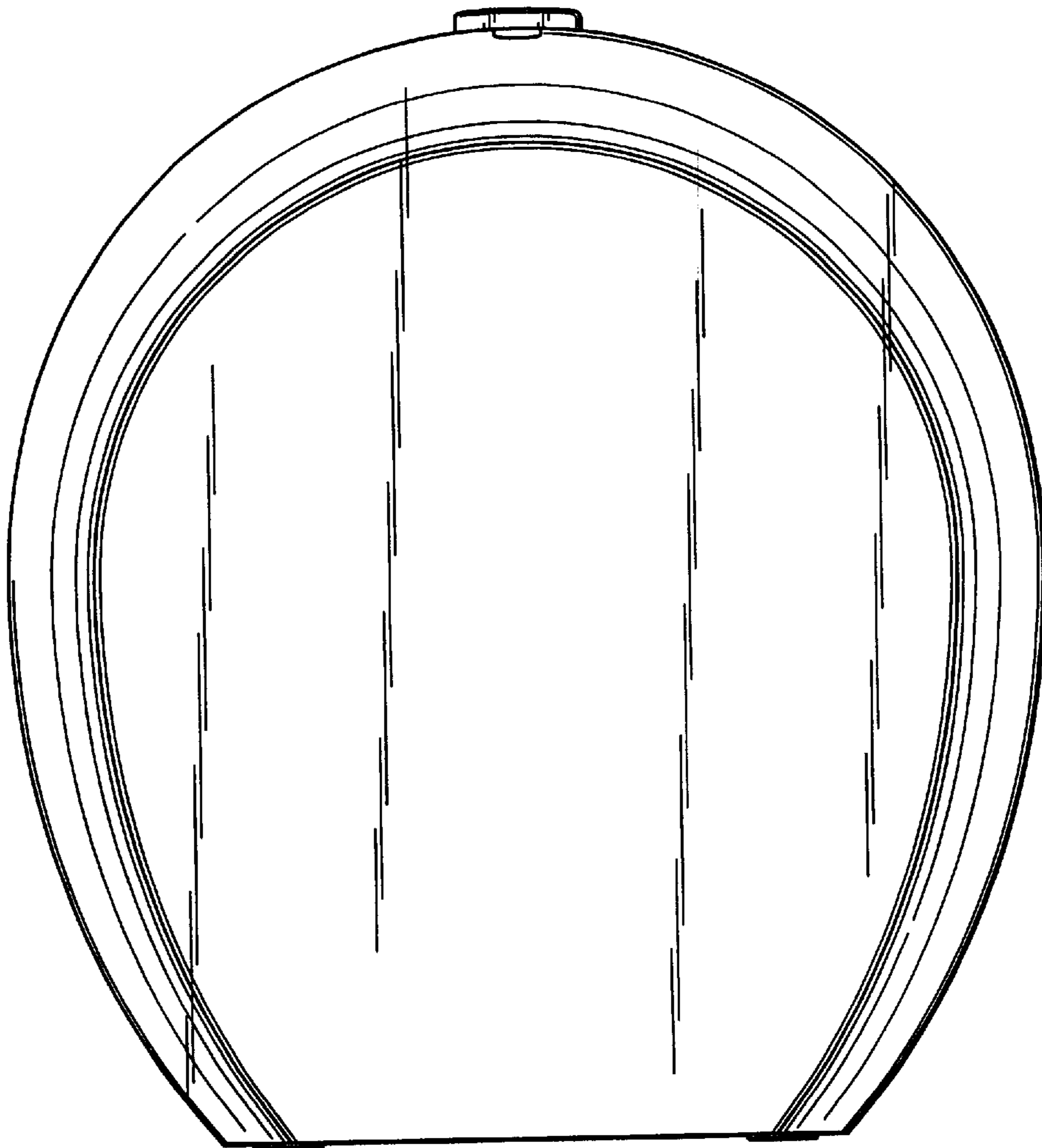

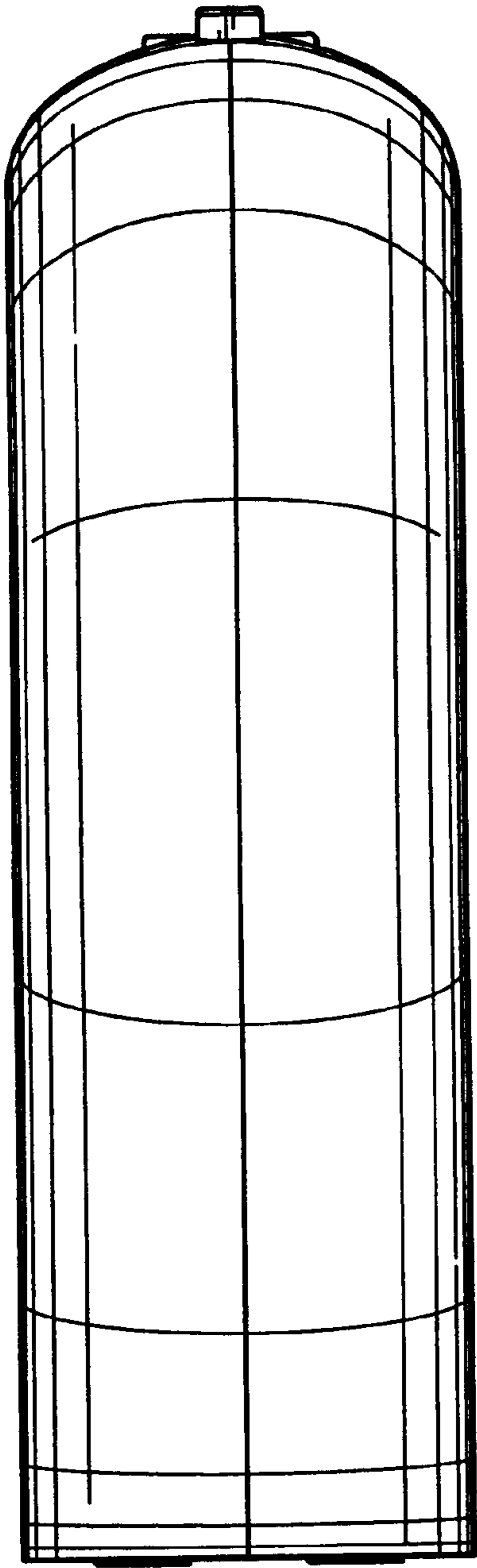

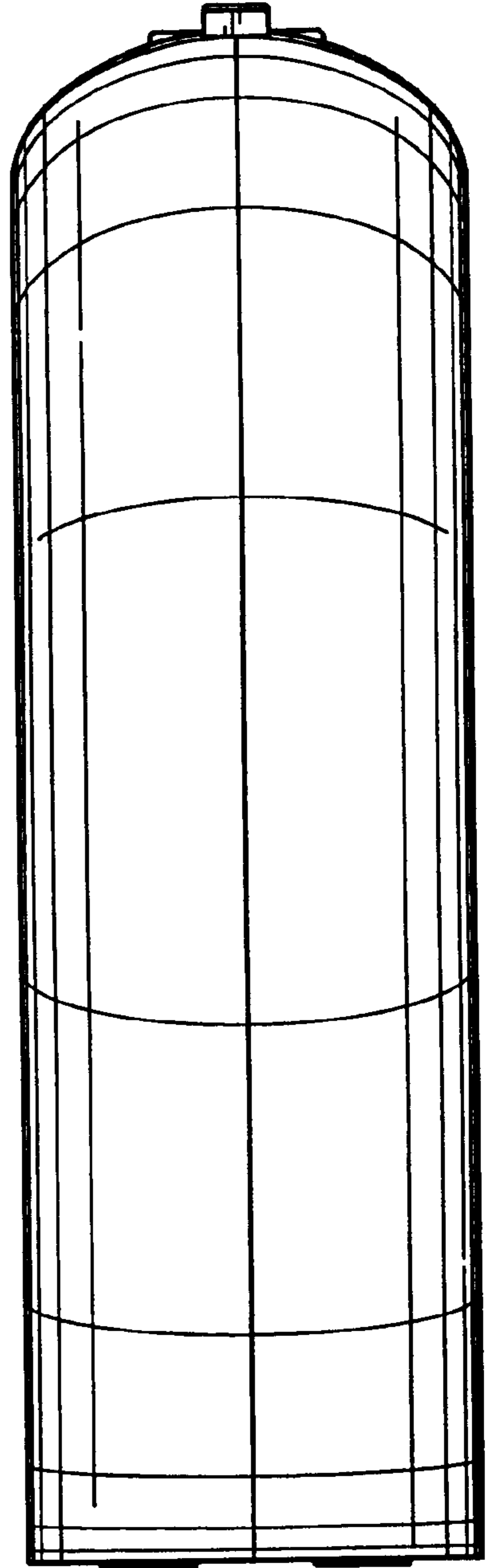

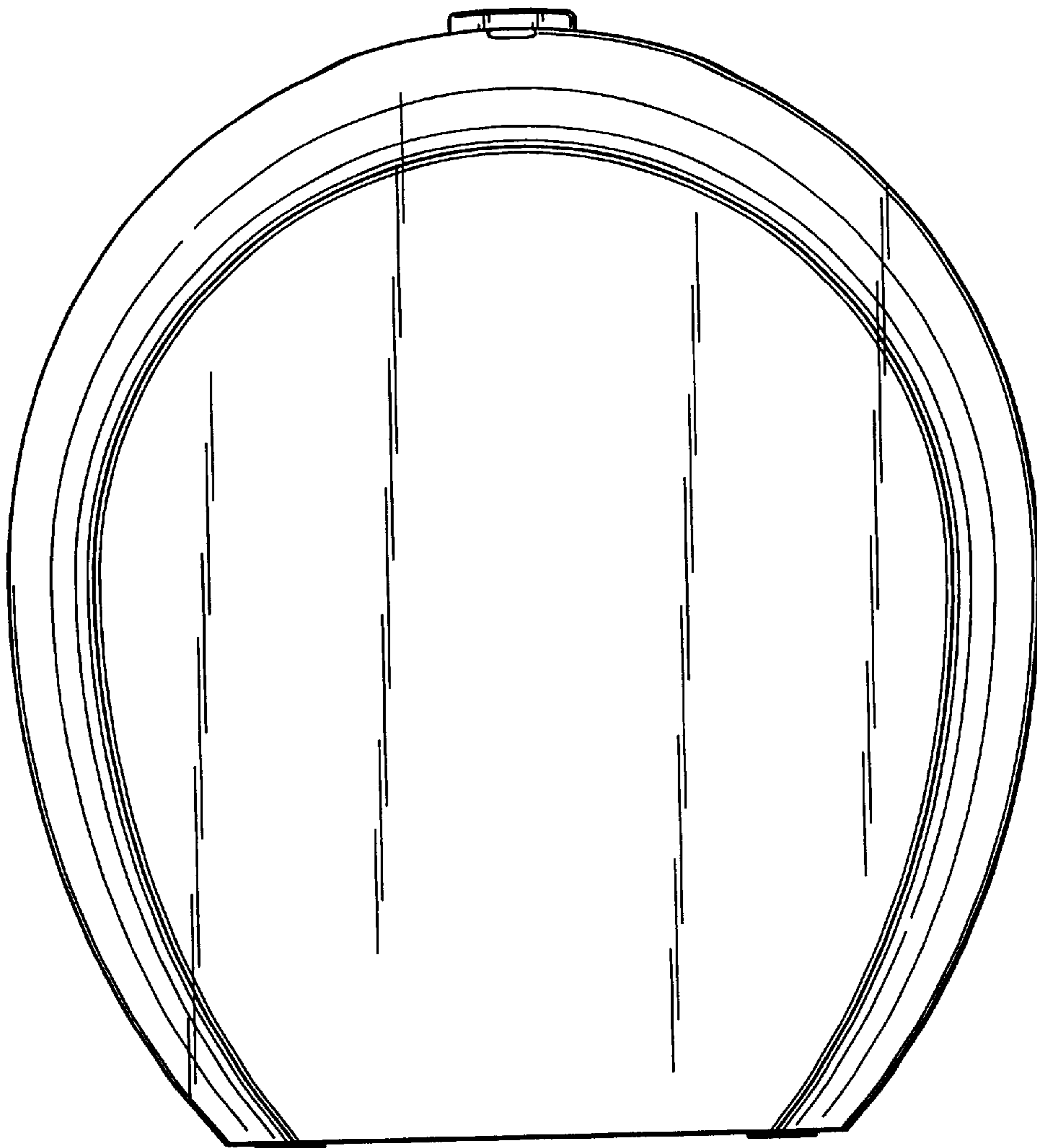

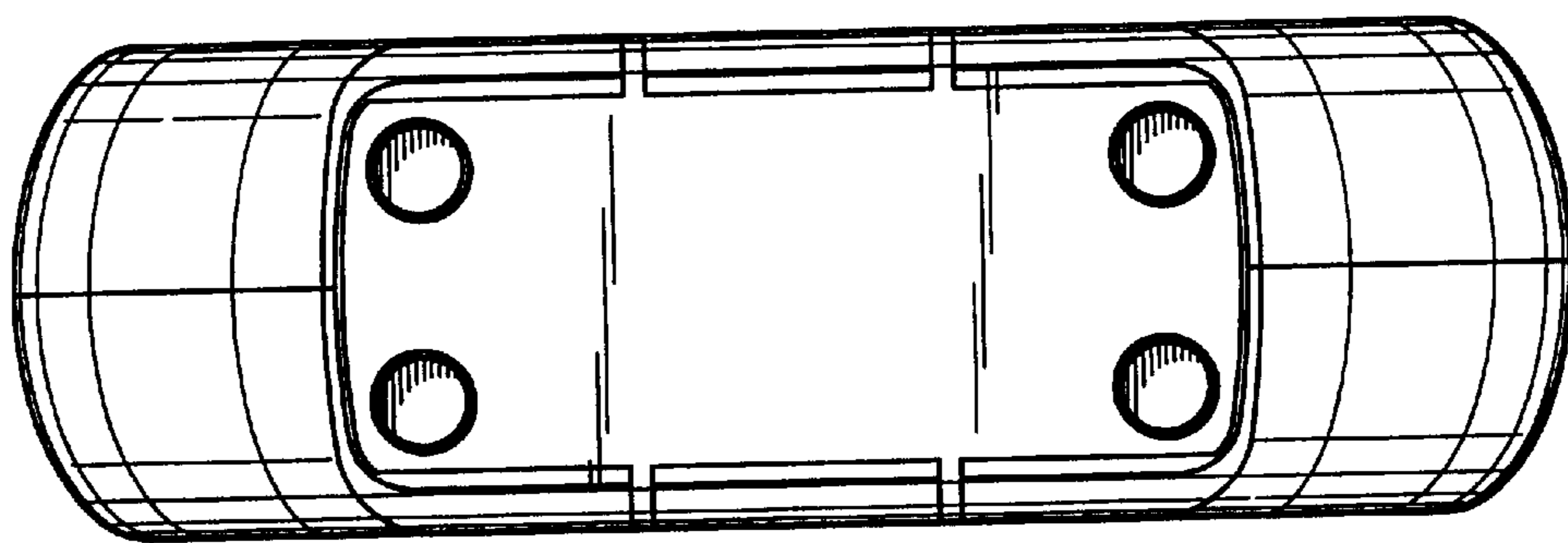
