The ornamental design of a coffee station or tray, as shown and described.

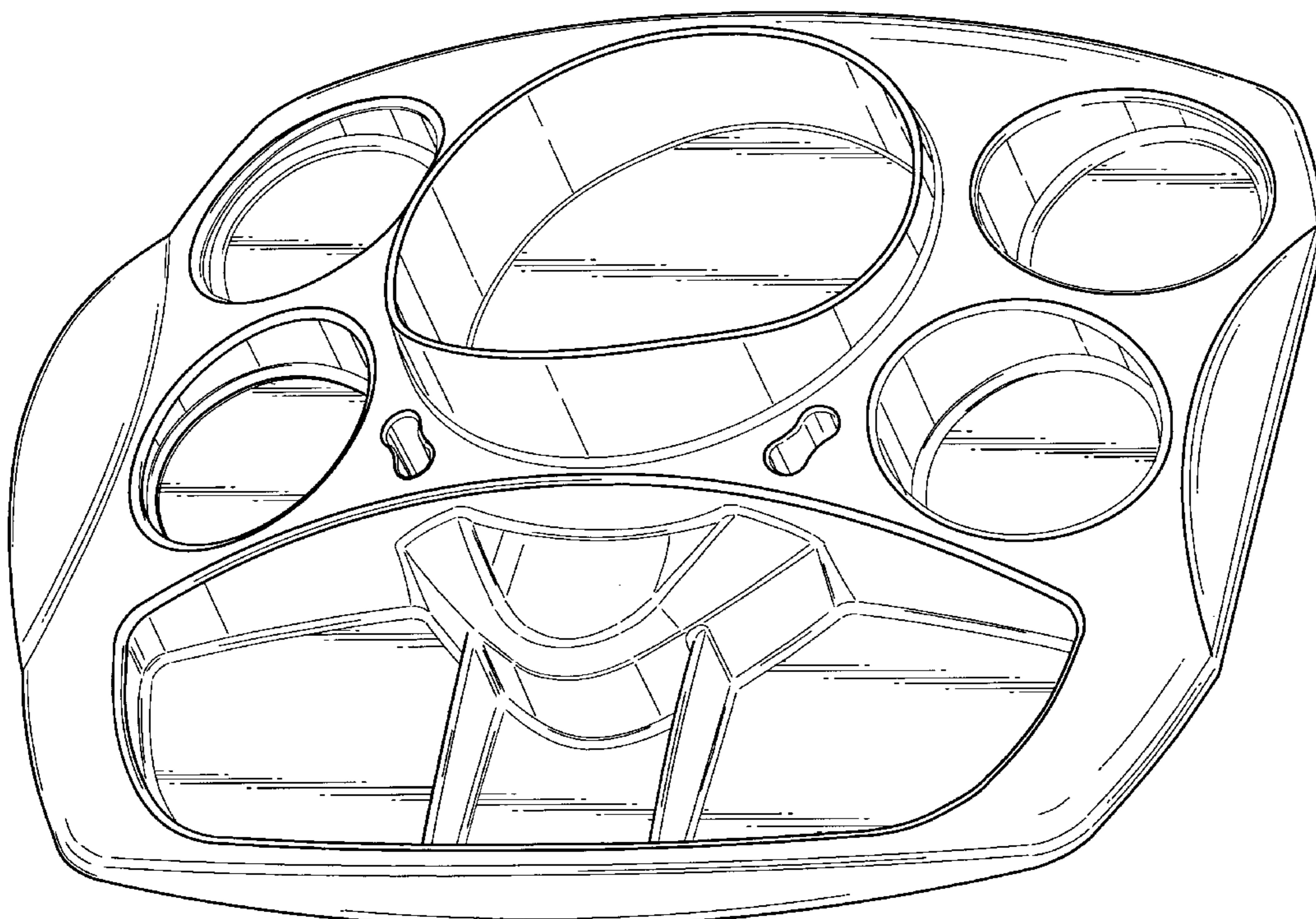
DESCRIPTION

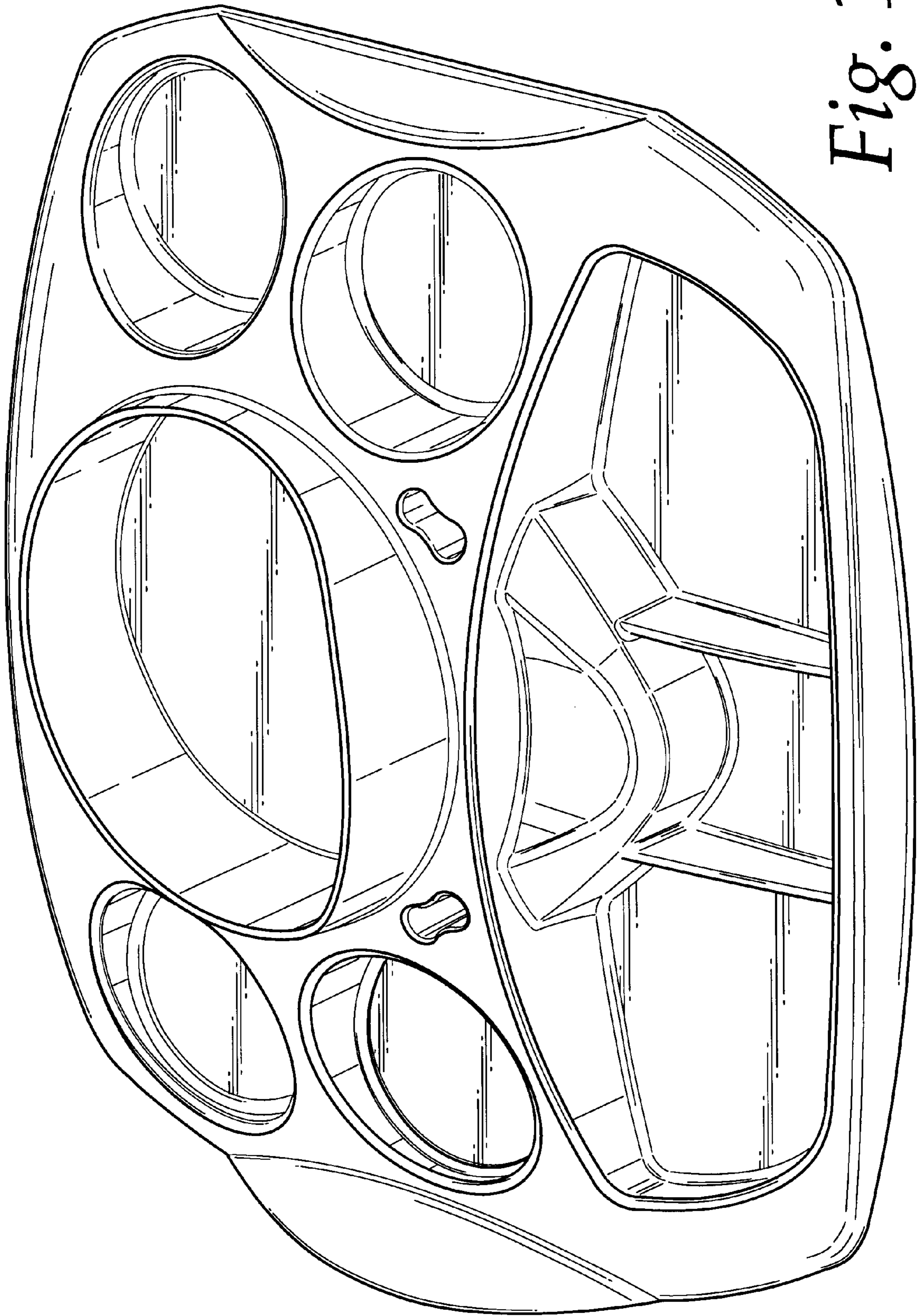

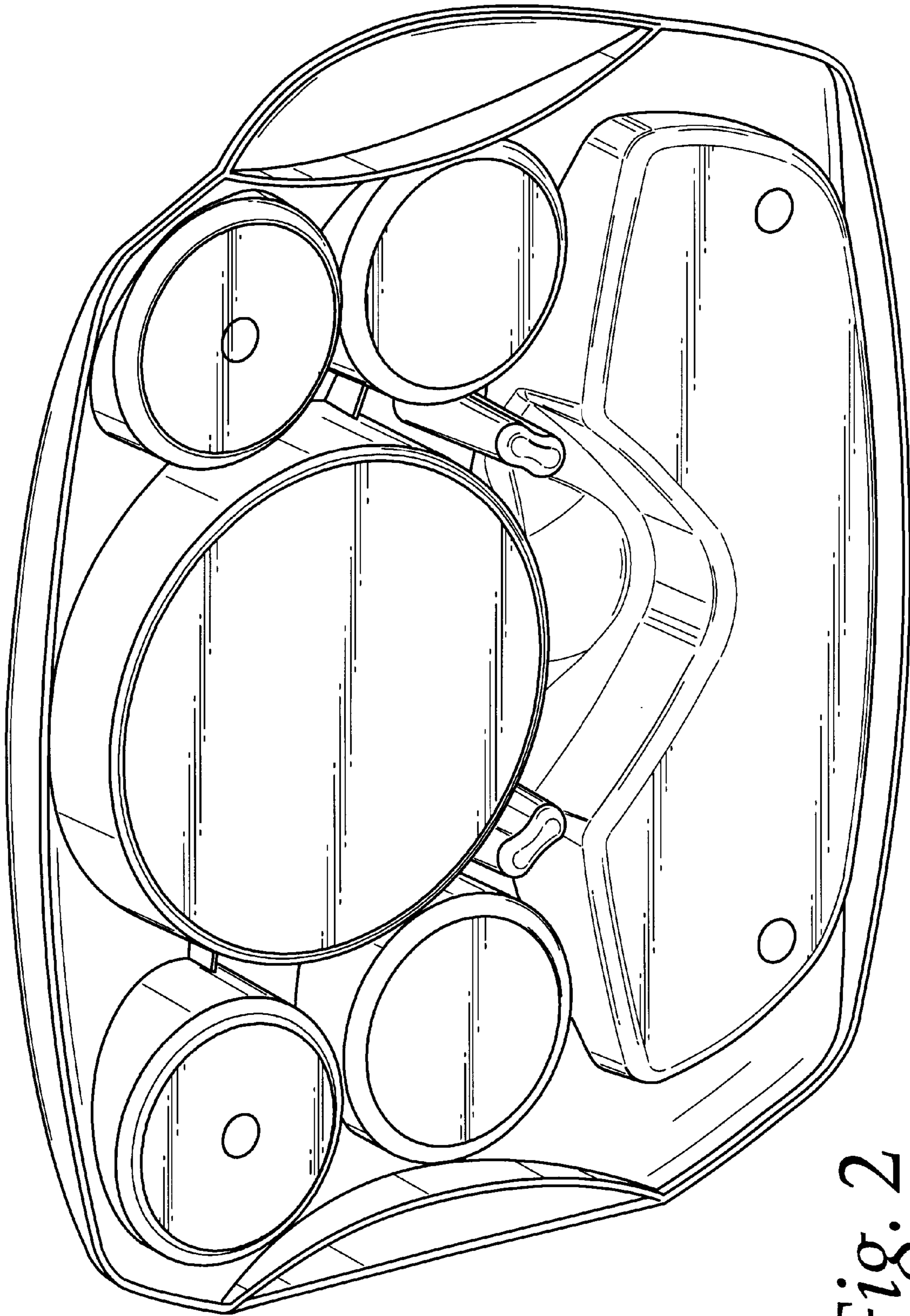

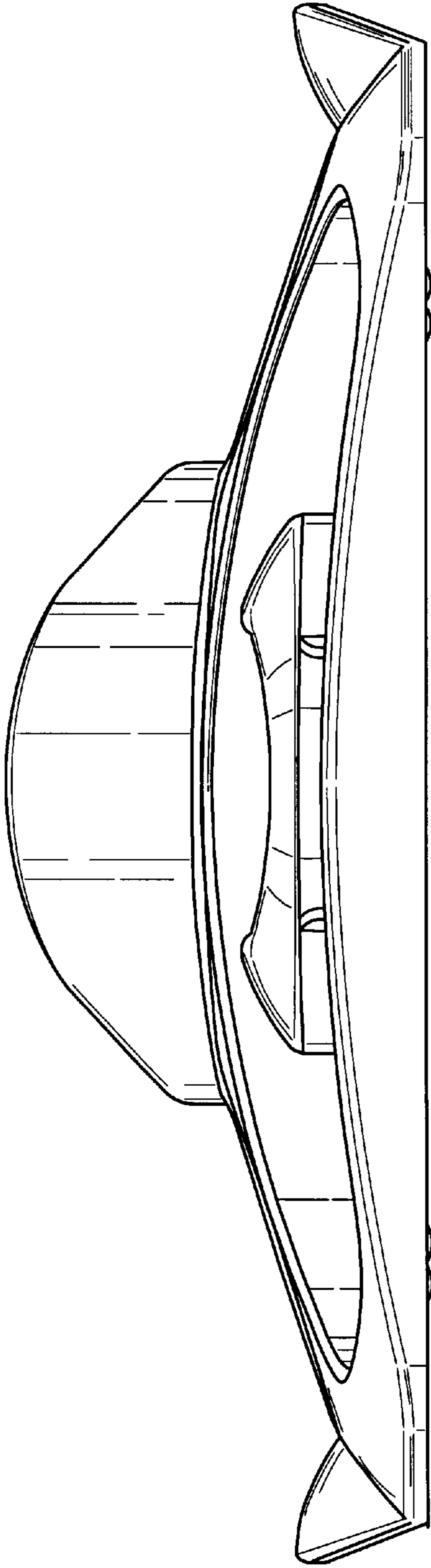

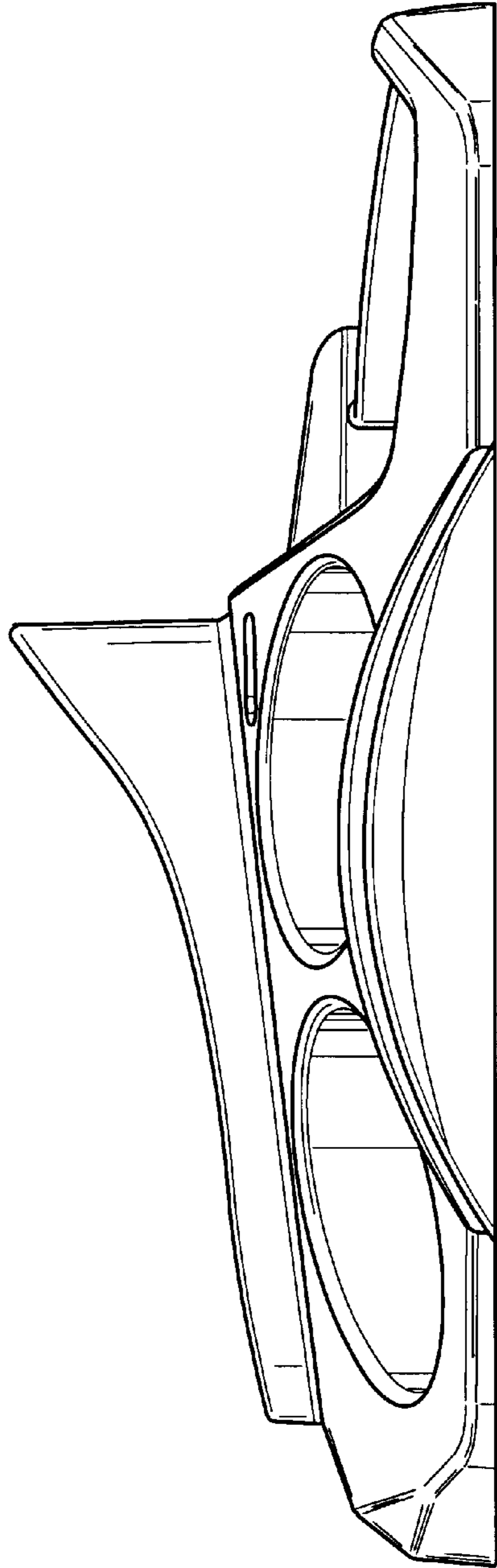

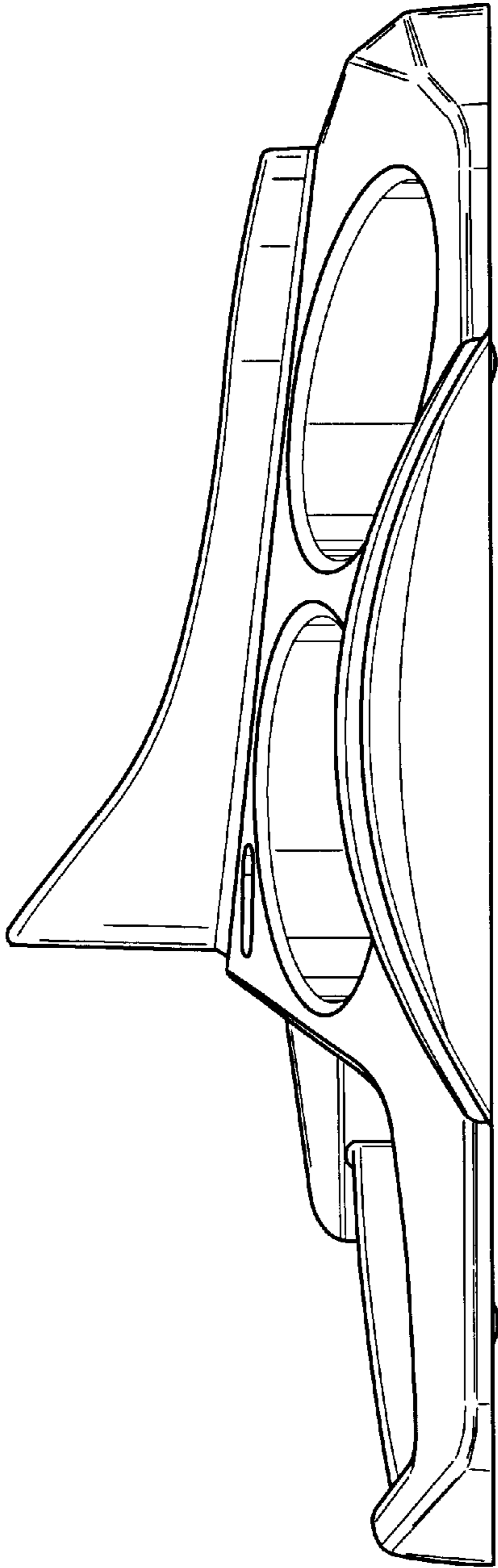

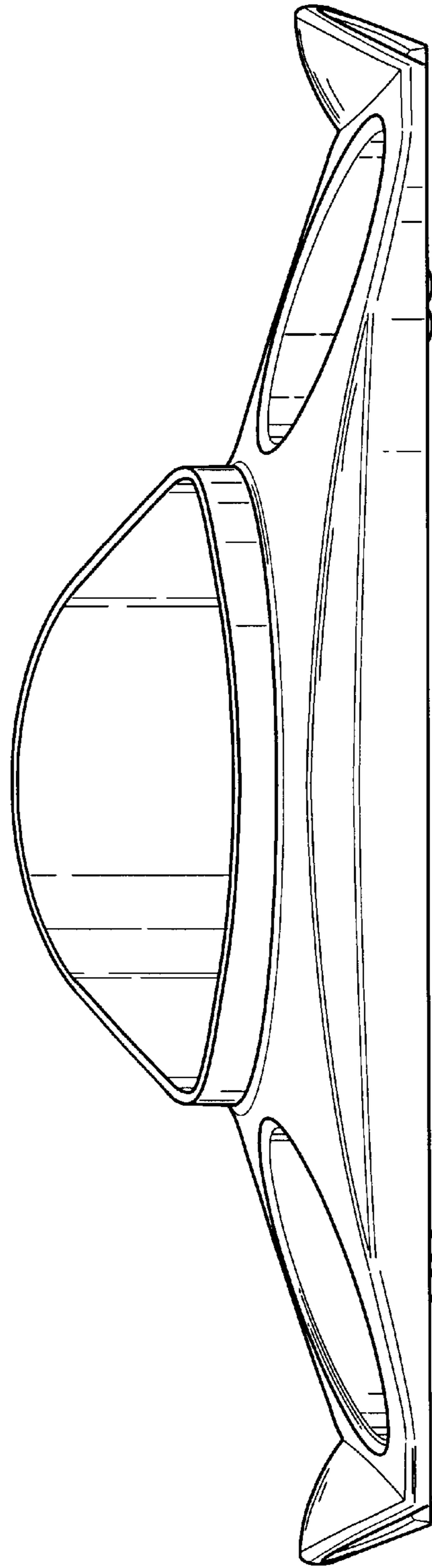

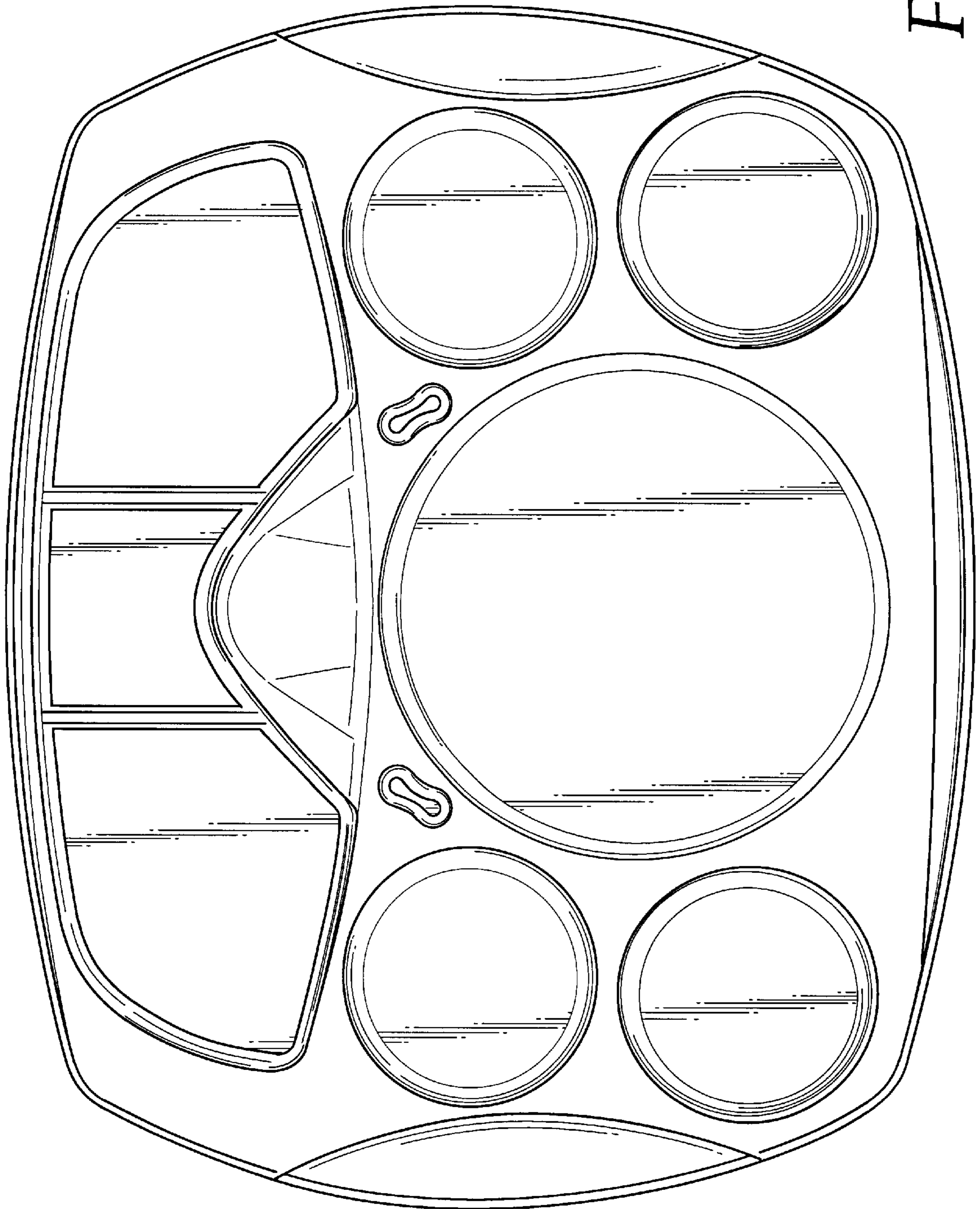

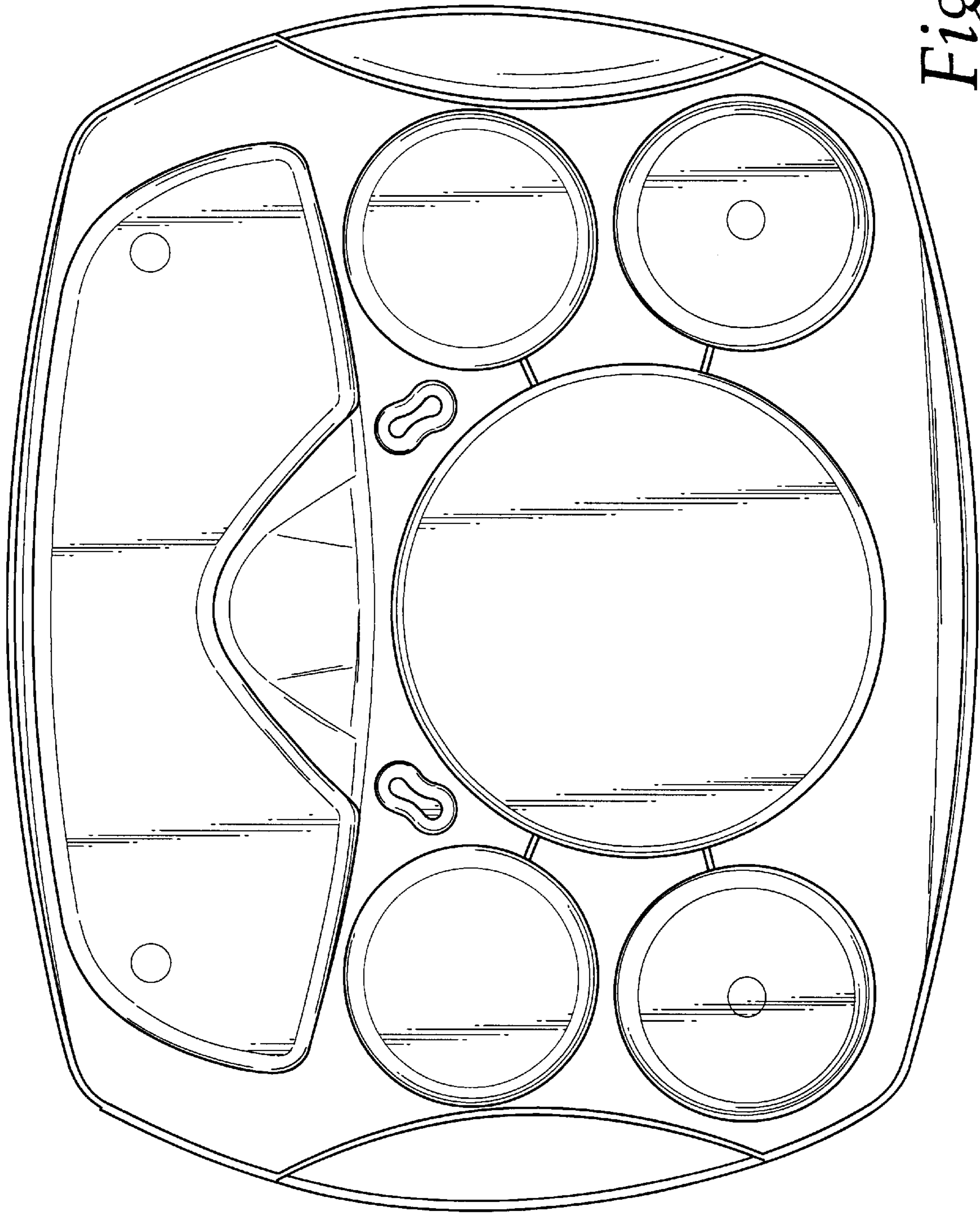
