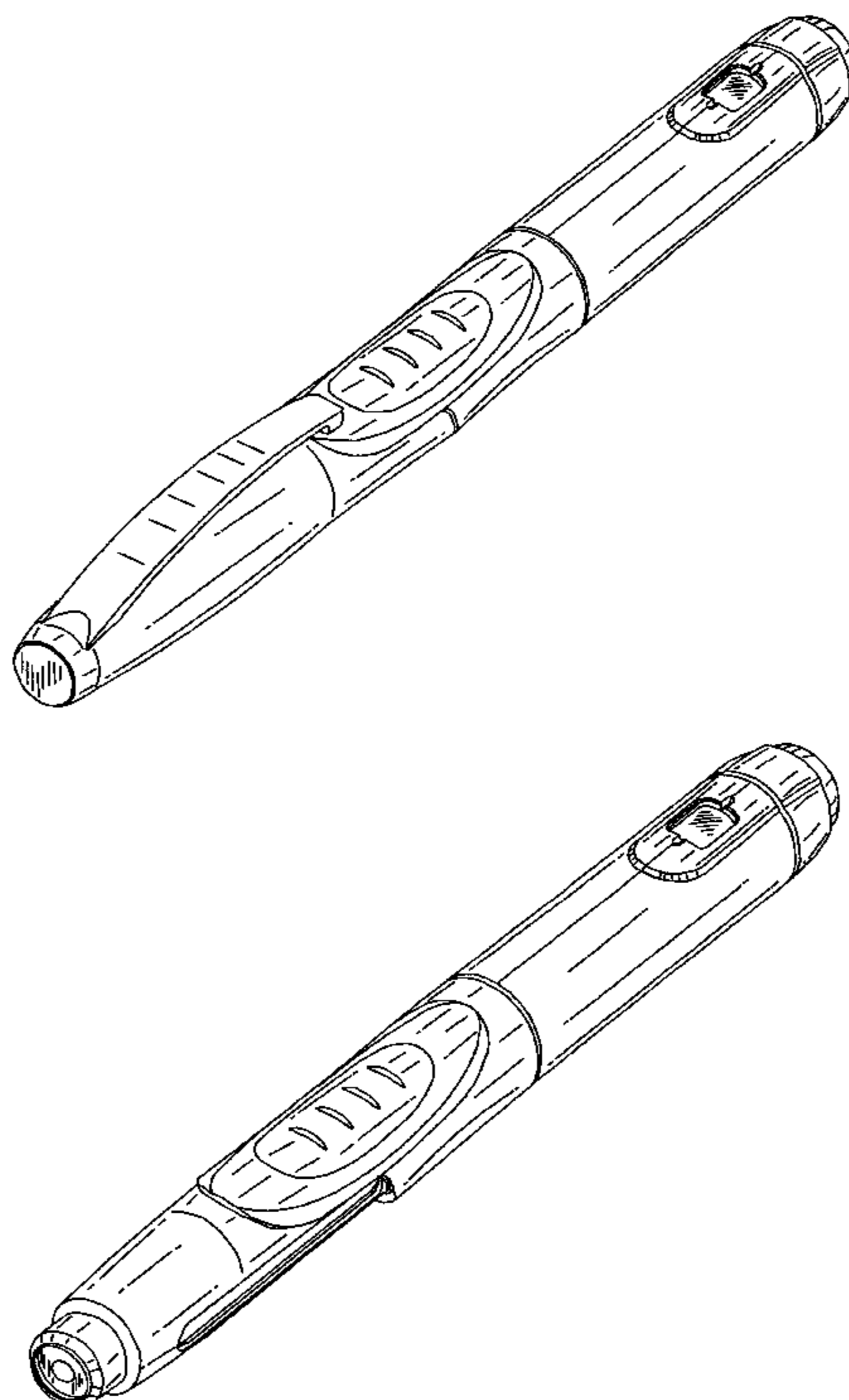
(57) **CLAIM**

The ornamental design for a medicament delivery device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a medicament delivery device with a cap on the device;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left-side view thereof;
 FIG. 5 is a right-side view thereof;
 FIG. 6 is a top view thereof;

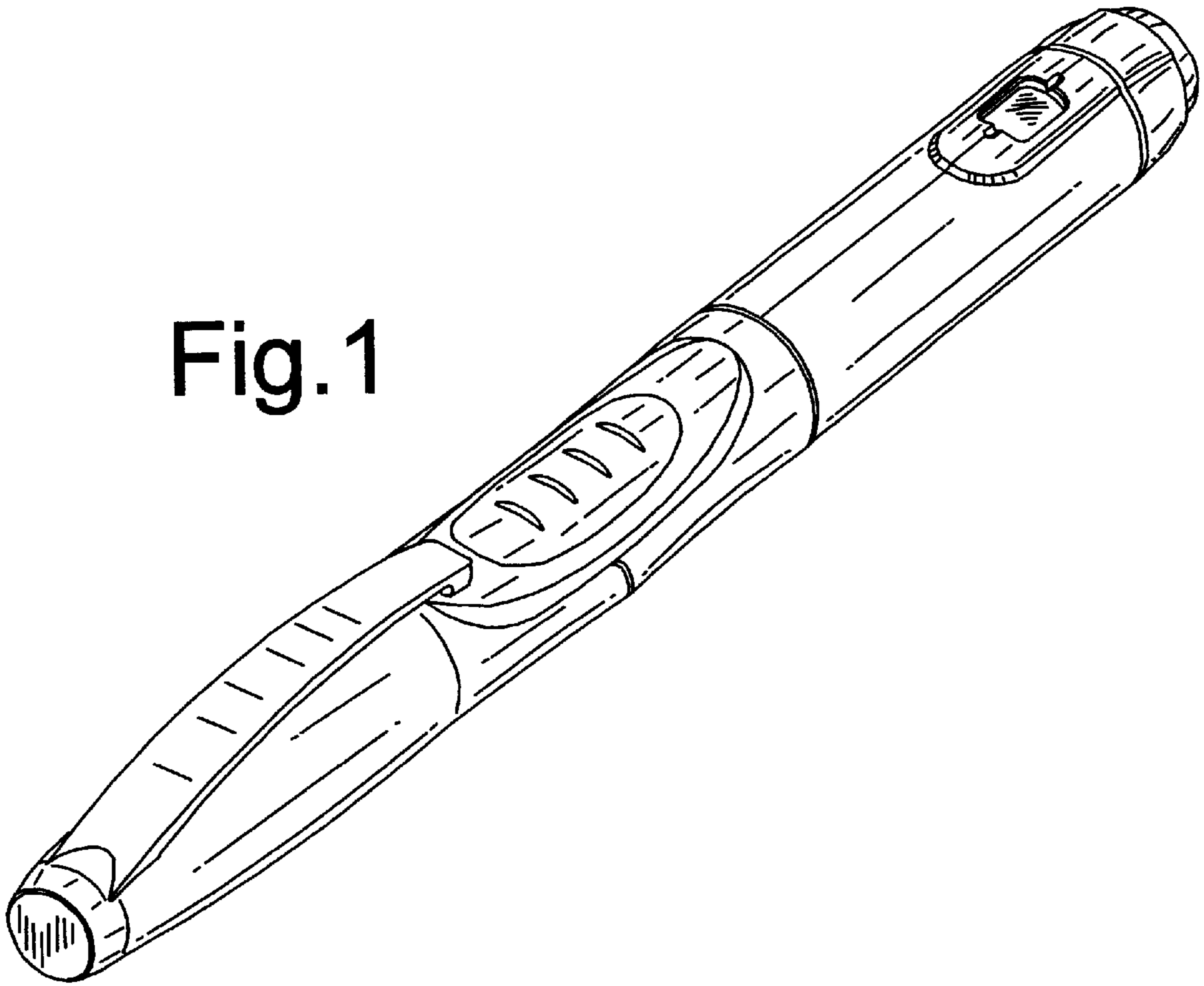

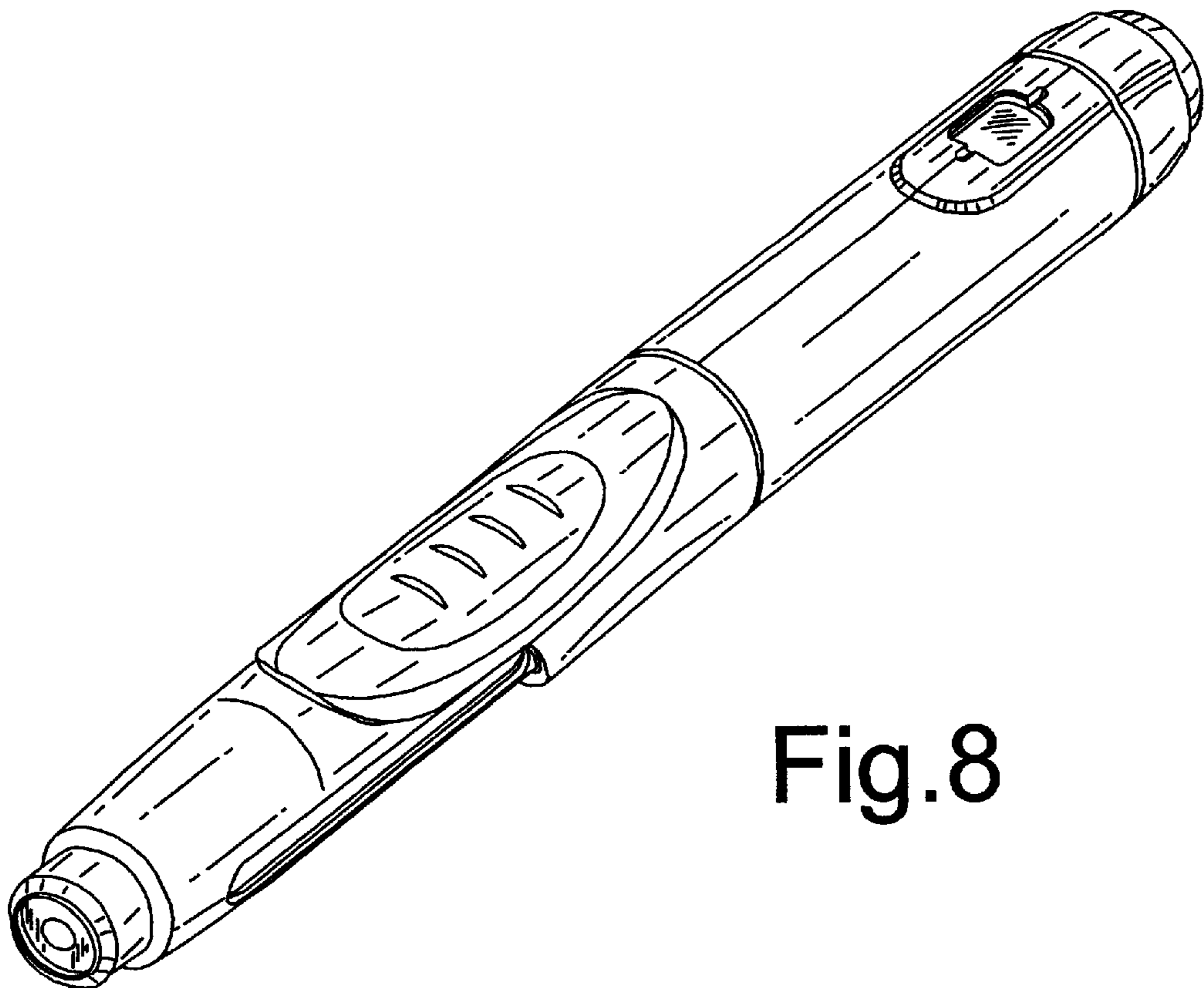

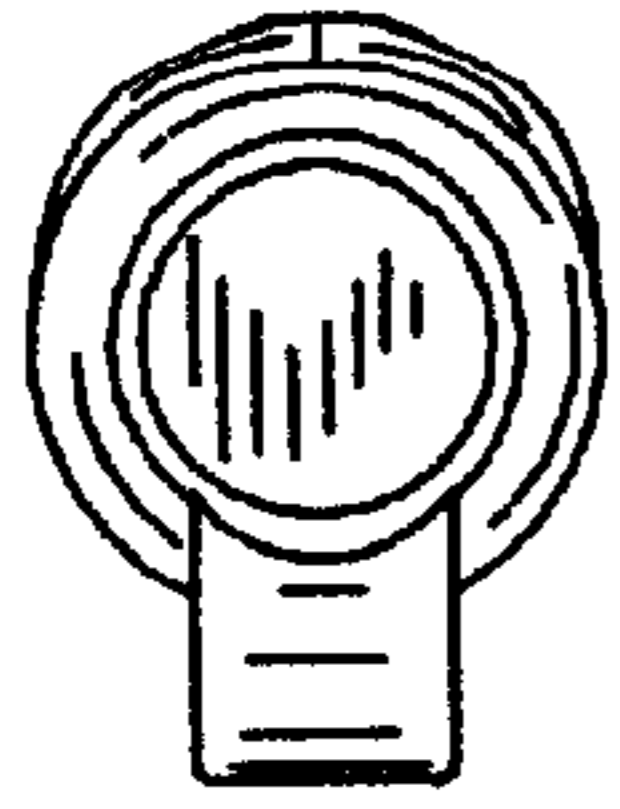

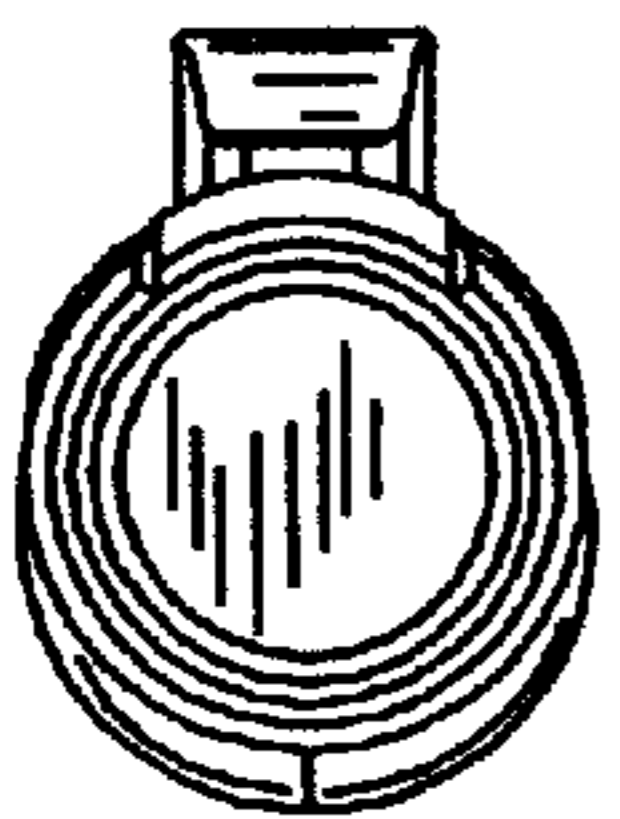

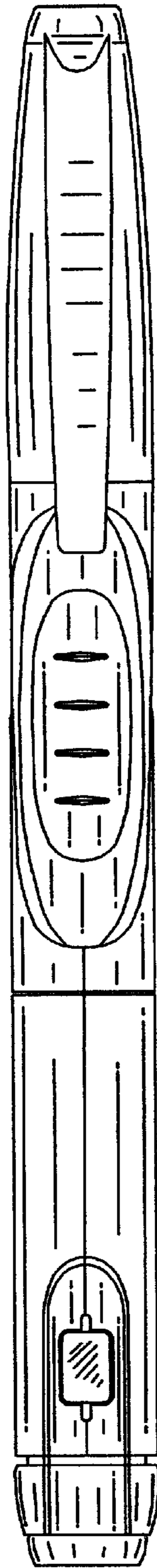

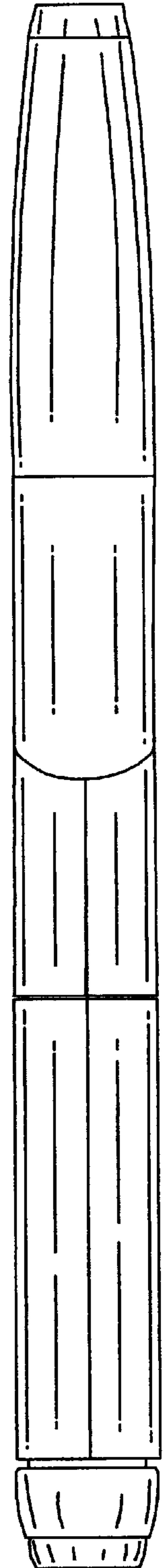

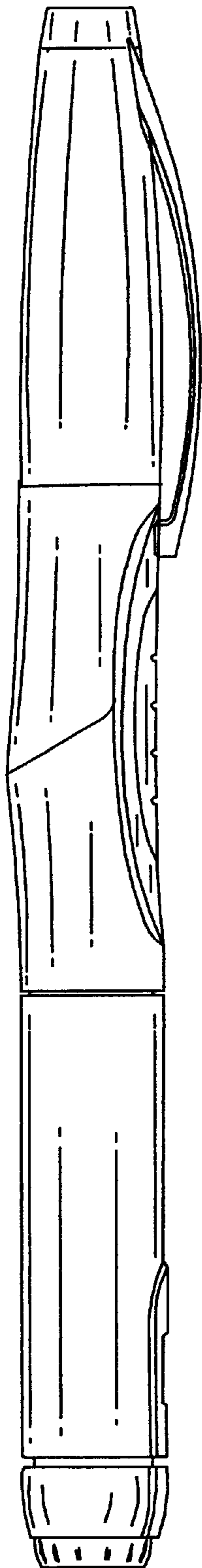

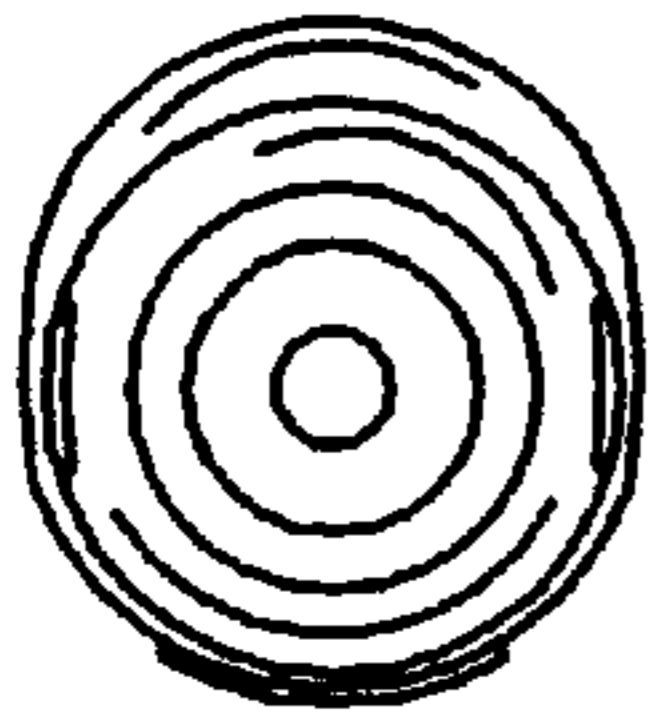

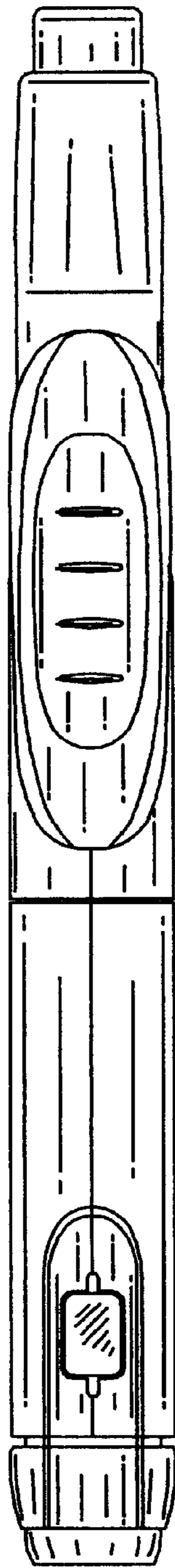

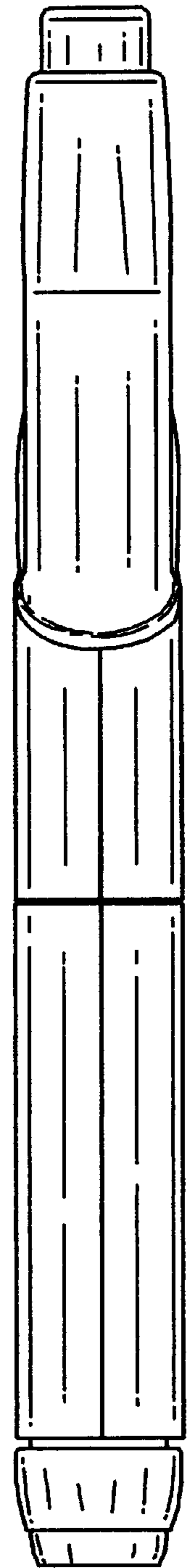

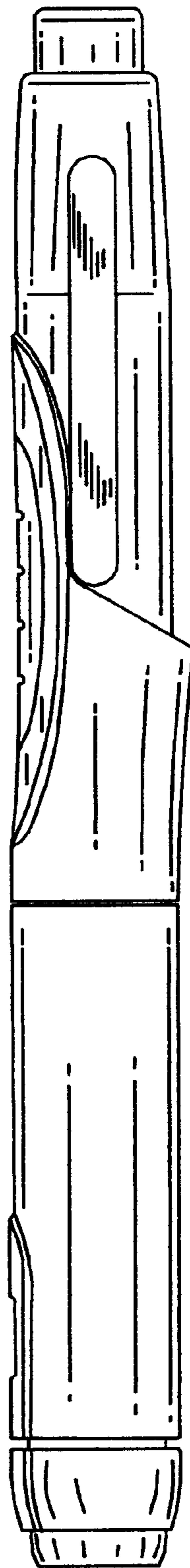
