FIG. 15 is a perspective view of FIG. 8, the straps being reattached.

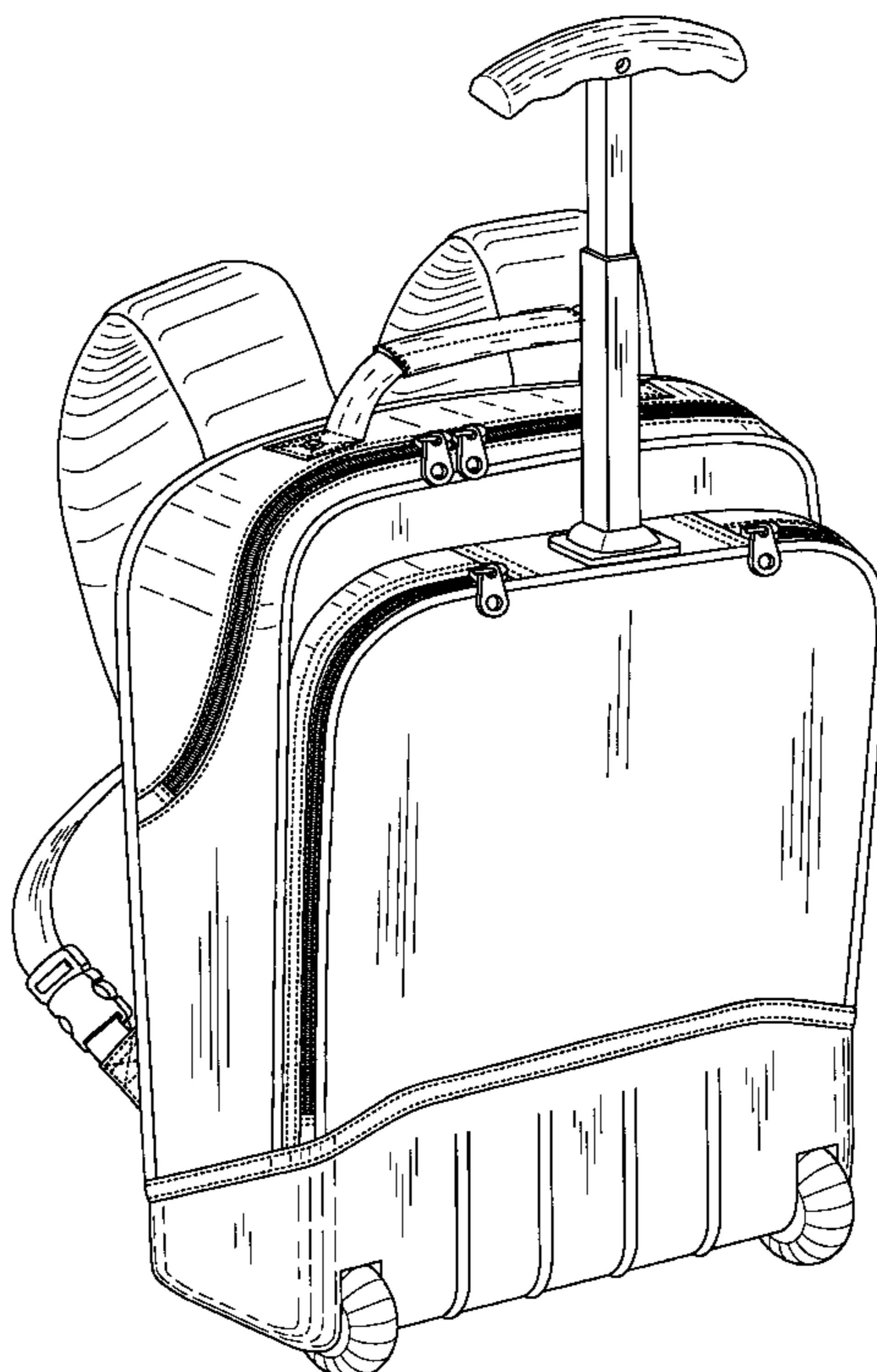
The broken lines shown on the claimed article throughout the views are understood to represent stitching.

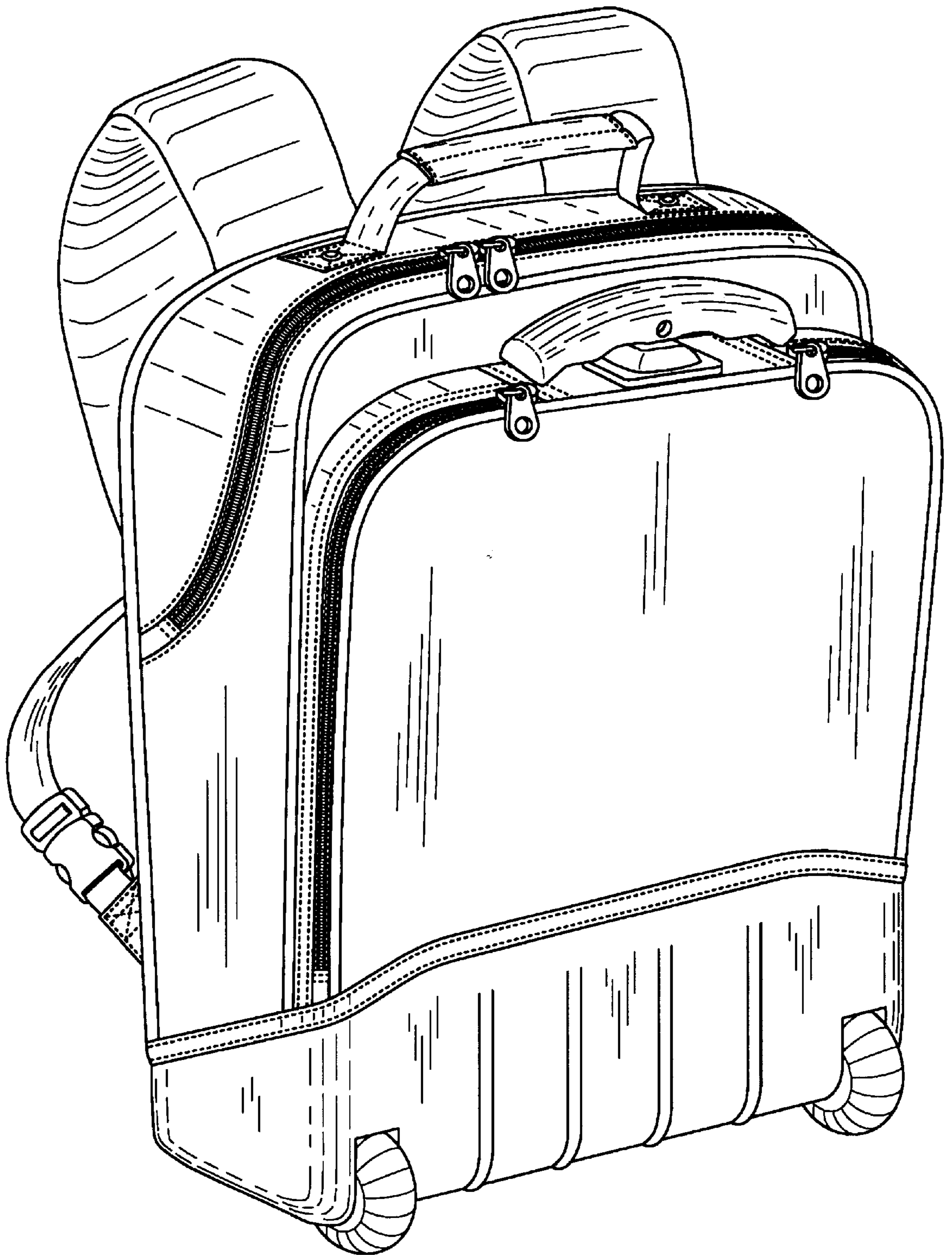

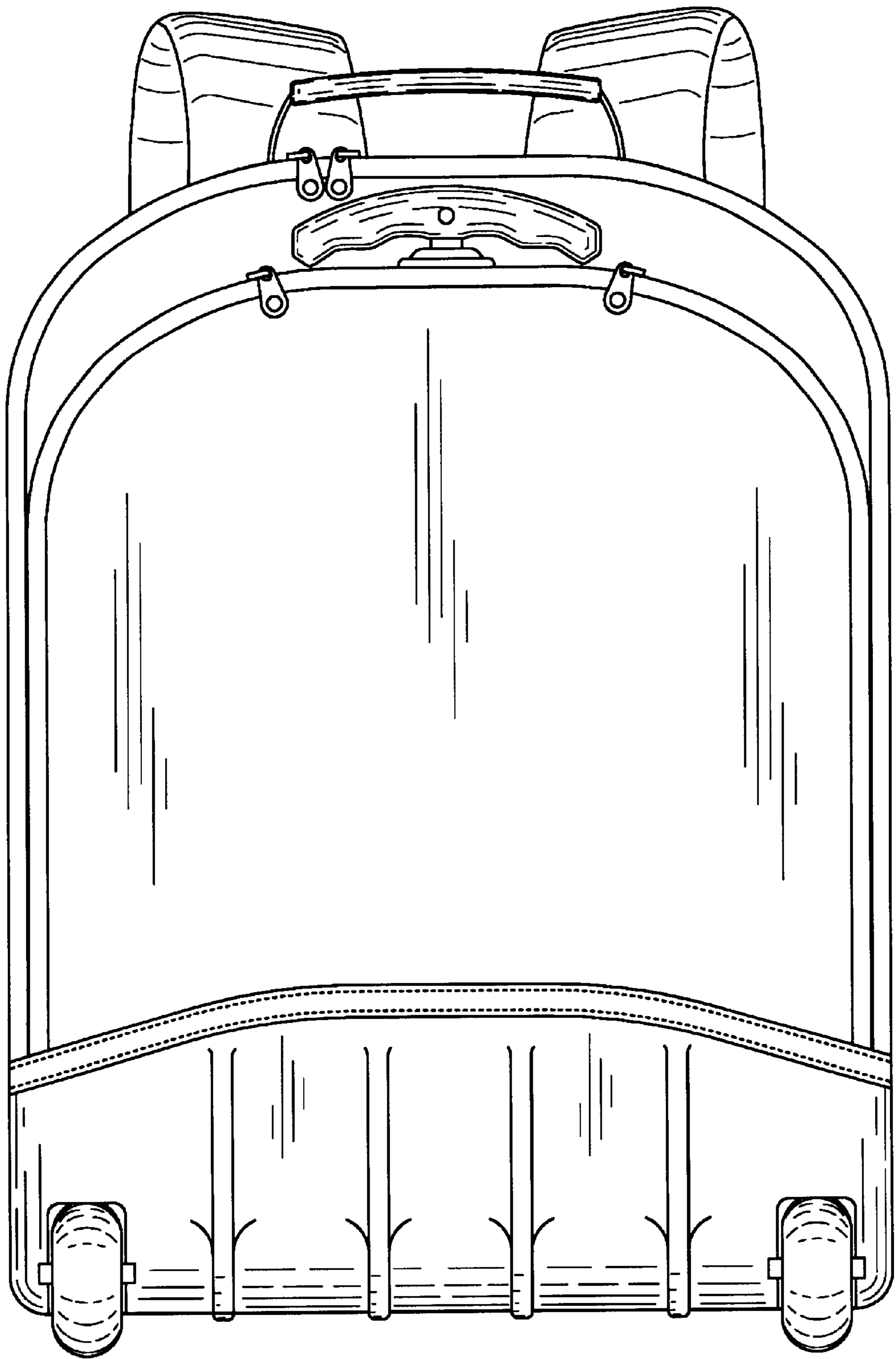

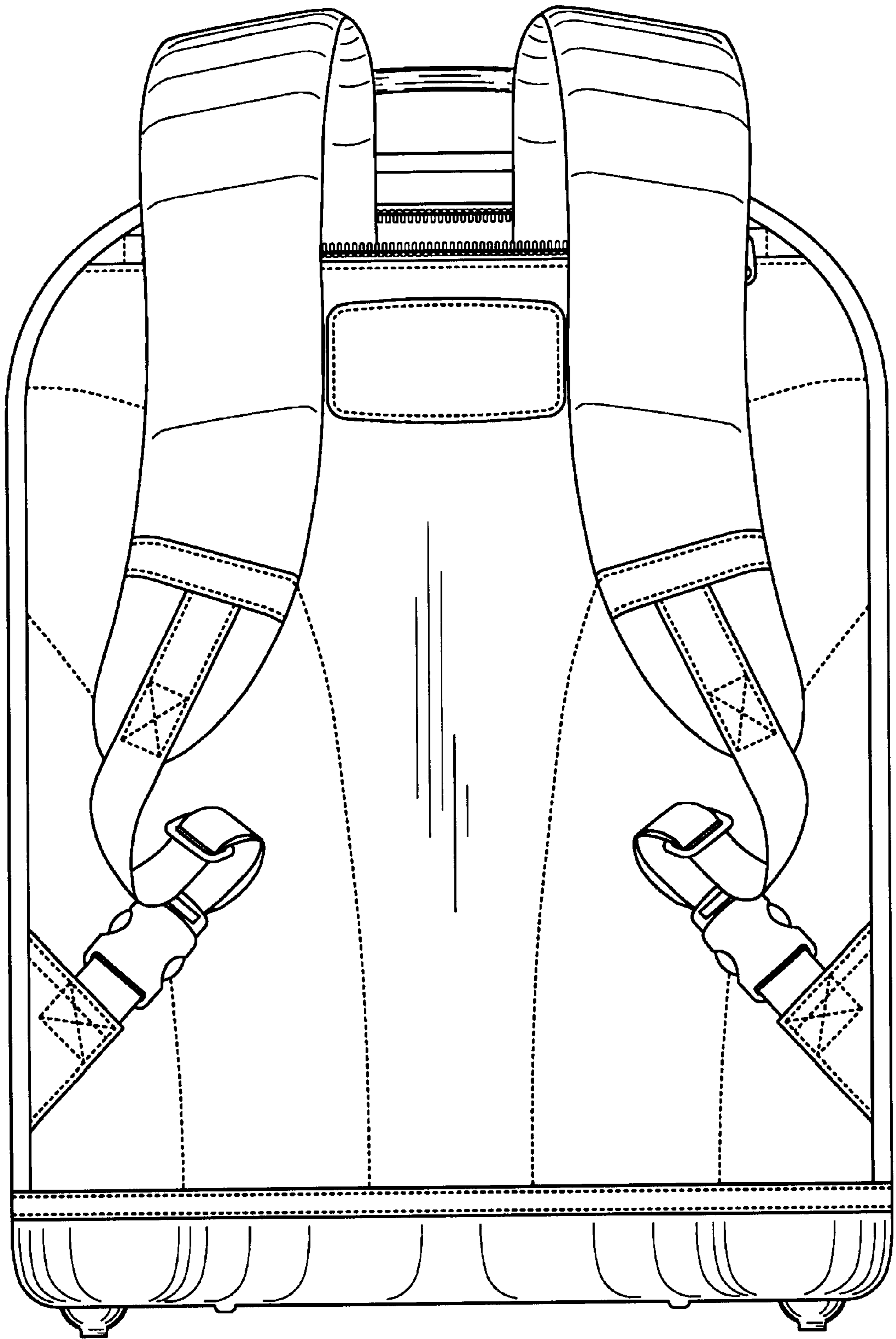

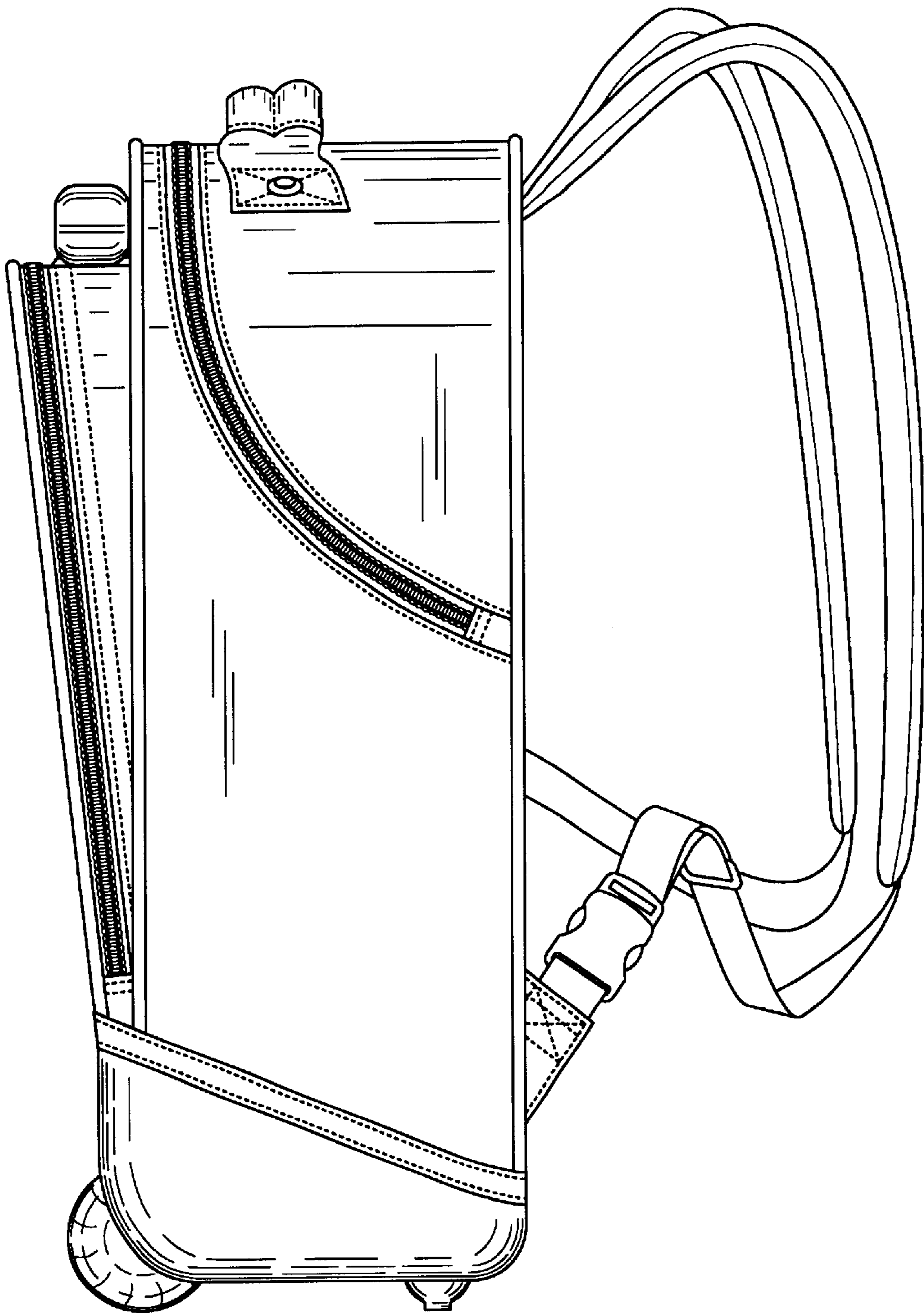

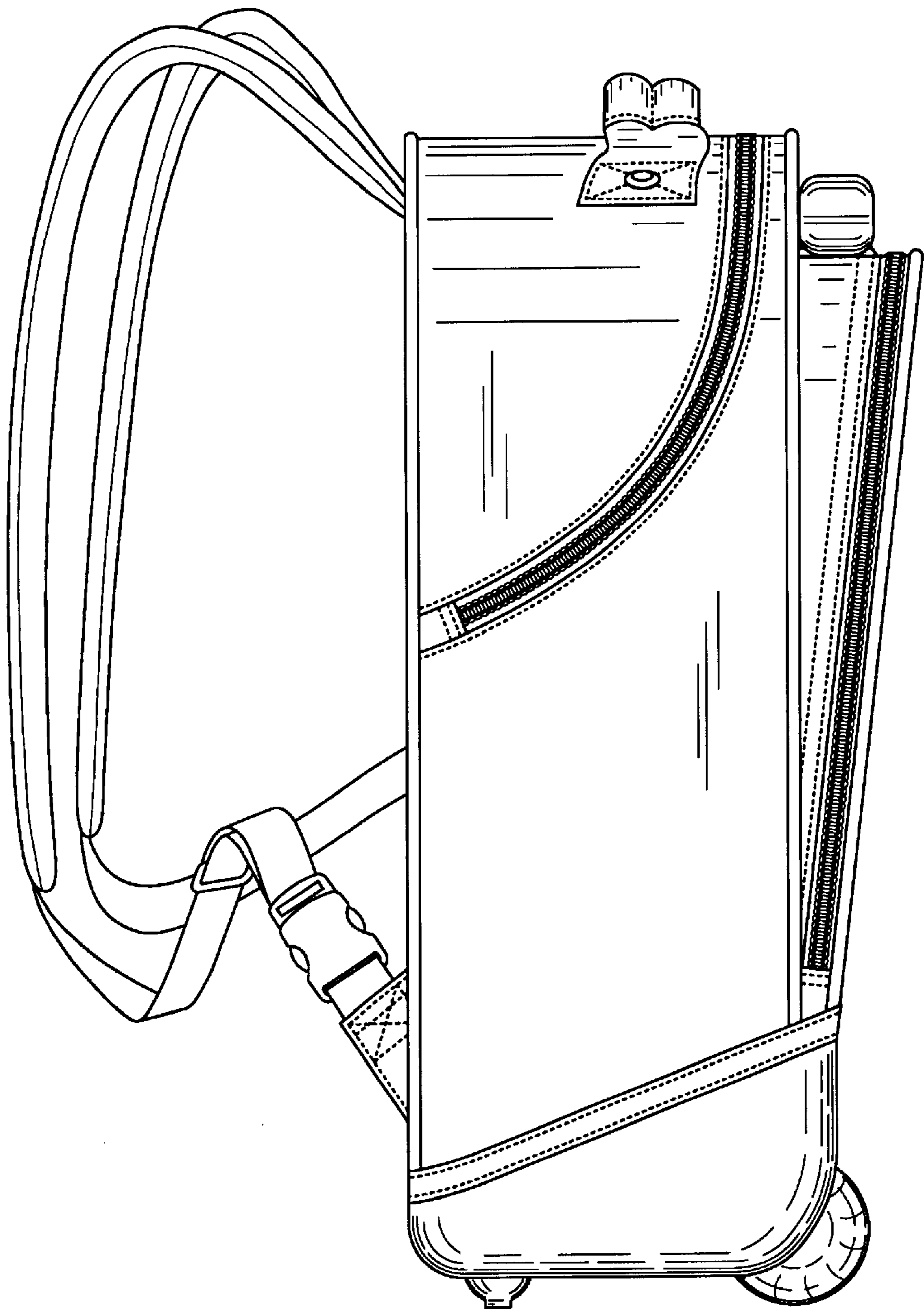

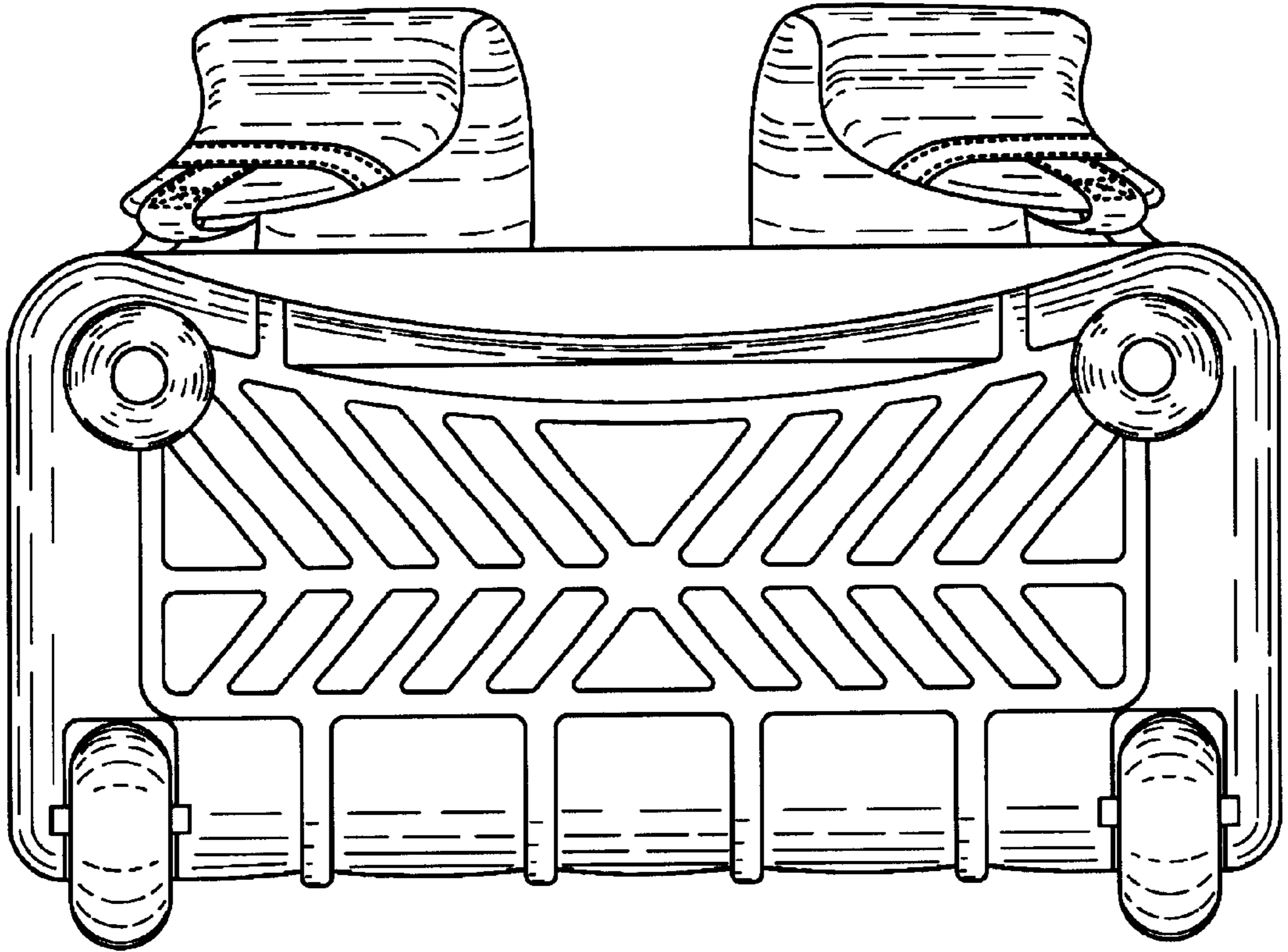

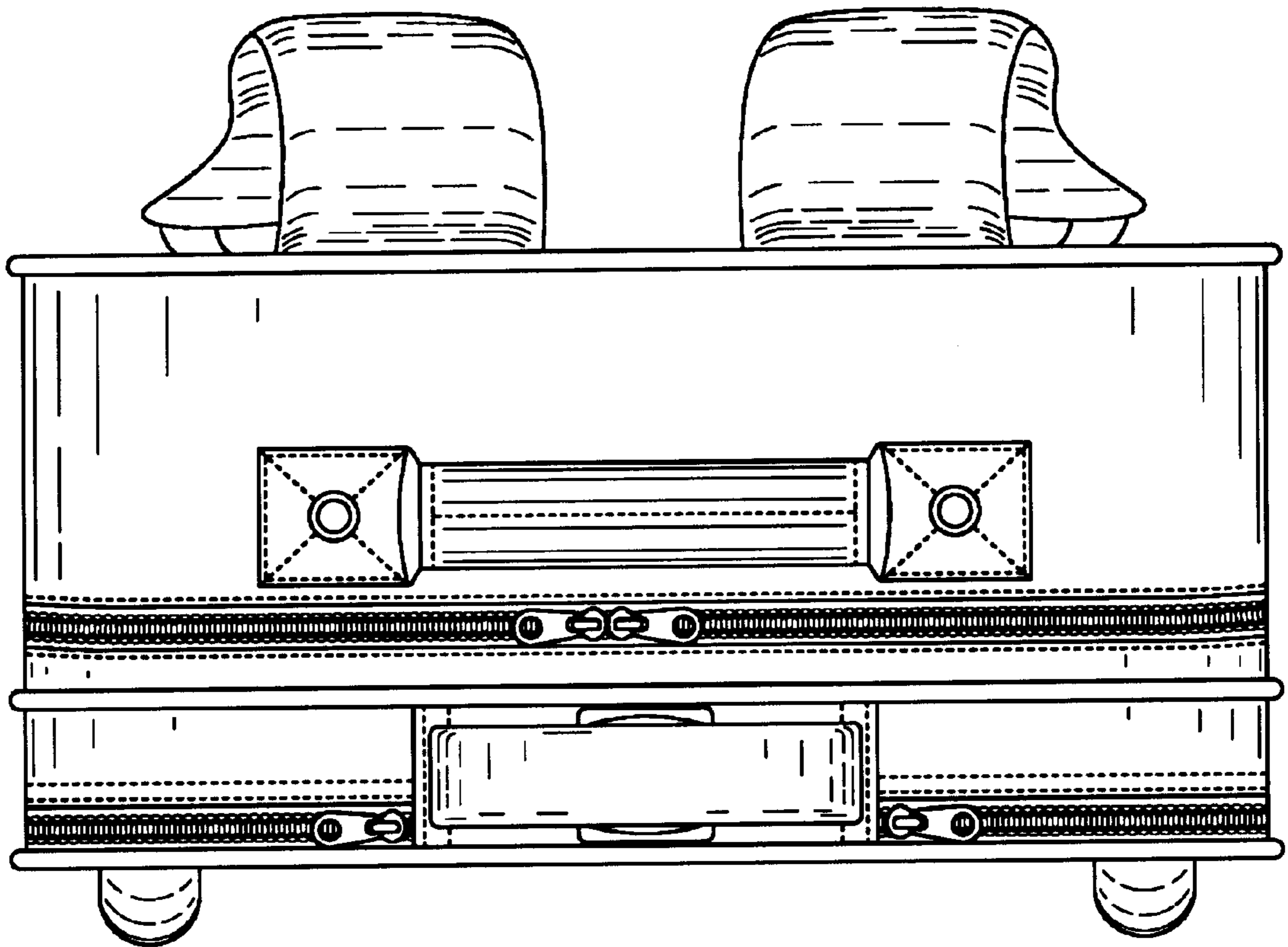

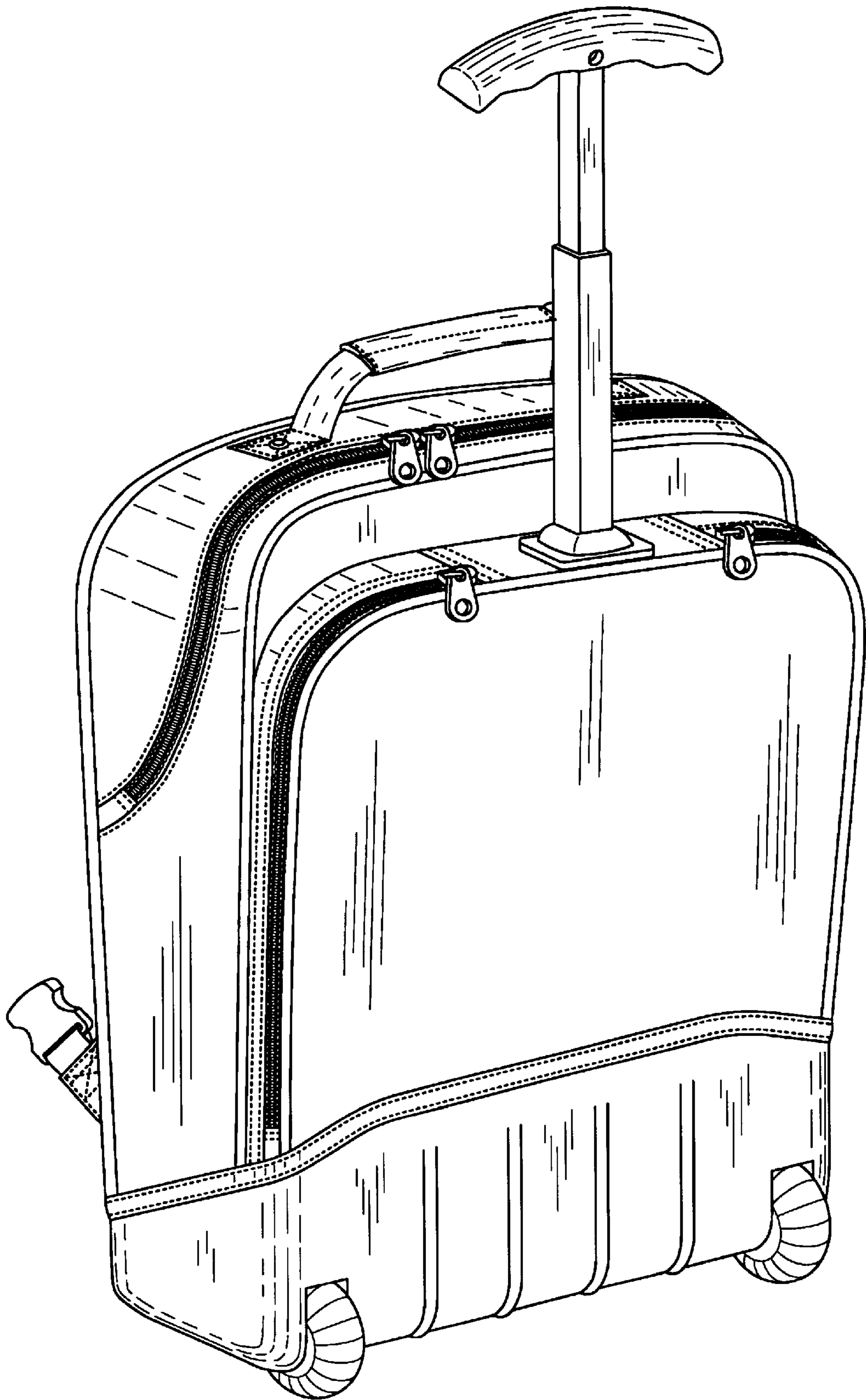

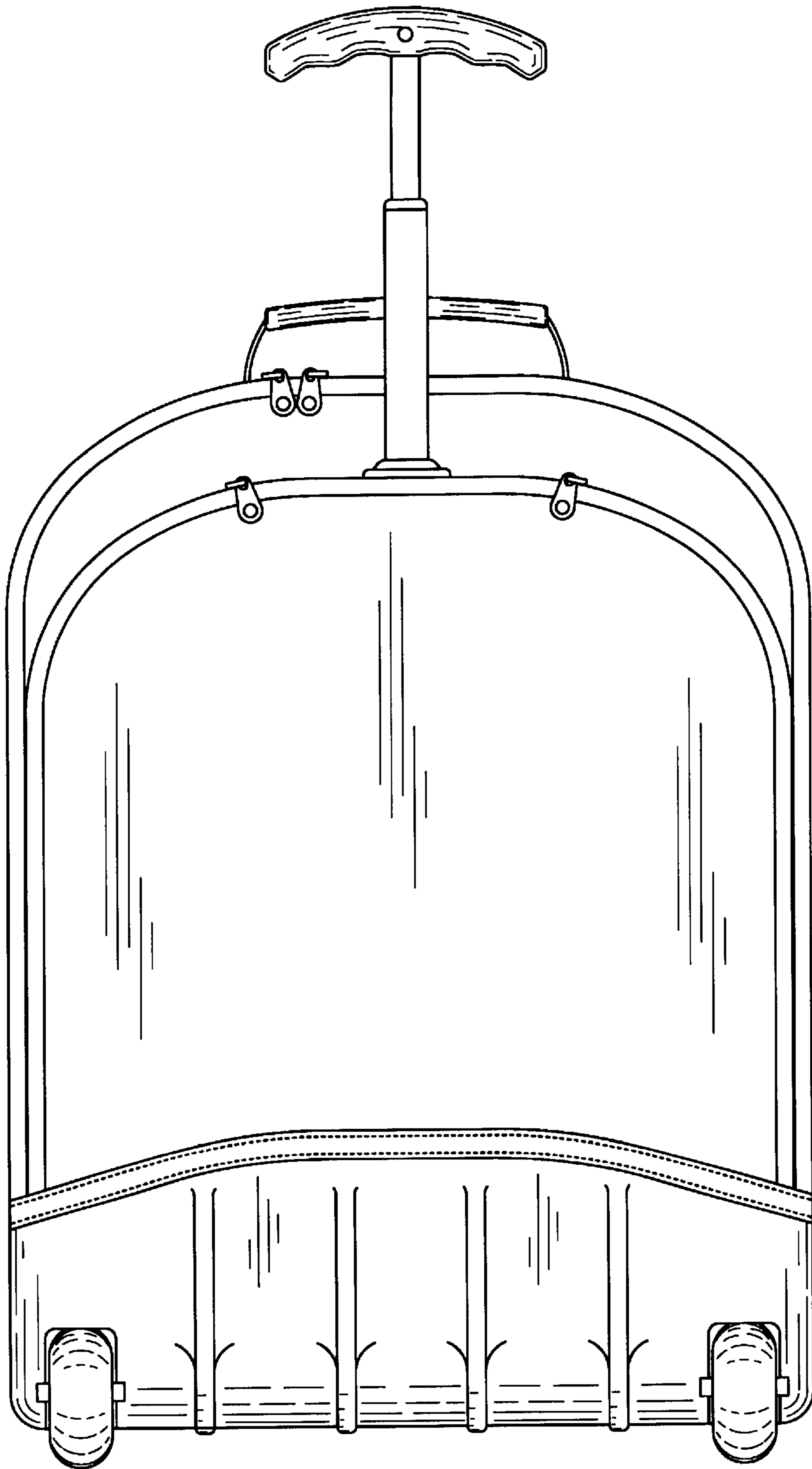

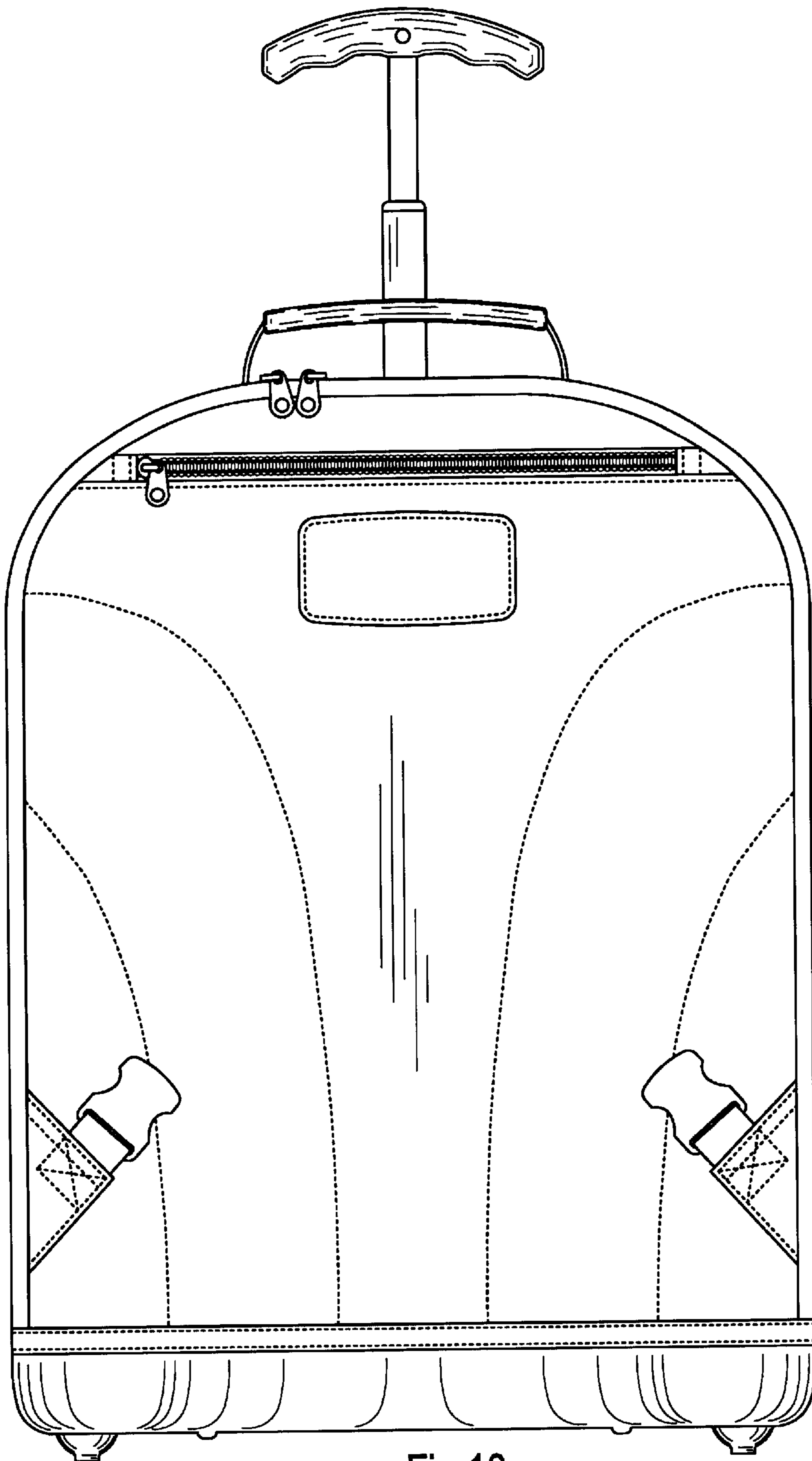

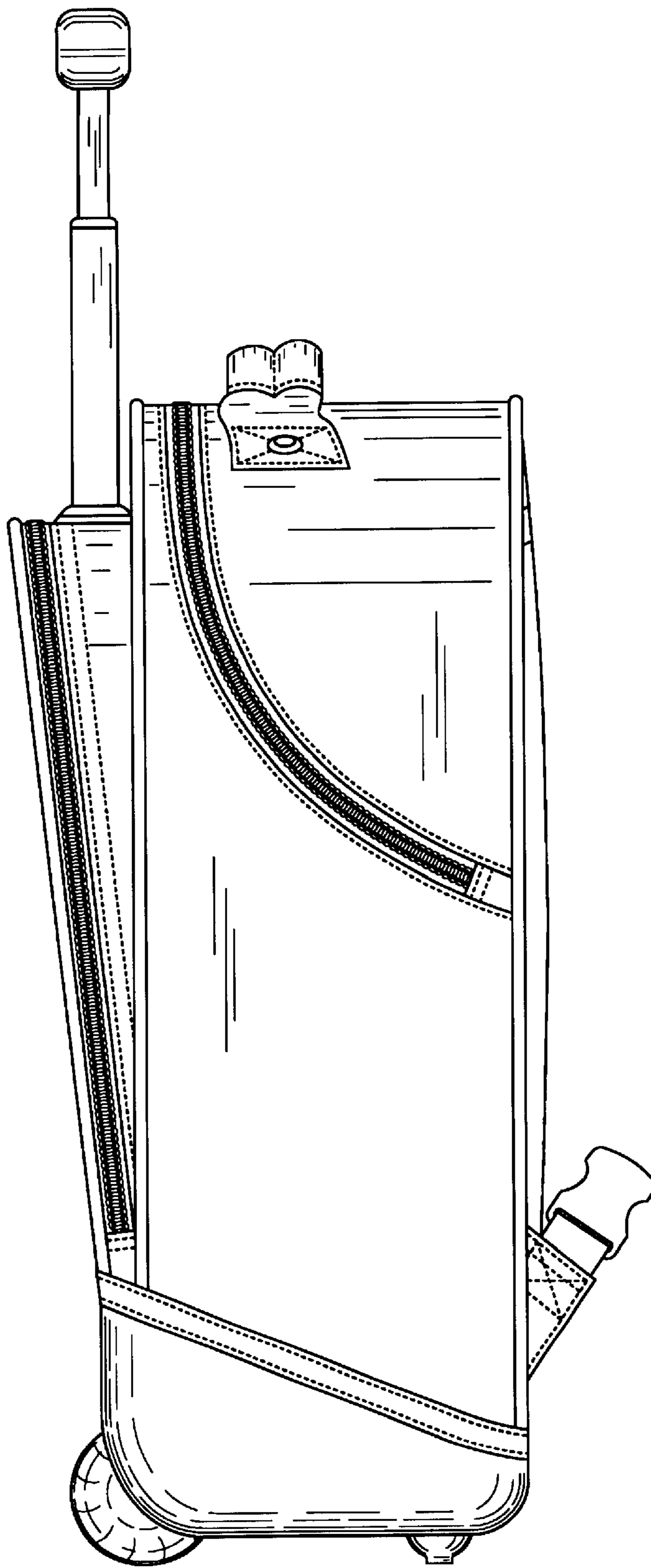

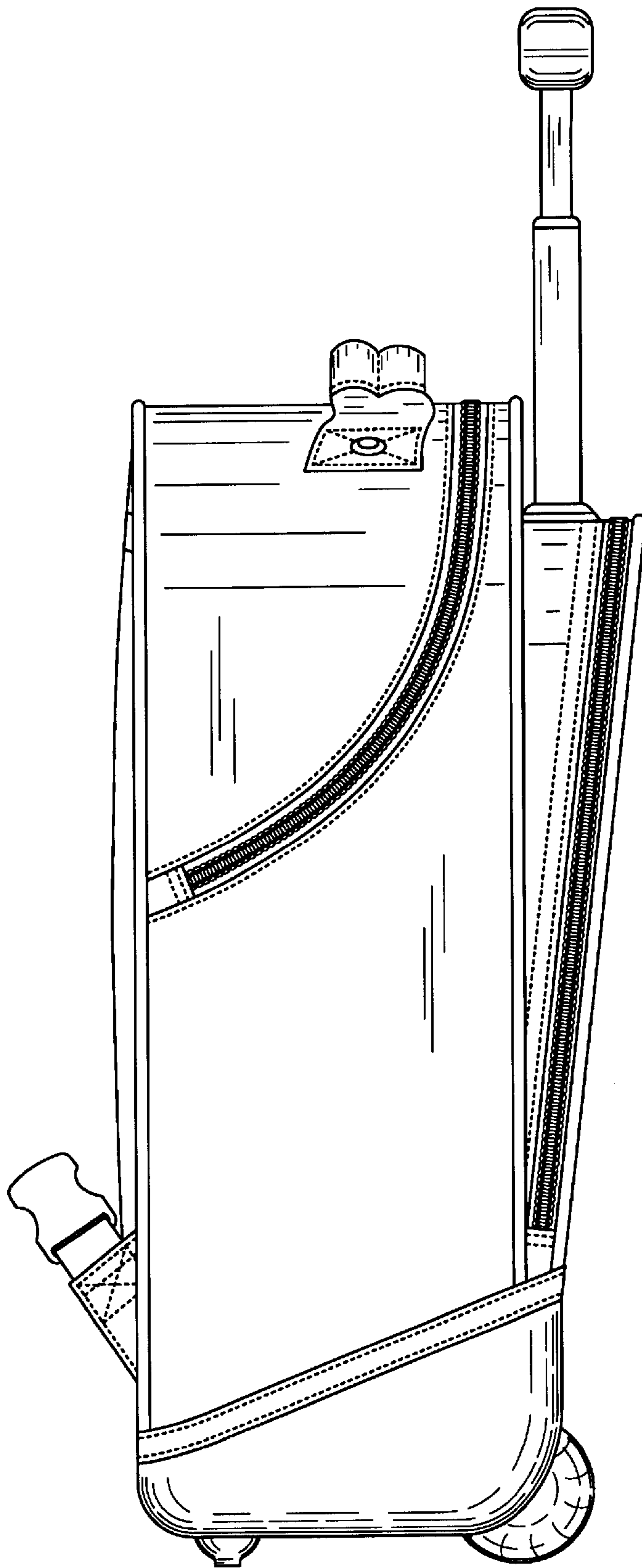

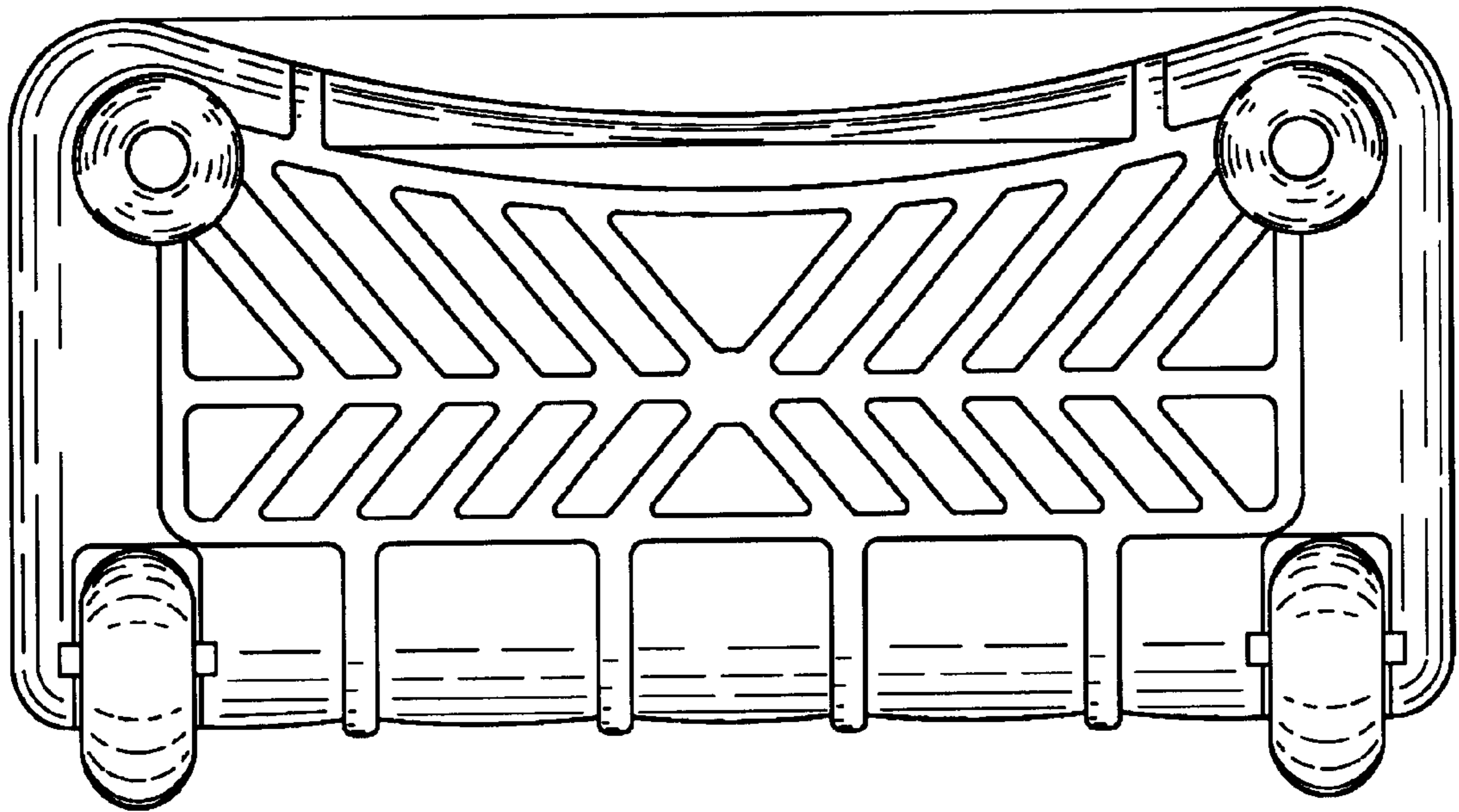

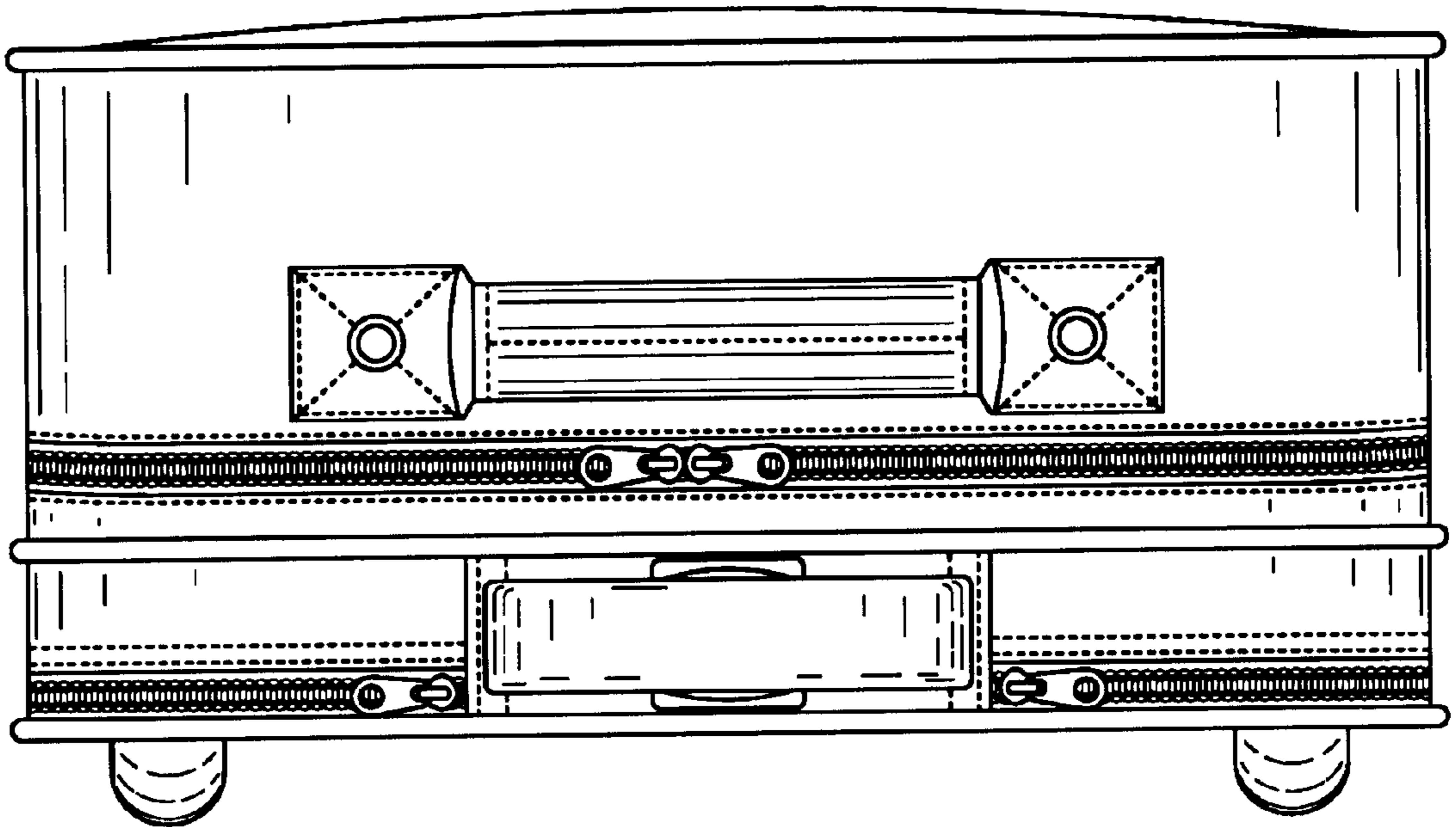

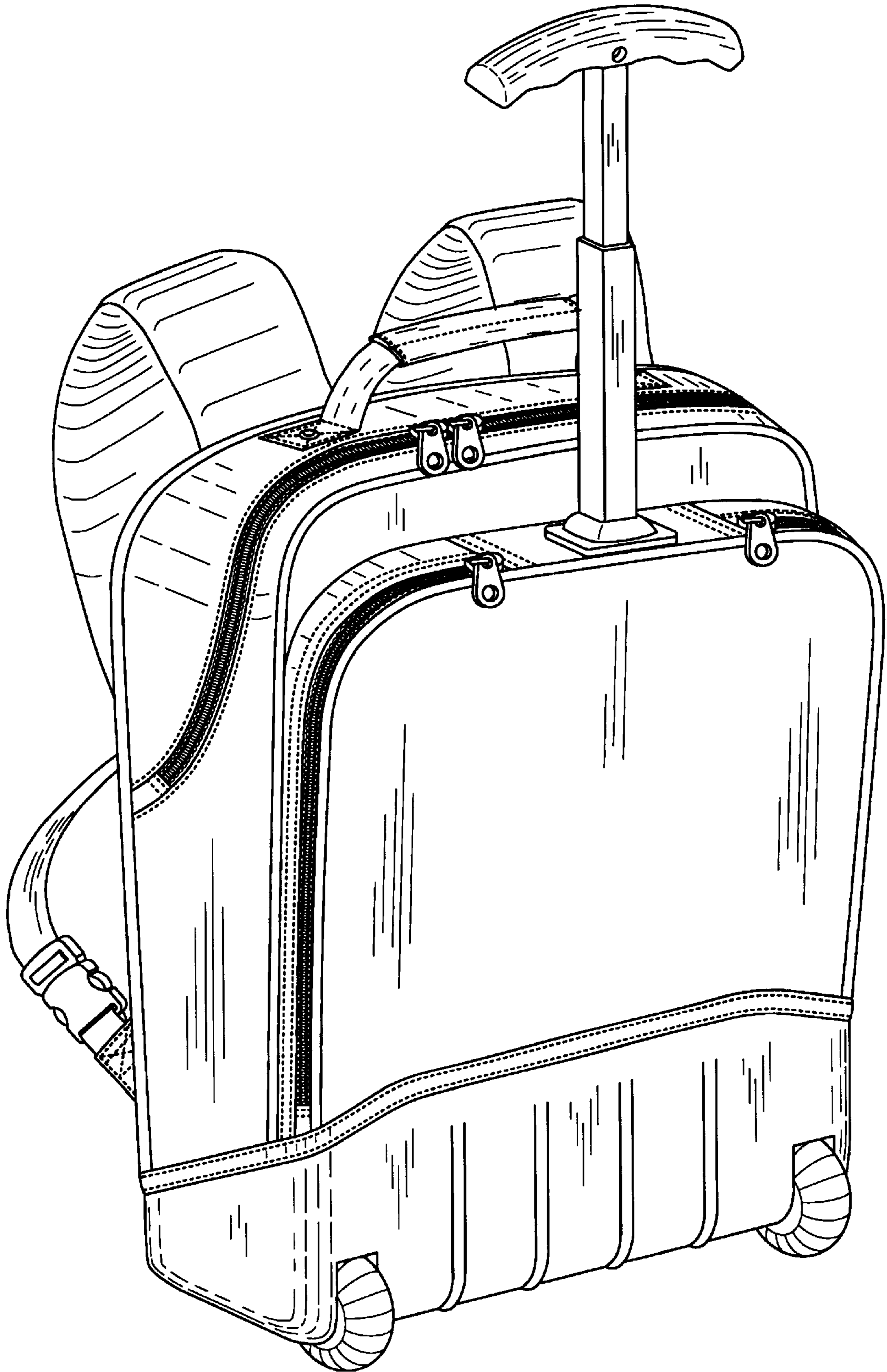
