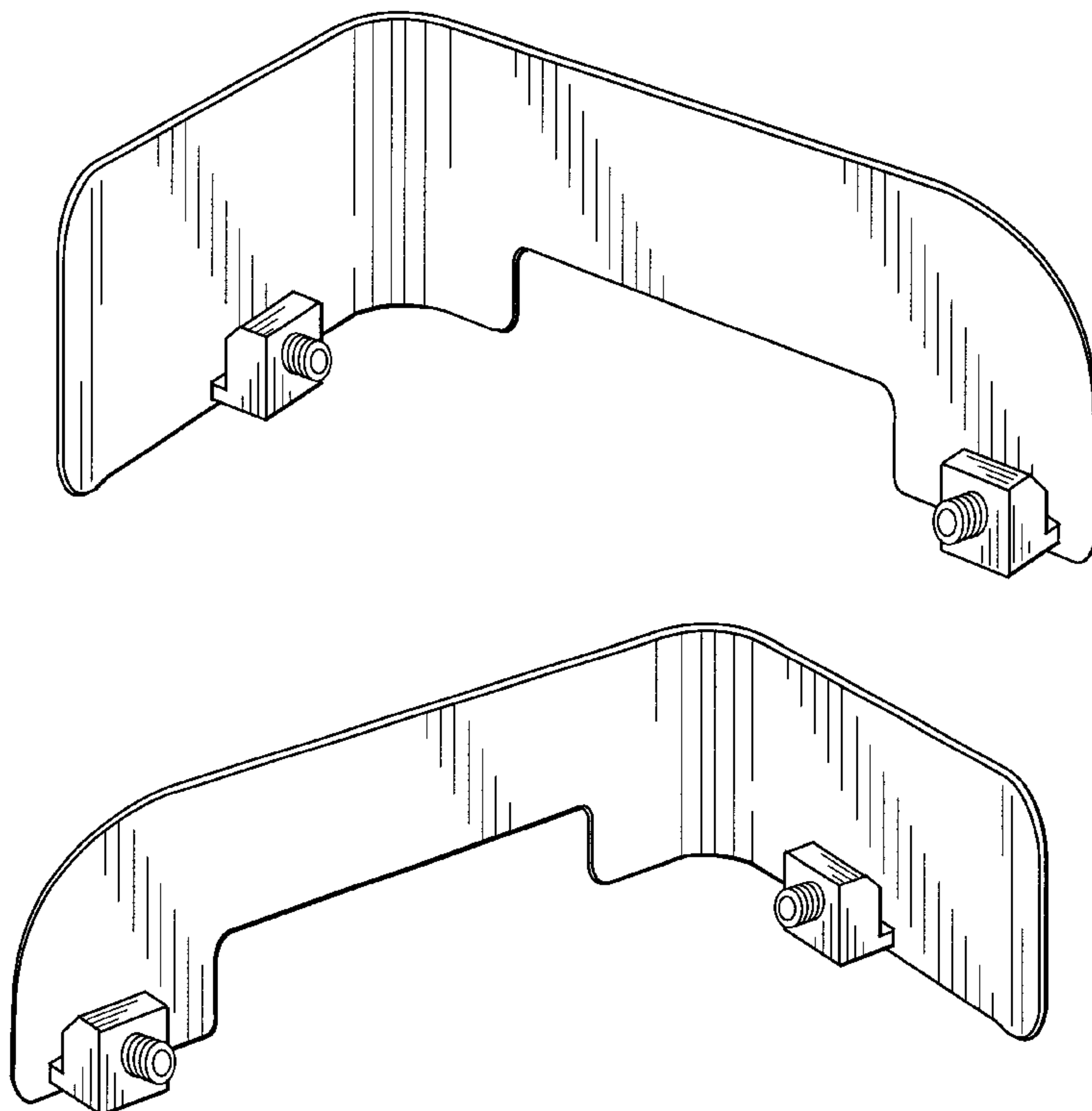
(57) **CLAIM**

as shown and described.

DESCRIPTION

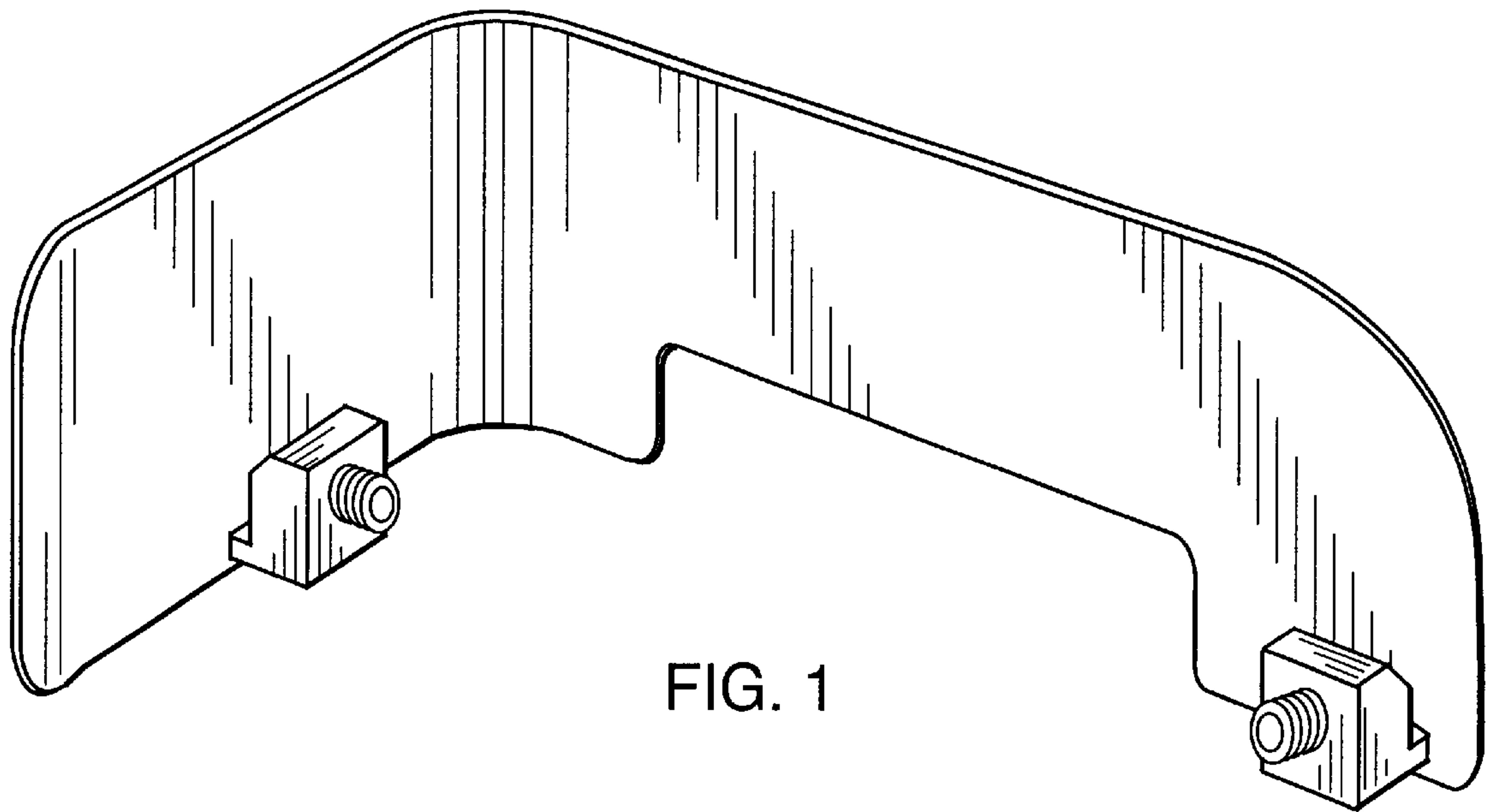

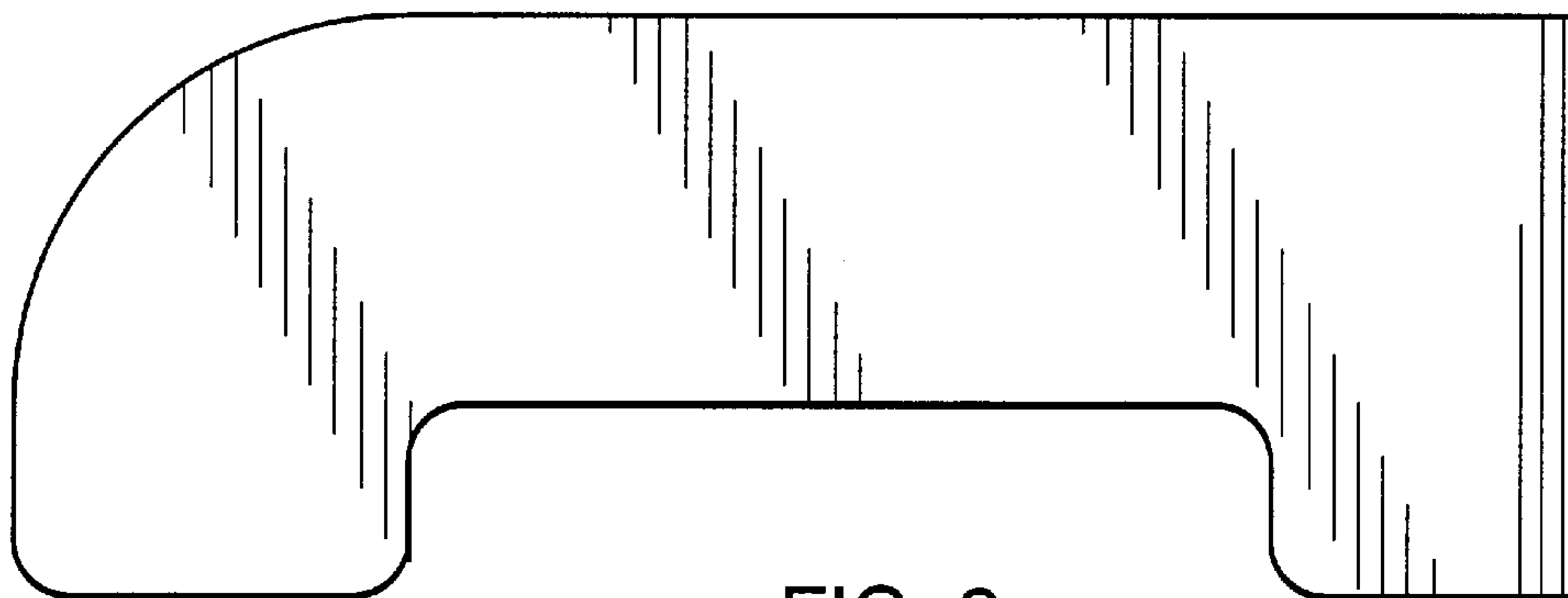

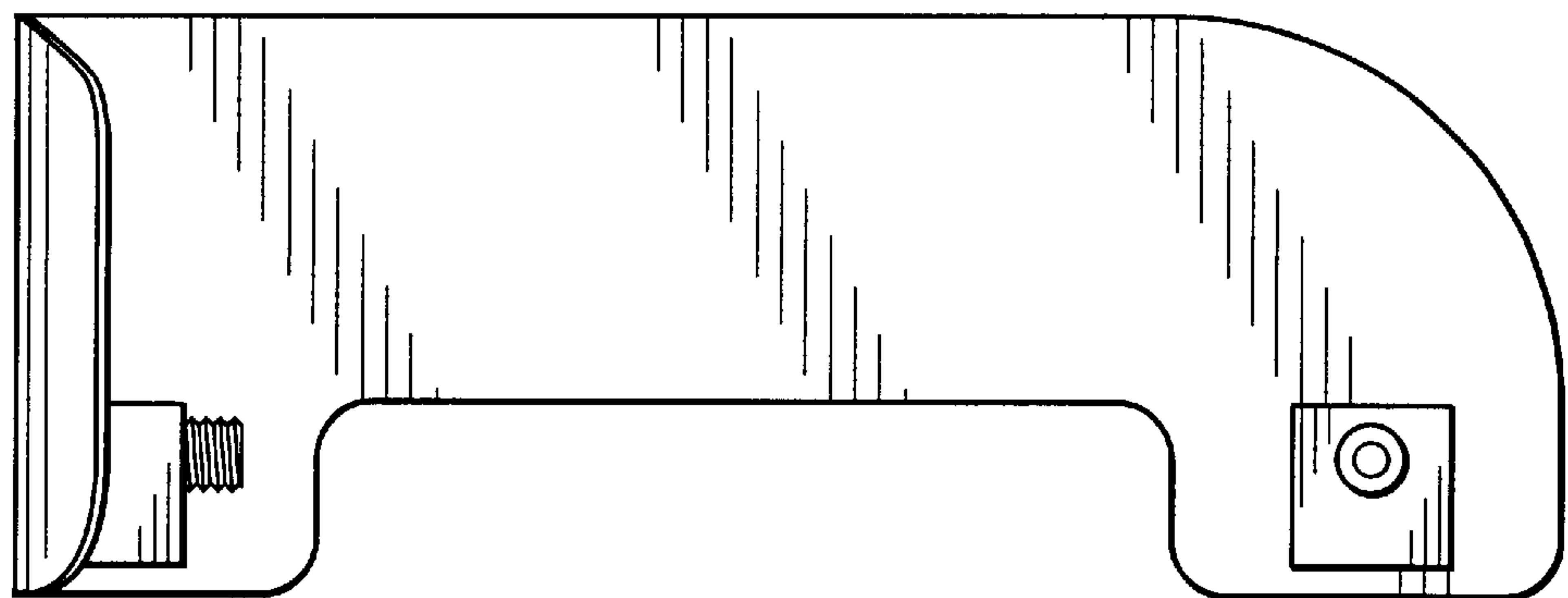

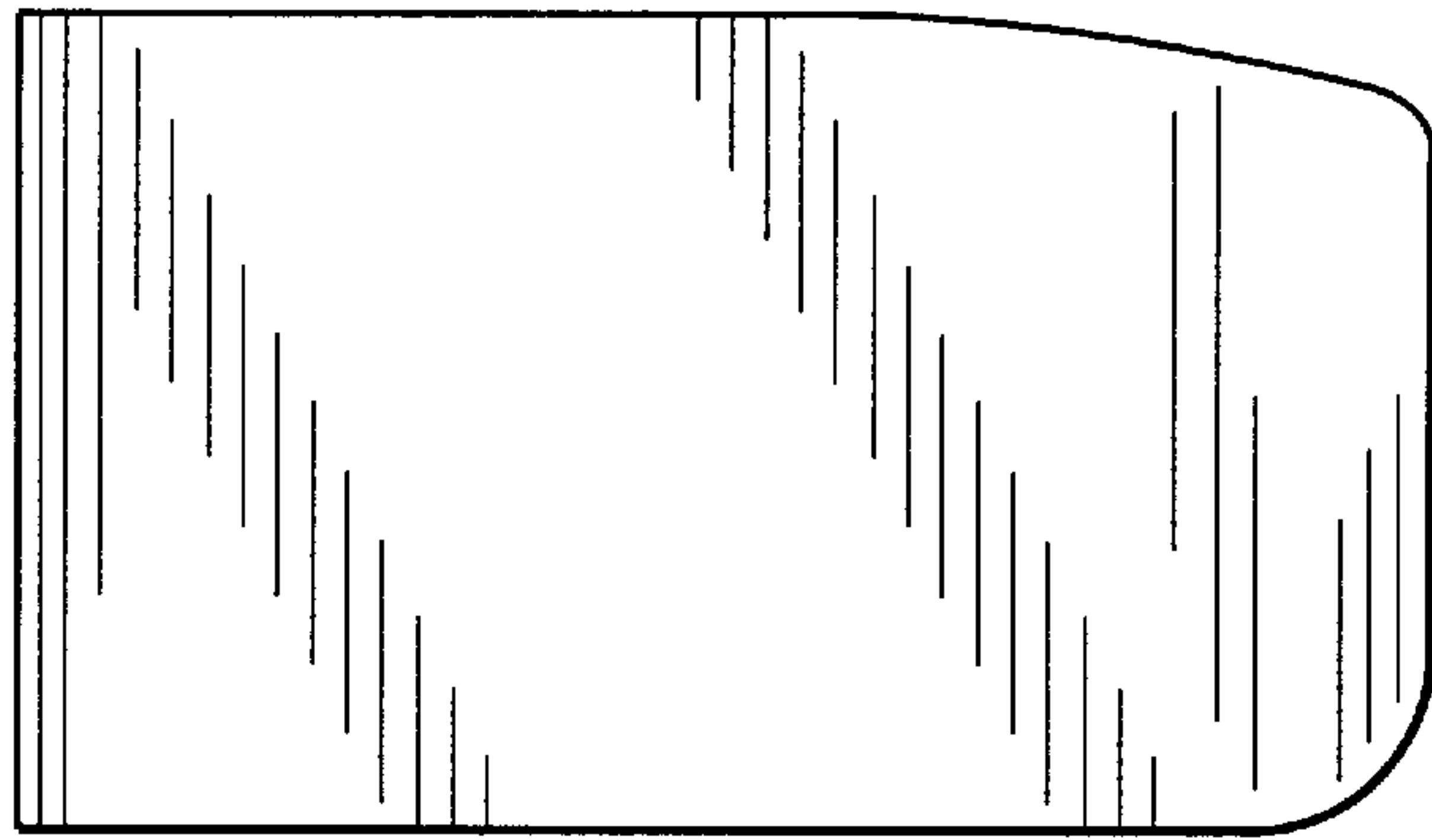

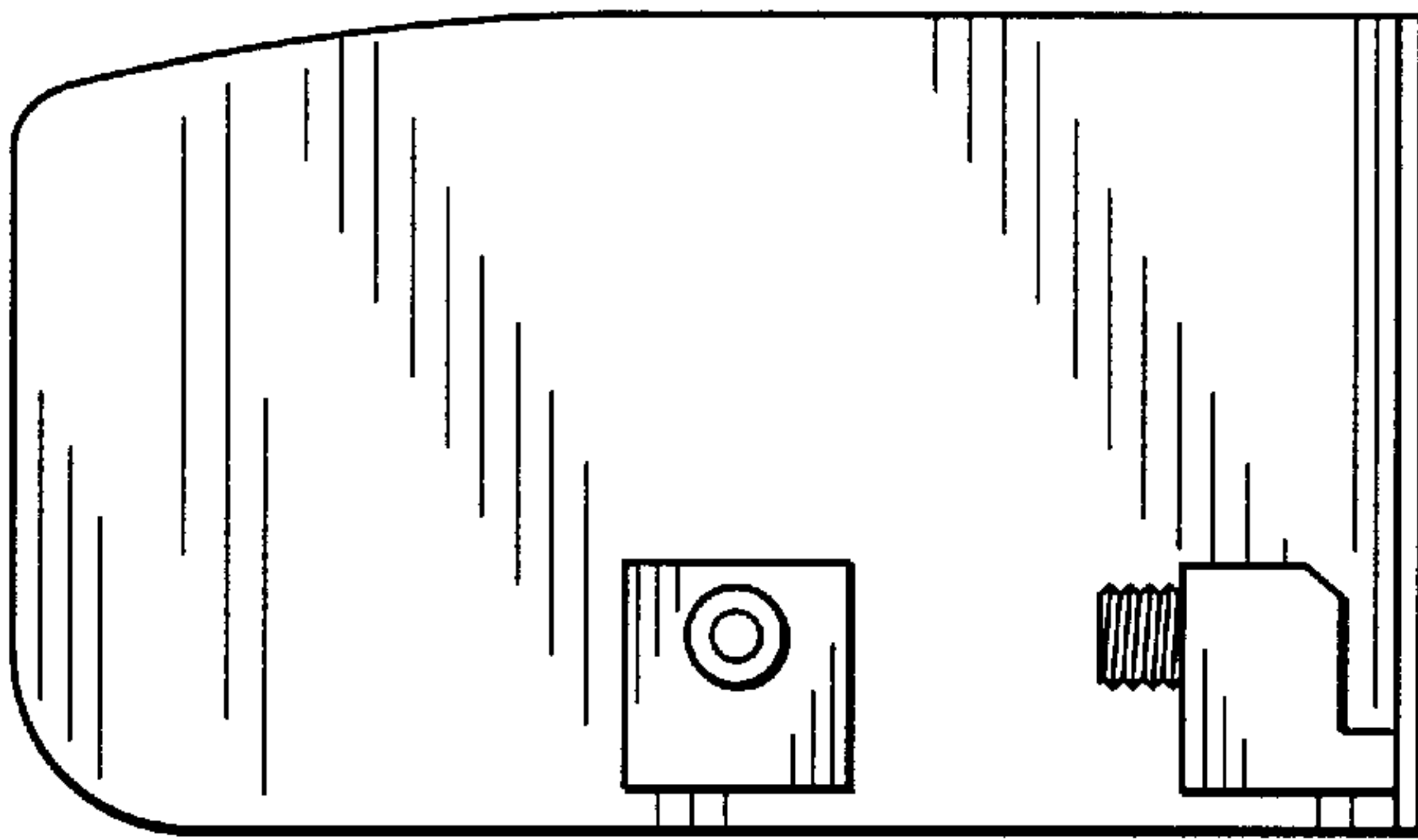

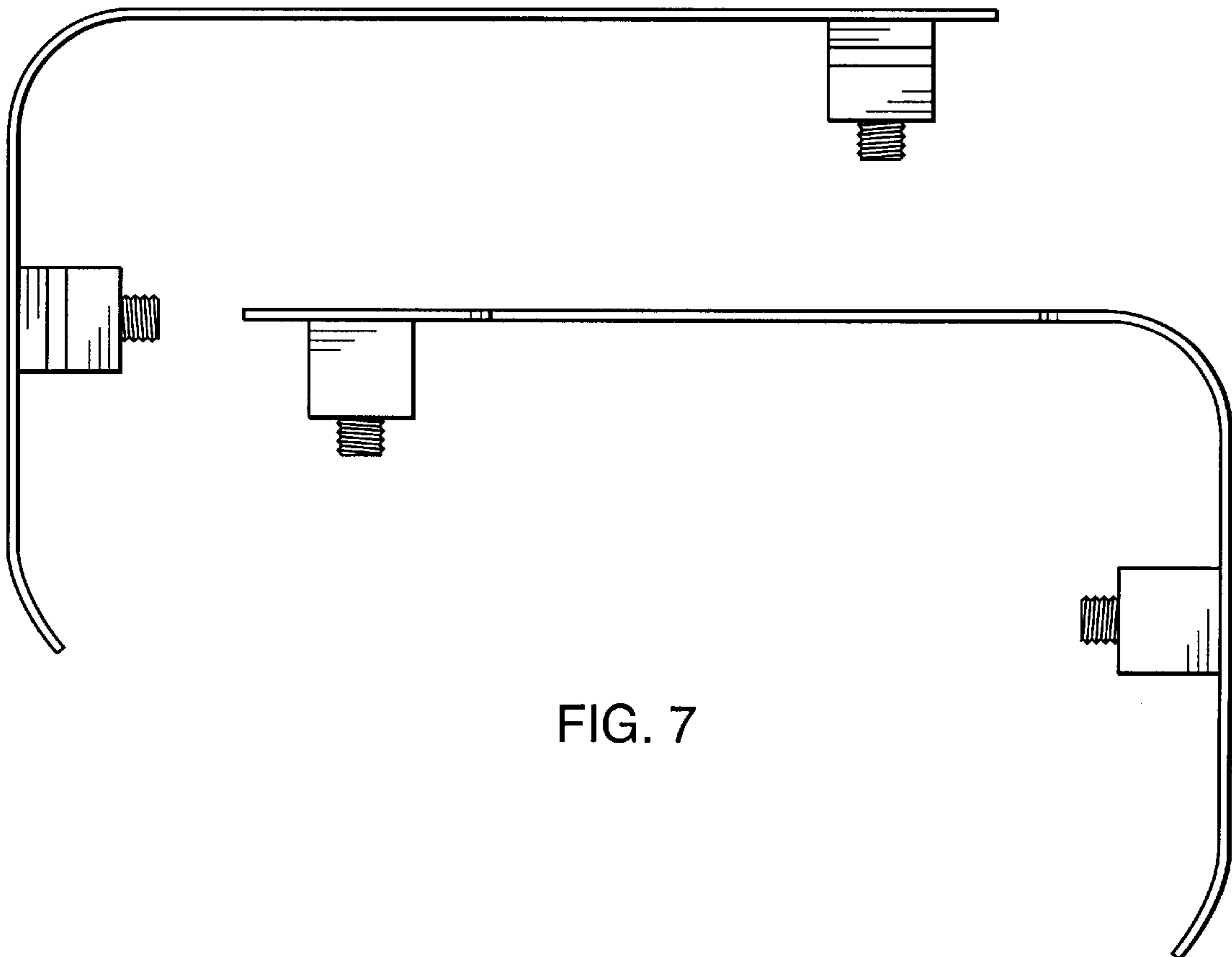

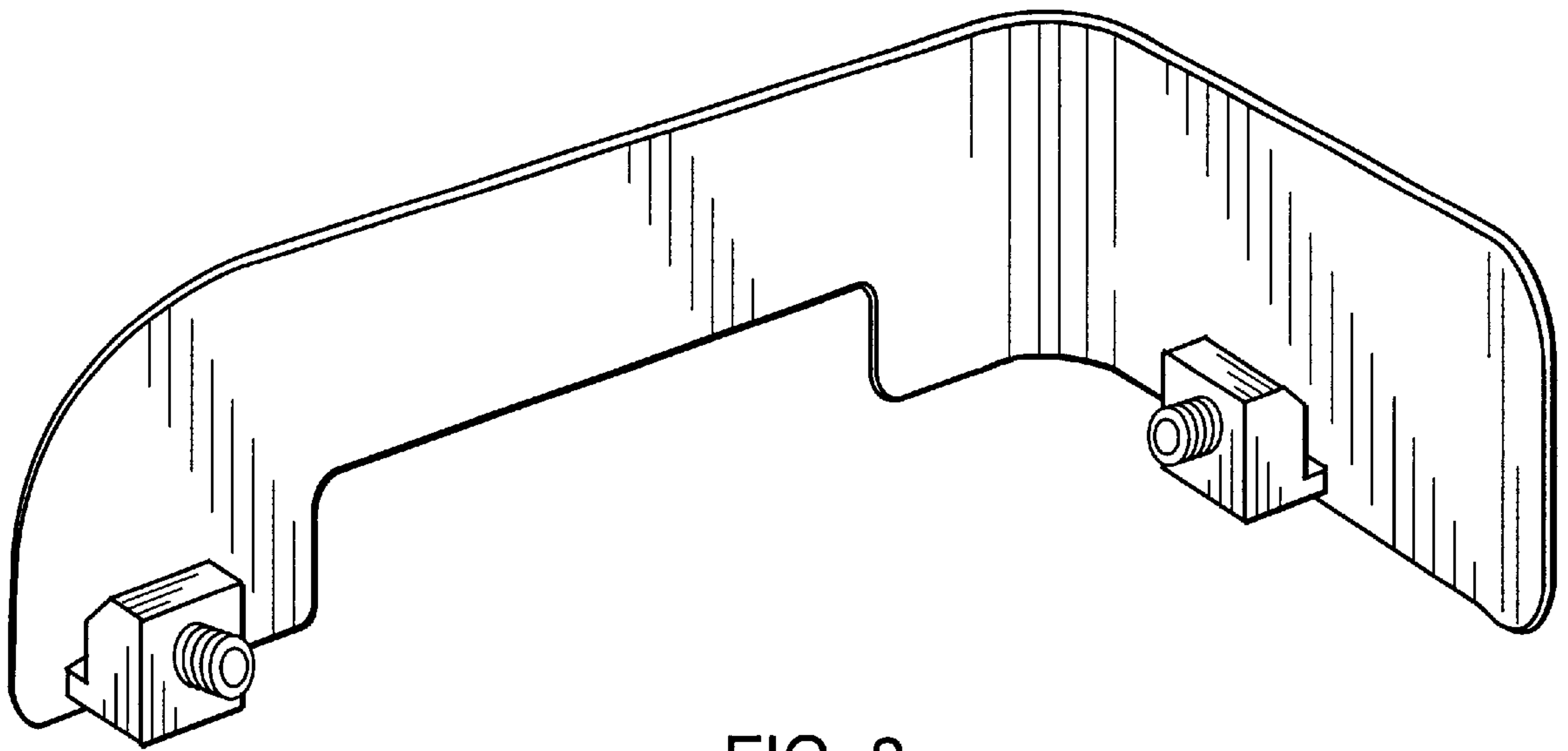

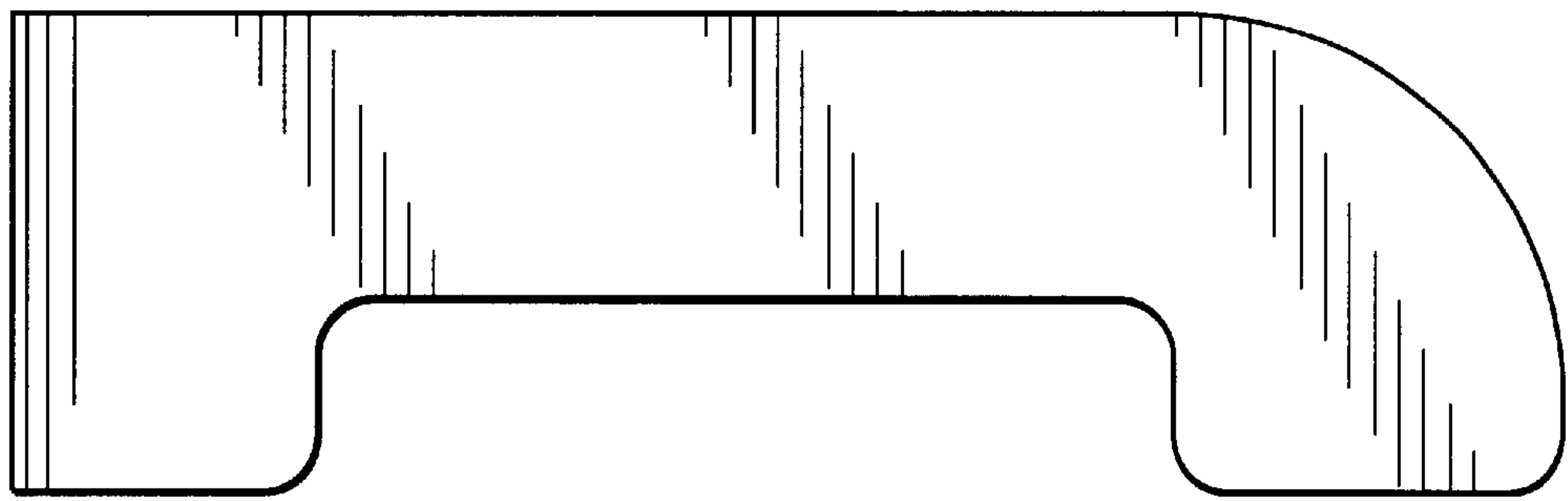

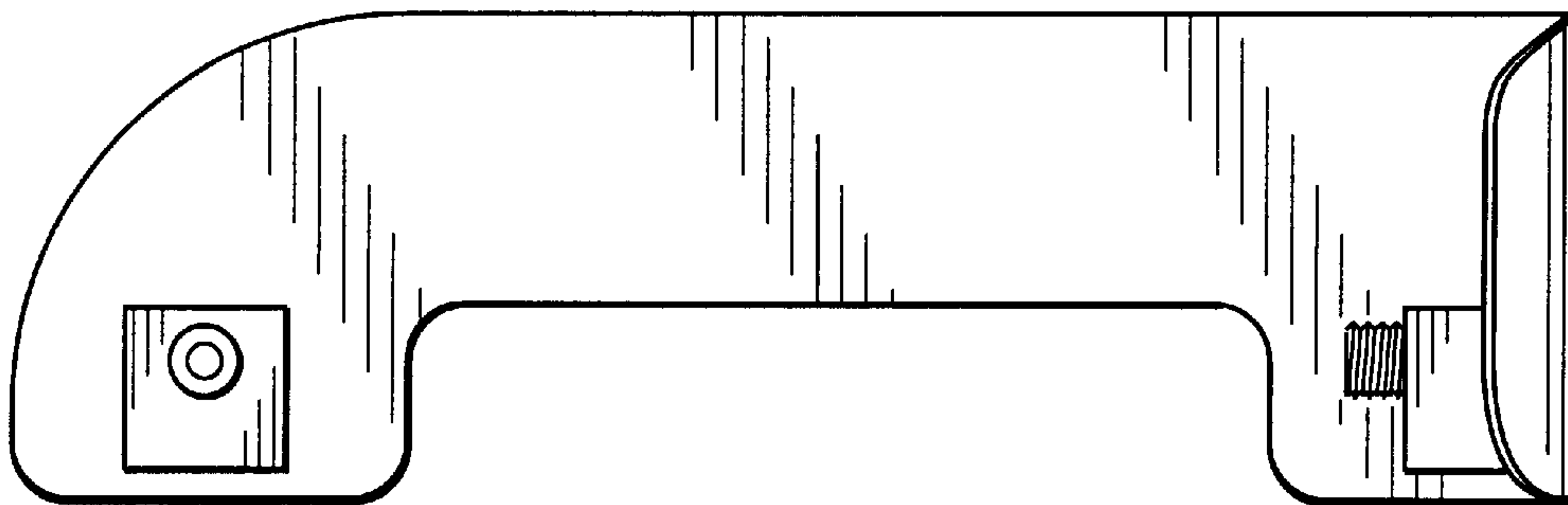

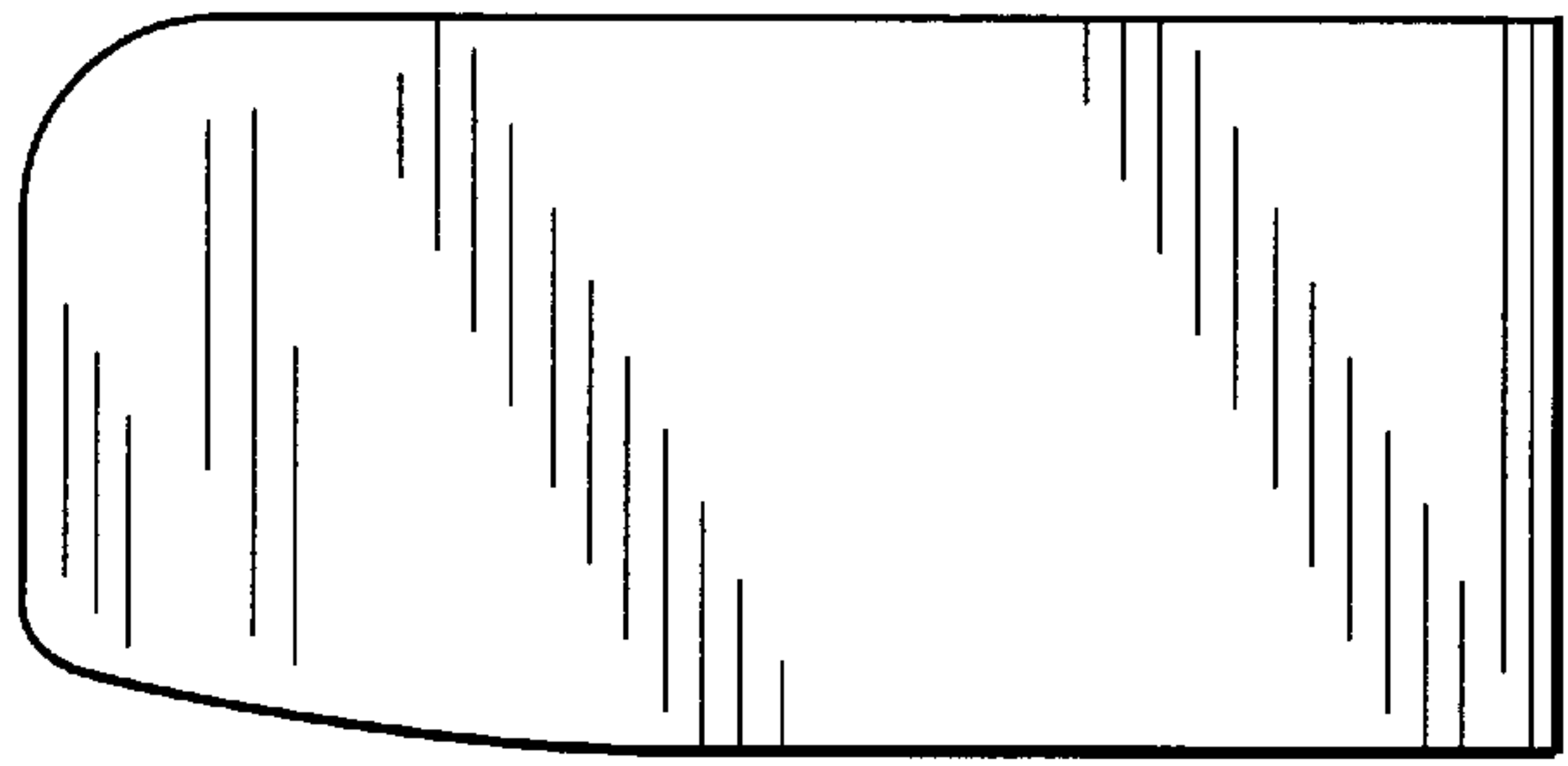

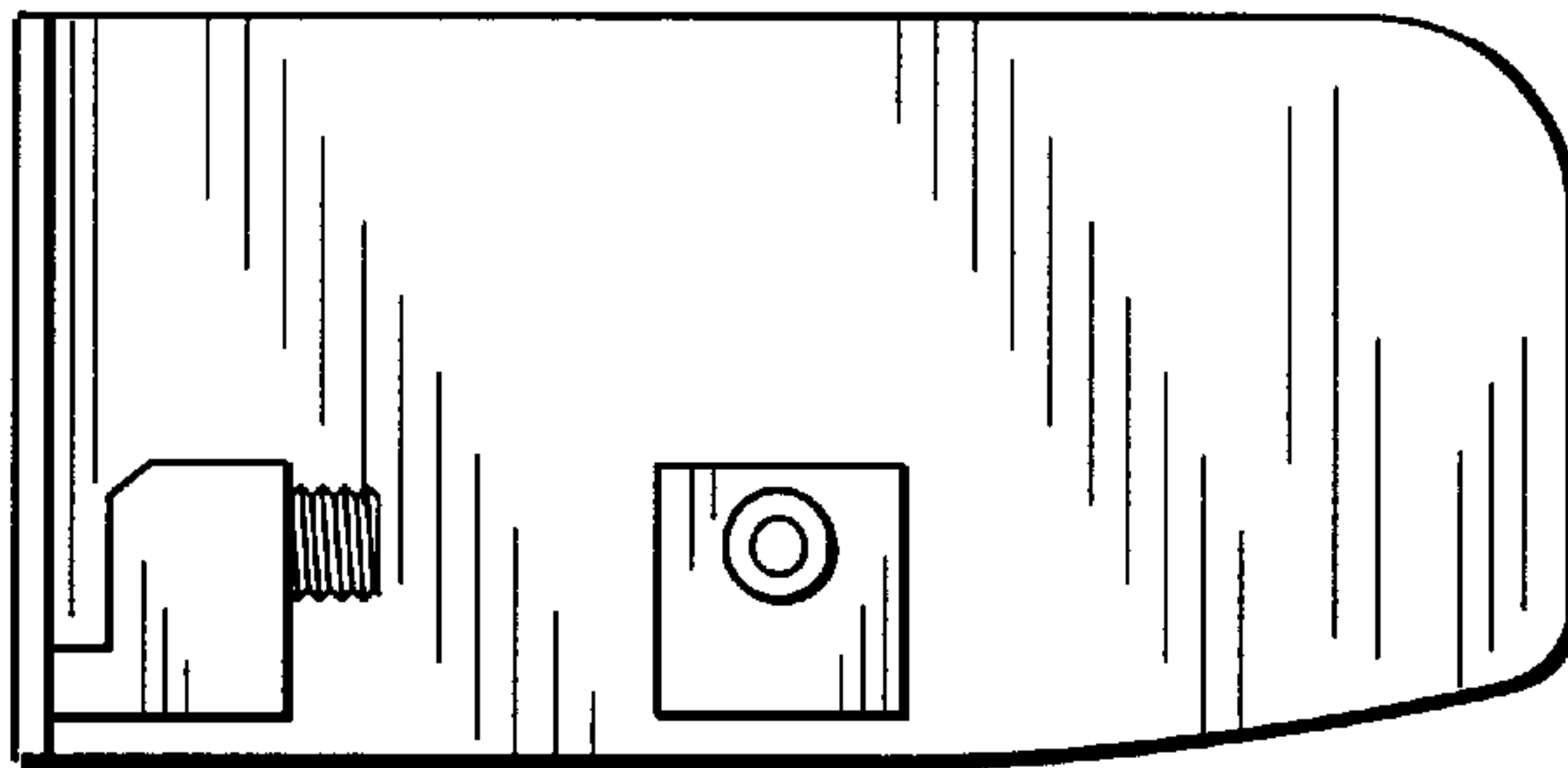

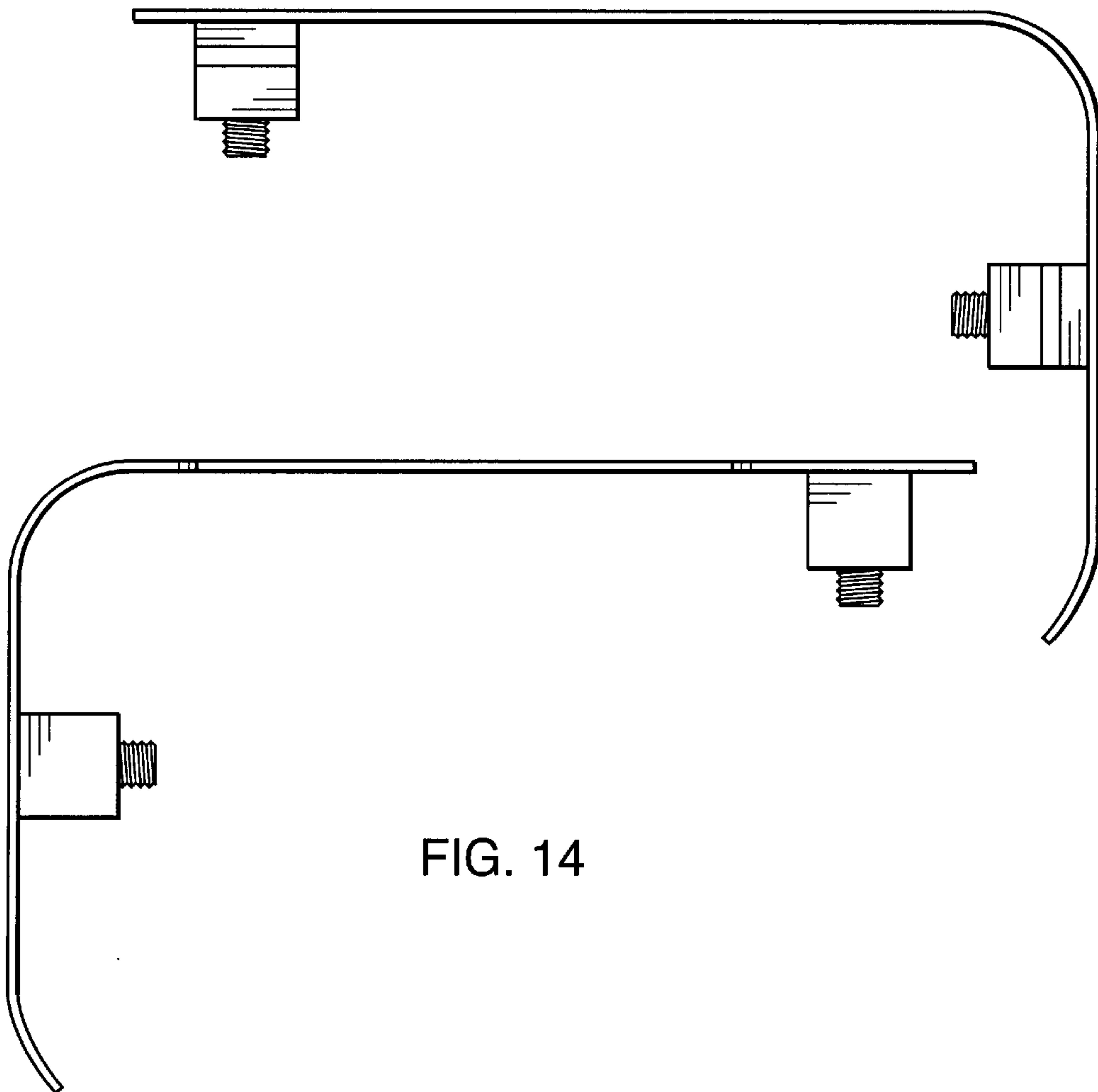
