(57) **CLAIM**

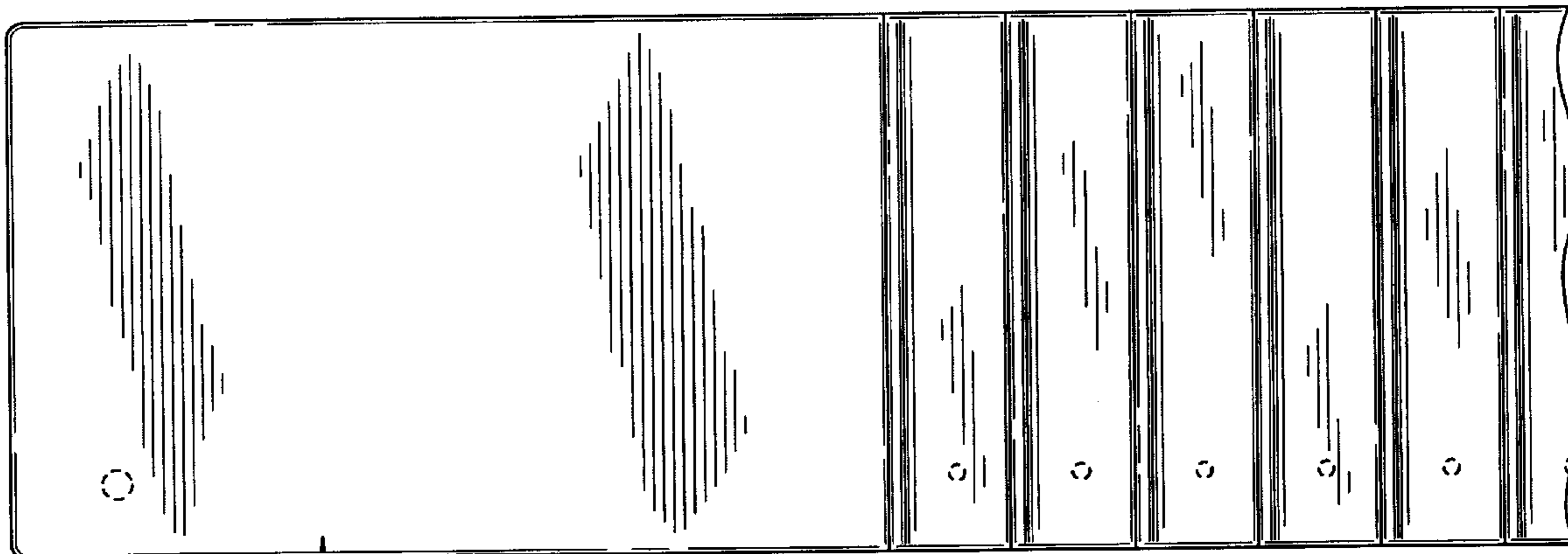
The ornamental design for a portion of an audio component face, as shown and described.

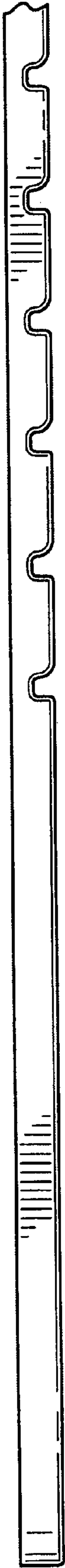

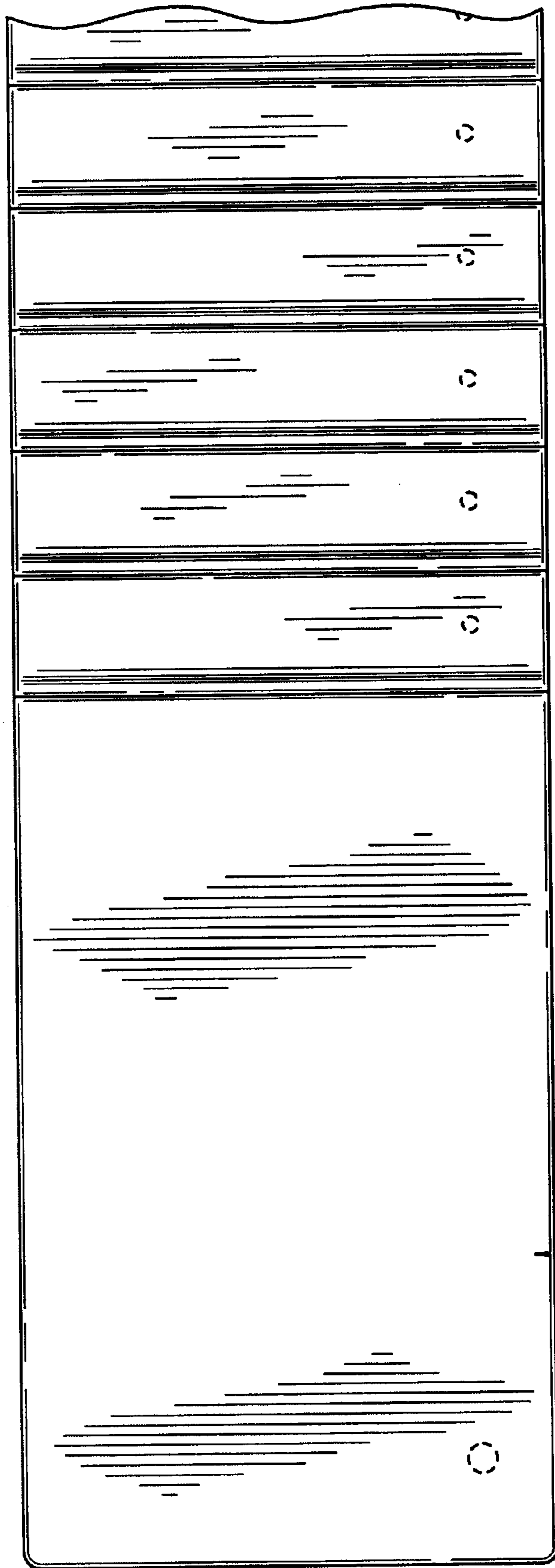
