FIG. 3 is a right side view thereof with cover;

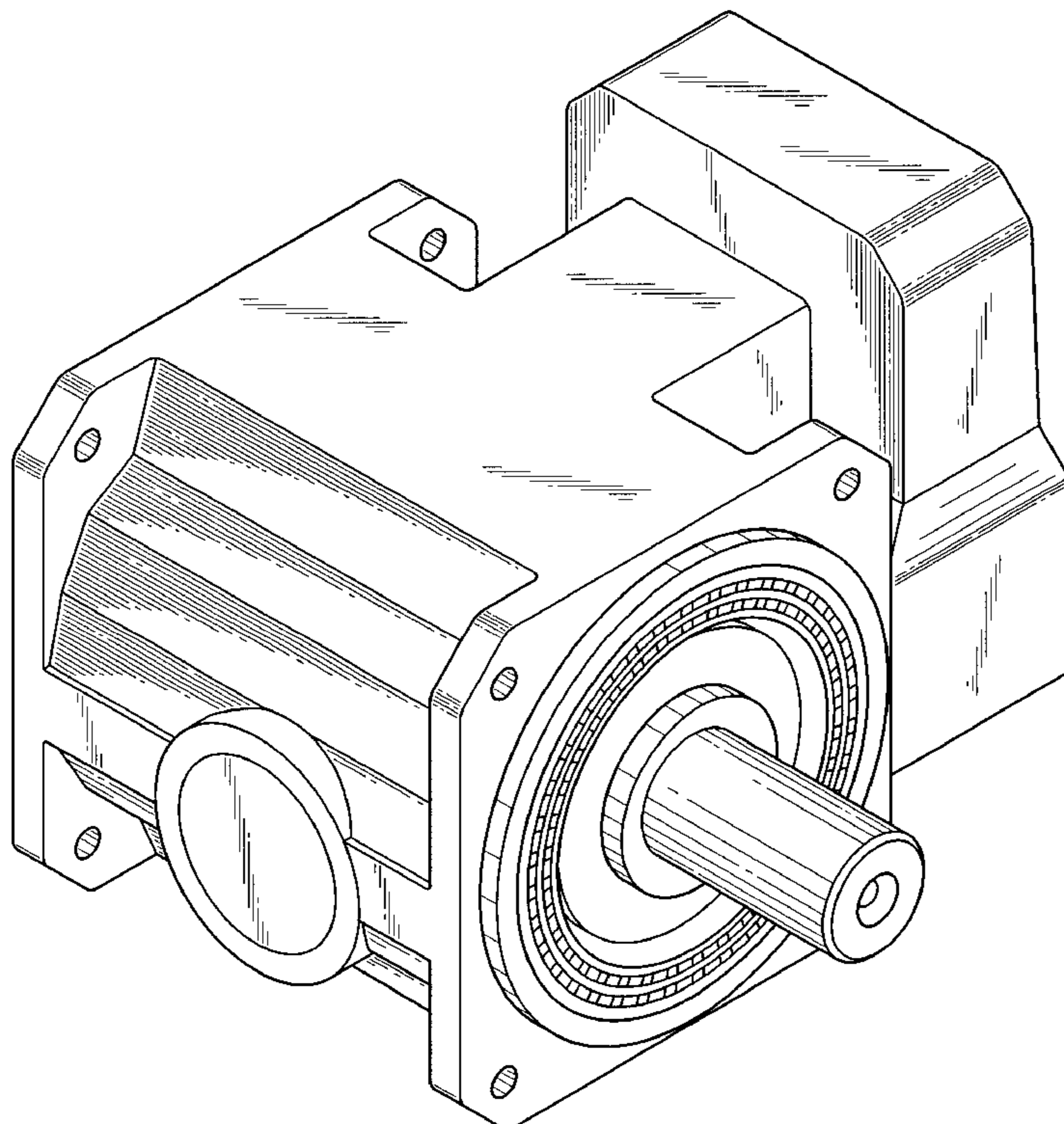
FIG. 4 is a left side view thereof with small cover;

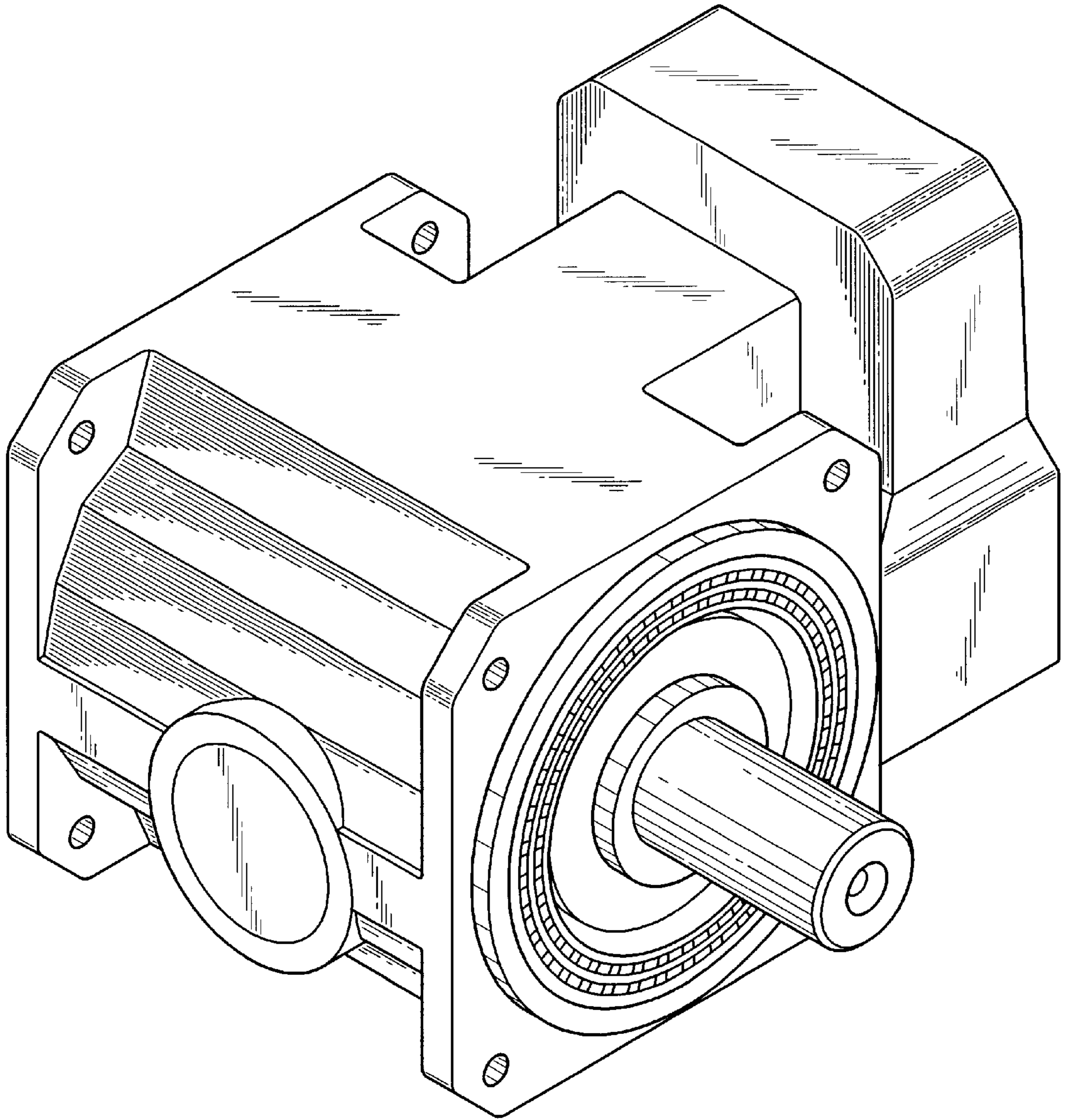

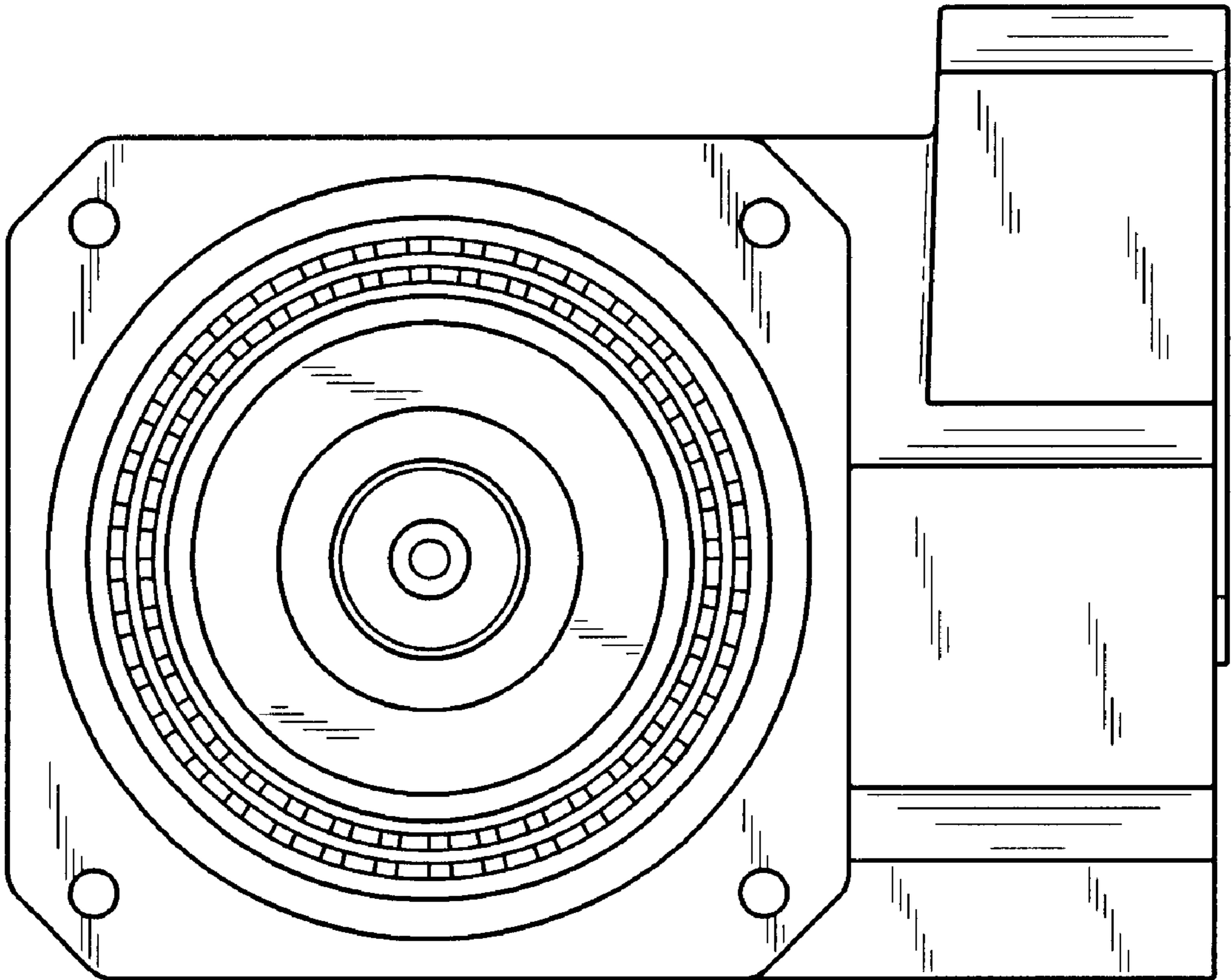

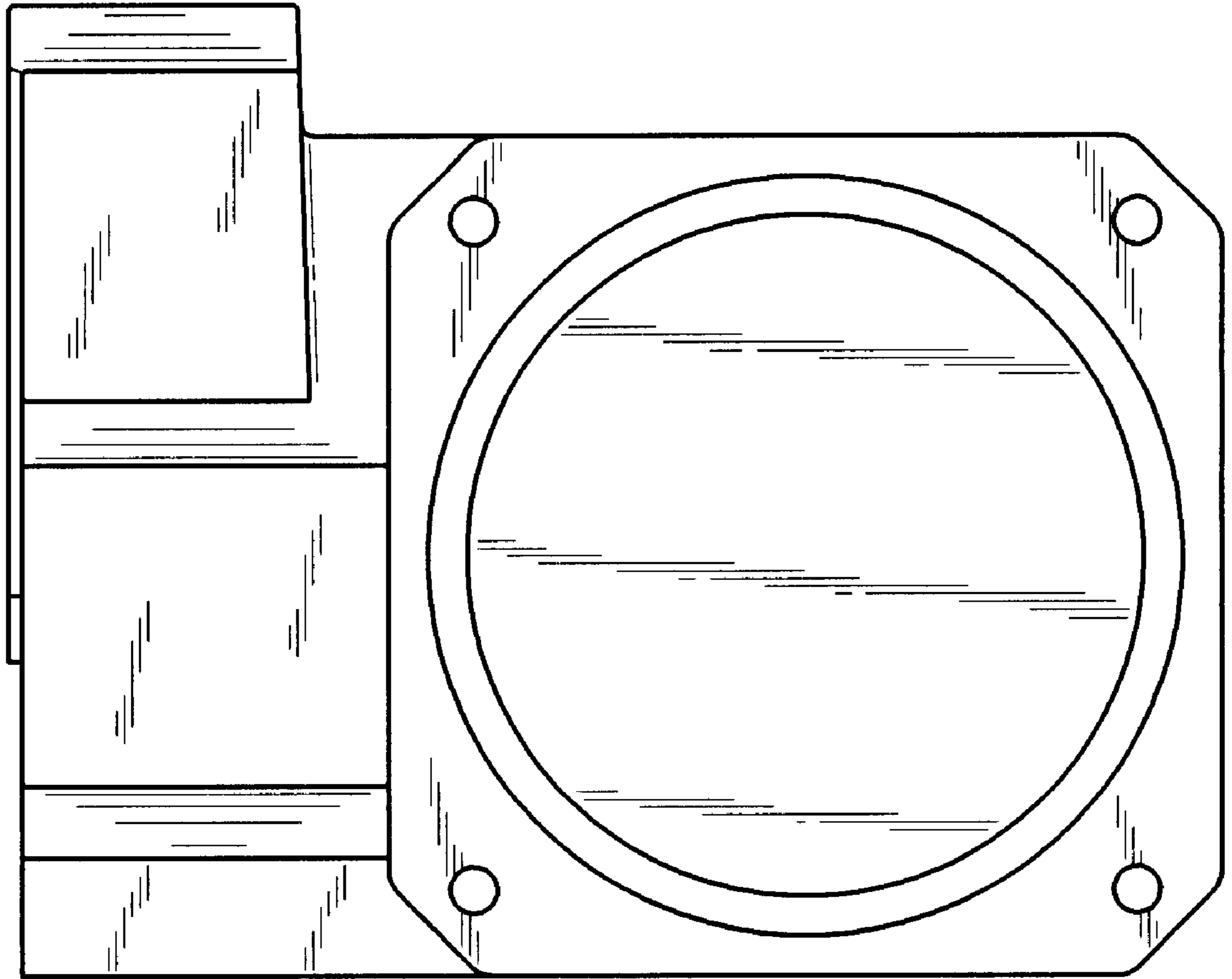

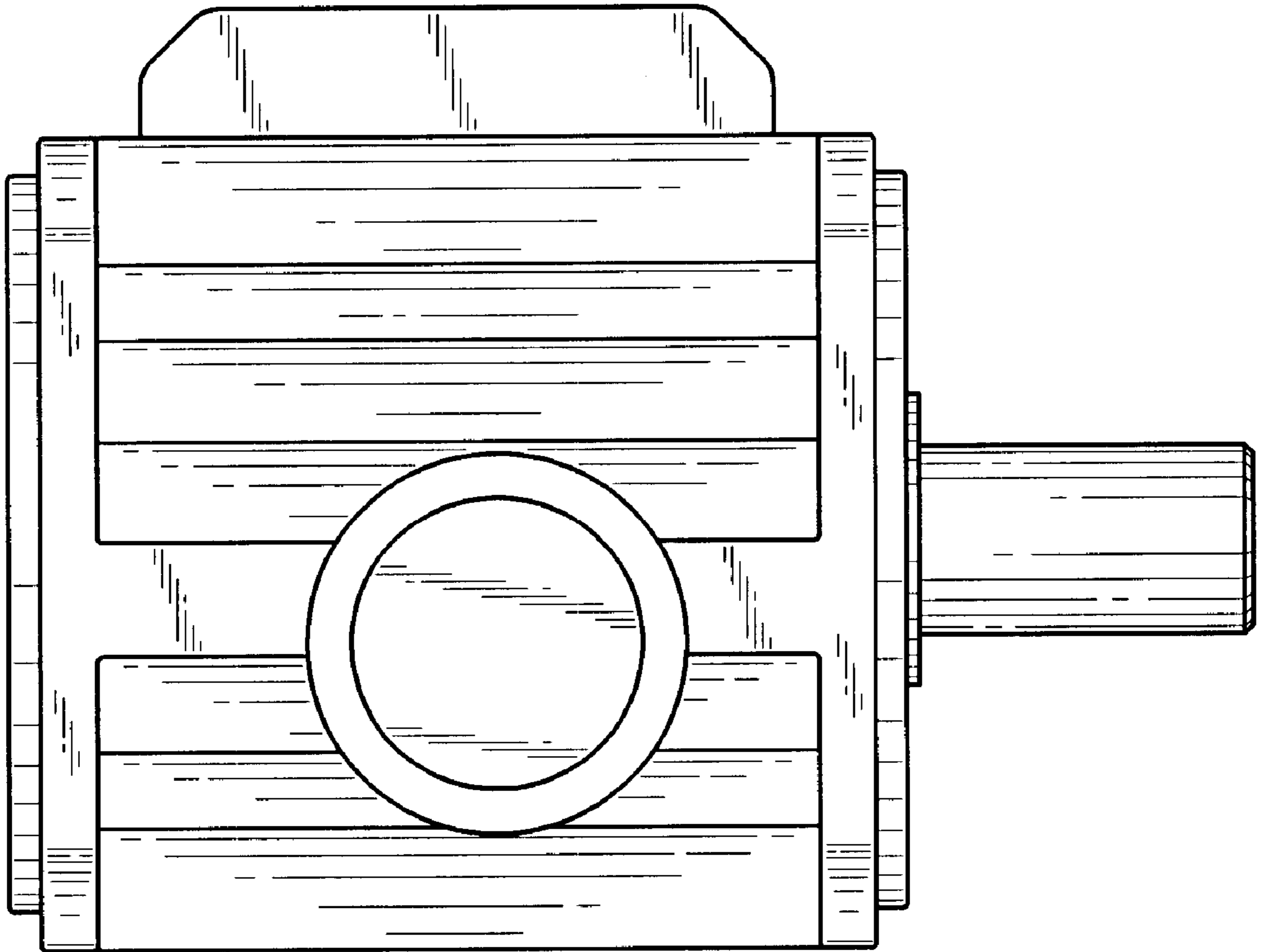

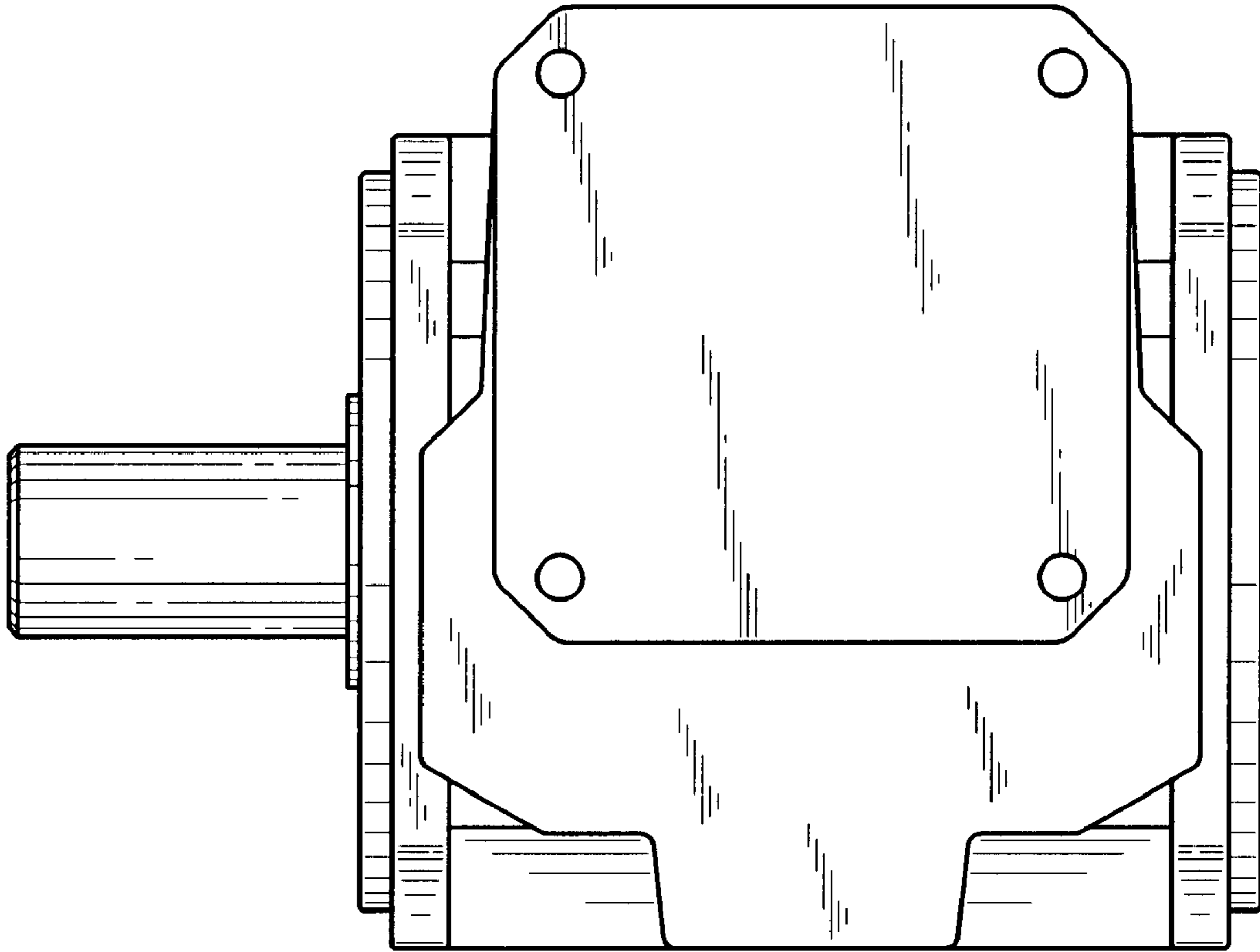

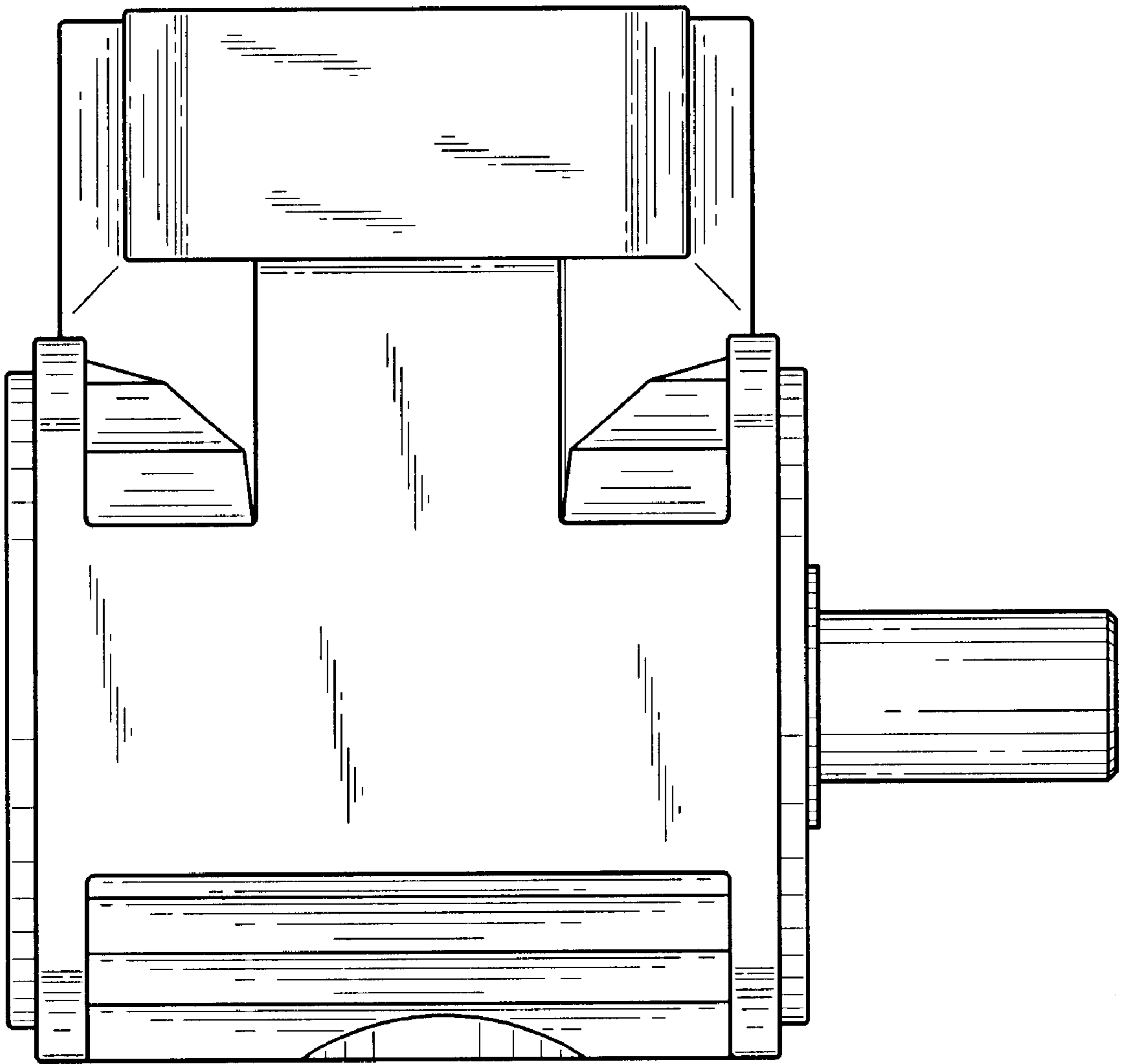

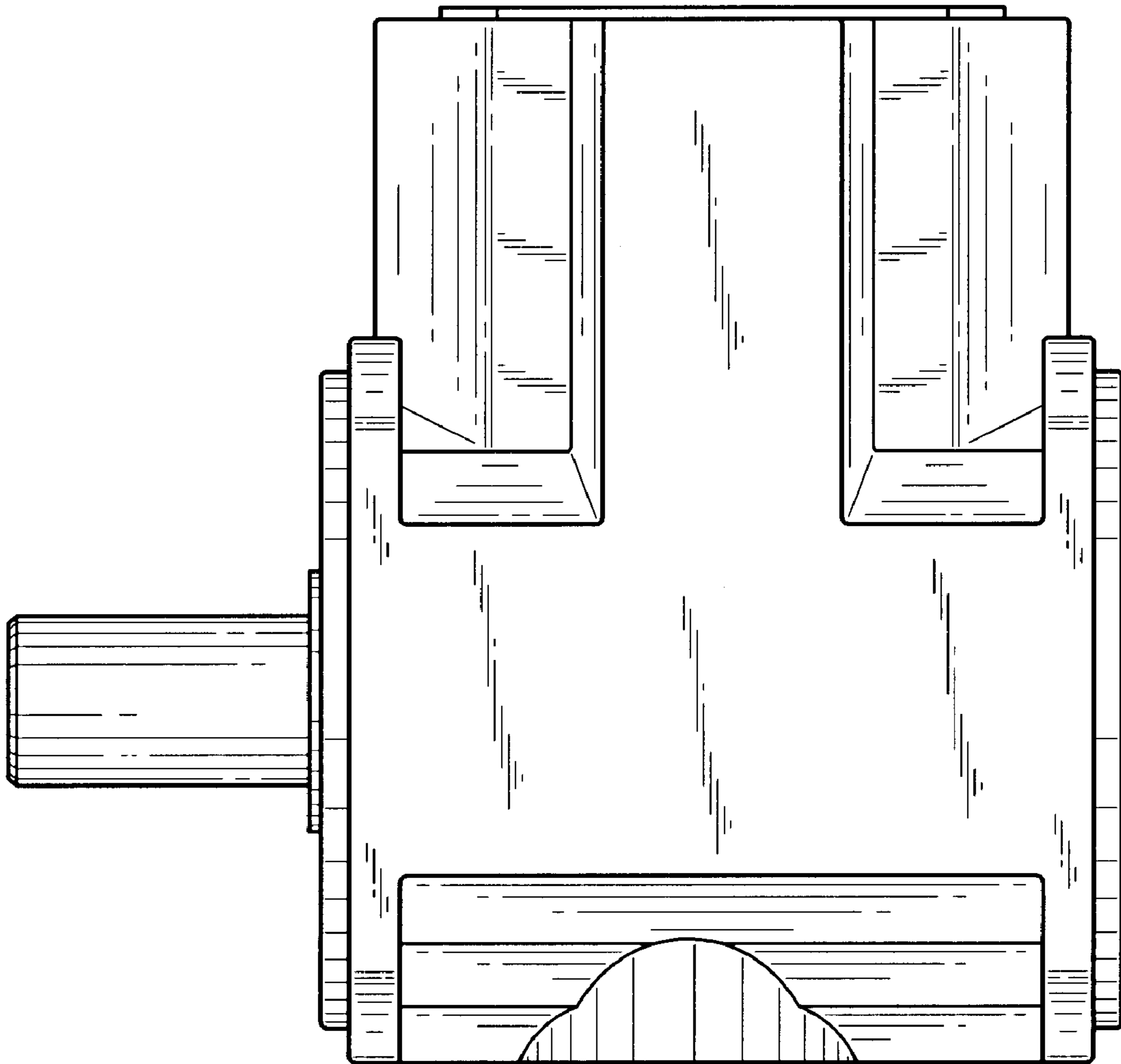
