FIG. 7 is a top view of the surface configuration of a scooter according to our novel design.

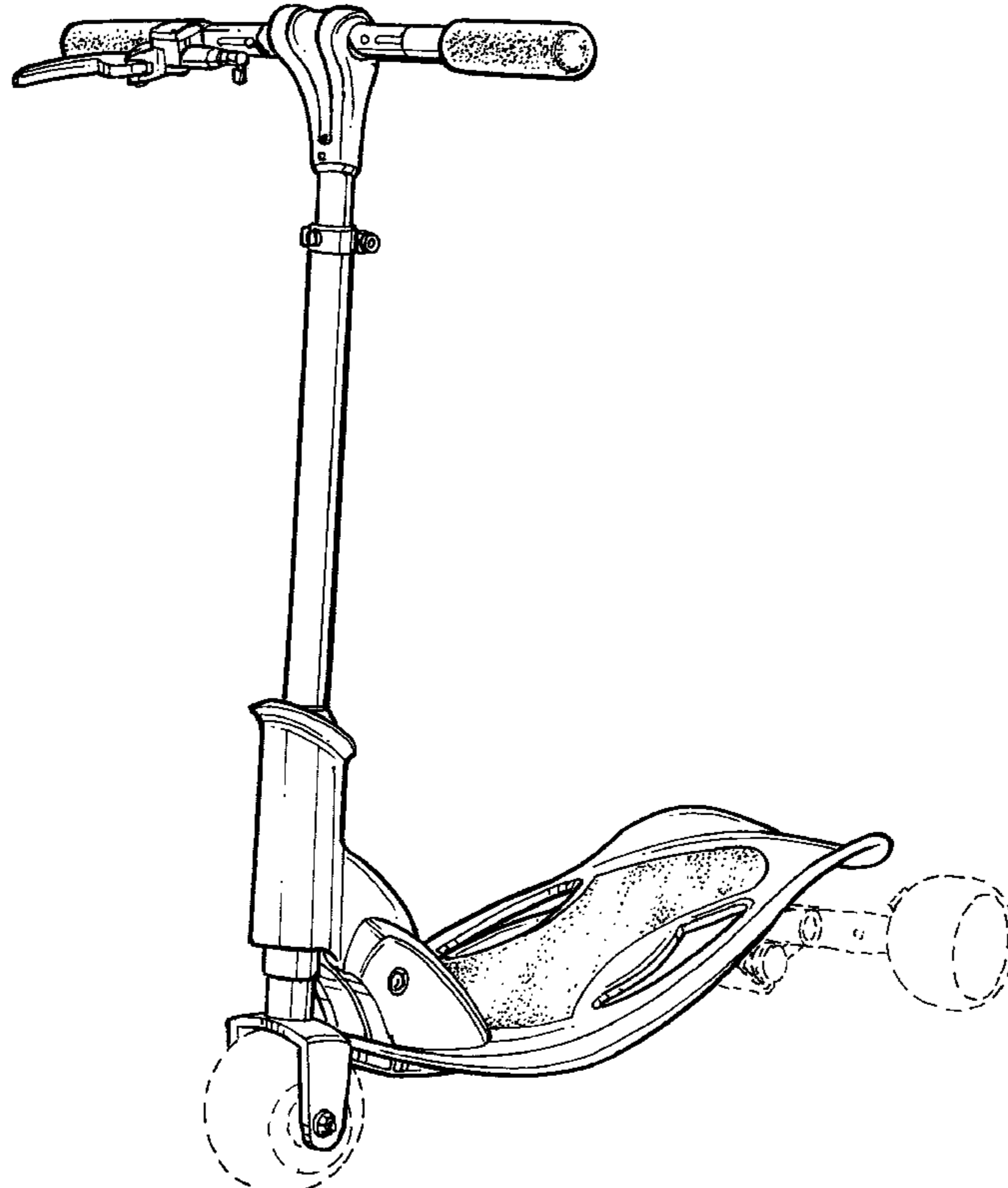

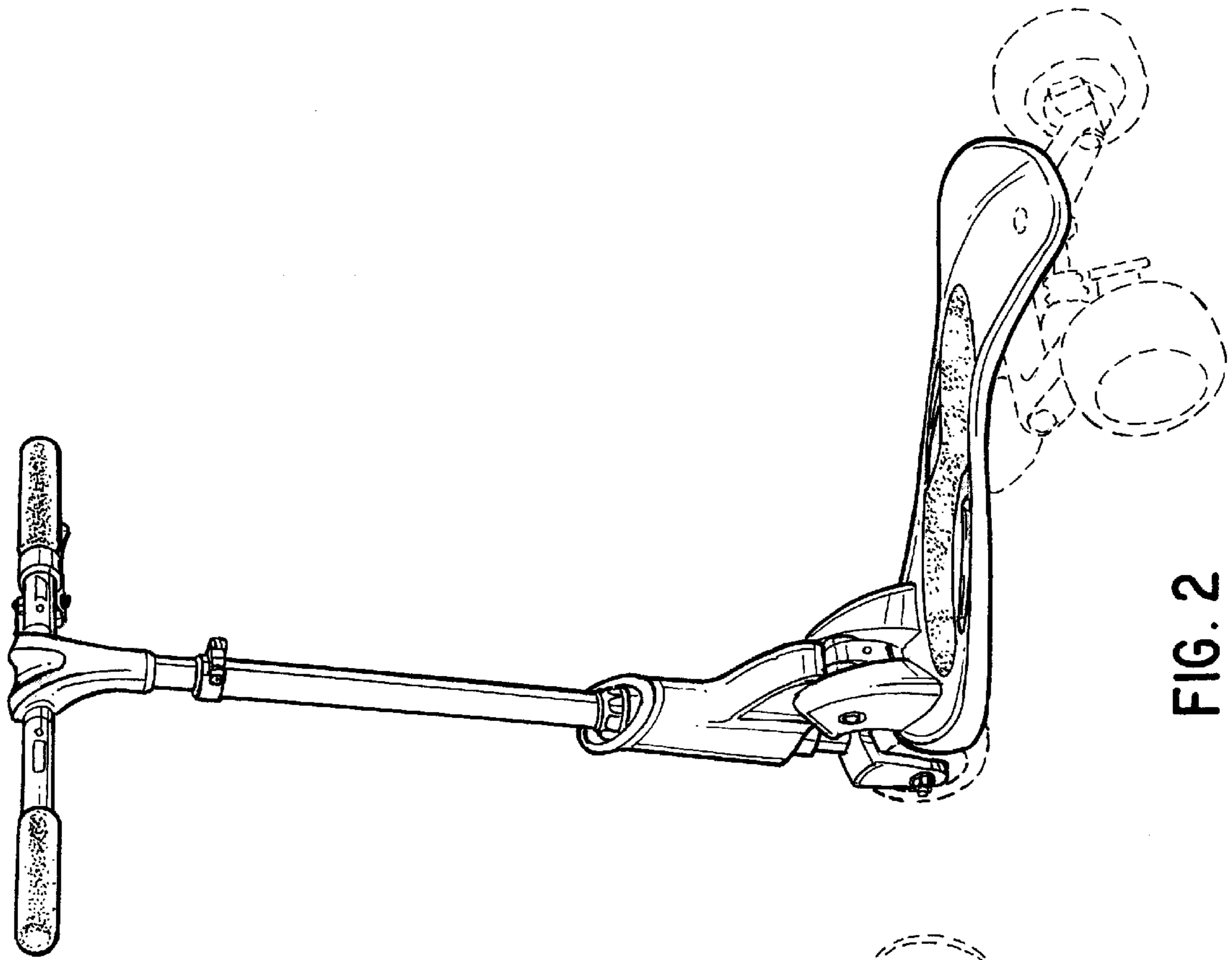

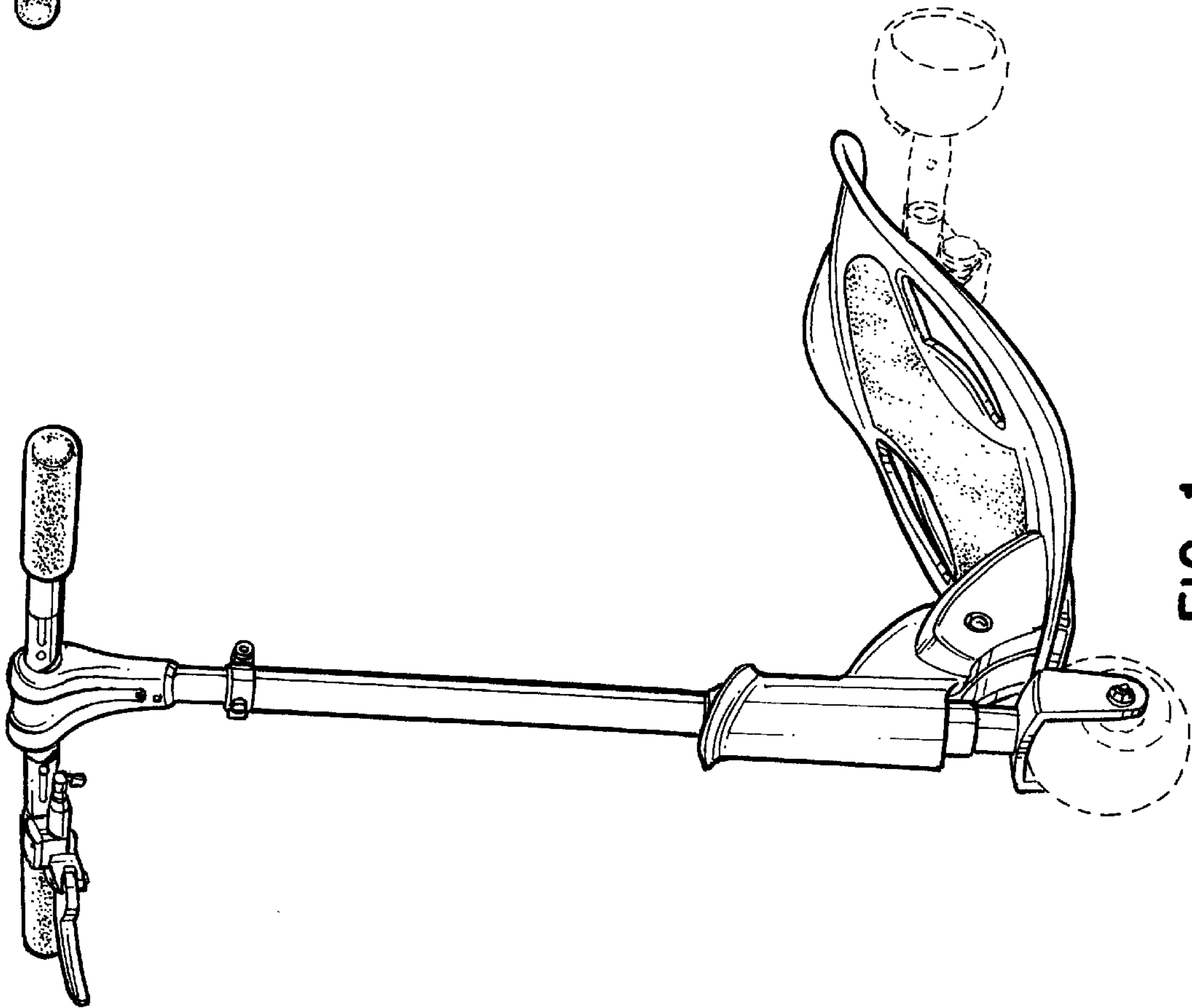

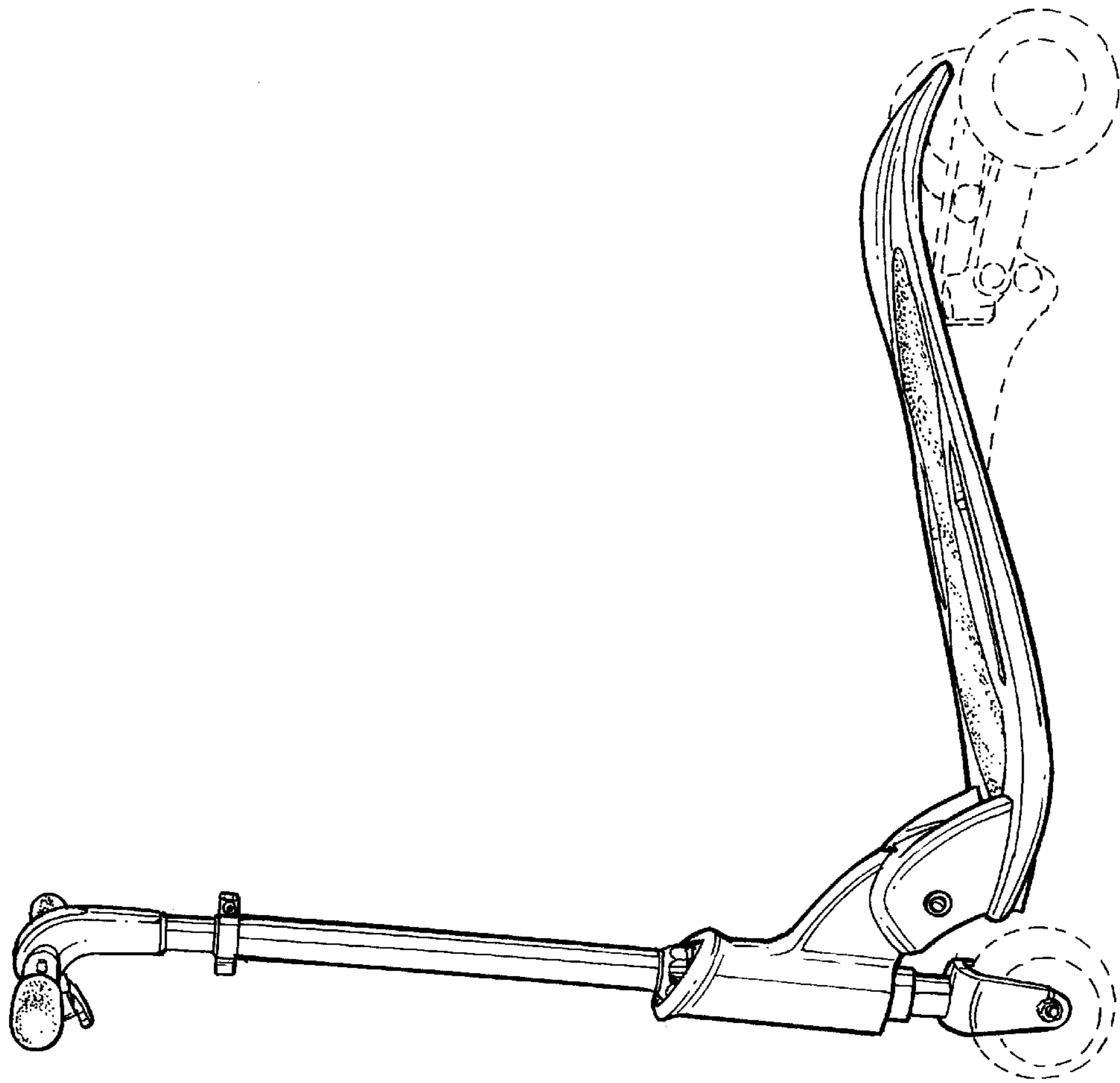

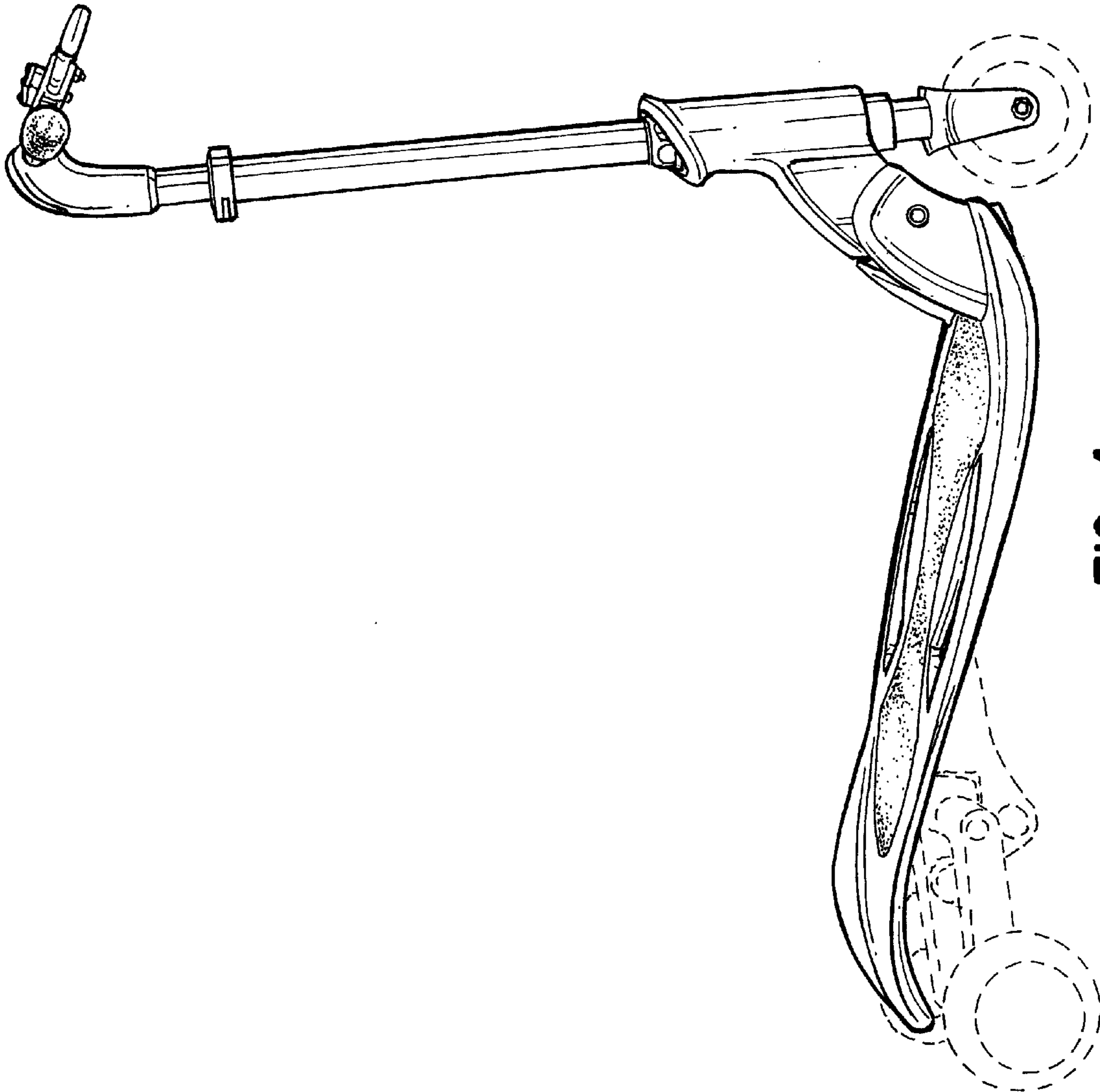

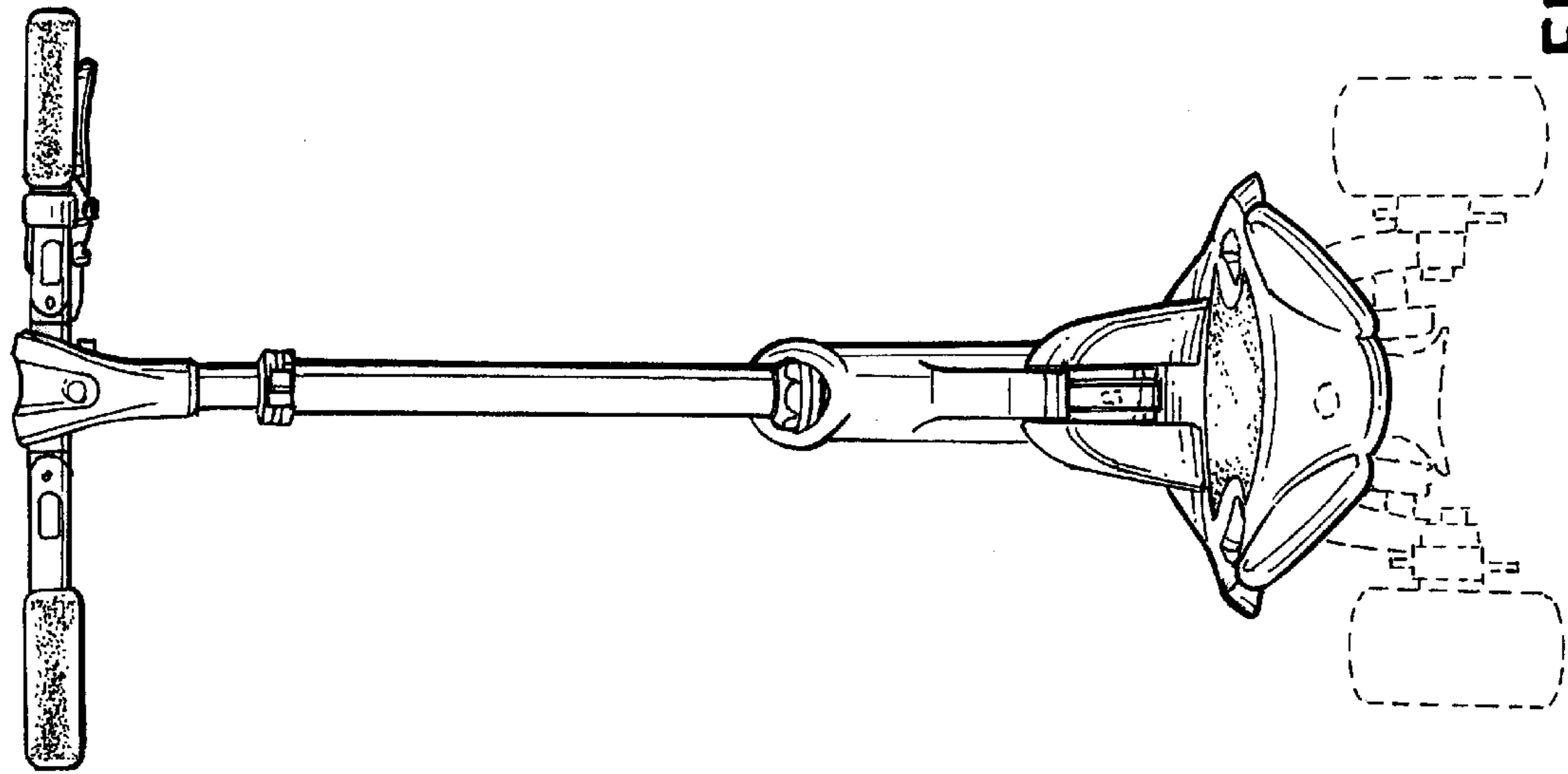

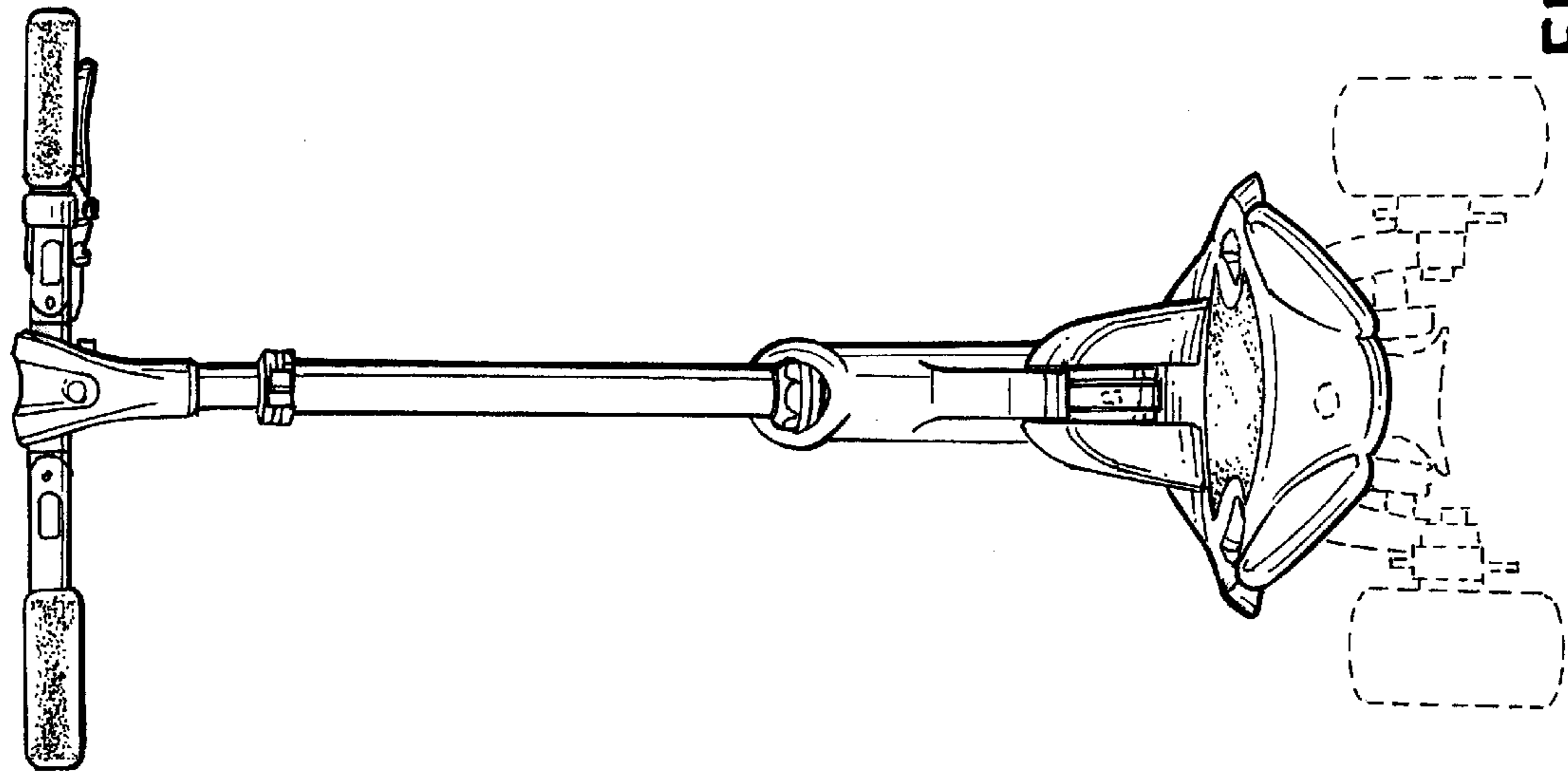

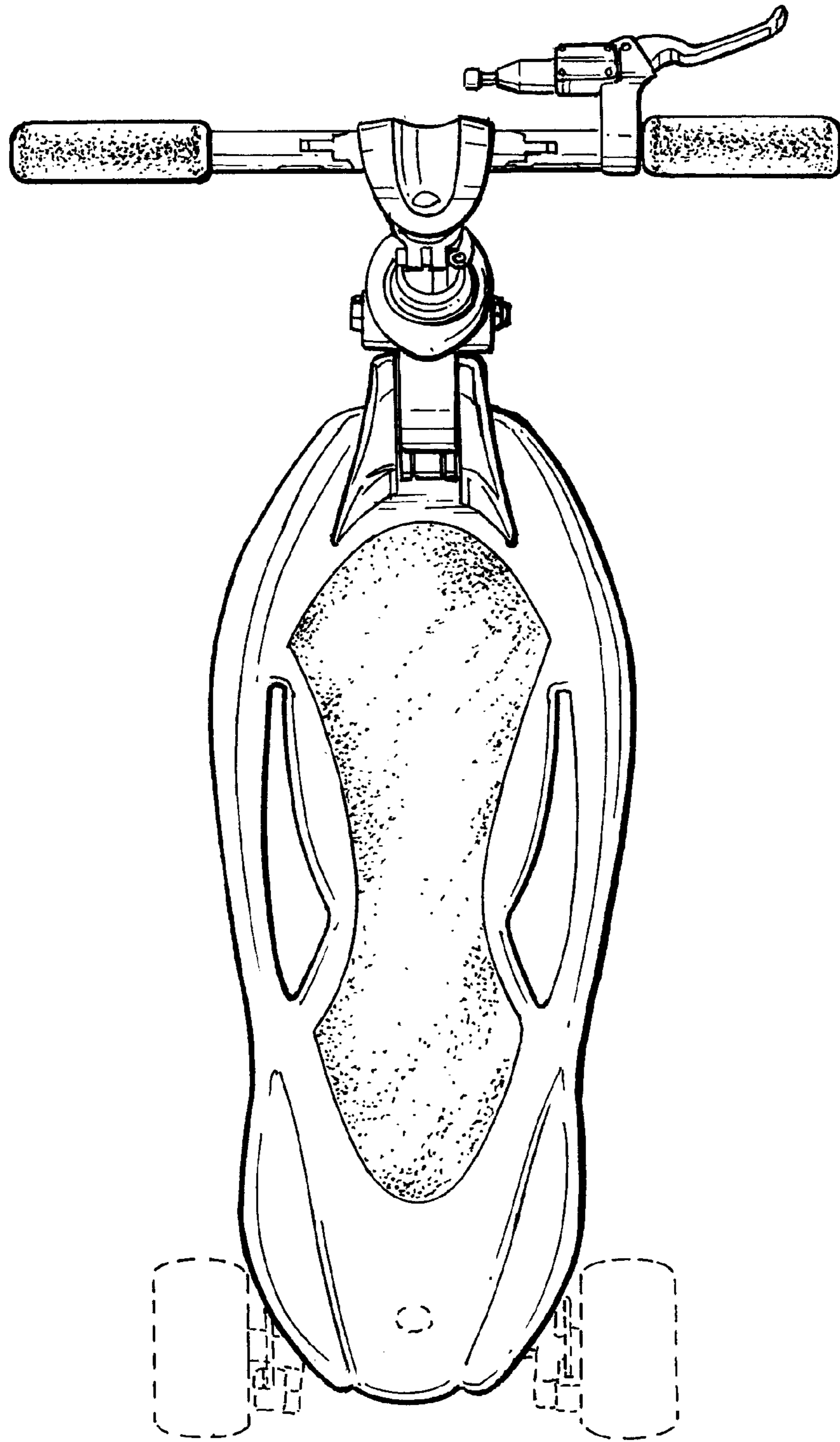
