FIG. 2 is a bottom rear perspective view thereof in a partially rotated position;

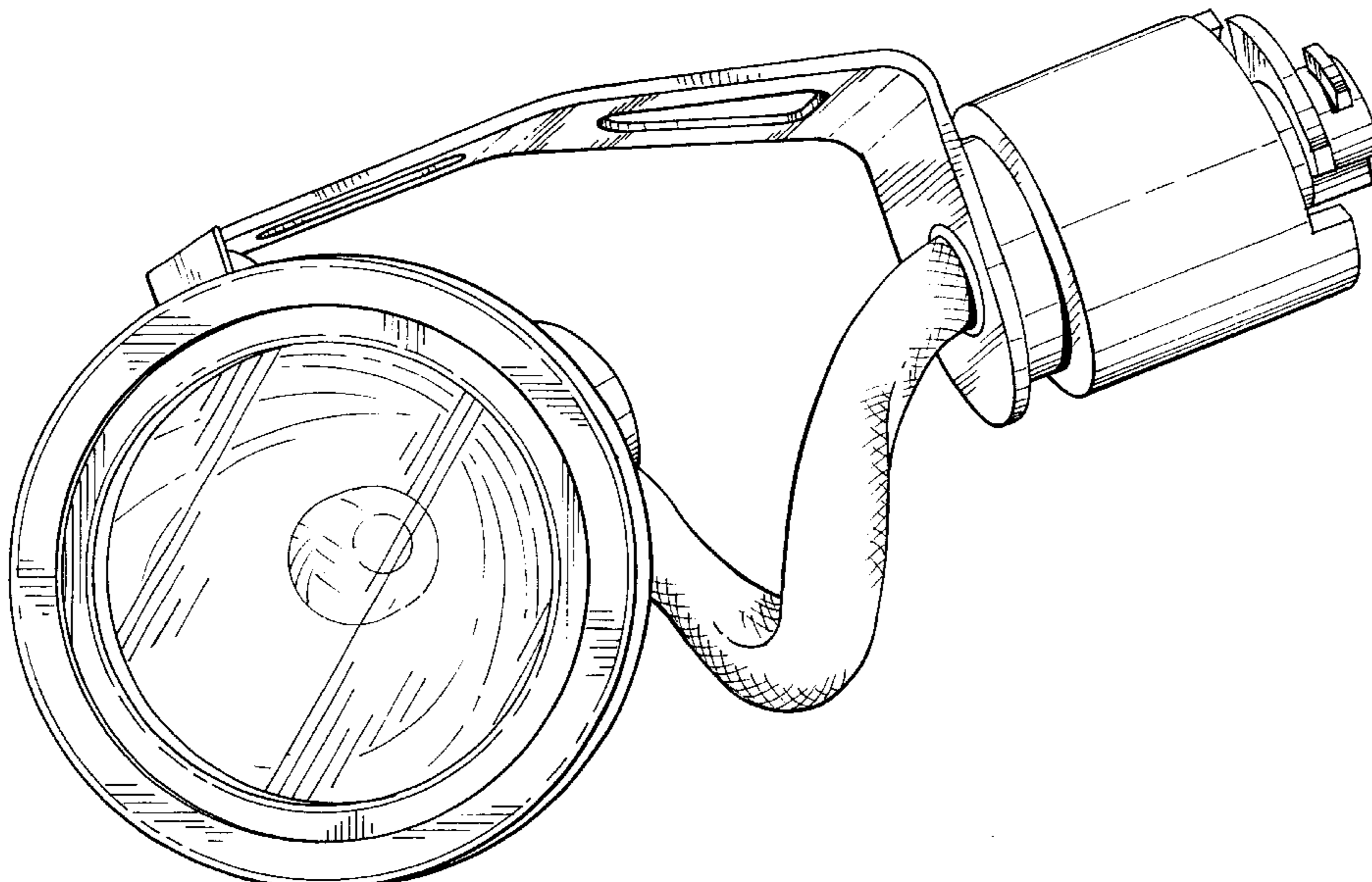
FIG. 3 is a top rear perspective view thereof in a partially rotated position;

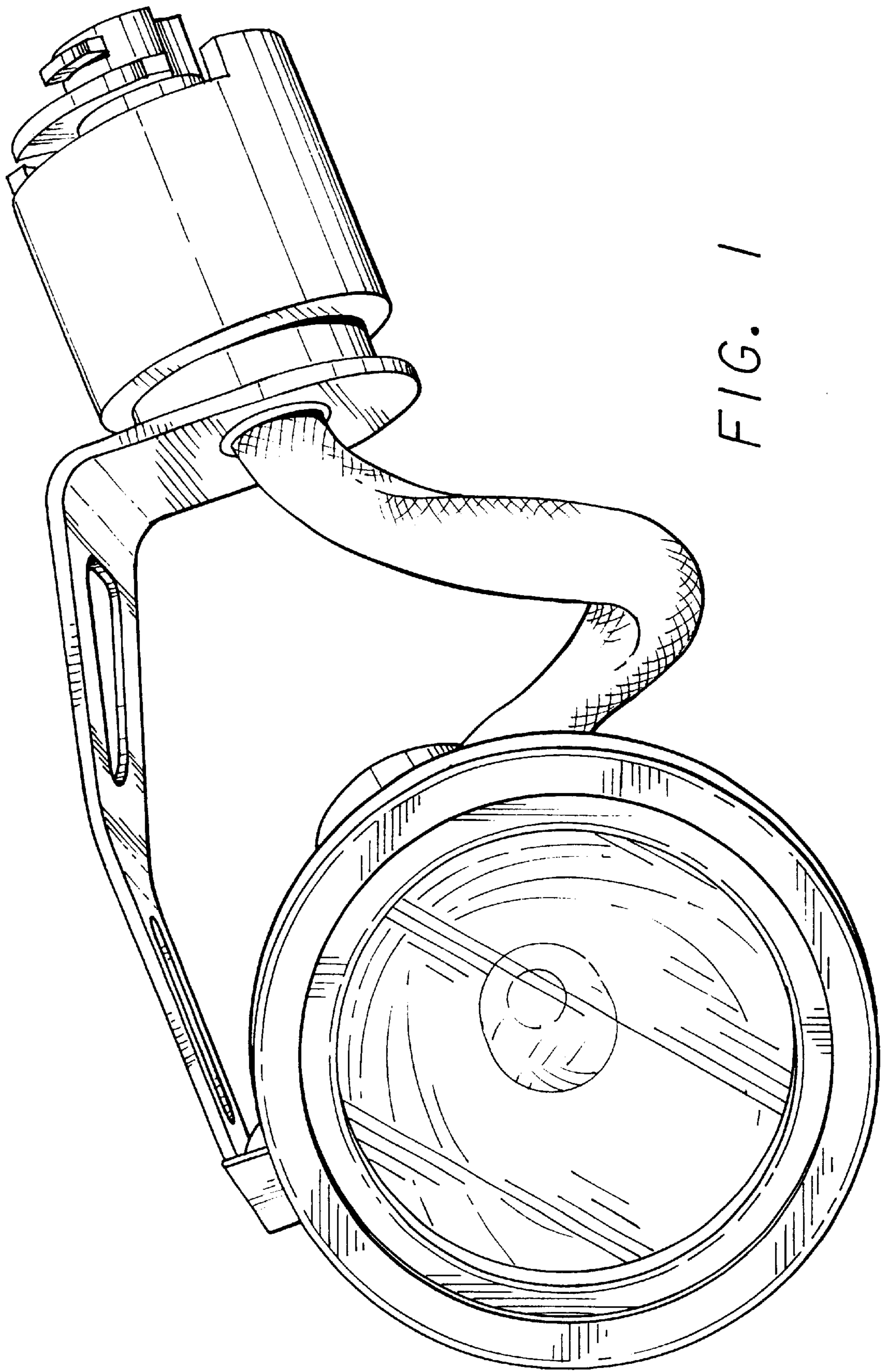

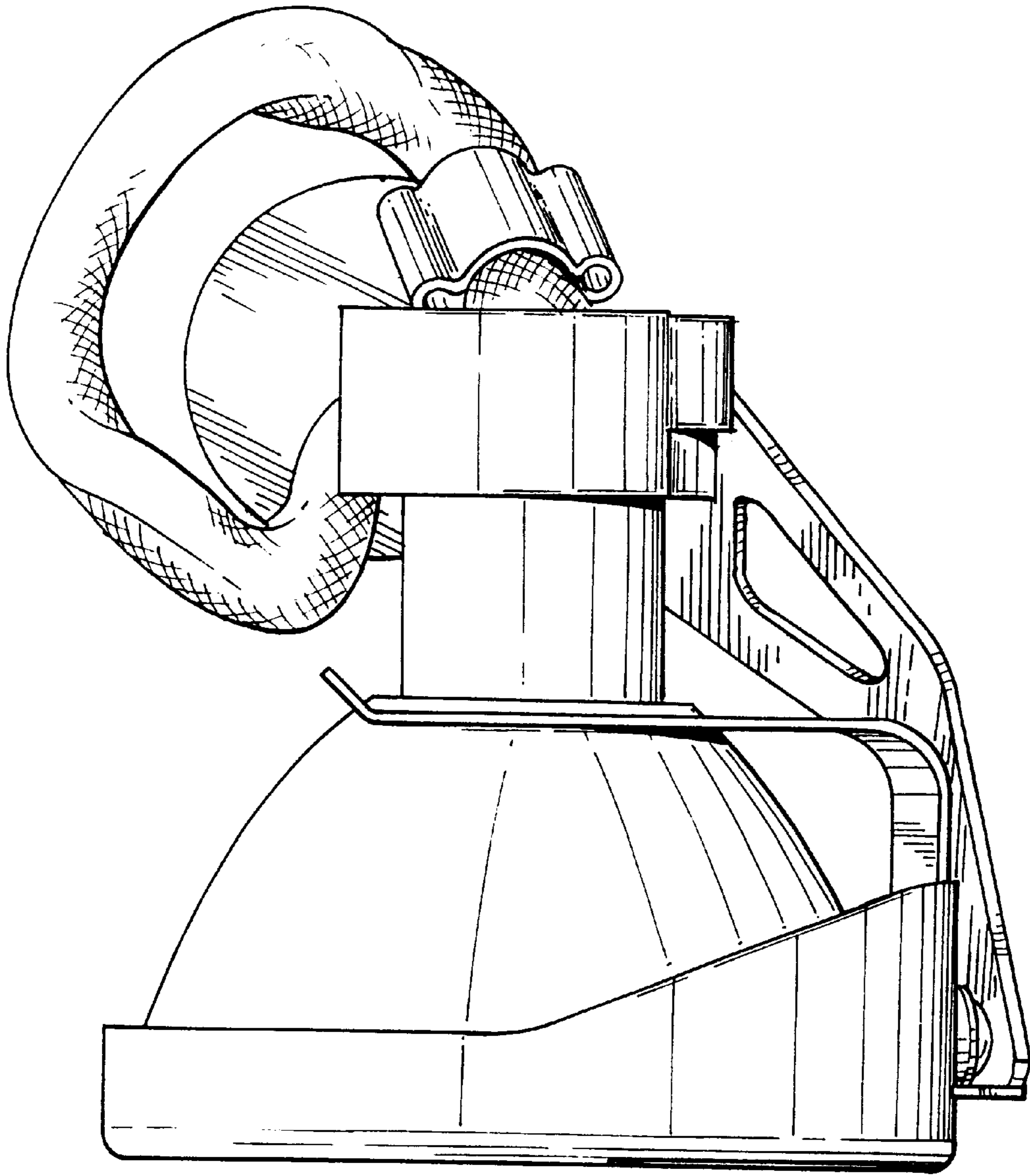

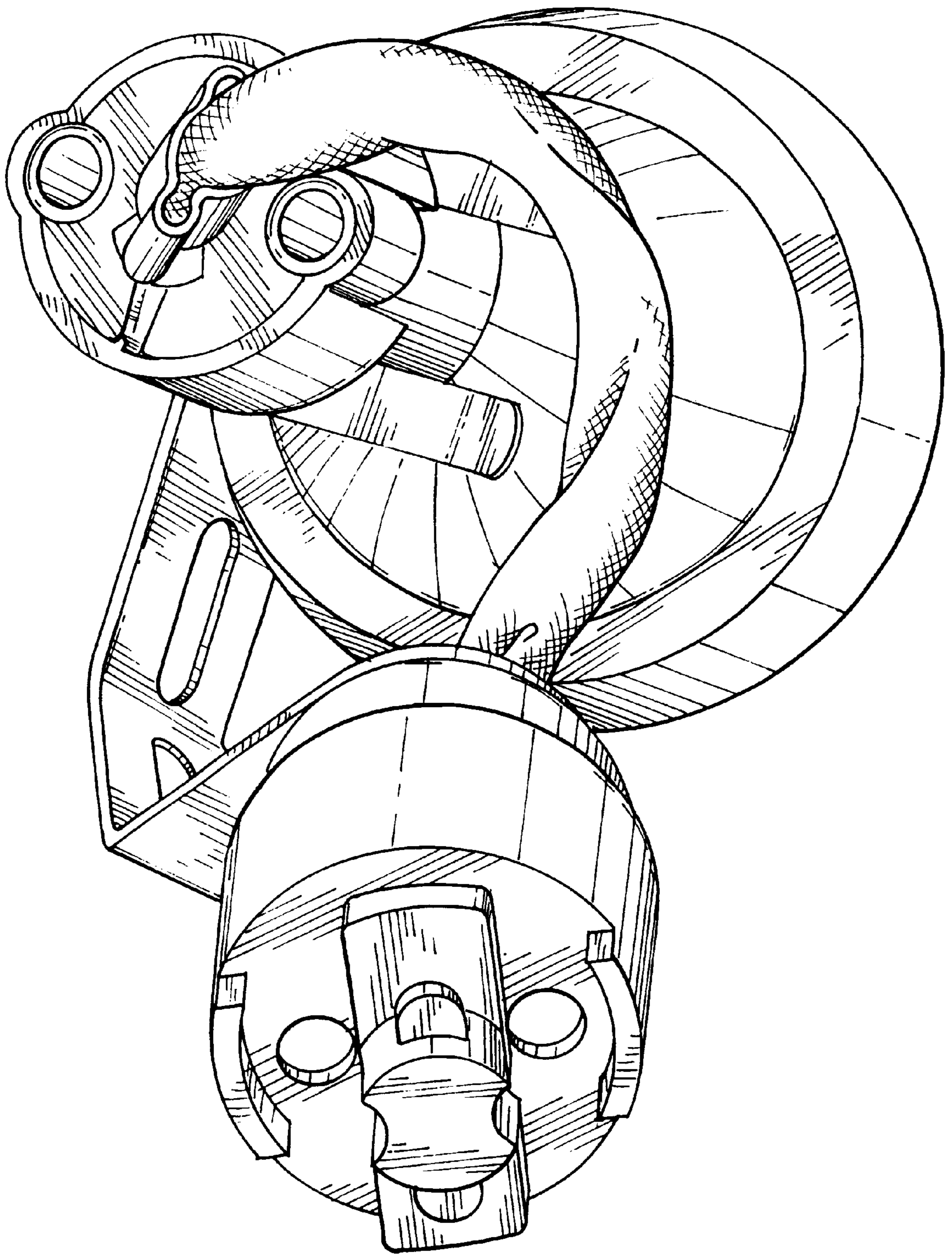
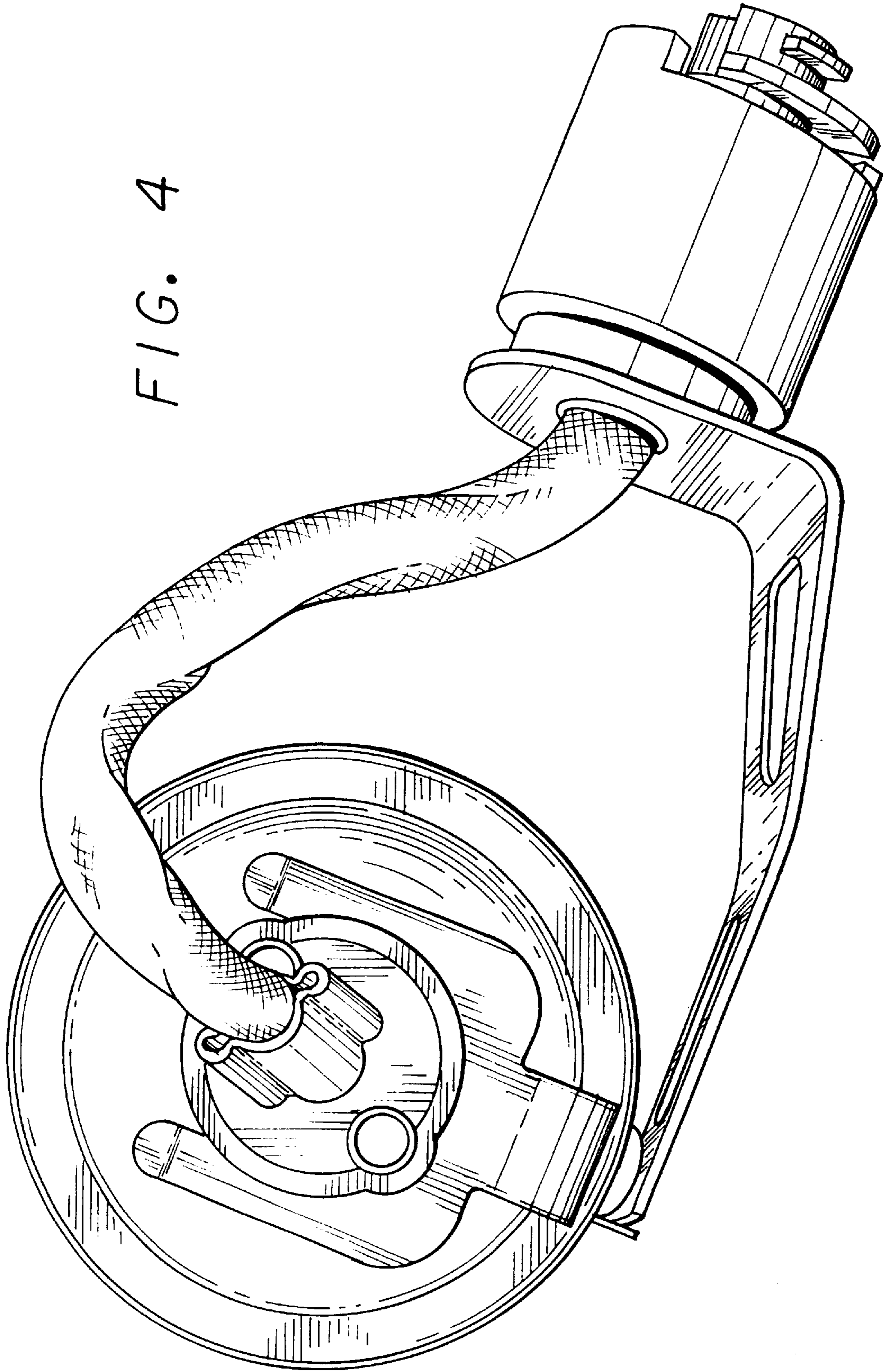

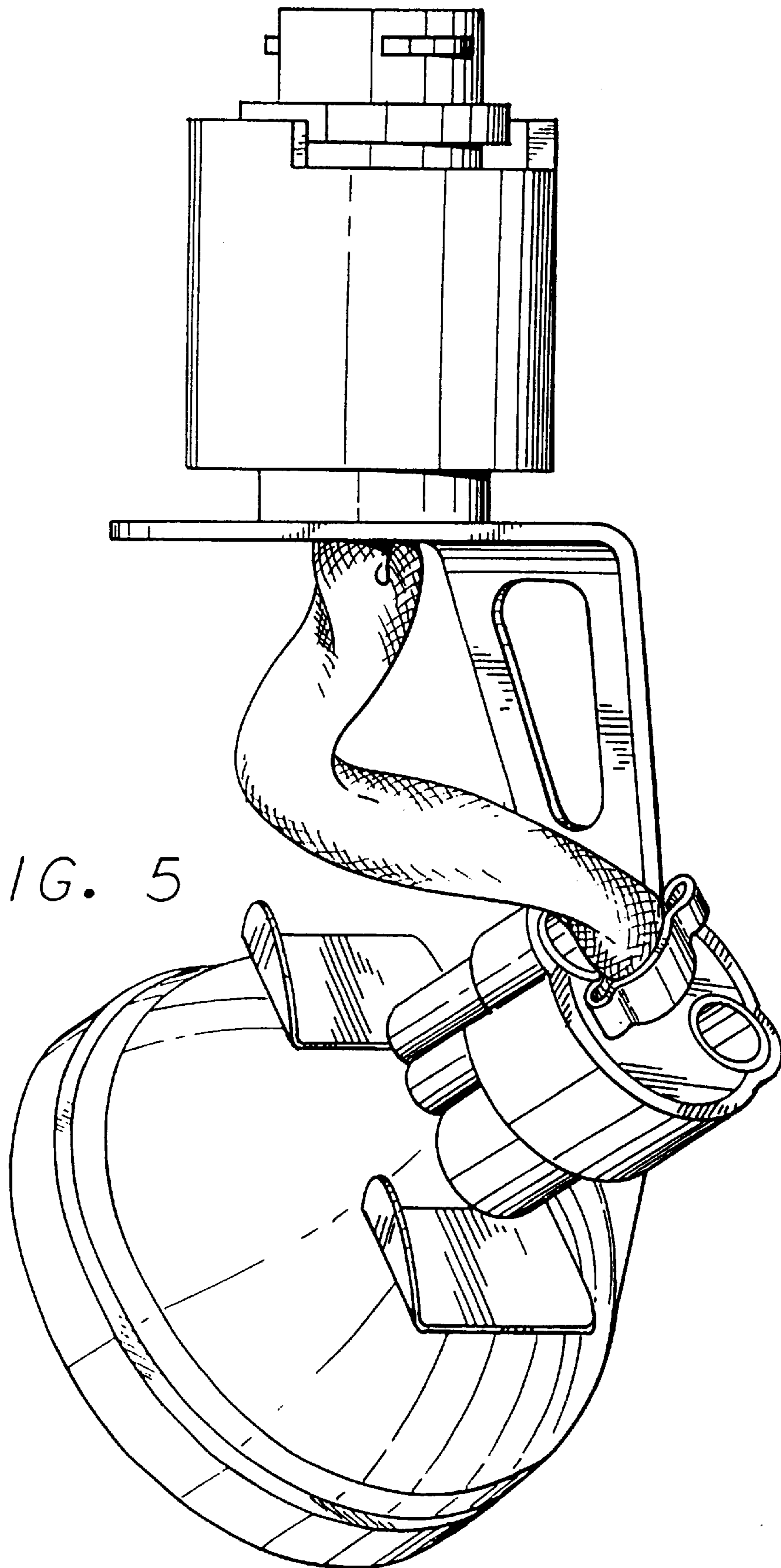

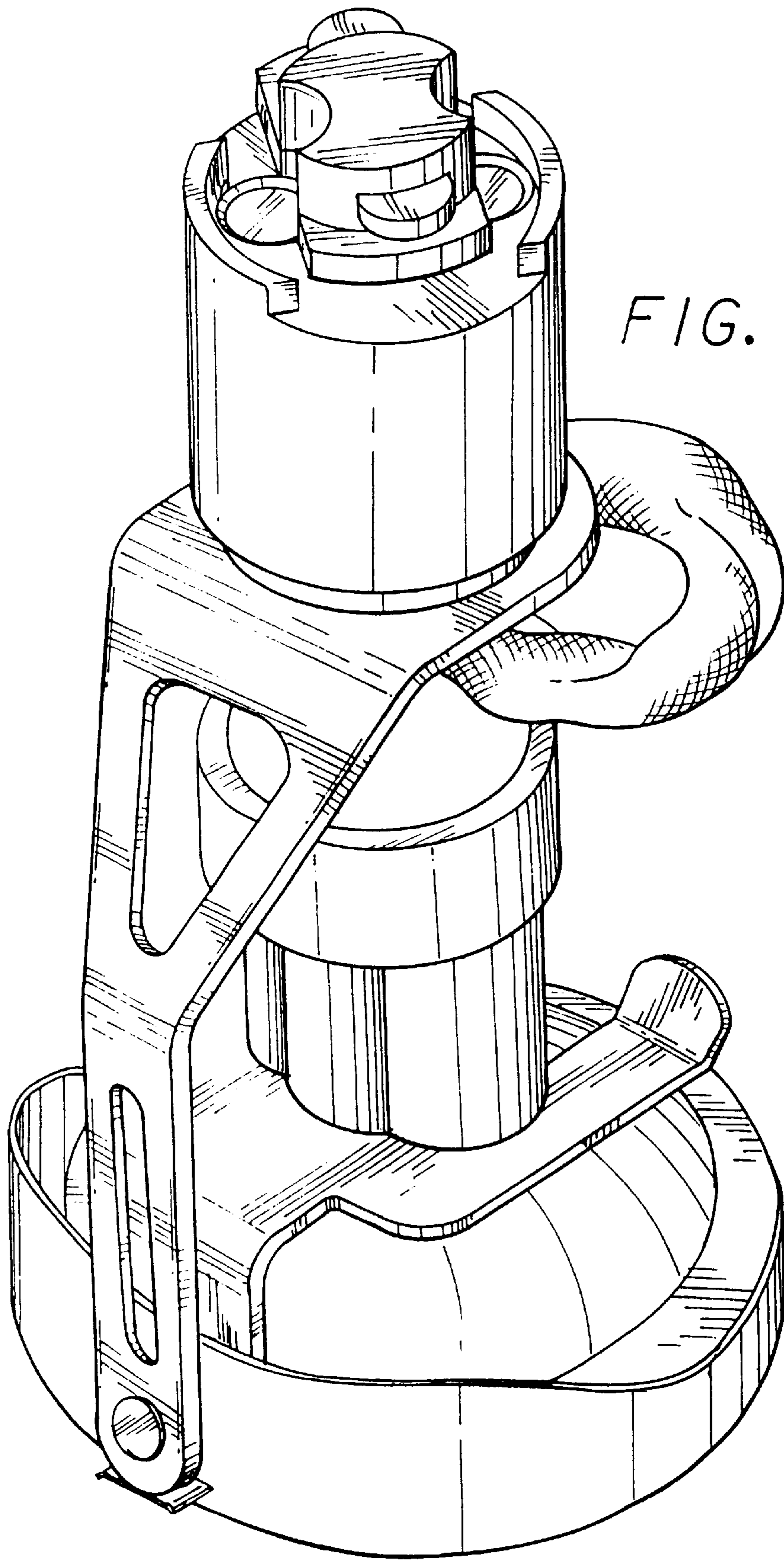
