FIG. 11 is a rear elevational view of the sock of FIG. 8;

FIG. 12 is a left side elevational view of the sock of FIG. 8;

FIG. 13 is a top plan view of the sock of FIG. 8; and,

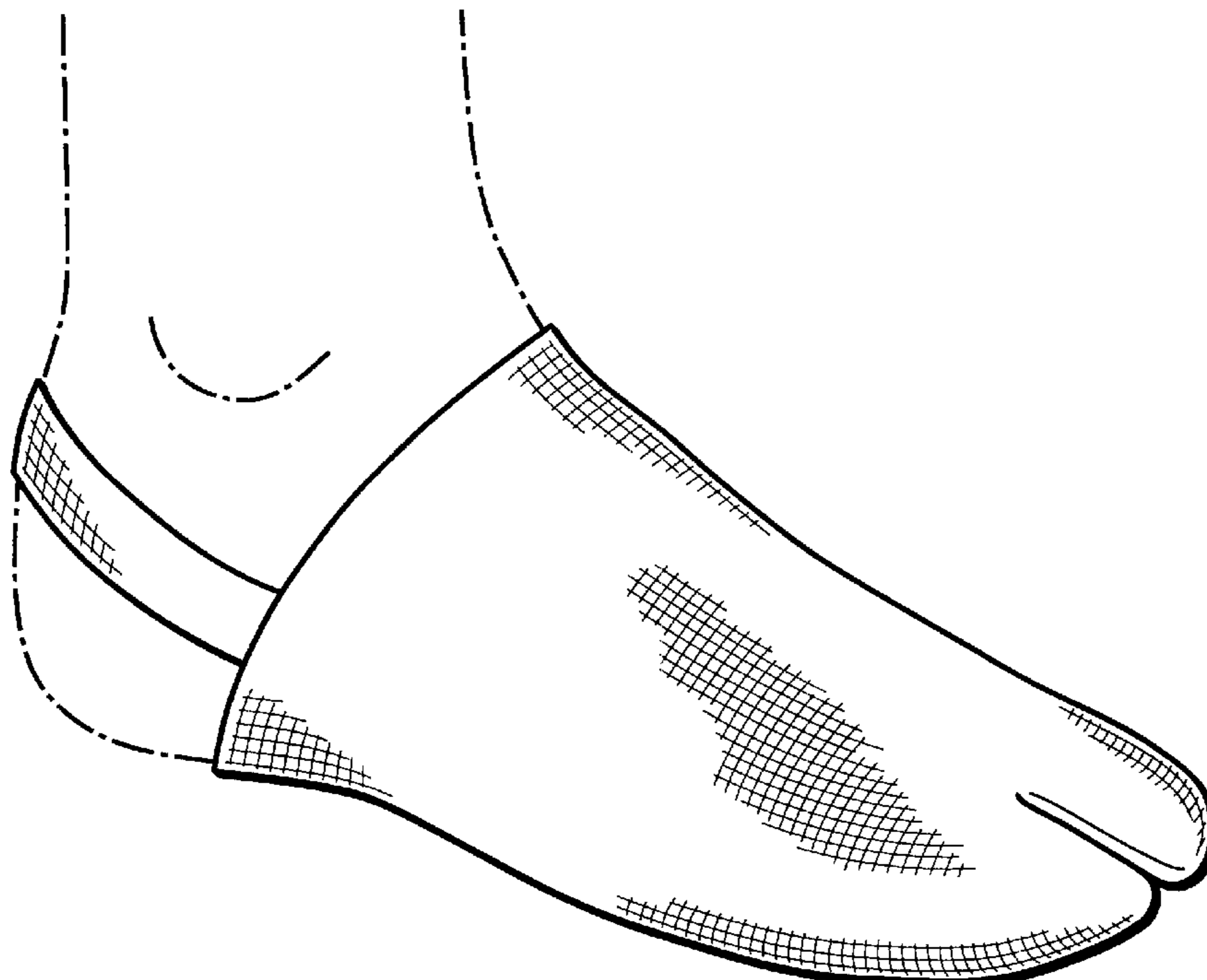
FIG. 14 is a bottom plan view of the sock of FIG. 8.

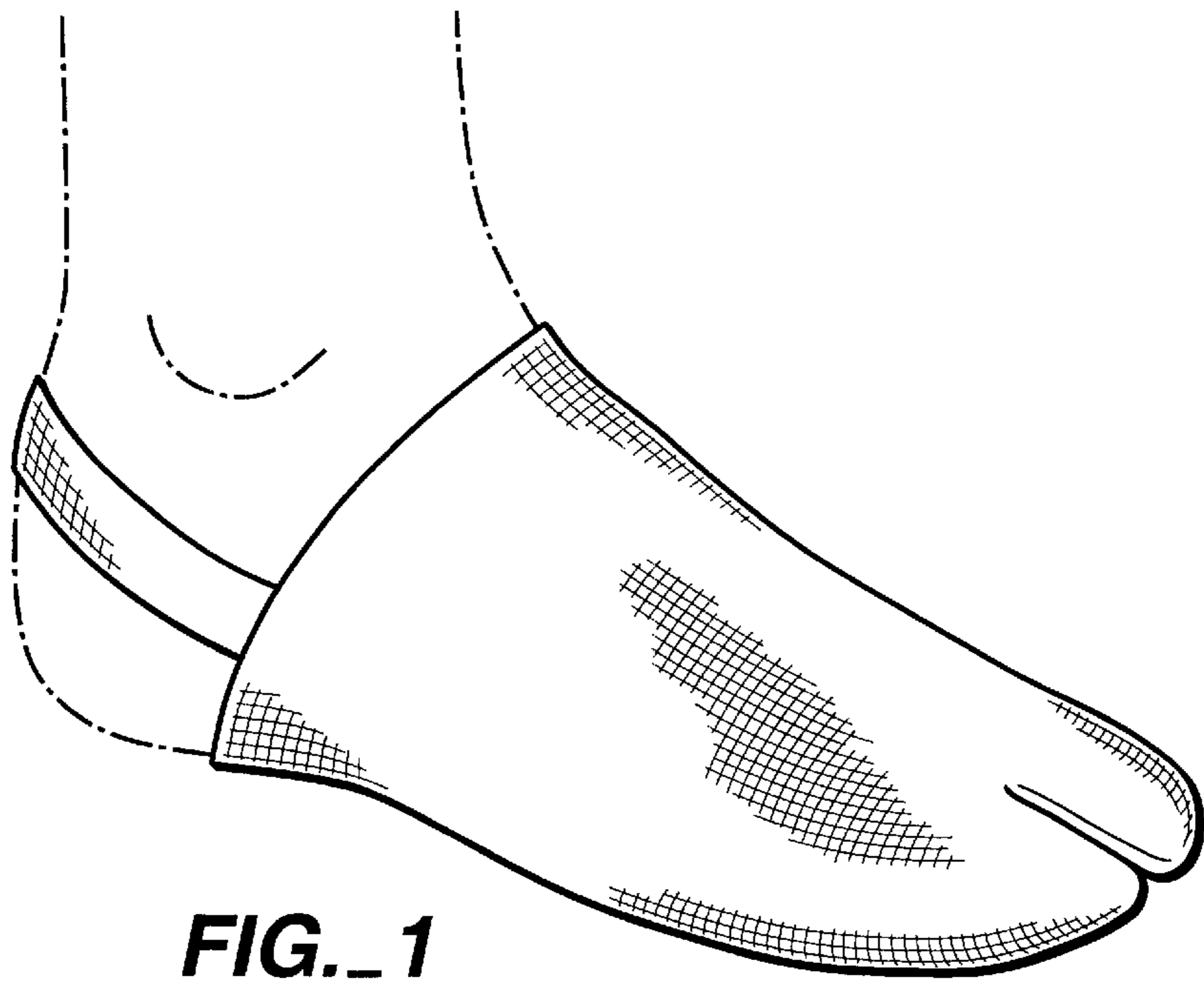

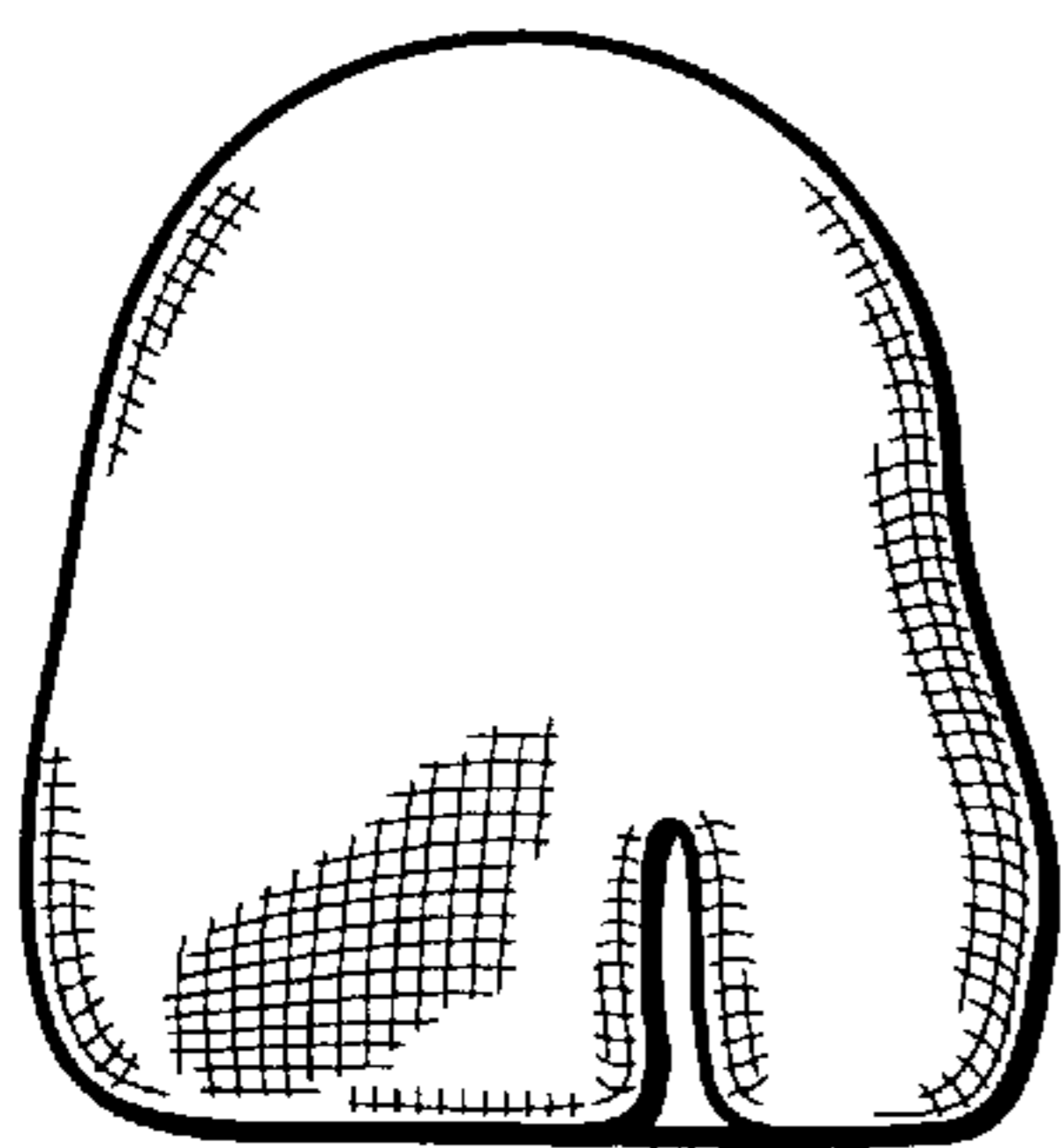

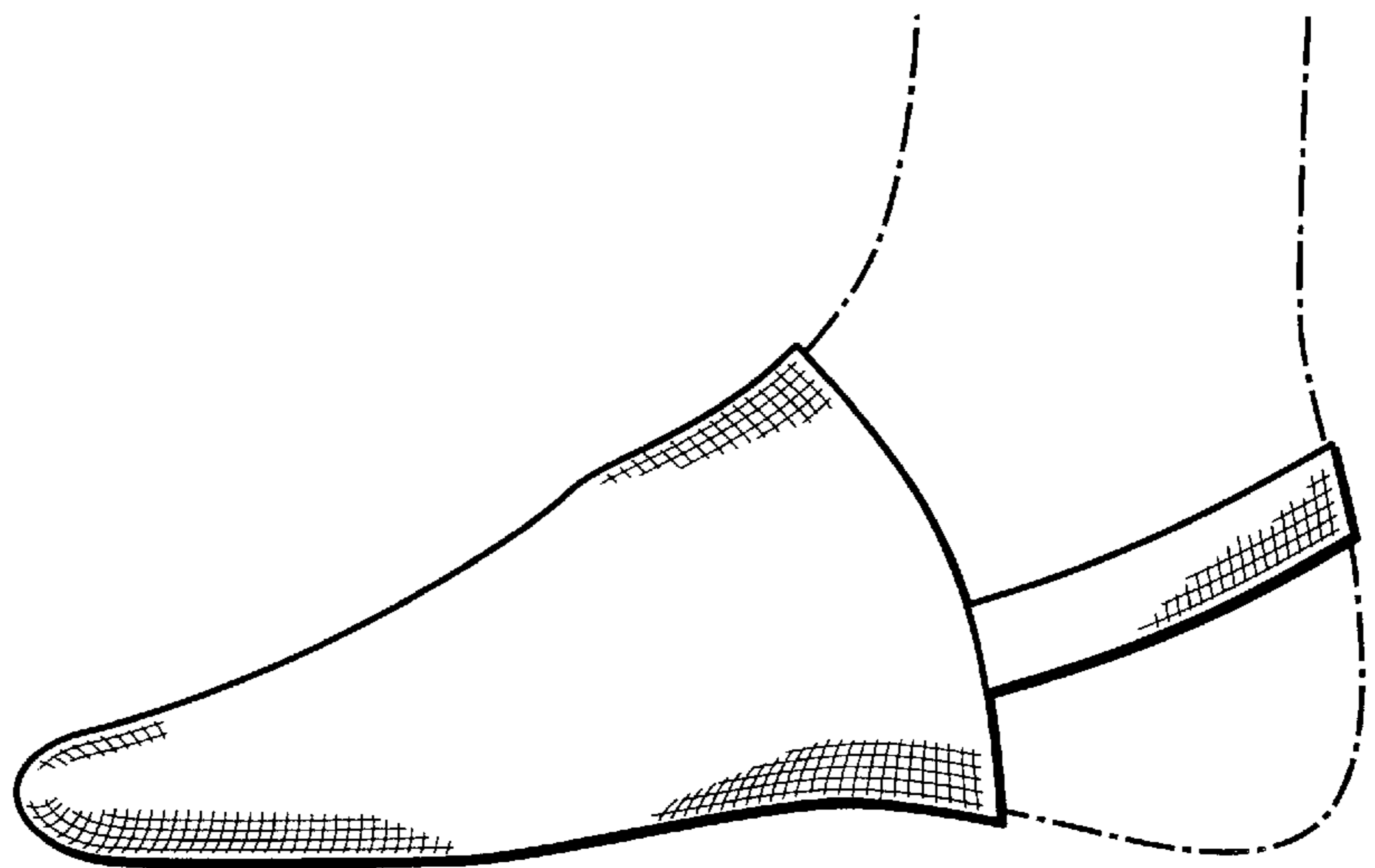

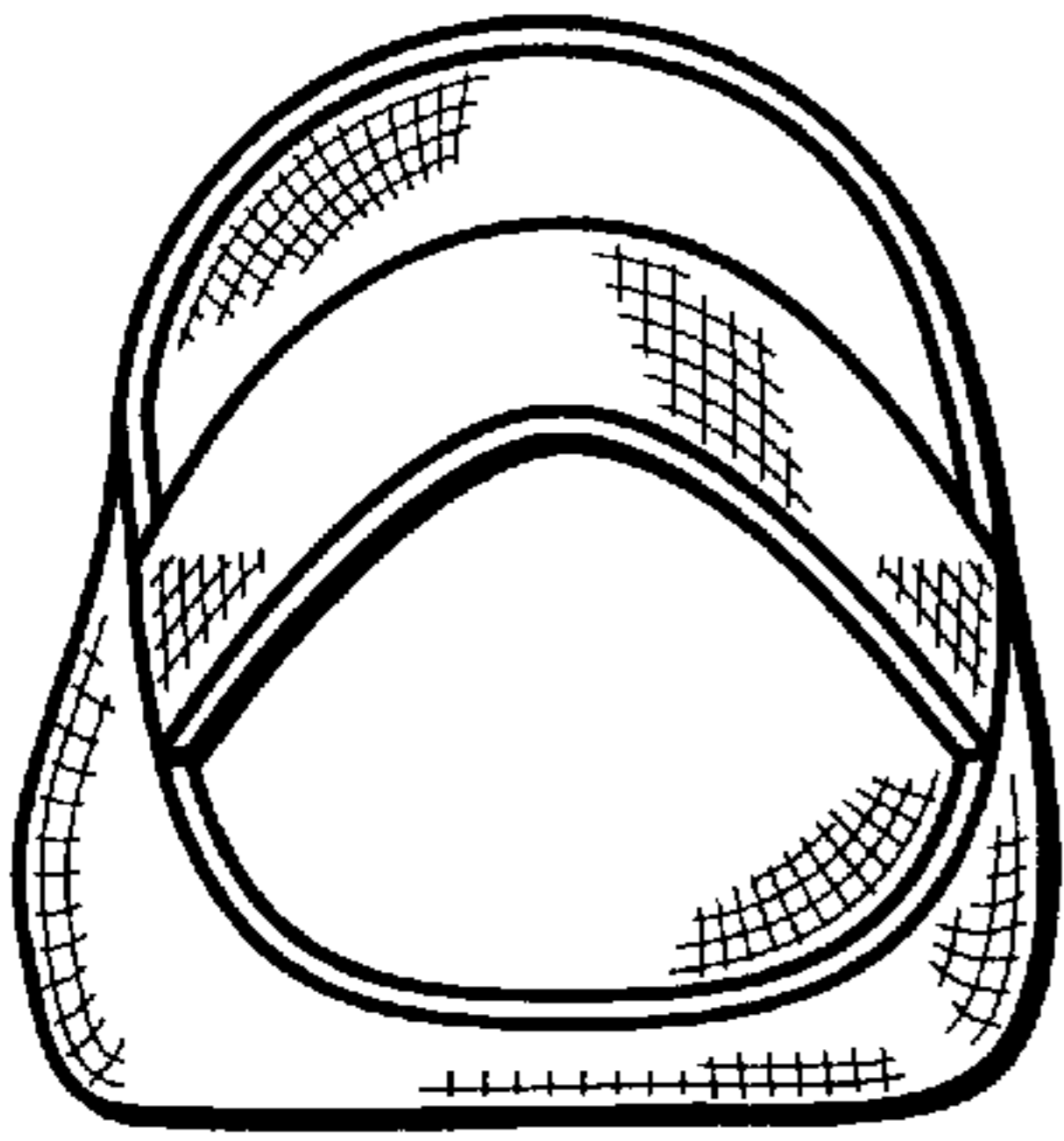

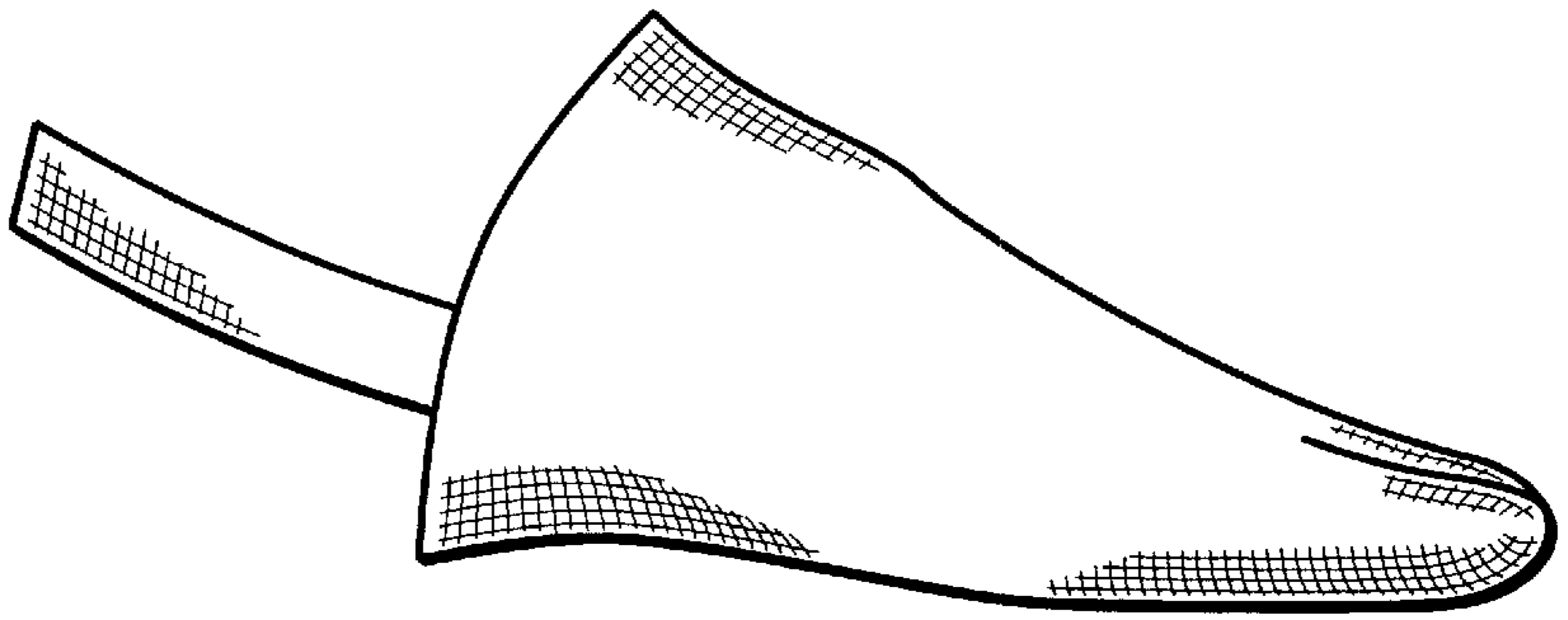

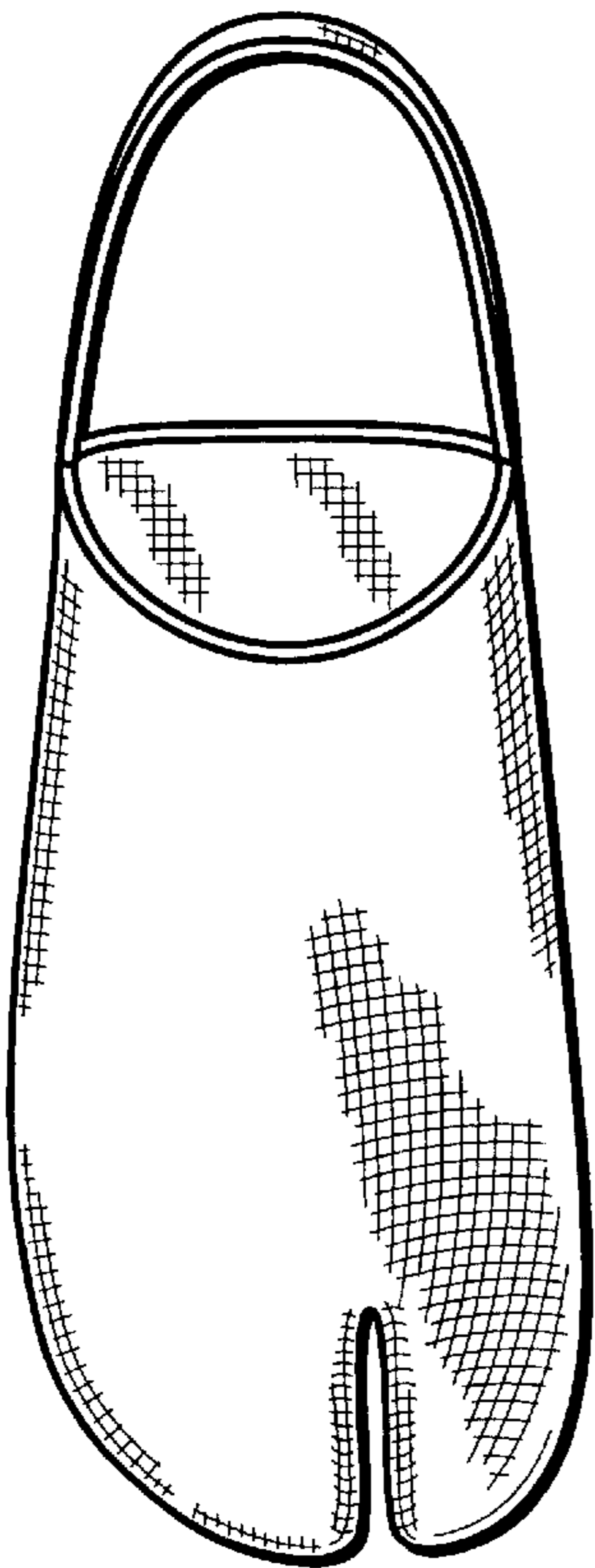

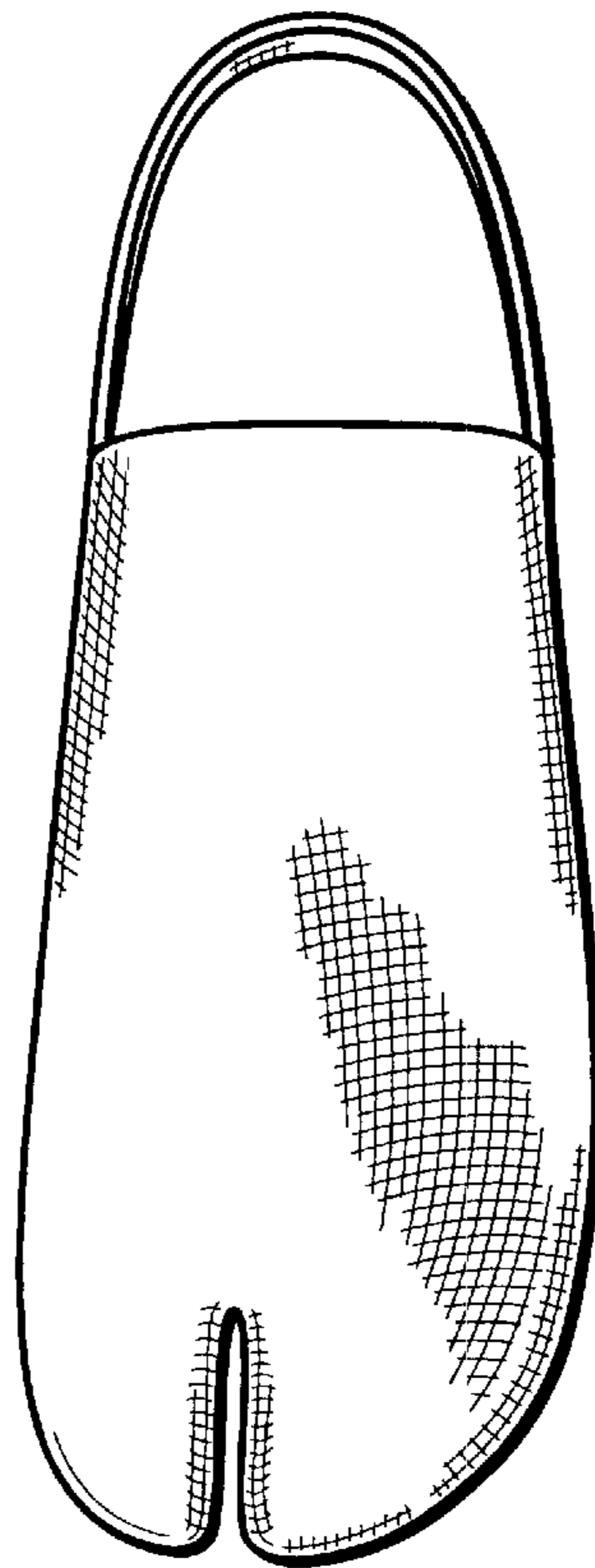

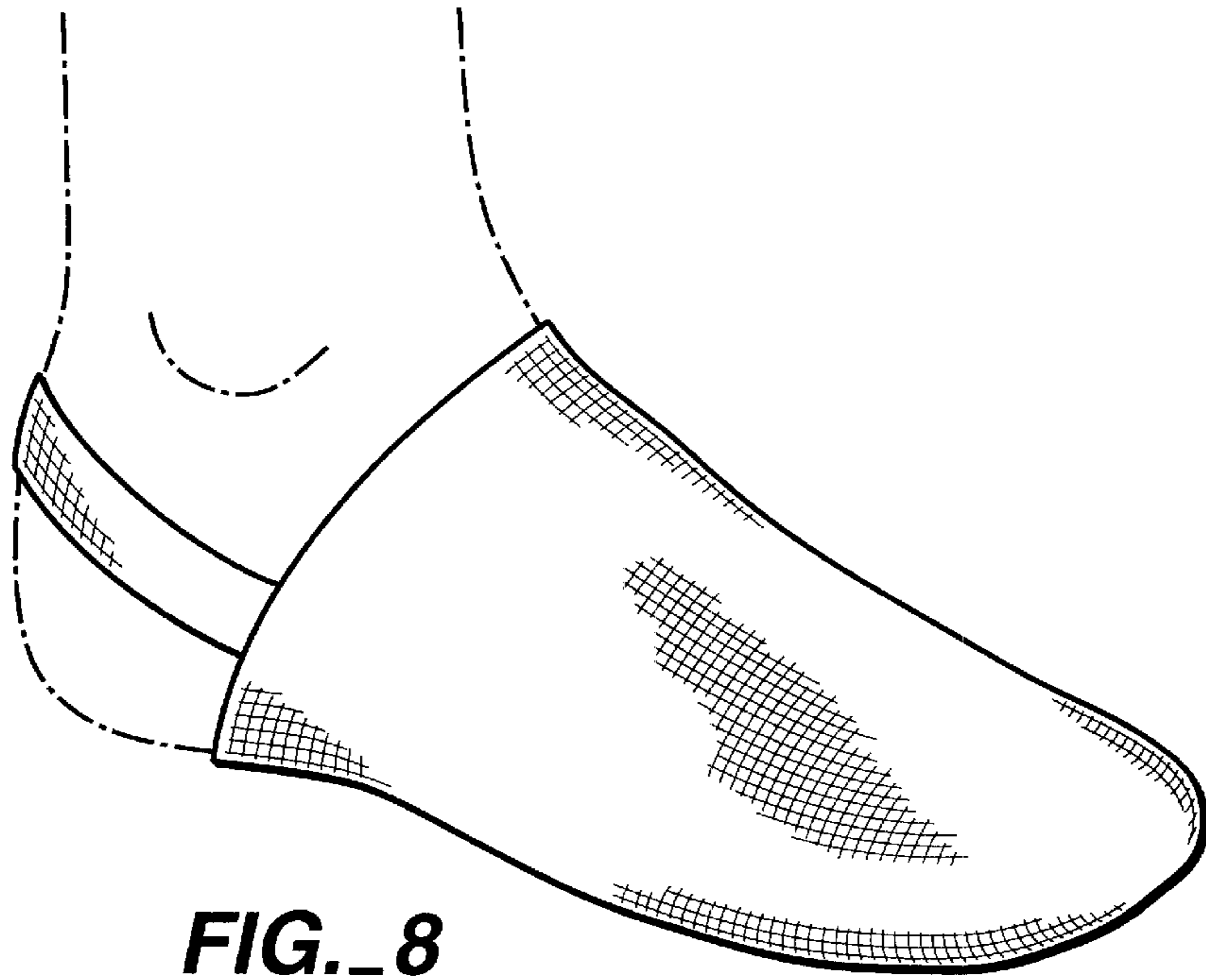

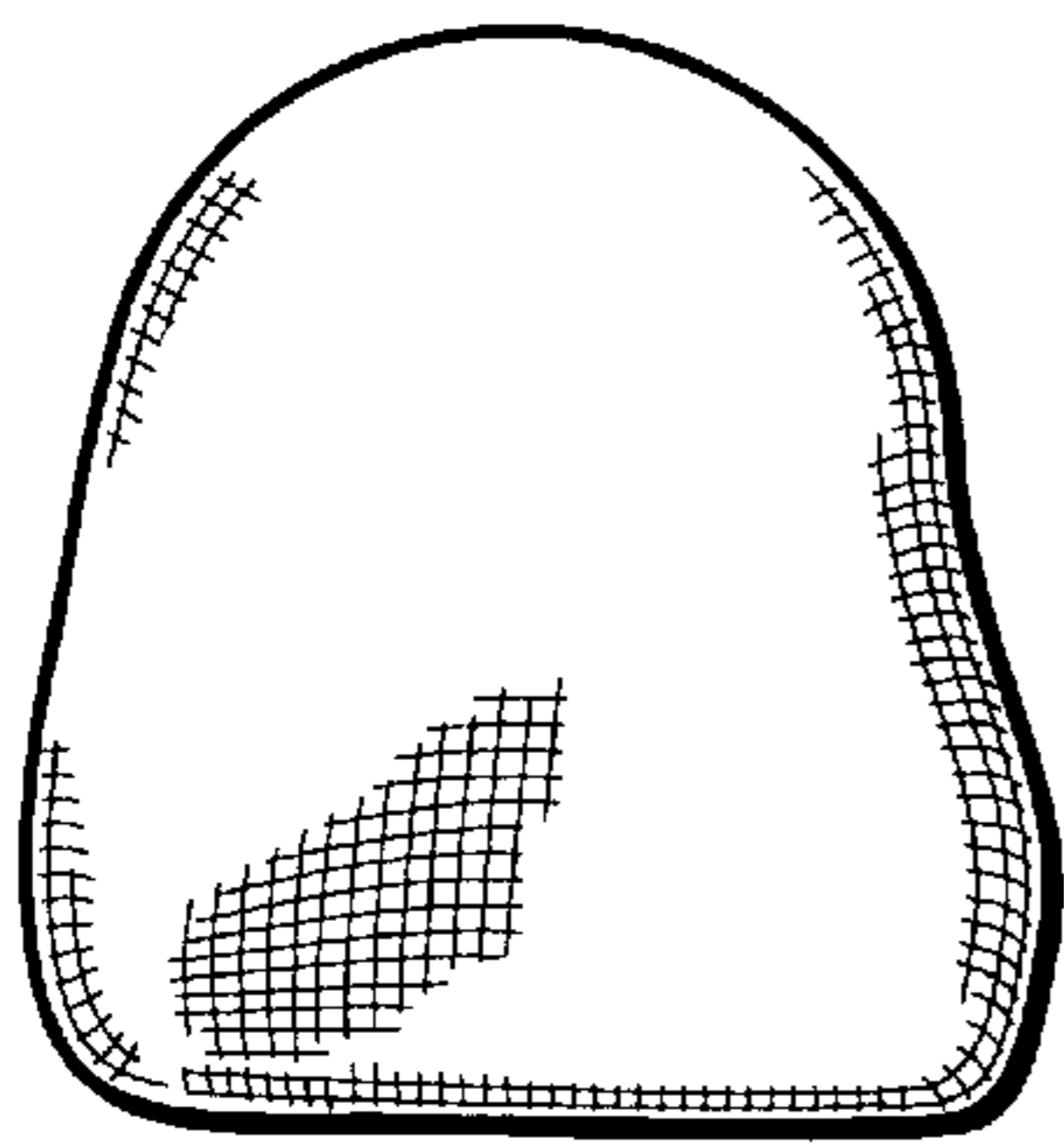

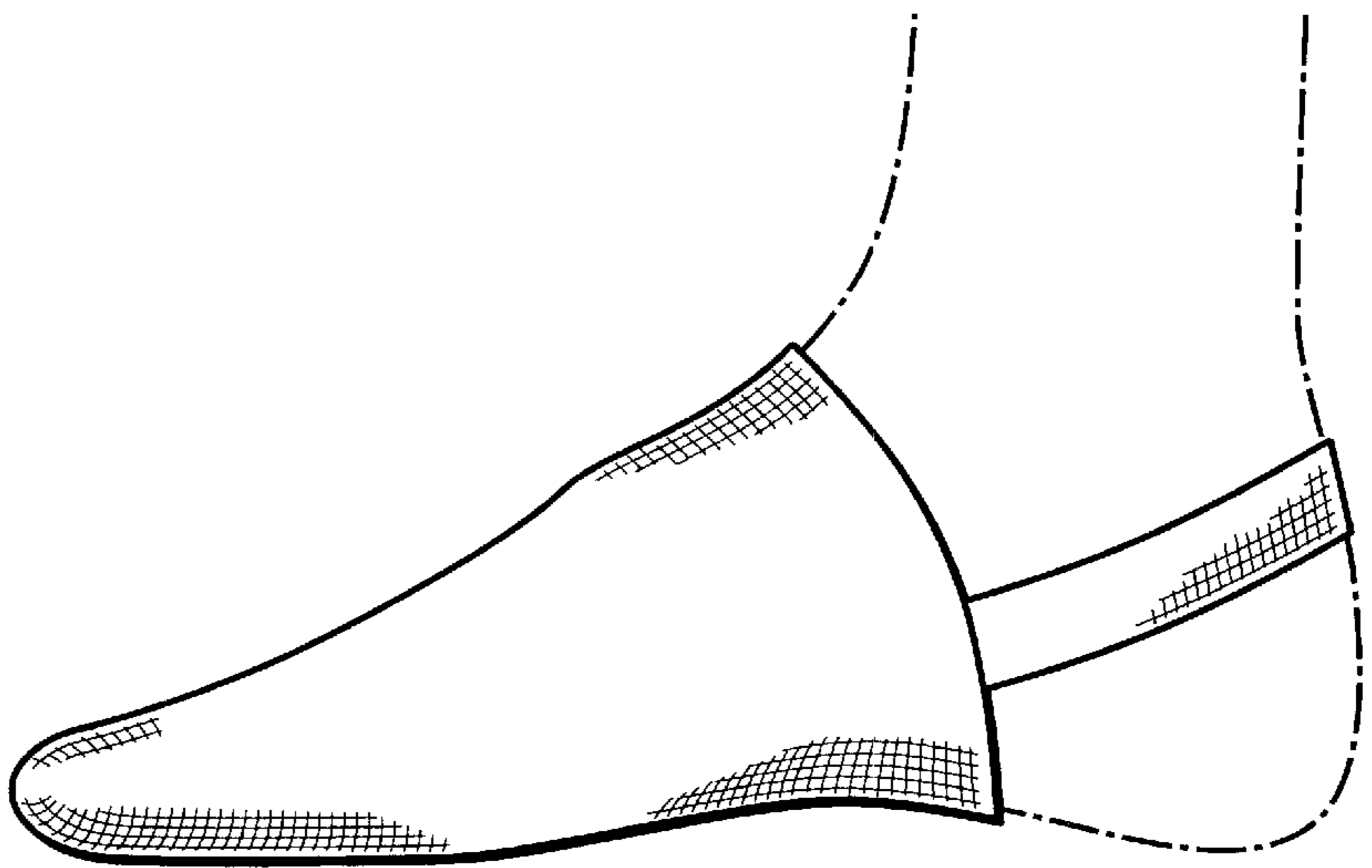

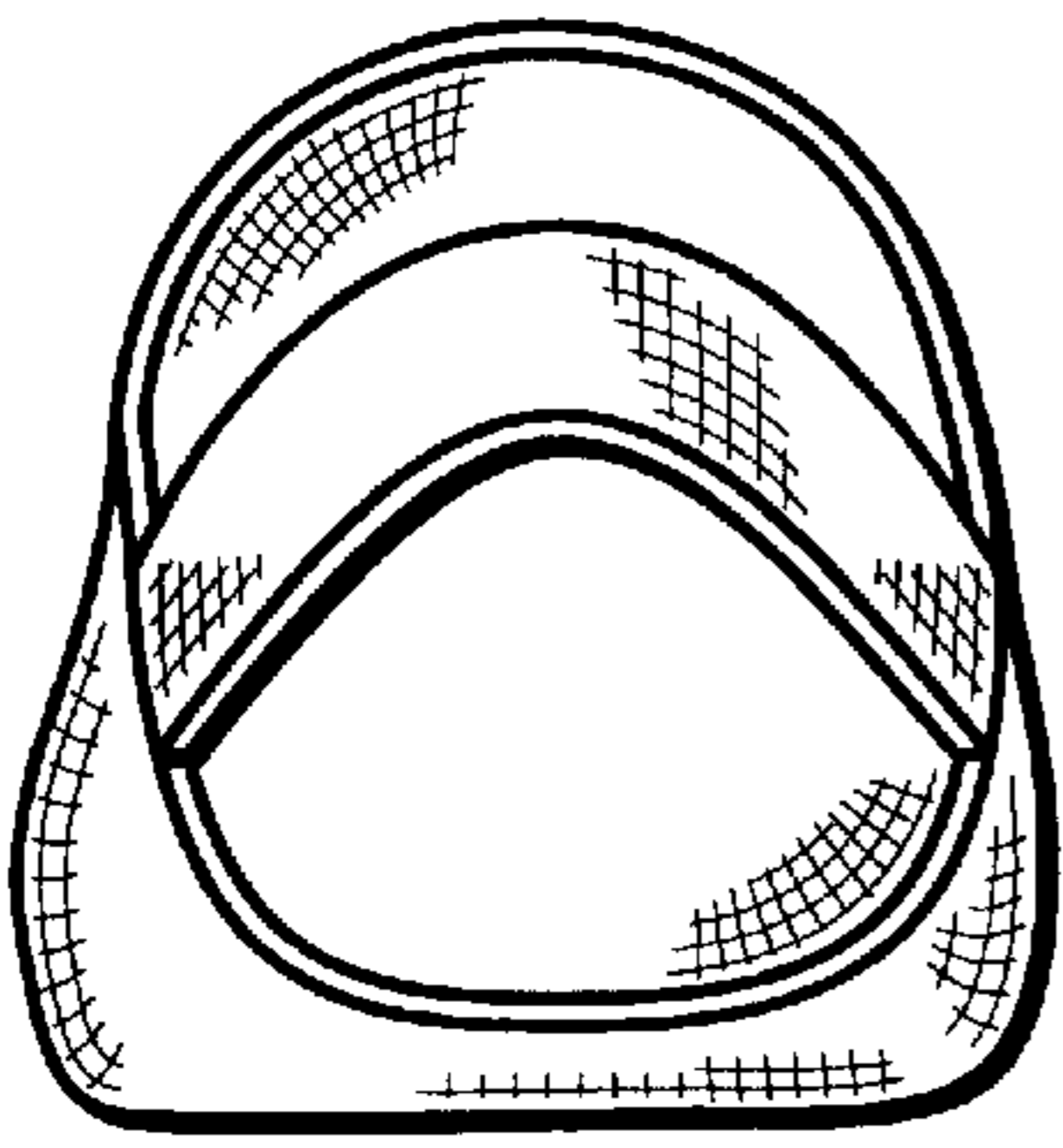

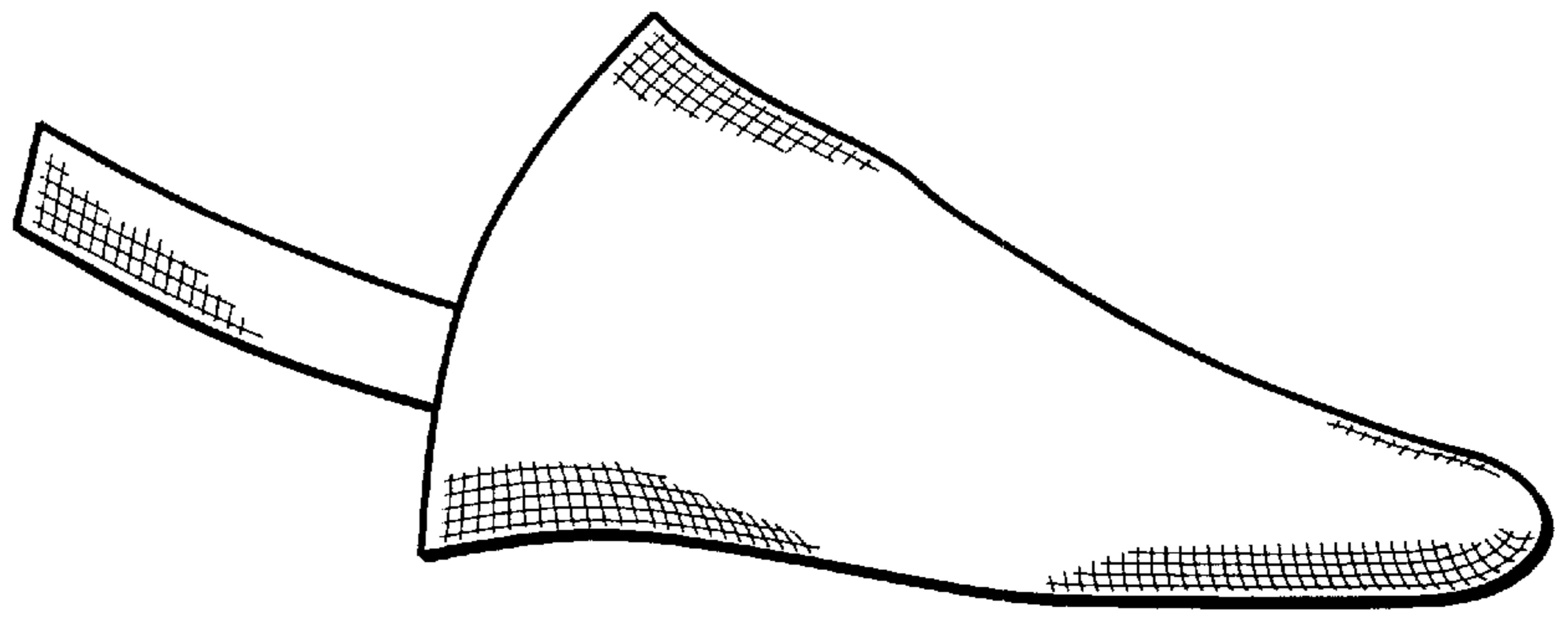

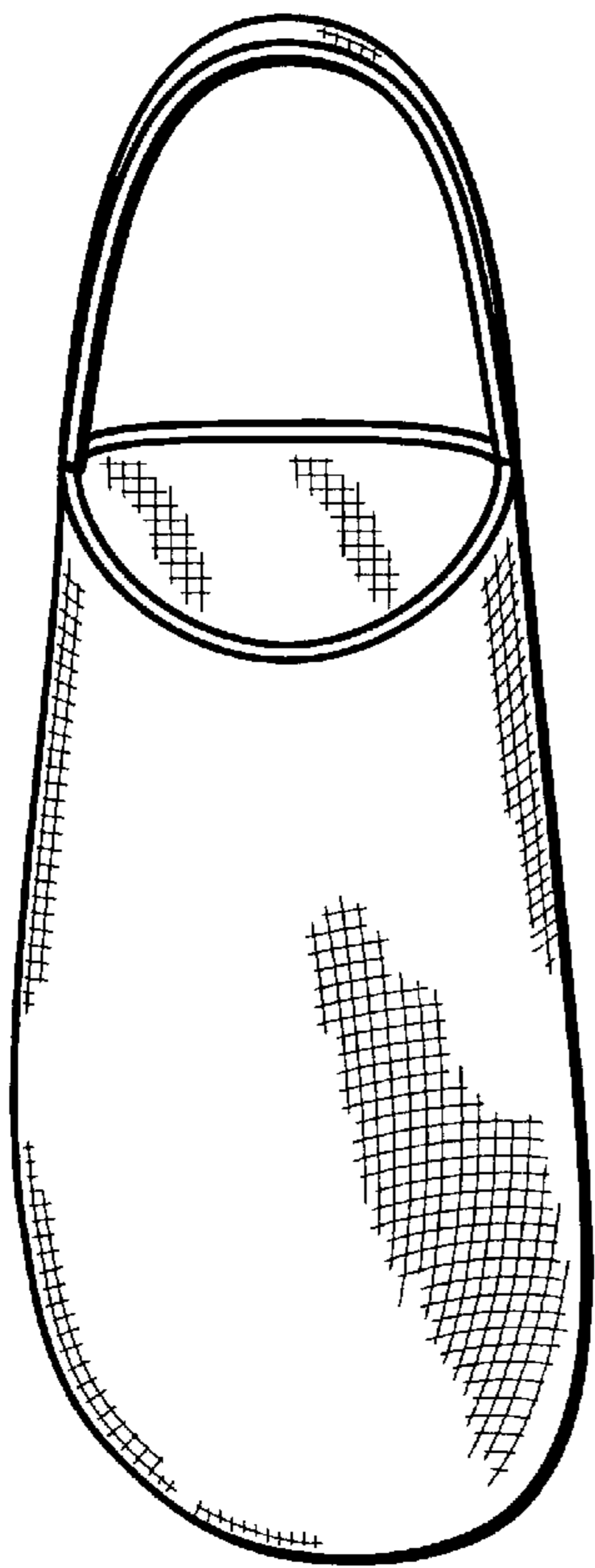

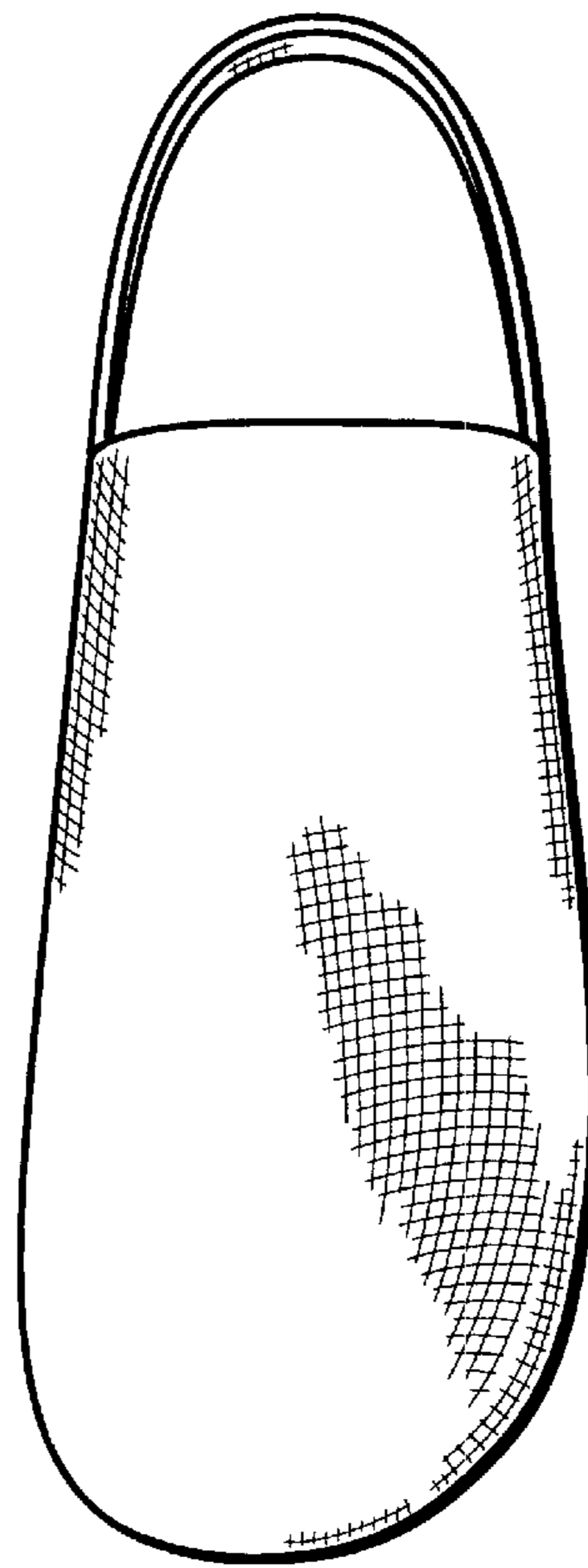
