(57) **CLAIM**

The ornamental design for a combined bowl and cover for household purposes, as shown and described.

DESCRIPTION

FIG. 1 side view of the combined bowl and cover for household purposes showing my new design;

FIG. 2 is a top perspective view thereof;

FIG. 3 is a top perspective view thereof with only a portion of the lid shown for clarity of illustration;

FIG. 4 is a bottom view of cover, shown separately for clarity of illustration;

FIG. 5 is a bottom view of a portion of the cover shown separately for clarity of illustration;

FIG. 6 is a side view of the bowl portion shown separately for clarity of illustration;

FIG. 7 is a bottom perspective view of FIG. 6;

FIG. 8 is a top perspective view of FIG. 6;

FIG. 9 is a top plan view of FIG. 6; and,

FIG. 10 is a bottom plan view of FIG. 10.












