(57) **CLAIM**

The ornamental design for garment having shoulder vents, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a garment having shoulder vents showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is an enlarged fragmentary front perspective view thereof;

FIG. 4 is an enlarged fragmentary rear perspective view of FIG. 3;

FIG. 5 is an enlarged perspective view of the vent portion thereof;

FIG. 6 is a front elevational view of FIG. 5;

FIG. 7 is a right side elevational view of FIG. 5;

FIG. 8 is a top plan view of FIG. 5;

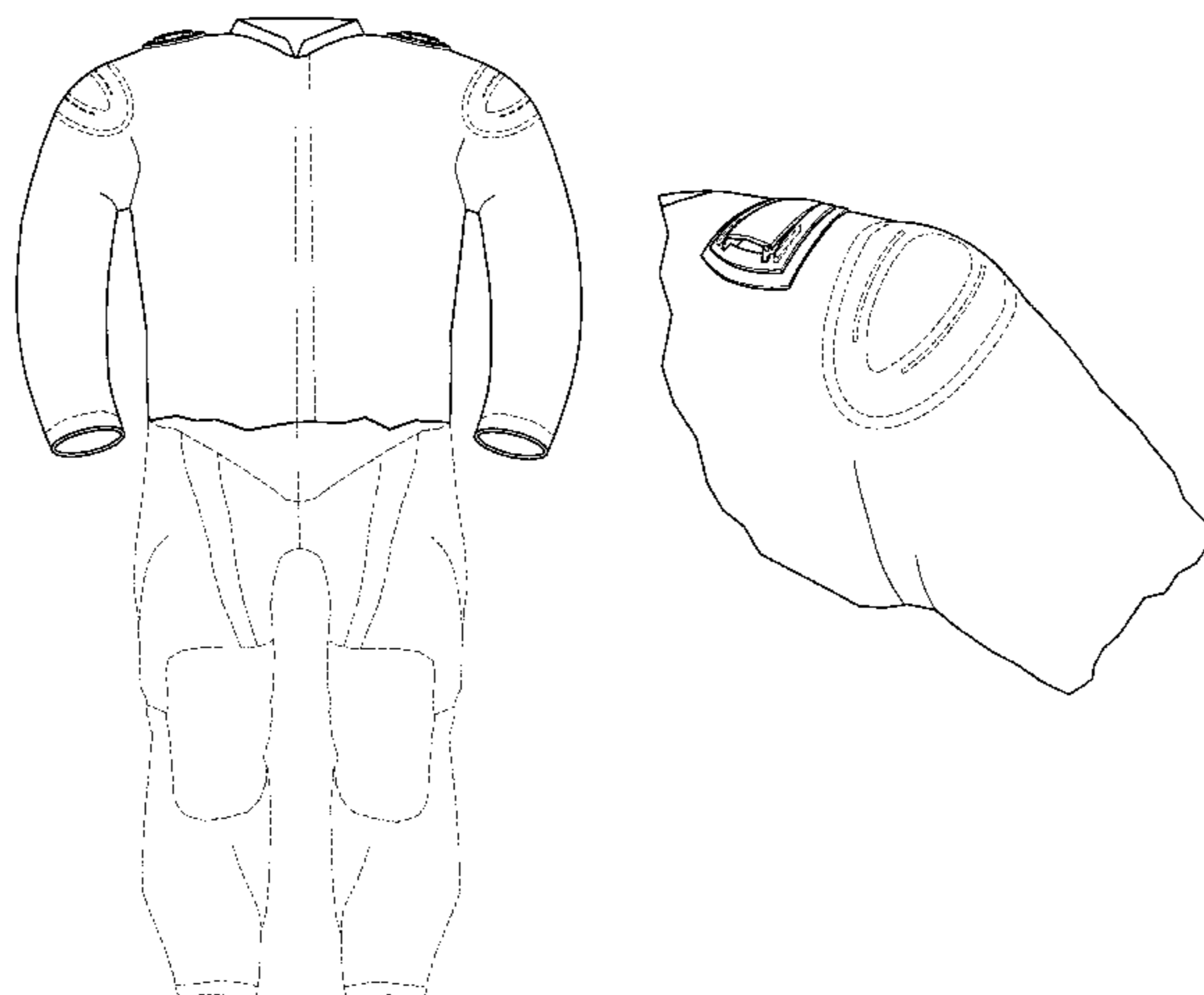
FIG. 9 is a rear elevational view of FIG. 5; and,

FIG. 10 is a true front elevational view of FIG. 5.

The broken line and fragmentary line illustration within the drawings are for illustrative purposes only and form no part of the presently claimed invention.

The claim is directed to the appearance of the garment with shoulder vents as shown in FIGS. 1 through 4. One of the vents is shown separately in FIGS. 5–10 for the purpose of showing aspects of the design that are not apparent from the other views.

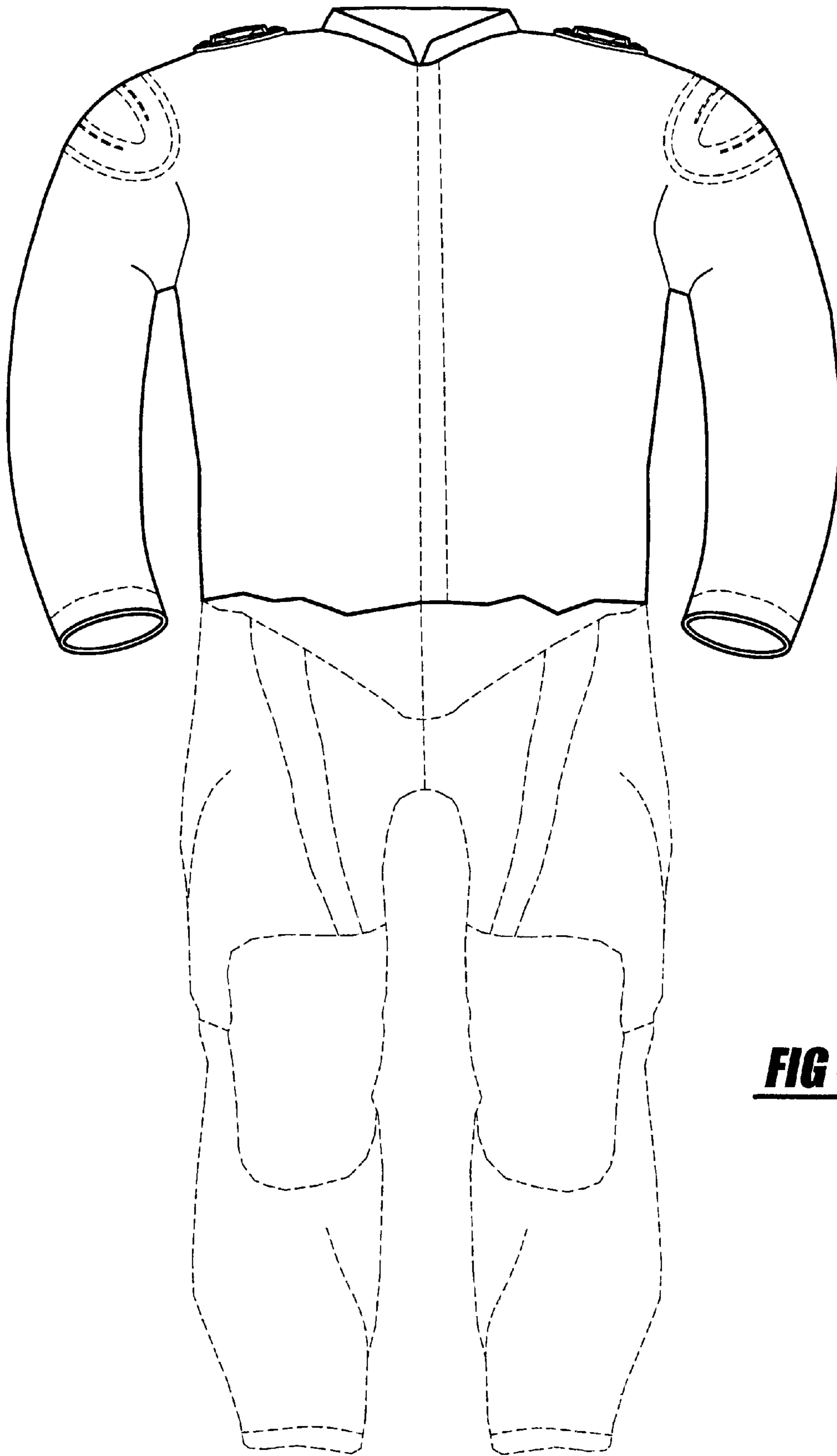

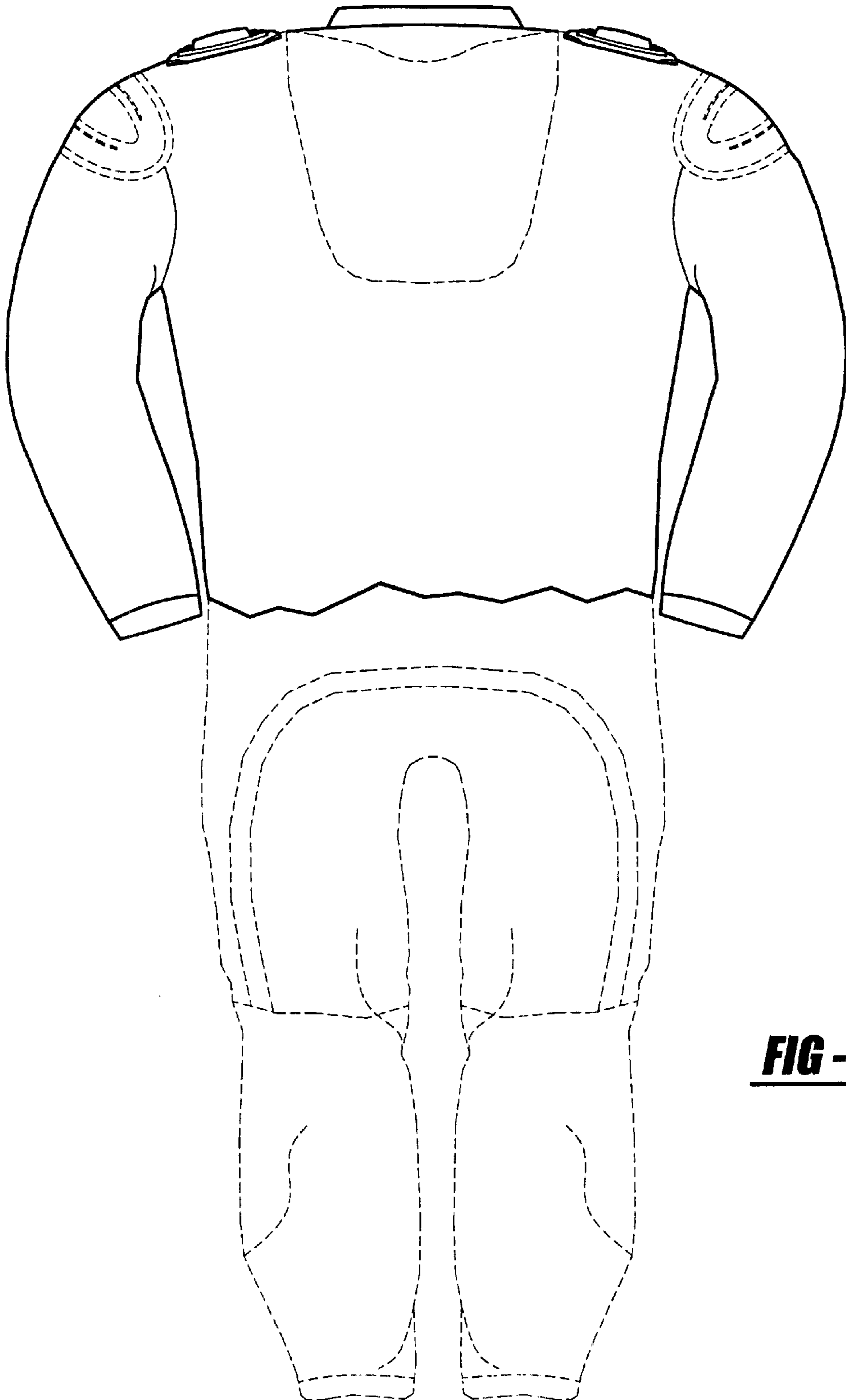

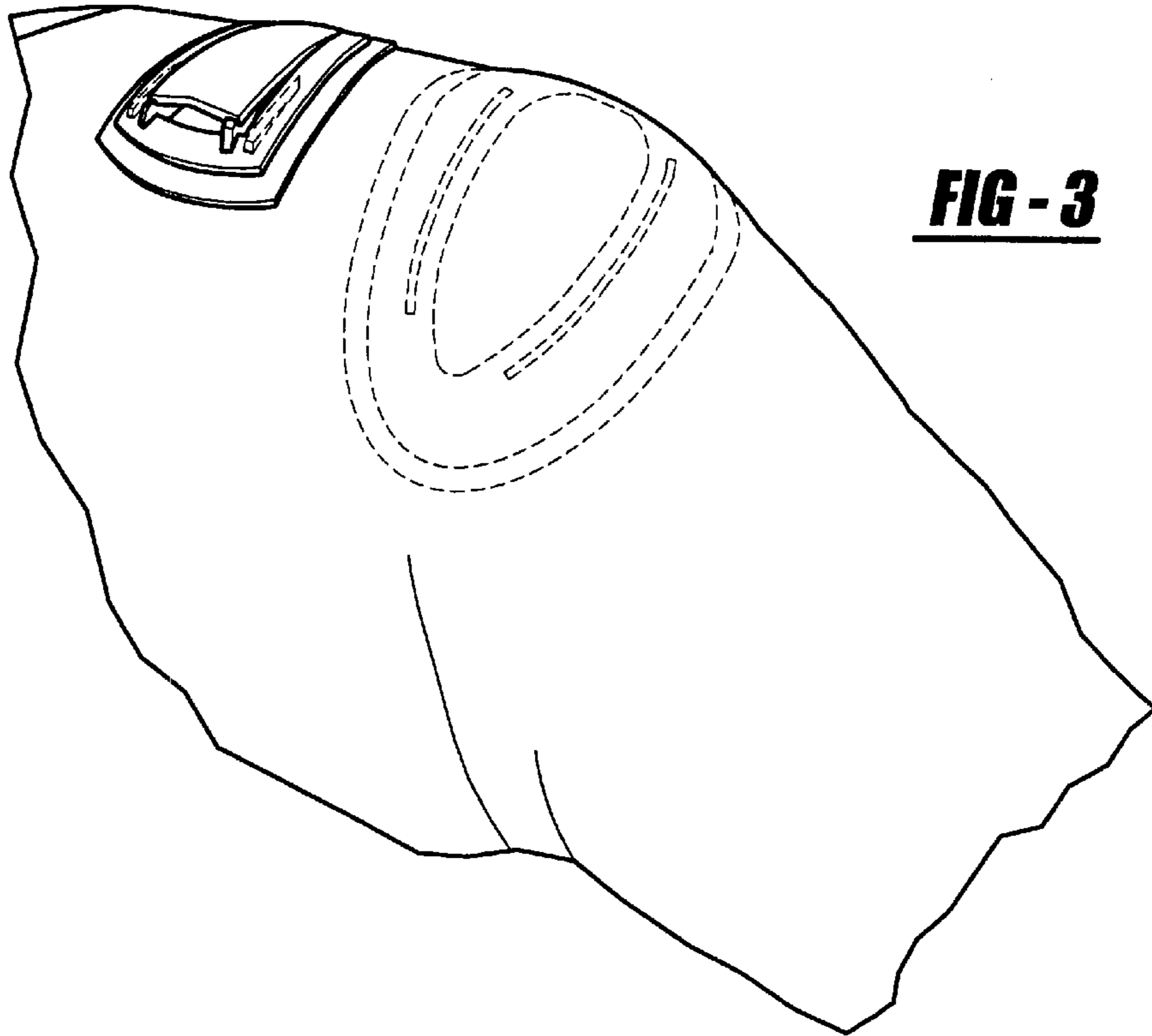

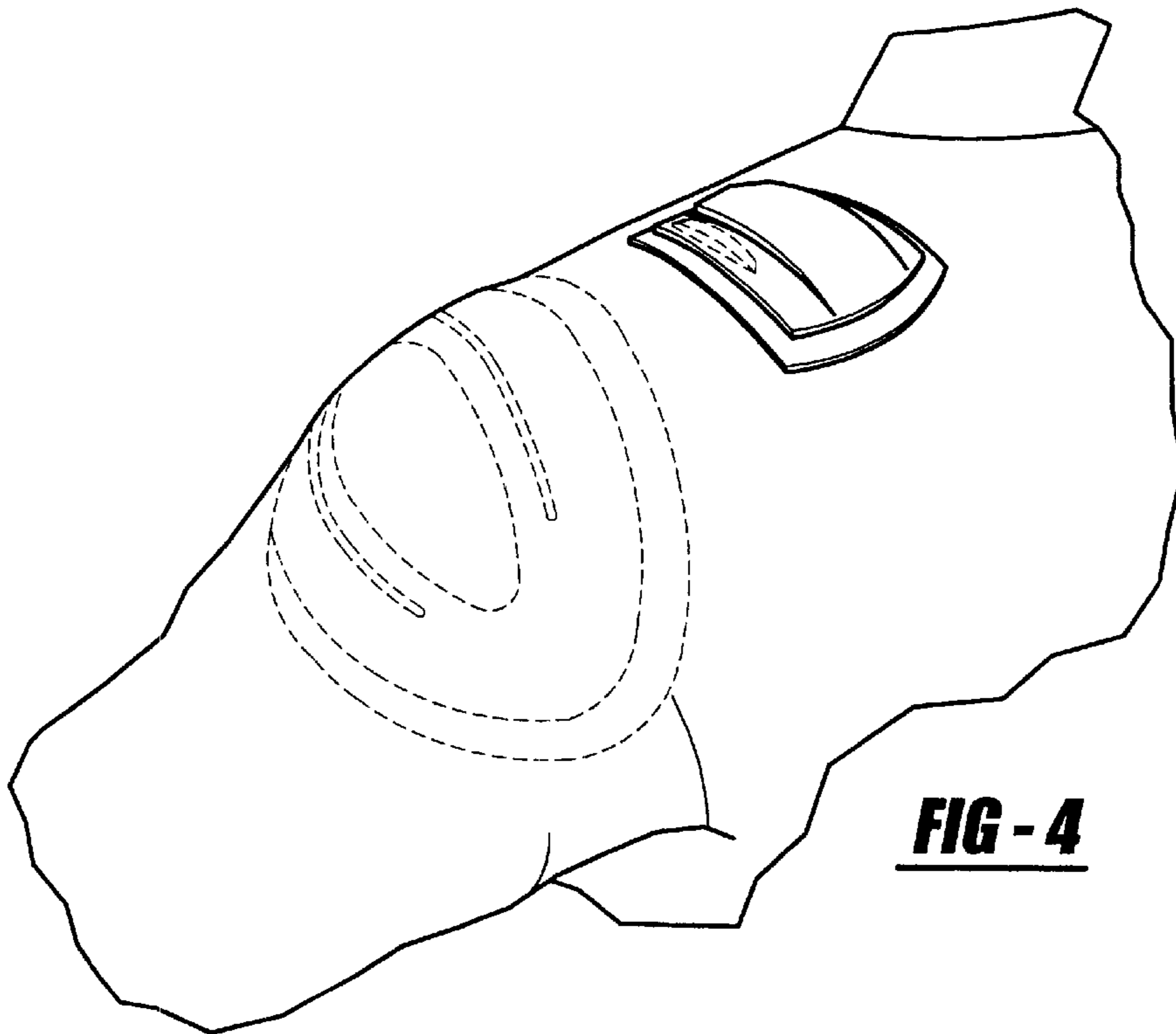

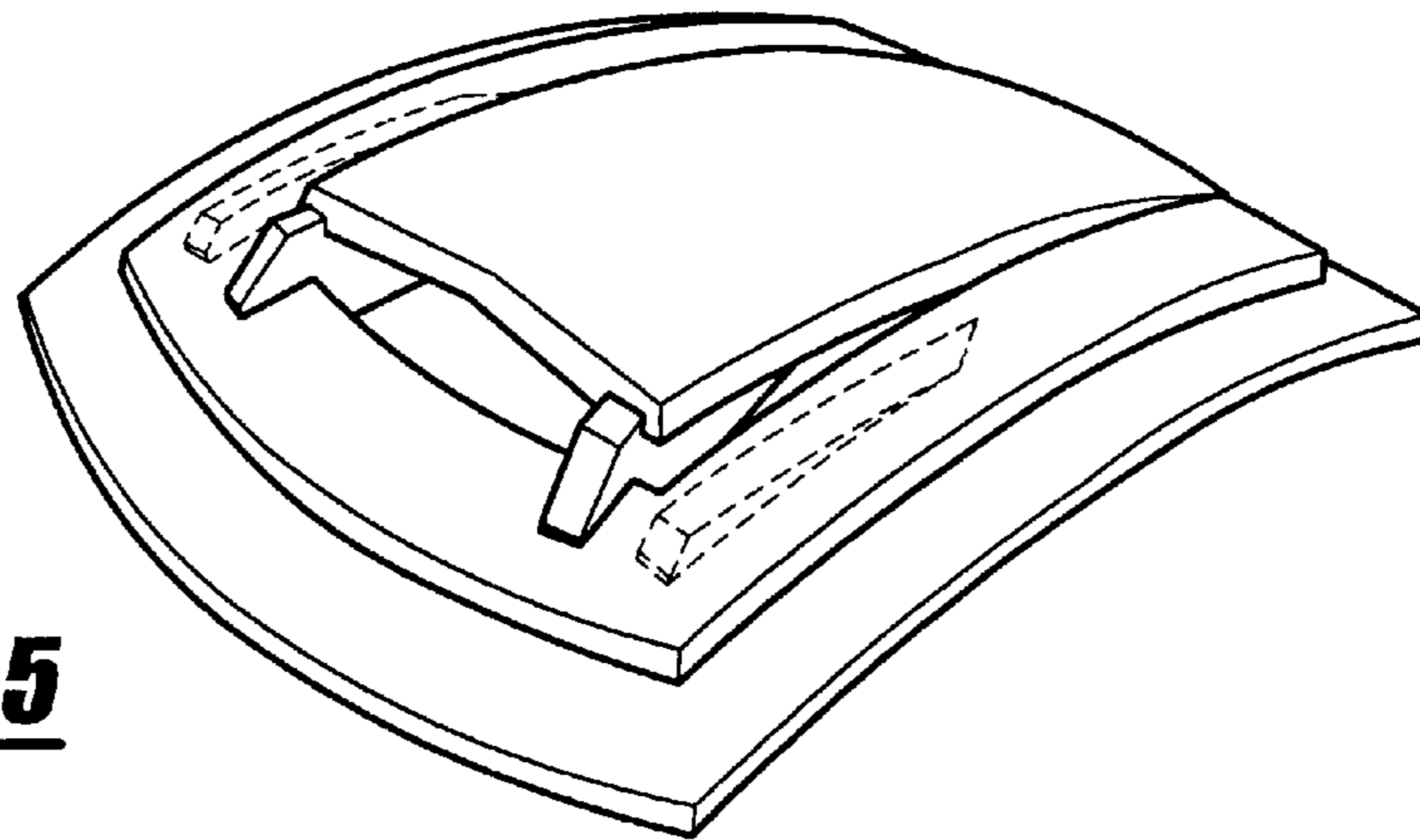

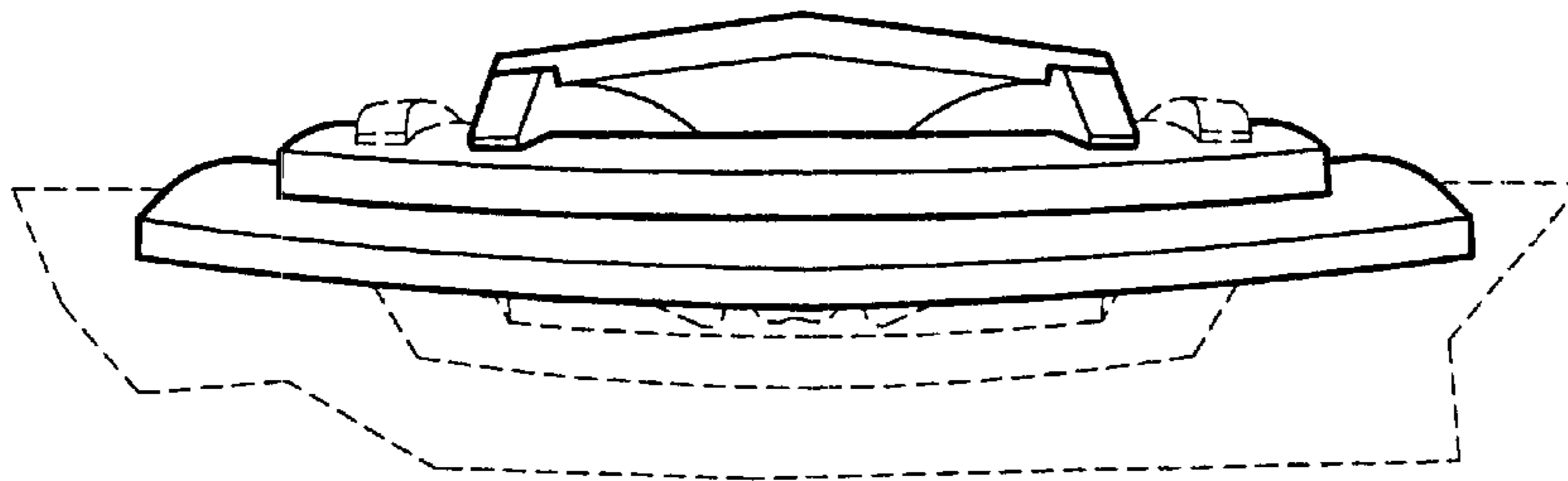

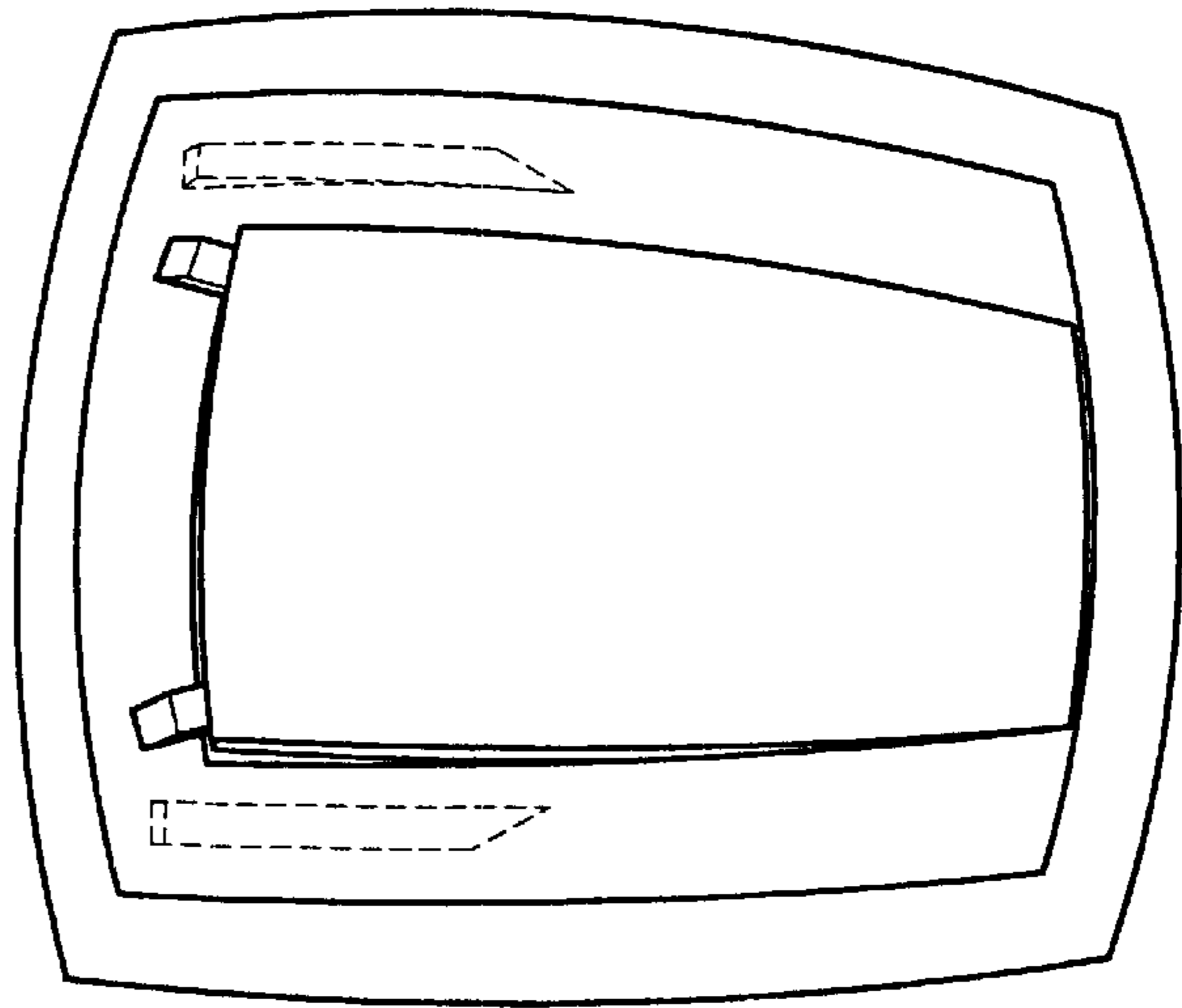

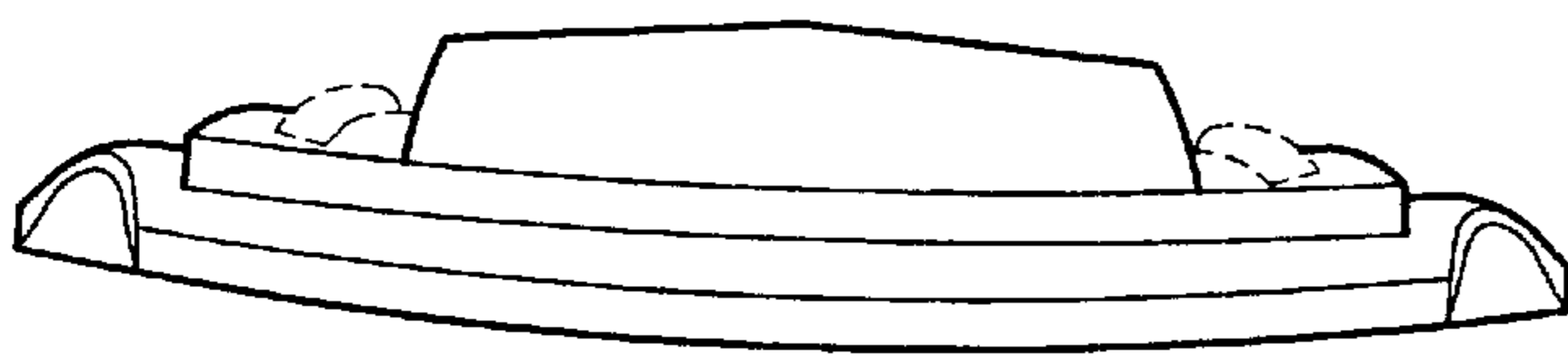

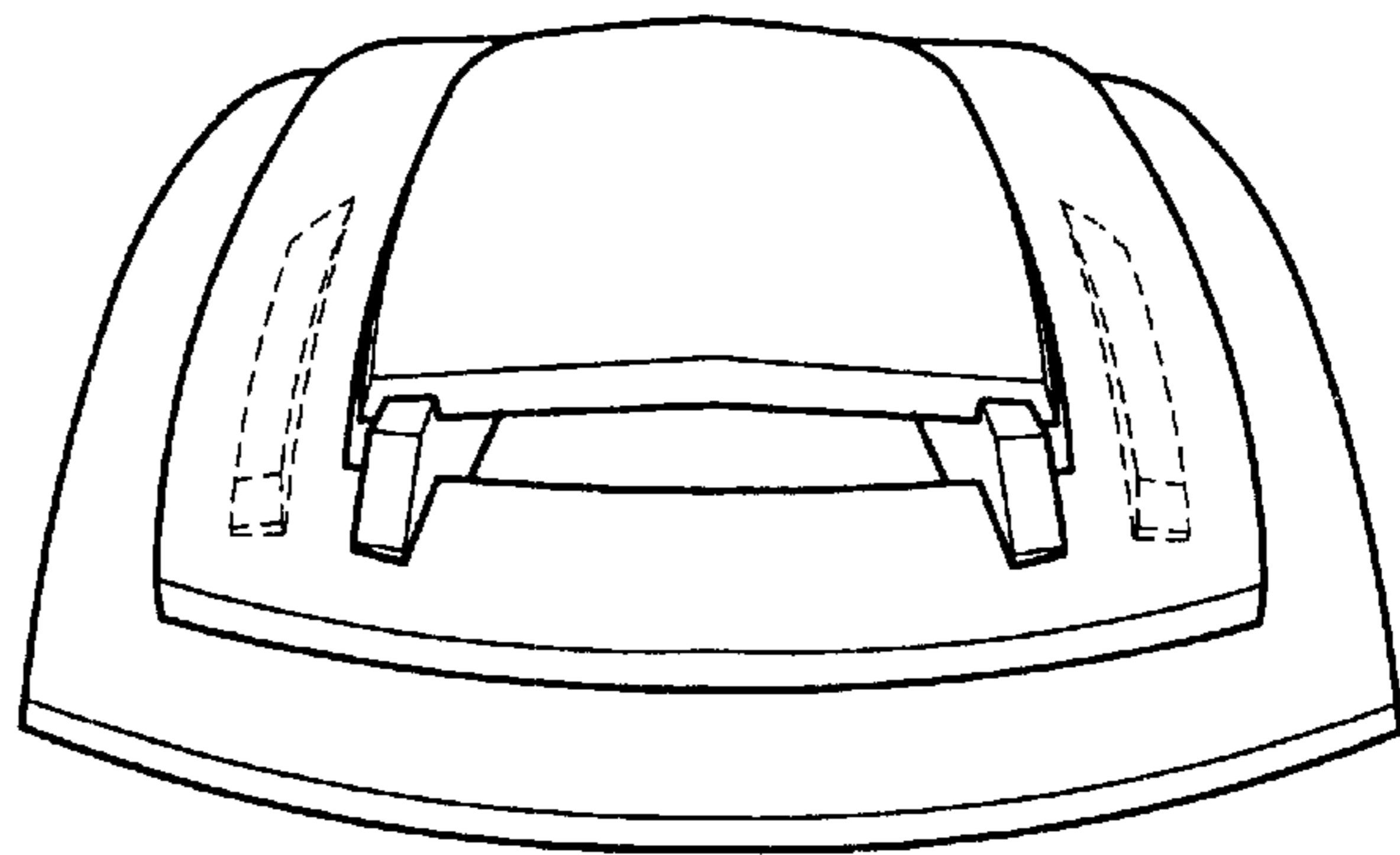
