(57) **CLAIM**

The ornamental design for an aircraft fuel cap opening tool, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an aircraft fuel cap opening tool according to the invention showing the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view, the left side identical mirror image thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken line portions of FIG. 1 are for illustrative purposes only and form no part of the claimed design.

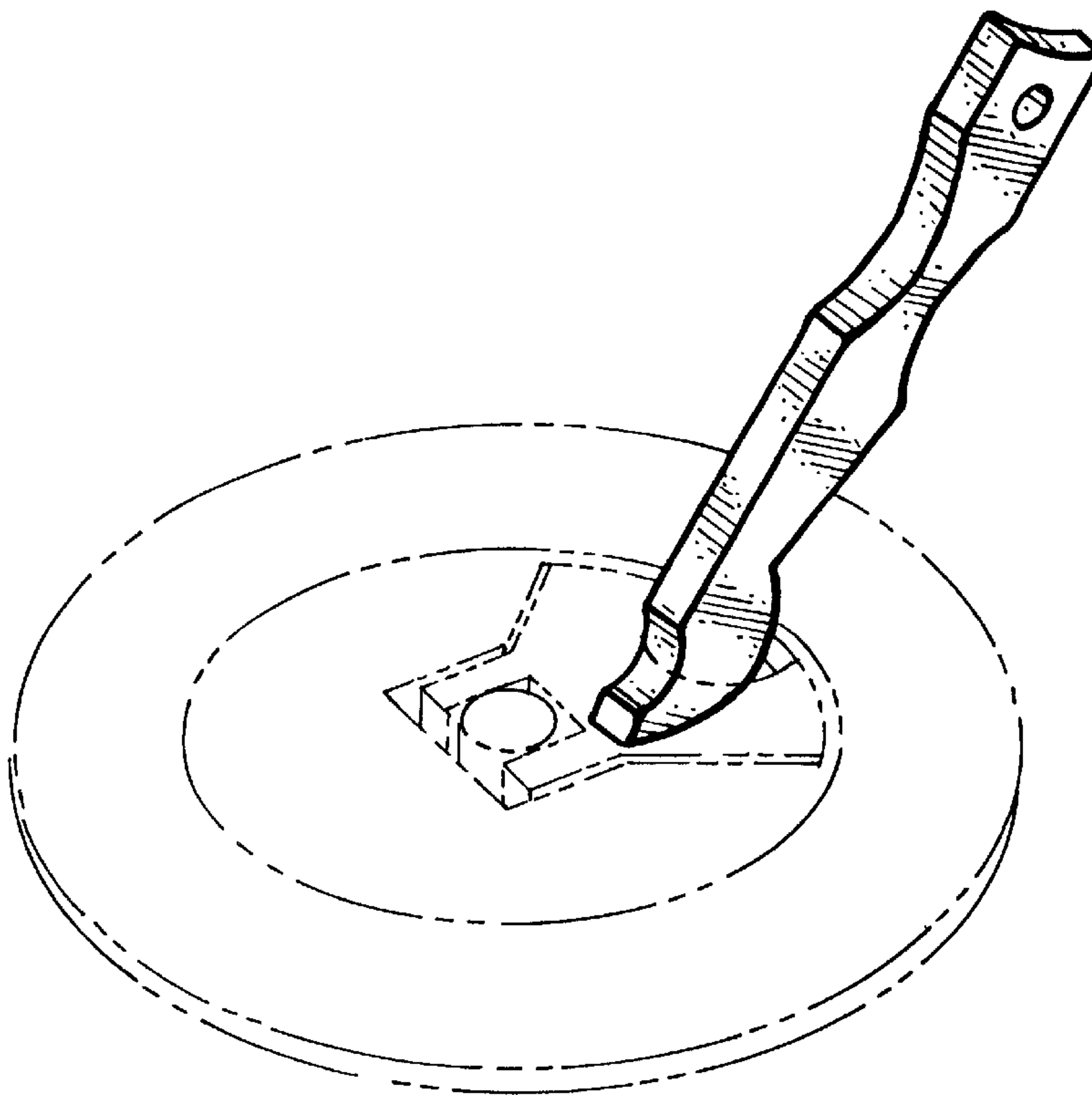

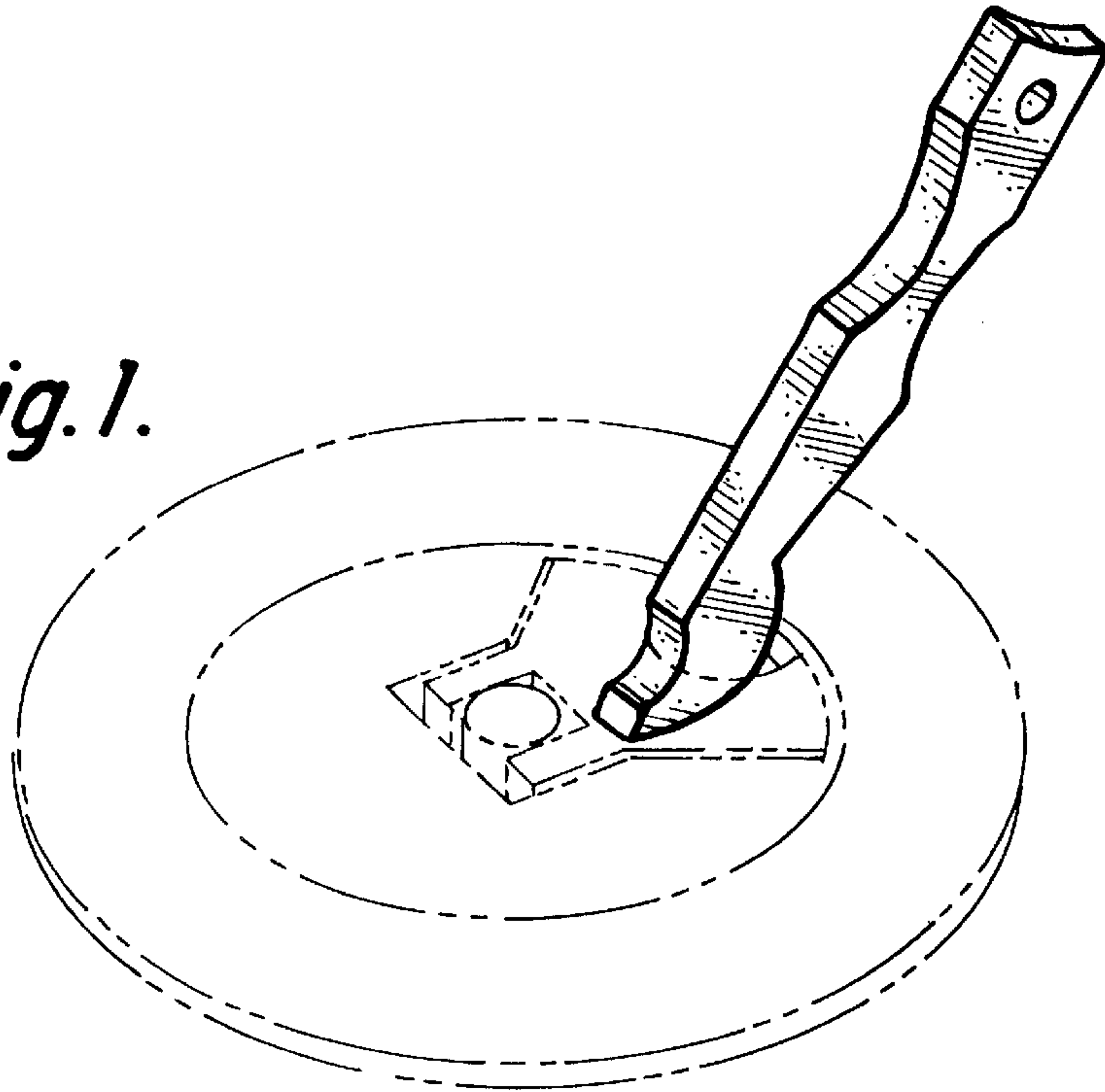
