(57) **CLAIM**

I claim the ornamental design for a plastic bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the plastic bottle showing the present invention.

FIG. 2 is a side elevation view of the plastic bottle of FIG. 1, all sides being identical.

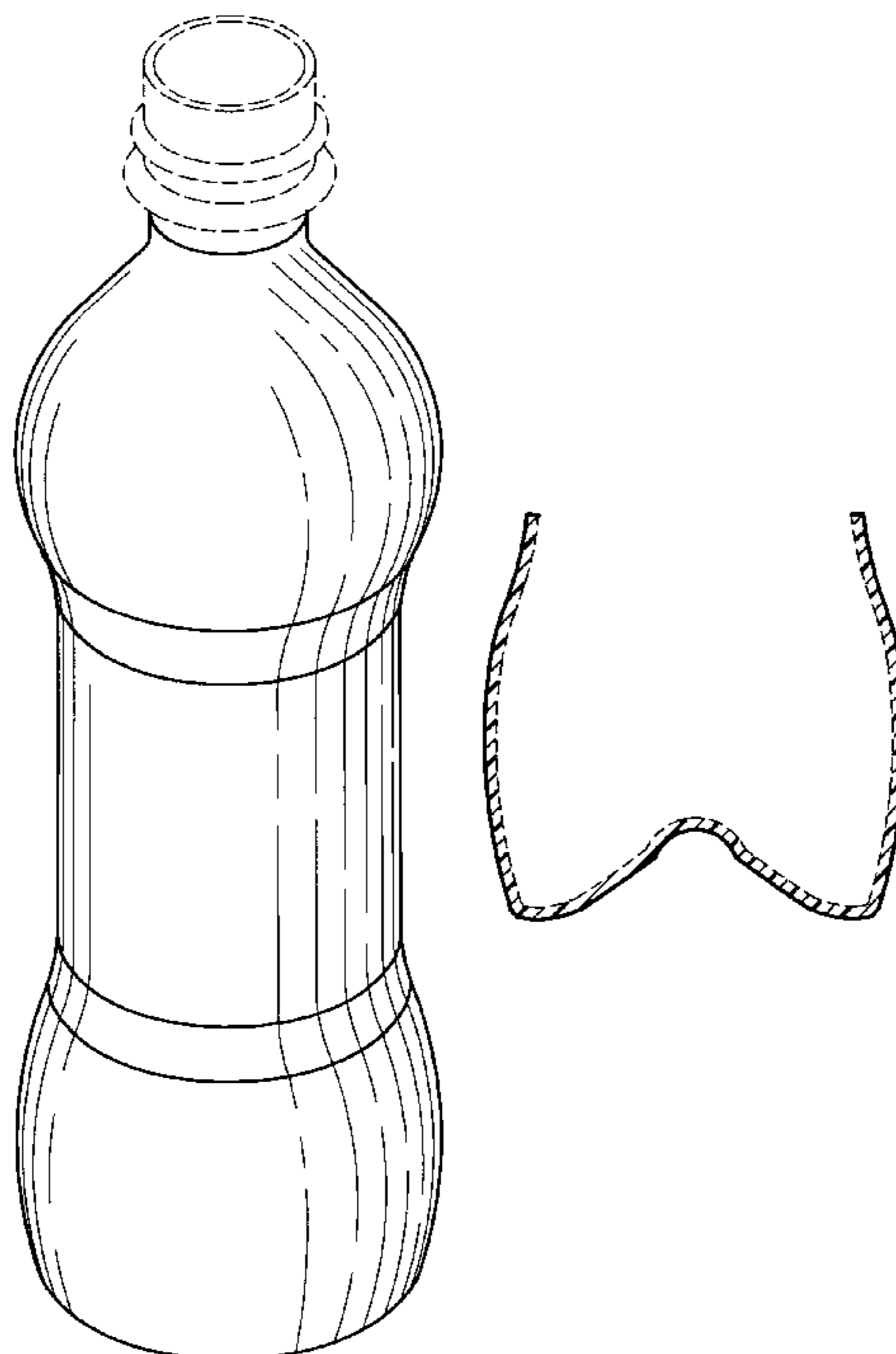
FIG. 3 is a plan view from the top of FIG. 2.

FIG. 4 is a plan view from the bottom of FIG. 2; and,

FIG. 5 is a partial section view of the lower sidewall and bottom portions of the plastic bottle taken along line 5—5 of FIG. 4.

The broken line showing in FIGS. 1-3 & 5 is for environmental purposes only and forms no part of the claimed design.

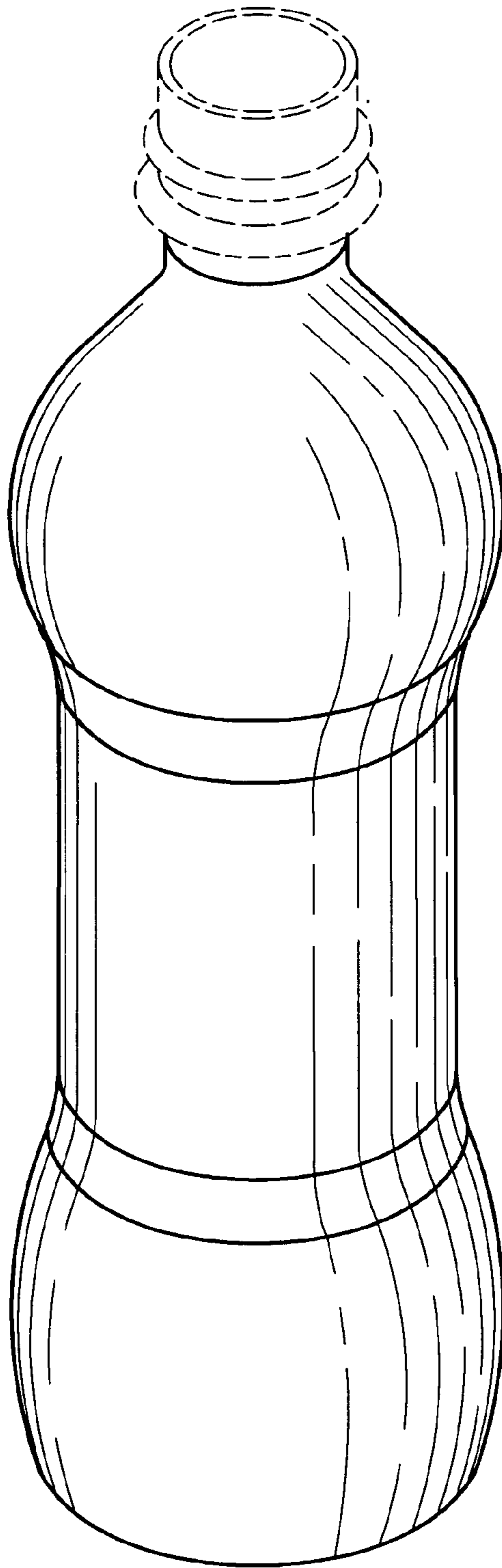

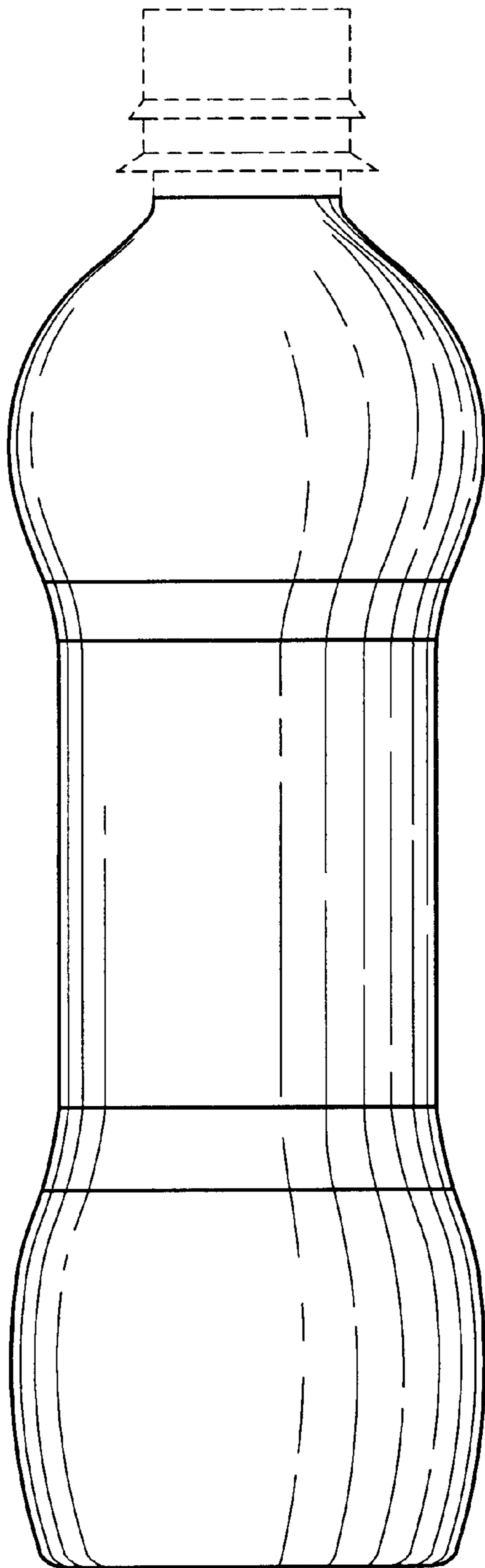

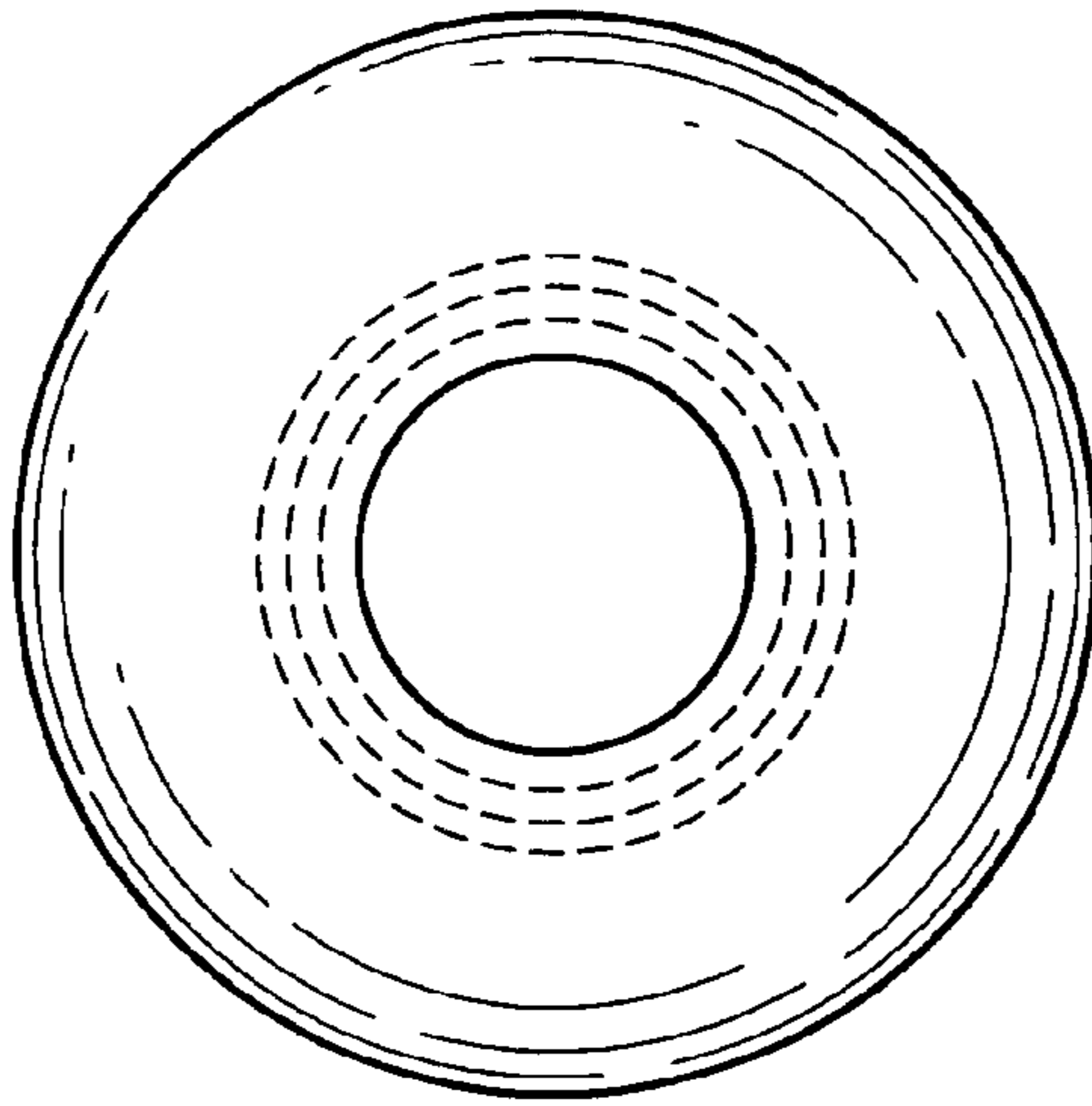

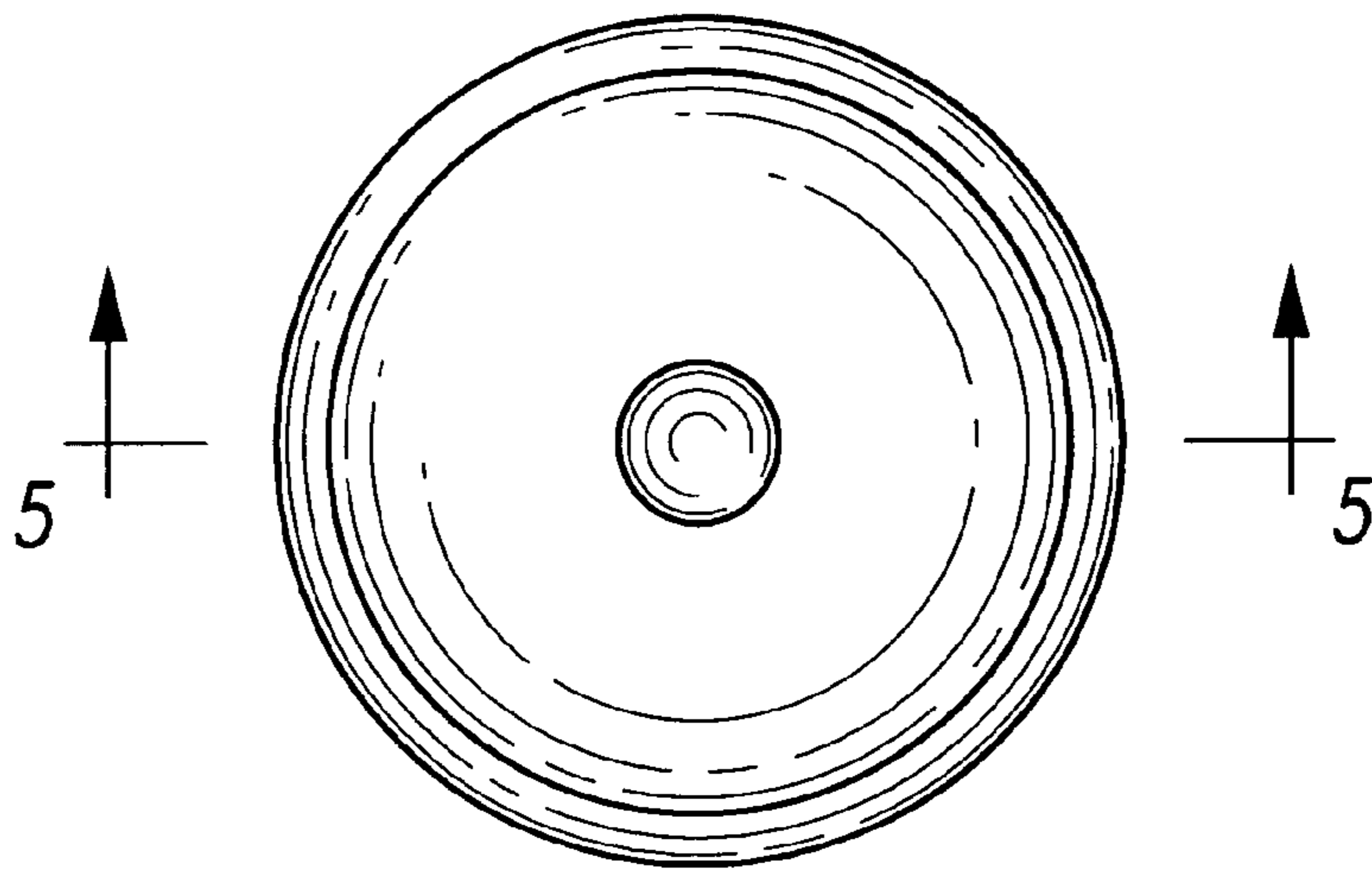

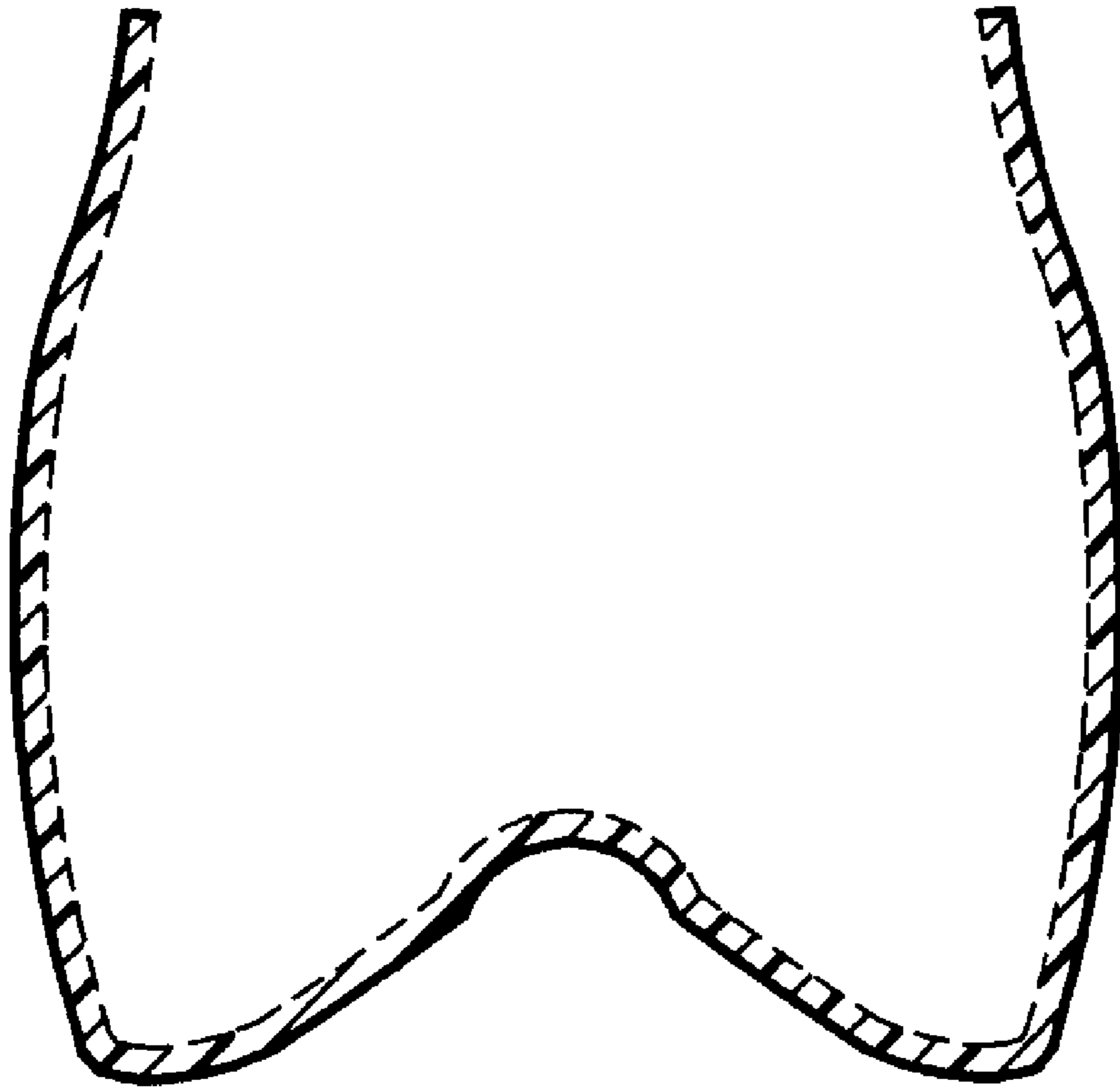
