(57) **CLAIM**

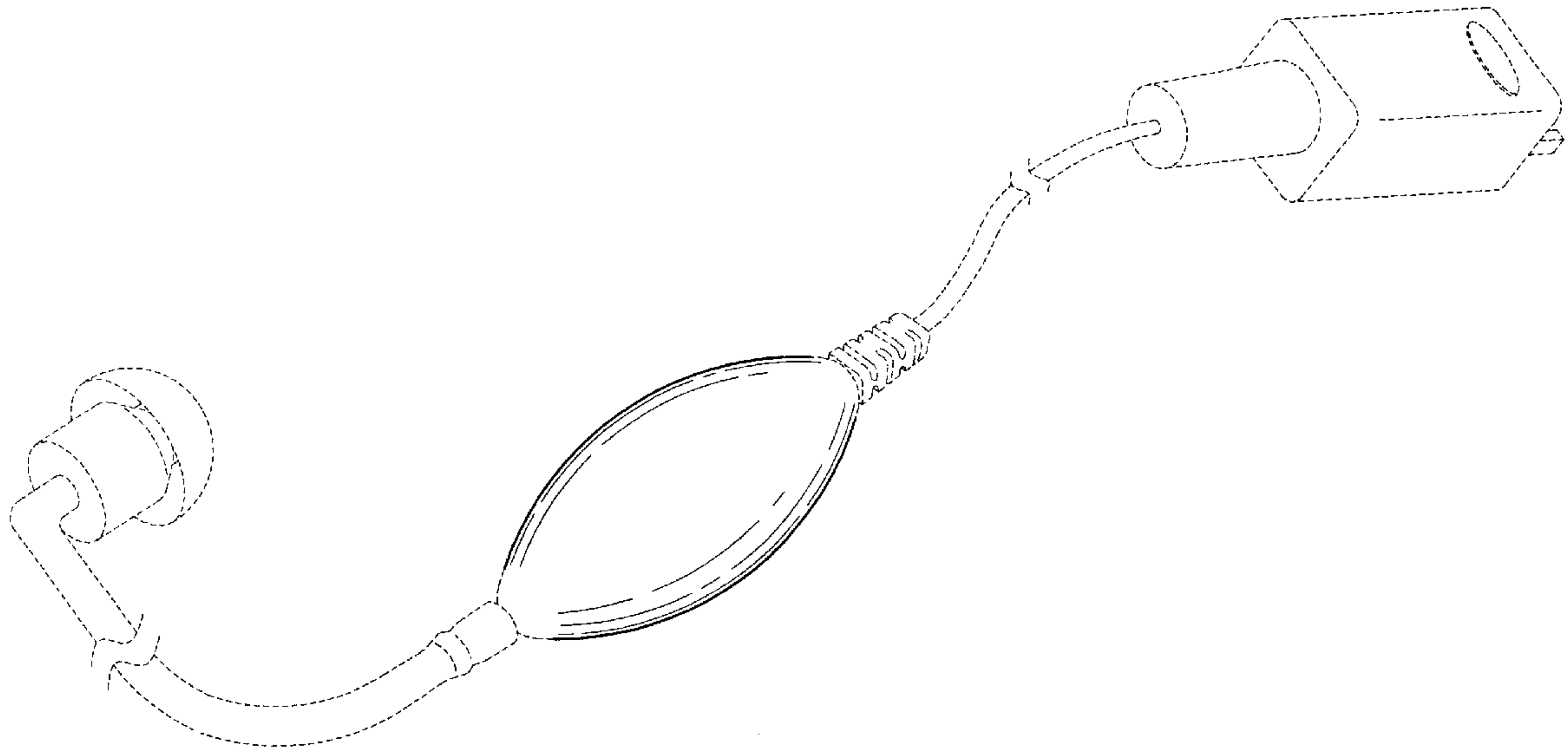
The ornamental design for a microphone and speaker capsule for cellular phone headset, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the microphone and speaker capsule of the present design;  
FIG. 2 is a front view of the microphone and speaker capsule of FIG. 1, the back view being identical thereto;  
FIG. 3 is a bottom view of the microphone and speaker capsule of FIG. 1; and,  
FIG. 4 is a top view of the microphone and speaker capsule of FIG. 1.

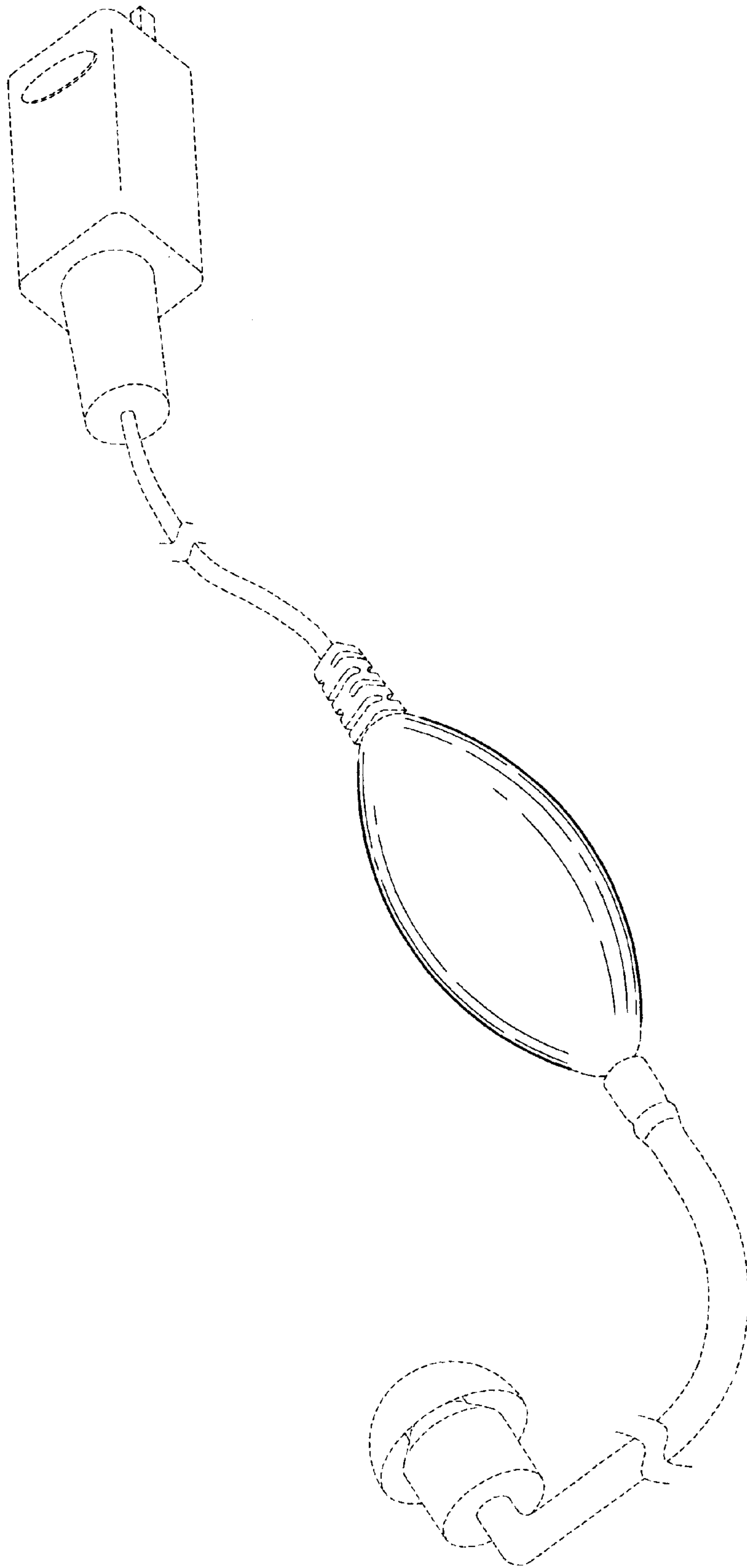

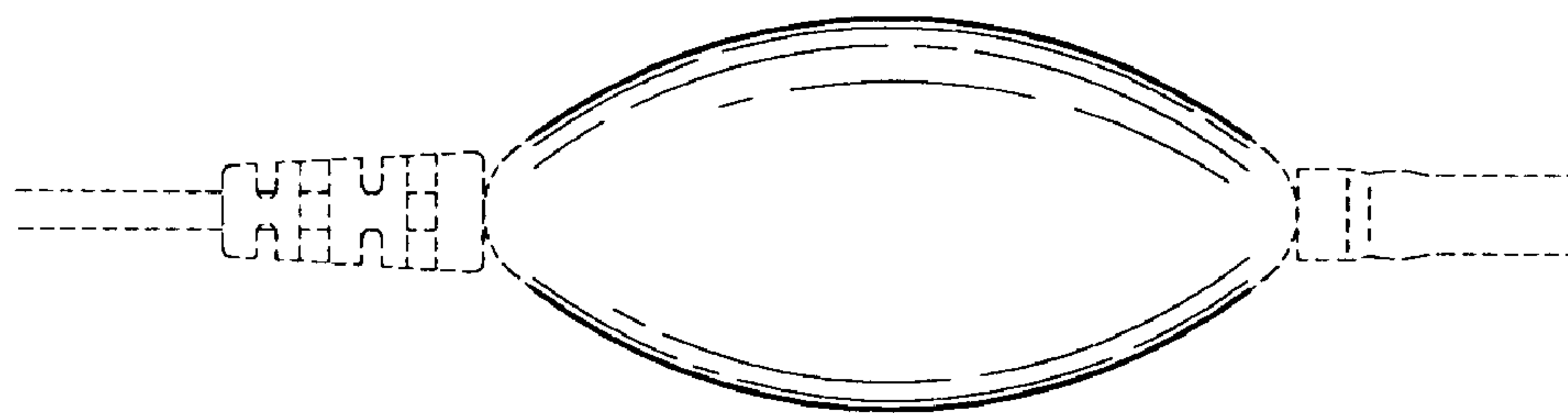

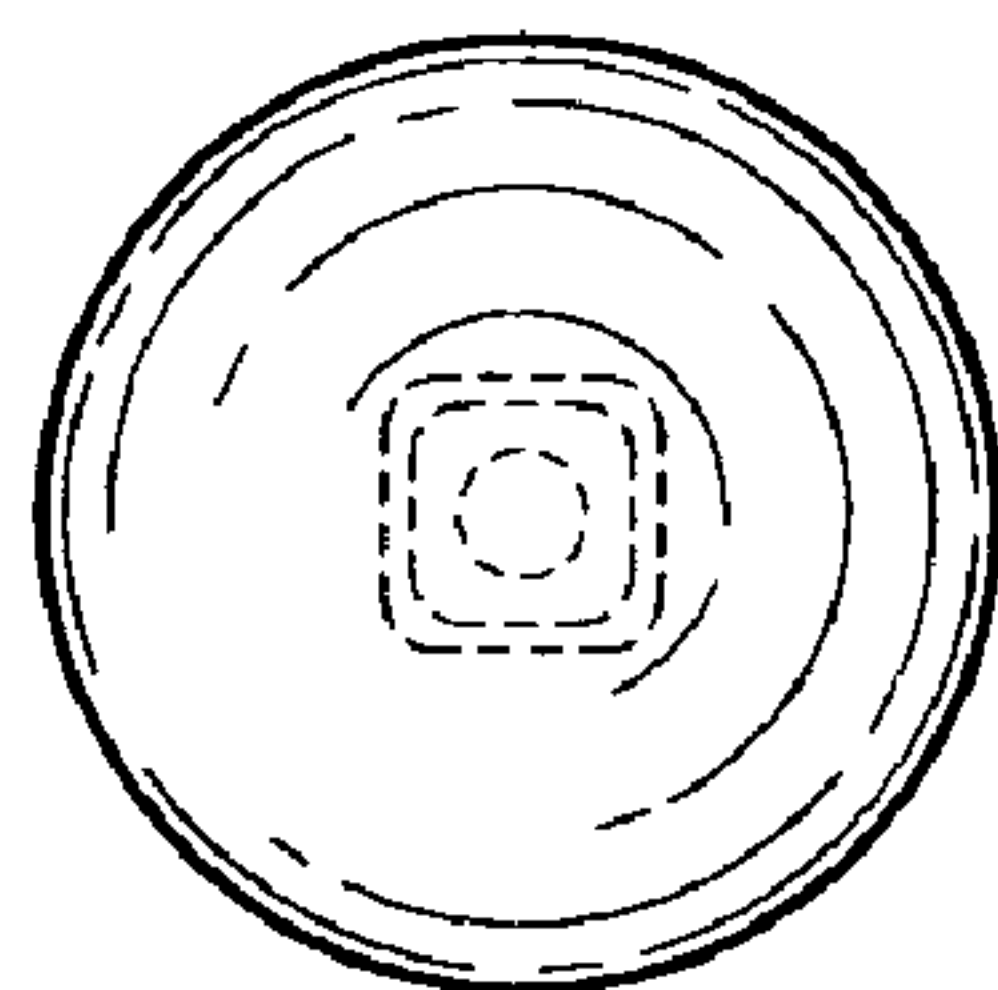

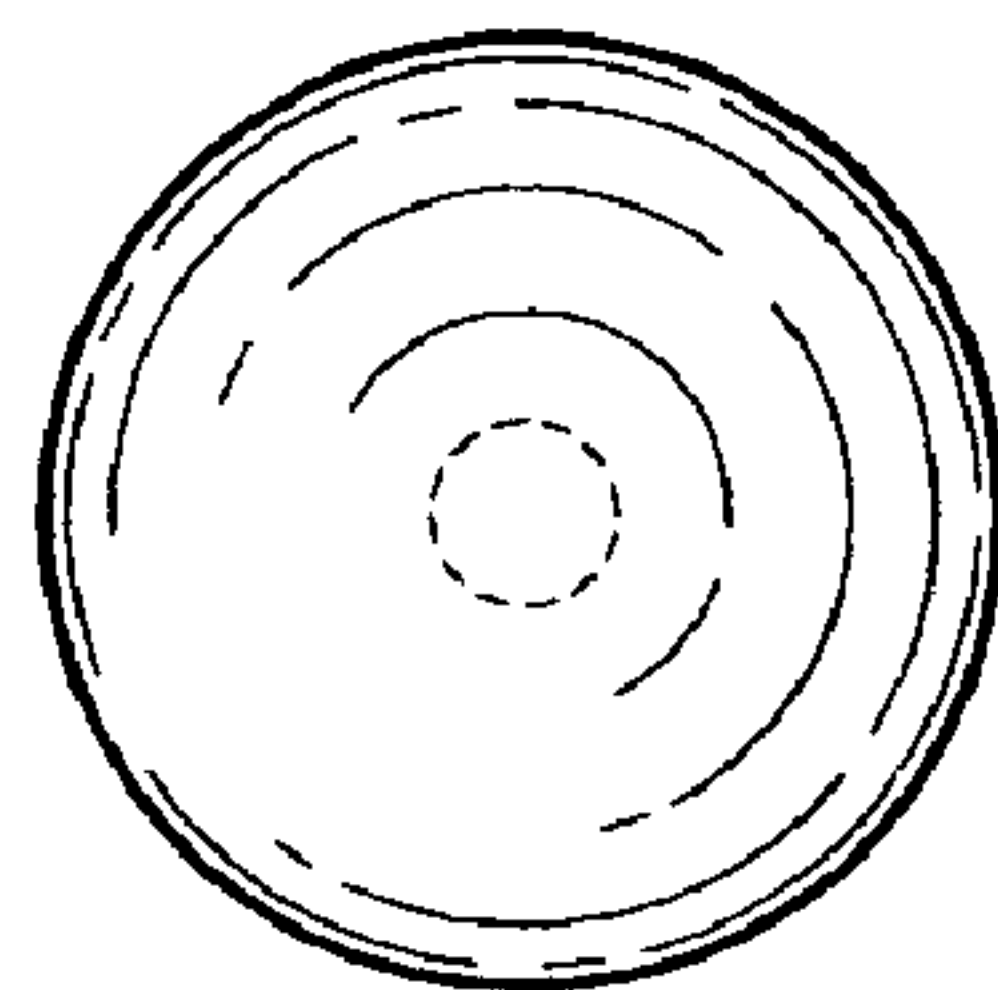
