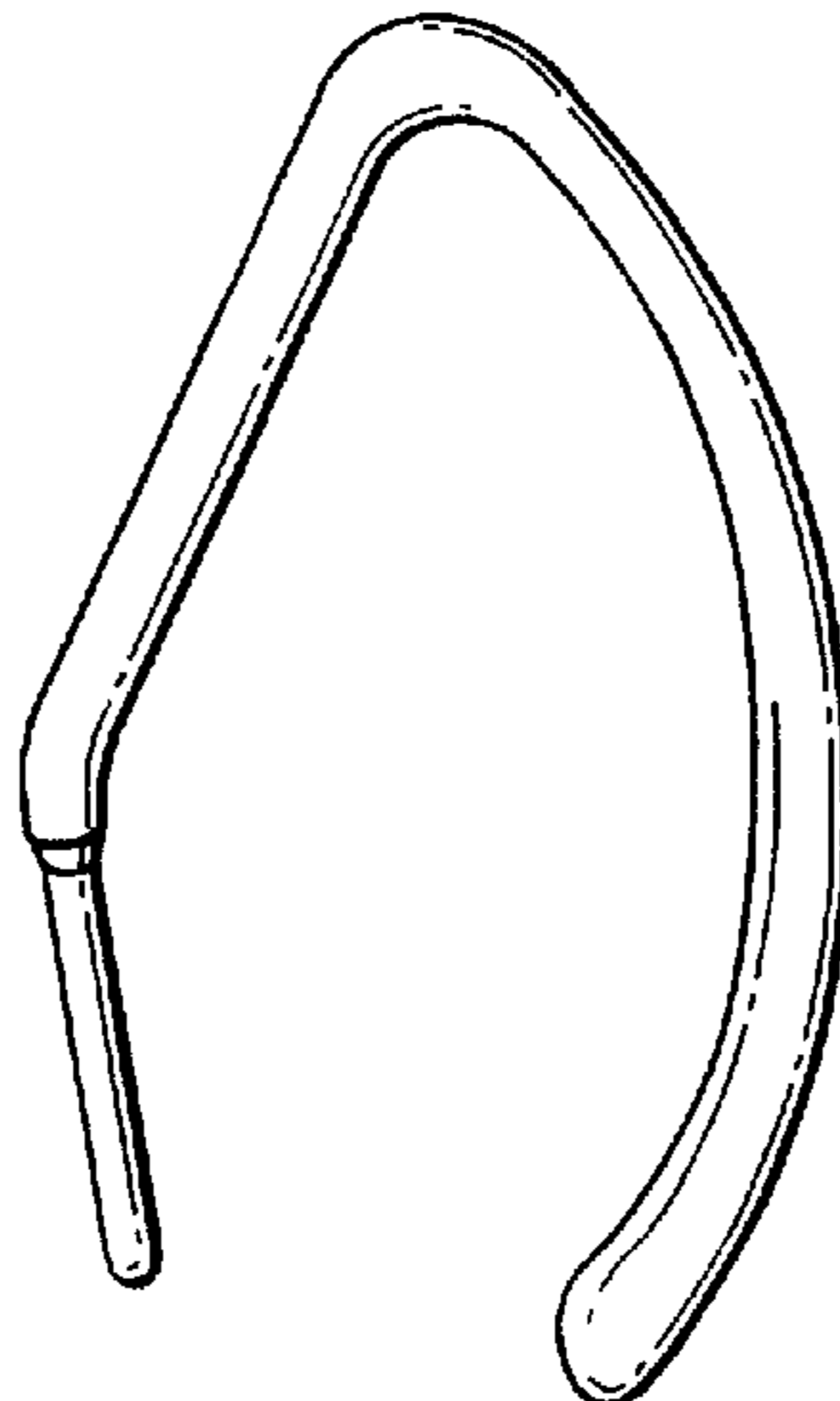
(57) **CLAIM**

The ornamental design for telephone headset earhook, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective end view of the telephone headset earhook; FIG. 2 is a side view of the telephone headset earhook; FIG. 3 is a top end view of the telephone headset earhook; and FIG. 4 is a bottom view of the telephone headset earhook; FIG. 5 is an end view of the telephone headset earhook; and, FIG. 6 is an end view opposite FIG. 5 of the telephone headset earhook.

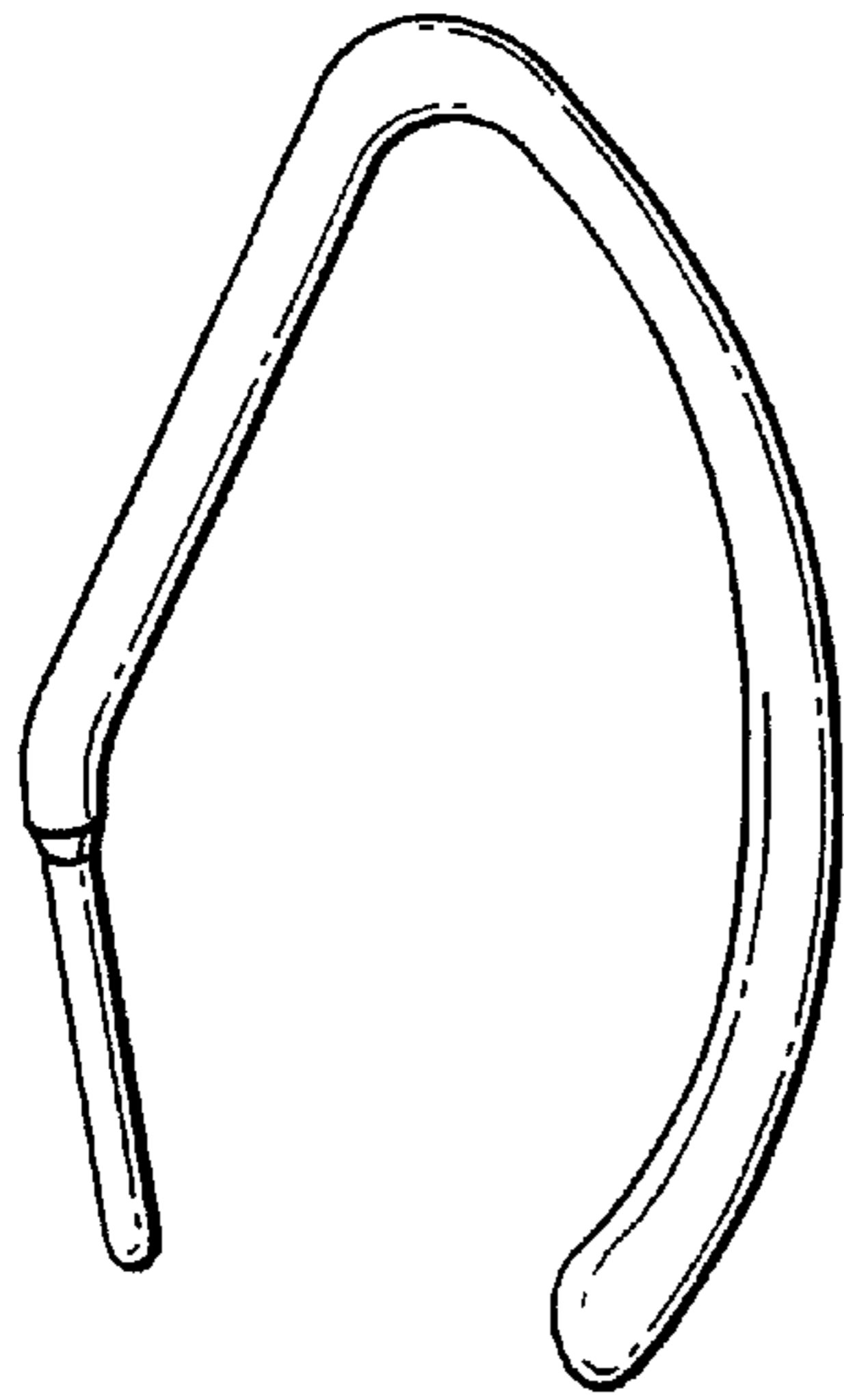

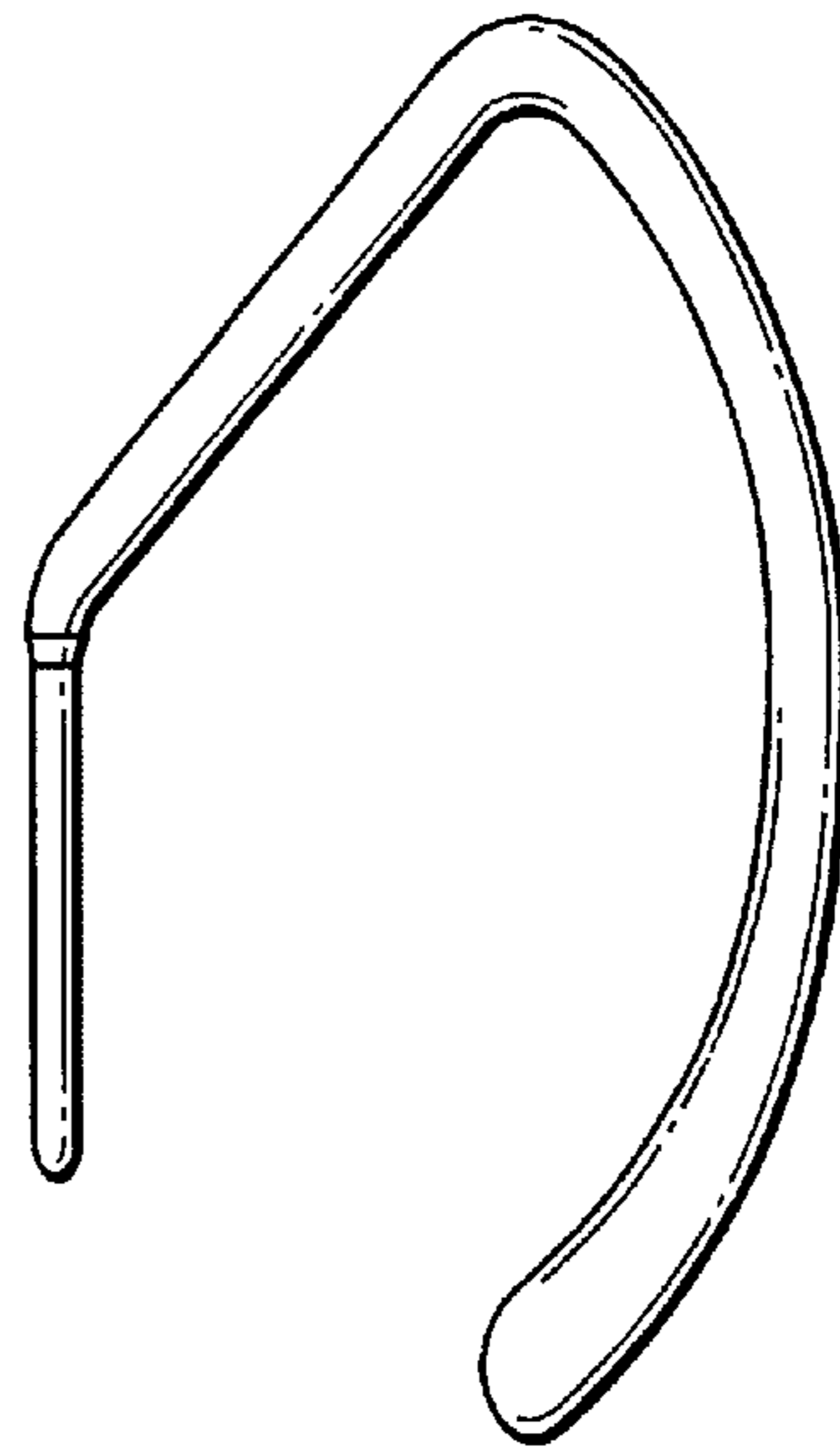
