The ornamental design for a front face for a handheld navigation device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a front face for a handheld navigation device according to the present invention;

FIG. 2 is a front elevational view thereof;

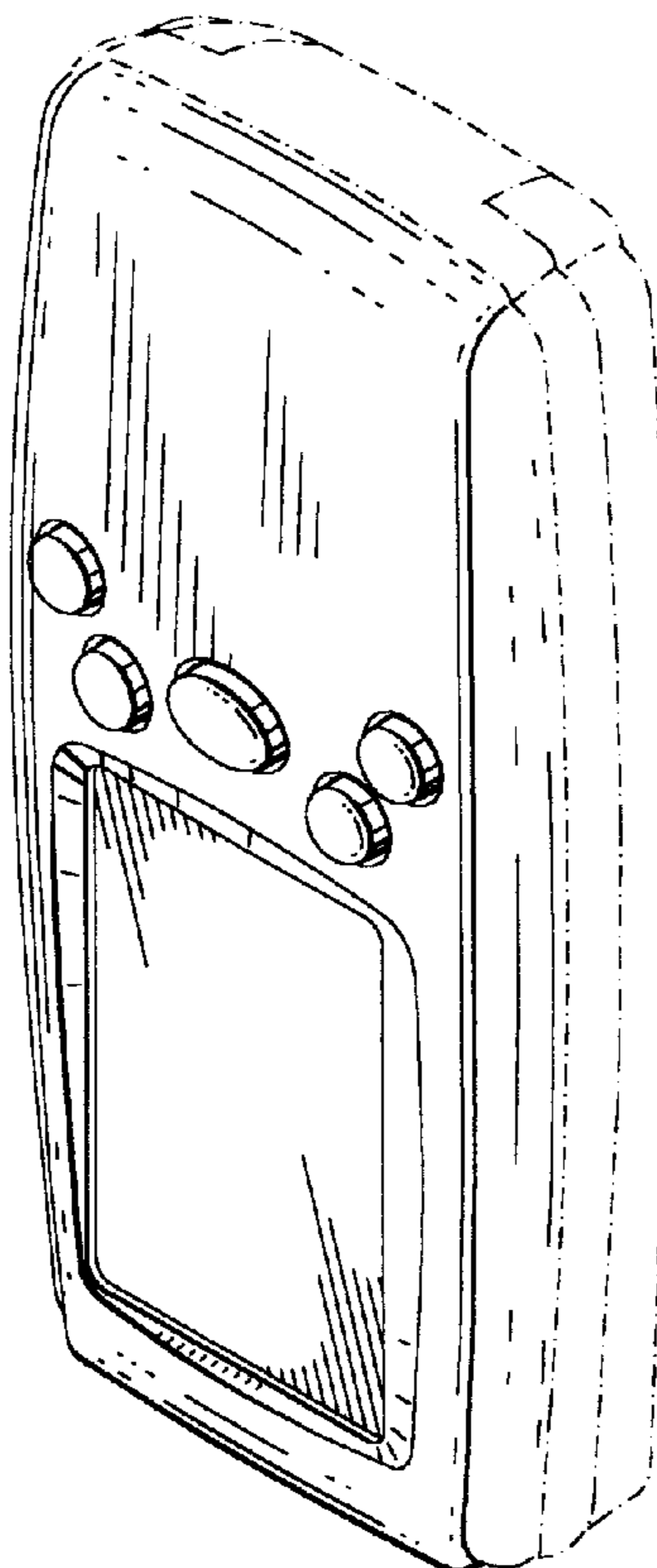
FIG. 3 is a top plan view thereof;

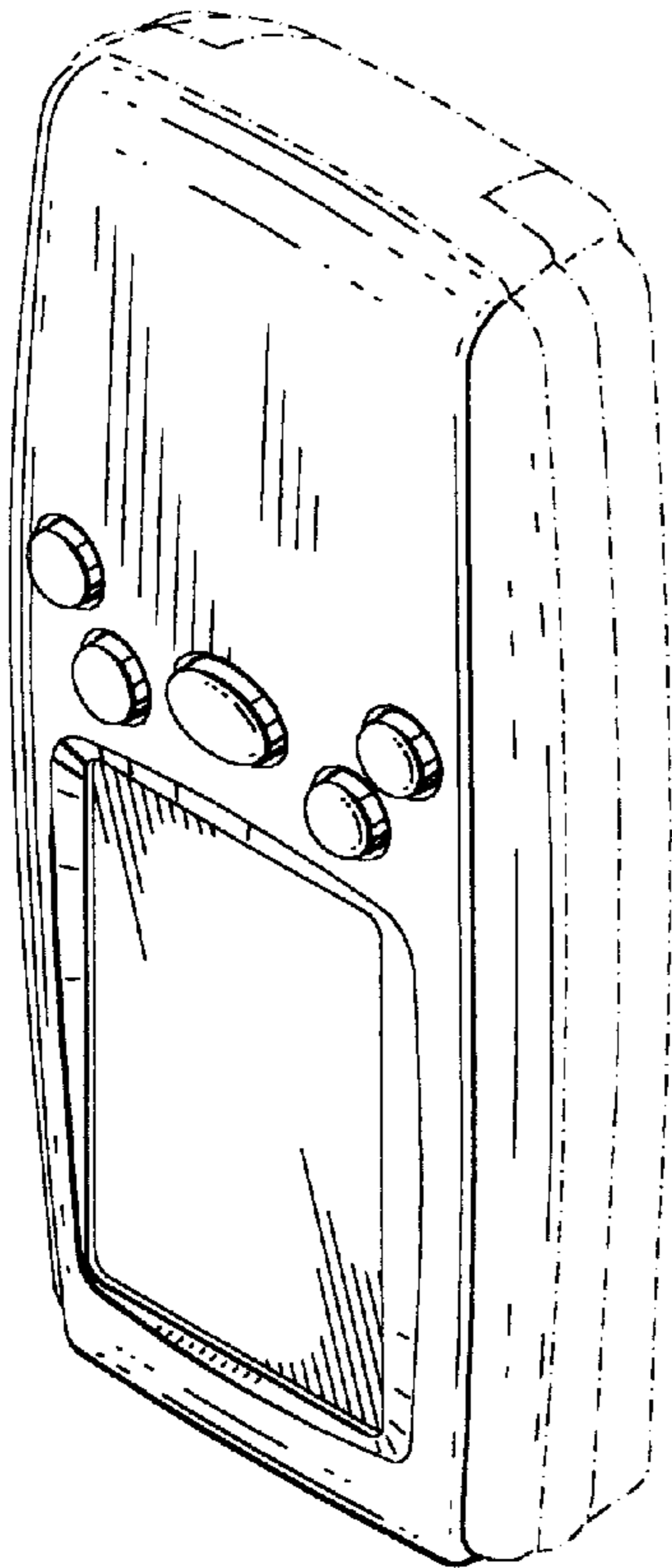

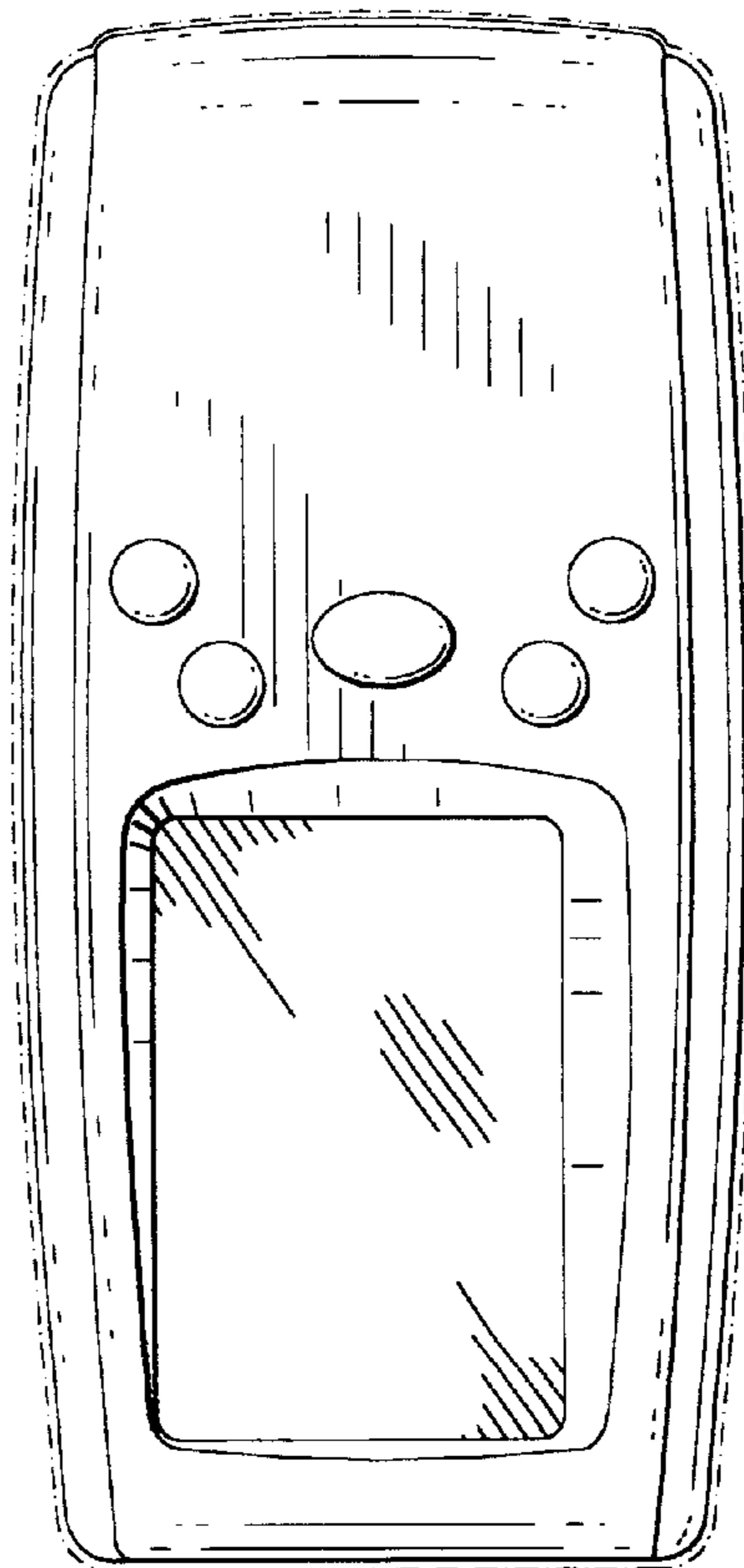

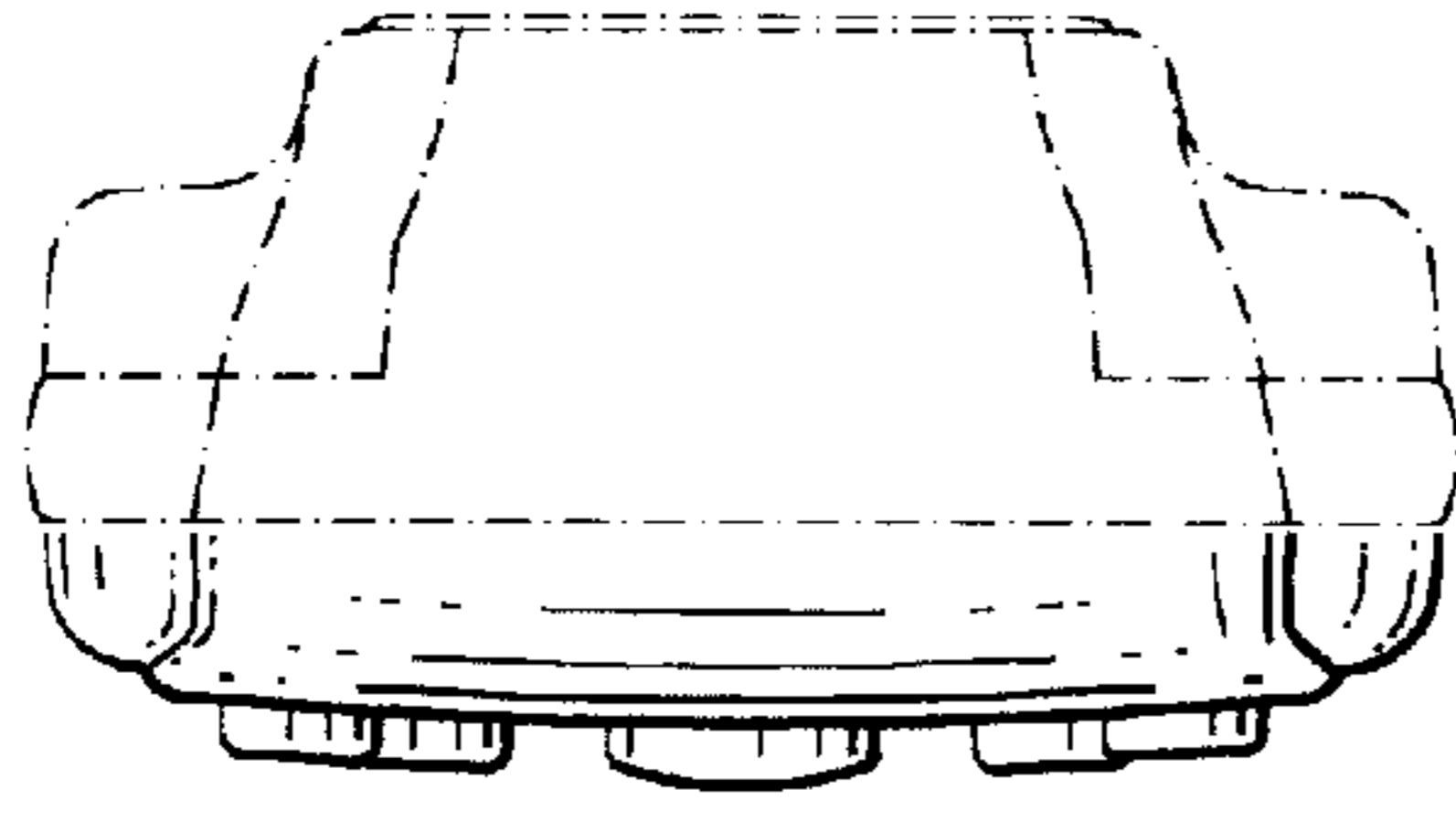

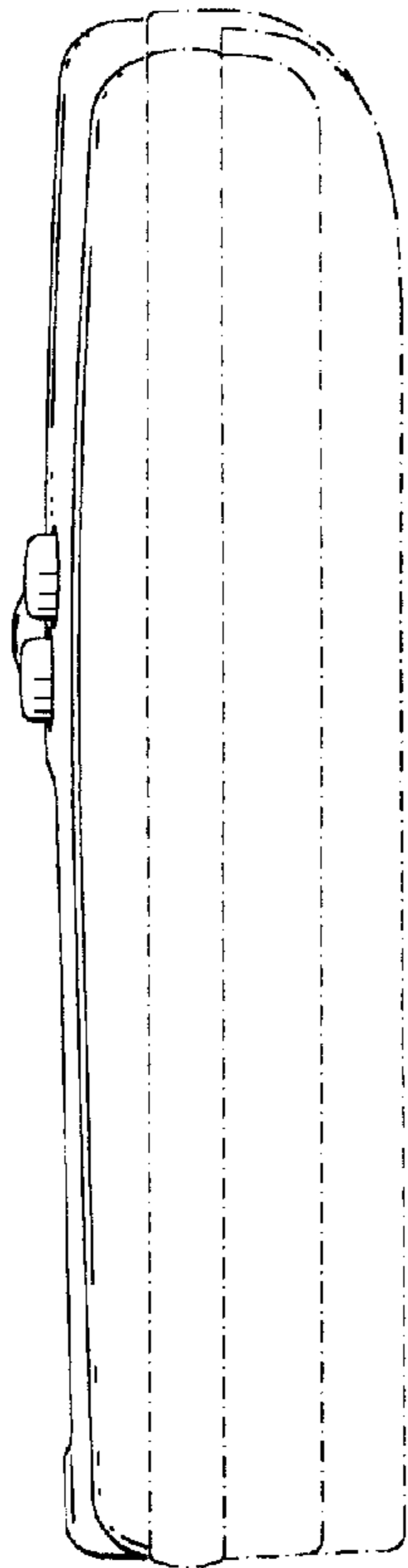

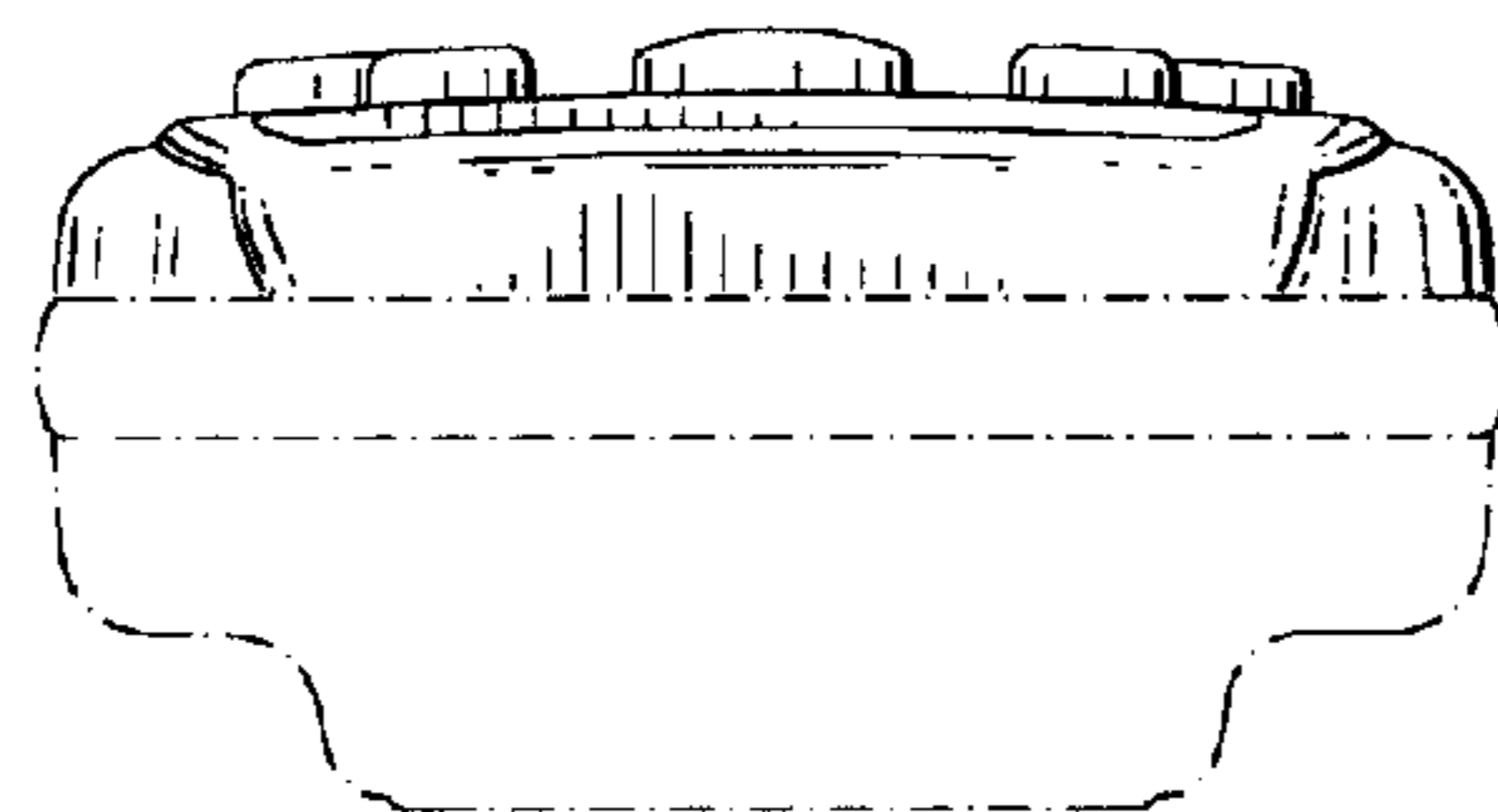
