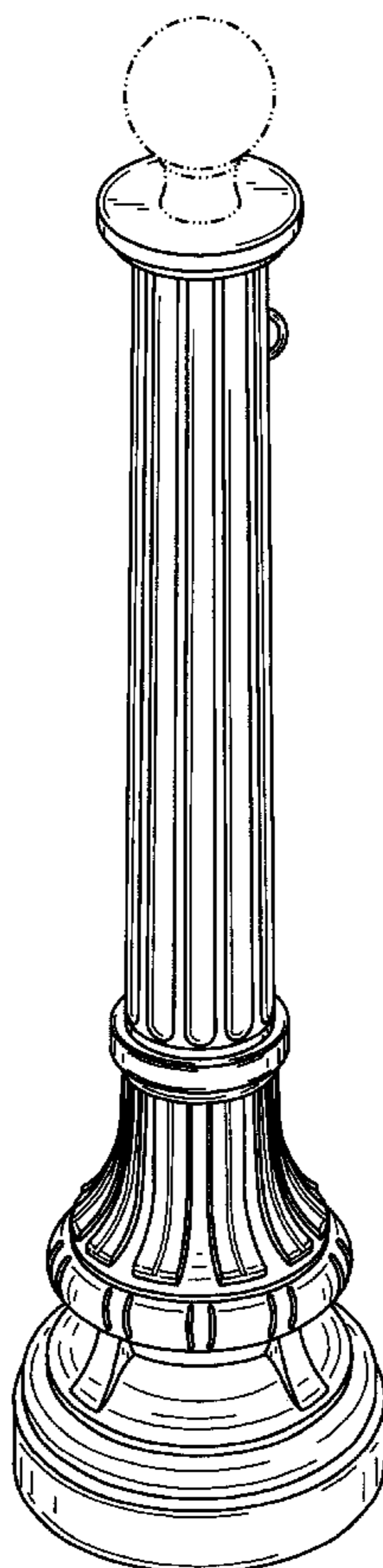

(57) **CLAIM**

The ornamental design for a multipurpose ornamental post, as shown and described.

FIG. 1 is a front perspective view of a multipurpose ornamental post with a globe mounted on the top thereof, showing my new design;

FIG. 4 is a right side elevation view thereof;

FIG. 6 is a front perspective view of a second embodiment of a multipurpose ornamental post with a cylindrical shaped object mounted on the top thereof; showing my new design;

FIG. 9 is a front perspective view of a third embodiment of a multipurpose ornamental post with a lantern shaped object mounted on the top thereof; showing my new design;

FIG. 12 is a front perspective view of a fourth embodiment of a multipurpose ornamental post with a rectangular shaped object mounted on the top thereof; showing my new design;

FIG. 16 is a right side elevation view thereof.

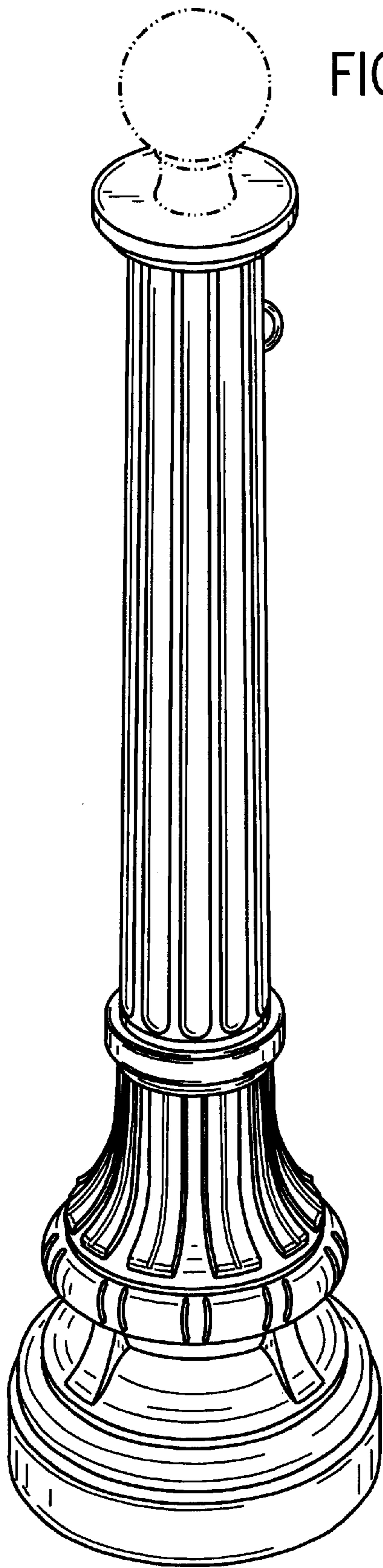

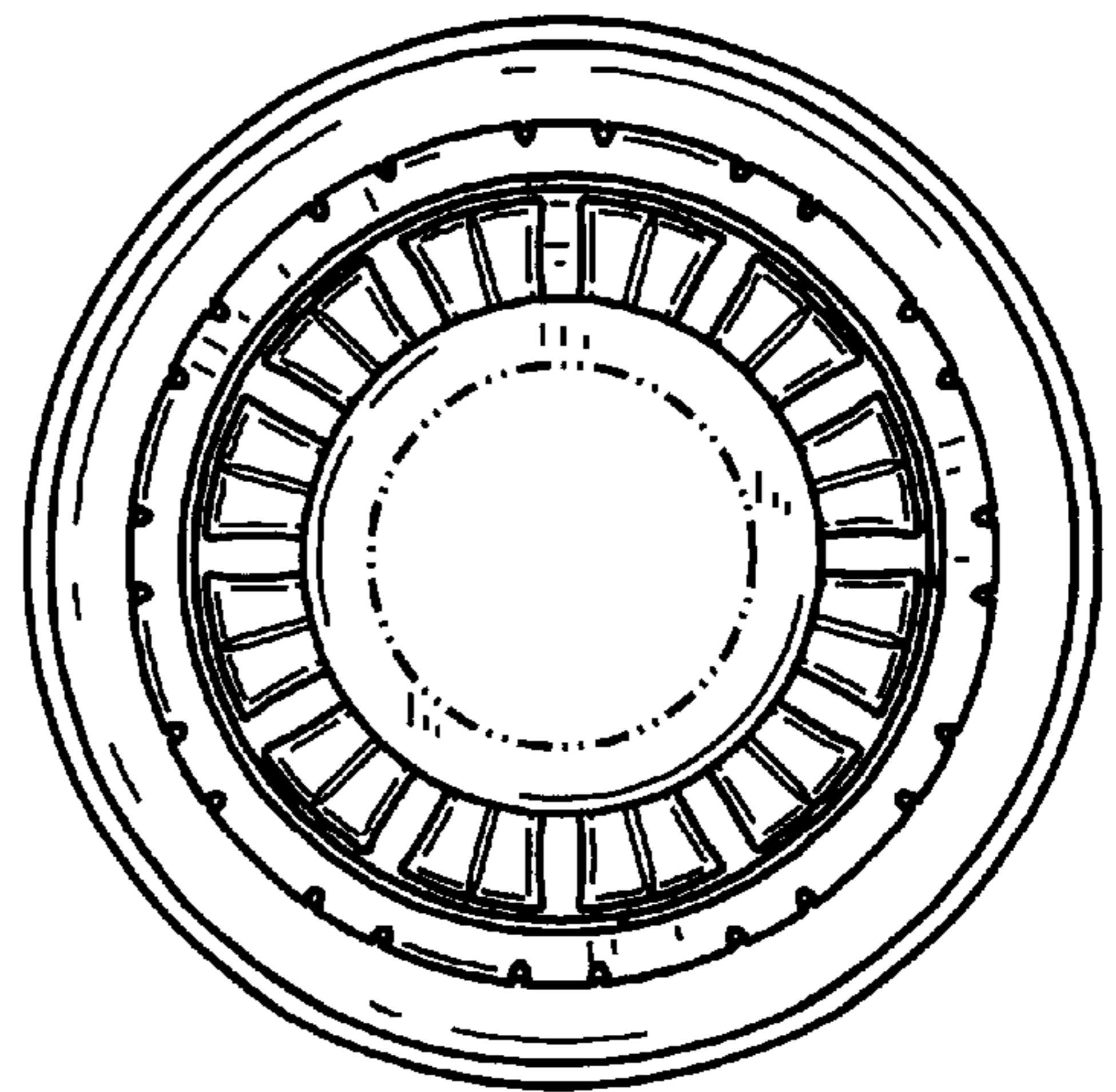
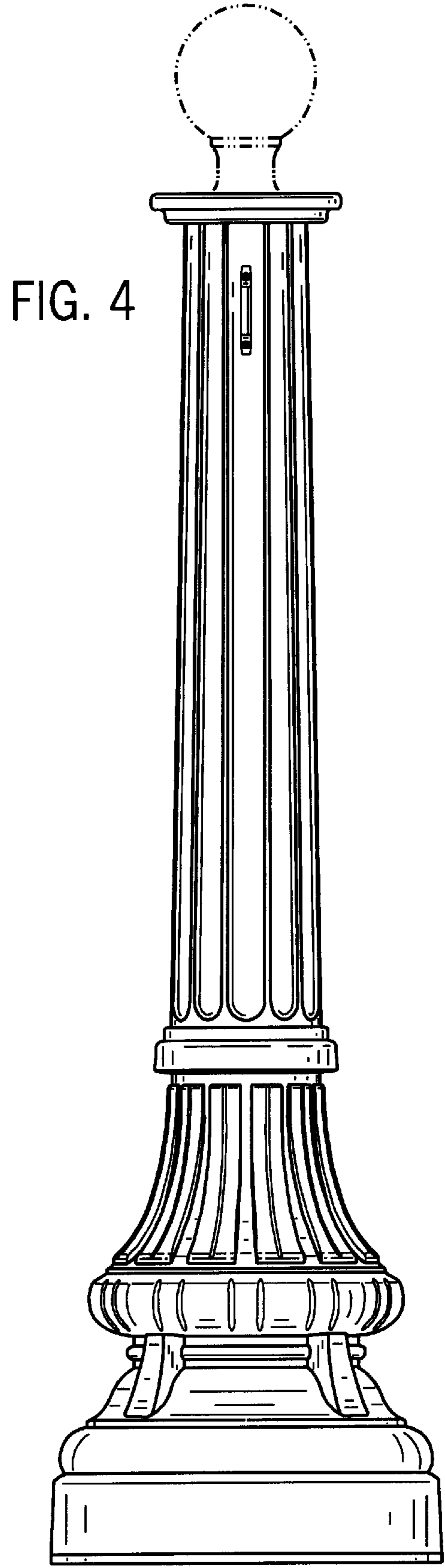
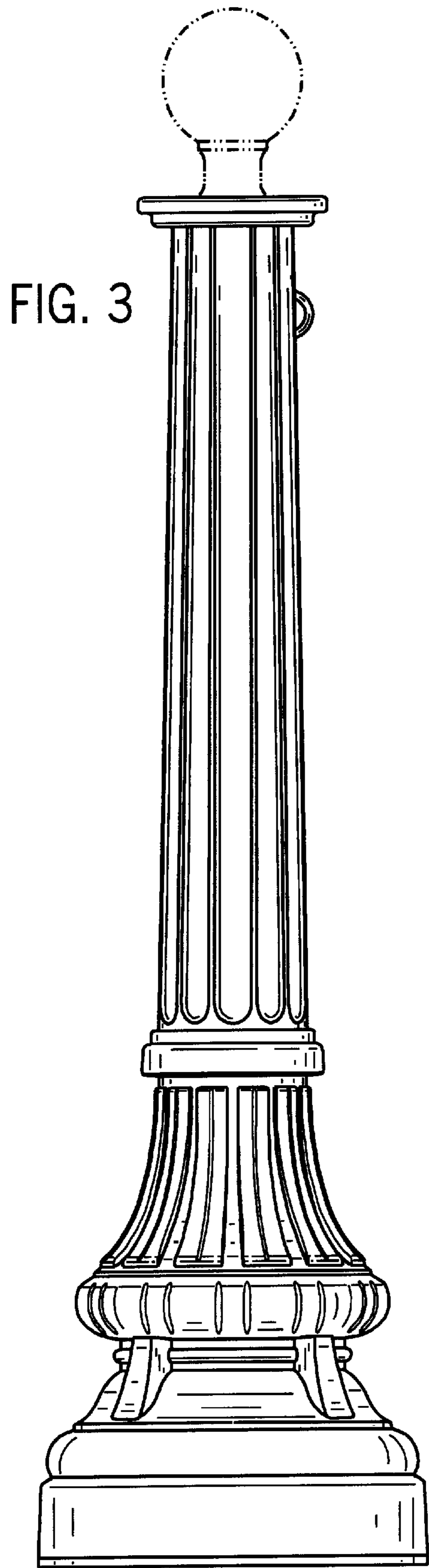

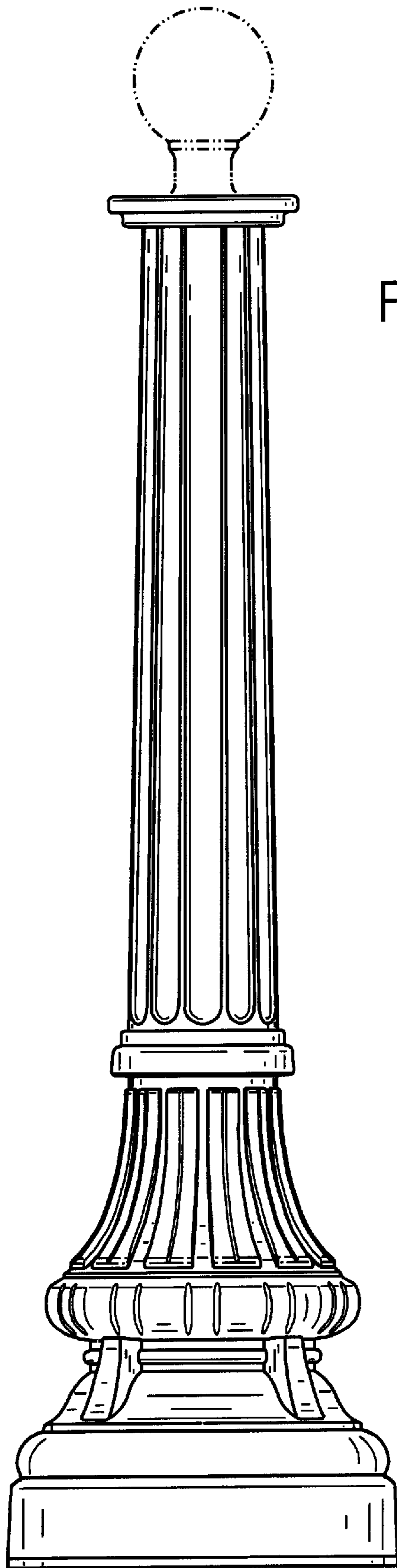

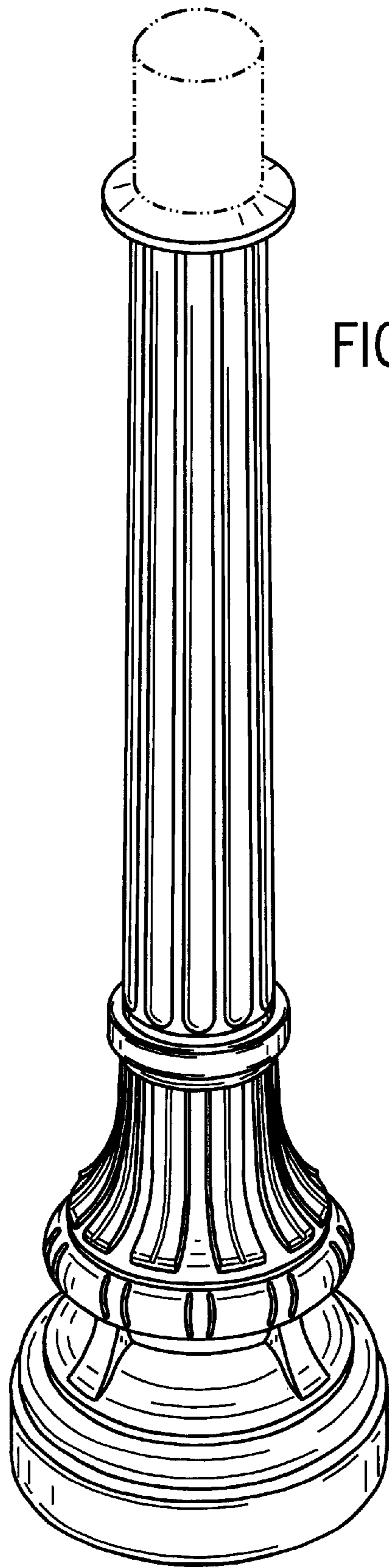

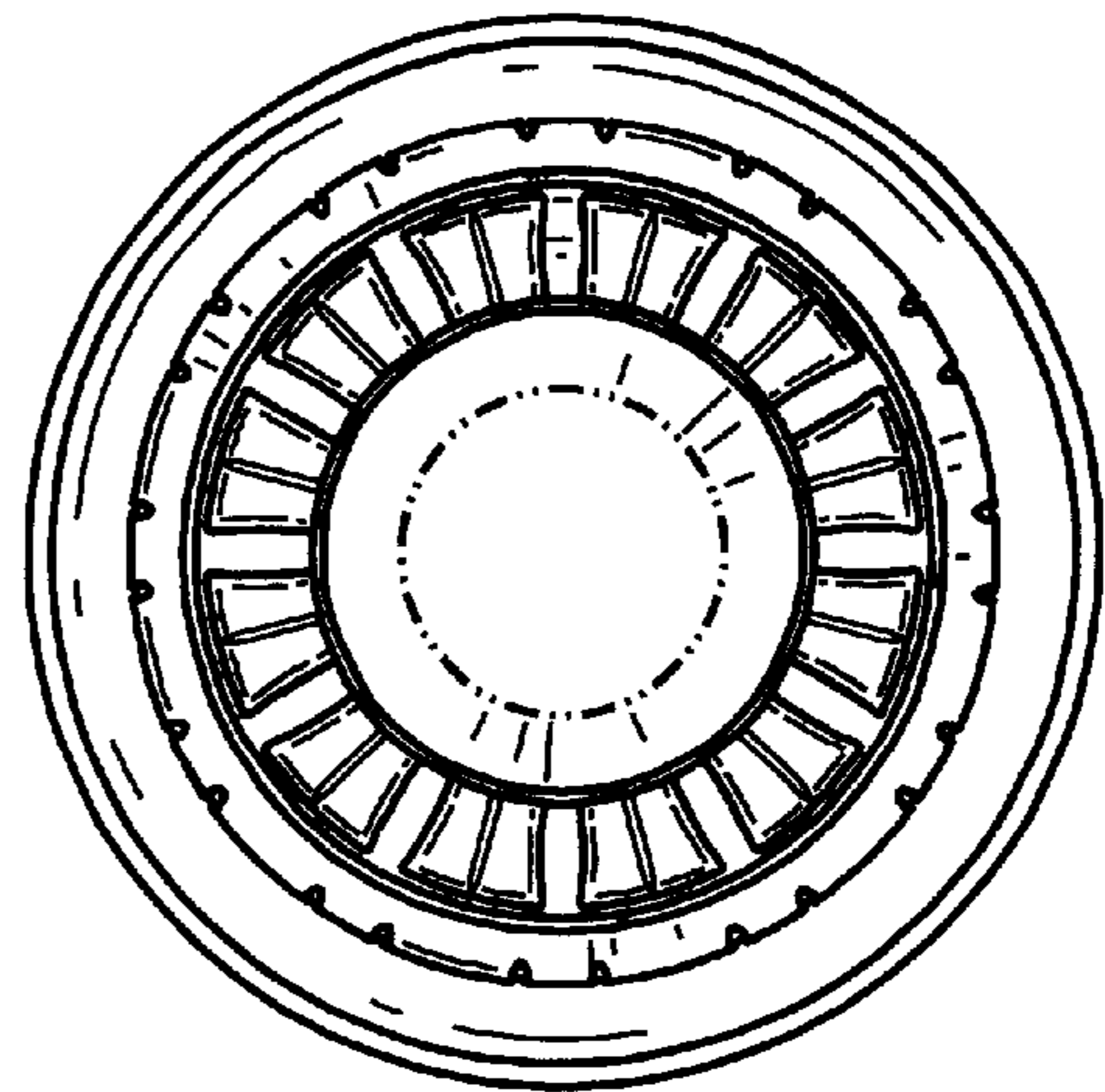
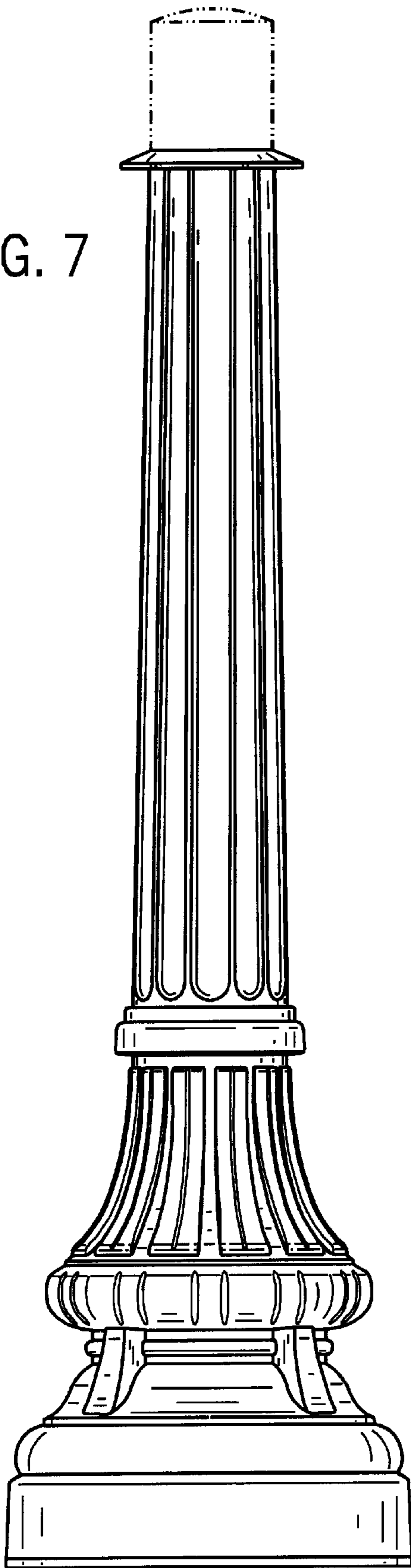

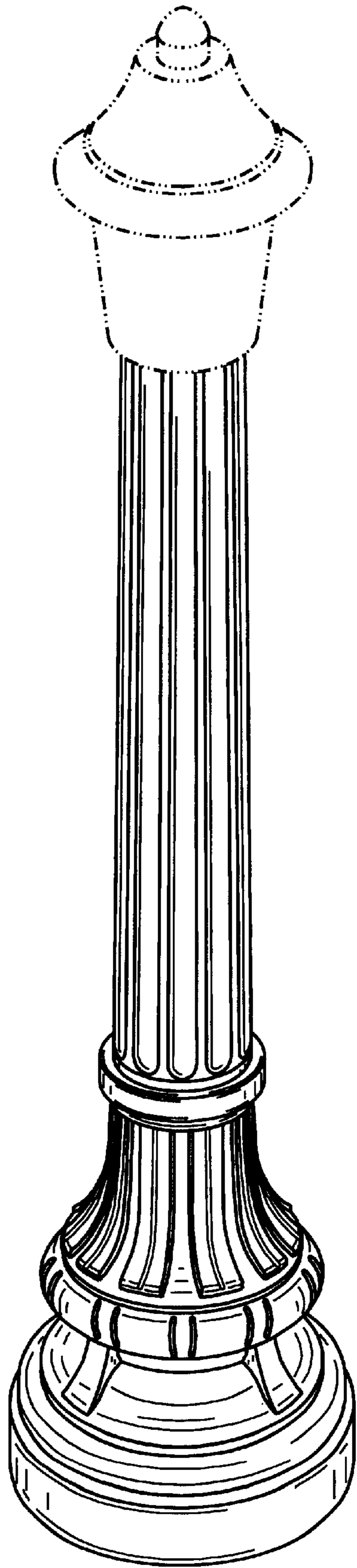

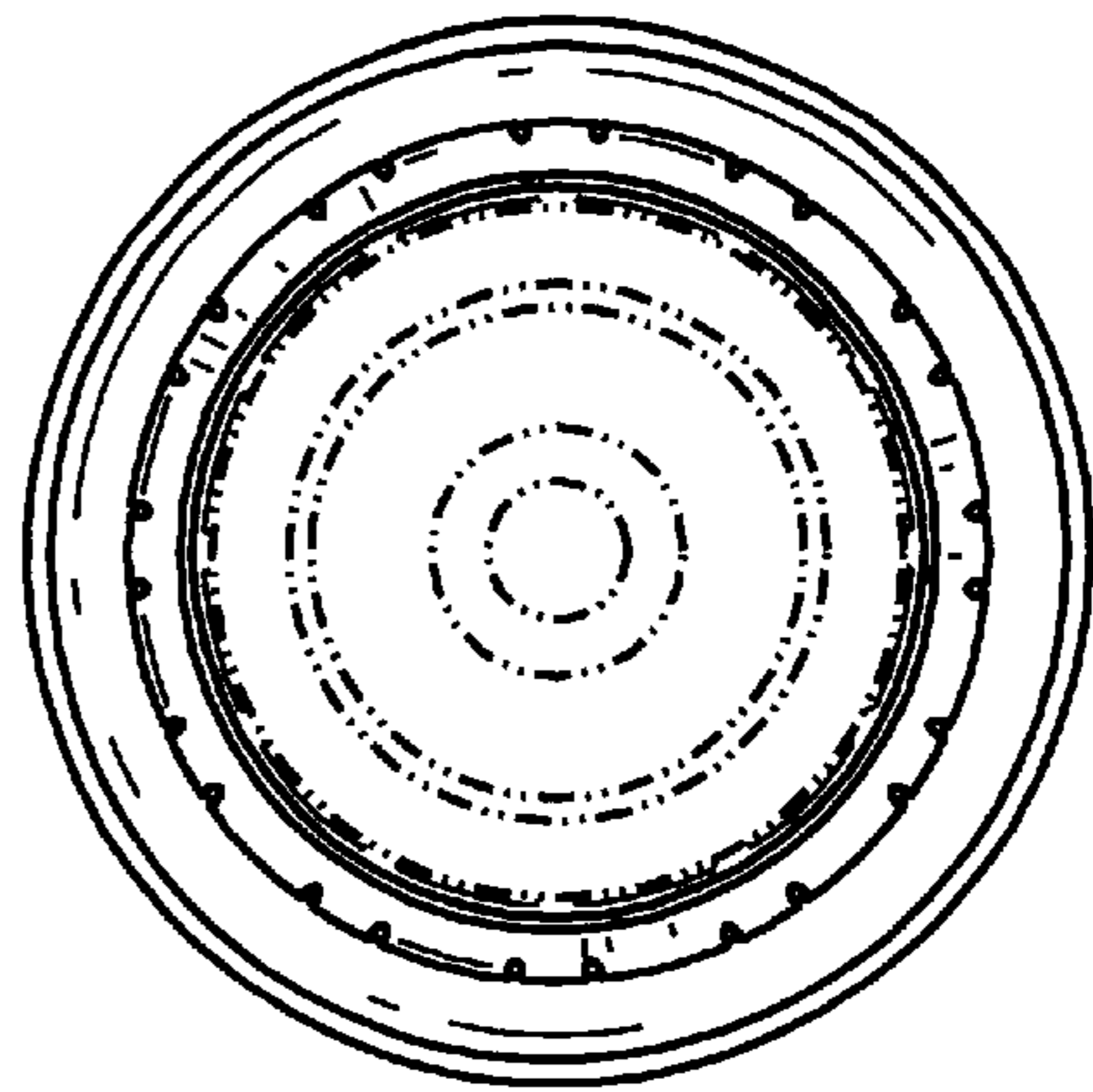
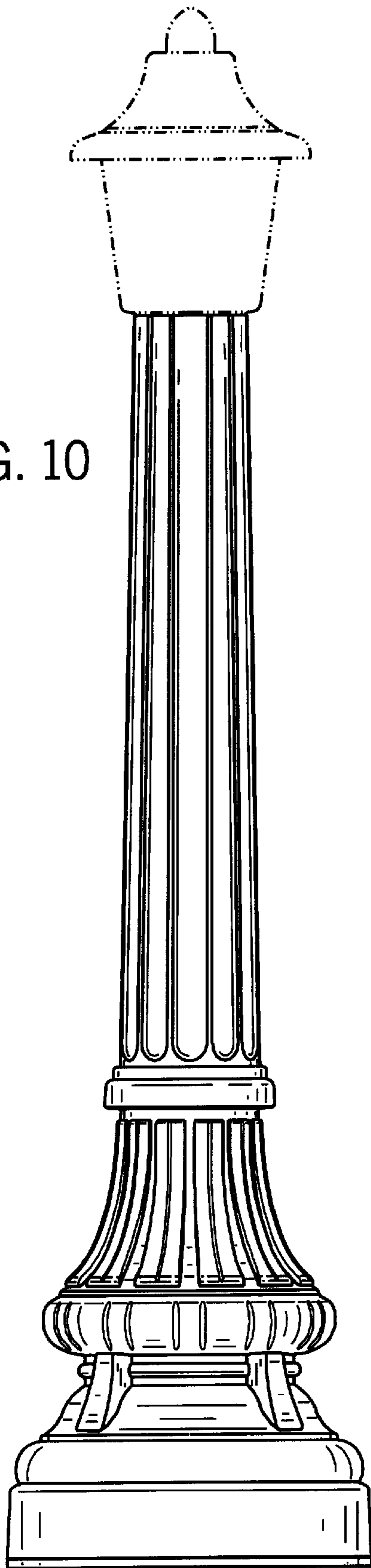

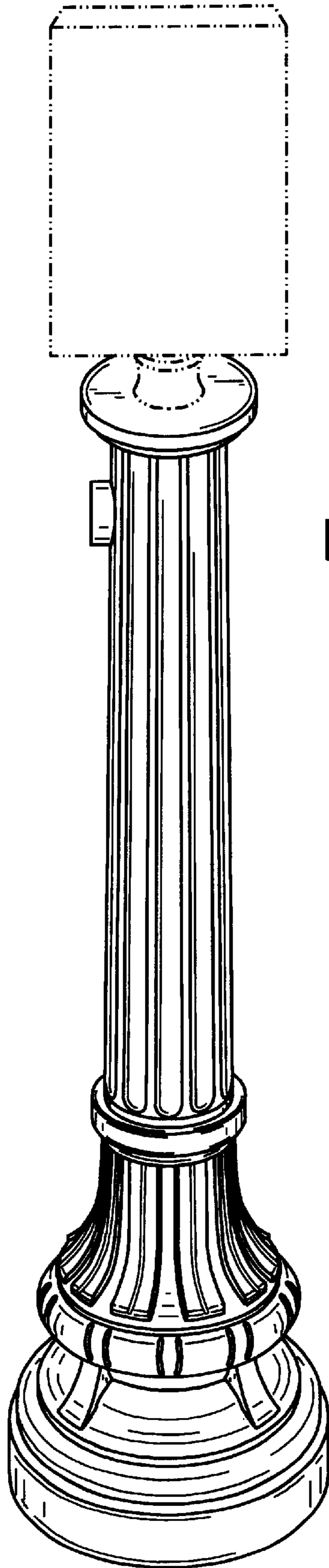

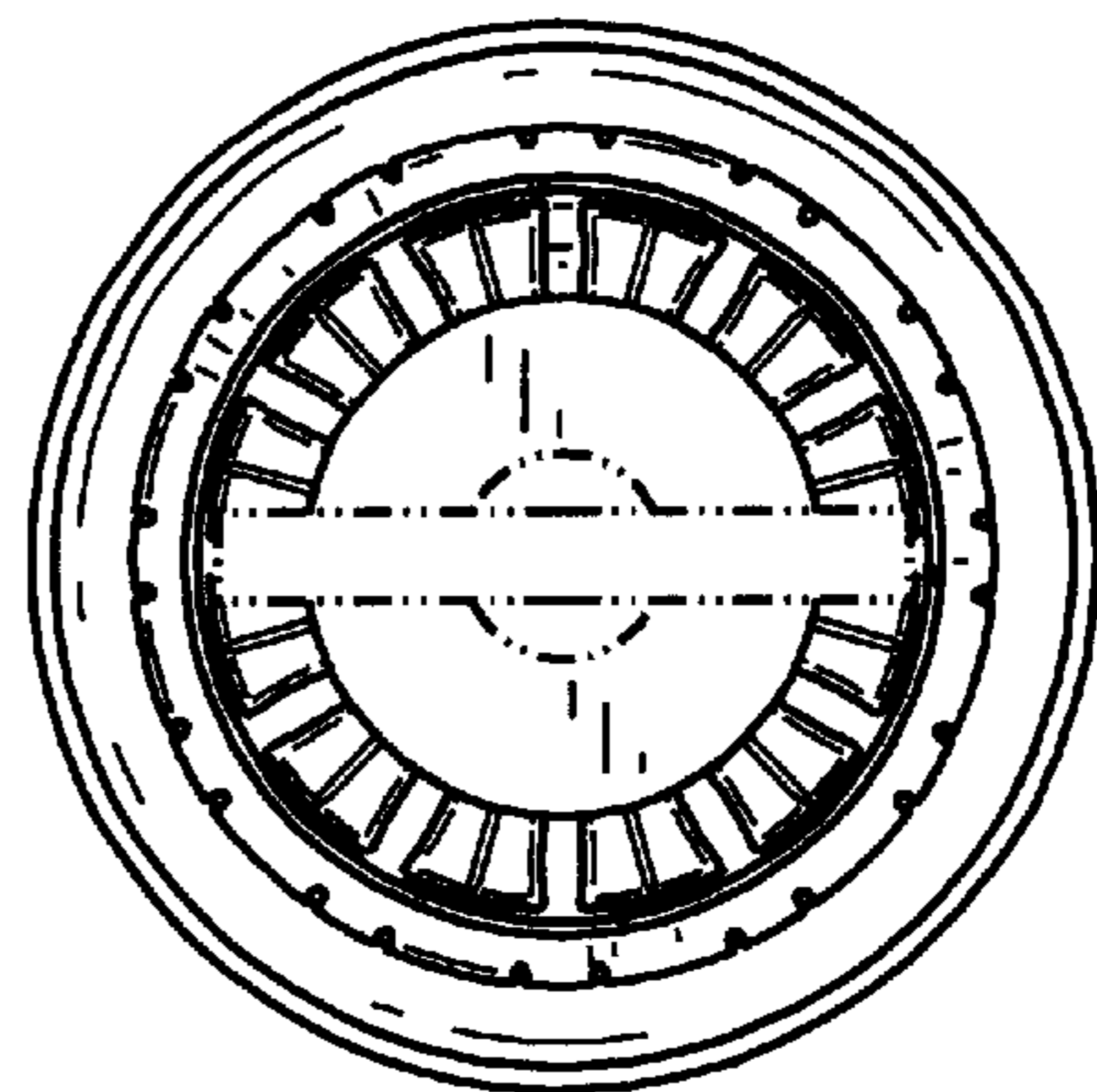
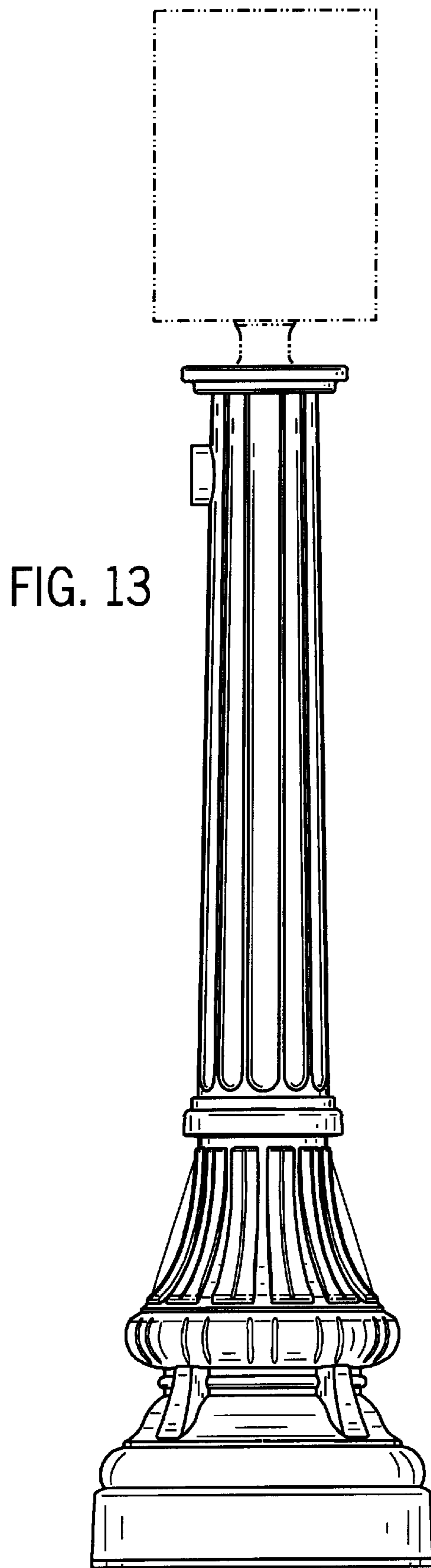

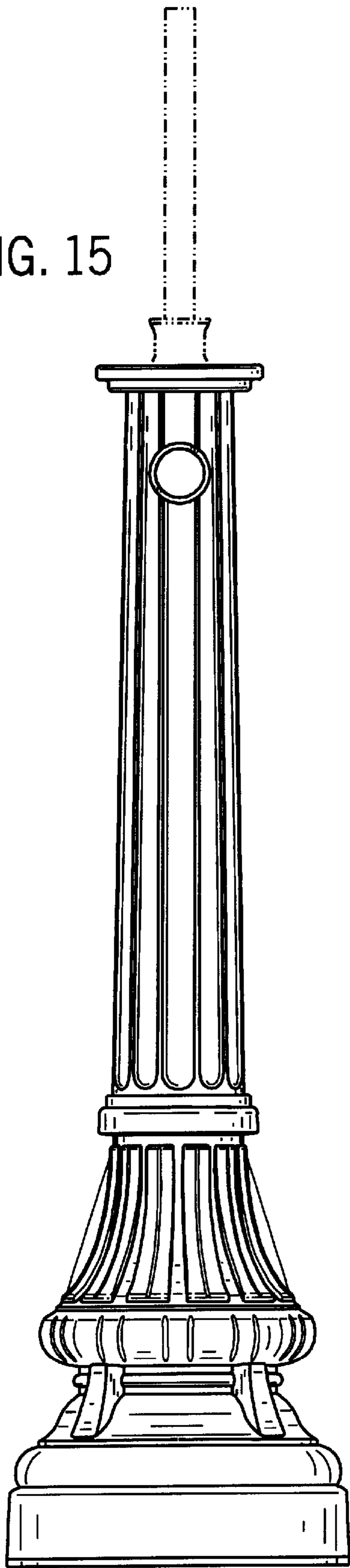
