The ornamental design for back washing device, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a back washing device, embodying our new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a cross-sectional view as seen along line 7—7 of FIG. 5;
FIG. 8 is a perspective view thereof; and,
FIG. 9 is a reduced perspective view thereof with the securing ring shown in an alternate position.

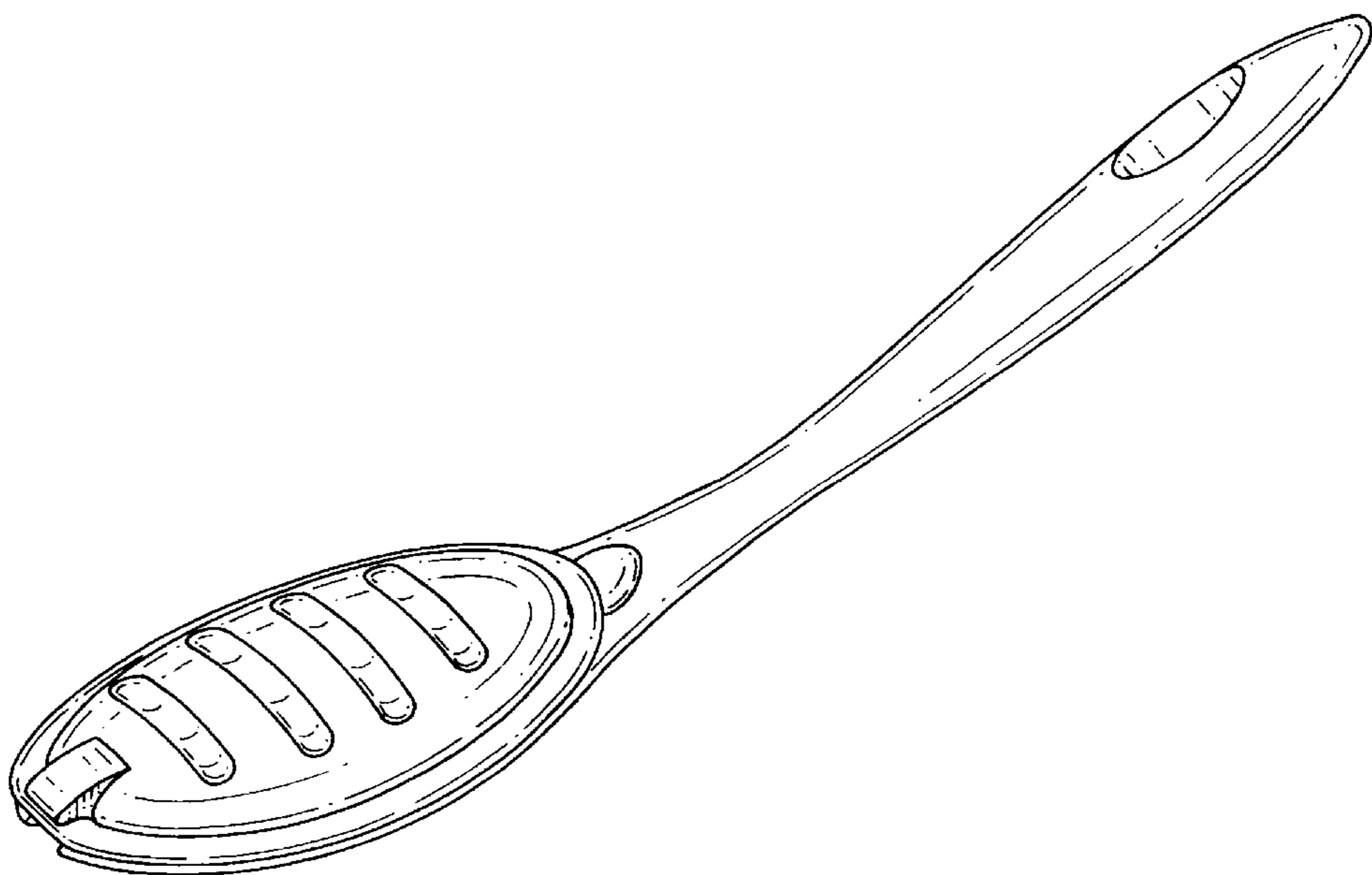

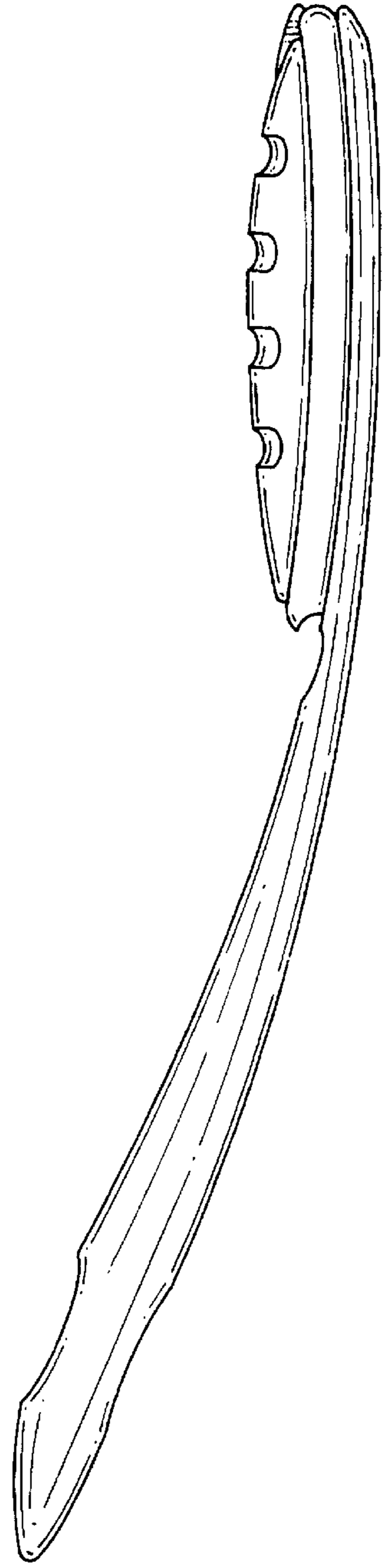

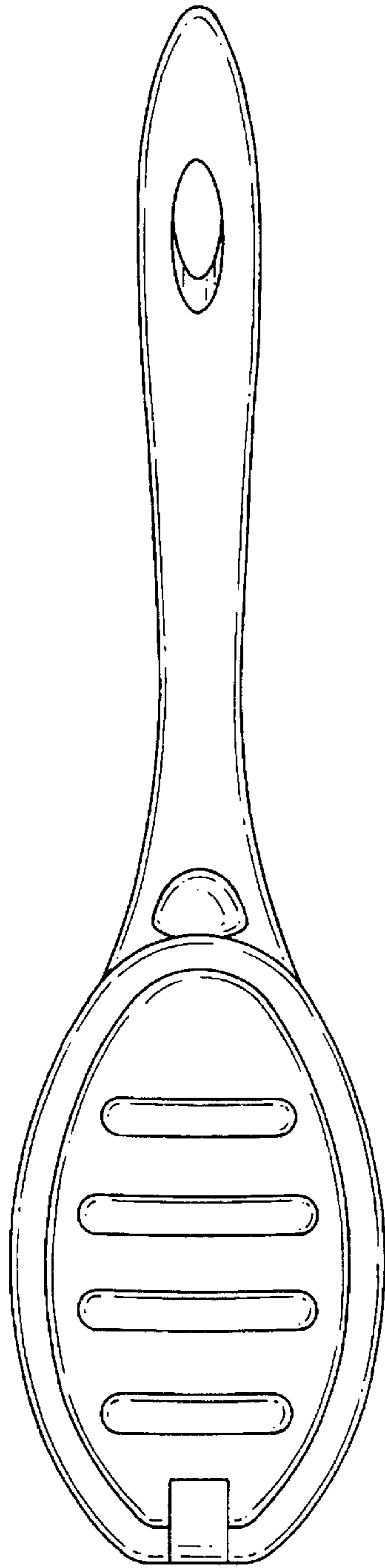

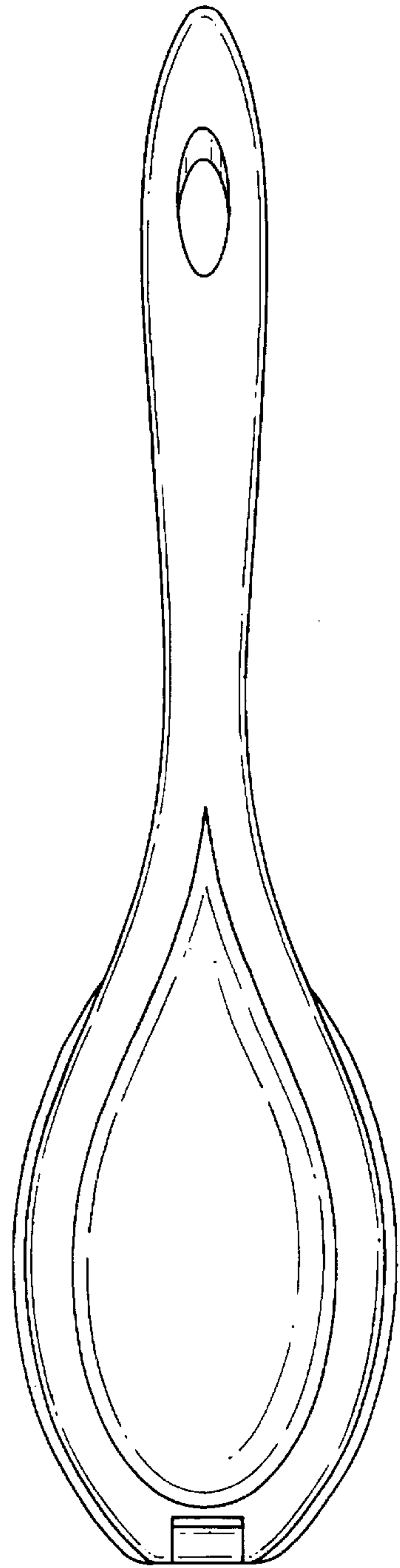

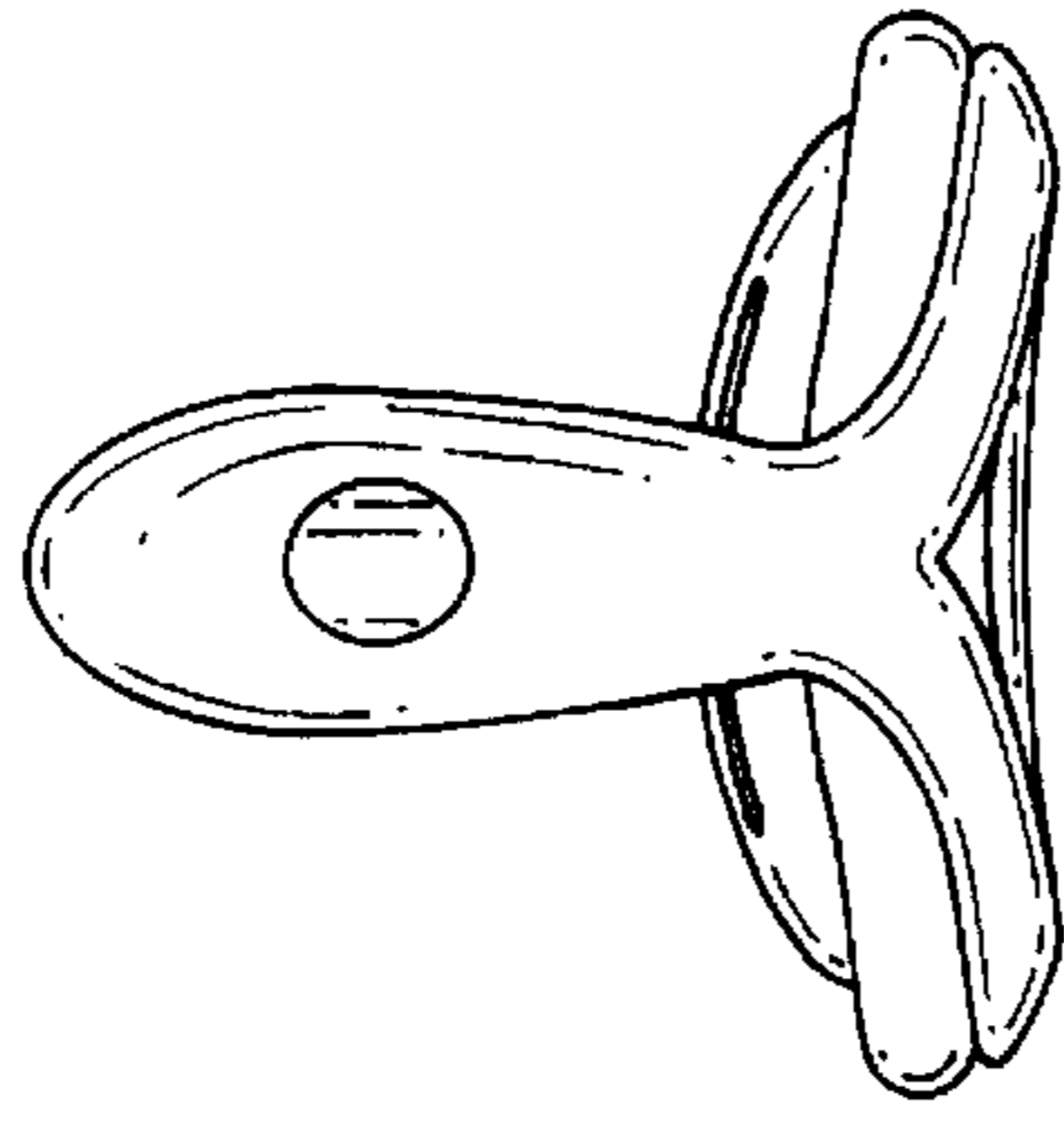

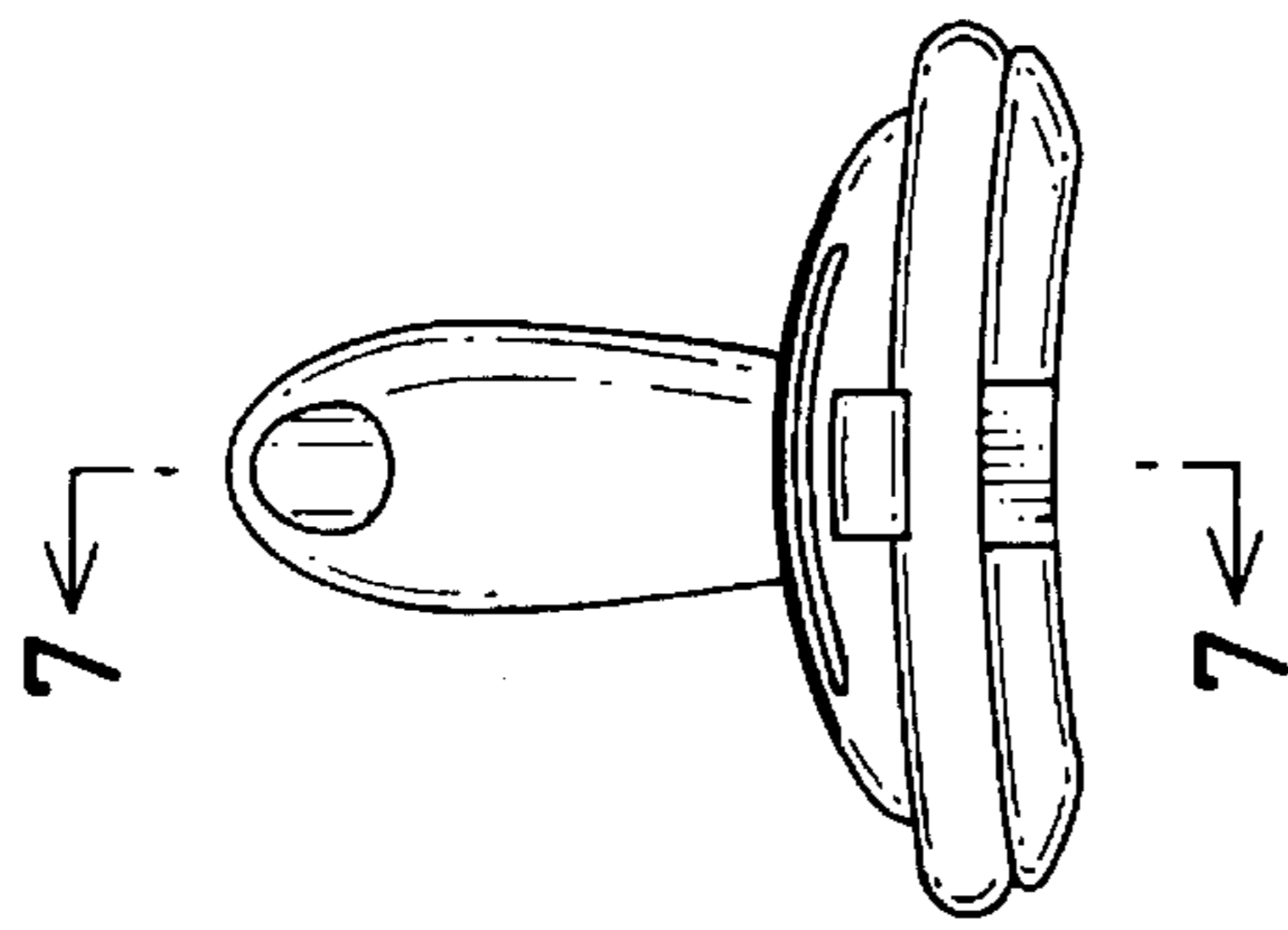

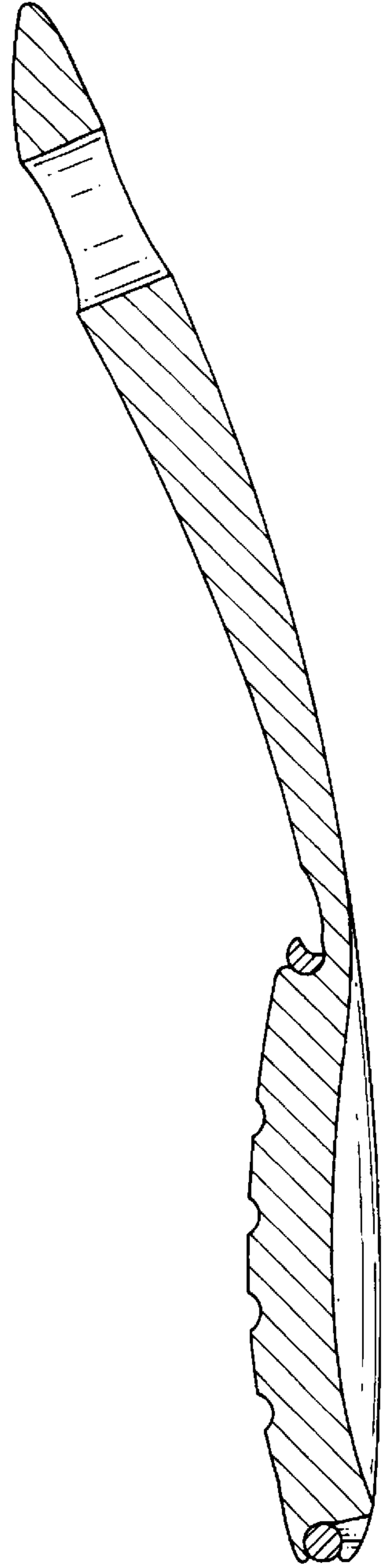

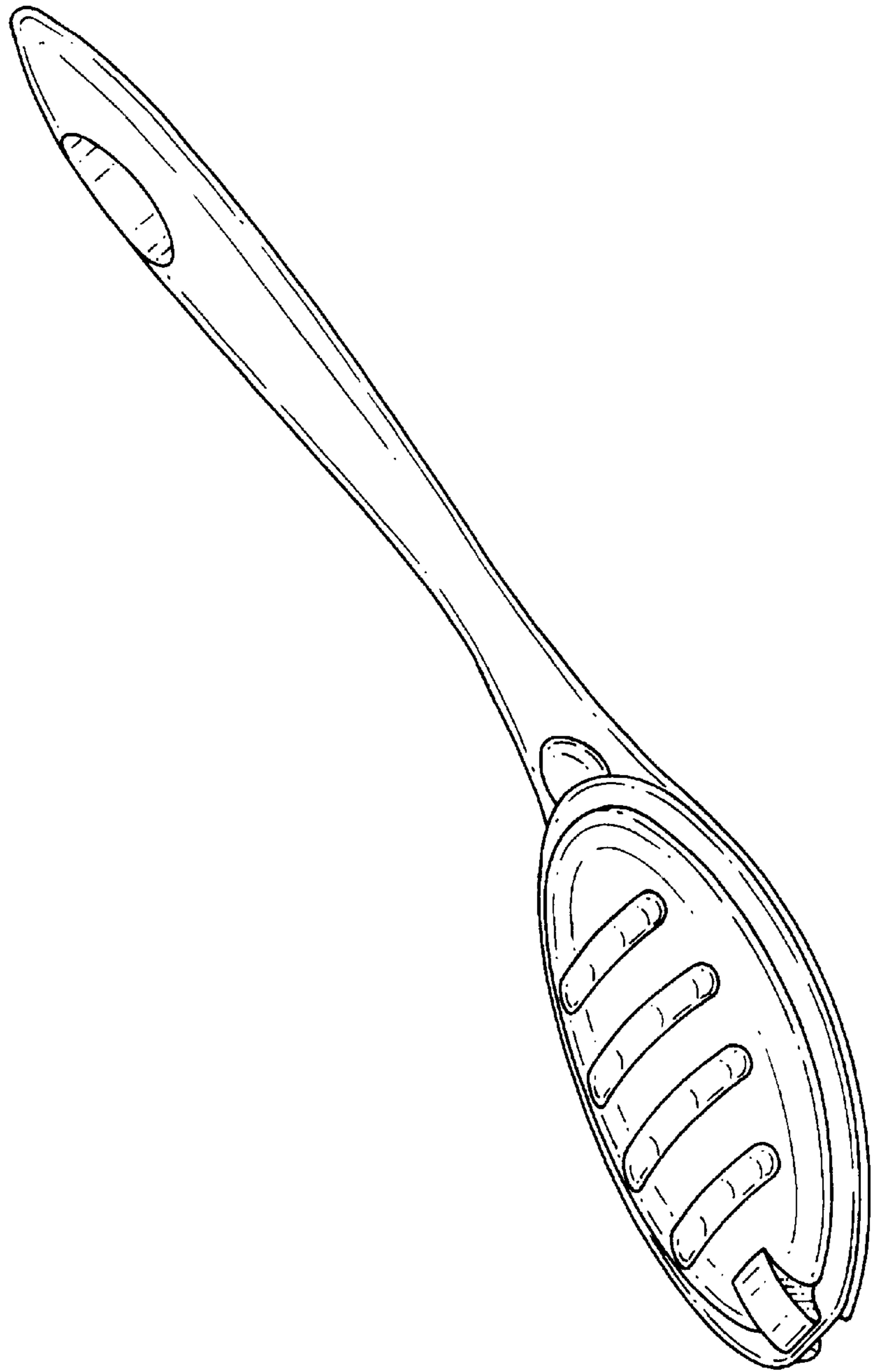
