DESCRIPTION

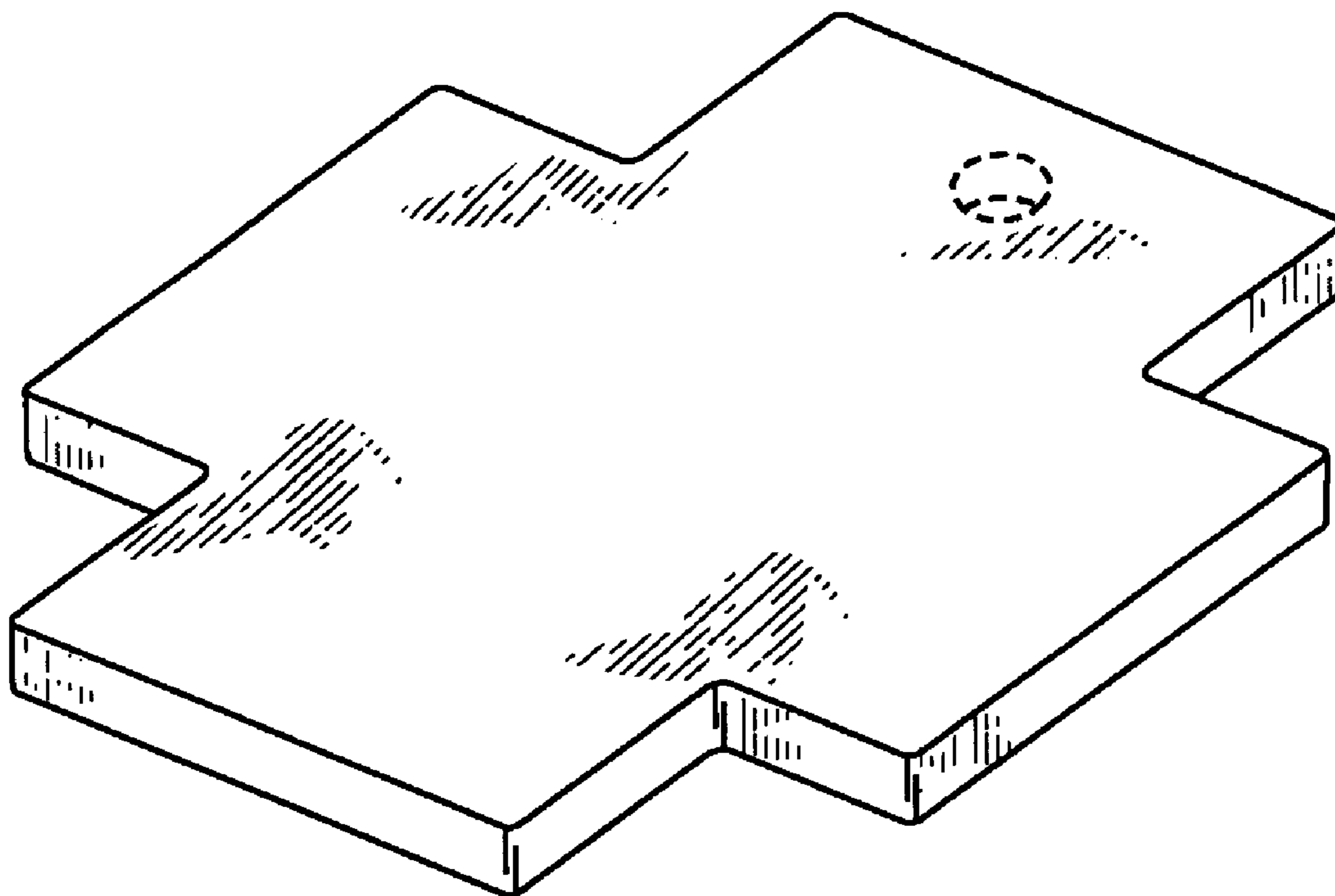
FIG. 1 is a top plan view of a dogtag showing my new design;

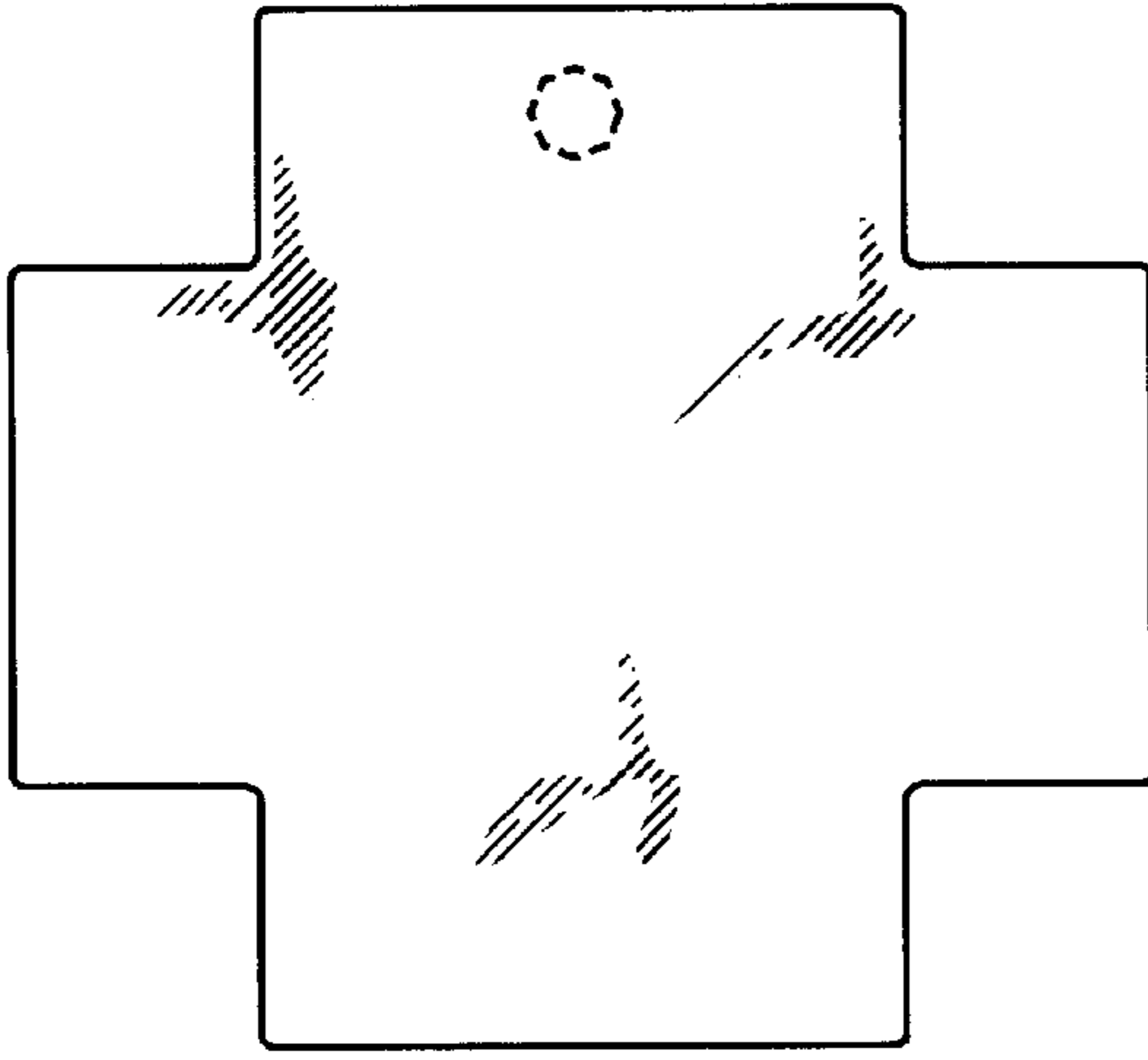

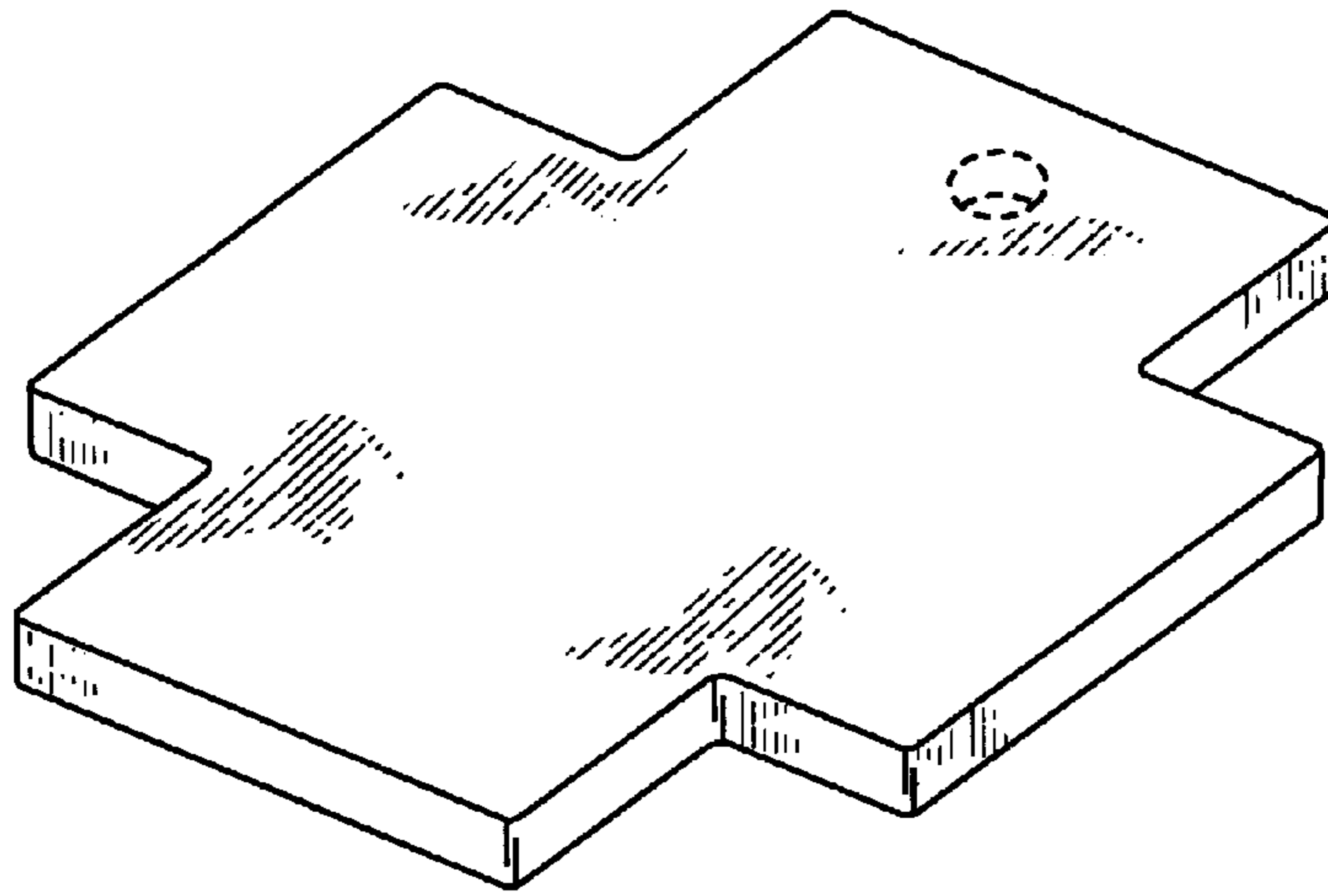
