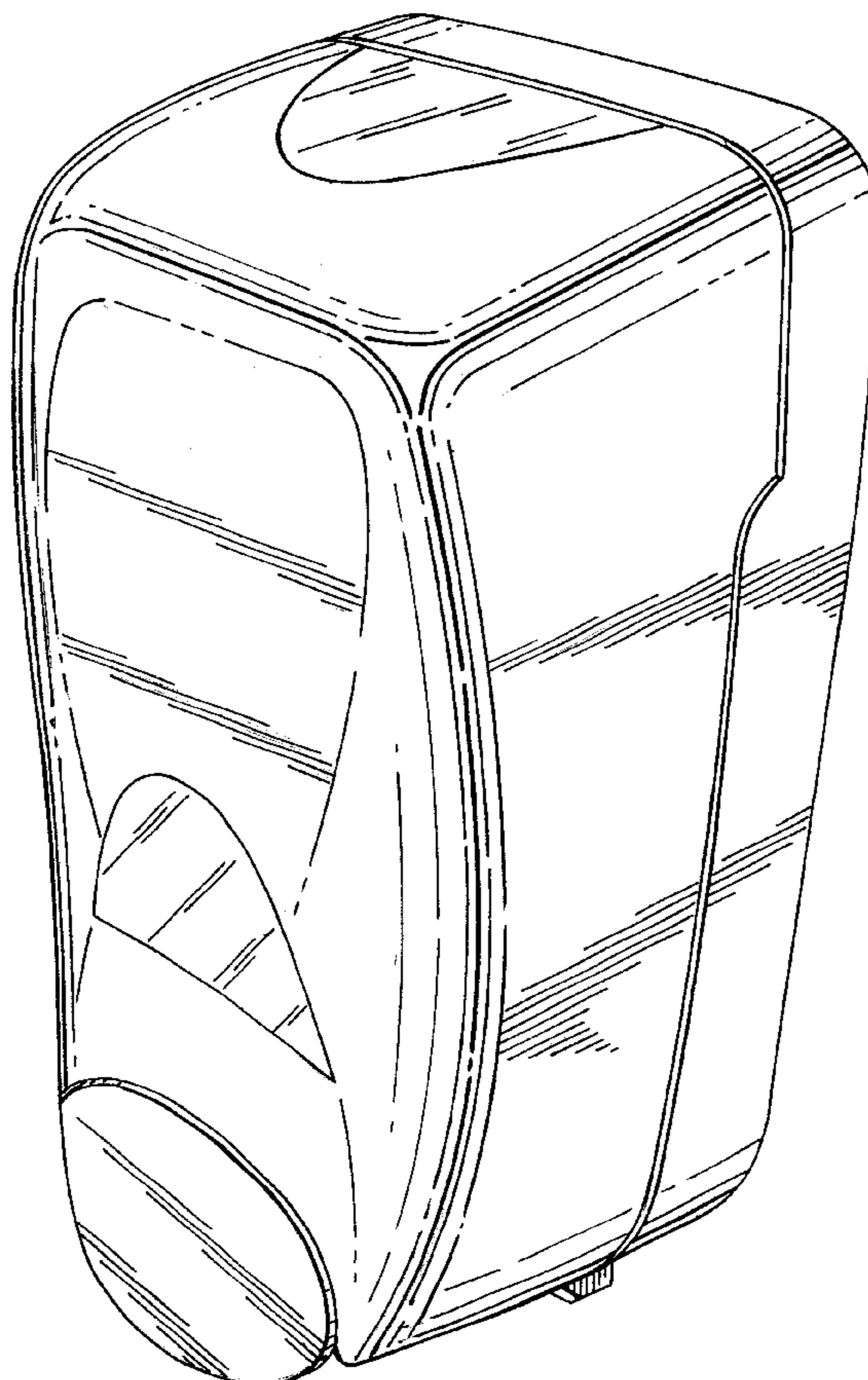

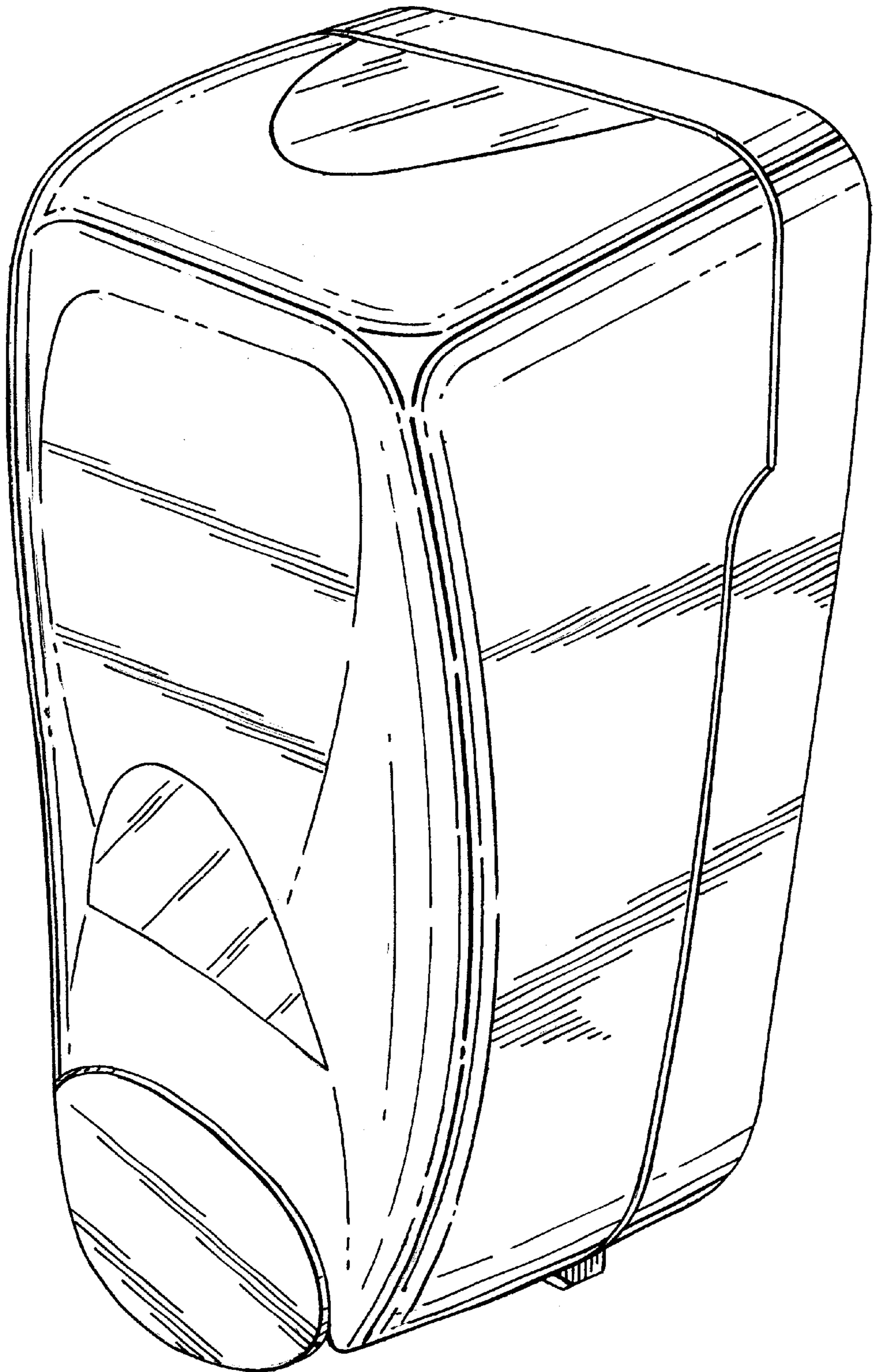
We claim the ornamental design for a dispenser, as shown and described.

**DESCRIPTION**

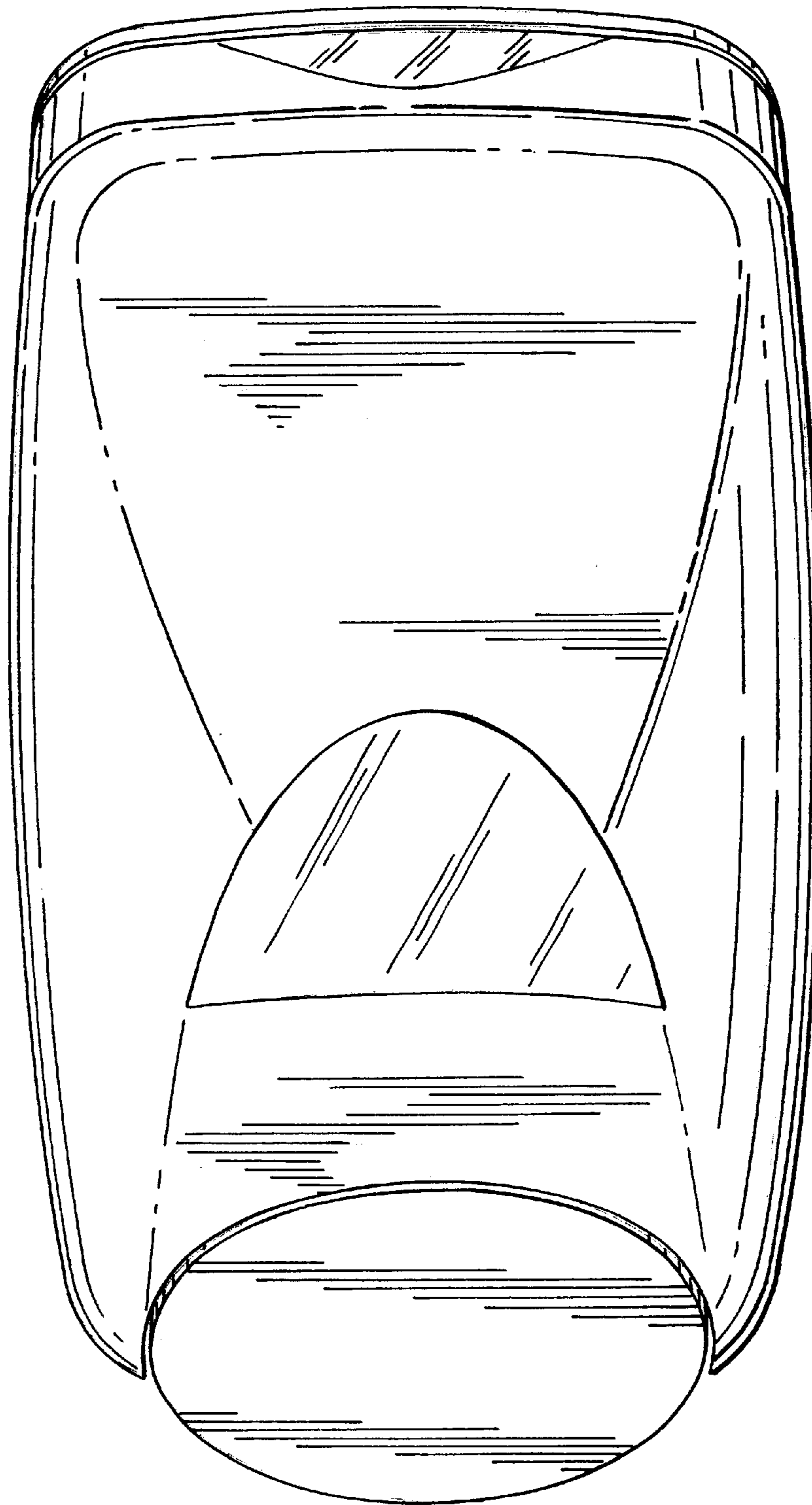
FIG. 1 is perspective view showing our new improved dispenser;

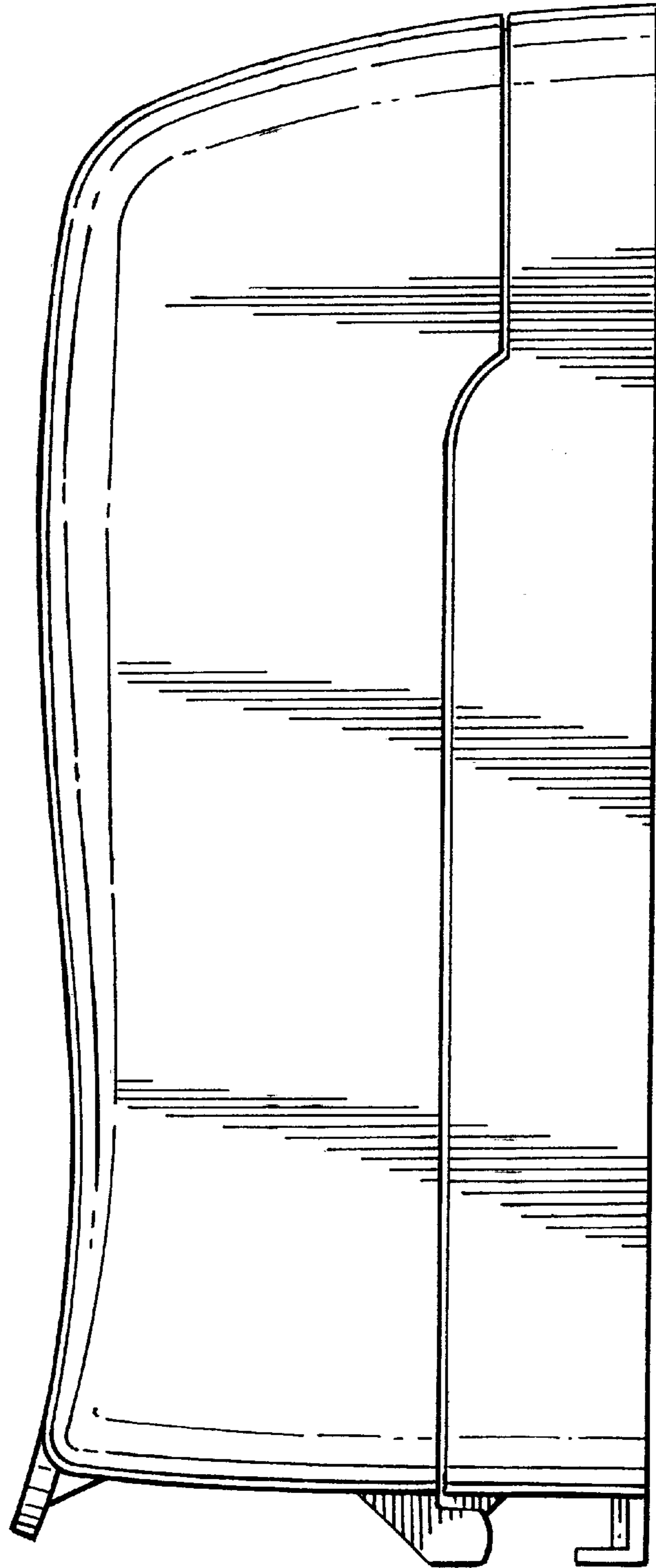

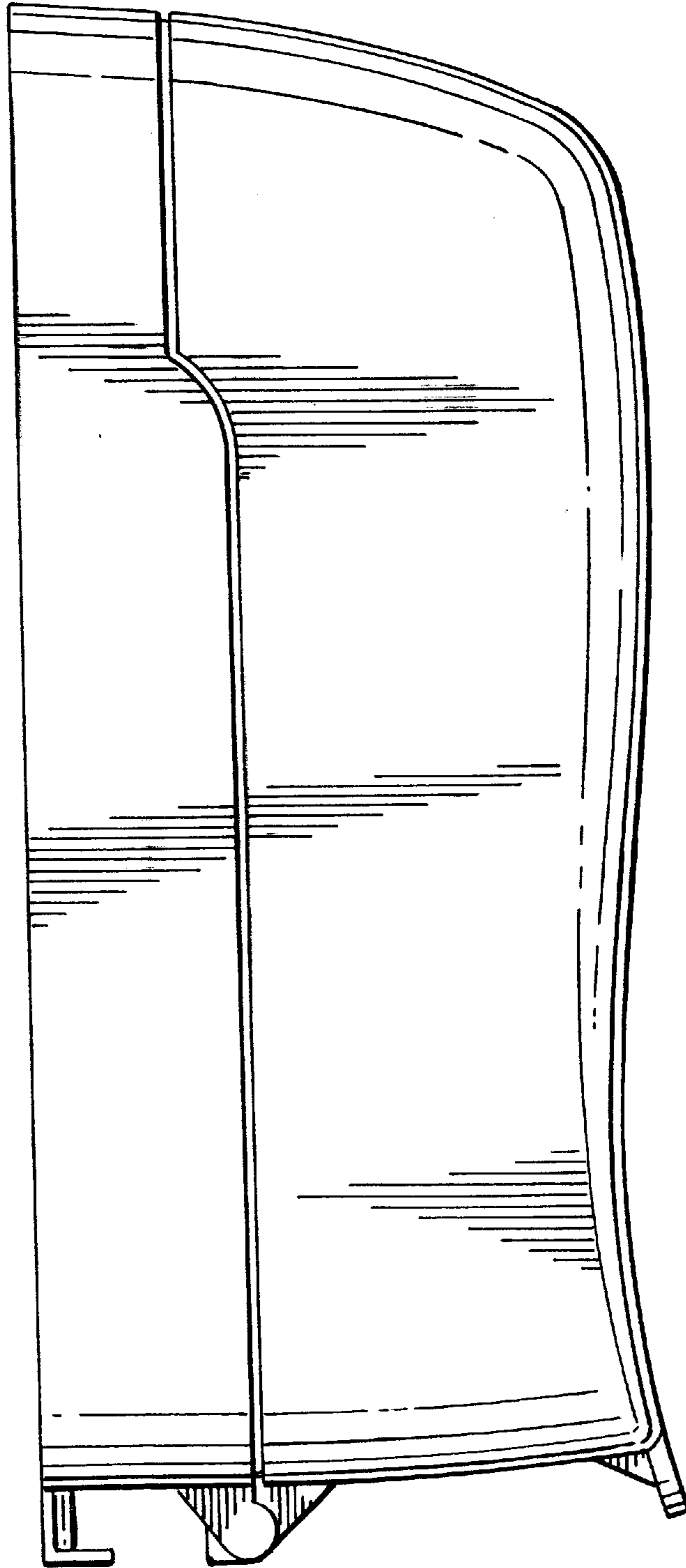

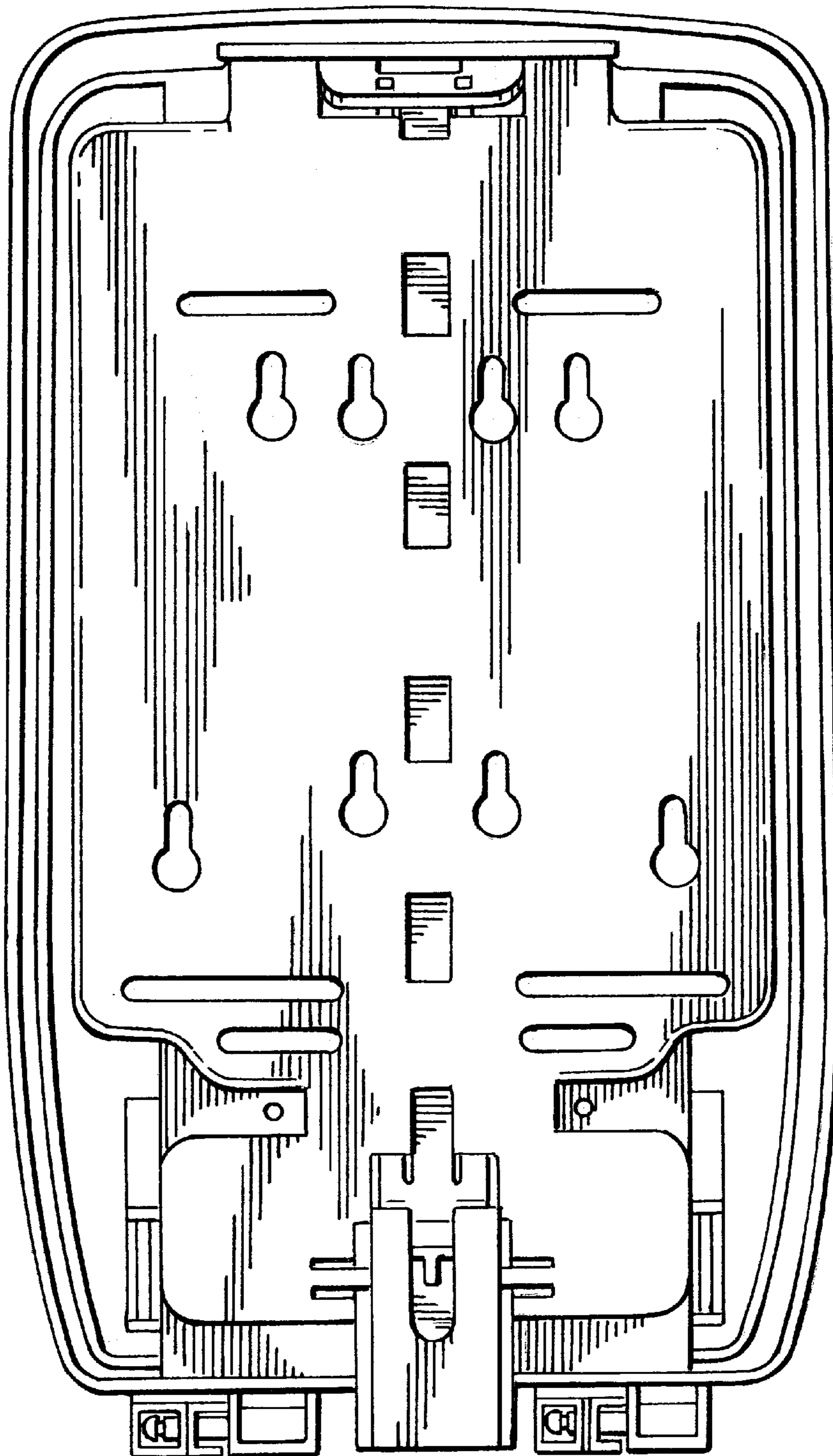
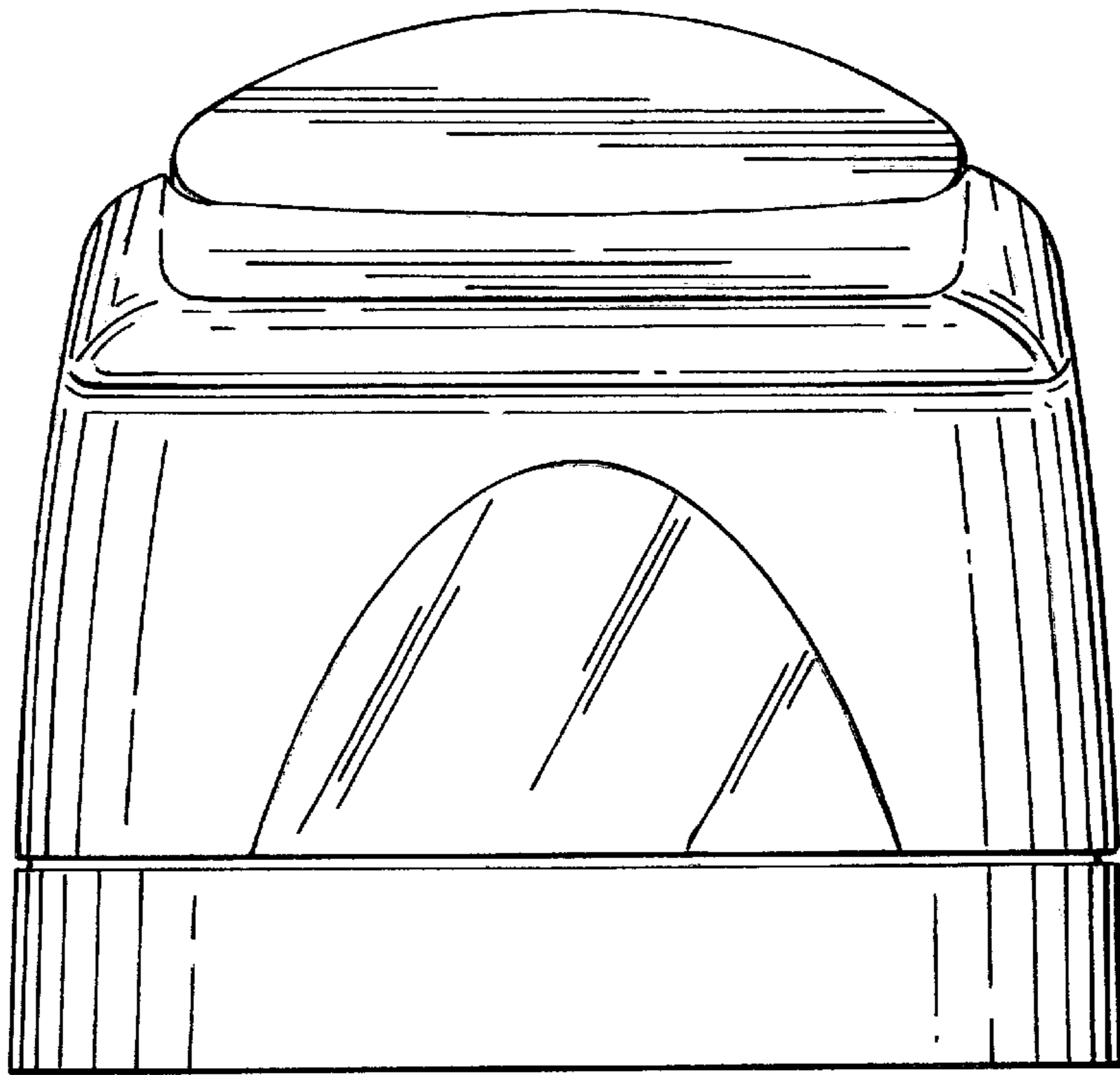
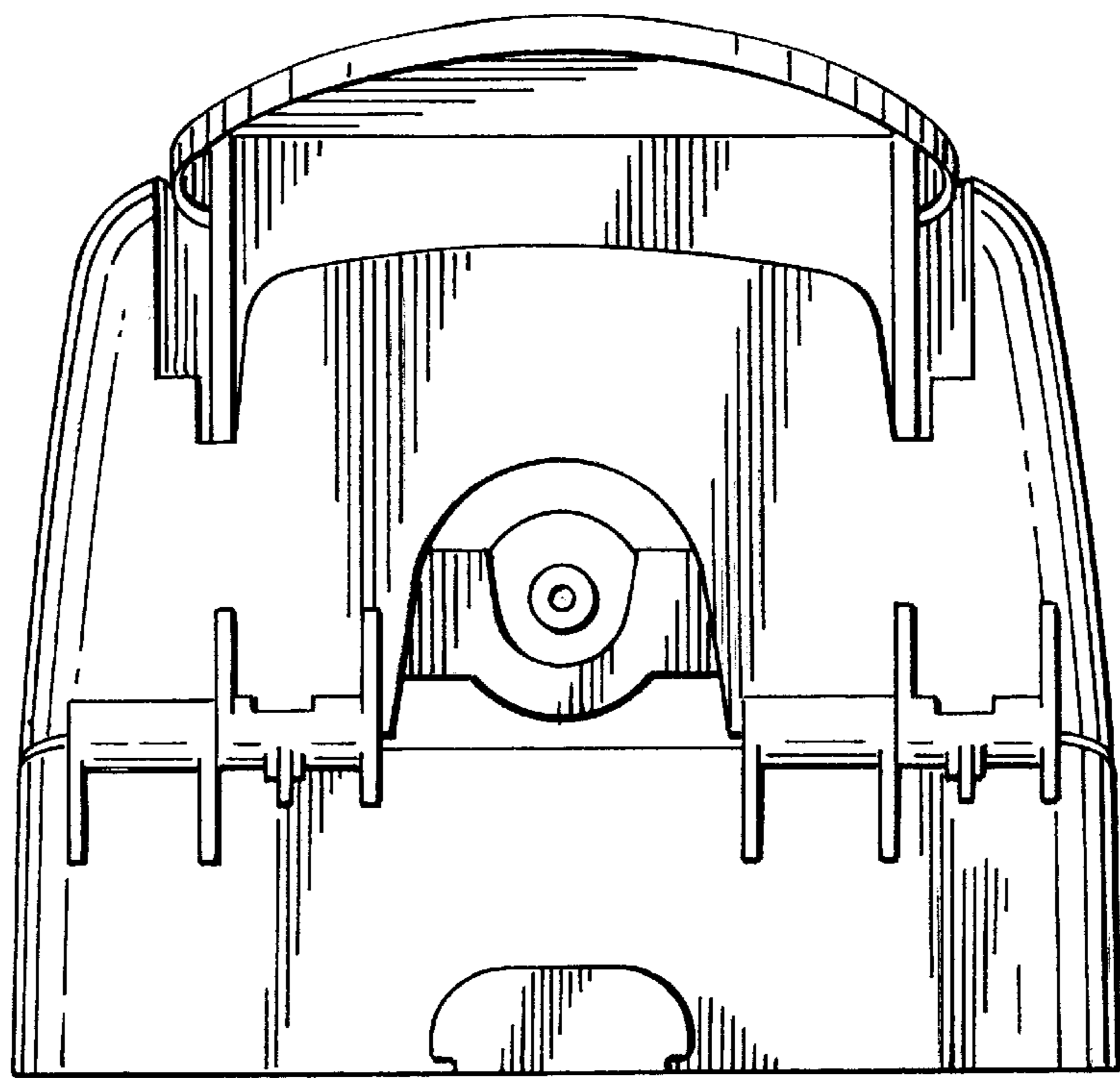
