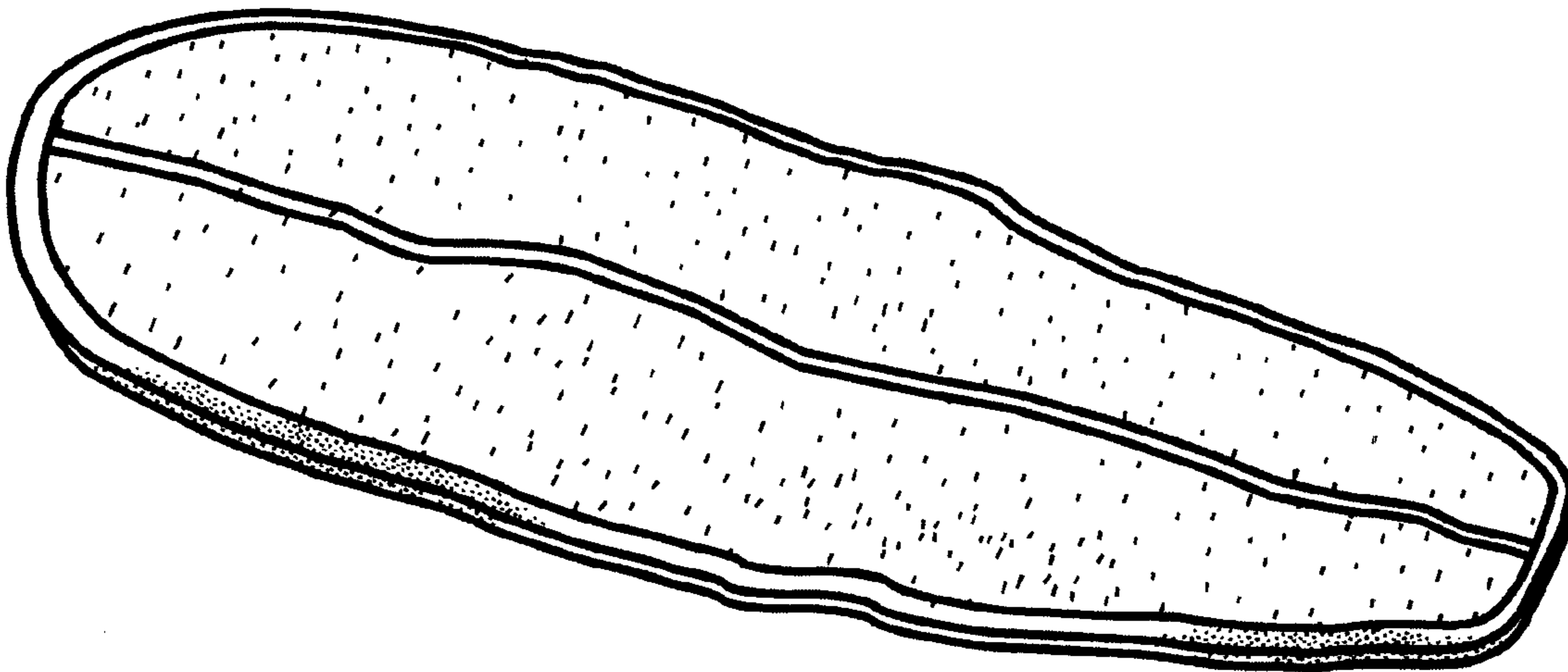

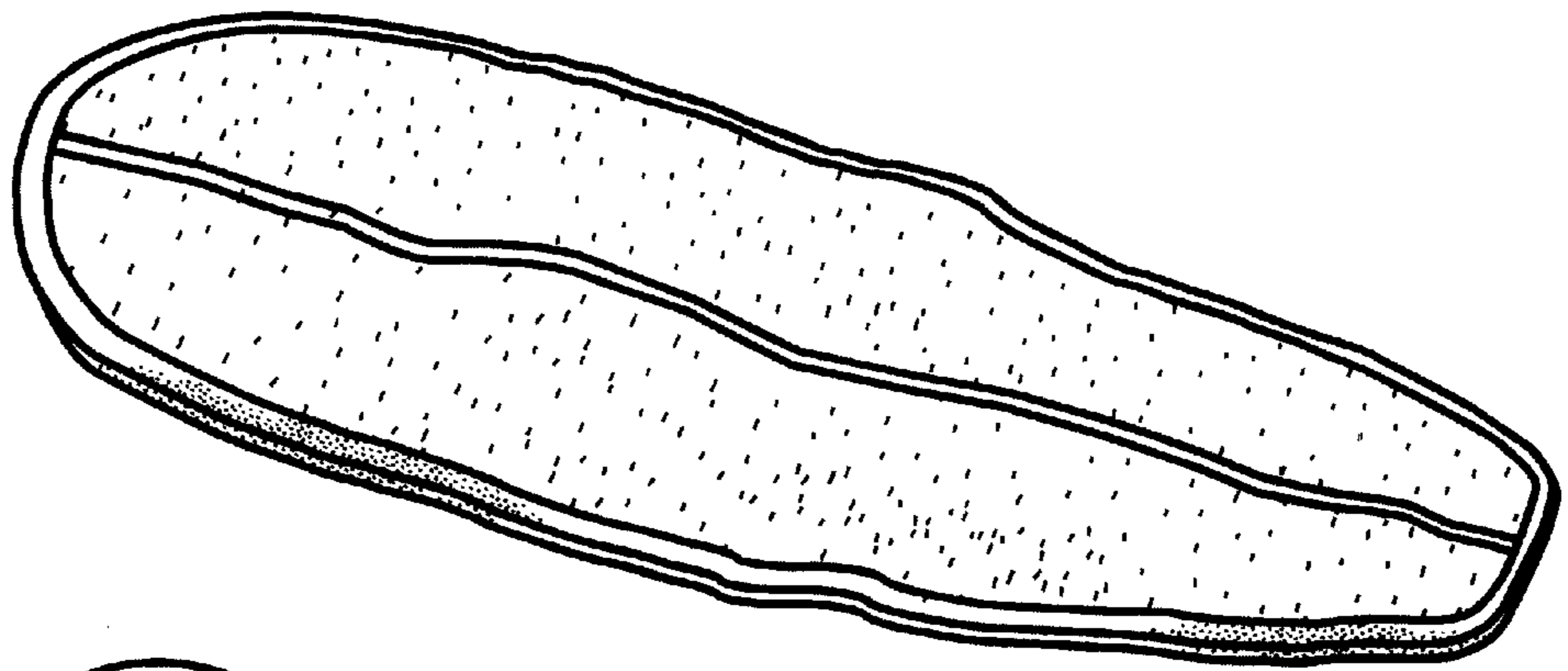
The ornamental design for a surfboard towel with border, as shown and described.

**DESCRIPTION**

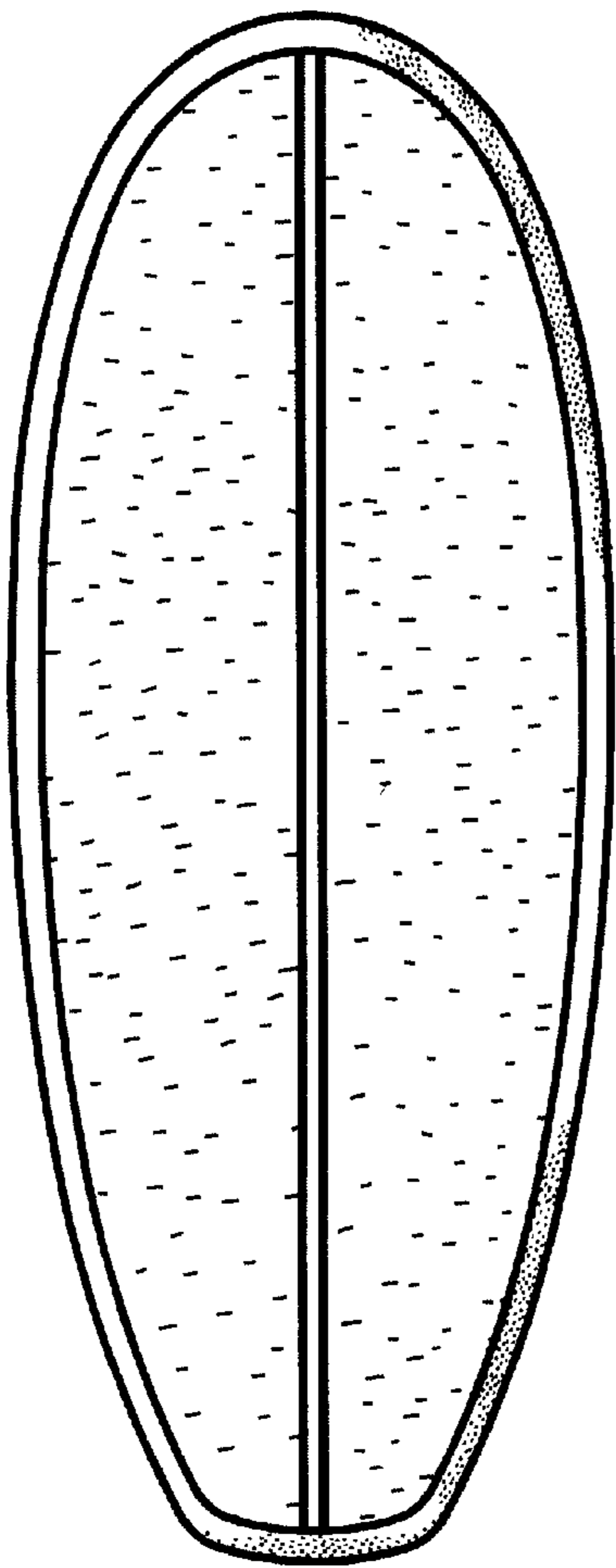
FIG. 1 is a perspective view of a surfboard towel with border showing my new design;

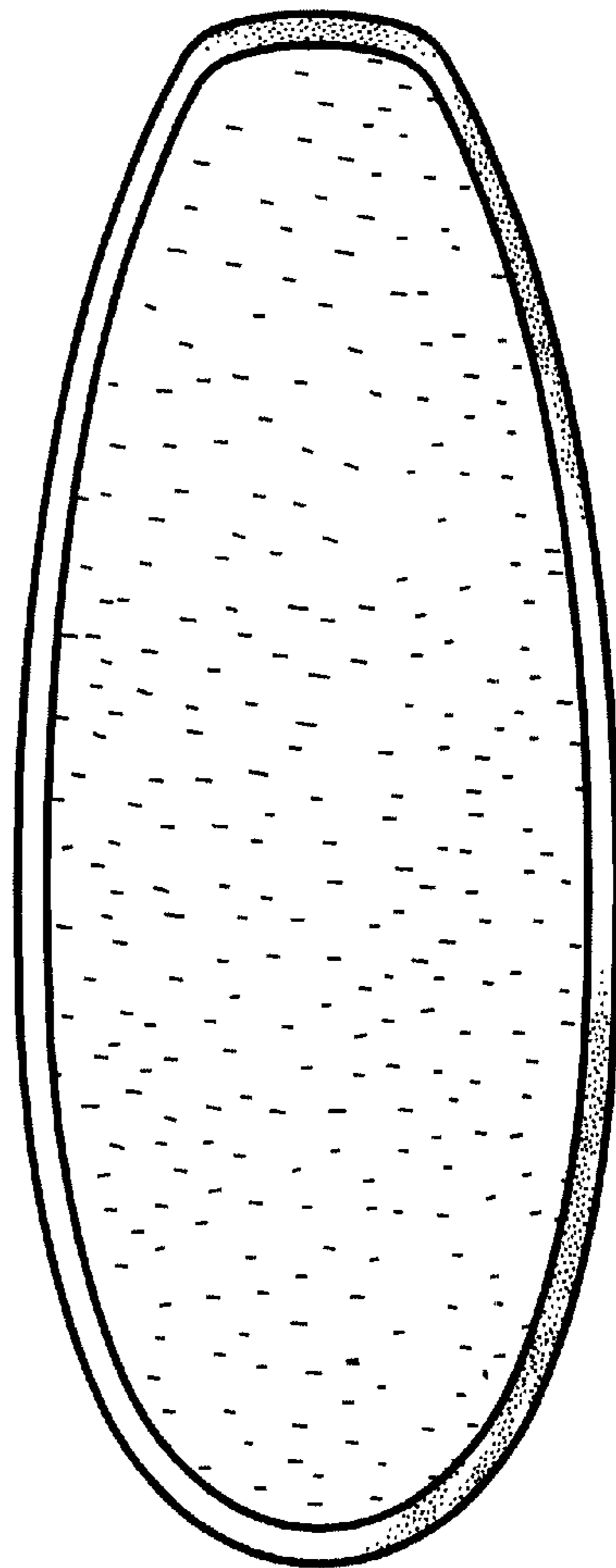
