FIG. 7 is a bottom view of the holding cabinet for serving precooked food products of FIG. 1, according to an embodiment of the design.

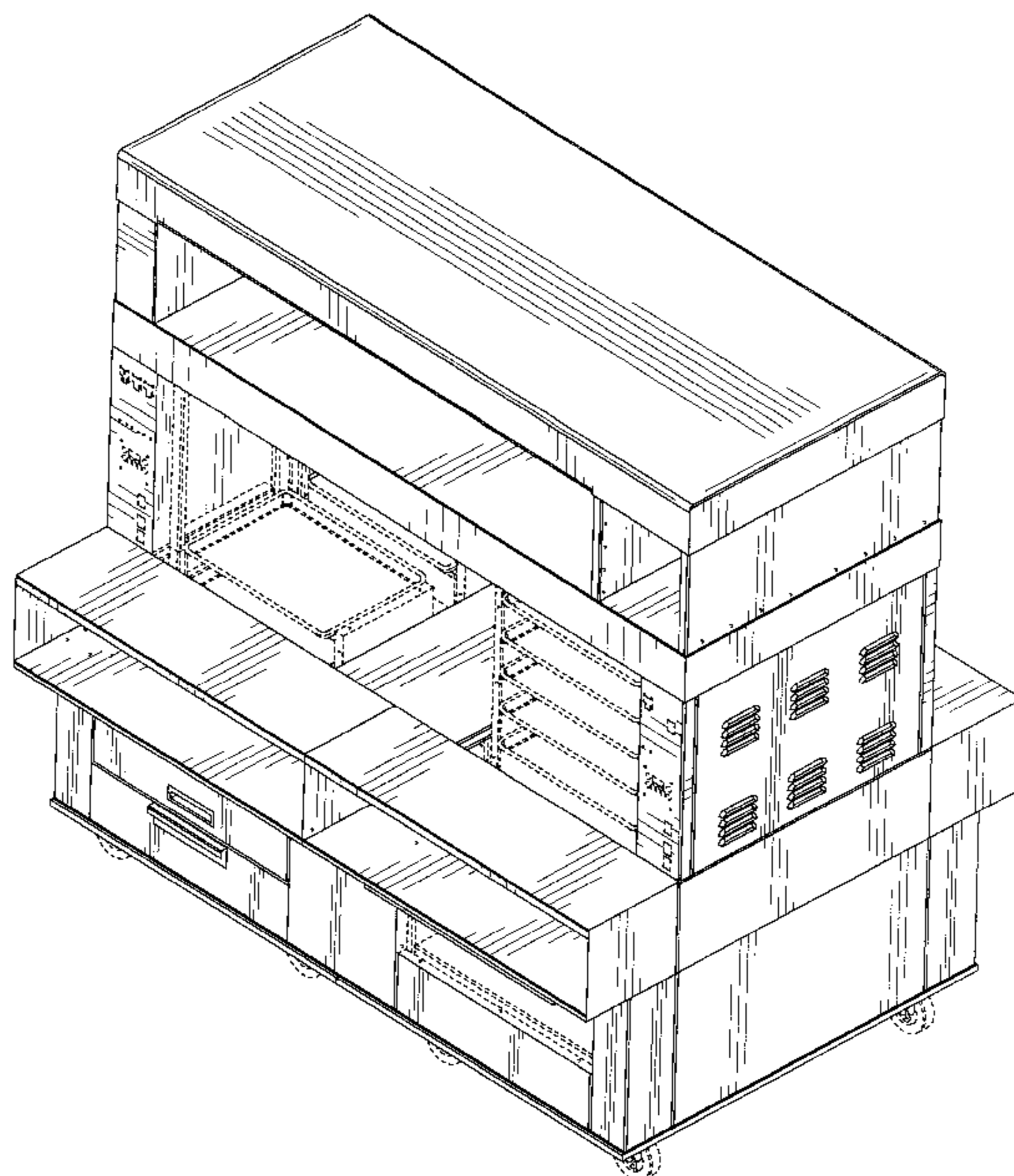

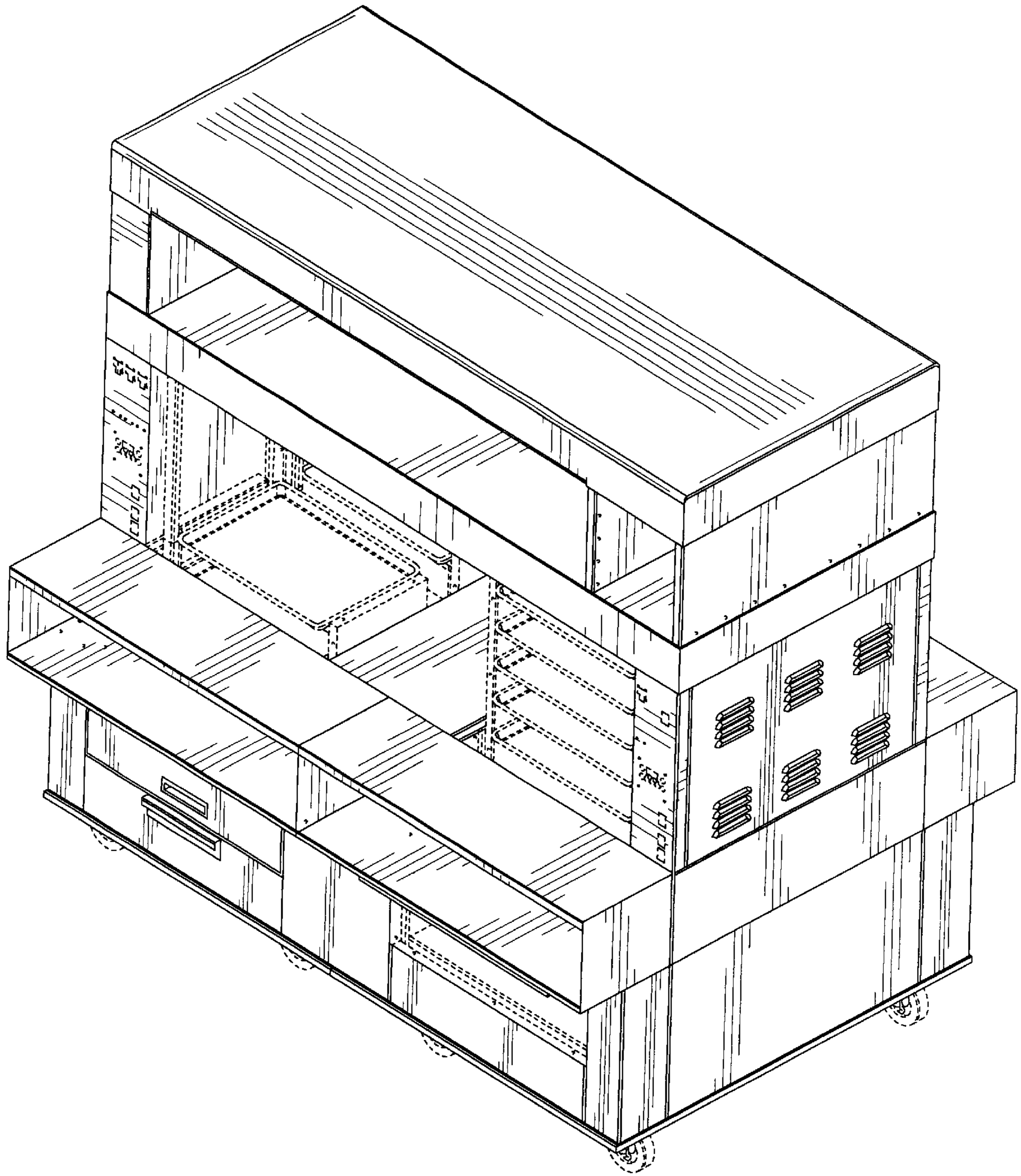

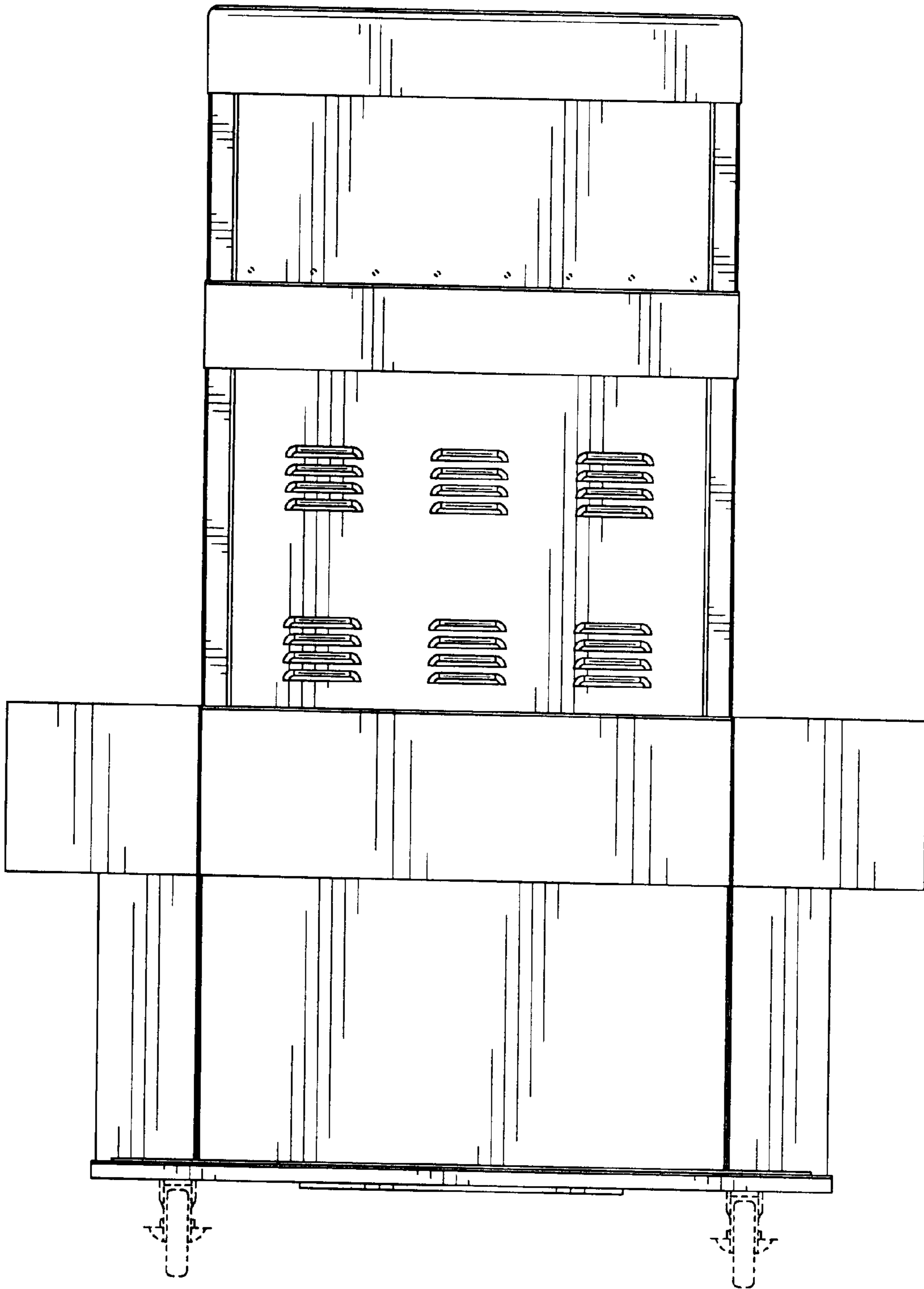

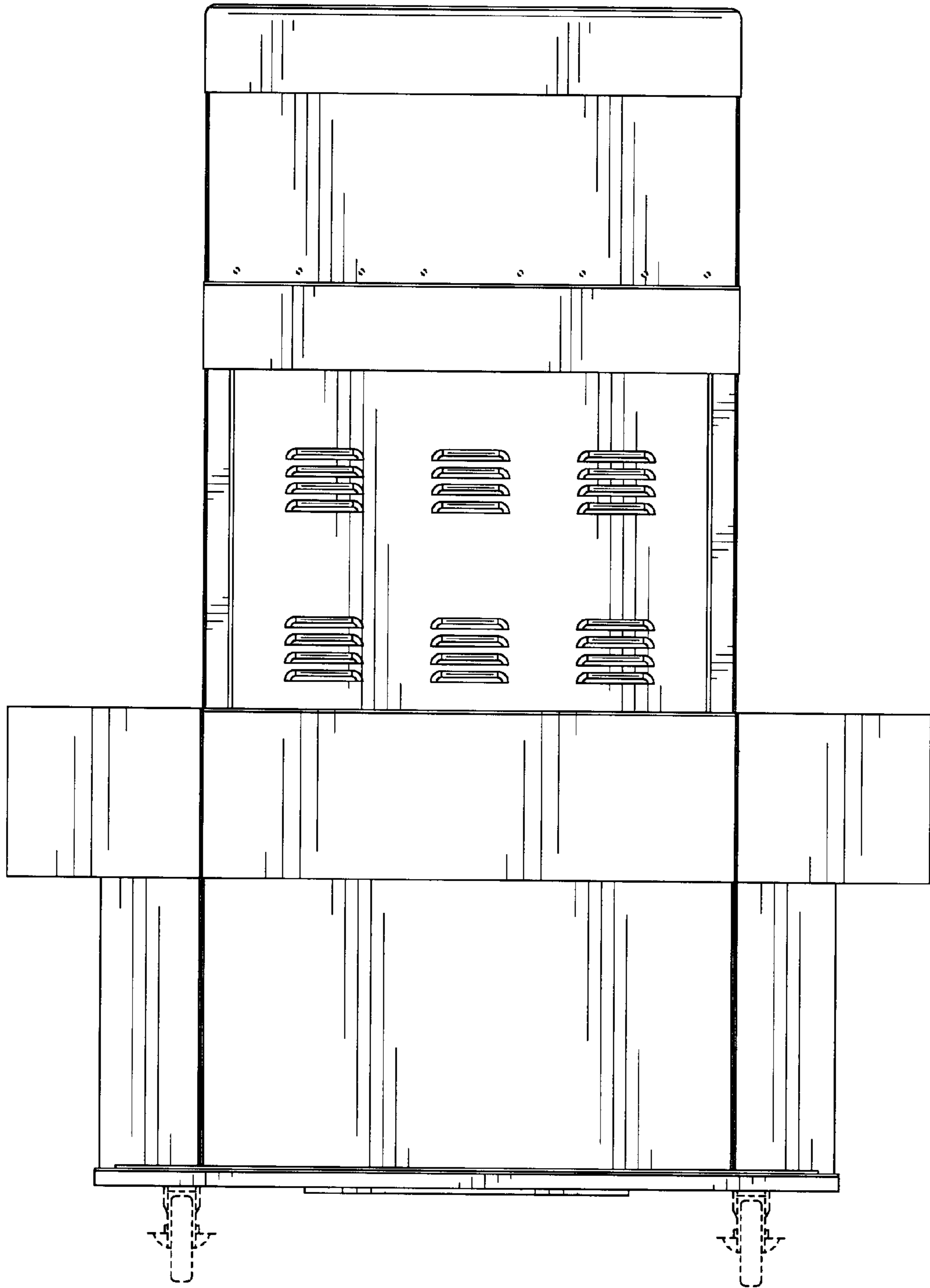

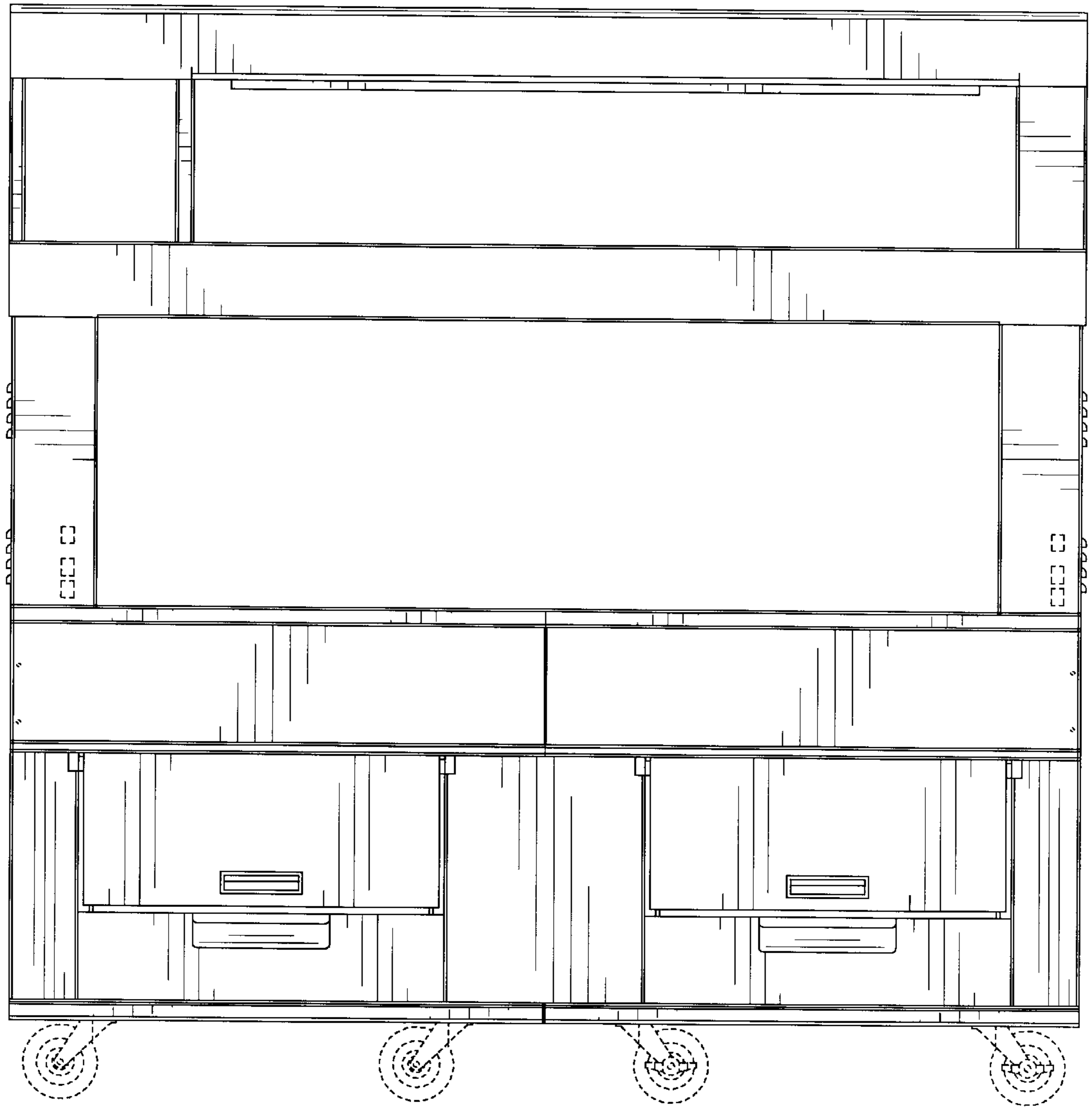

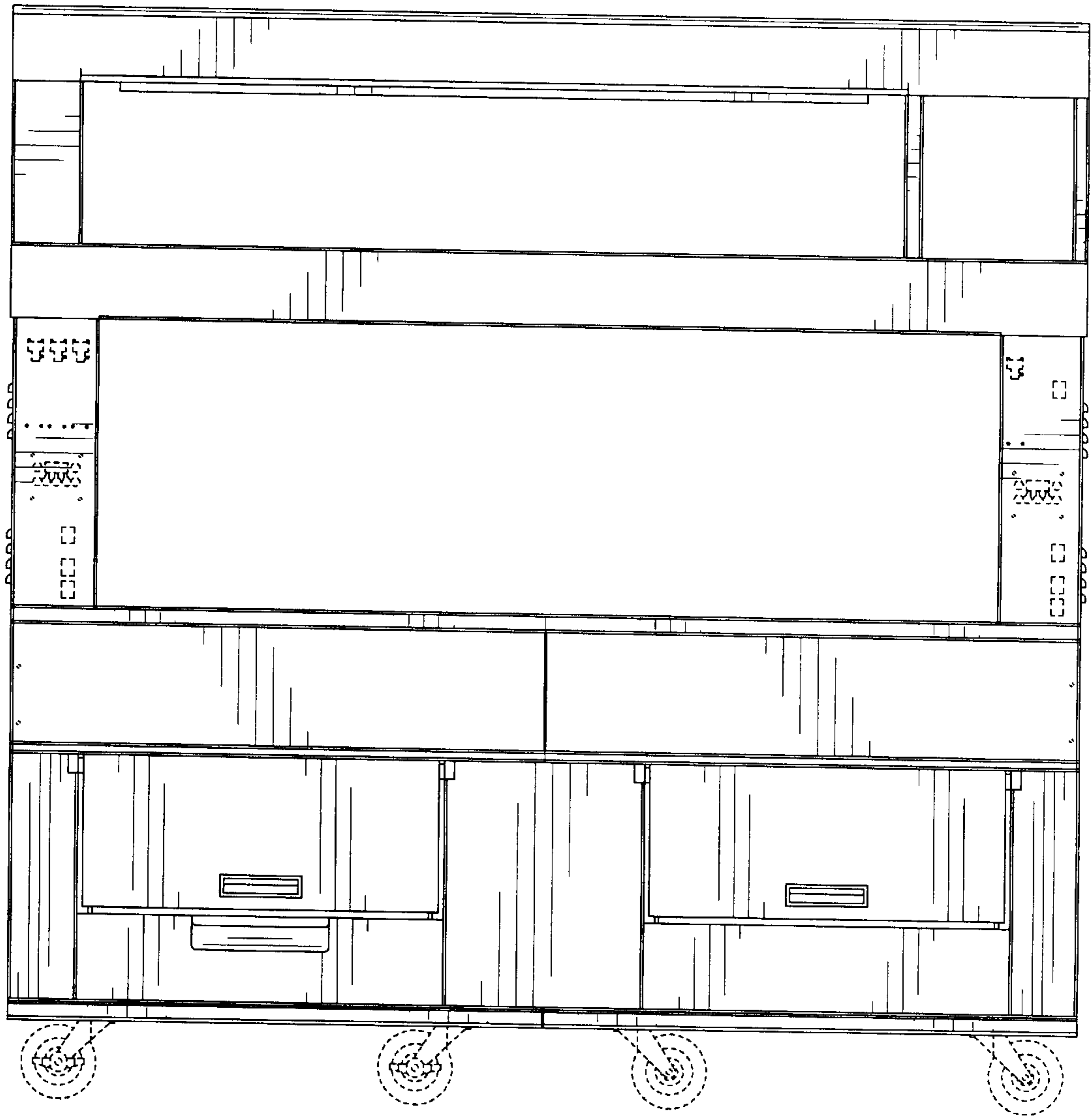

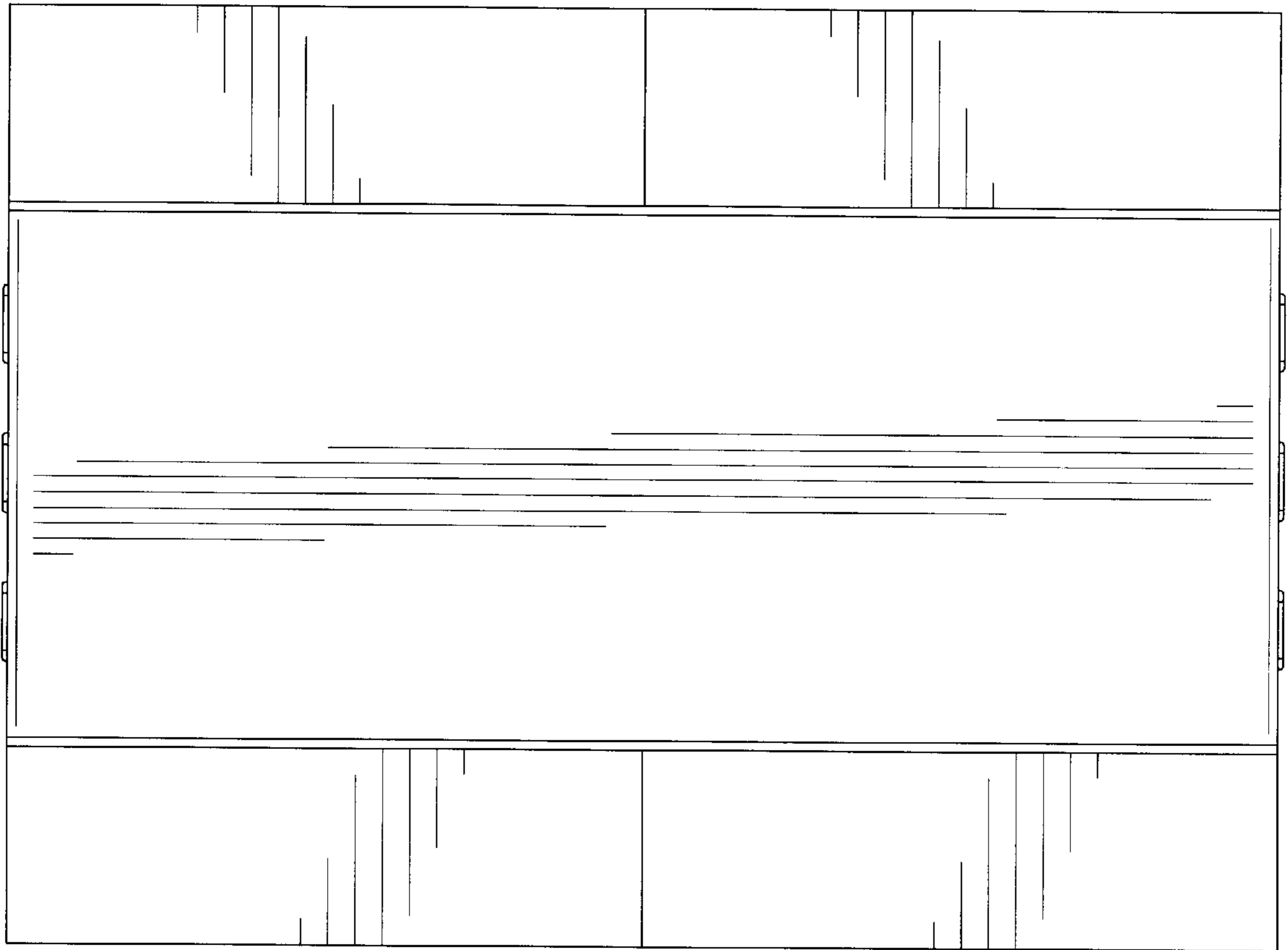

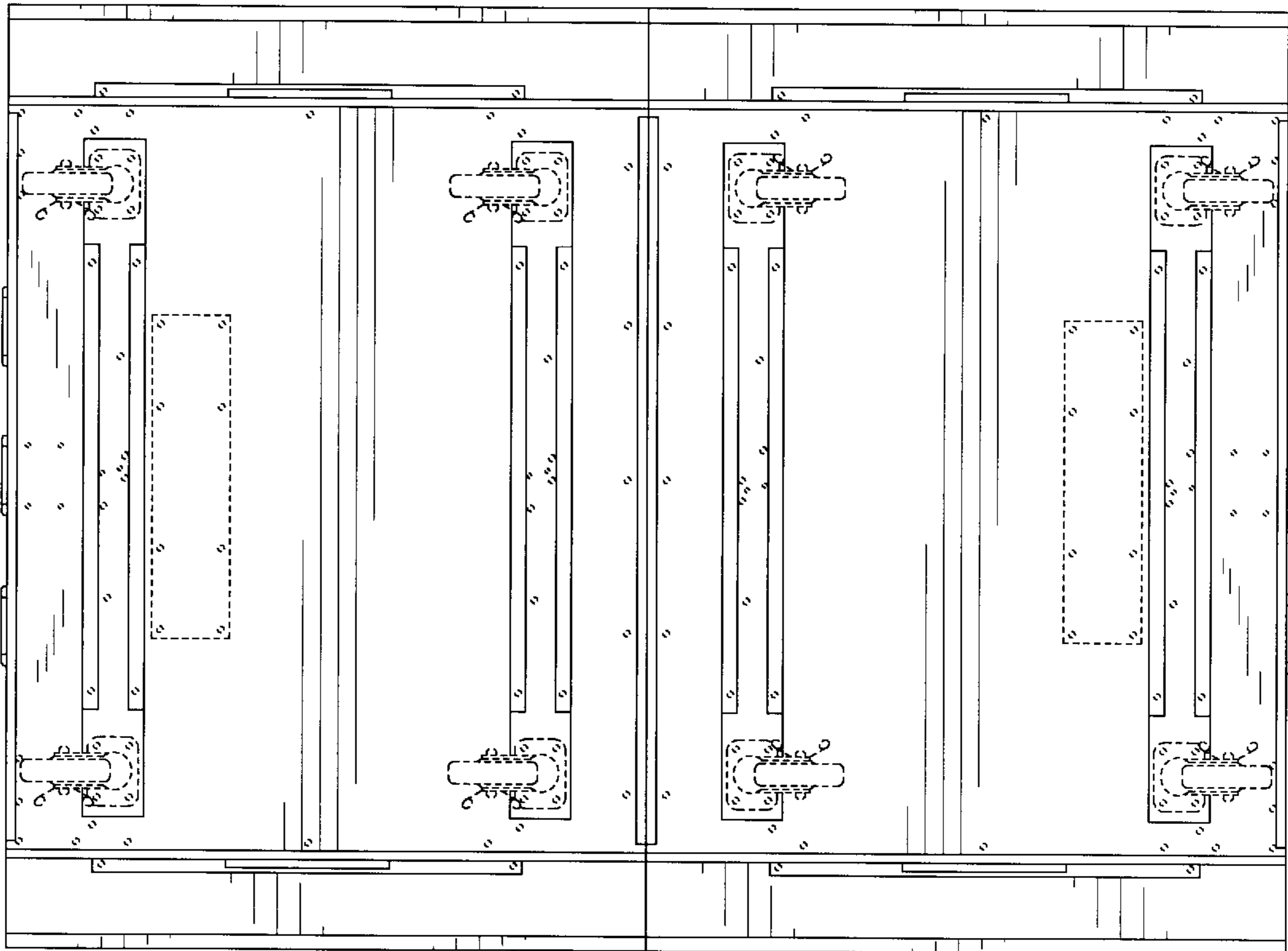
