FIG. 1 is a perspective view of a cupcake shot glass showing my new design;

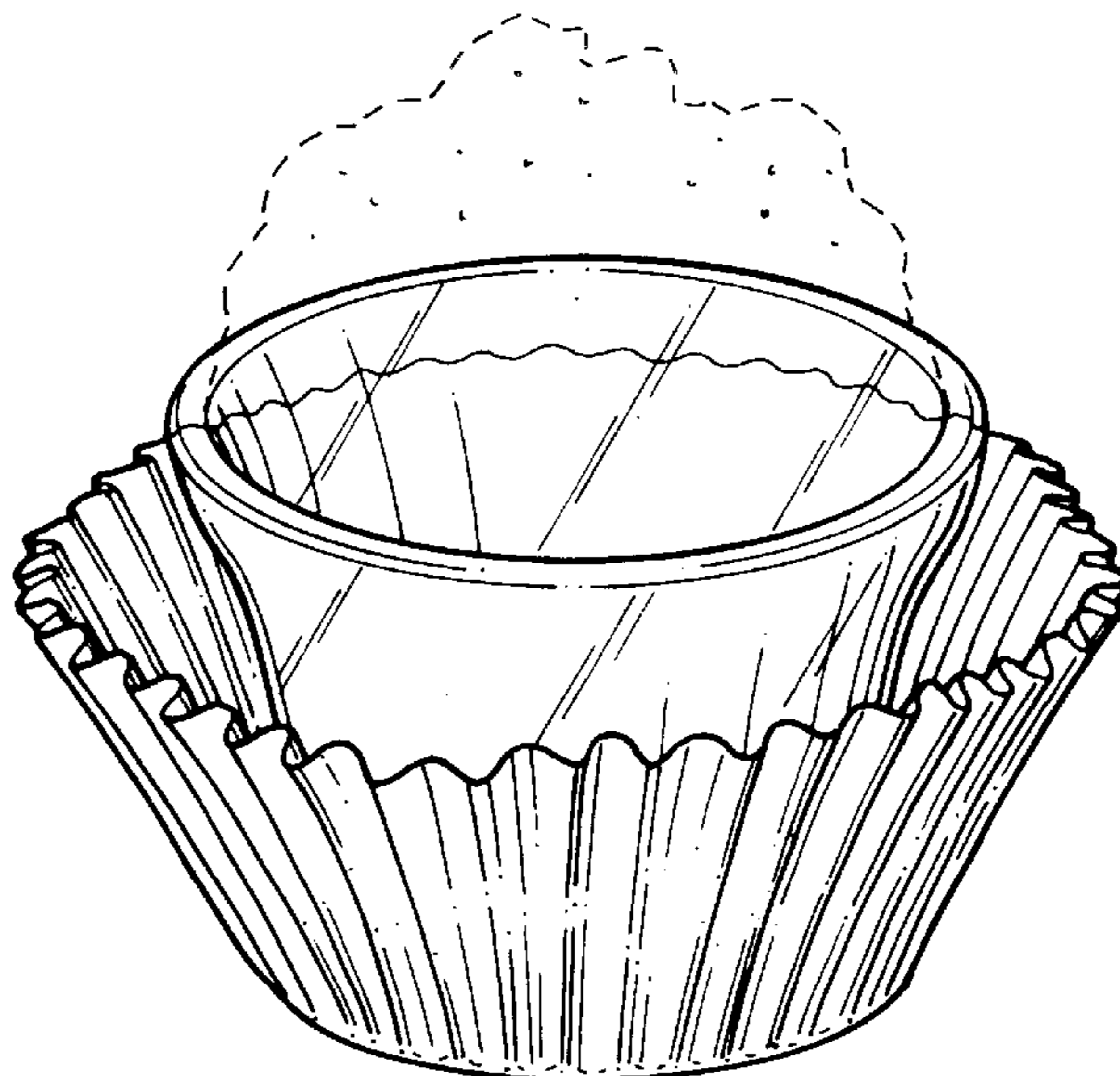
FIG. 2 is a top plan view thereof;

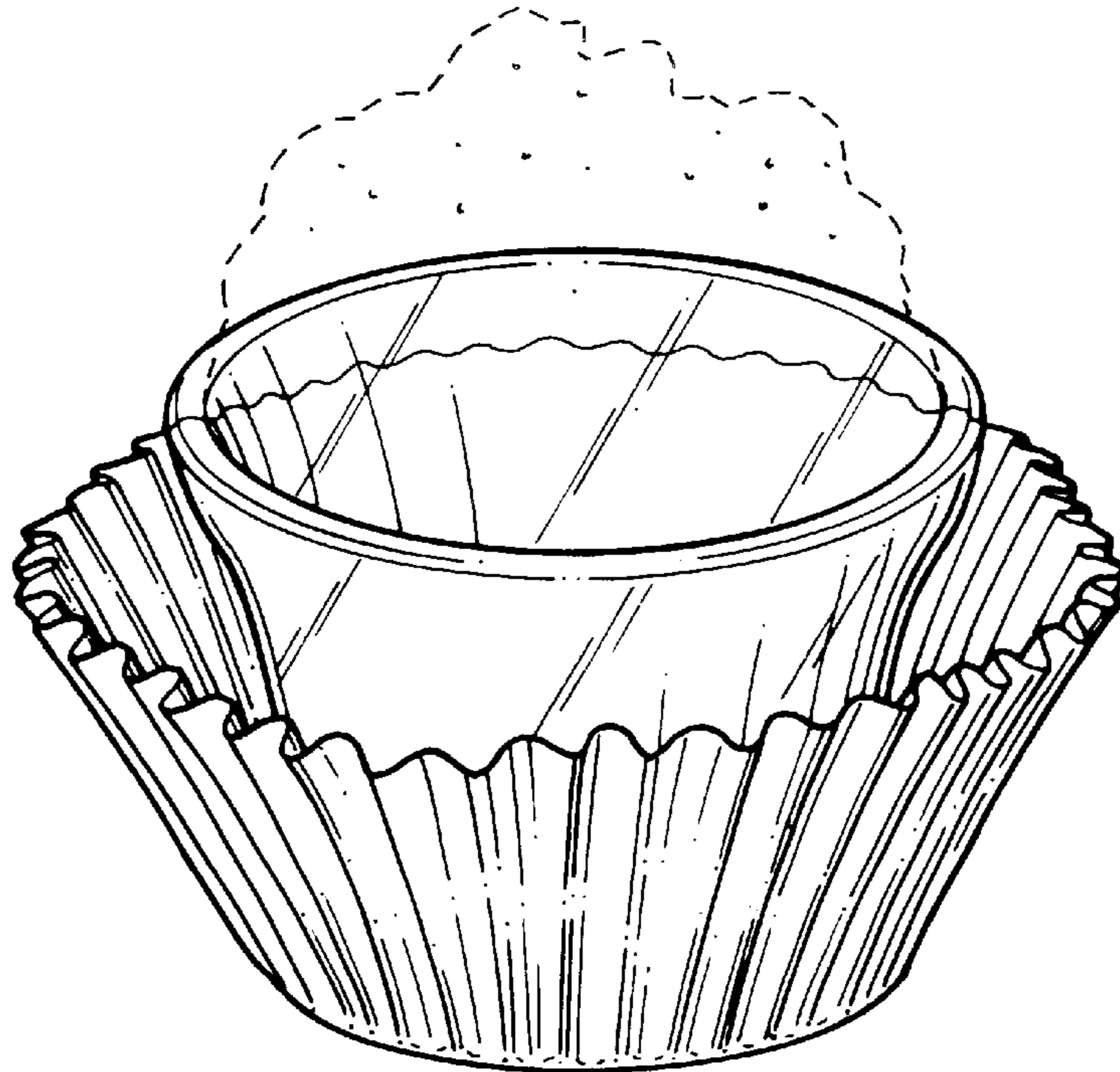

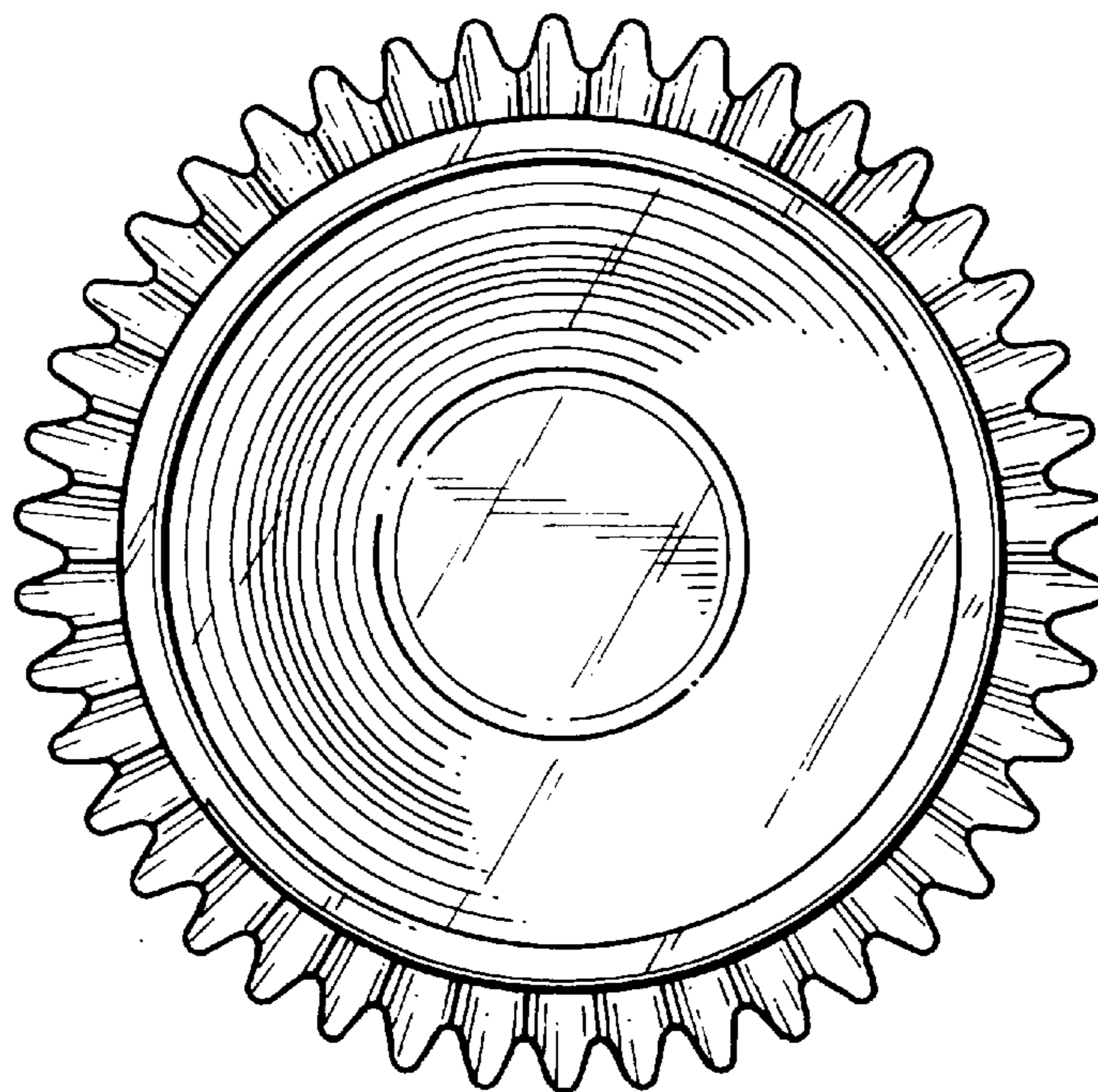

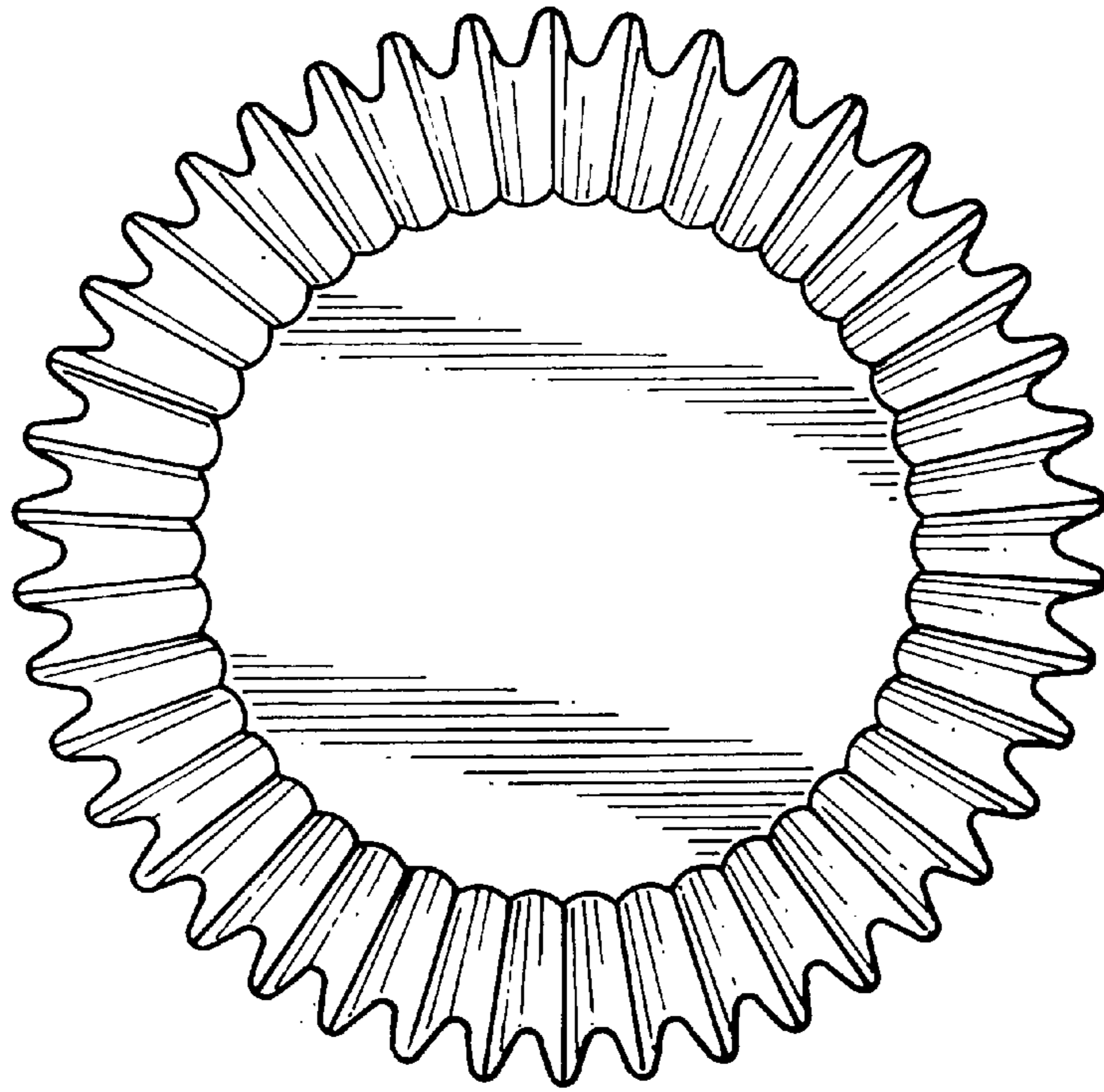

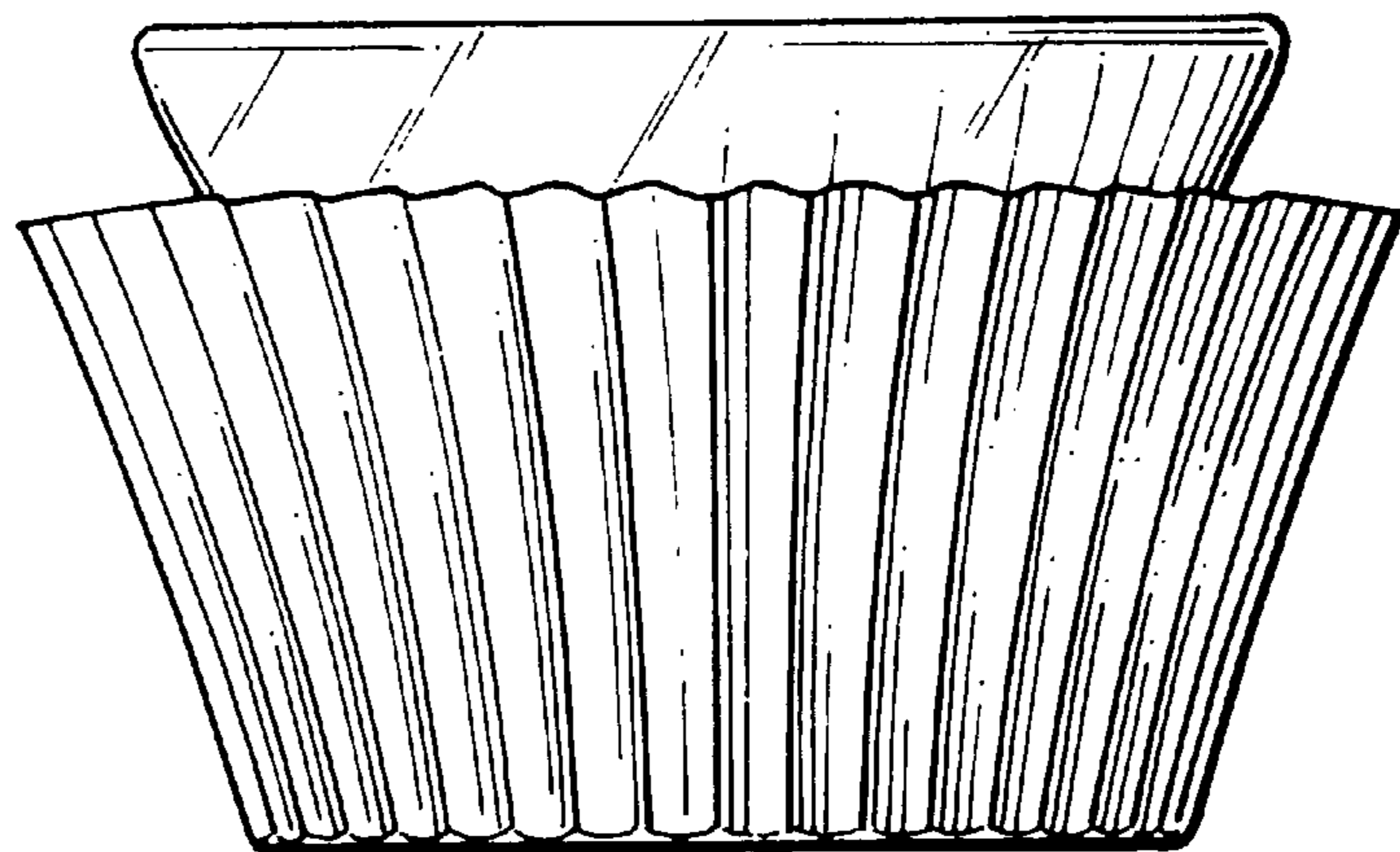
