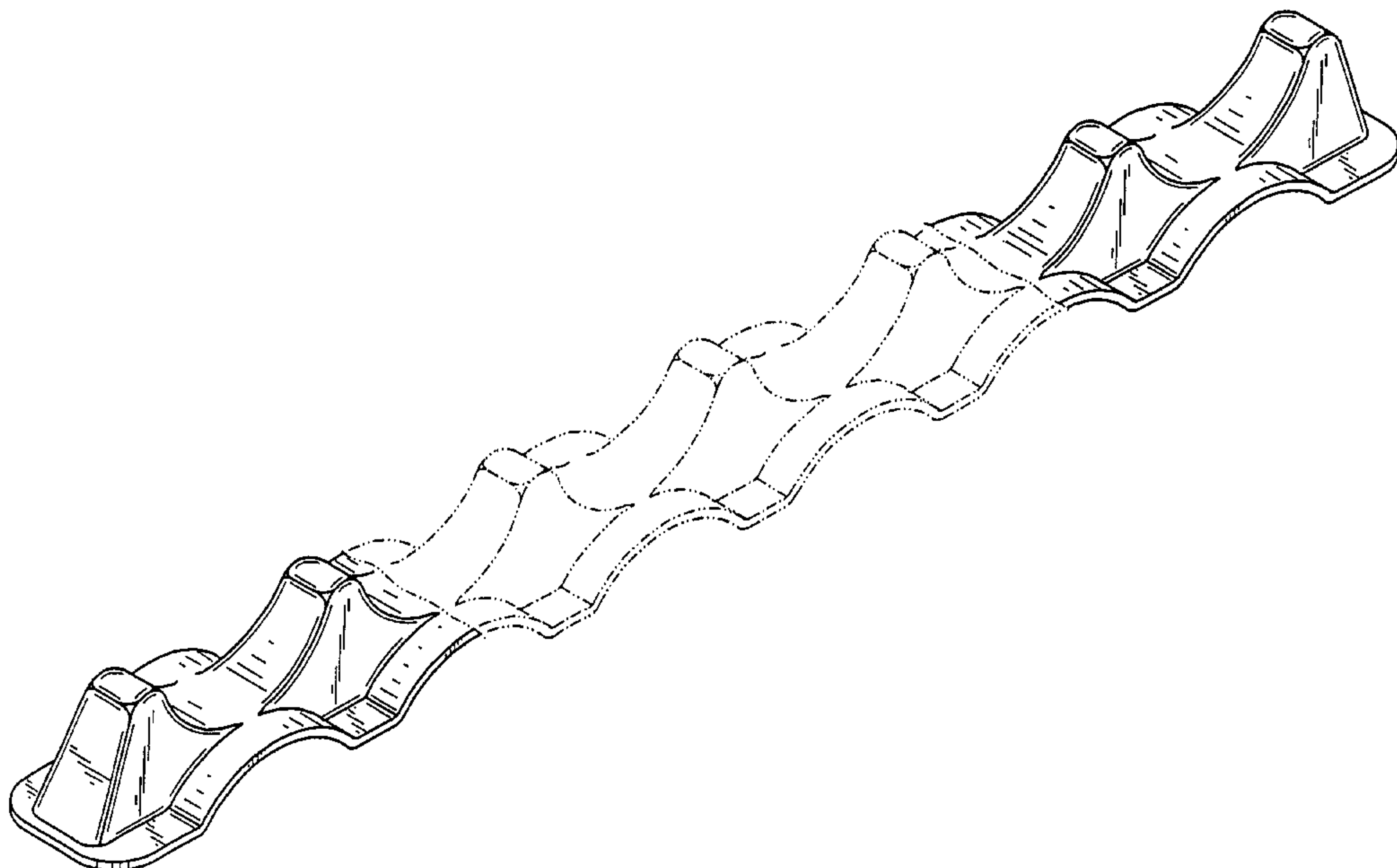
The ornamental design for a narrow roll support, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a roll support in accordance with the present invention;
 FIG. 2 is an end view of the roll support of the present invention;
 FIG. 3 is a top plan view of the roll support of the present invention;
 FIG. 4 is a side elevational view of the roll support of the present invention; and,
 FIG. 5 is a bottom plan view of the roll support of the present invention.

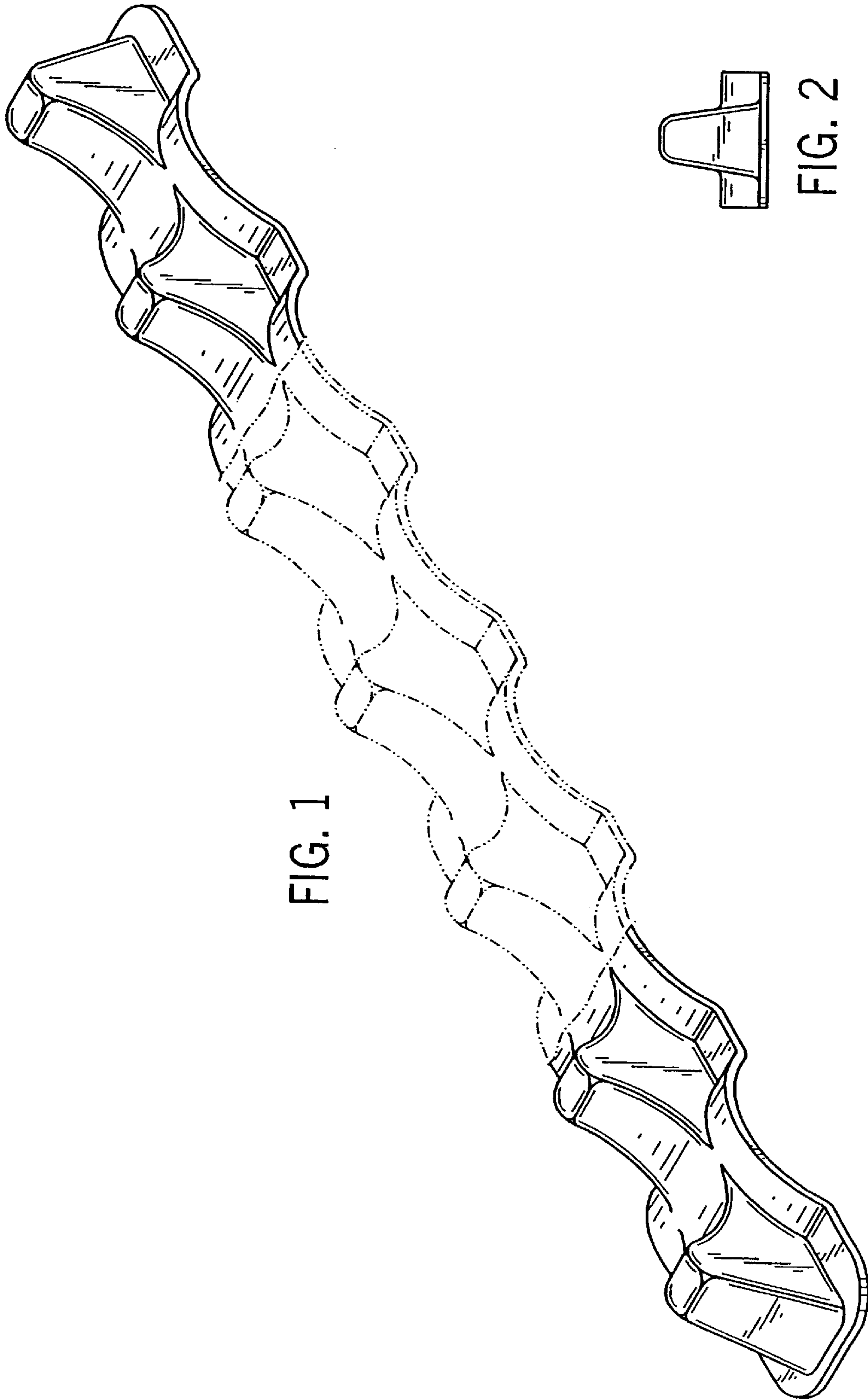

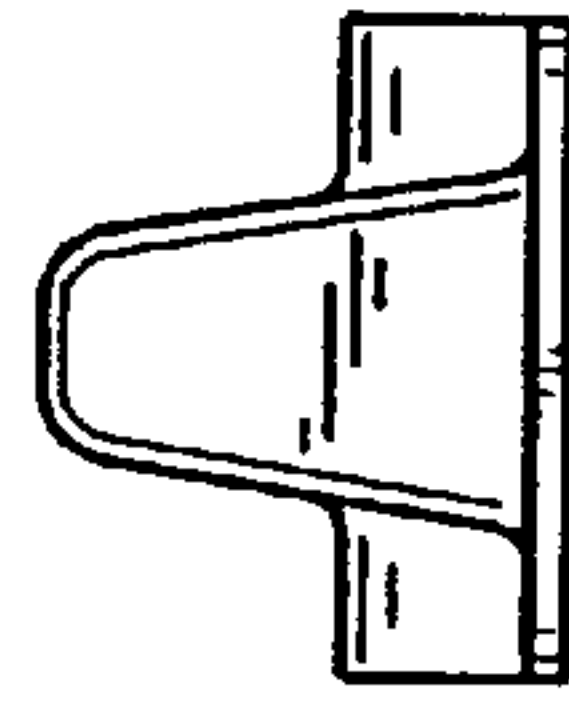

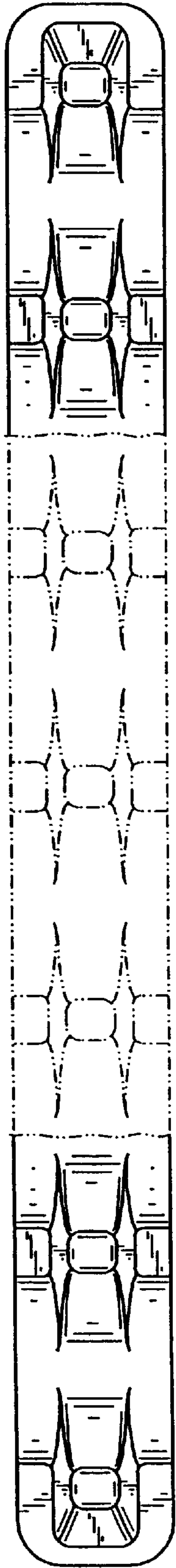

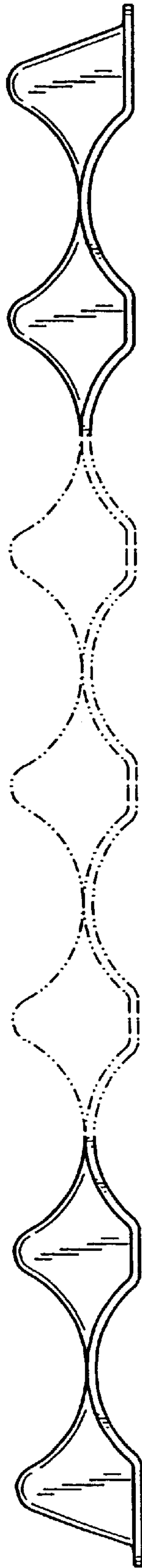

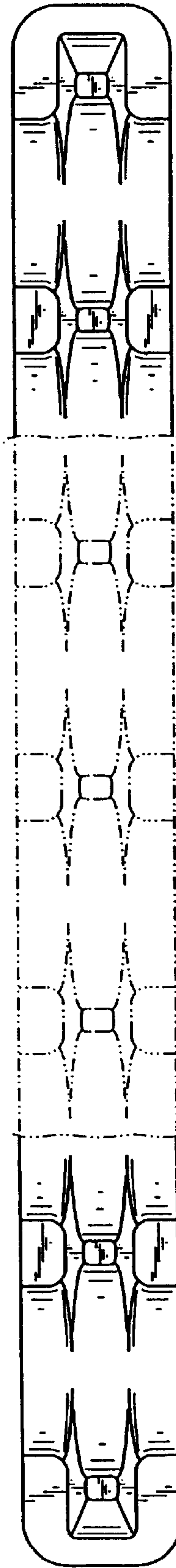
