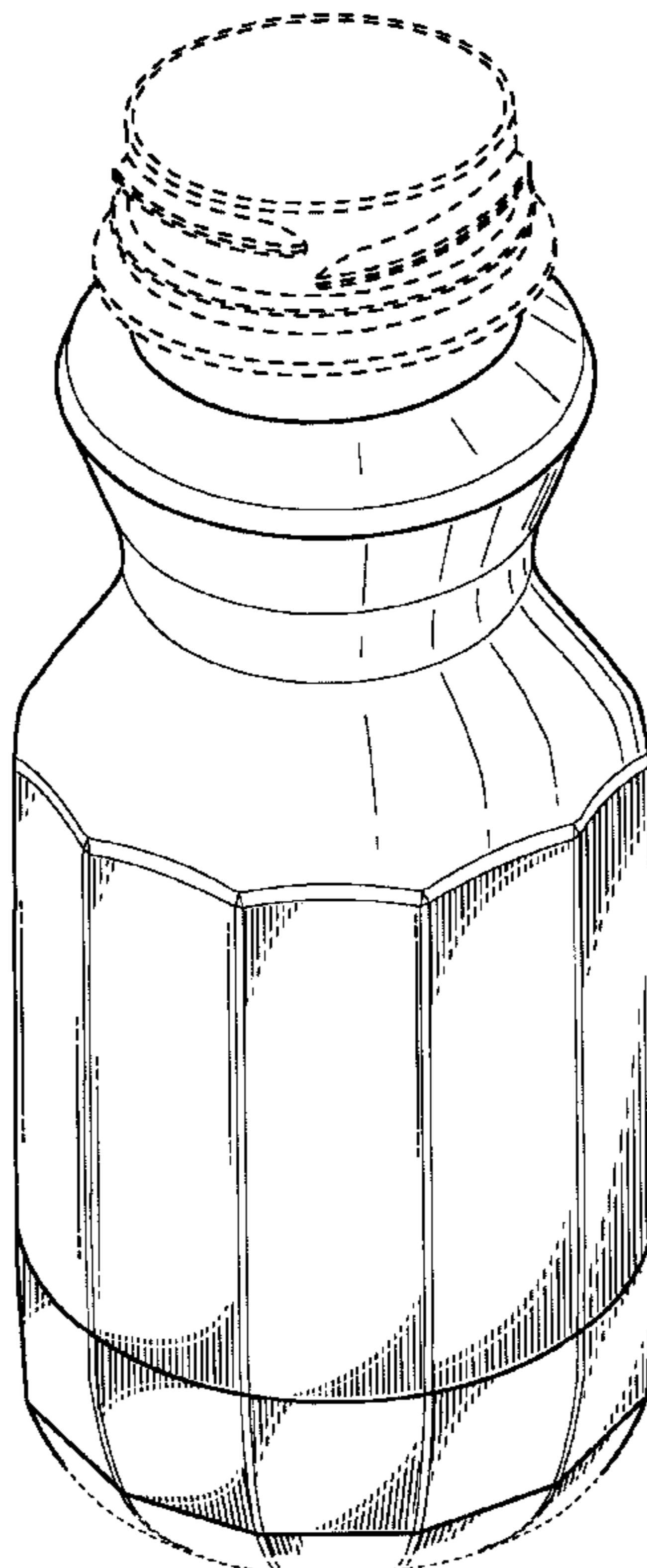
(57) **CLAIM**

We claim the ornamental design for a bottle, as shown.

DESCRIPTION

FIG. 1 is a top front side perspective view of a bottle showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.

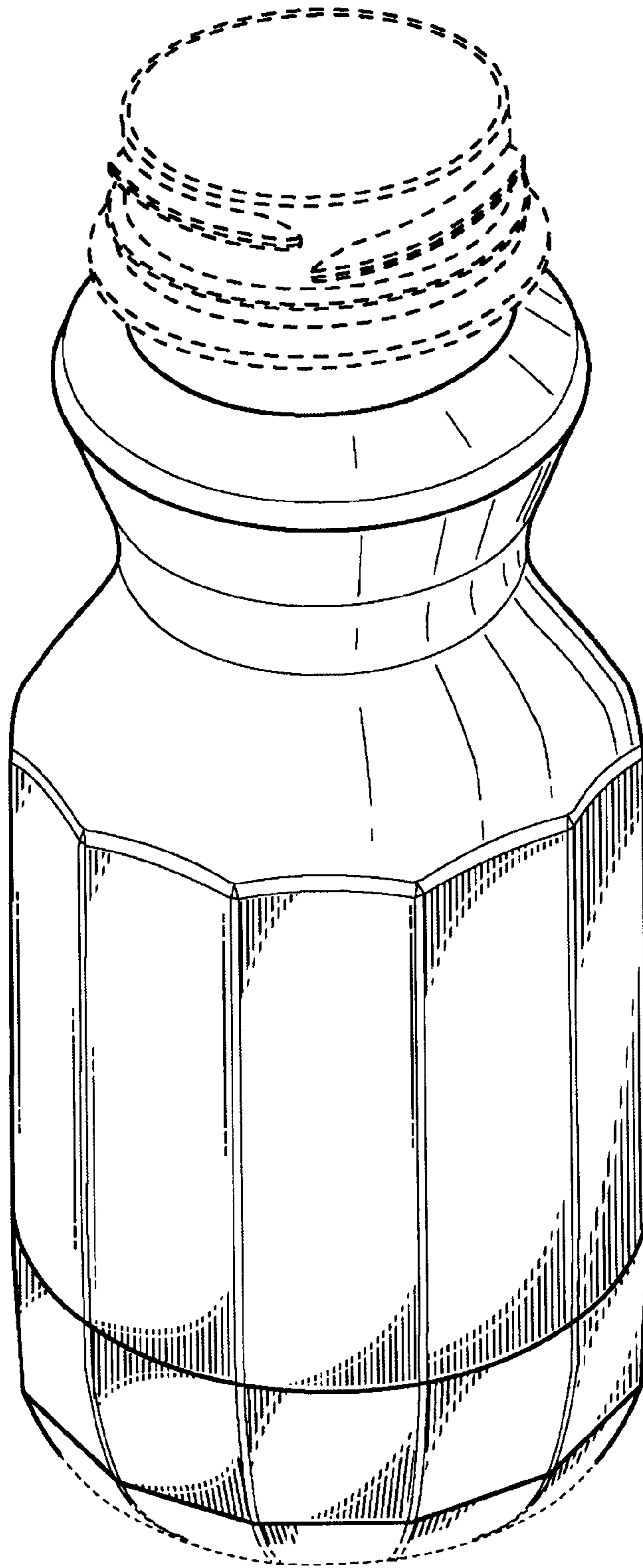

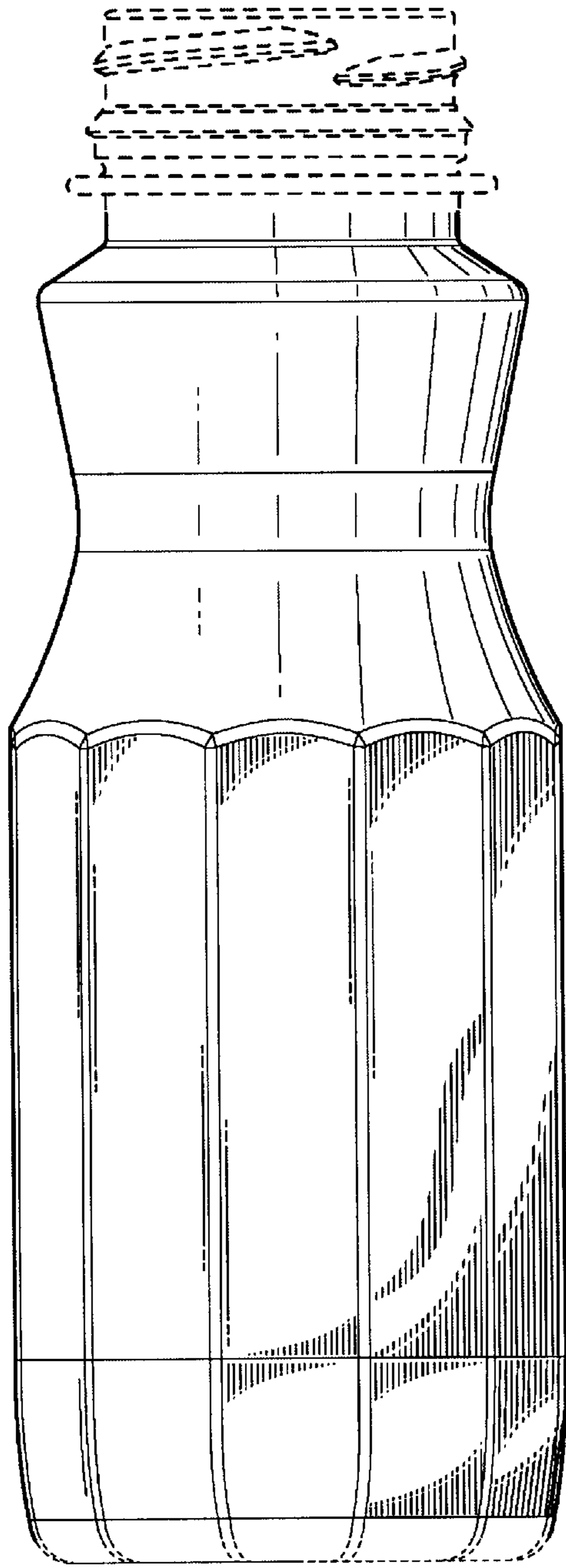

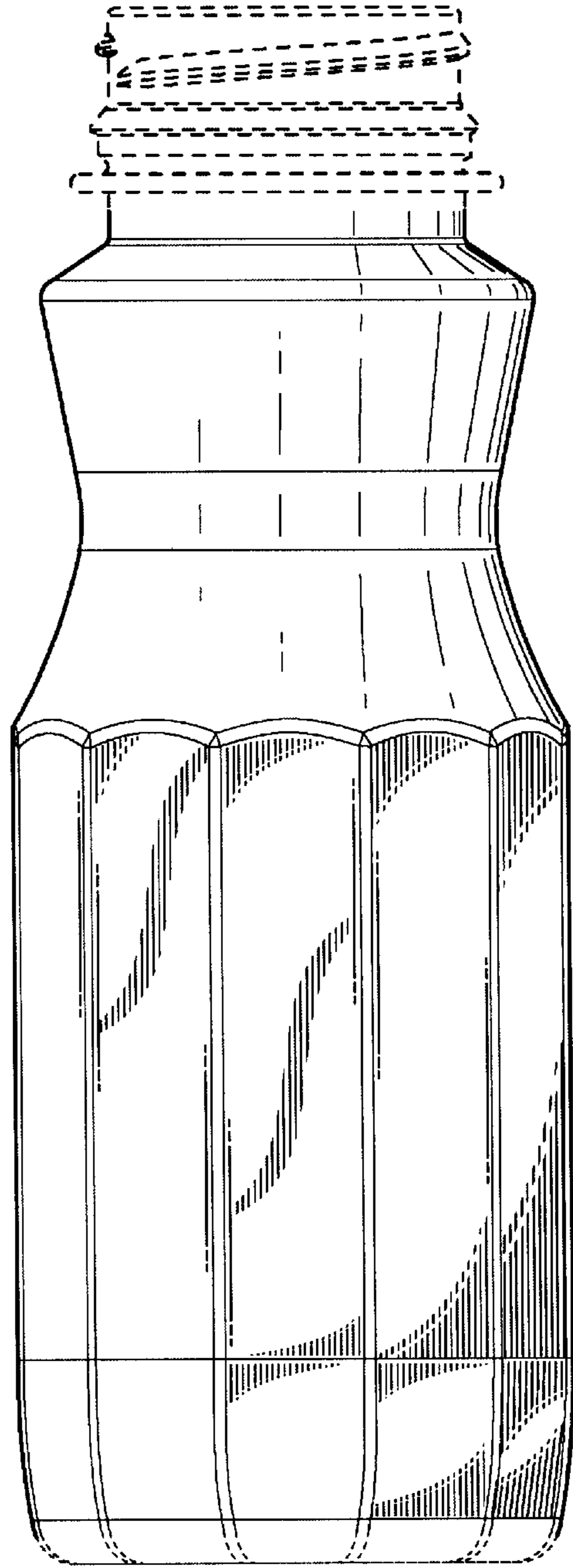

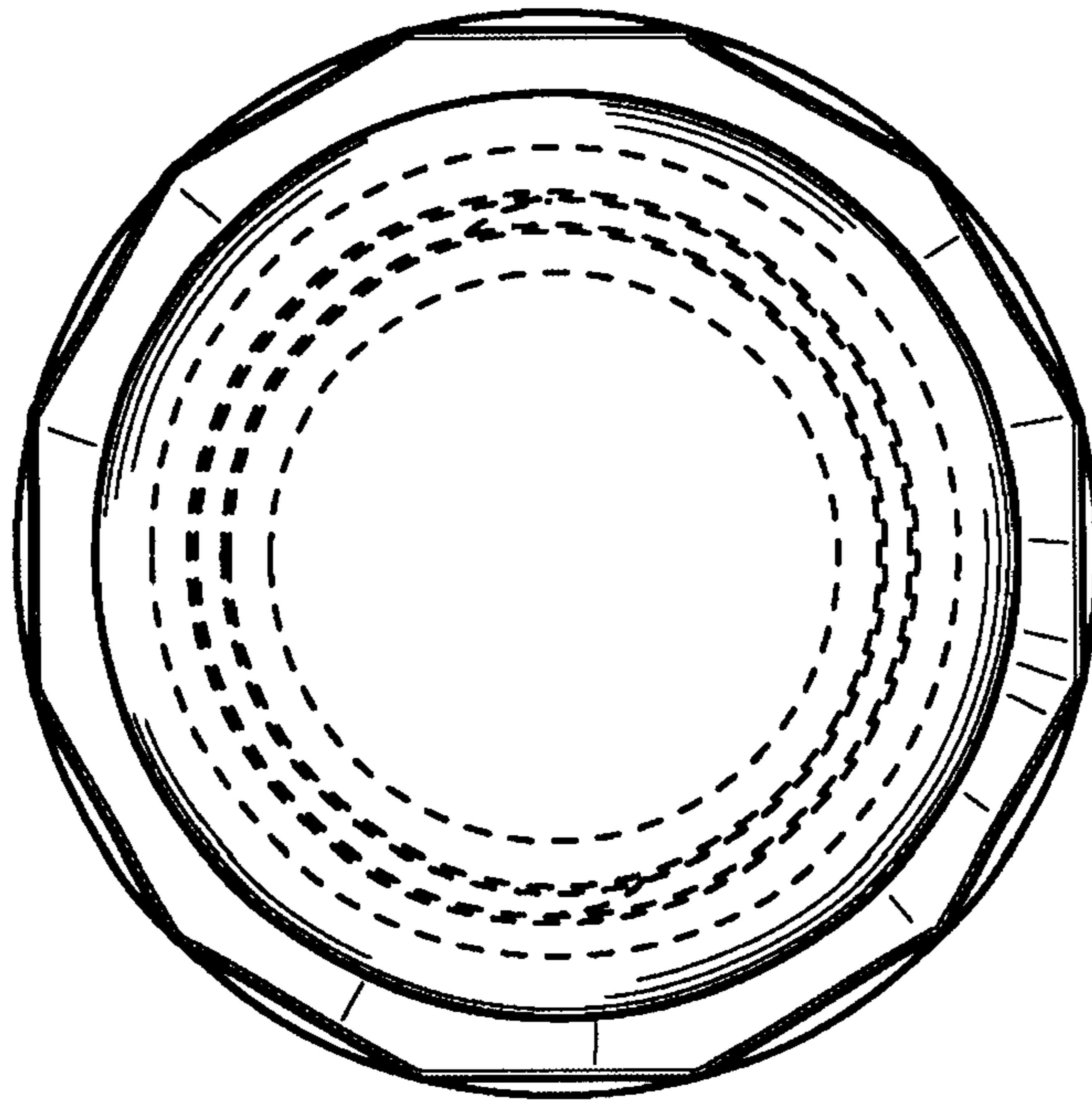

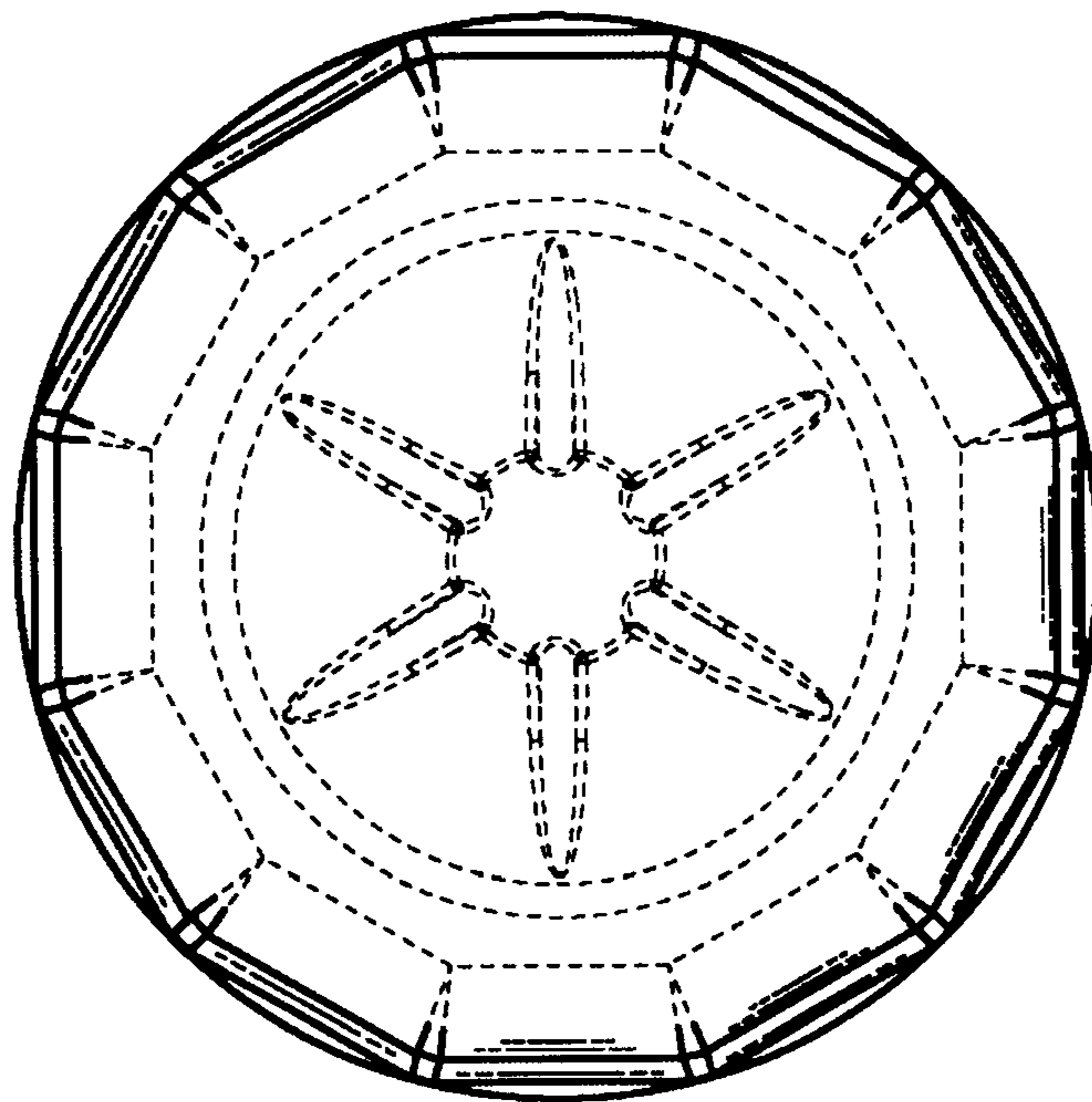
