#### (57) CLAIM

The ornamental design for an integrated replacement tail lens assembly for automobile, as shown and described.

#### **DESCRIPTION**

FIG. 1 is a right side perspective view of the integrated replacement lens assembly of the present design;

FIG. 2 is a right side perspective view of the integrated replacement lens assembly of the present design showing the cover removed;

FIG. 3 is a front view of the integrated replacement lens assembly of the present design;

FIG. 4 is a right side view of the integrated replacement lens assembly of the present design;

FIG. 5 is a top sectional view of the integrated replacement lens assembly of the present design; and,

FIG. 6 is a left side perspective view of the integrated replacement lens assembly of the present design showing the lens assembly installed on an automobile.

The broken lines showing of the lens assembly in FIG. 5 and of the automobile in FIG. 6 are for illustrative purposes only and form no part of the claimed design.
