(57) **CLAIM**

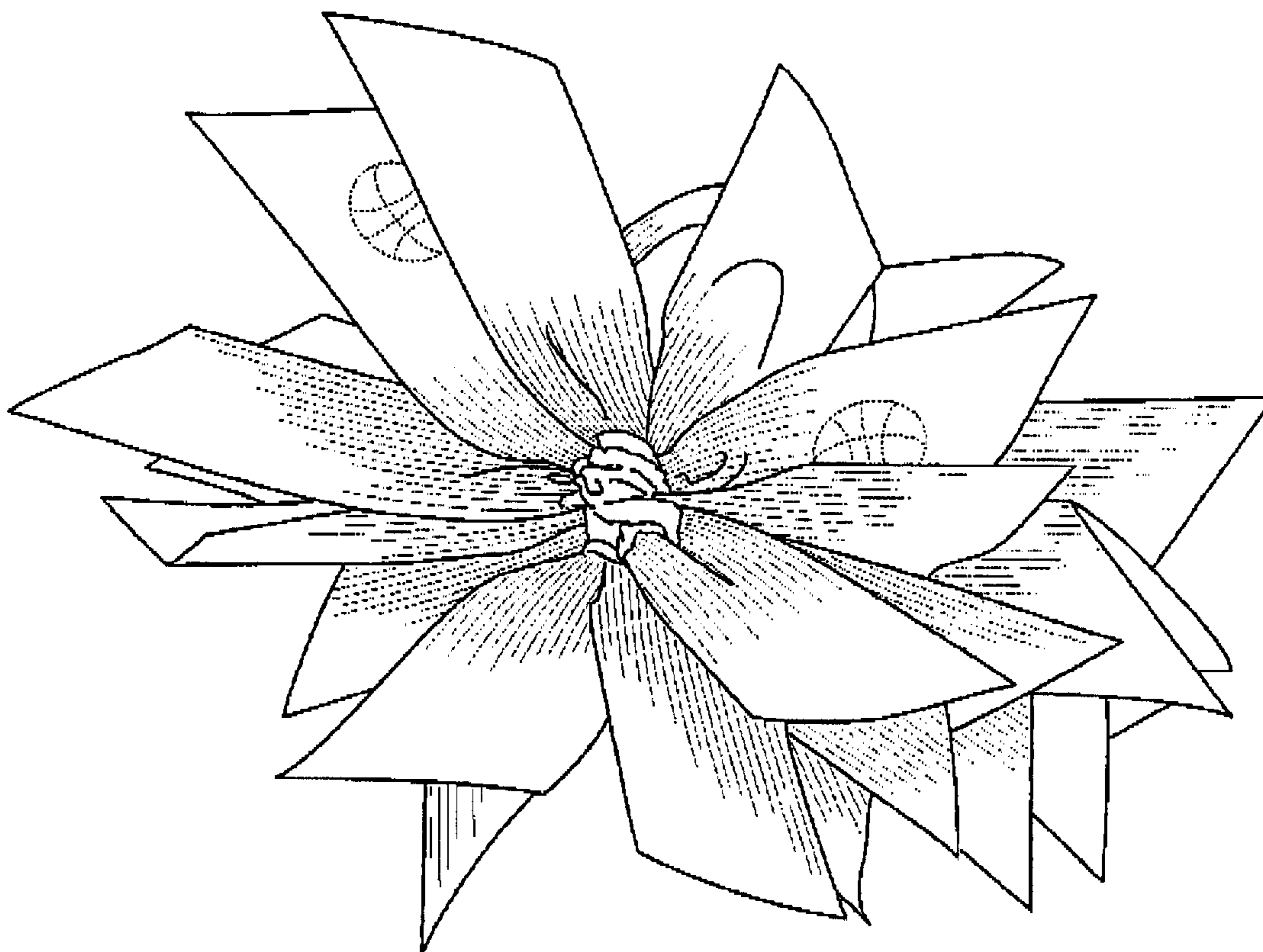
The ornamental design for a decorative hair accessory, as shown and described.

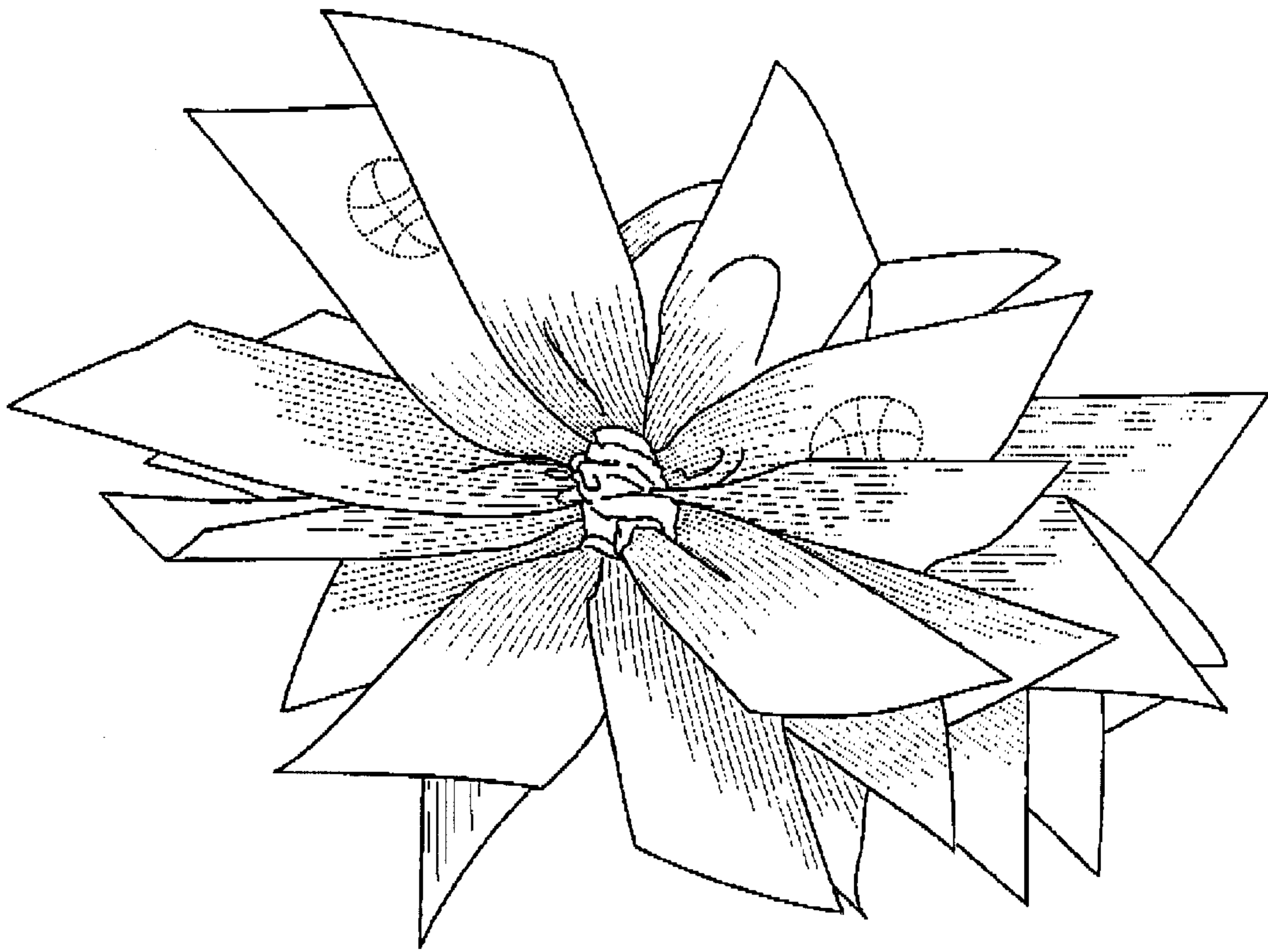

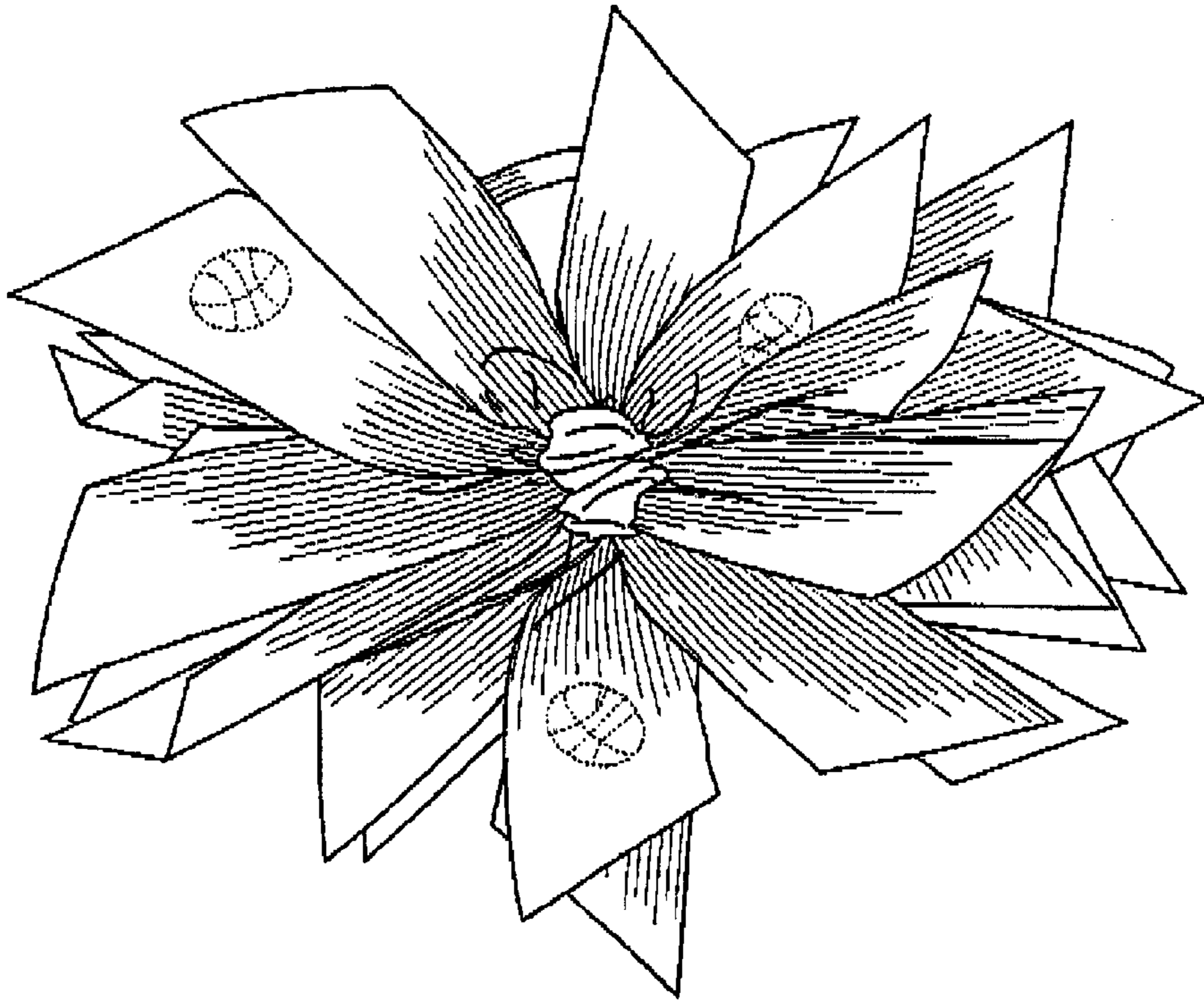

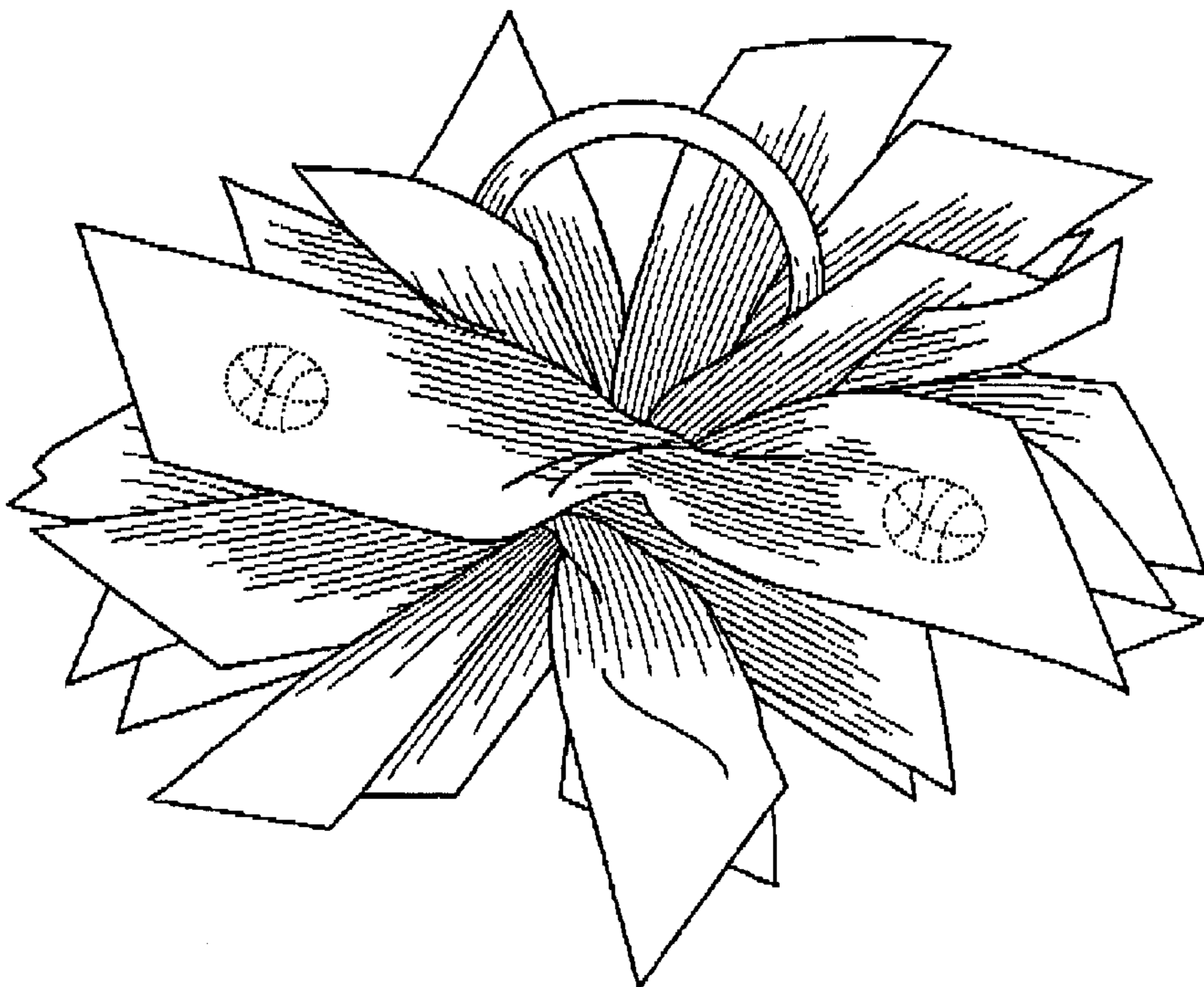

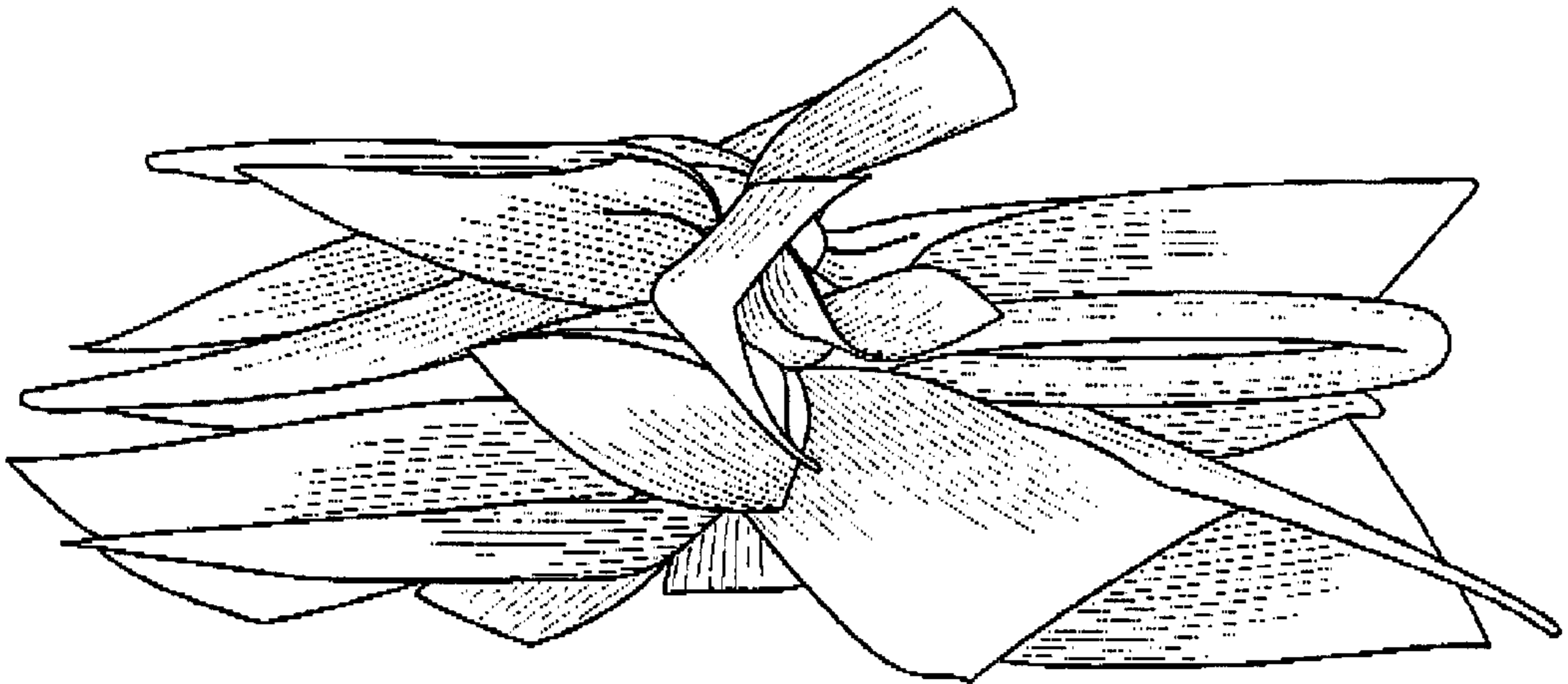

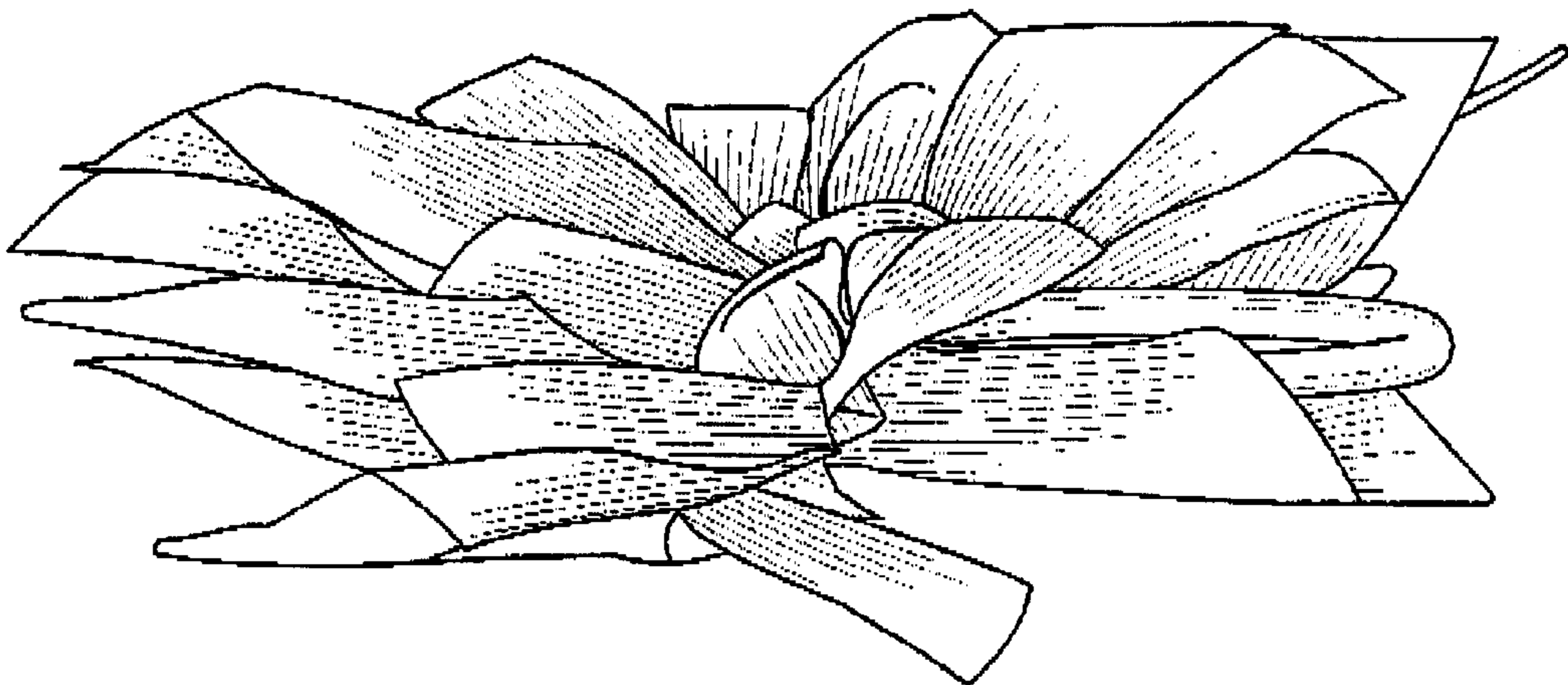

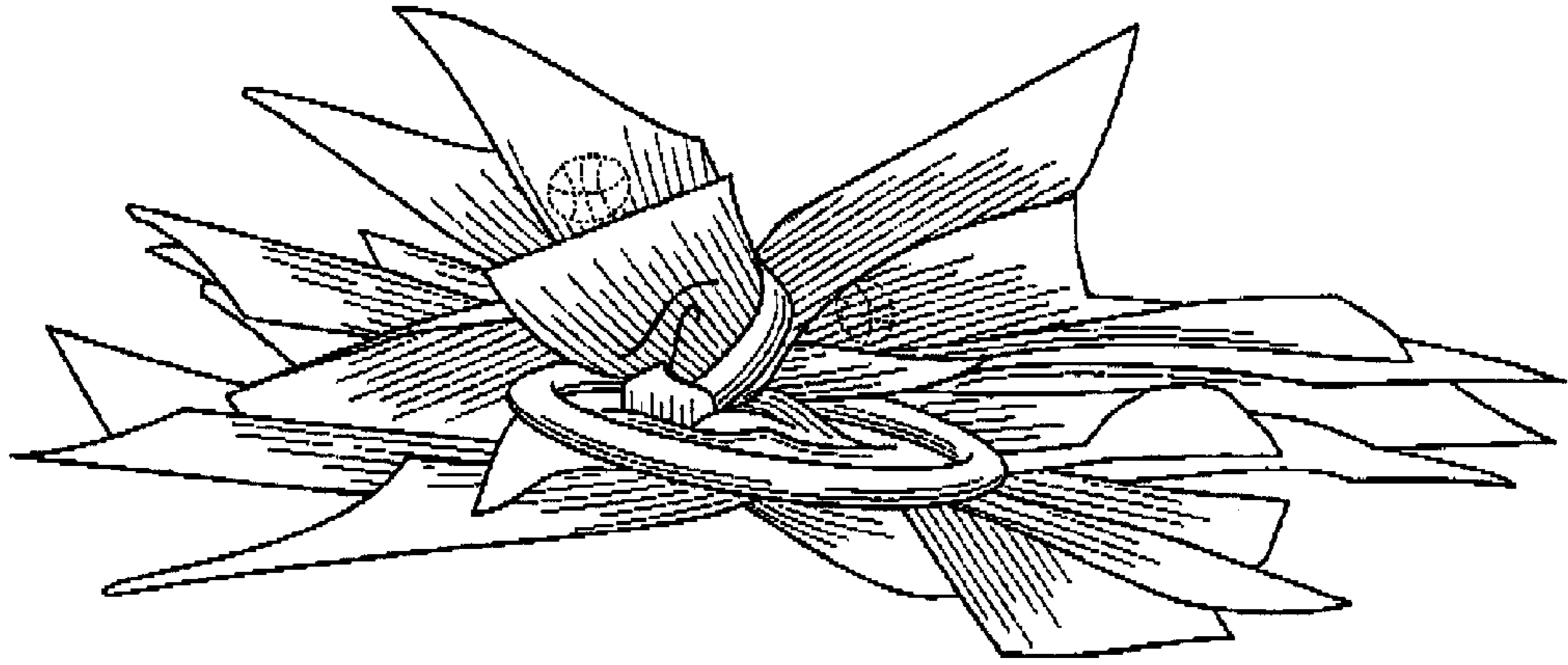

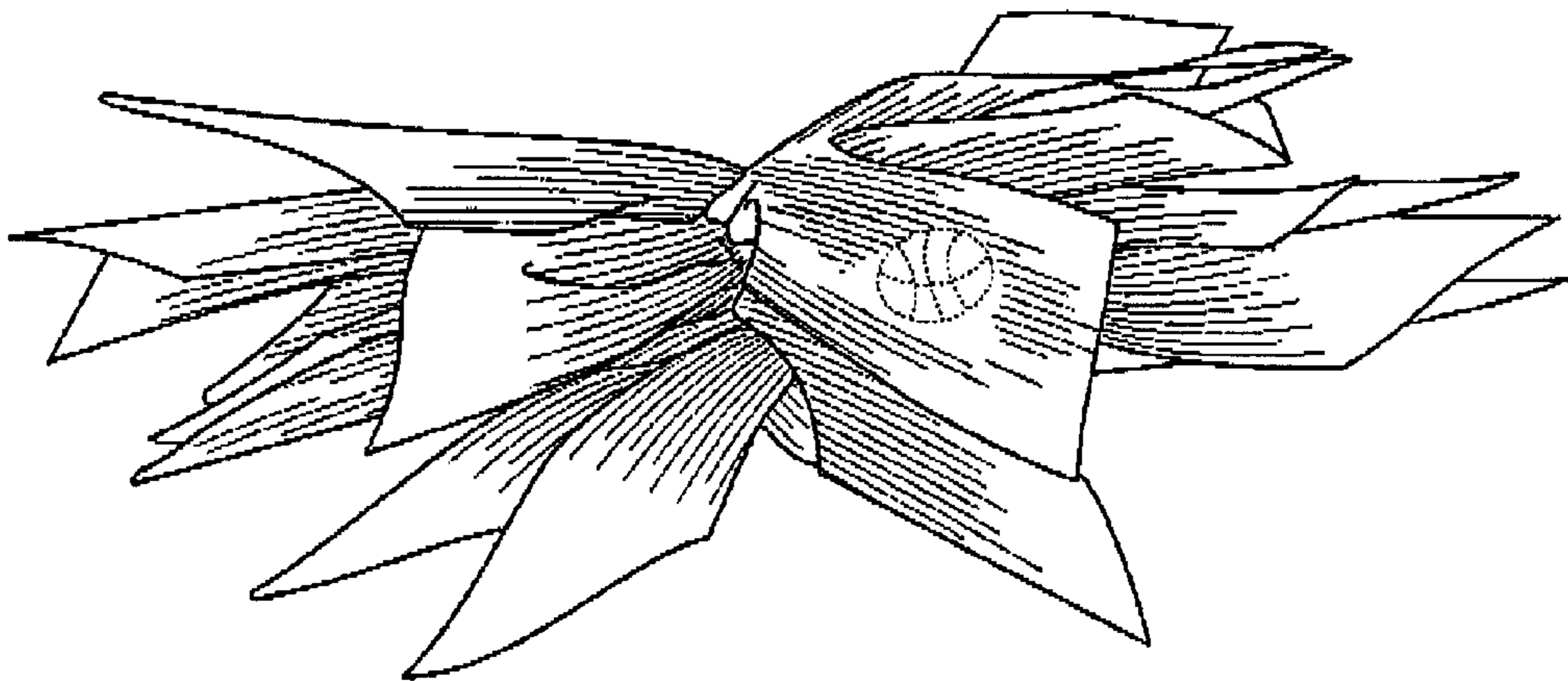
