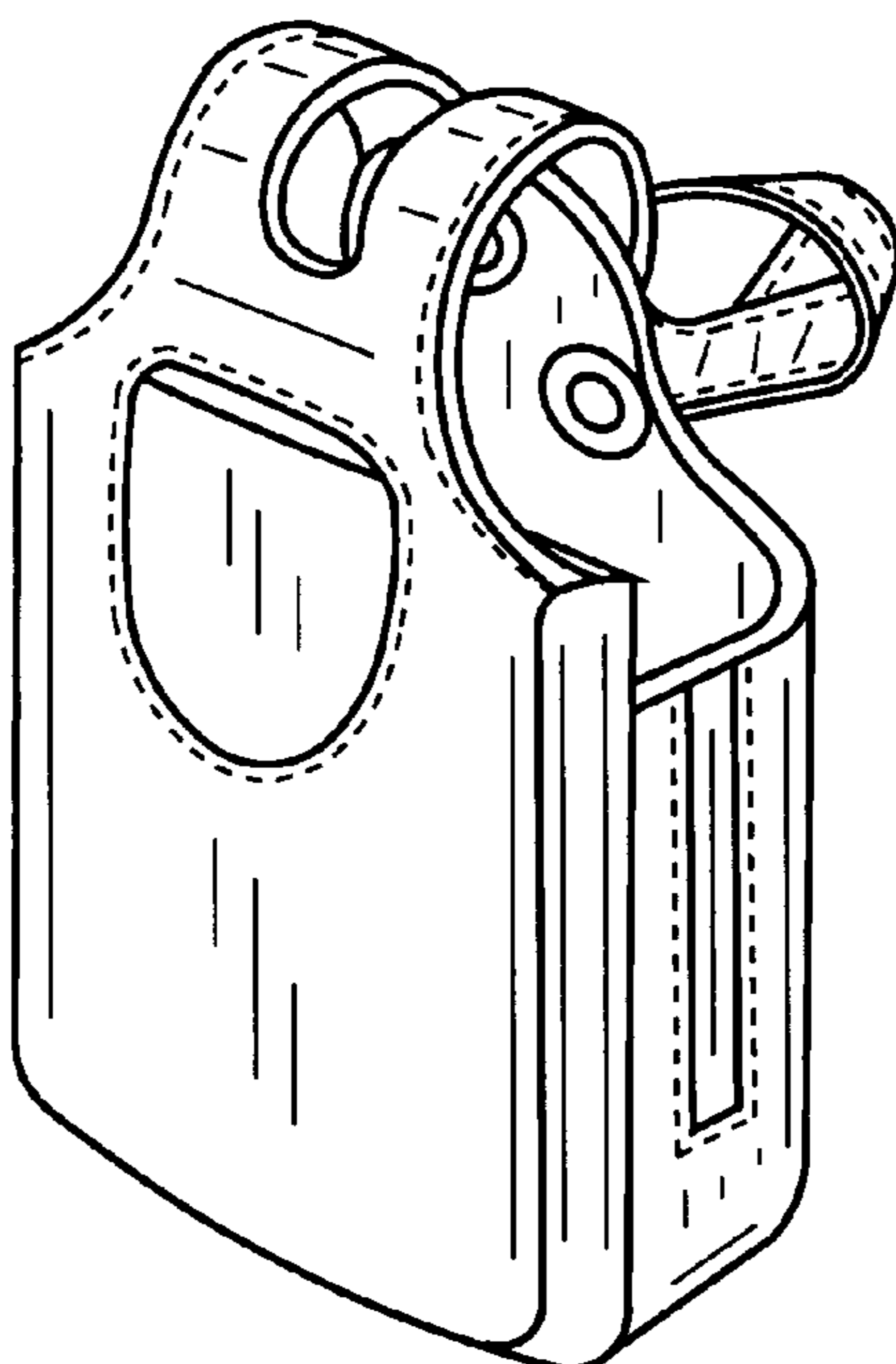
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of the carrying case showing our new design;

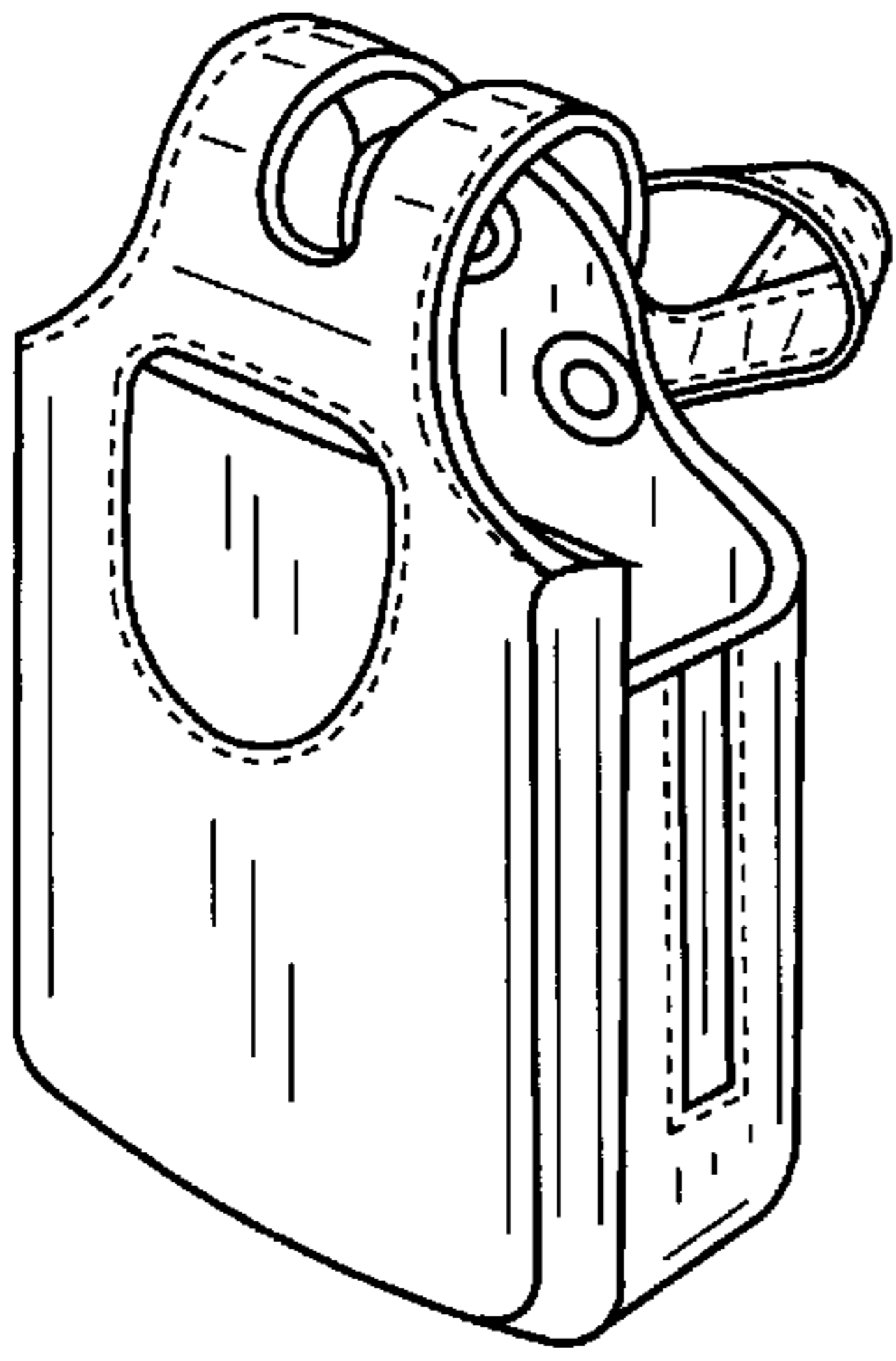

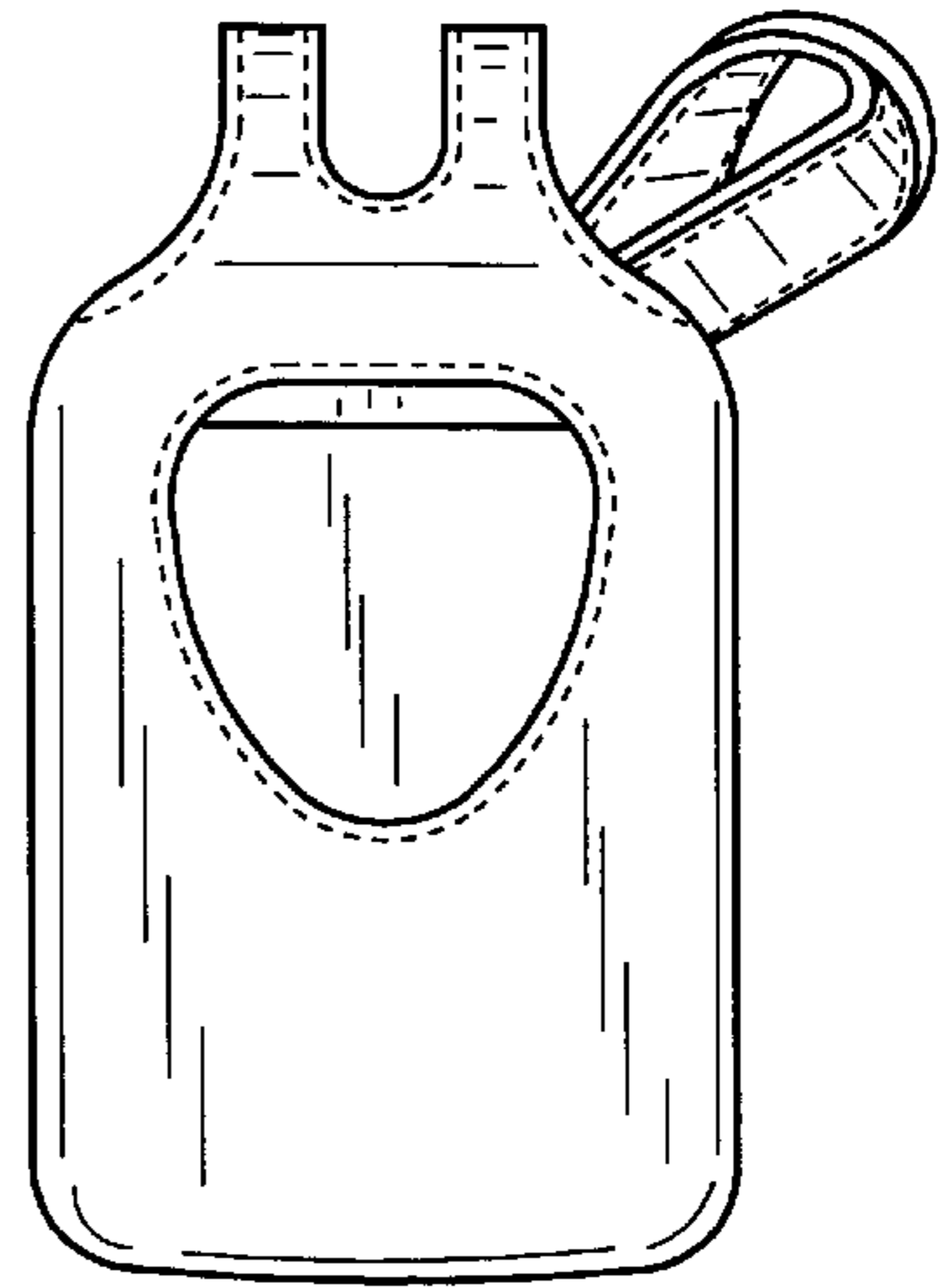

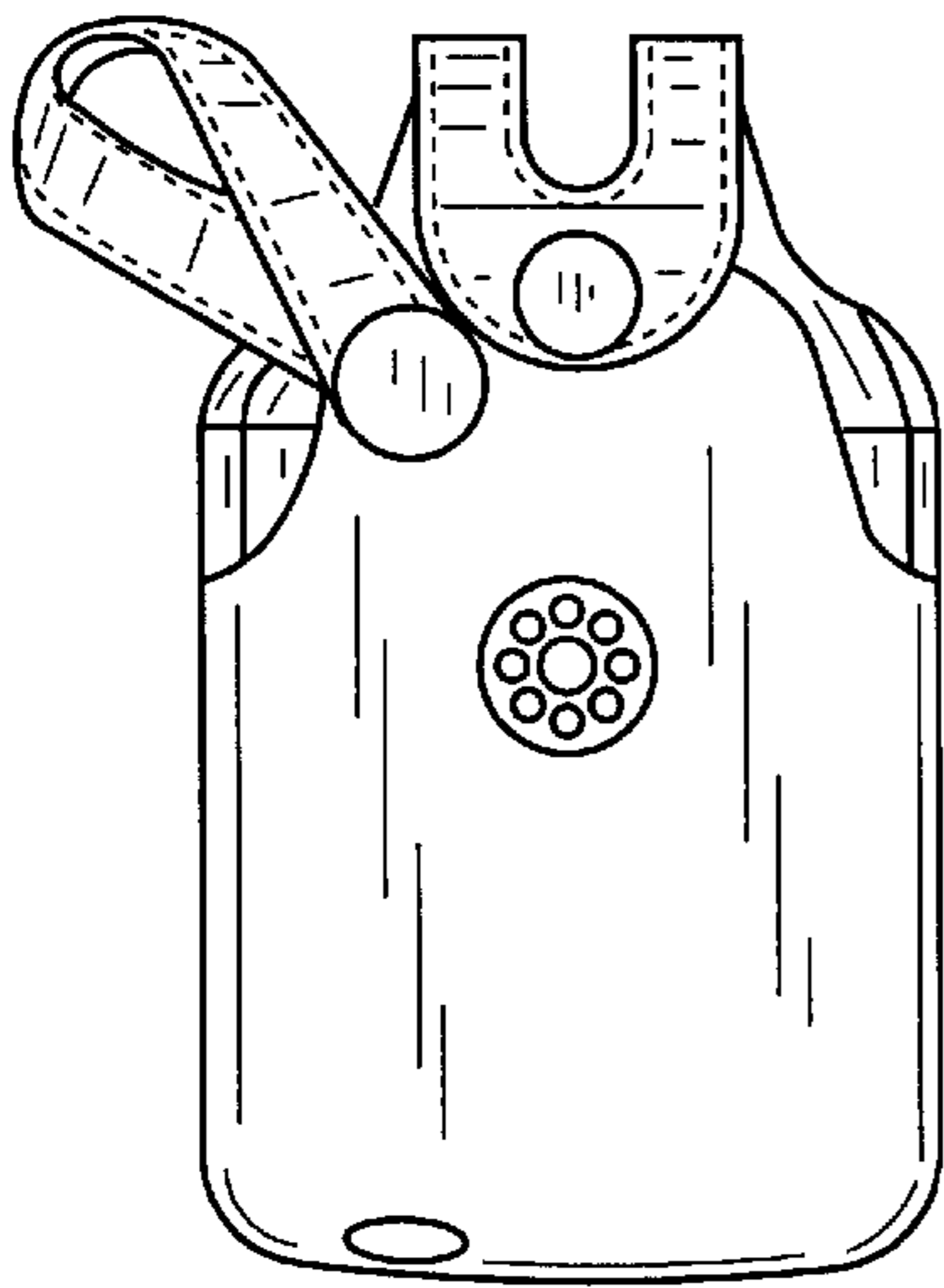

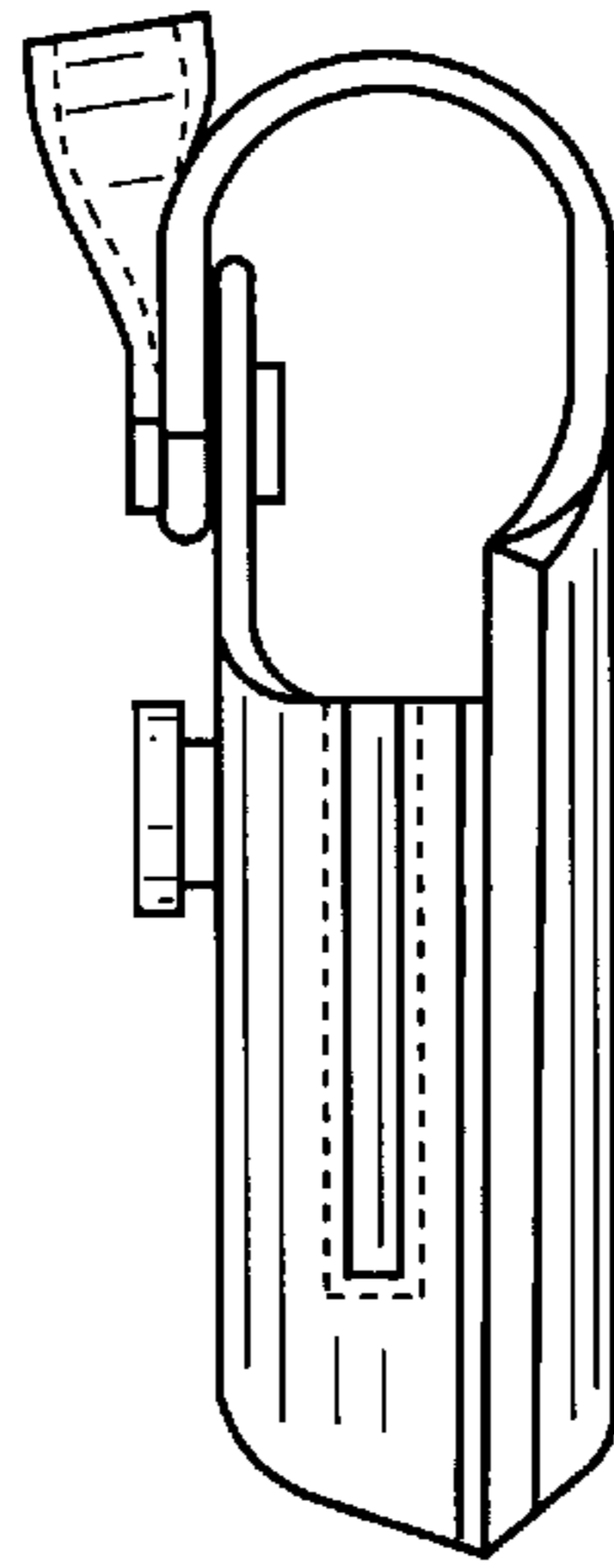

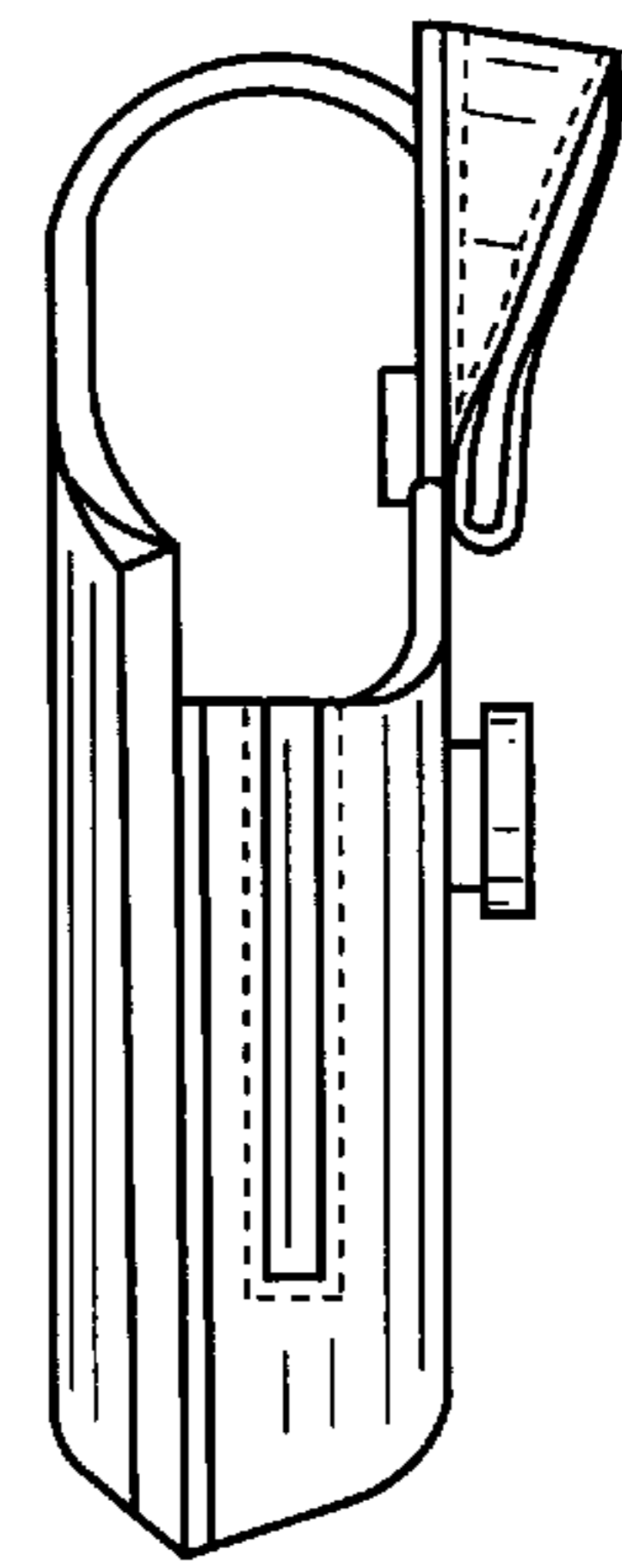

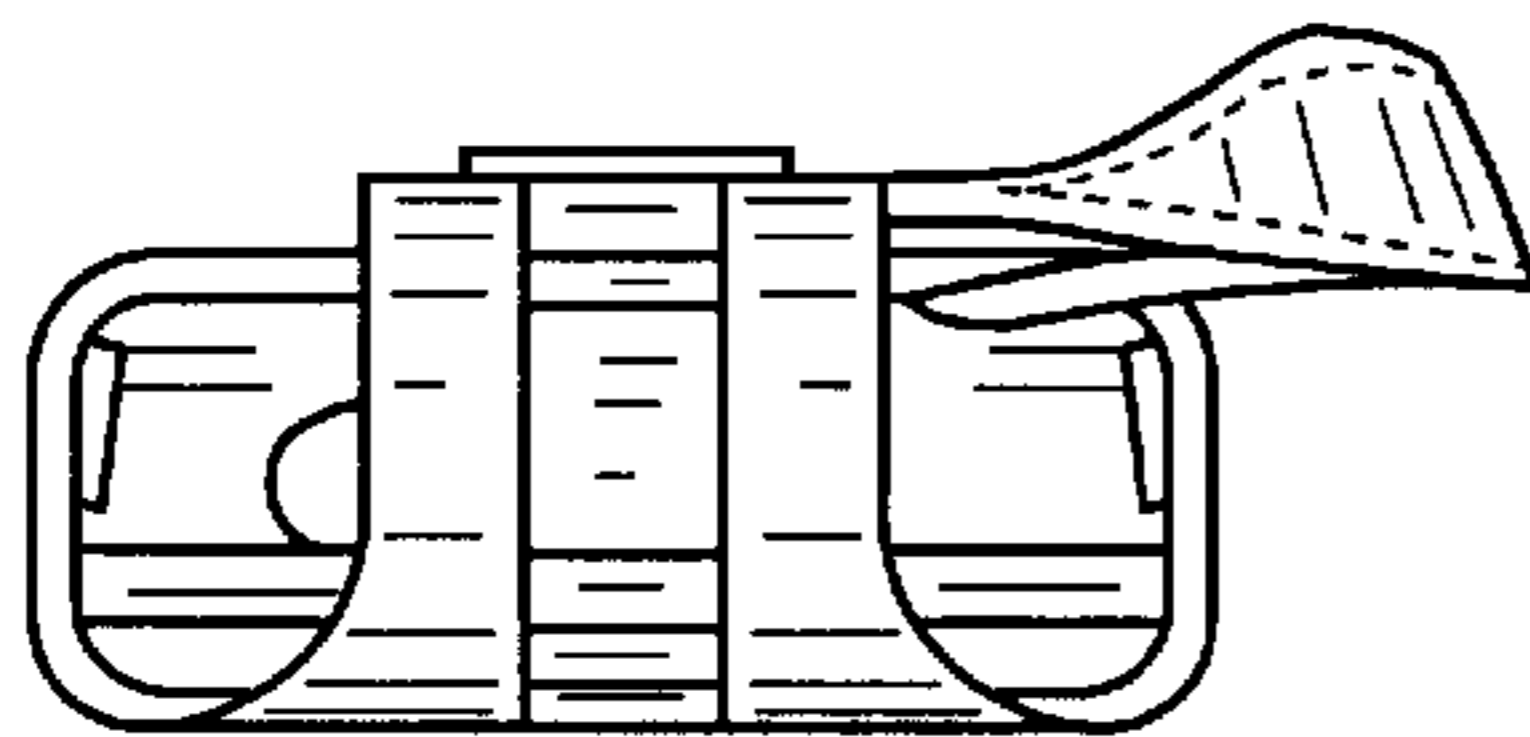

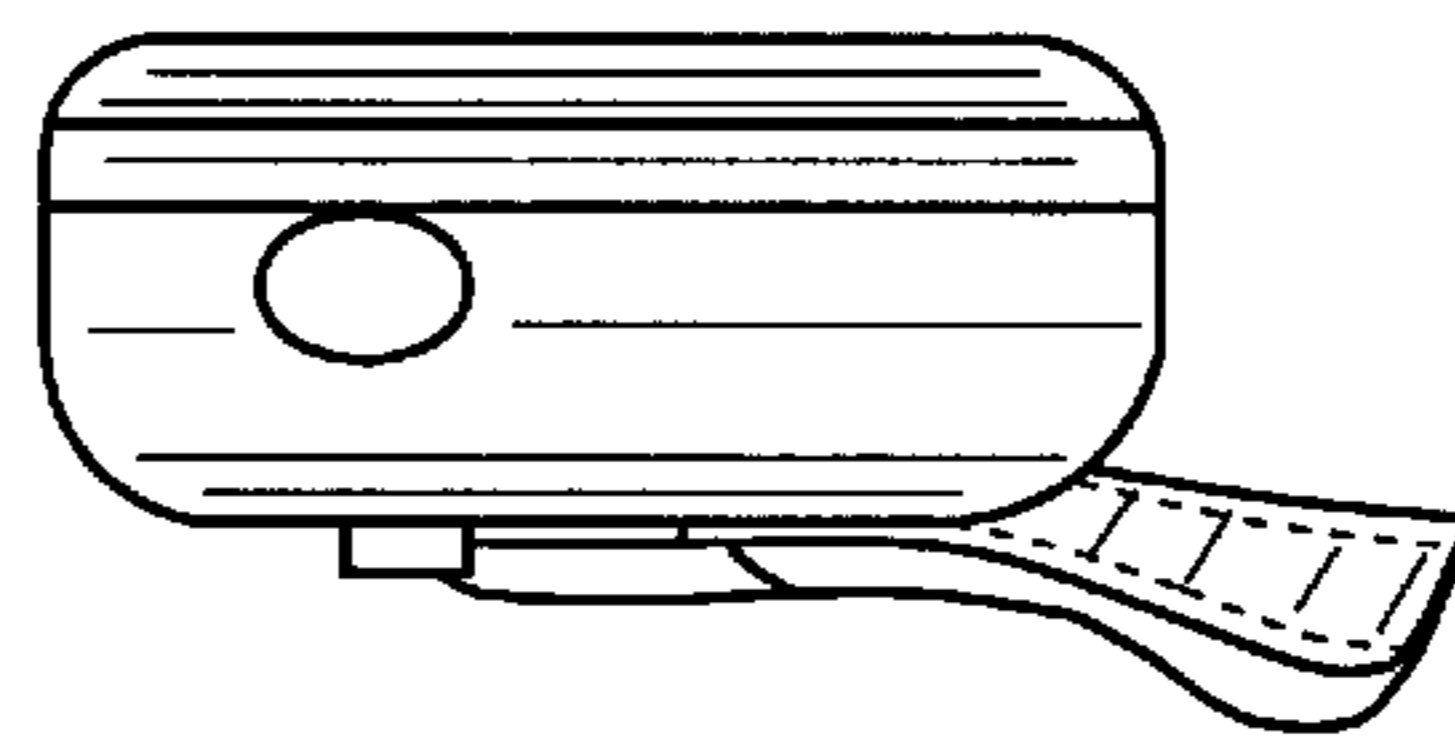
