The ornamental design for a modular CD holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view looking from above of a modular CD holder showing my new design;

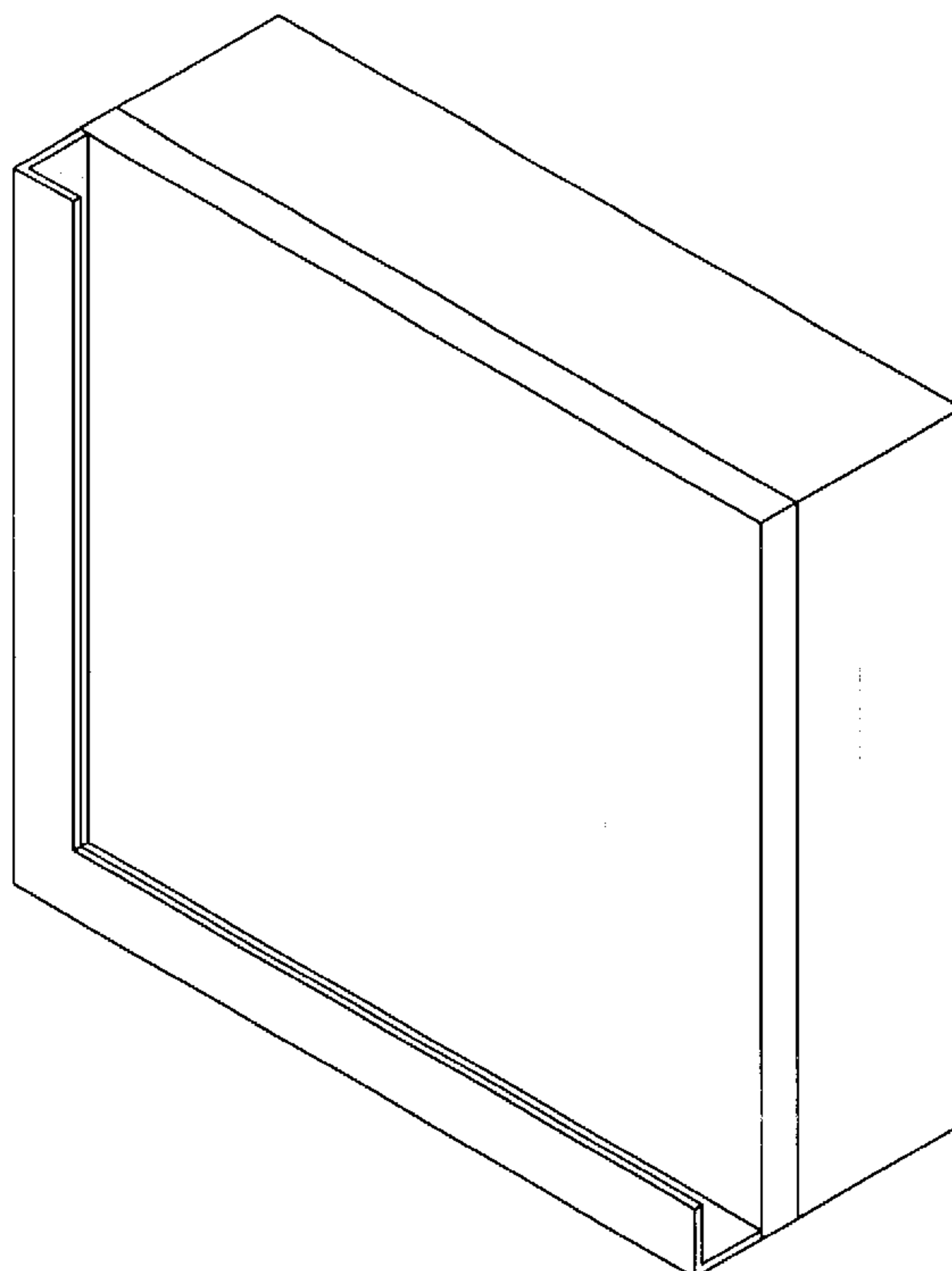

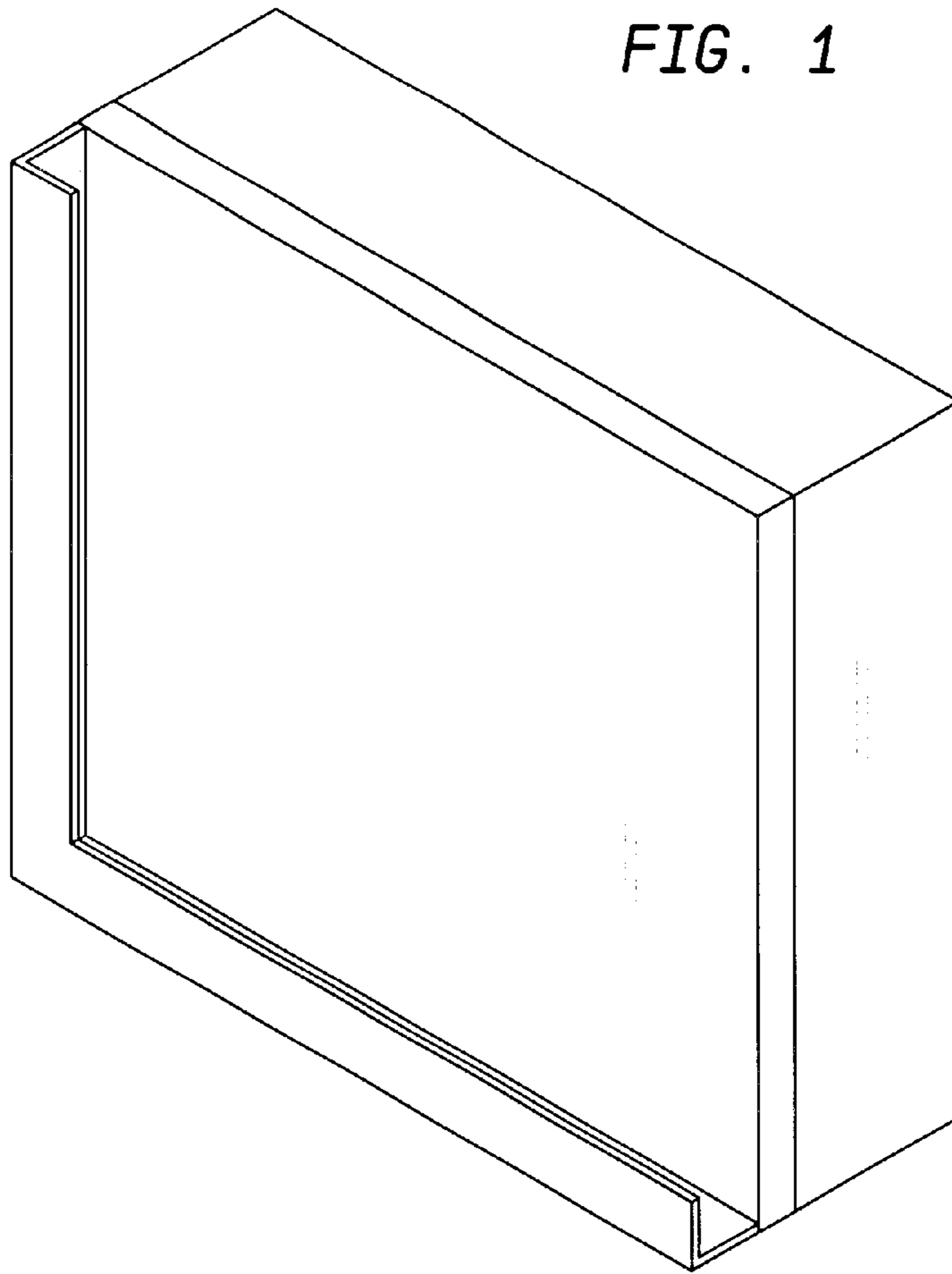
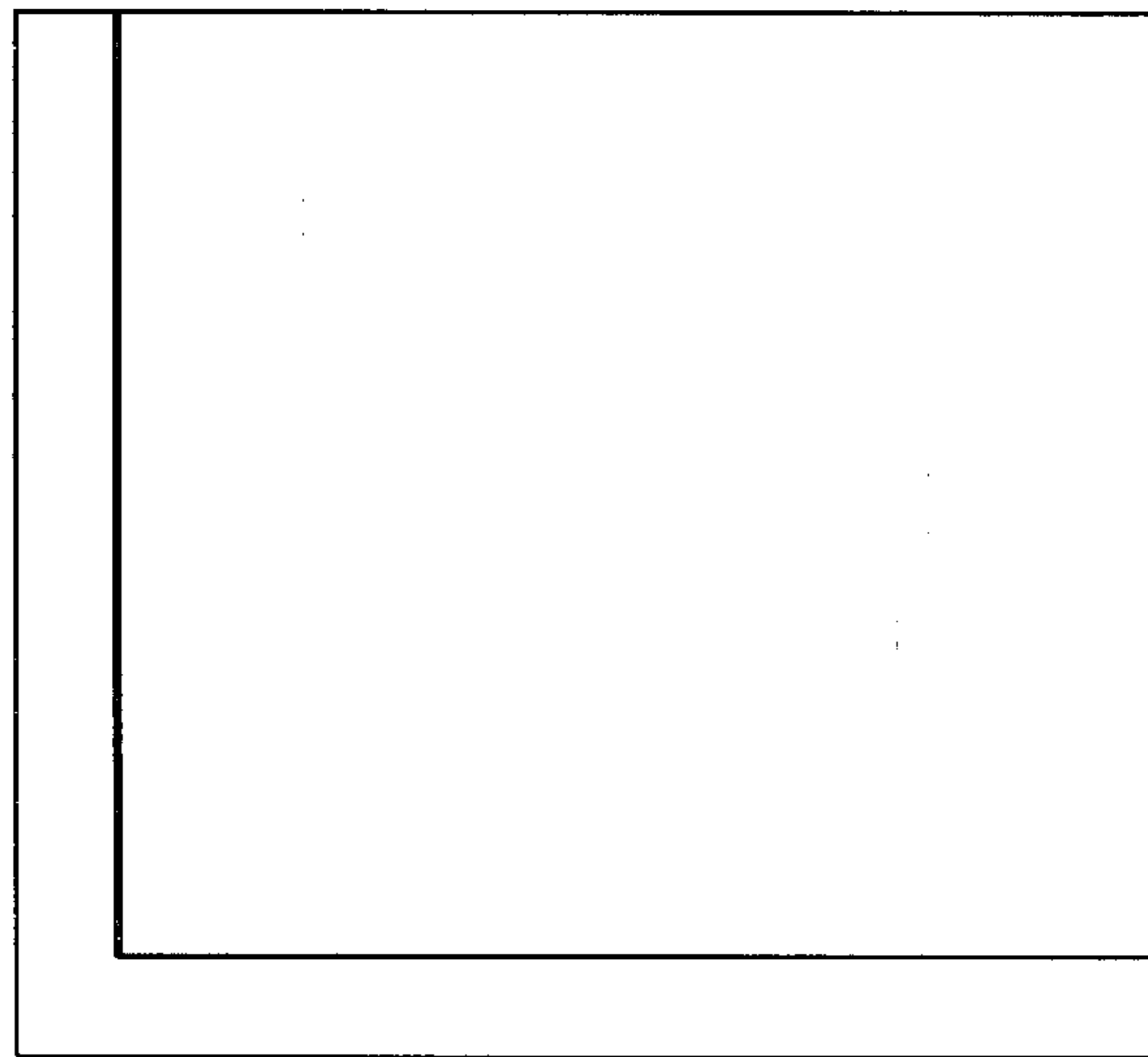
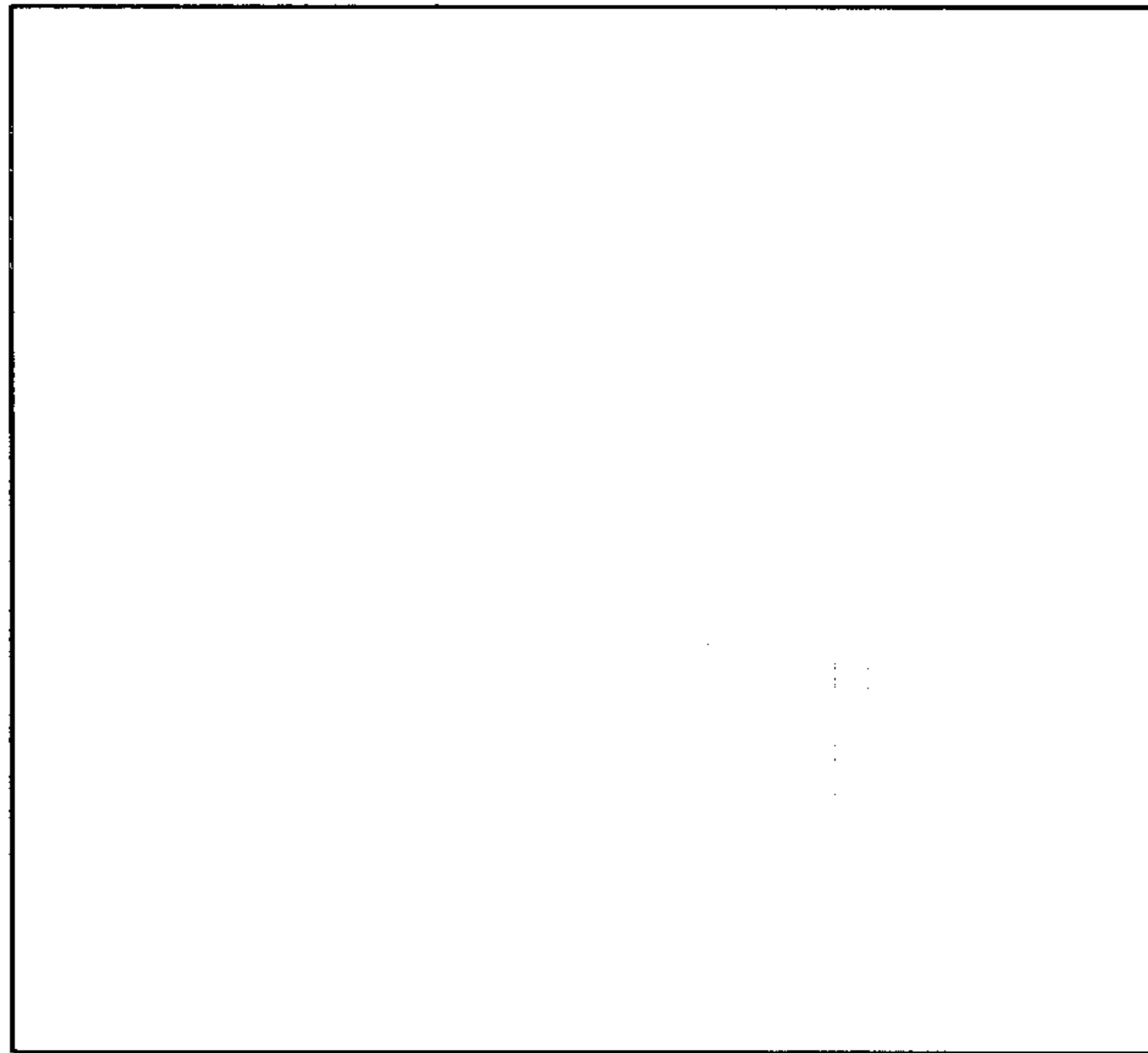

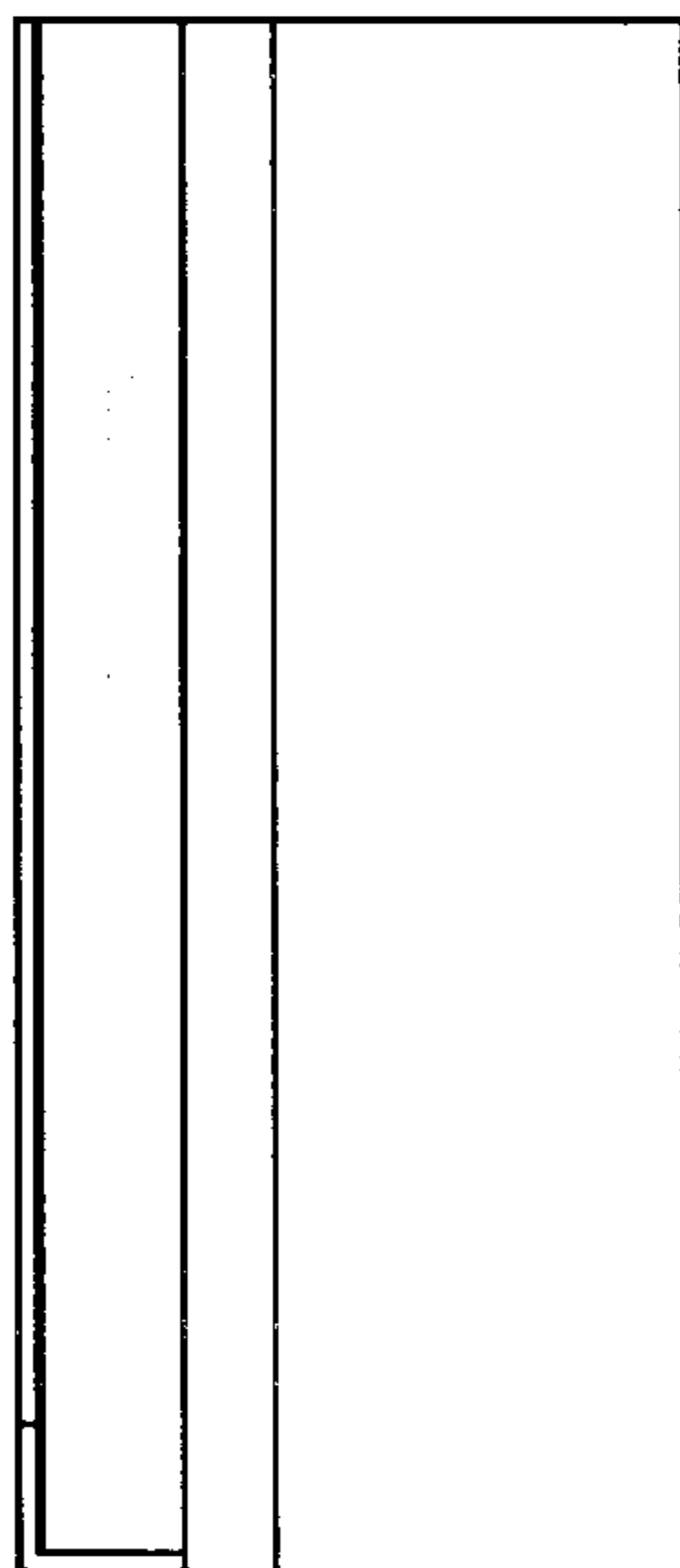

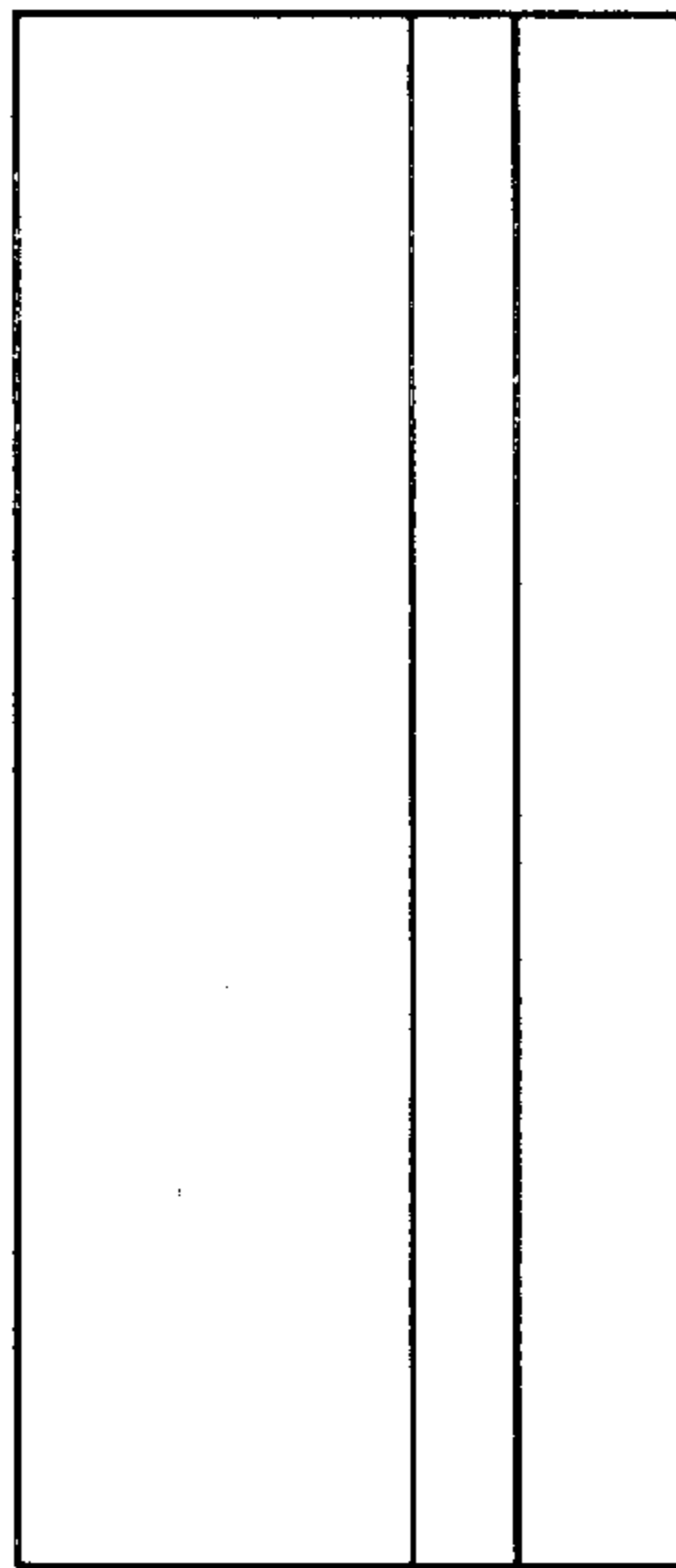

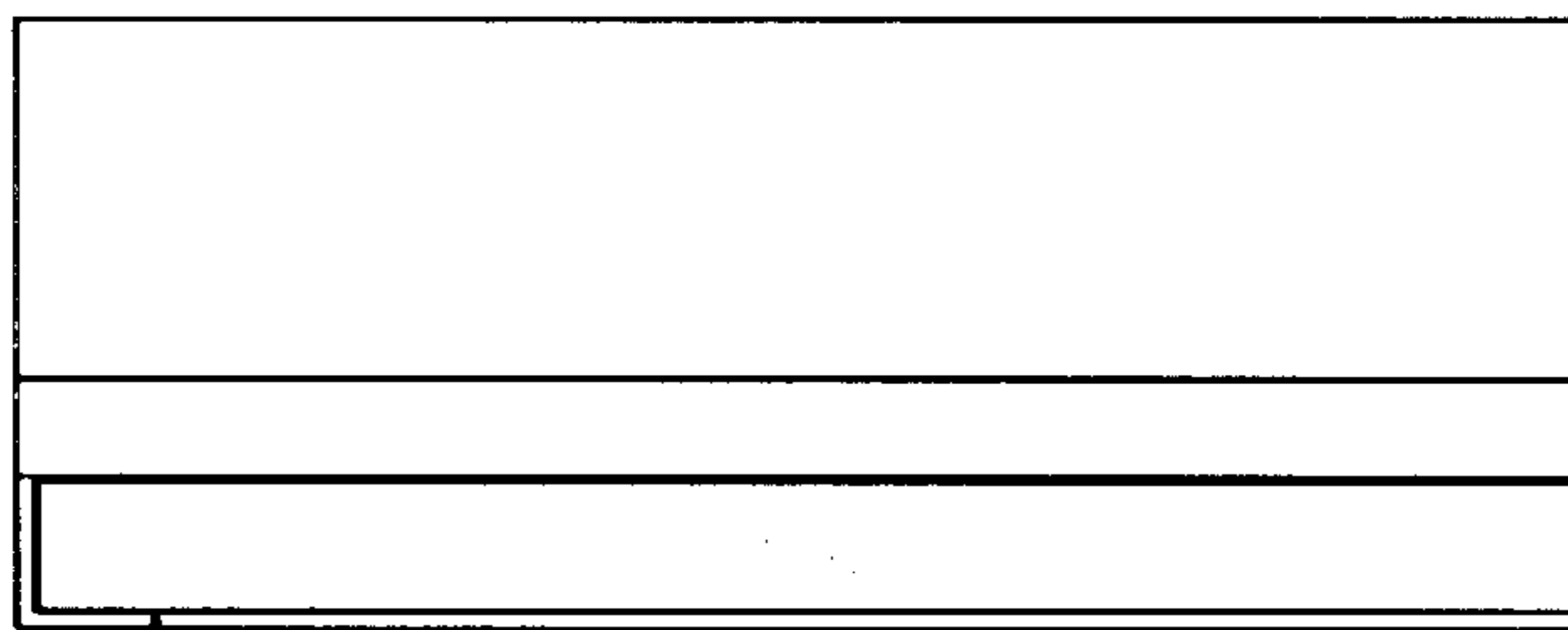
