(57) **CLAIM**

The ornamental design for a desk, as shown in the drawing figures.

**DESCRIPTION**

FIG. 1 is a front perspective view of a desk employing my novel design;

FIG. 2 is a back perspective view of the desk of FIG. 1;

FIG. 3 is a side perspective view of the desk of FIG. 1;

FIG. 4 is an elevation view of the front of the desk;

FIG. 5 is an elevation view of the back of the desk;

FIG. 6 is an elevation view of the left side of the desk;

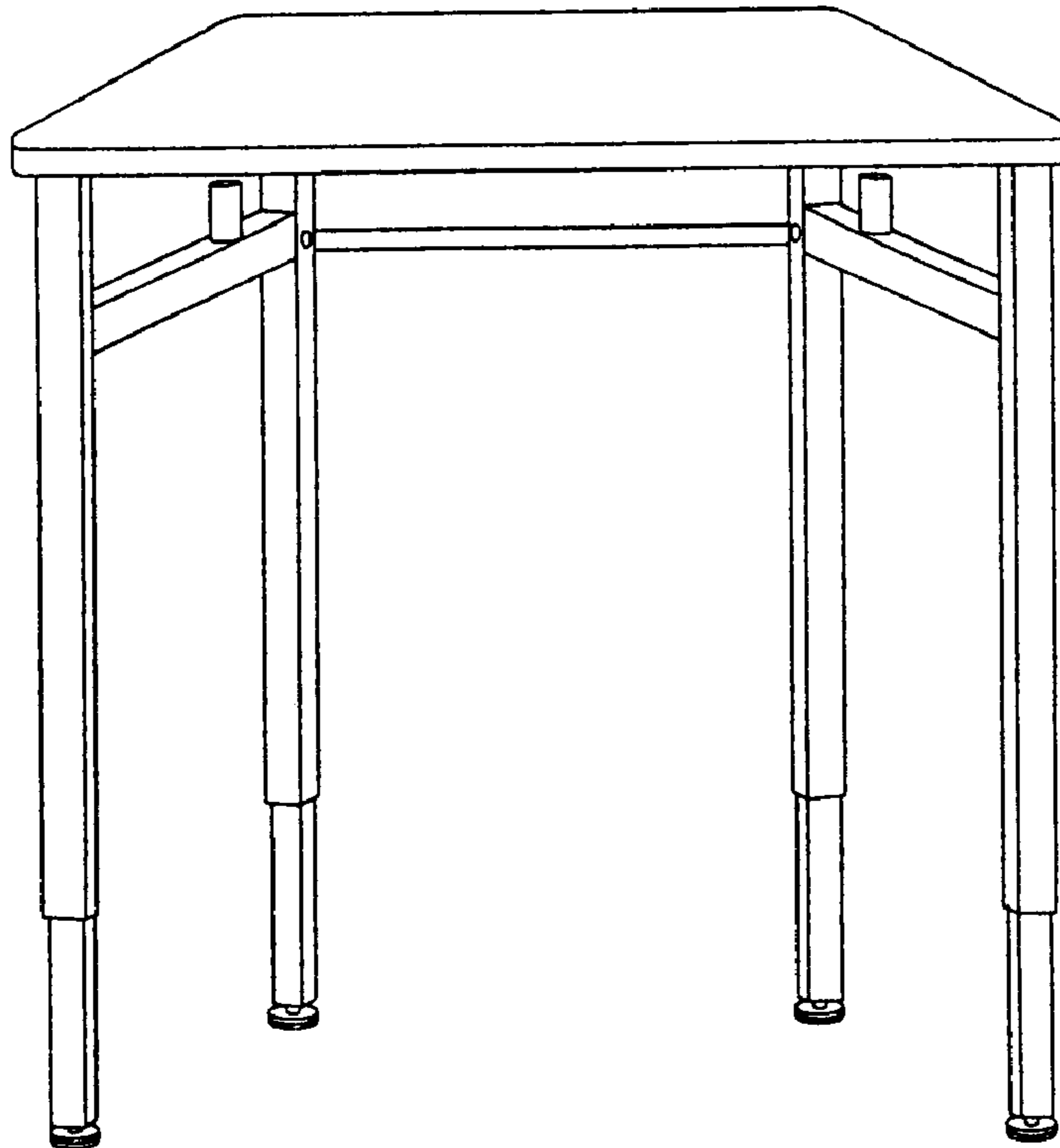
FIG. 7 is an elevation view of the right side of the desk;

FIG. 8 is a plan view of the top of the desk;

FIG. 9 is a plan view of the bottom of the desk; and,

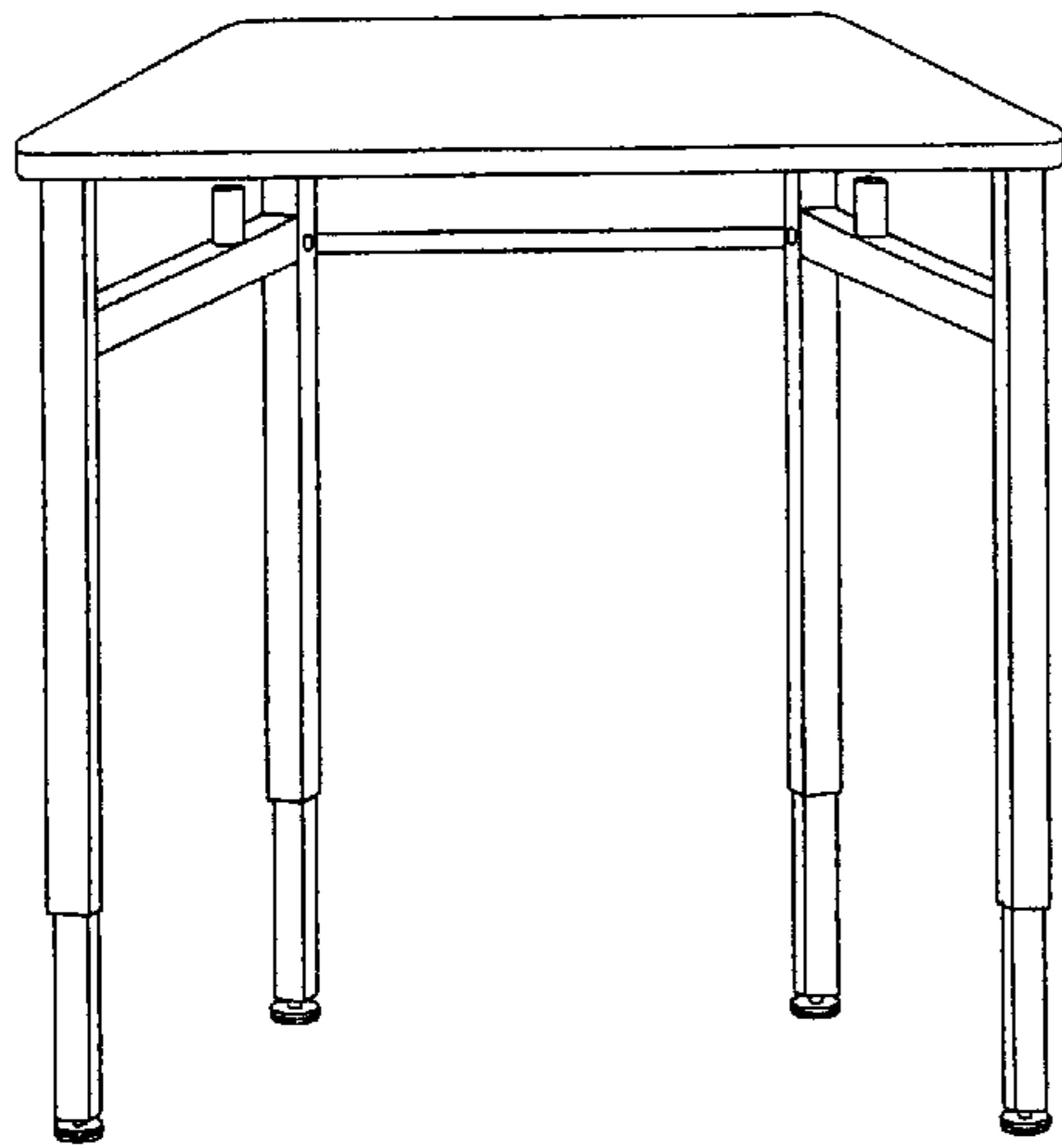

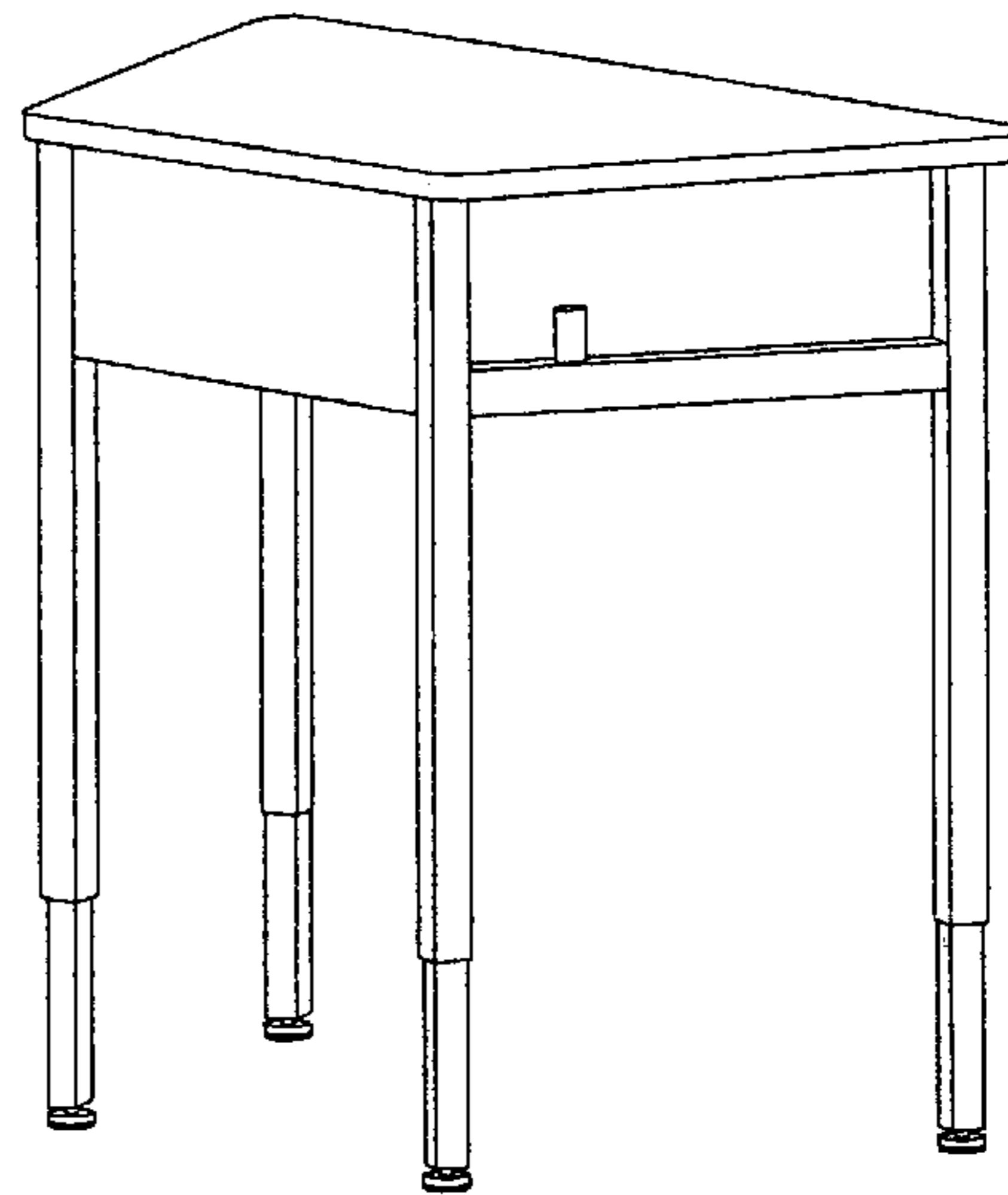

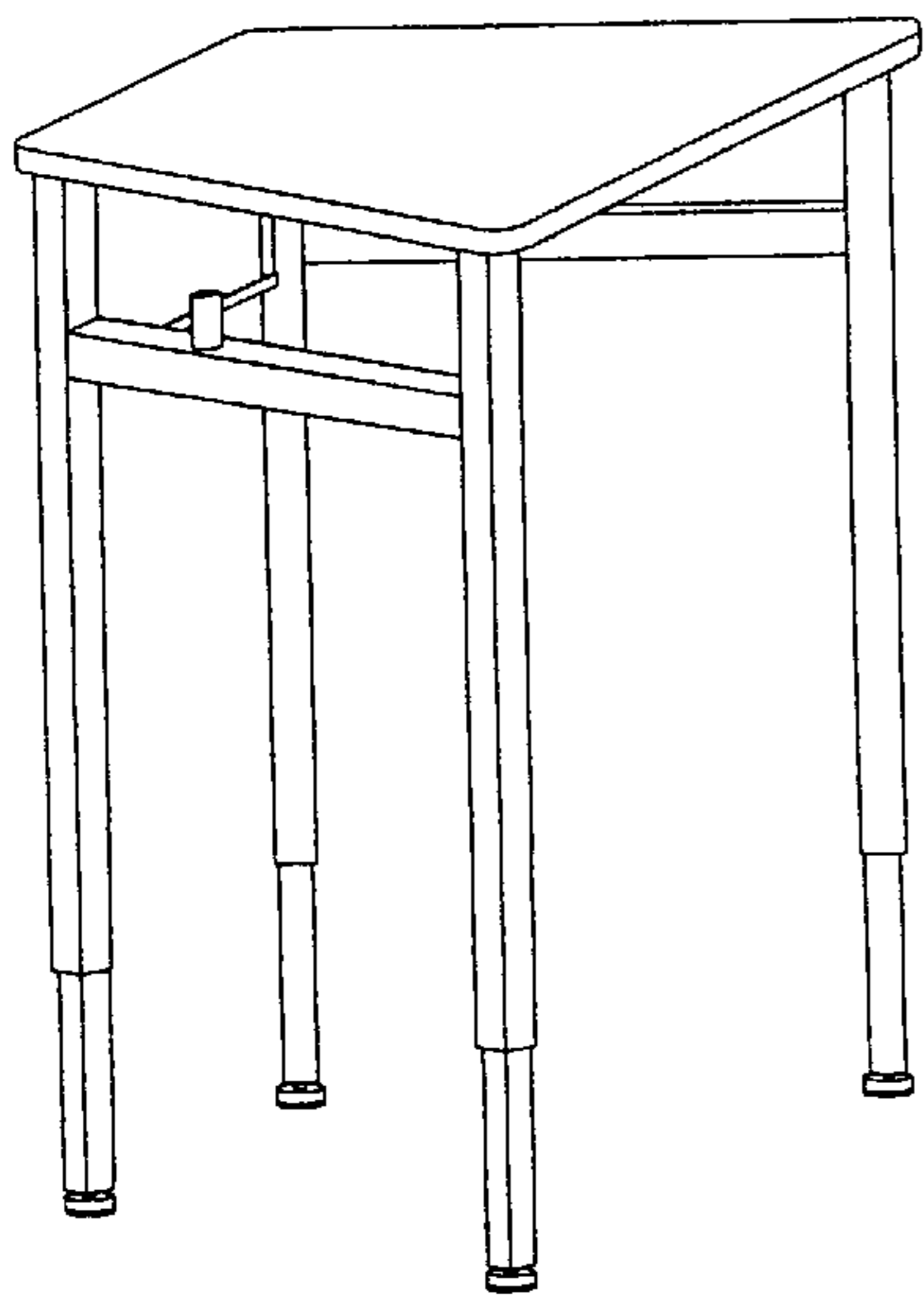

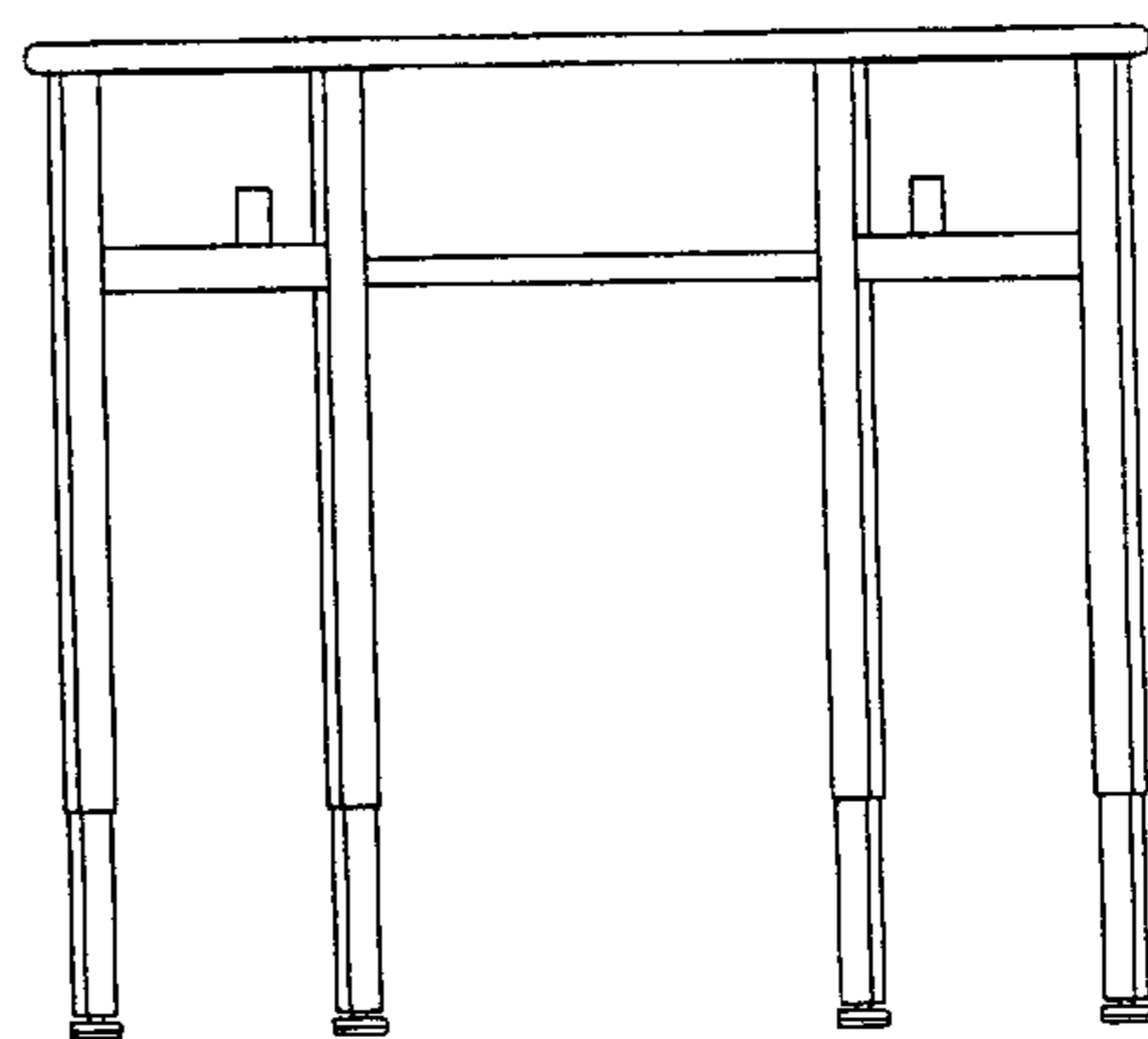

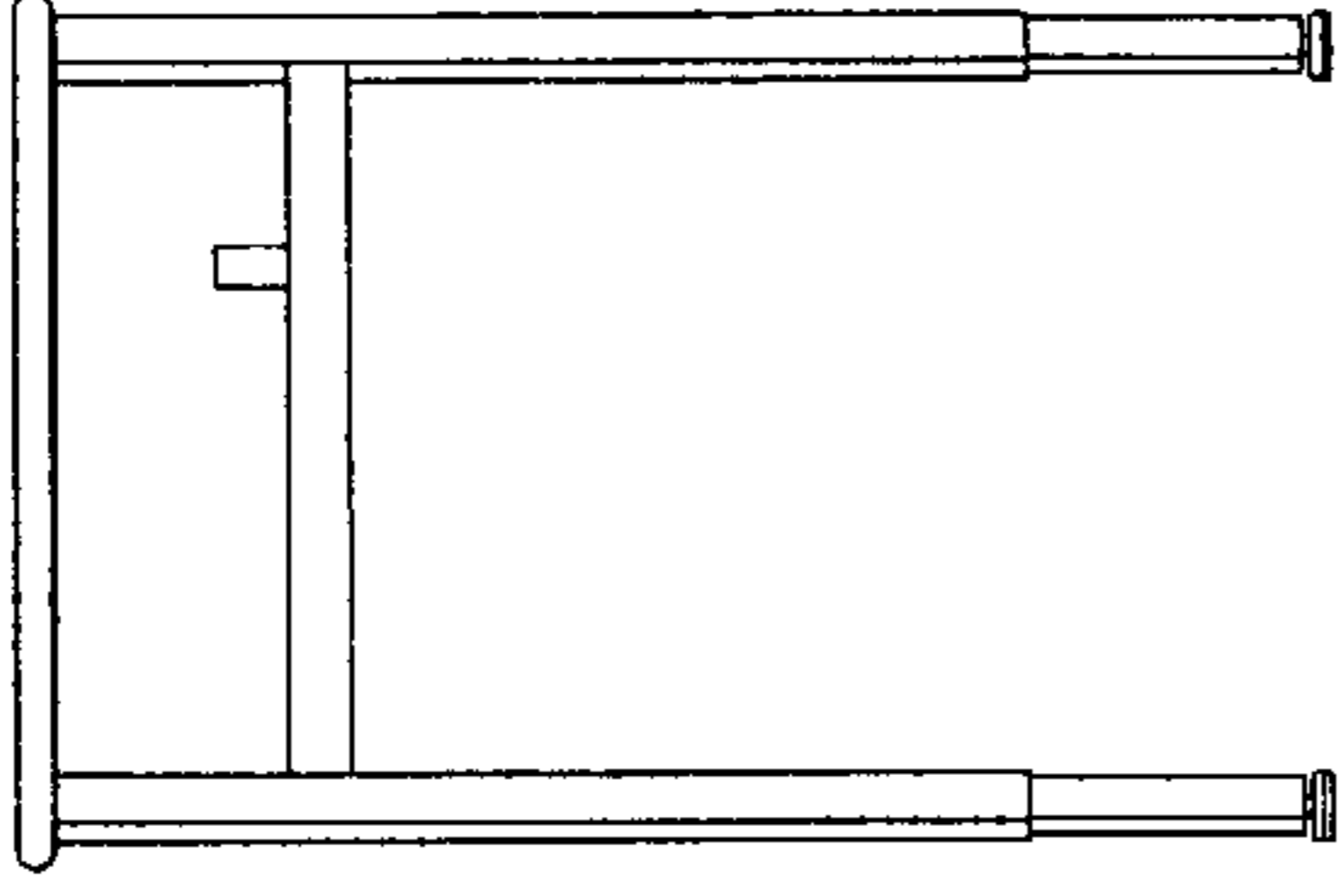

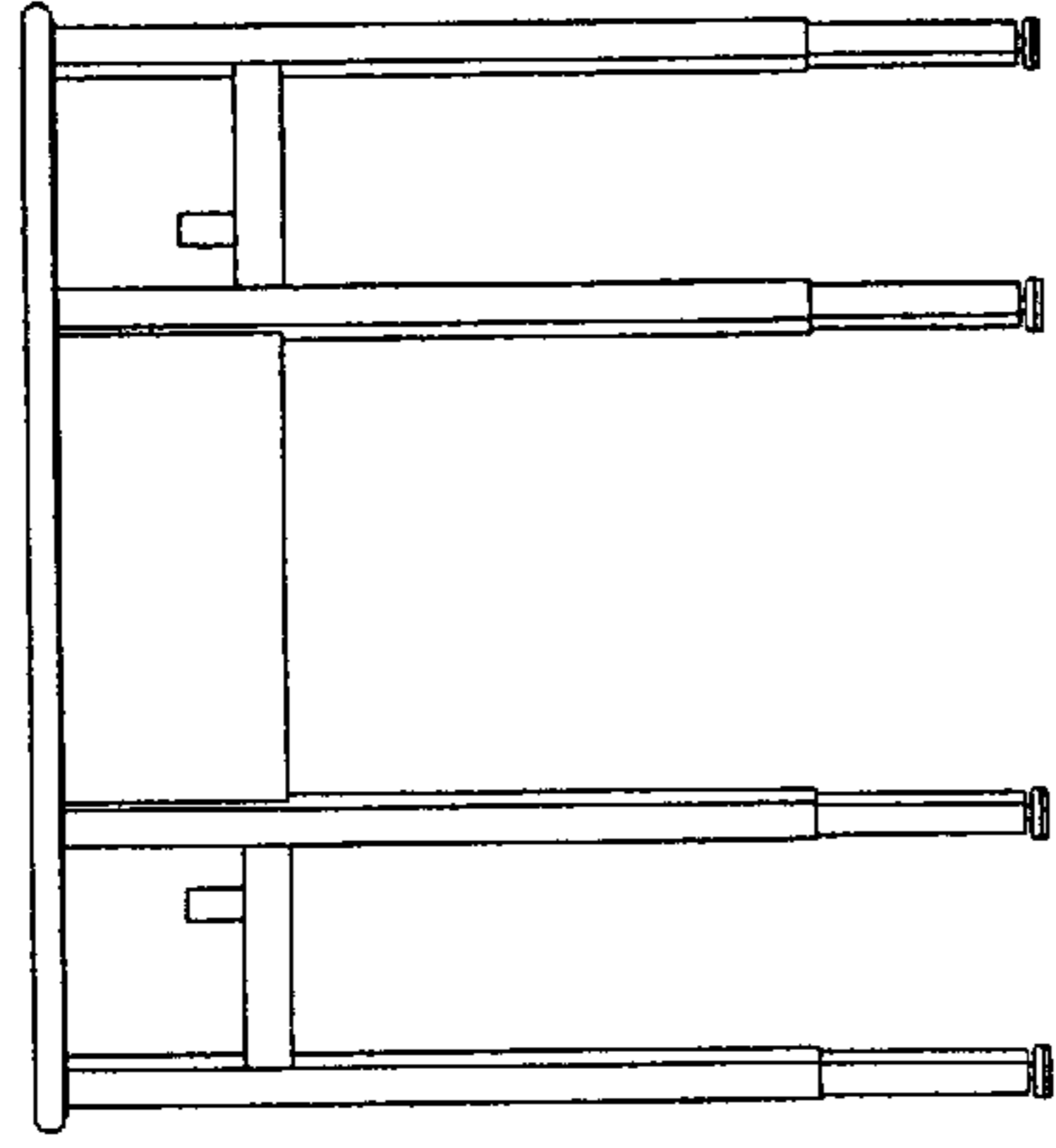

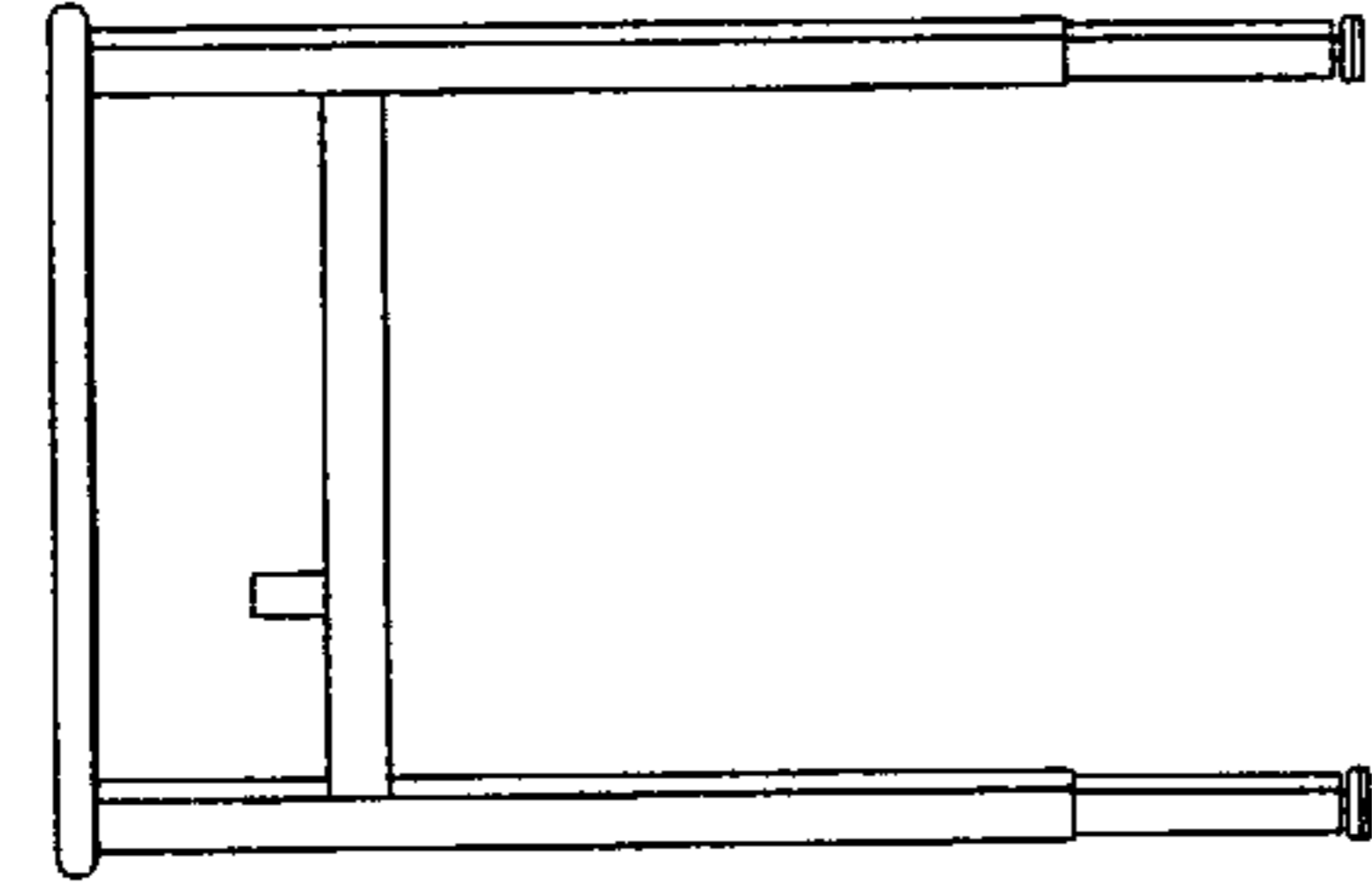

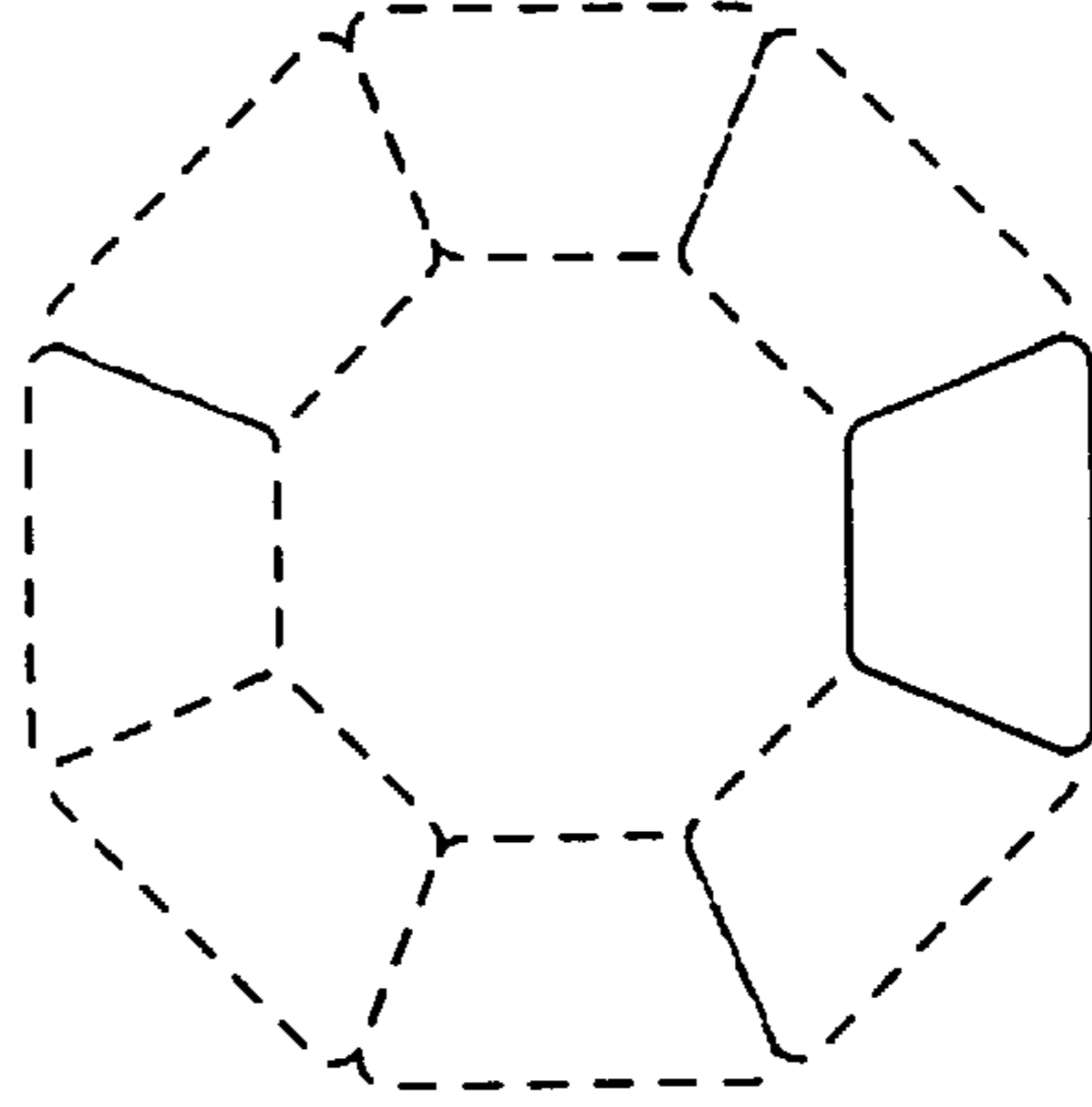

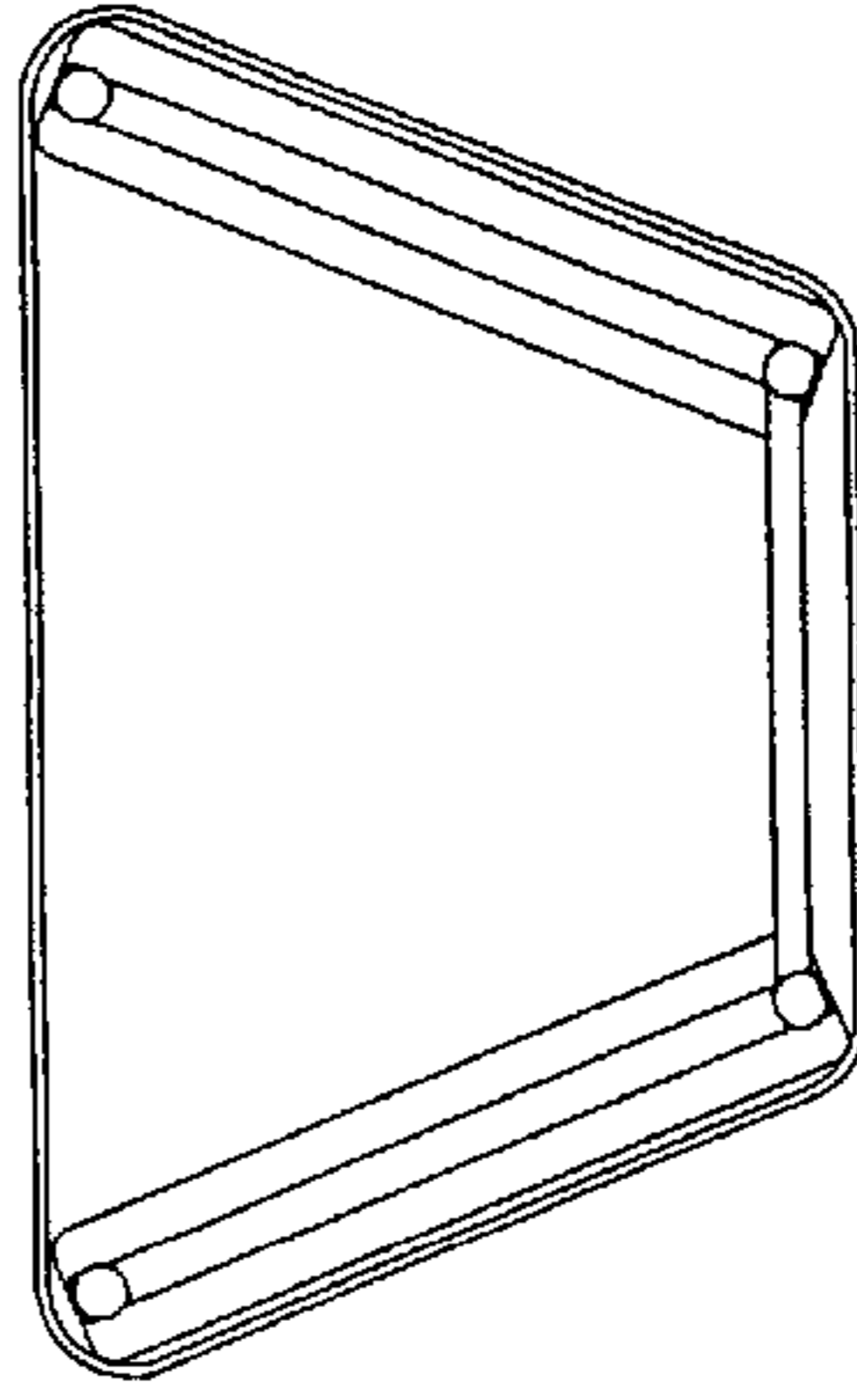

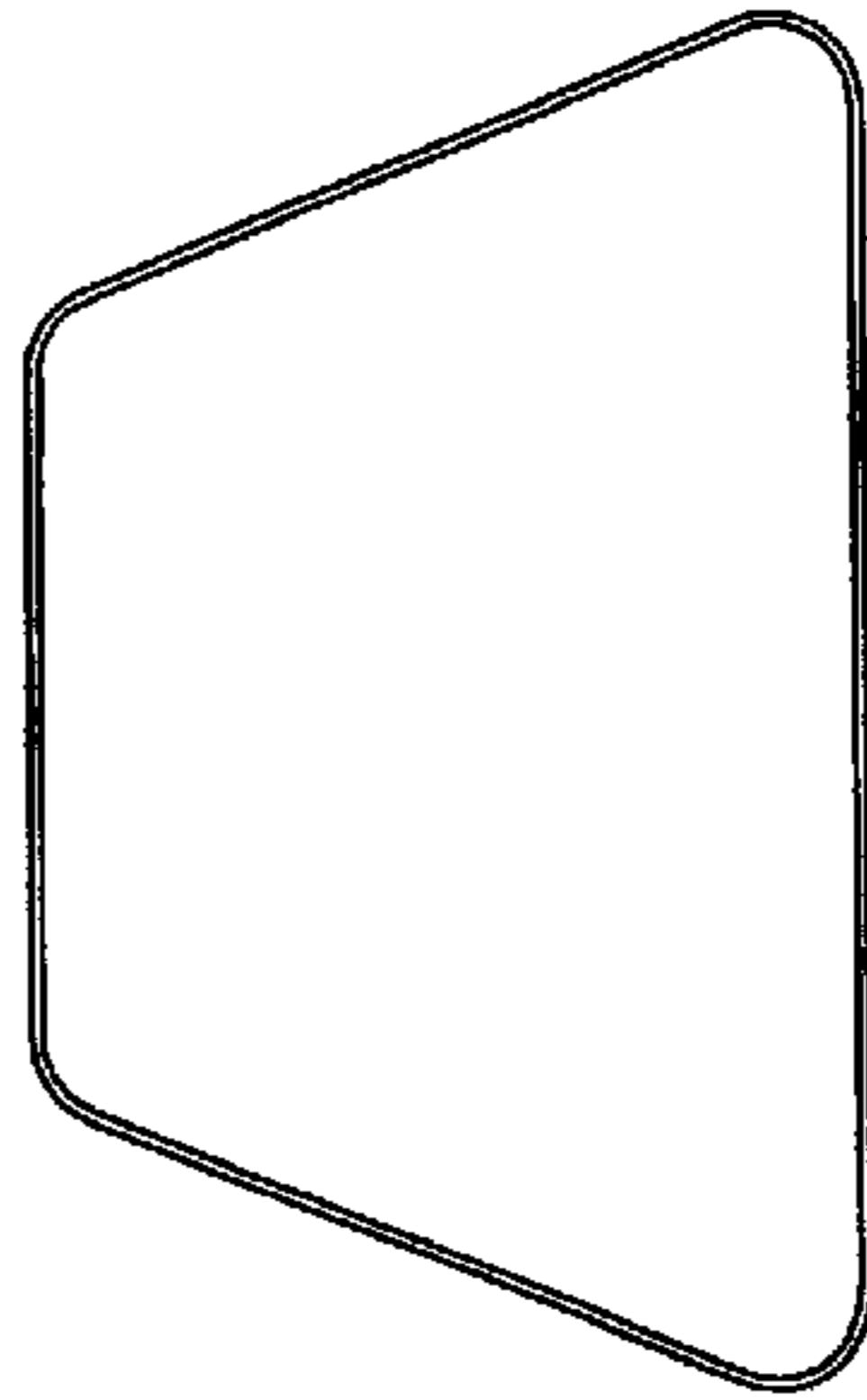
