FIG. 4 is a top plan view showing my new design for a cooperating interlocking screw slot, the broken lines showing the rest of the screw is for illustrated purposes only and forms no part of the claimed design;

FIG. 5 is a front elevational view thereof taken along line 5—5 in FIG. 4, the rear elevational view being identical thereto, the broken lines showing the rest of the screw is for illustrated purposes only and forms no part of the claimed design; and,

FIG. 6 is a left side elevational view thereof taken along line 6—6 in FIG. 4, the right side elevational view being identical thereto, the broken lines showing the rest of the screw is for illustrated purposes only and forms no part of the claimed design.
