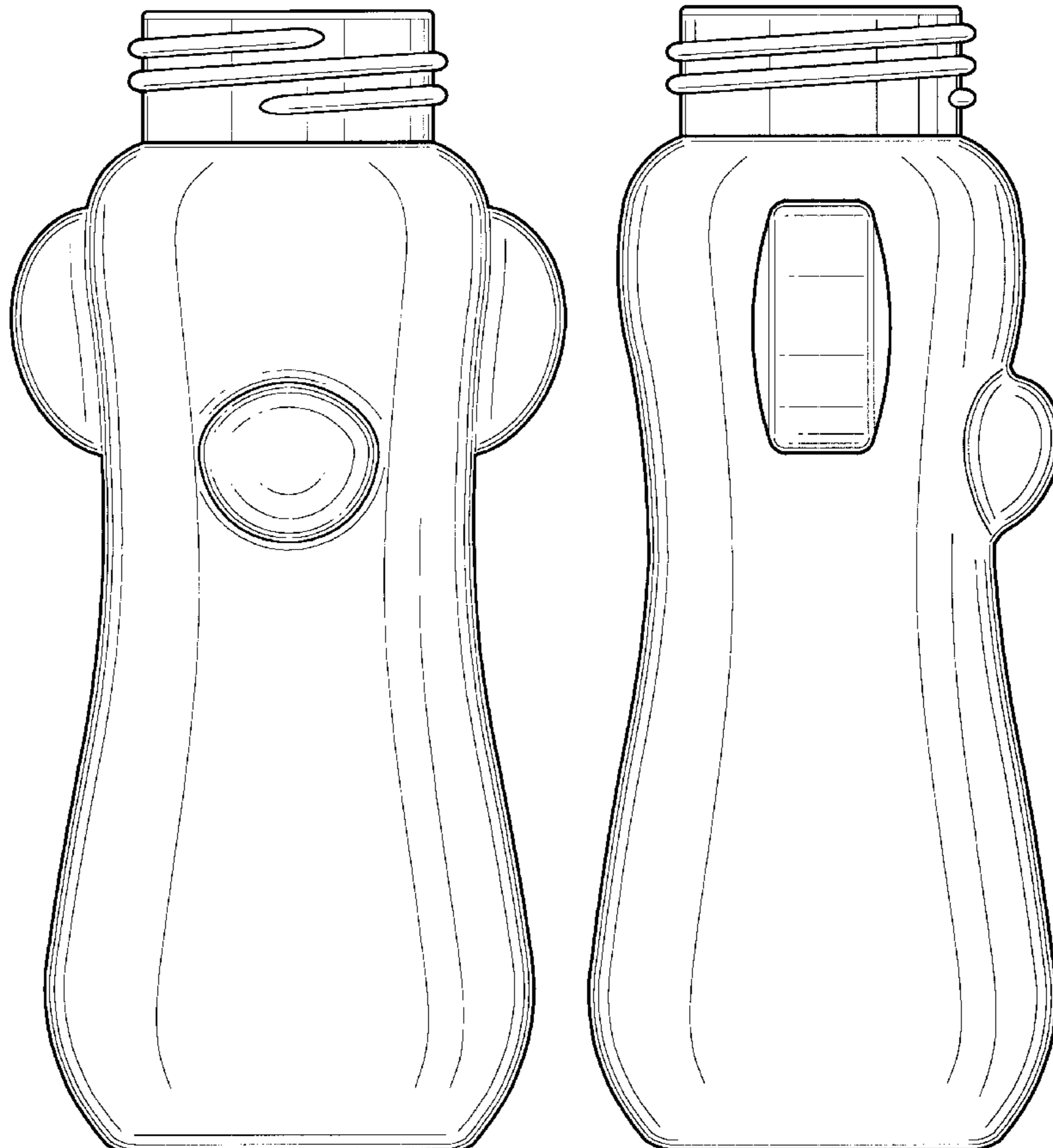
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the bottle;
FIG. 2 is a back elevational view of the bottle;
FIG. 3 is a top plan view of the bottle without the cap;
FIG. 4 is the bottom plan view of the bottle; and,
FIG. 5 is the side elevational view of the bottle, the other side being a mirror image.

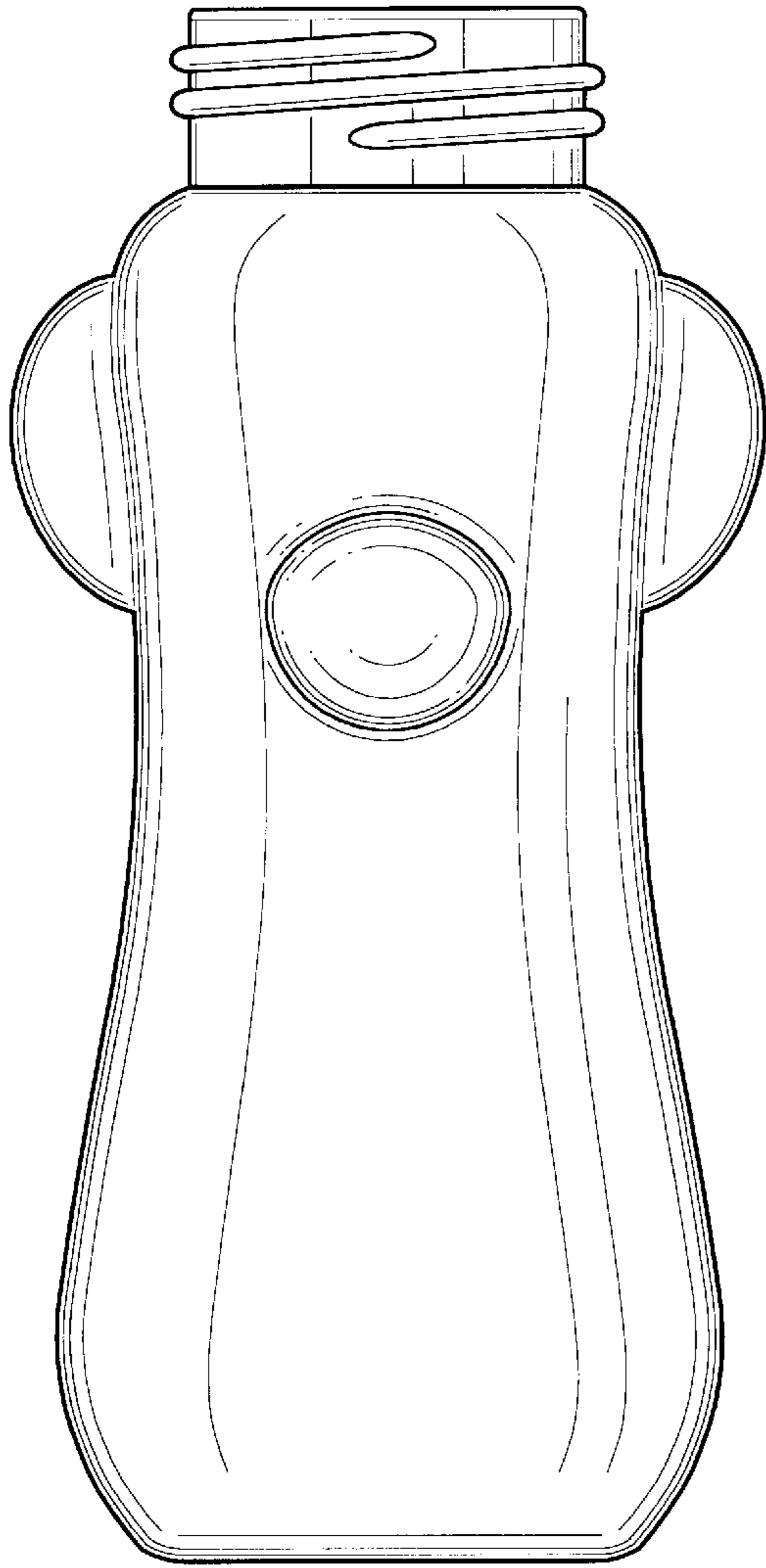

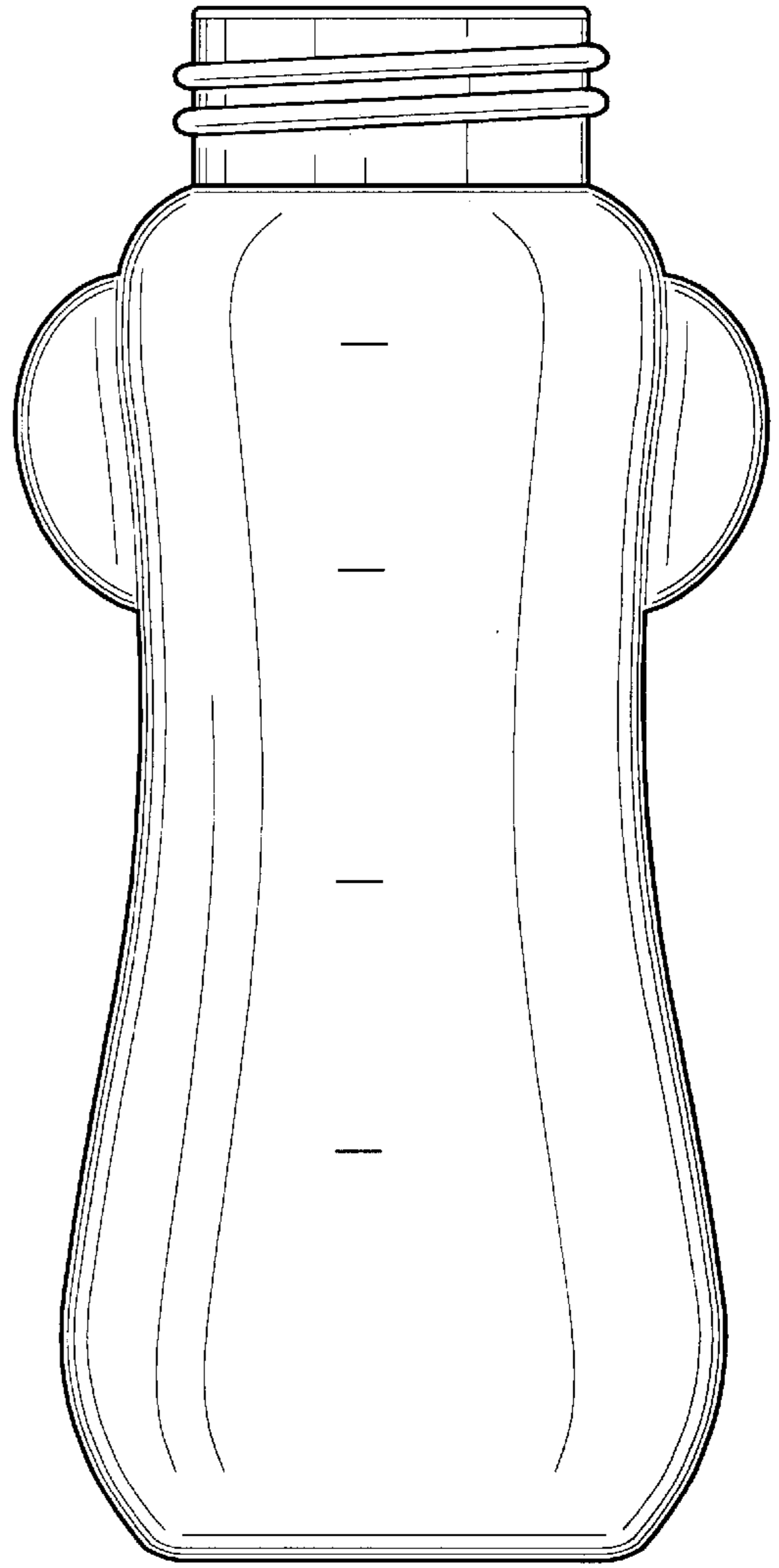

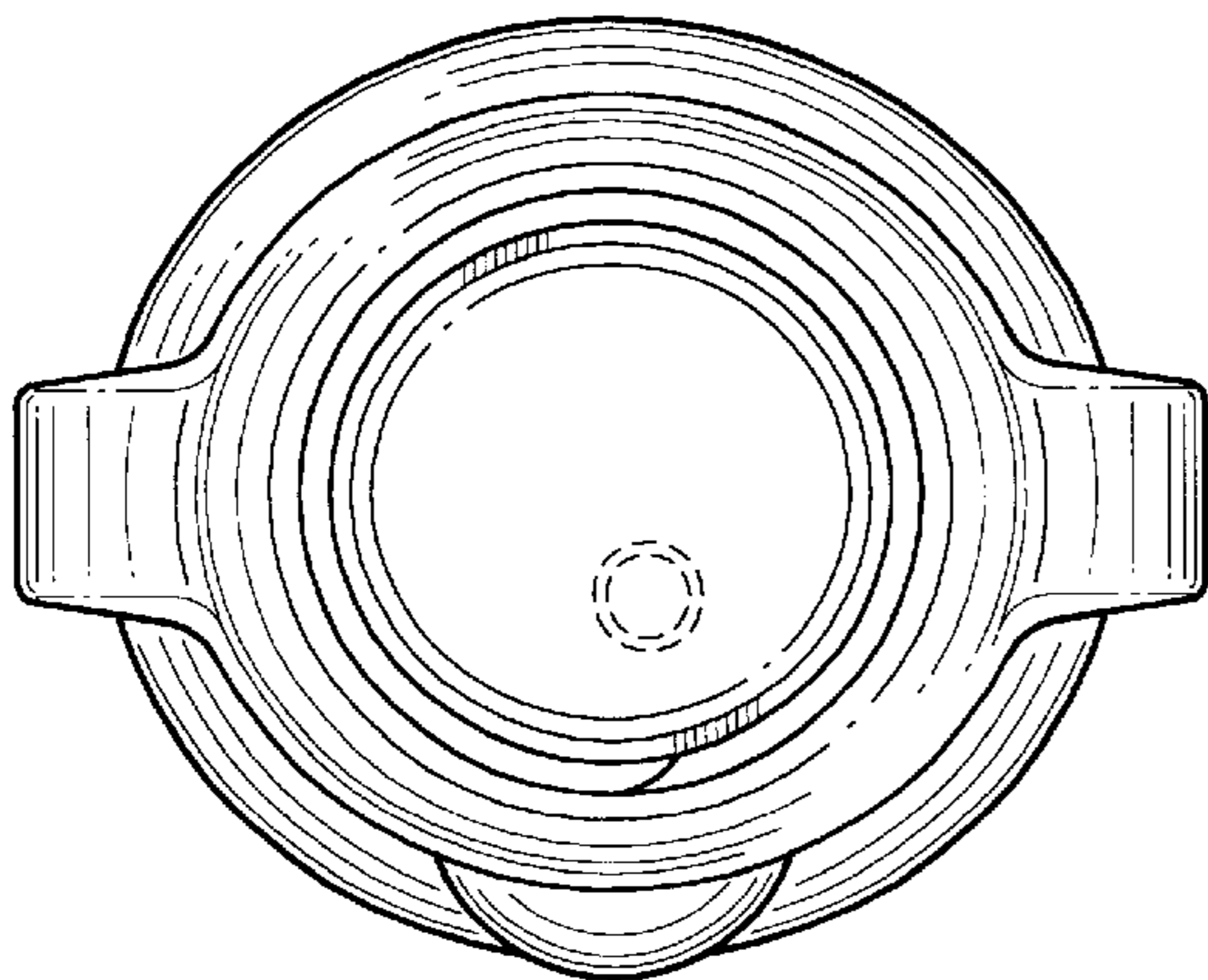

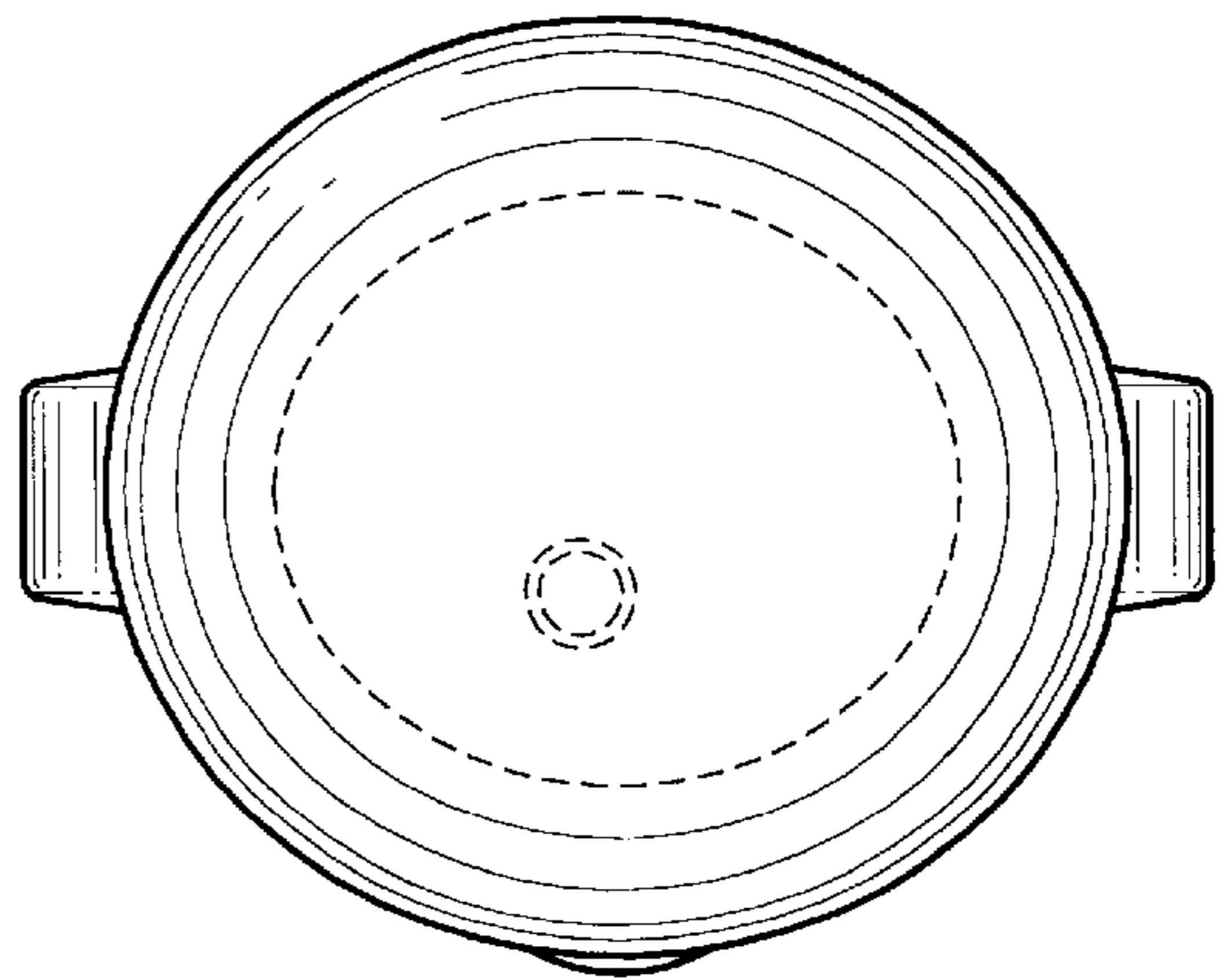

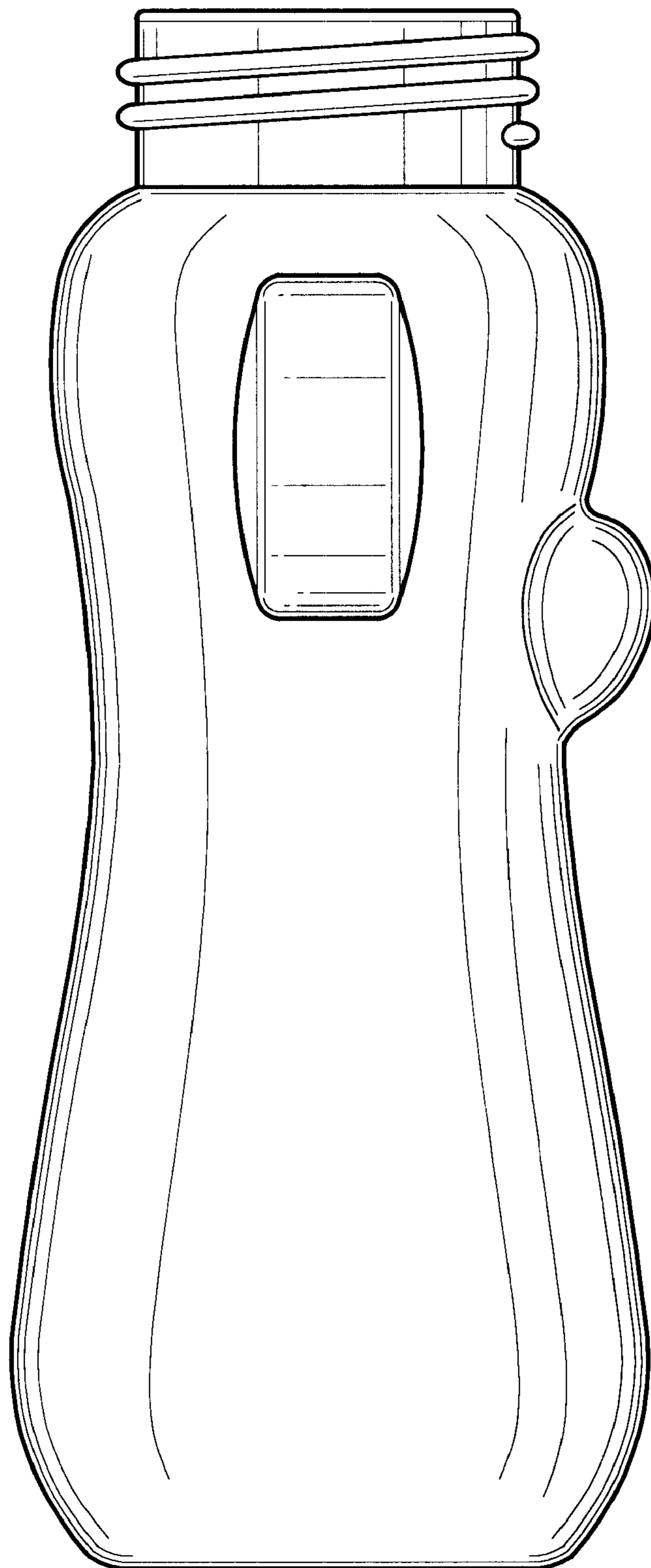
