We claim the ornamental design for a smooth bottle, as shown and described.

FIG. 3 is a front view thereof;

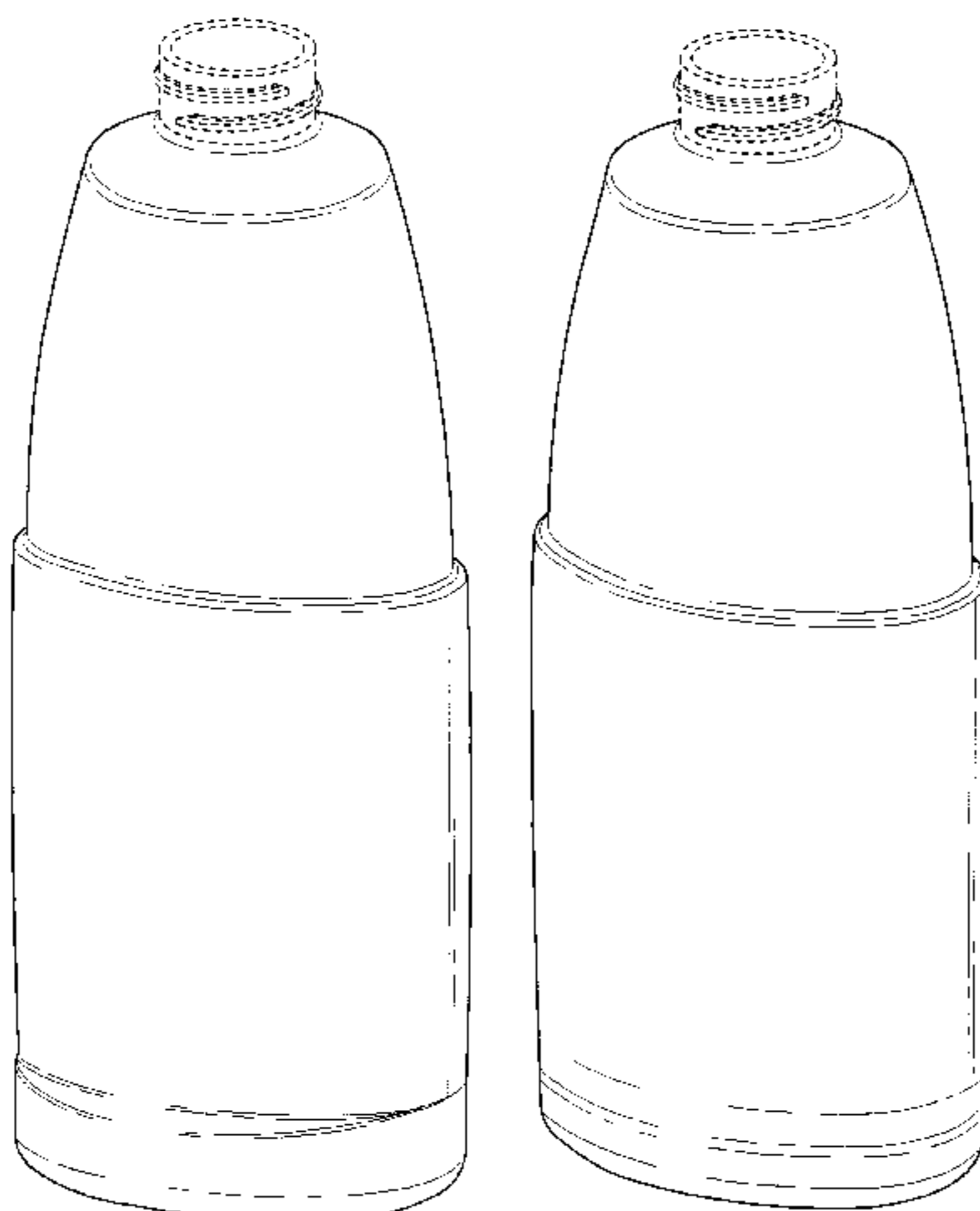
FIG. 4 is a rear view thereof;

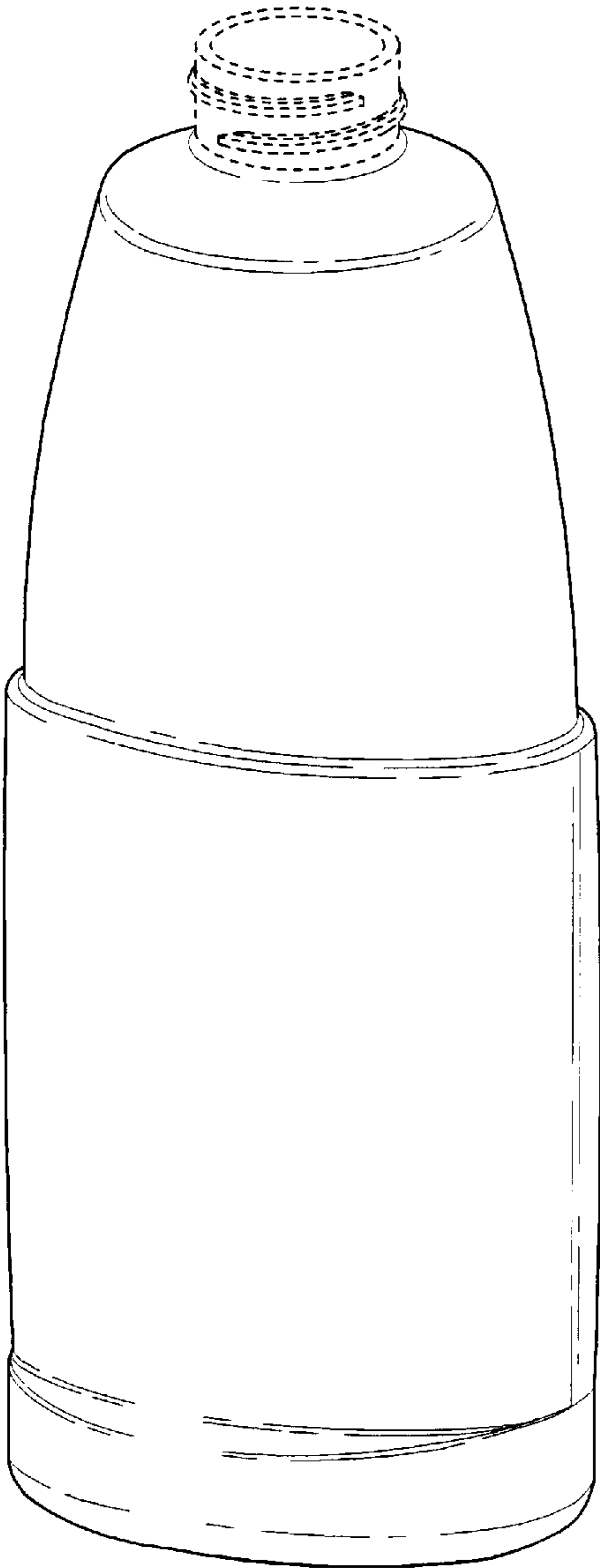

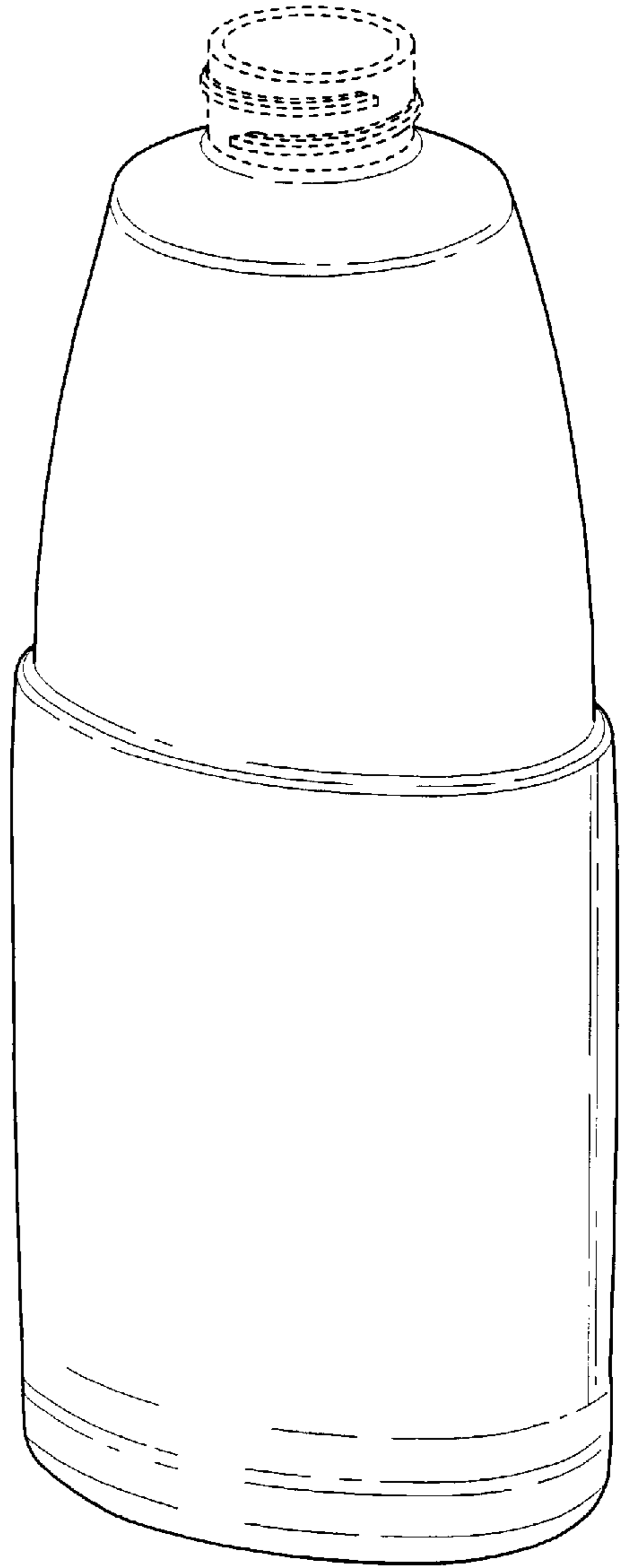

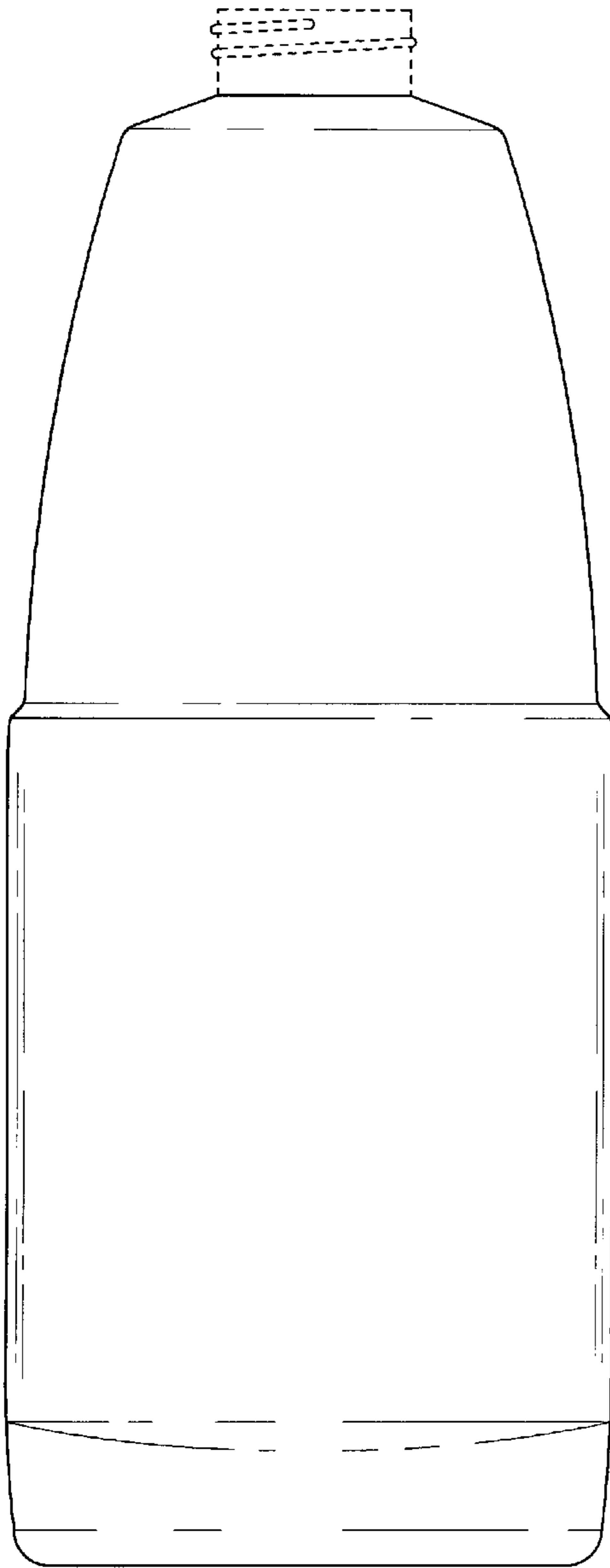

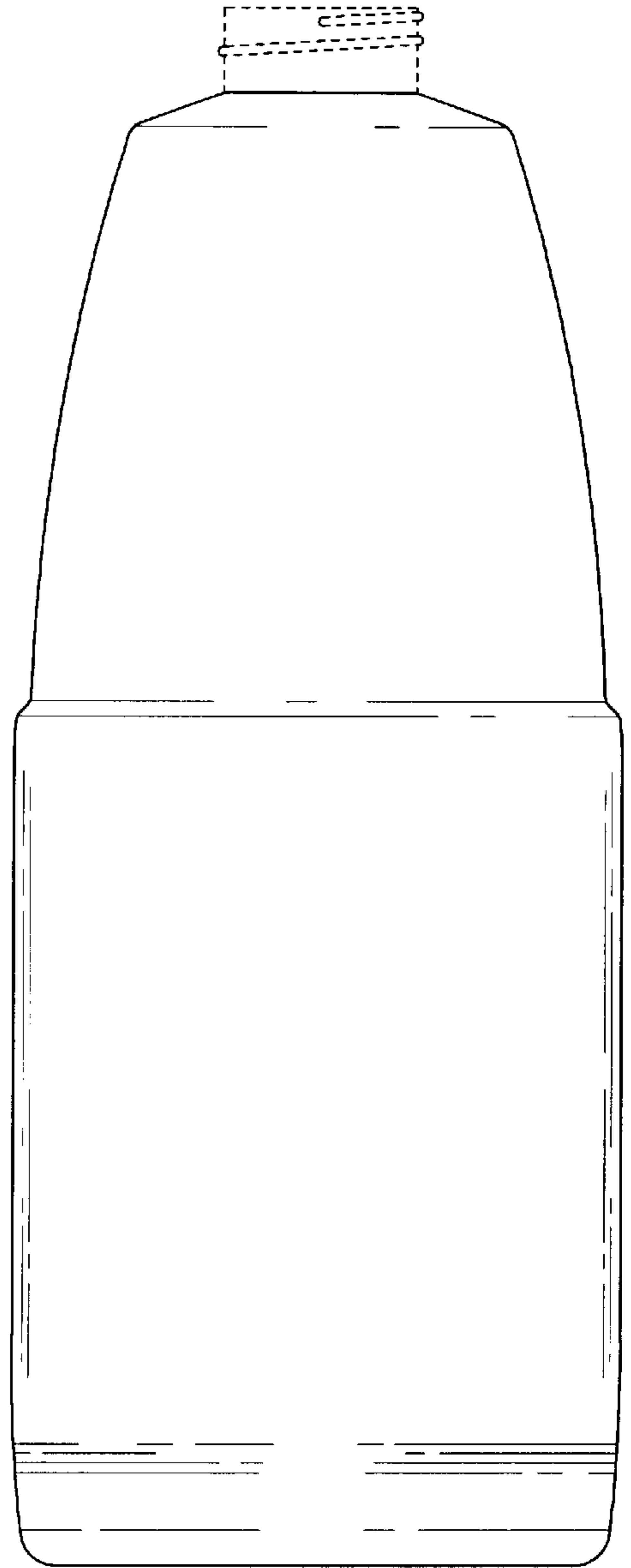

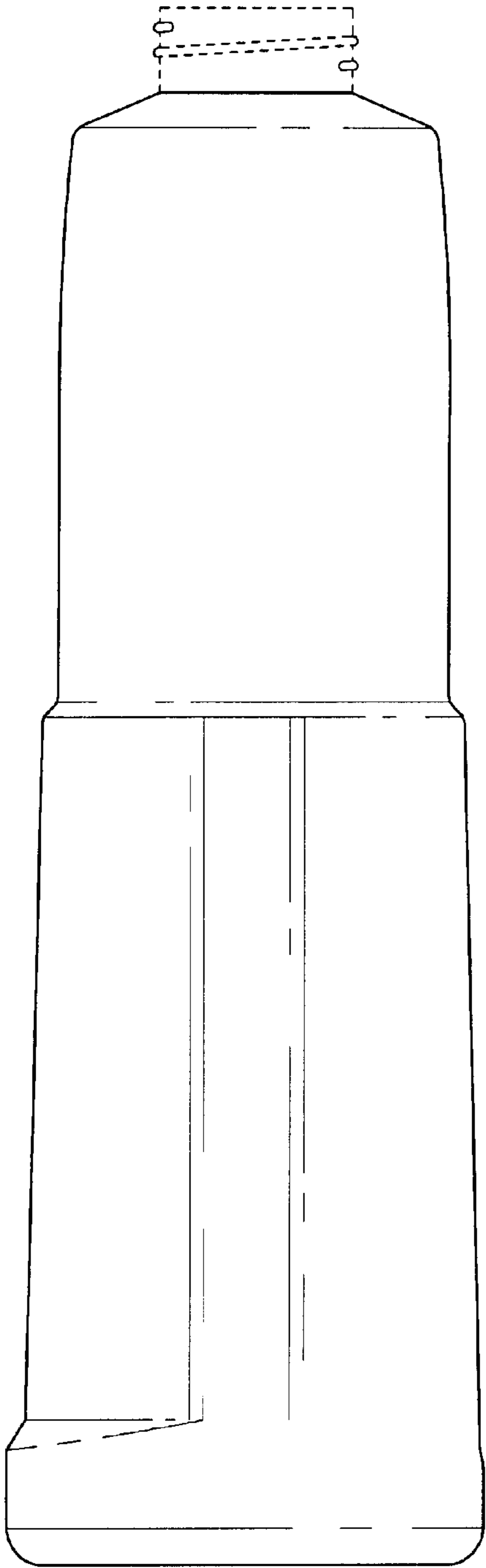

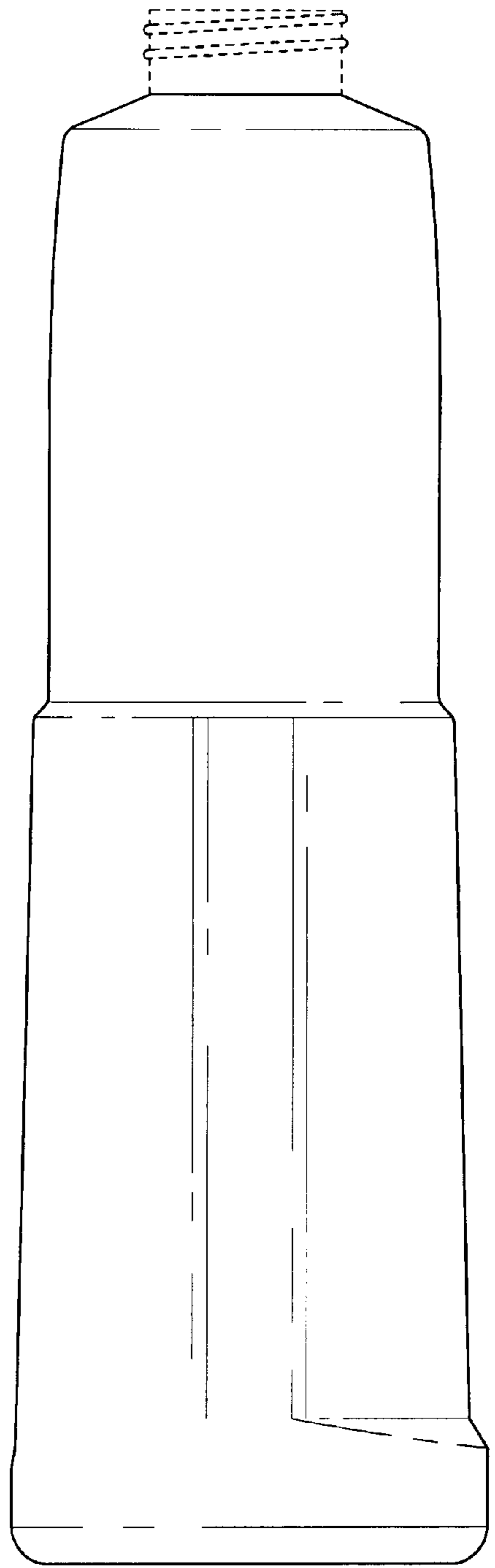

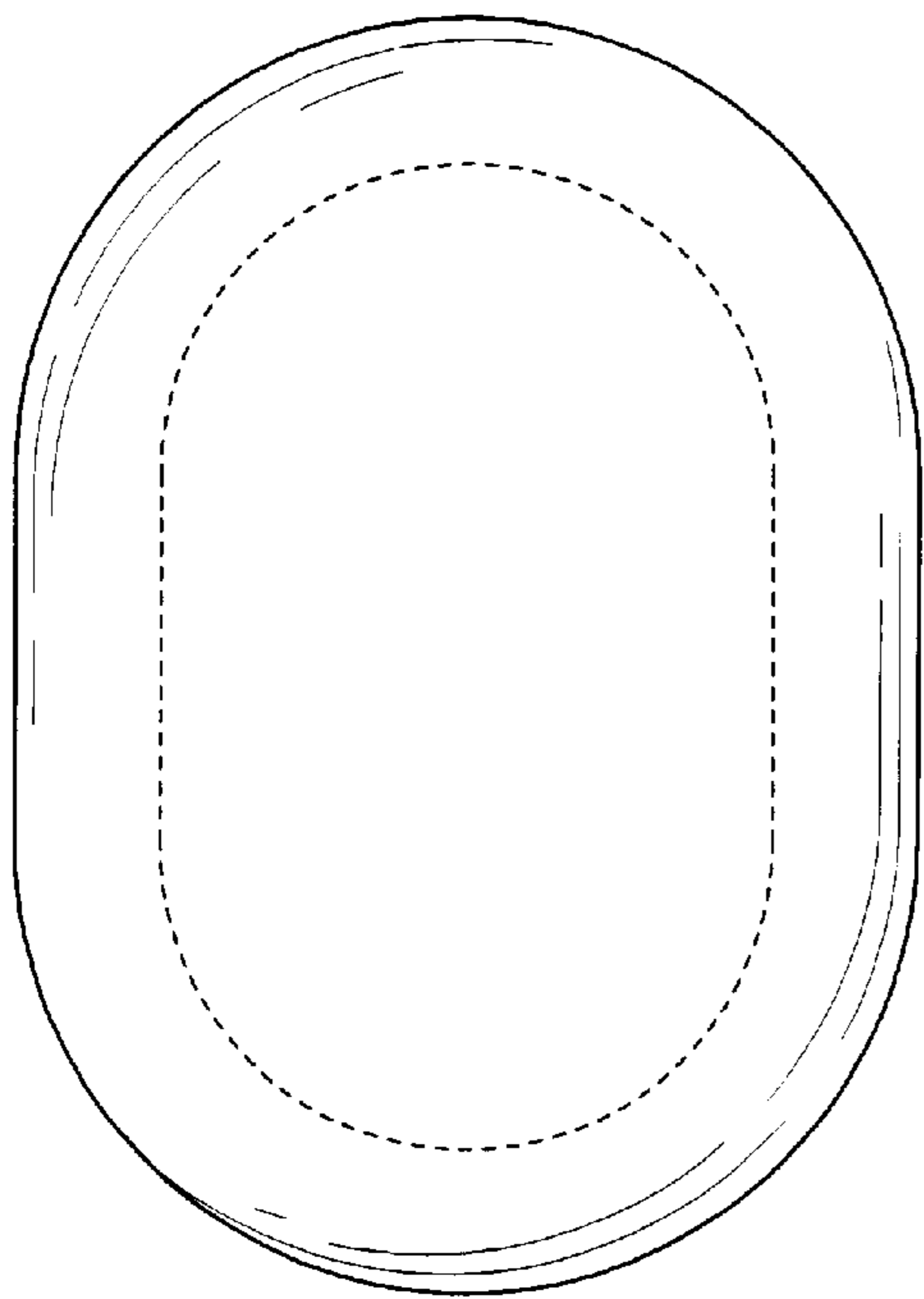

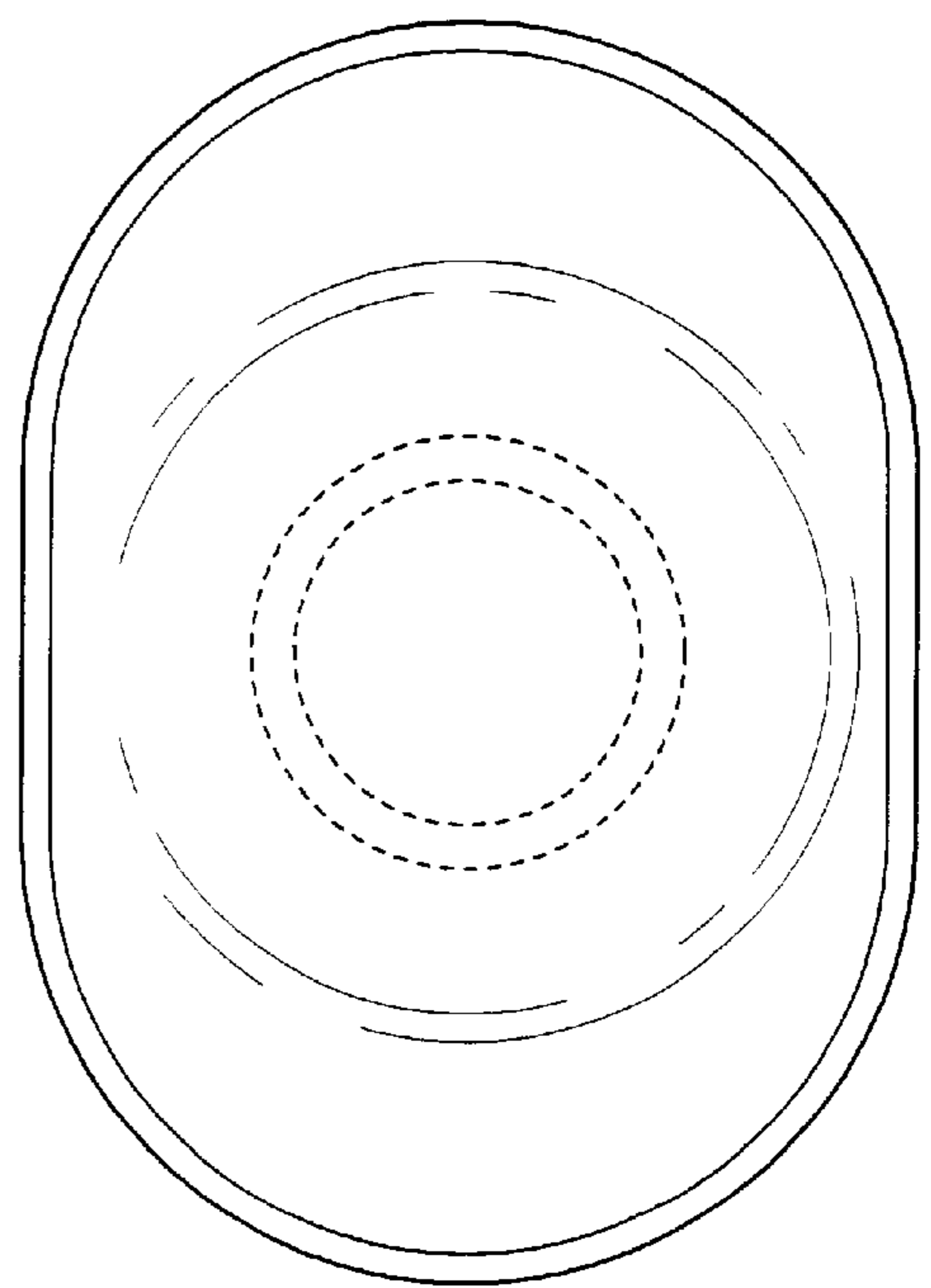
