(57) **CLAIM**

We claim the ornamental design for a cellular phone, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the cellular phone of the present invention;
 FIG. 2 is a front elevation view of the cellular phone of the present invention;
 FIG. 3 is a back elevation view of the cellular phone of the present invention;
 FIG. 4 is a left side plan view of the cellular phone of the present invention;
 FIG. 5 is a right side plan view of the cellular phone of the present invention;
 FIG. 6 is a top plan view of the cellular phone of the present invention;
 FIG. 7 is a lower plan view of the cellular phone of the present invention; and,
 FIG. 8 is a front elevational view of the cellular phone of the present invention, shown rotated to an open position.

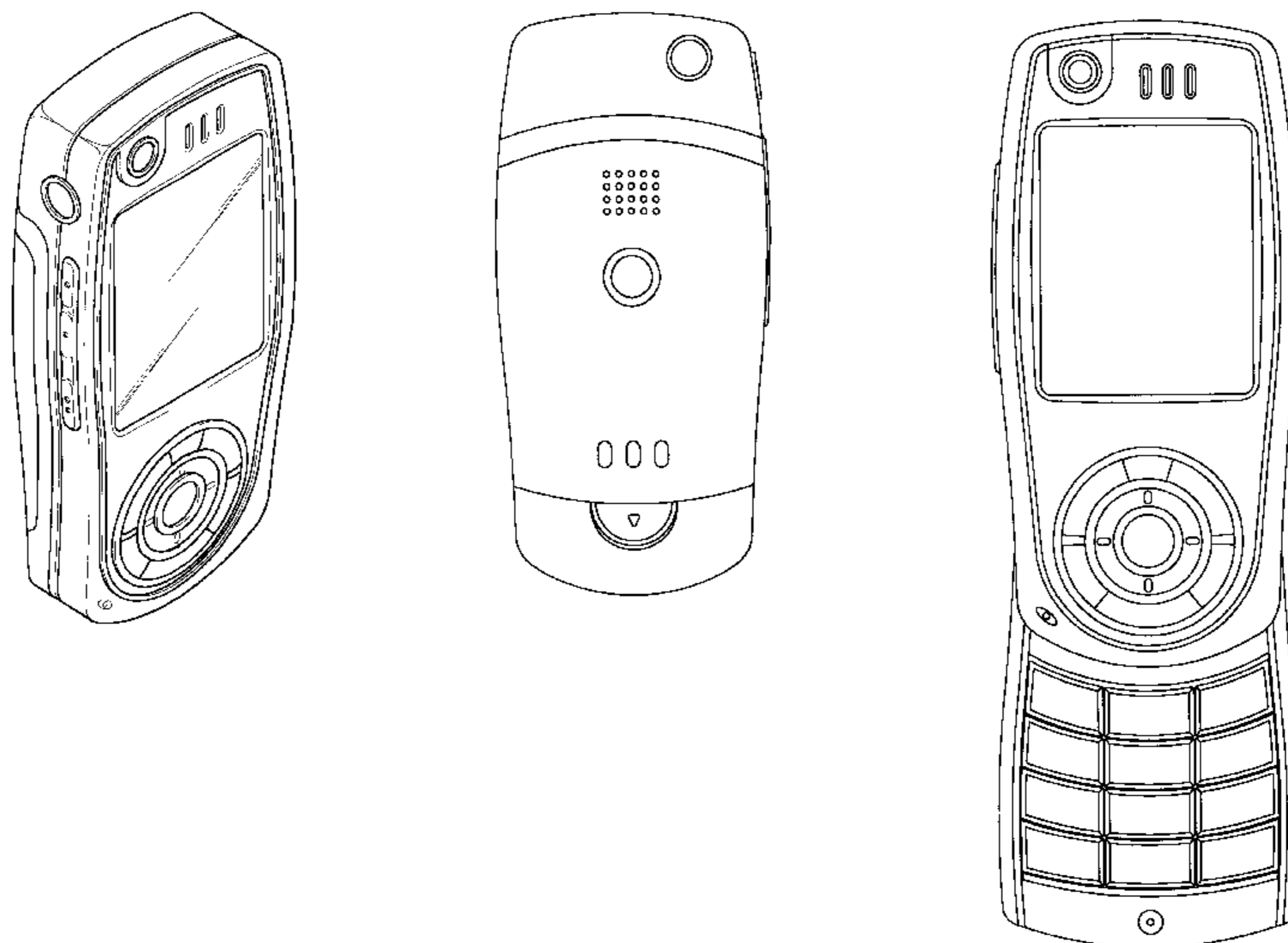

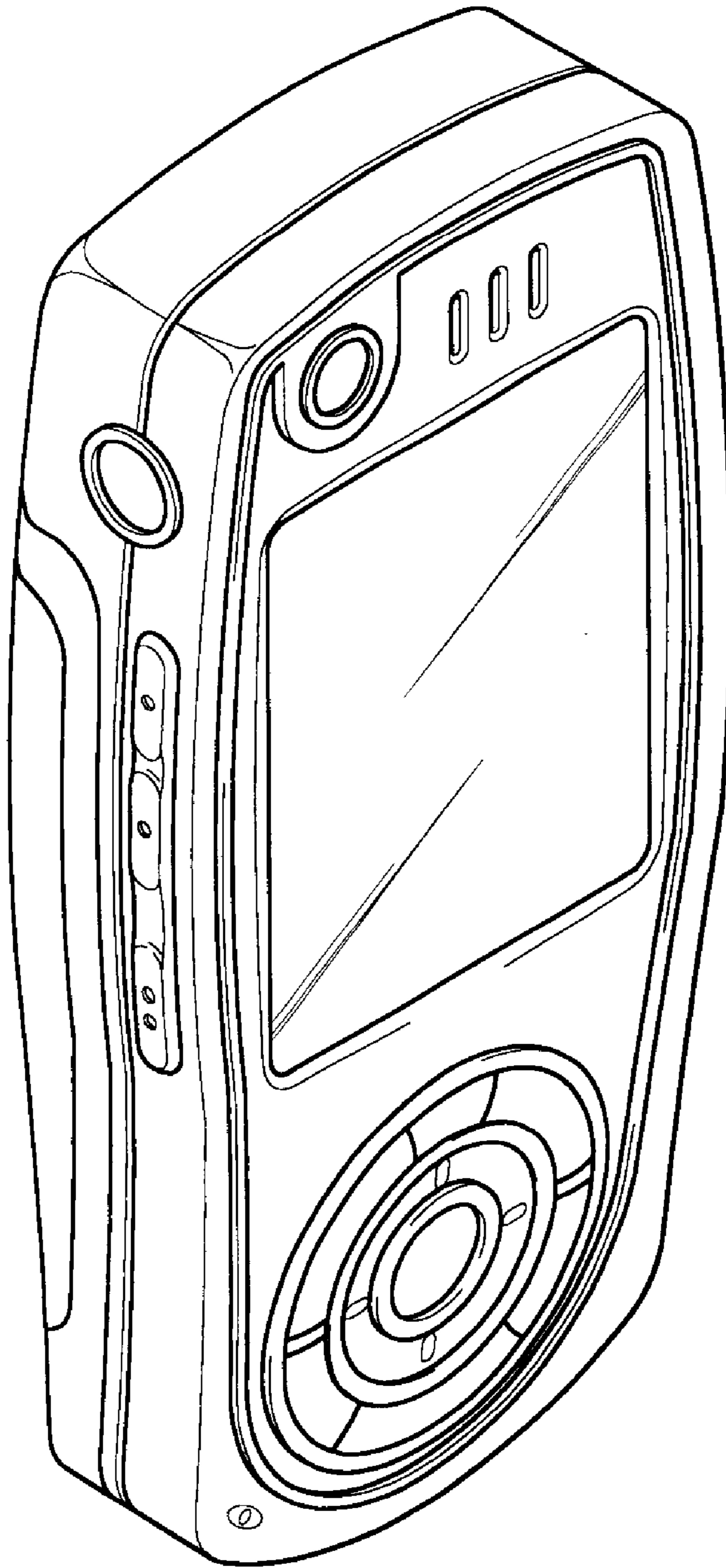

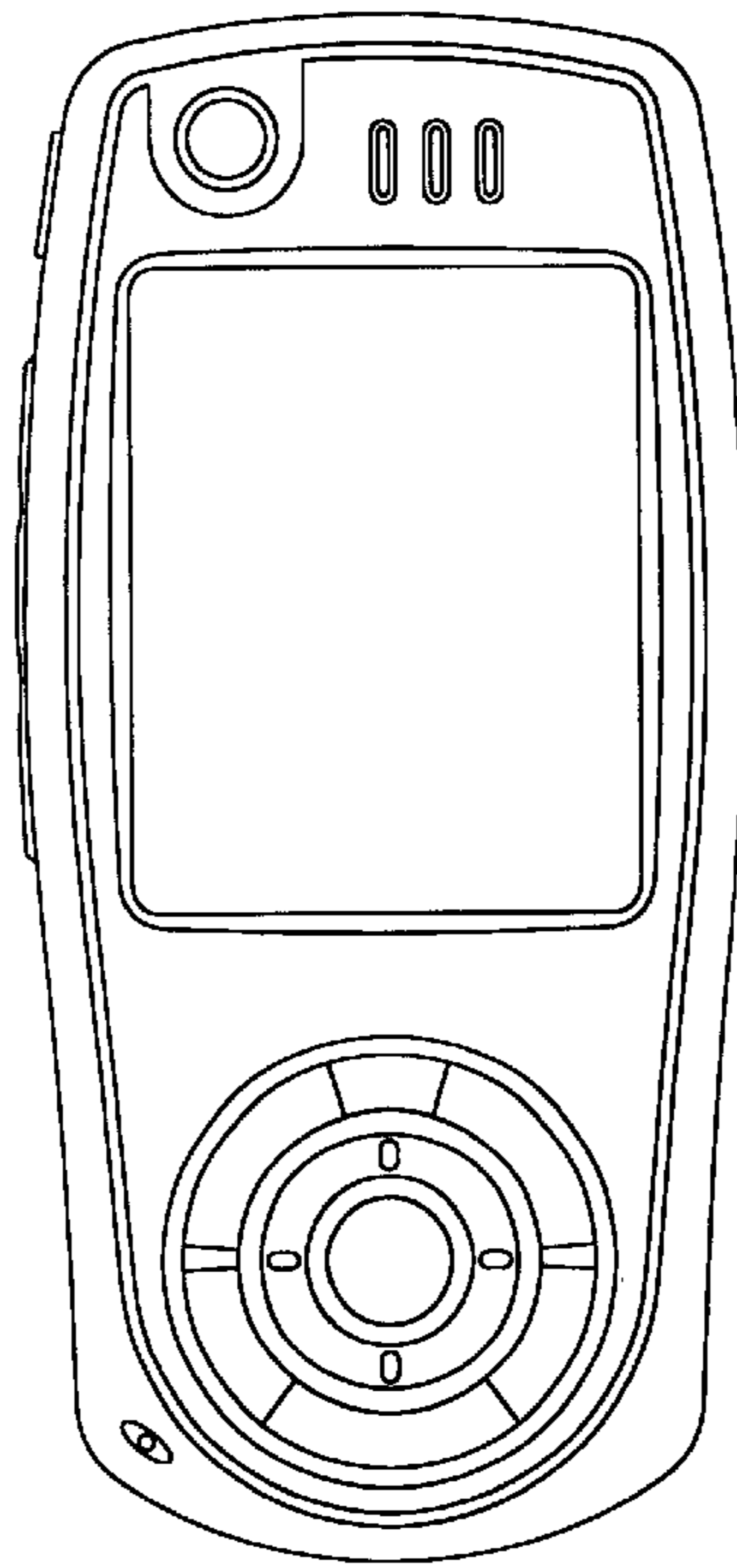

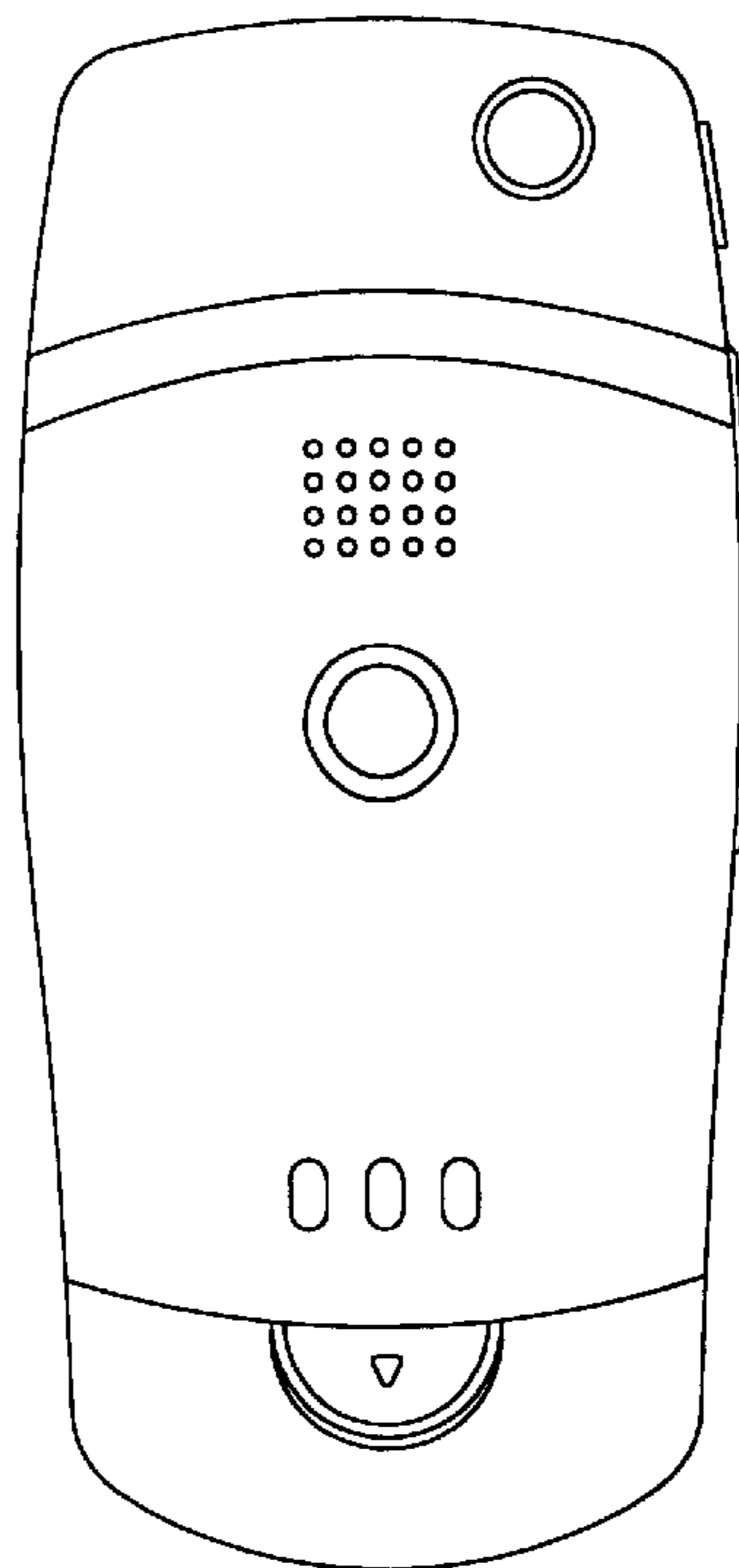

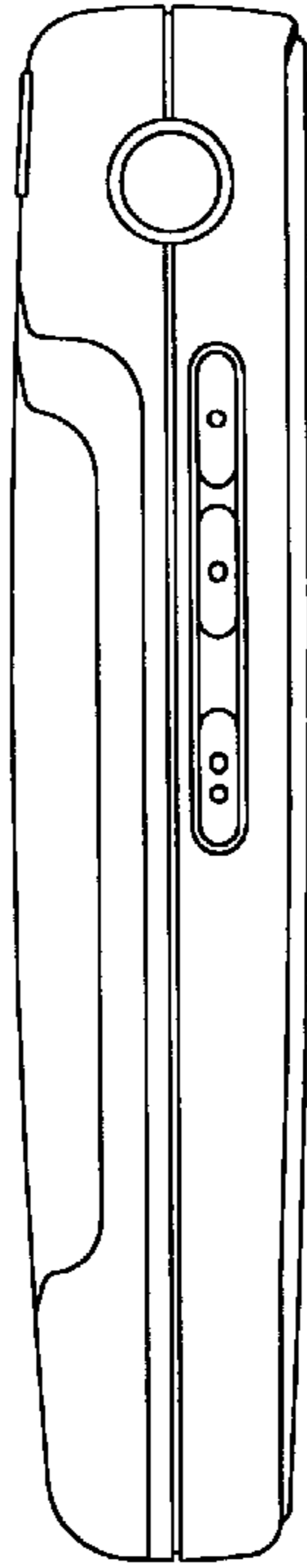

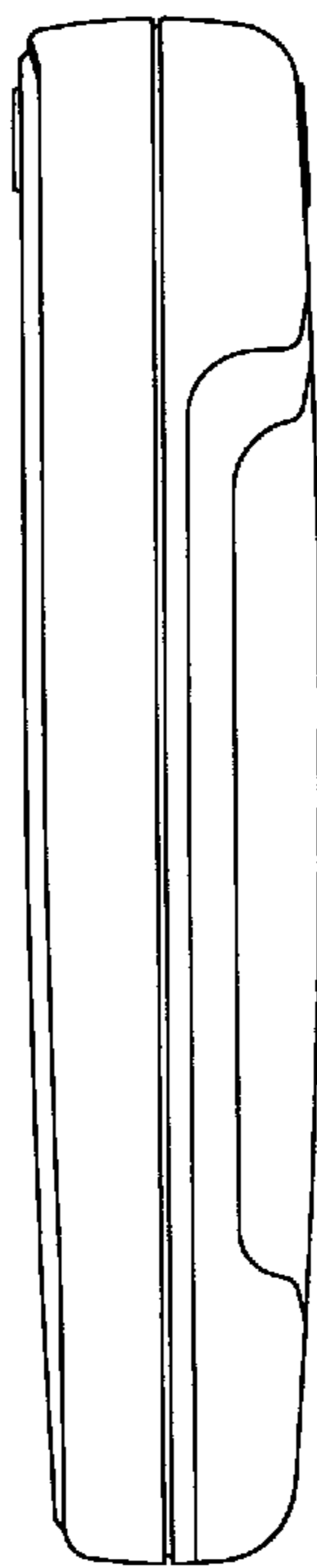

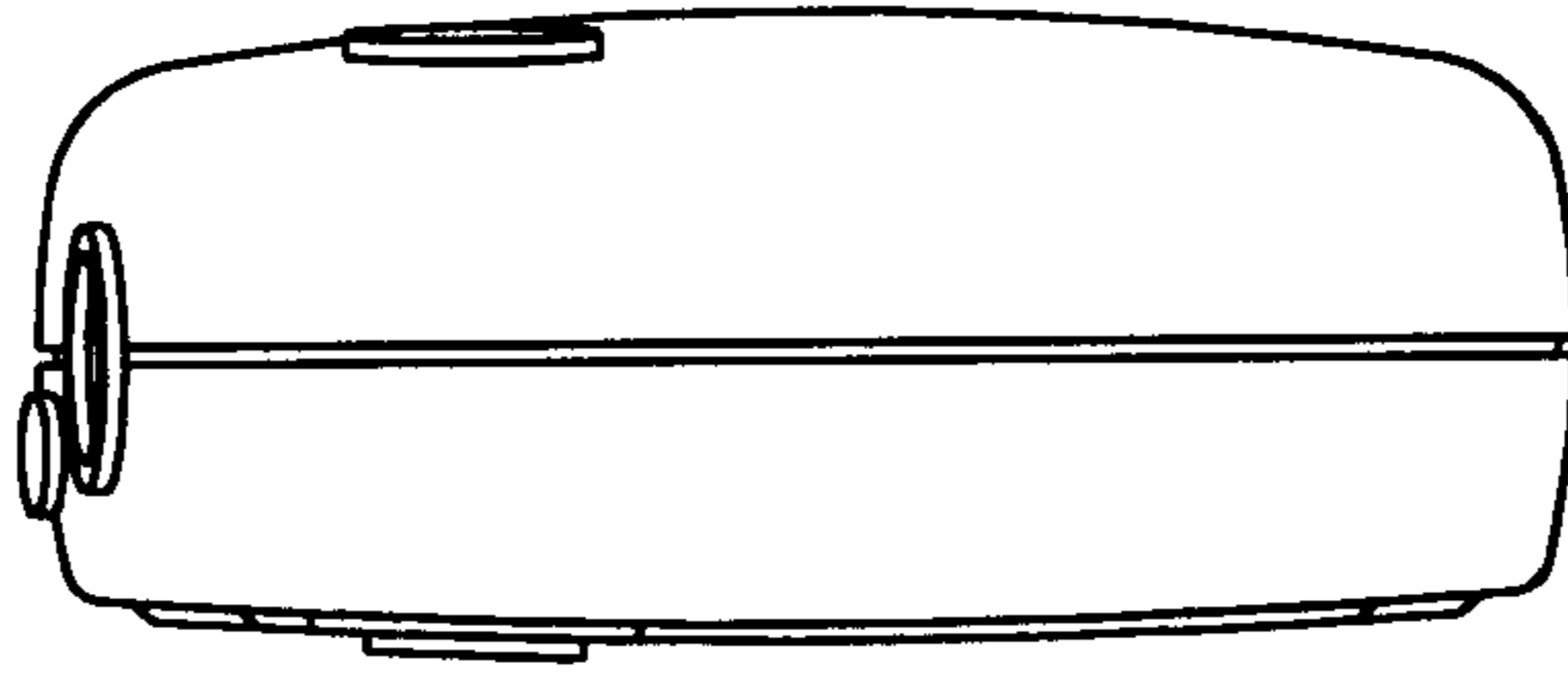

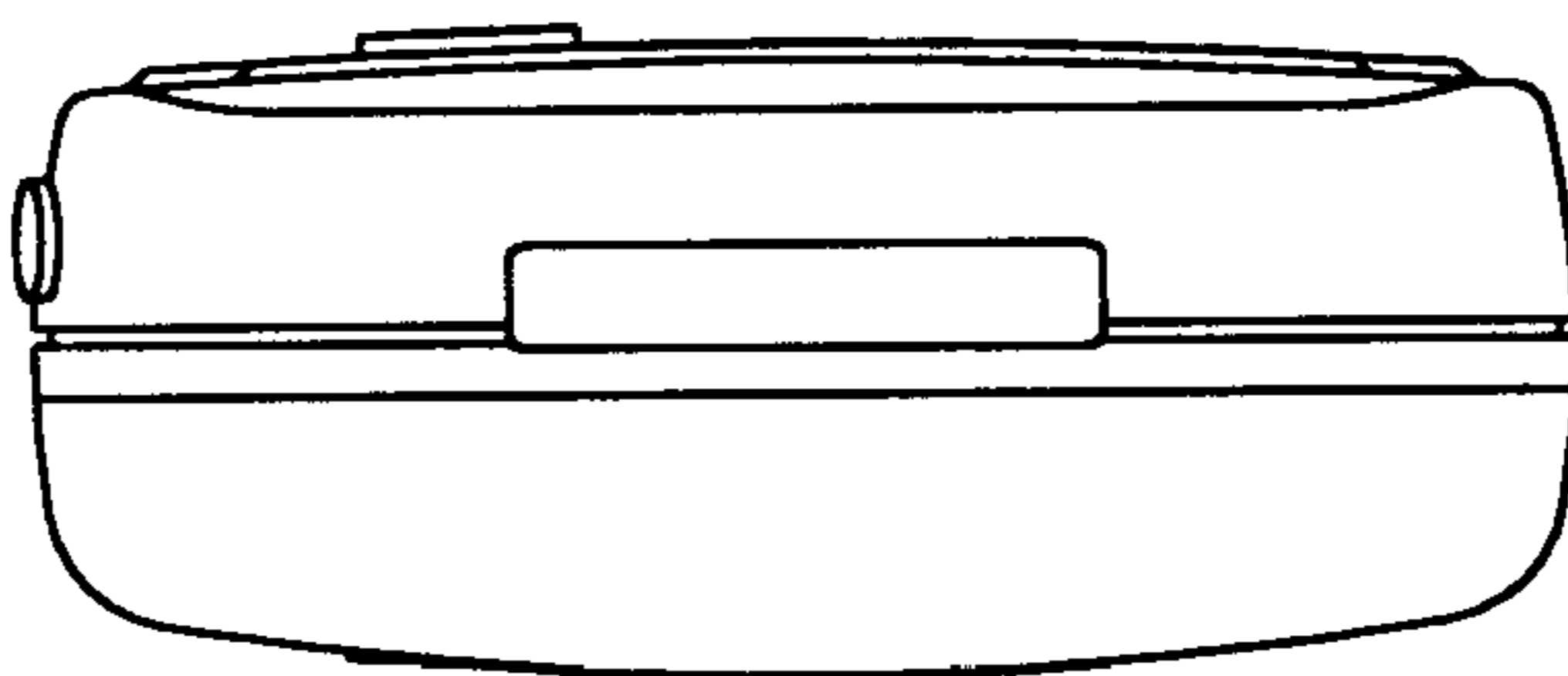
