The ornamental design for a portable communication device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front orthographic view of a portable communication device showing a first embodiment of our new design;

FIG. 11 is a right side orthographic view thereof;

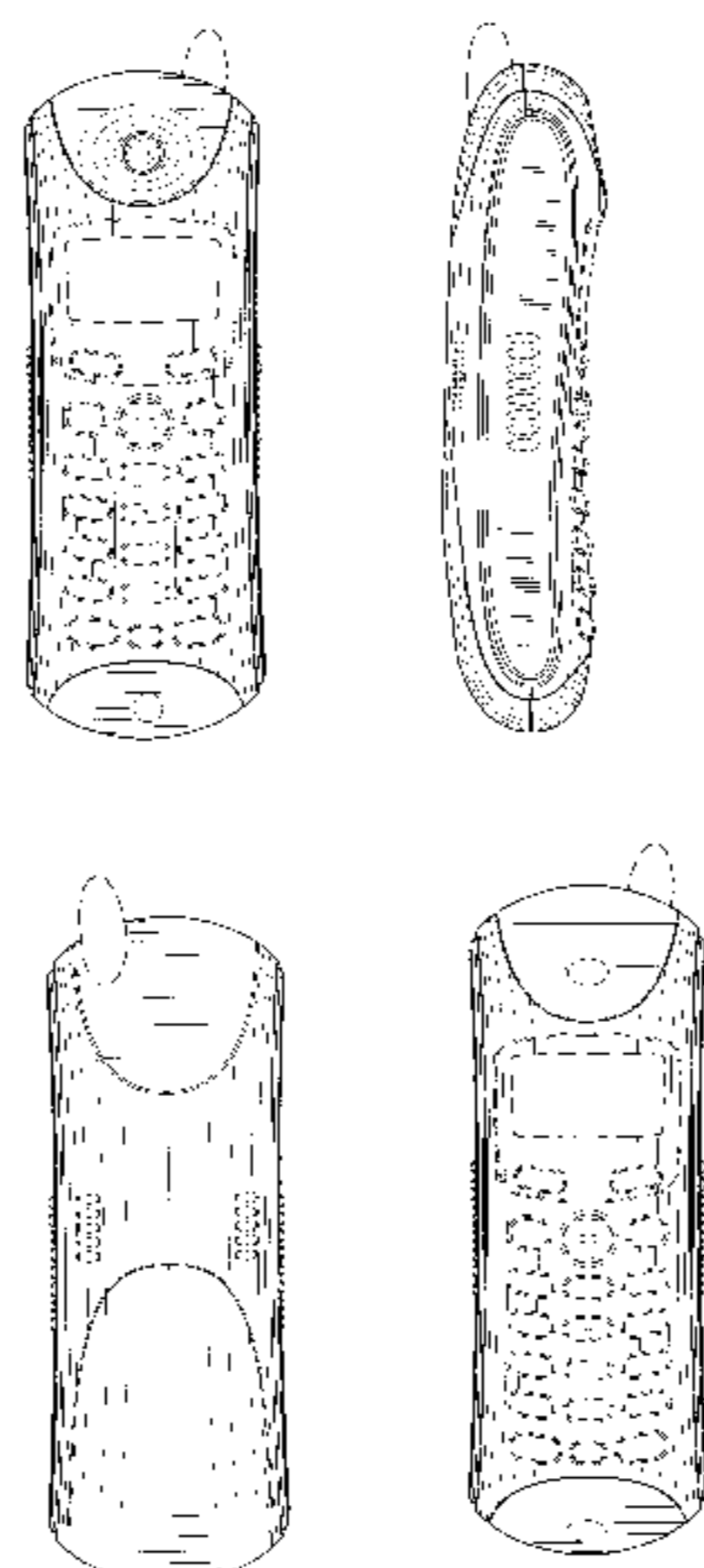
FIG. 12 is a top orthographic view thereof;

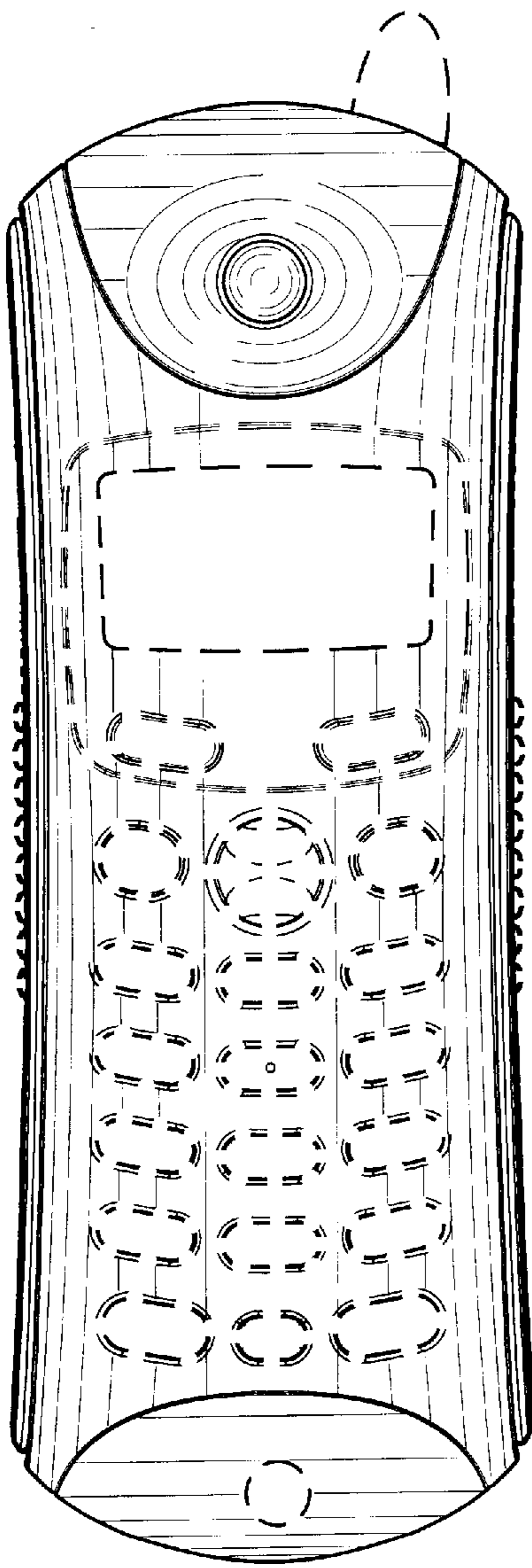

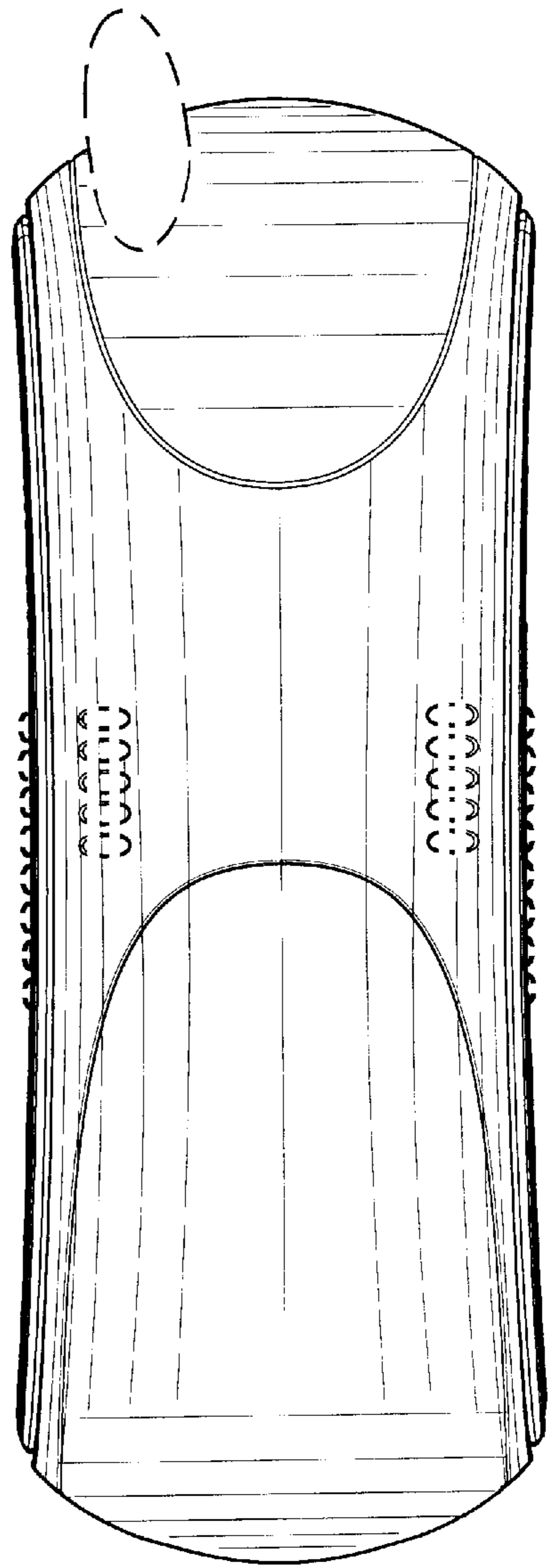

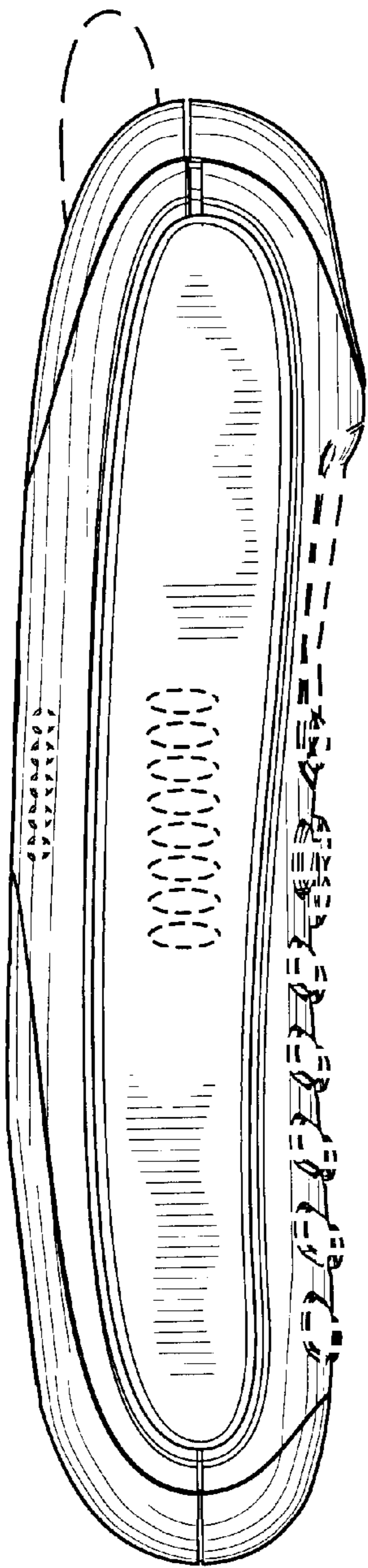

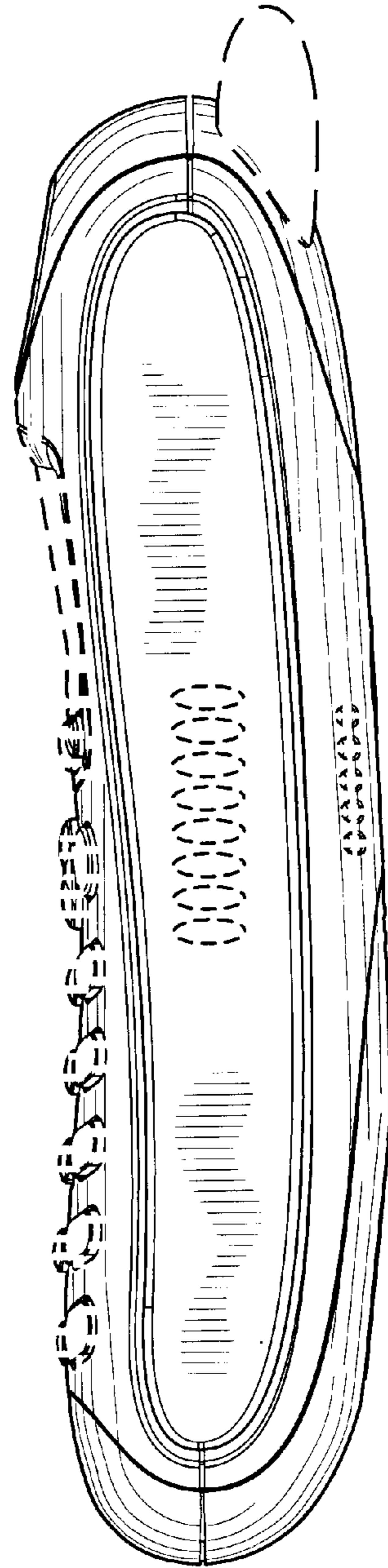

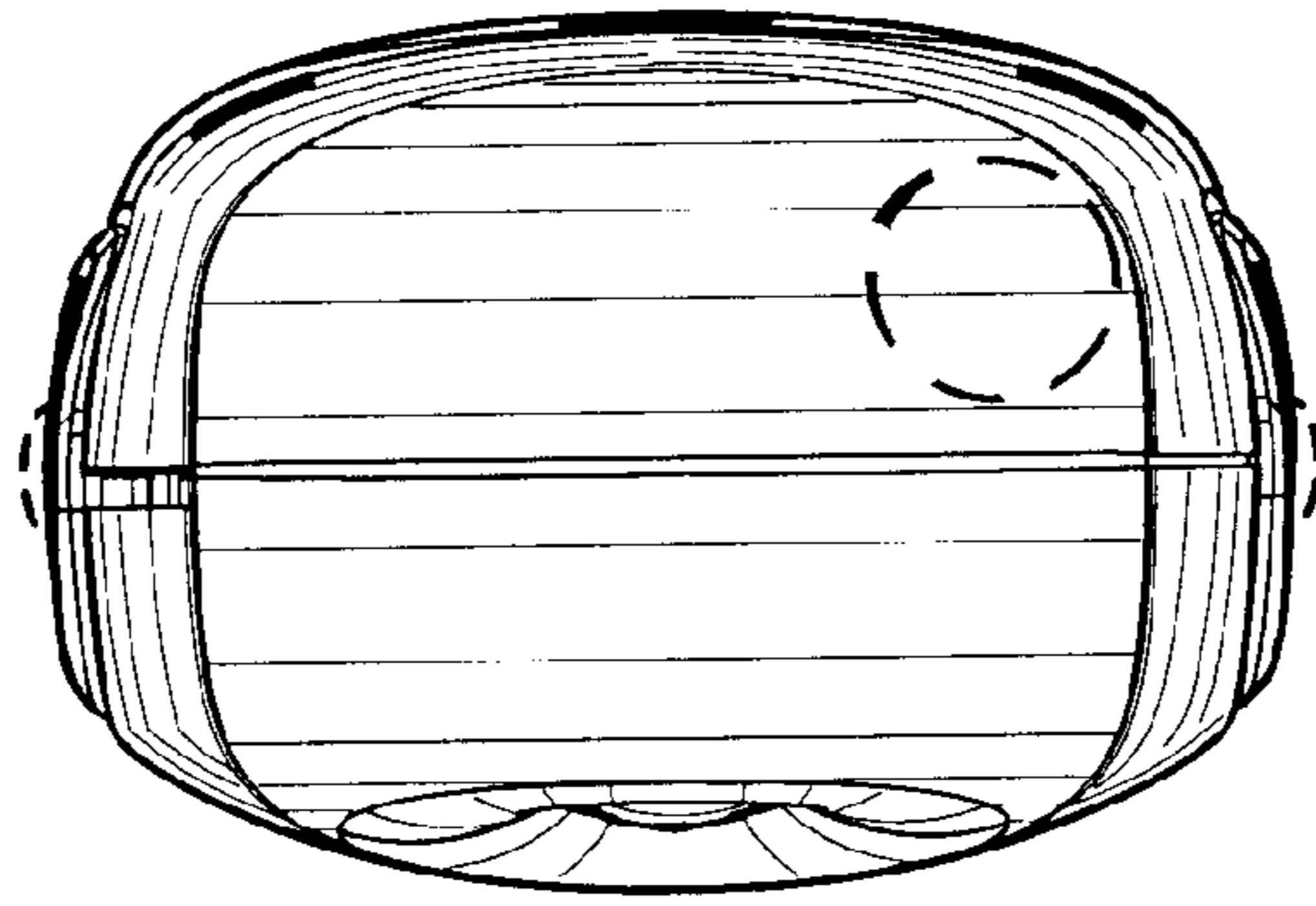

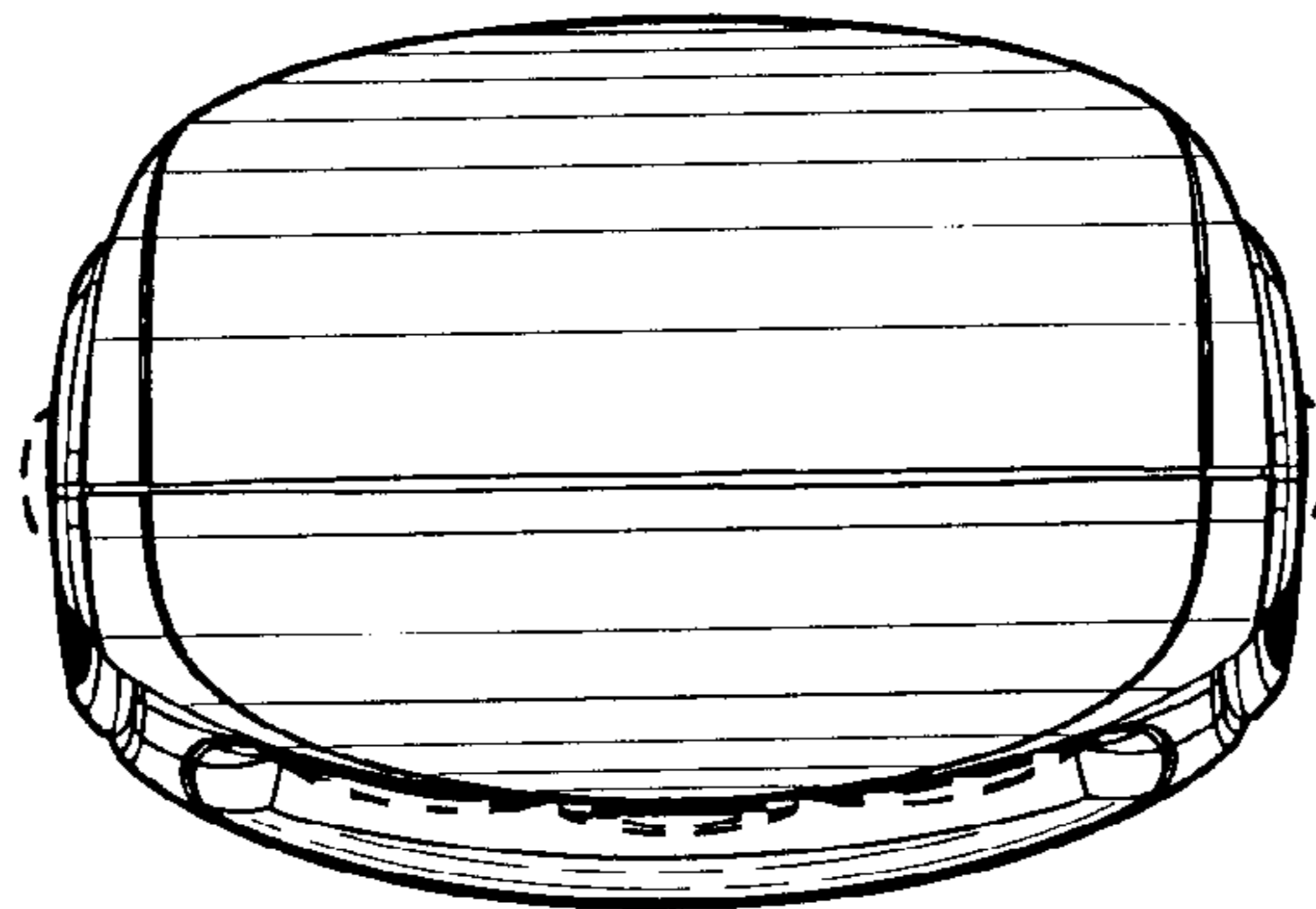

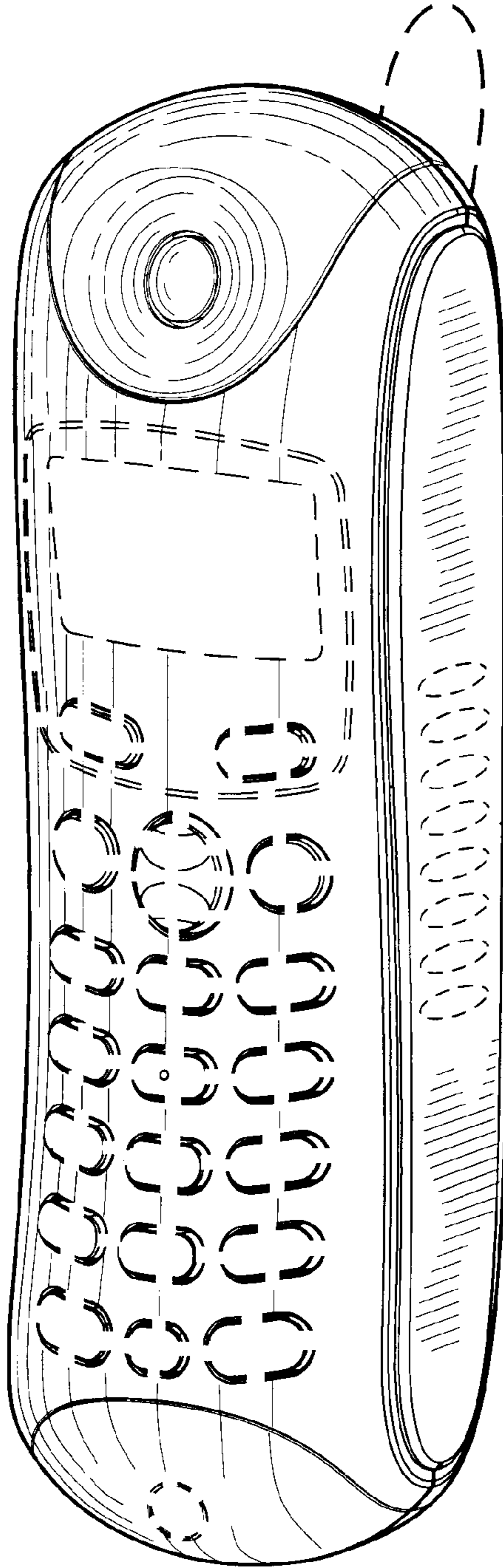

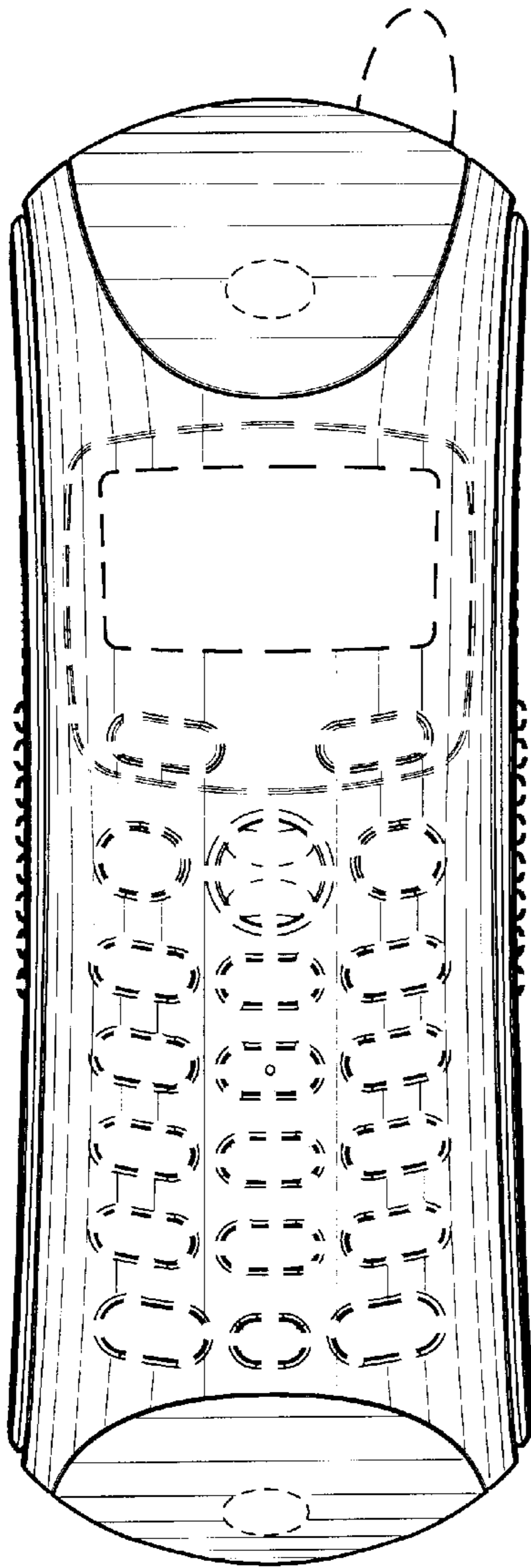

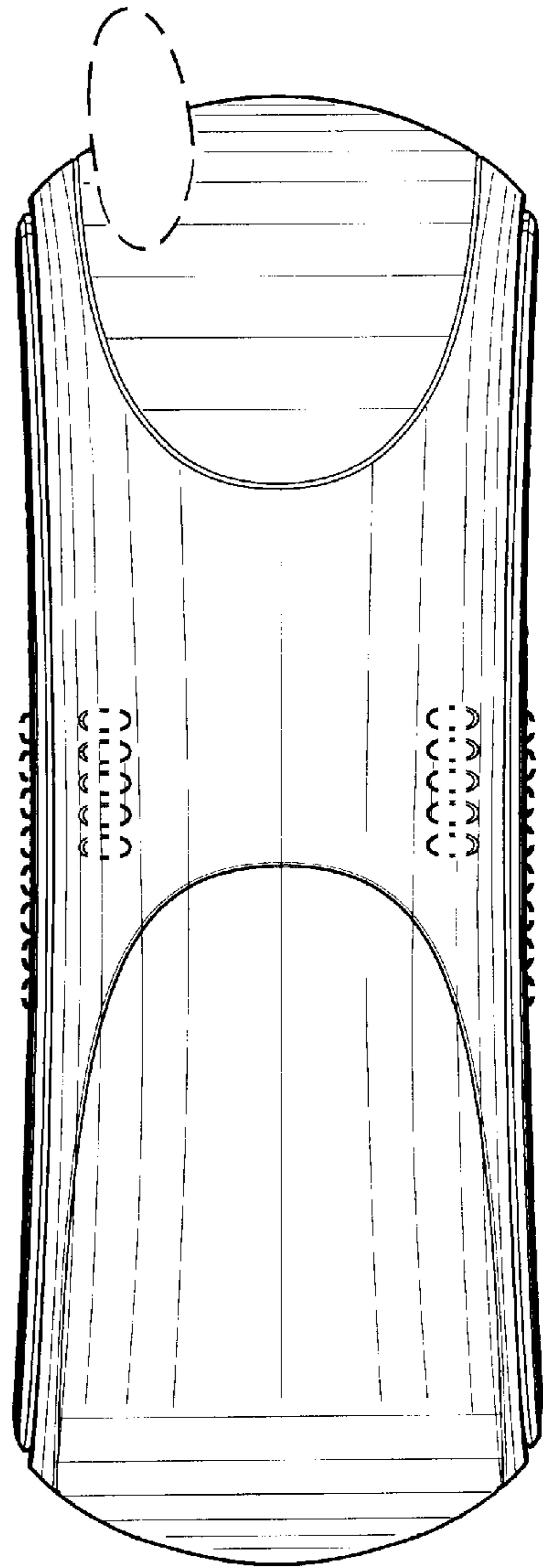

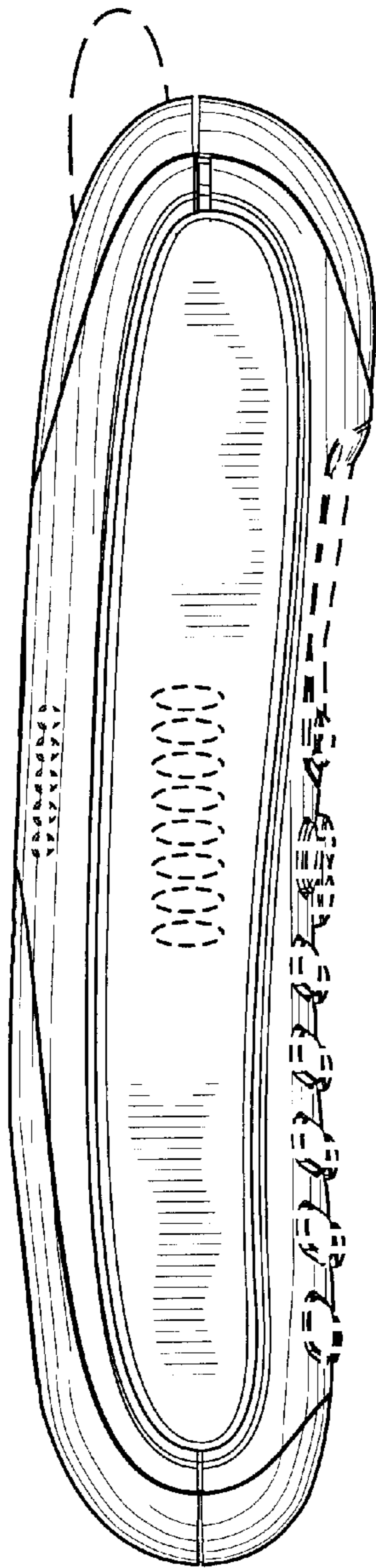

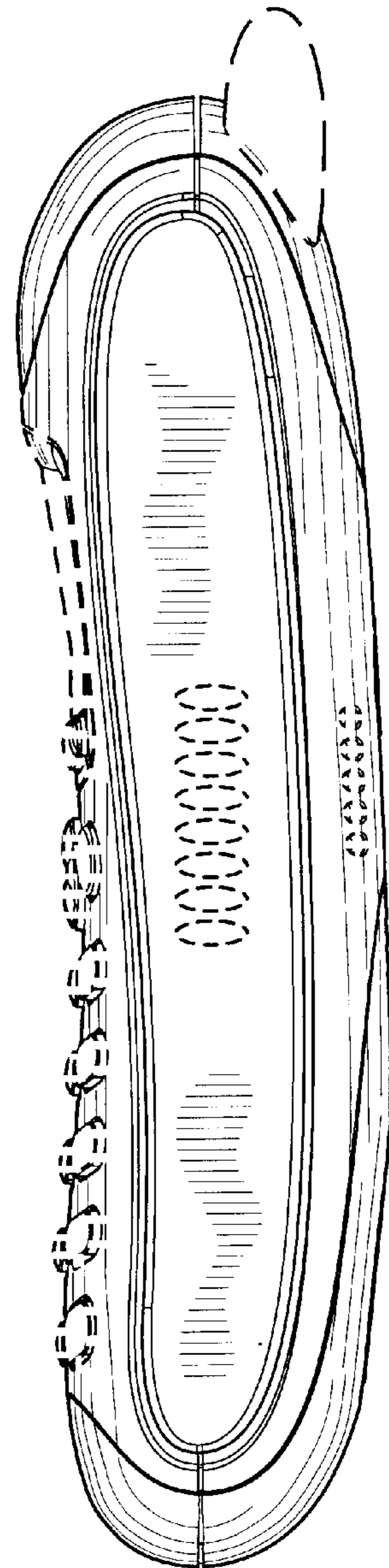

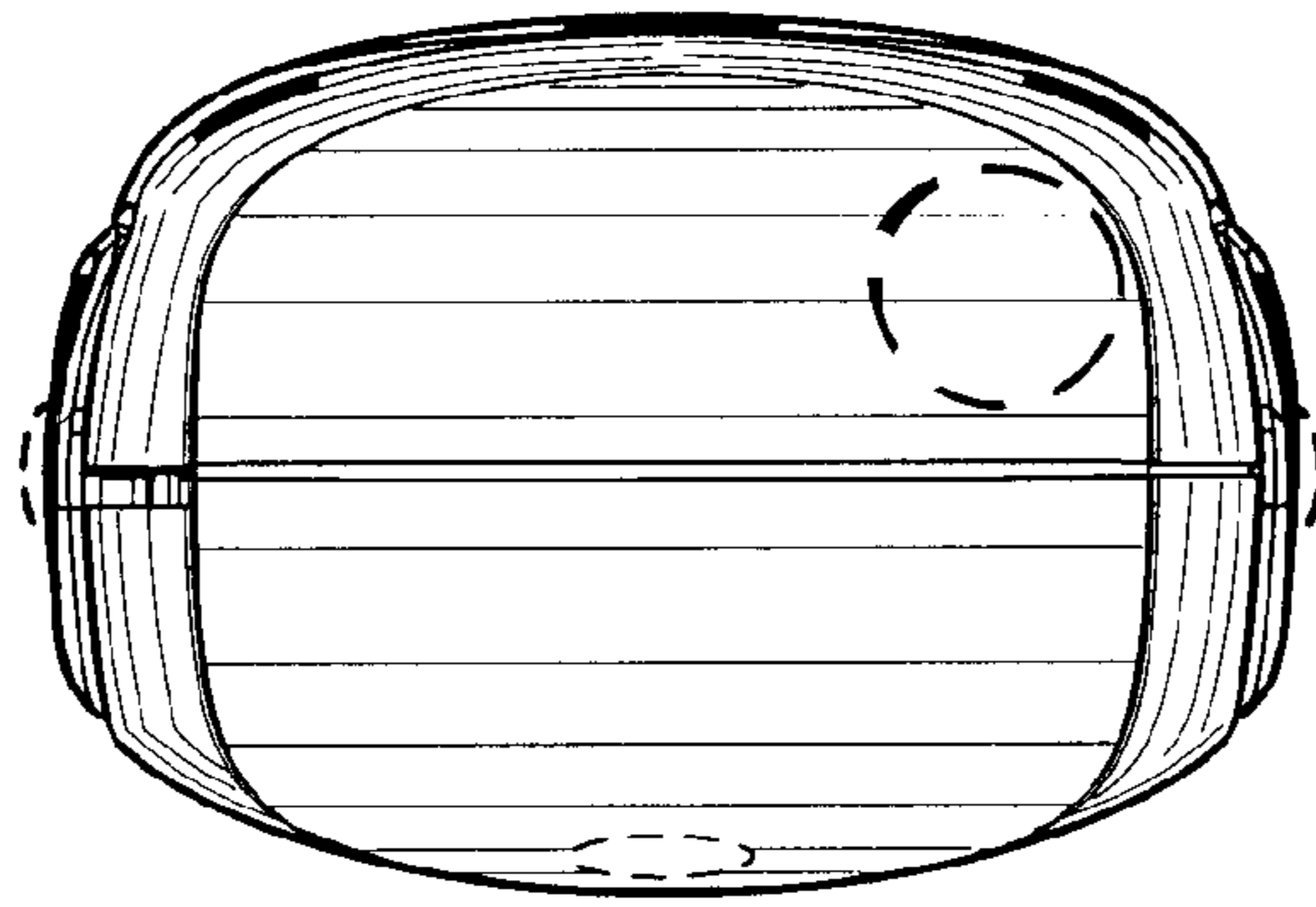

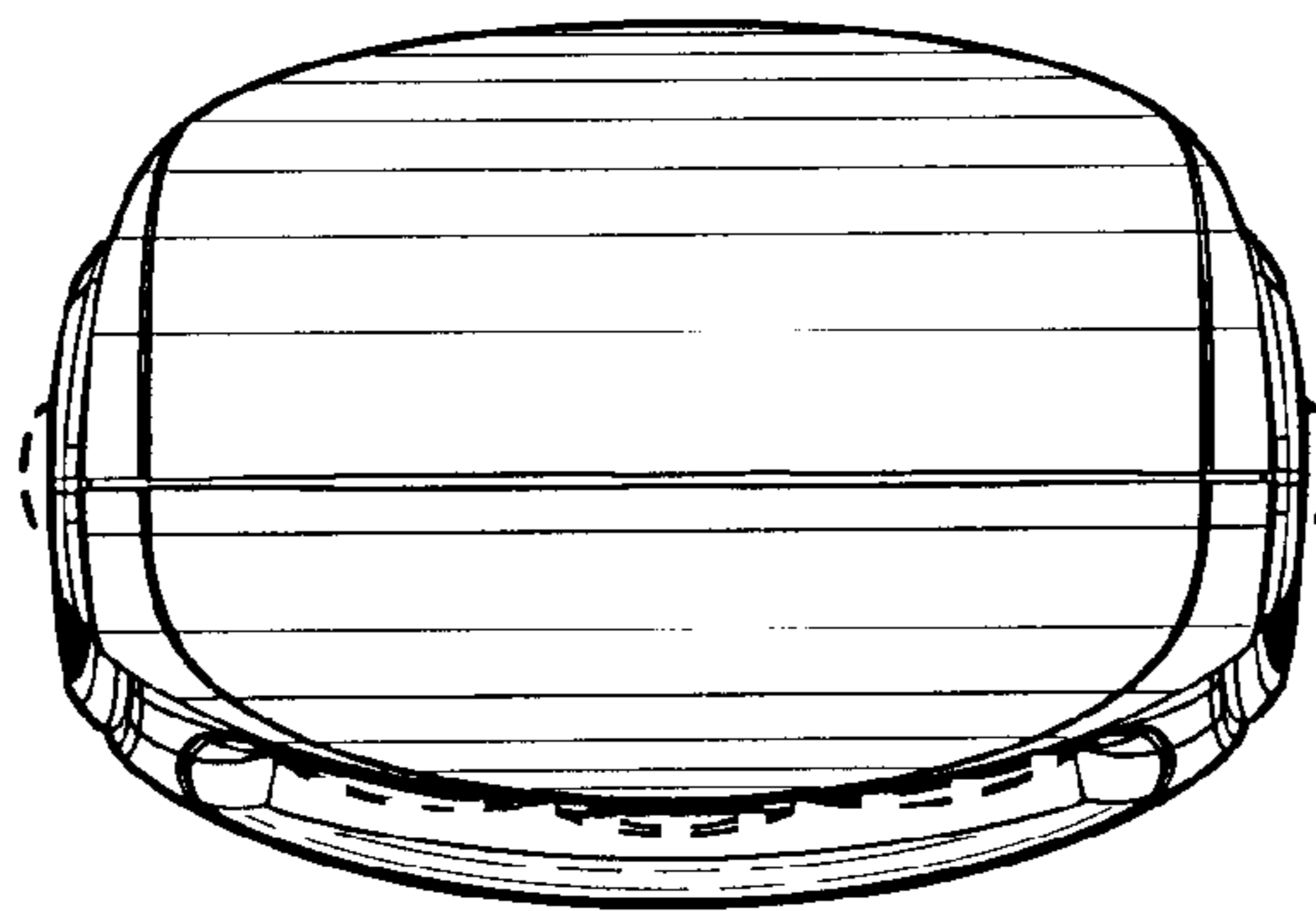

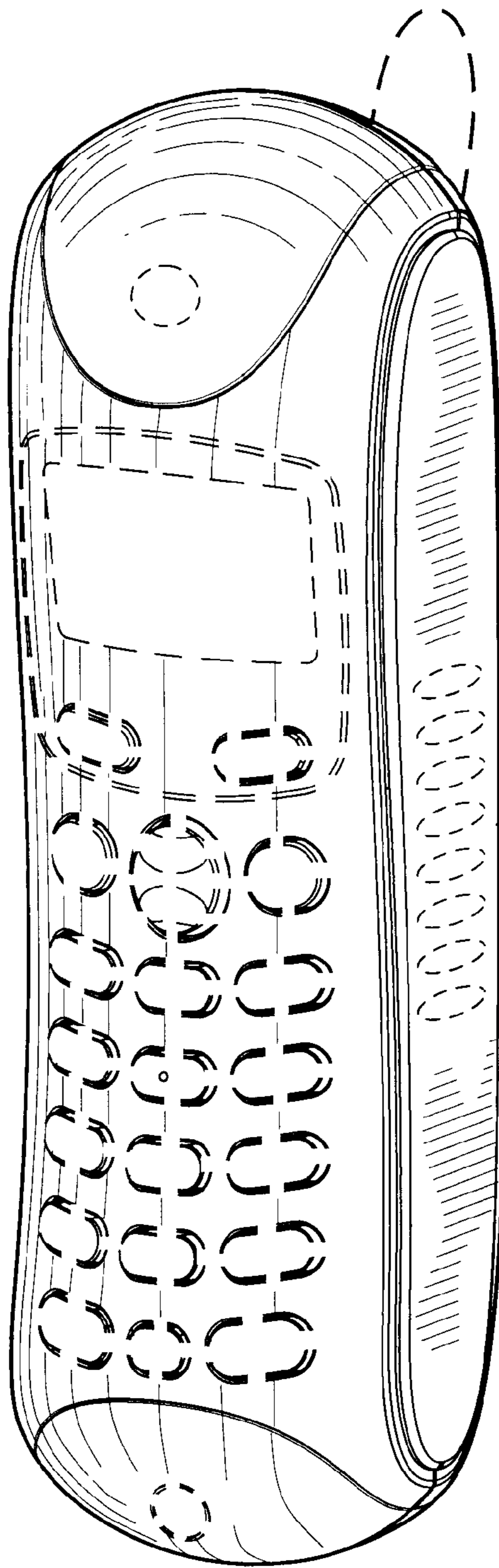
