The ornamental design for a single-lens reflex camera, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a single-lens reflex camera showing our new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a perspective view thereof.

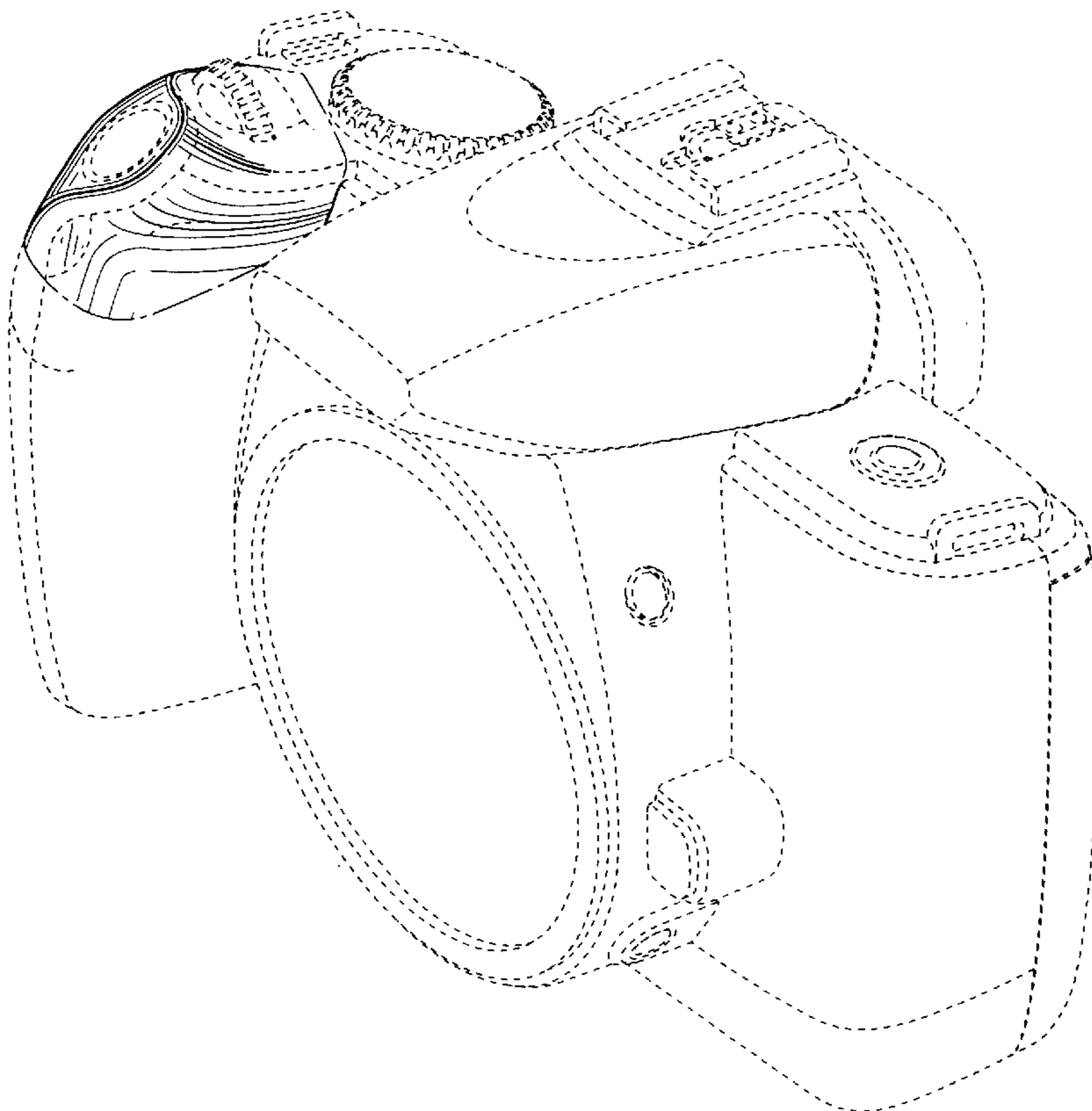

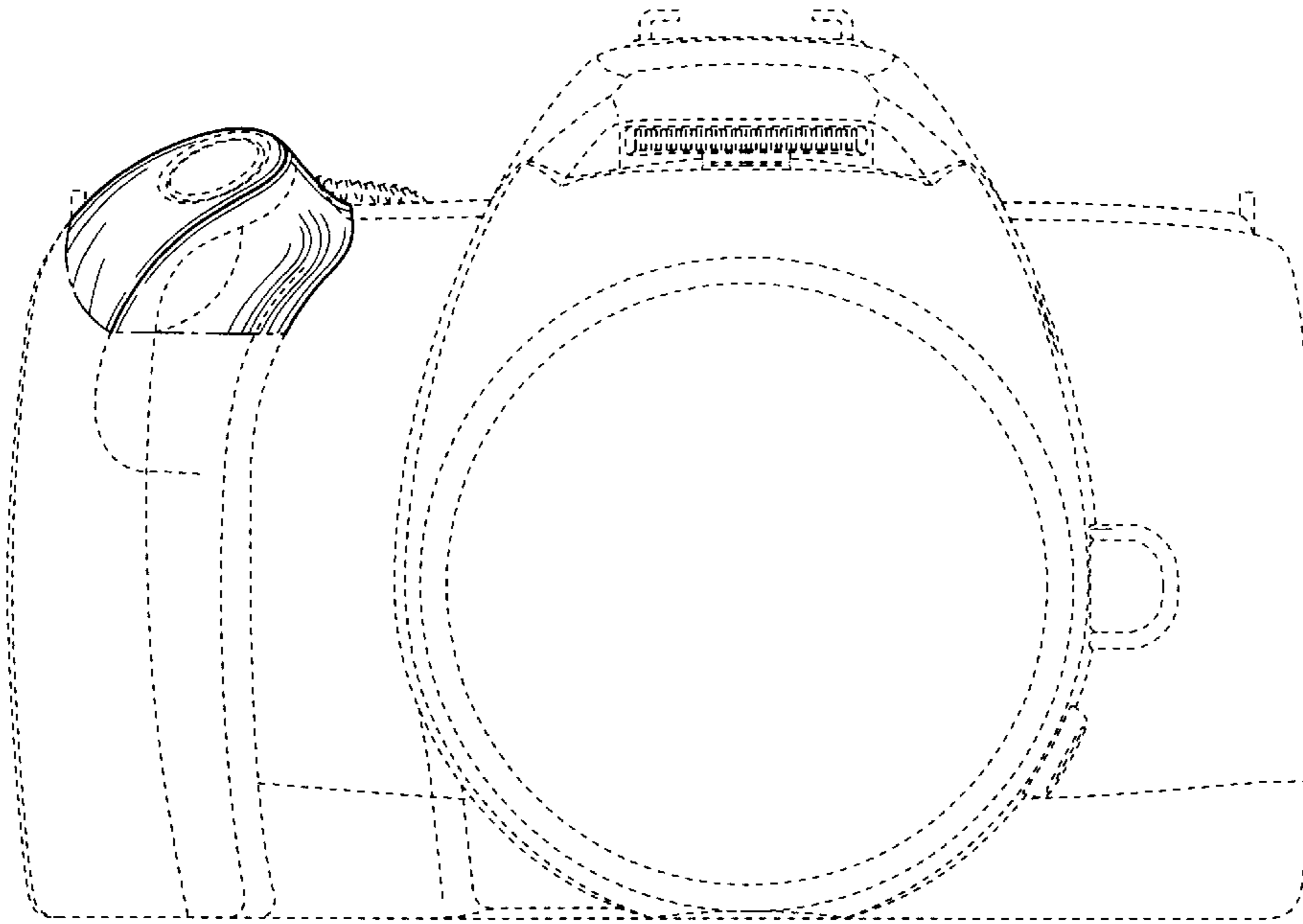

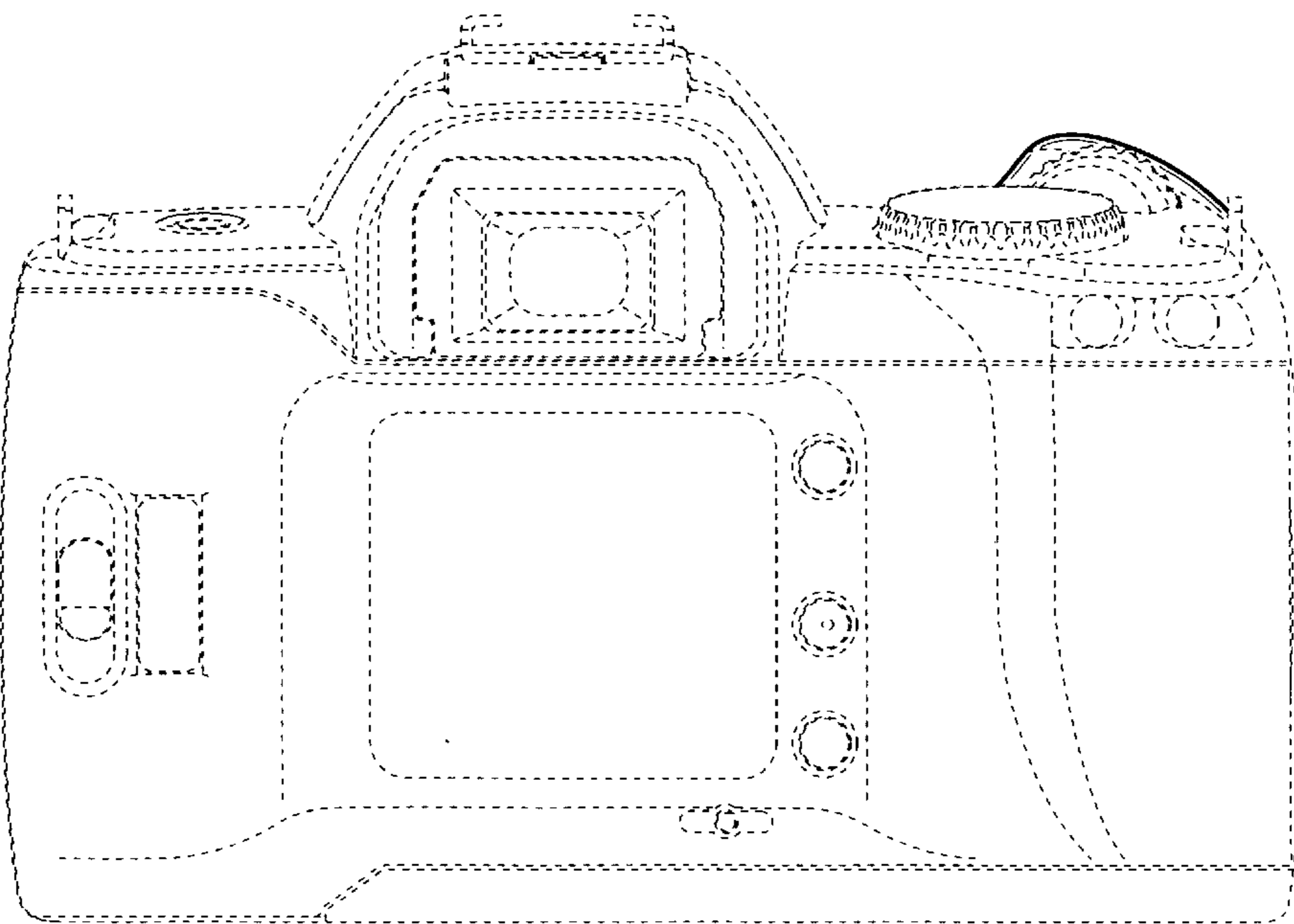

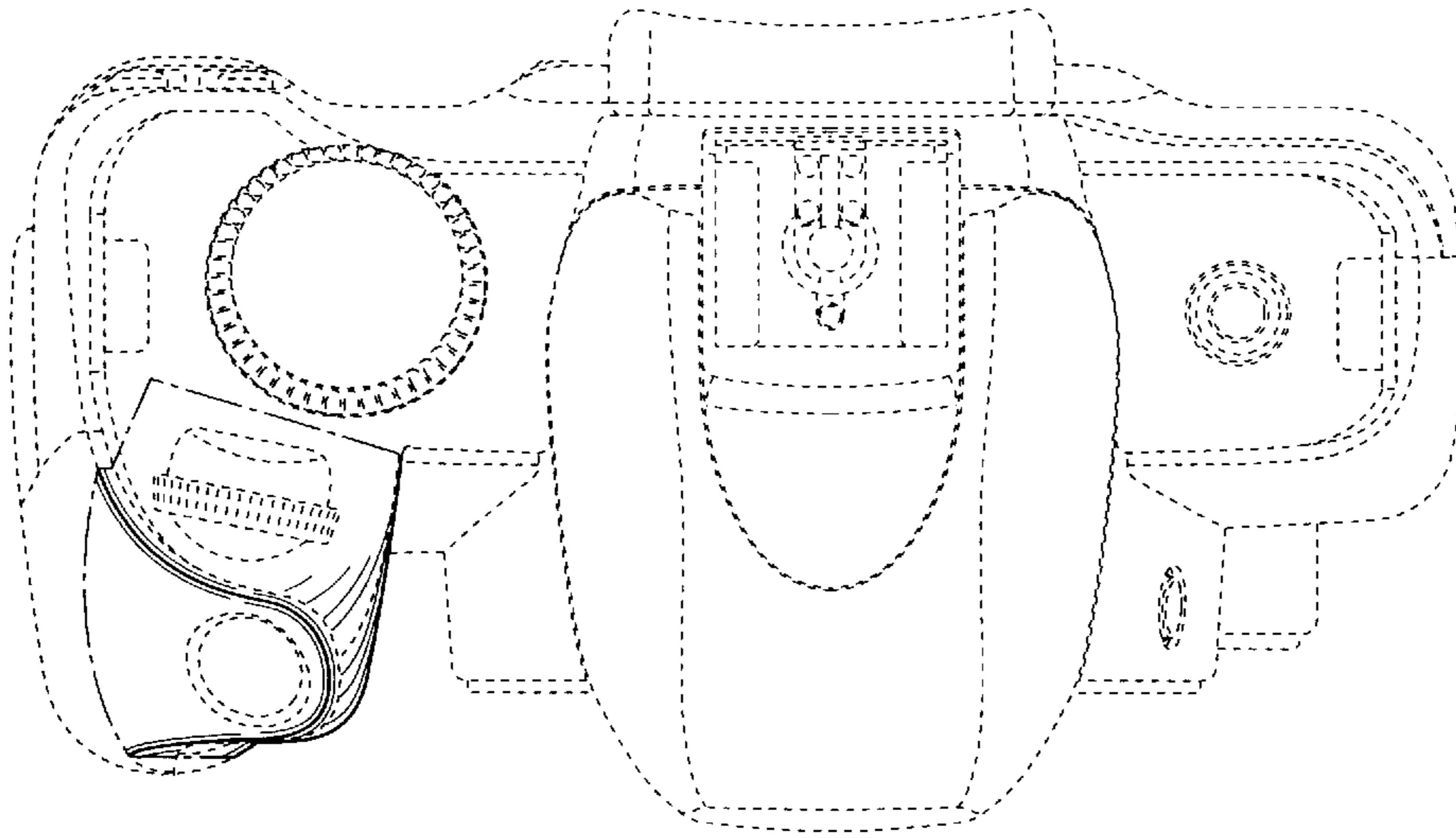

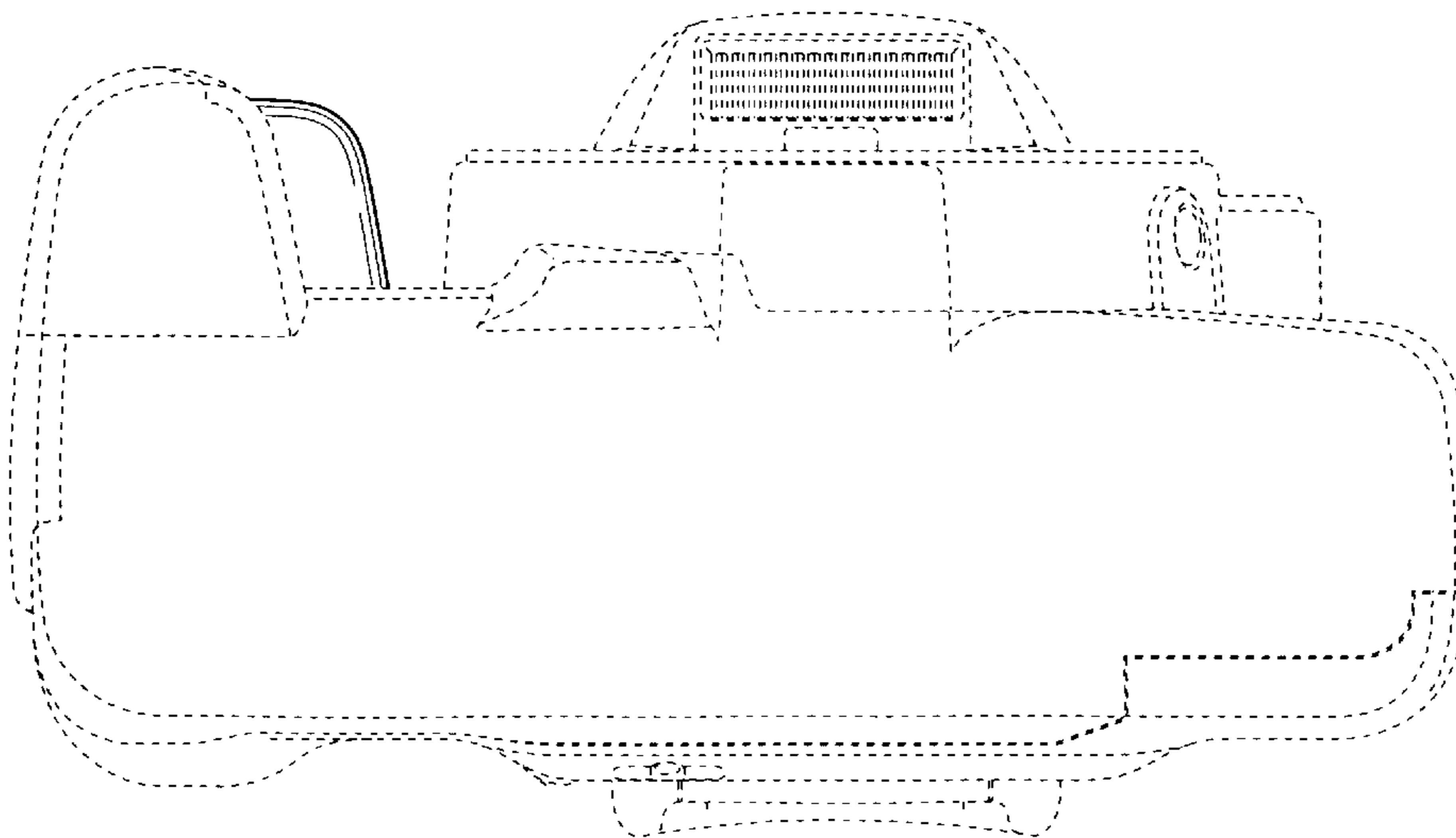

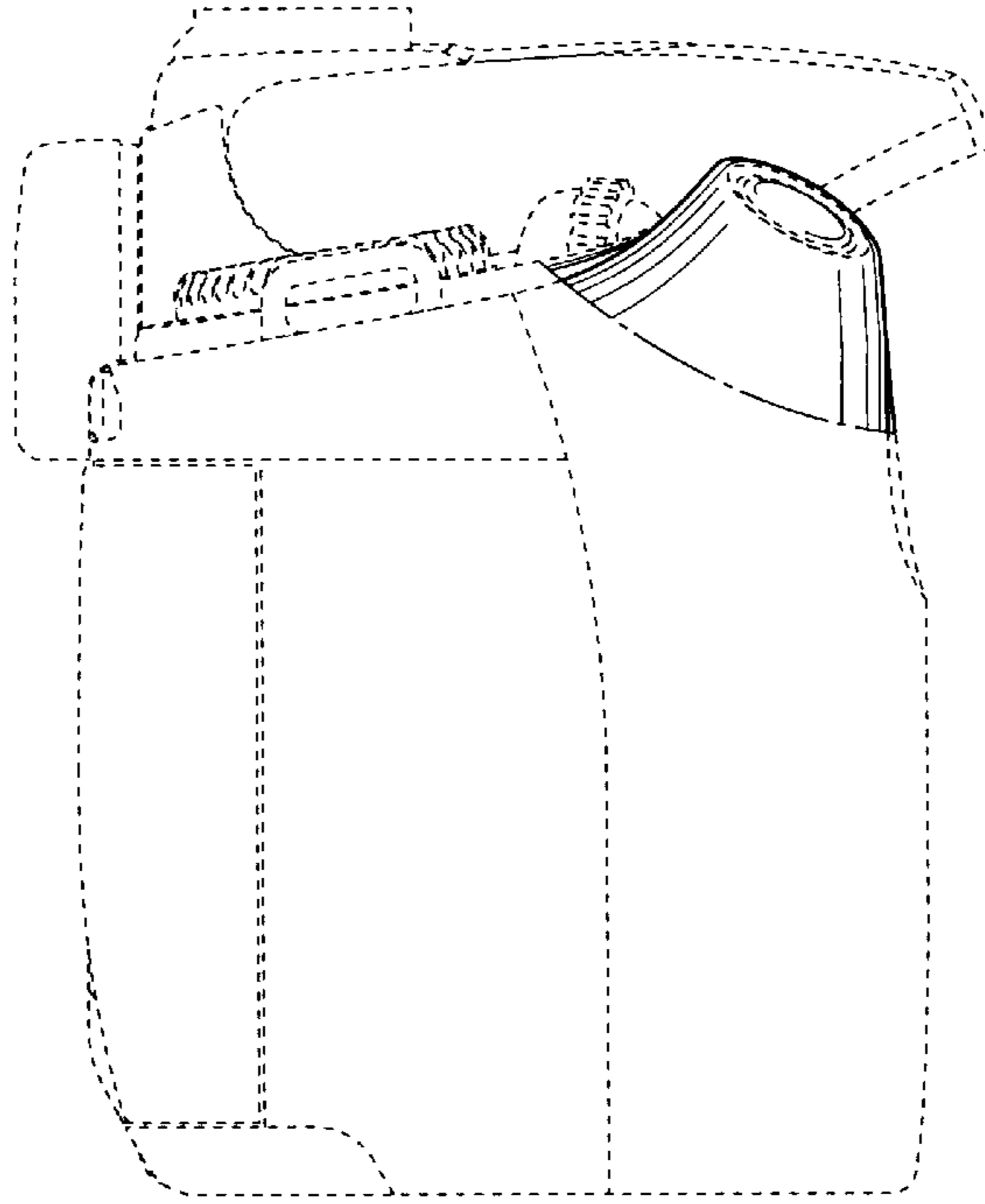

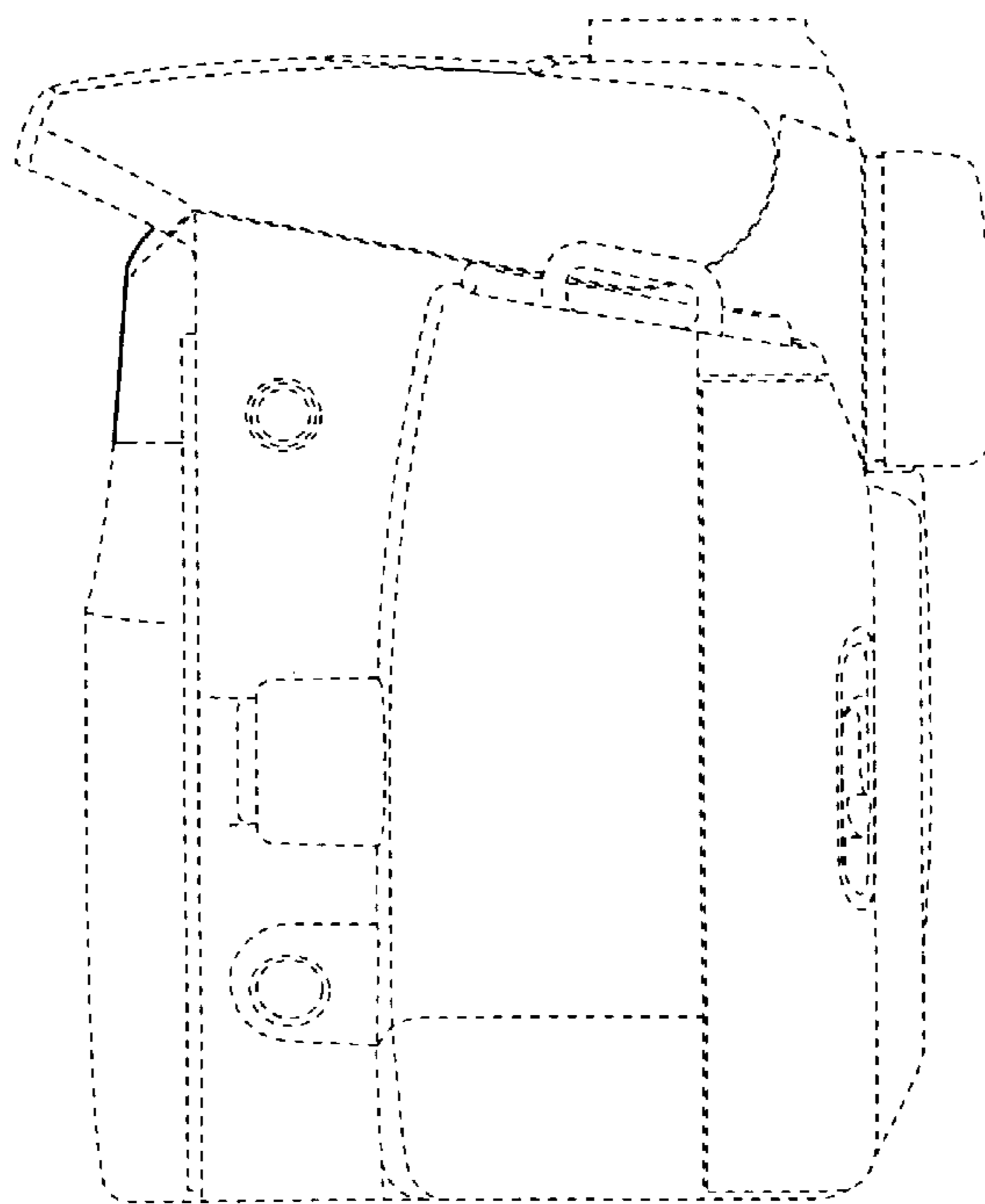
