FIG. 1 is a top, front and right side perspective view of a rate card adaptor for mailing machine according to the present invention;

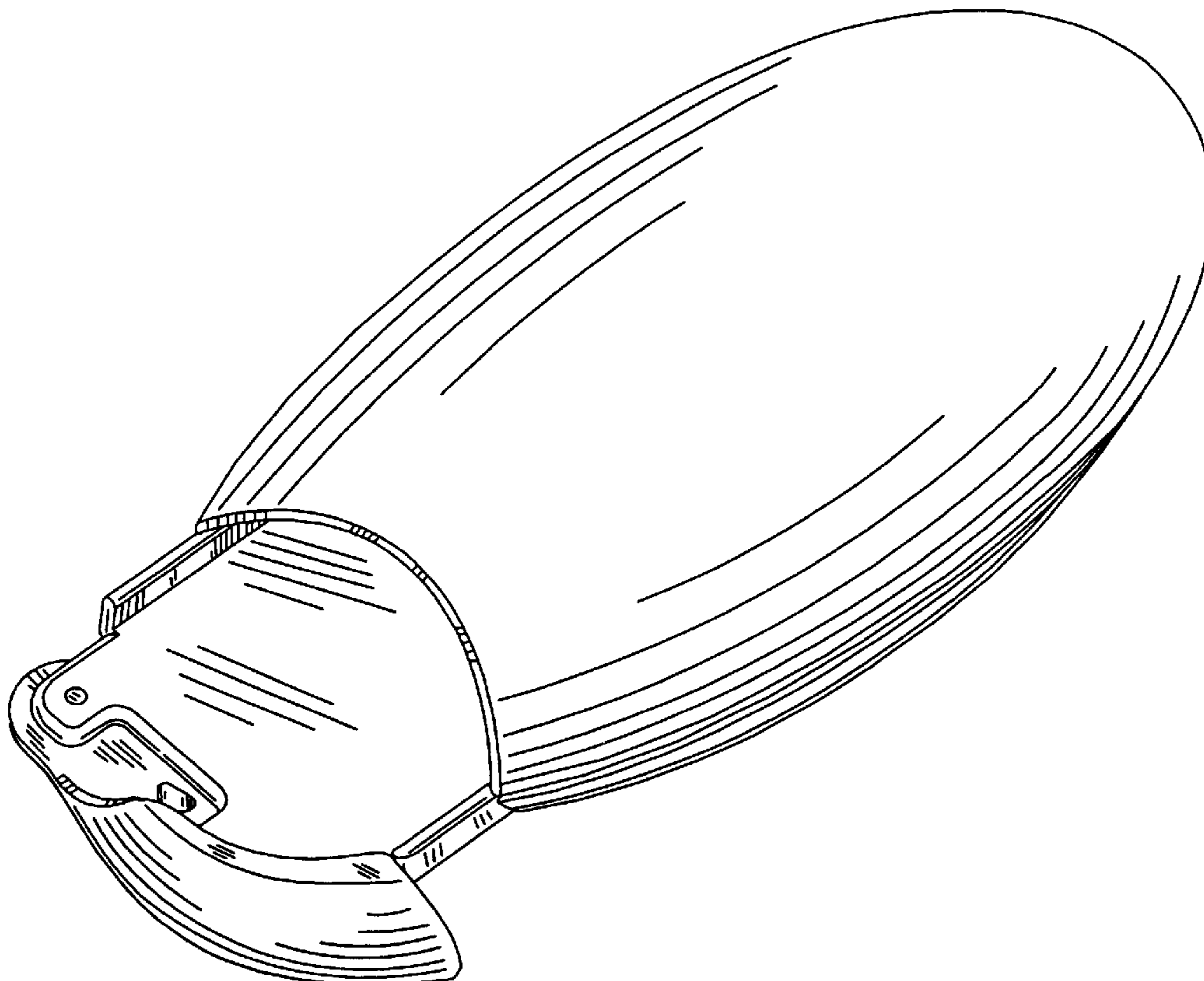

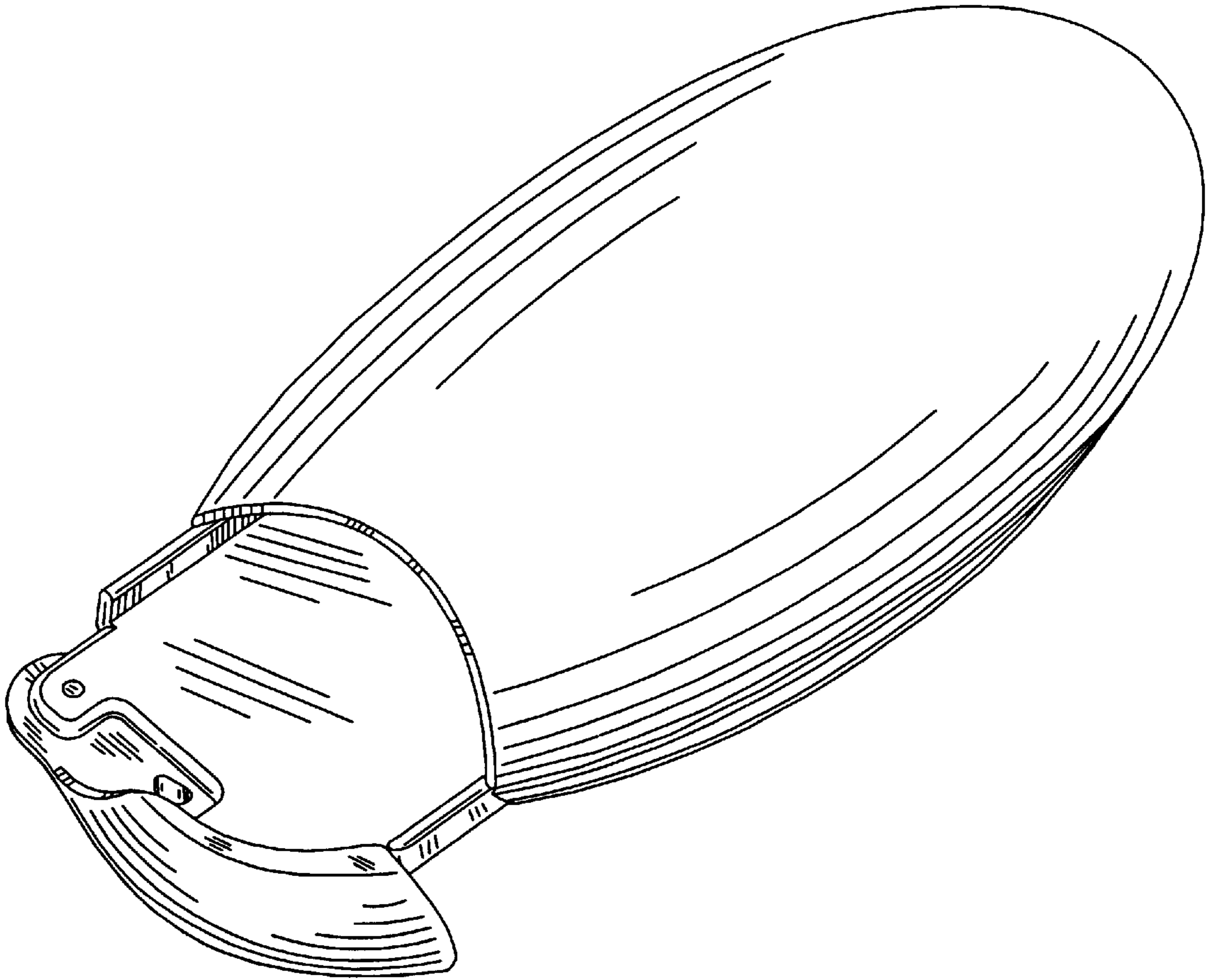

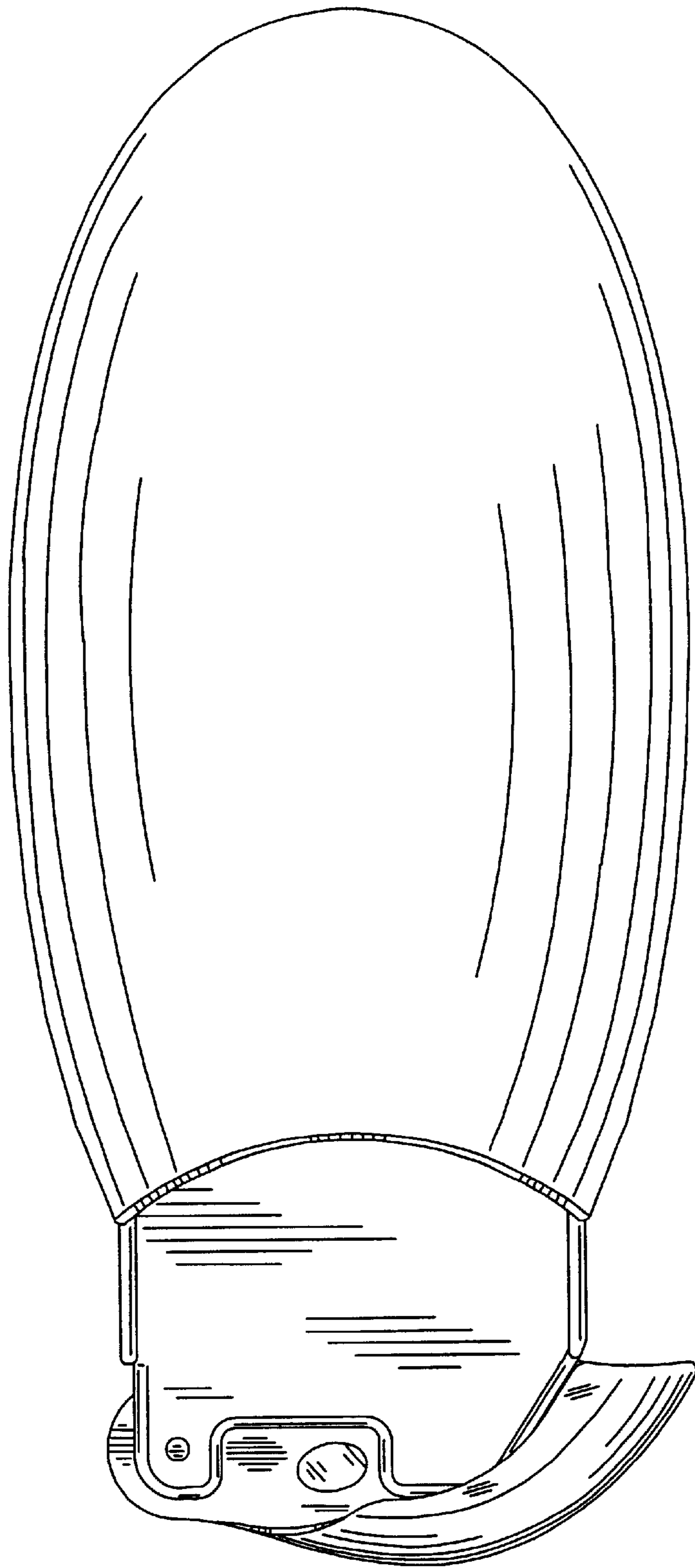

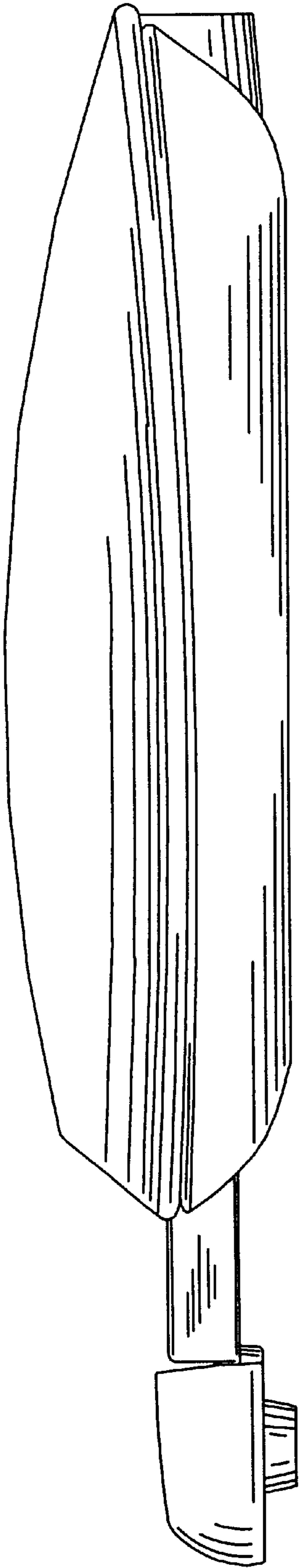

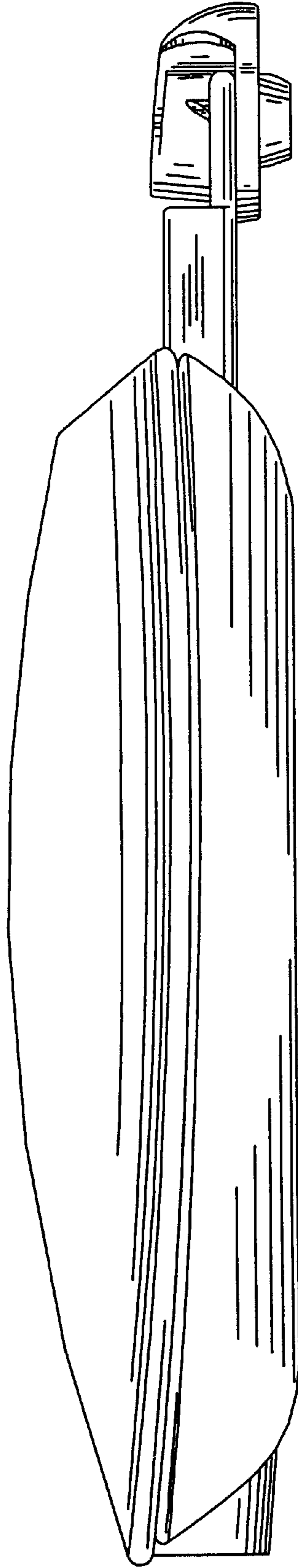

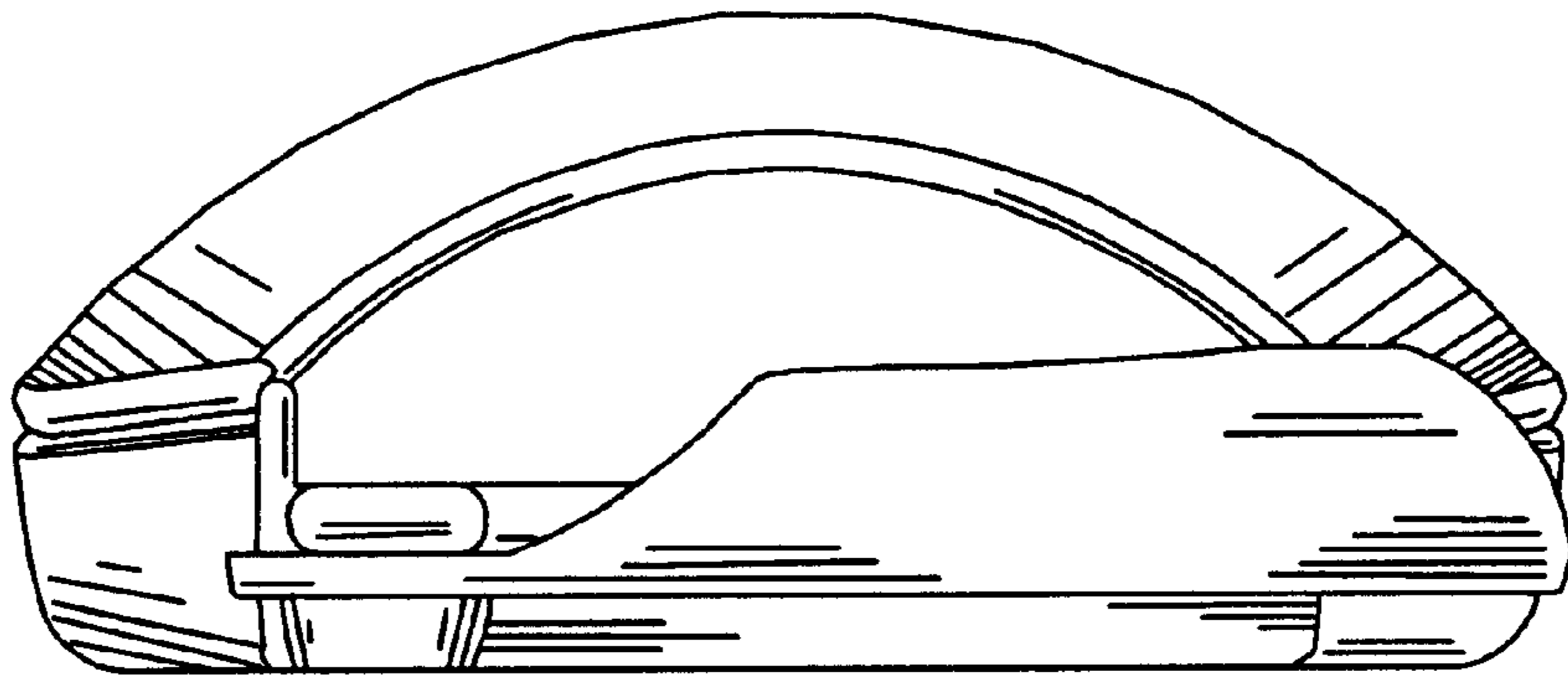

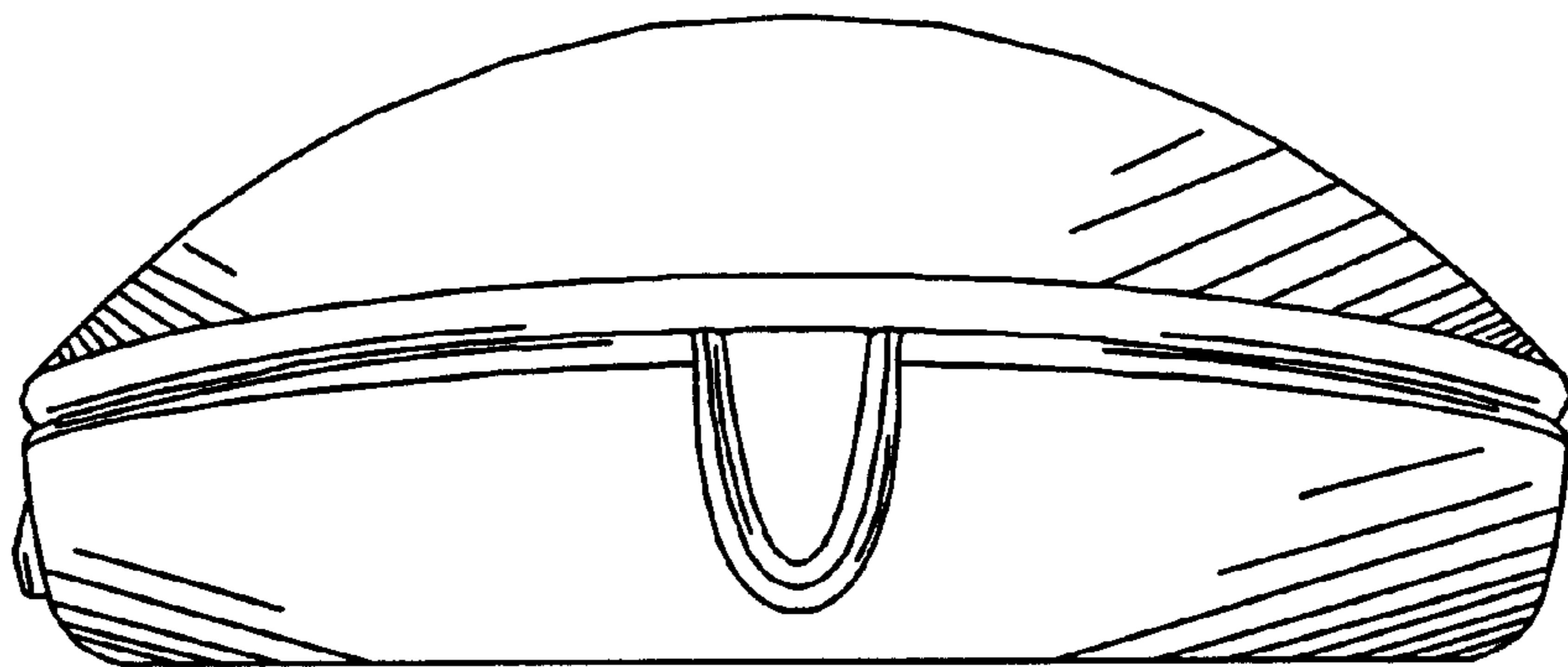

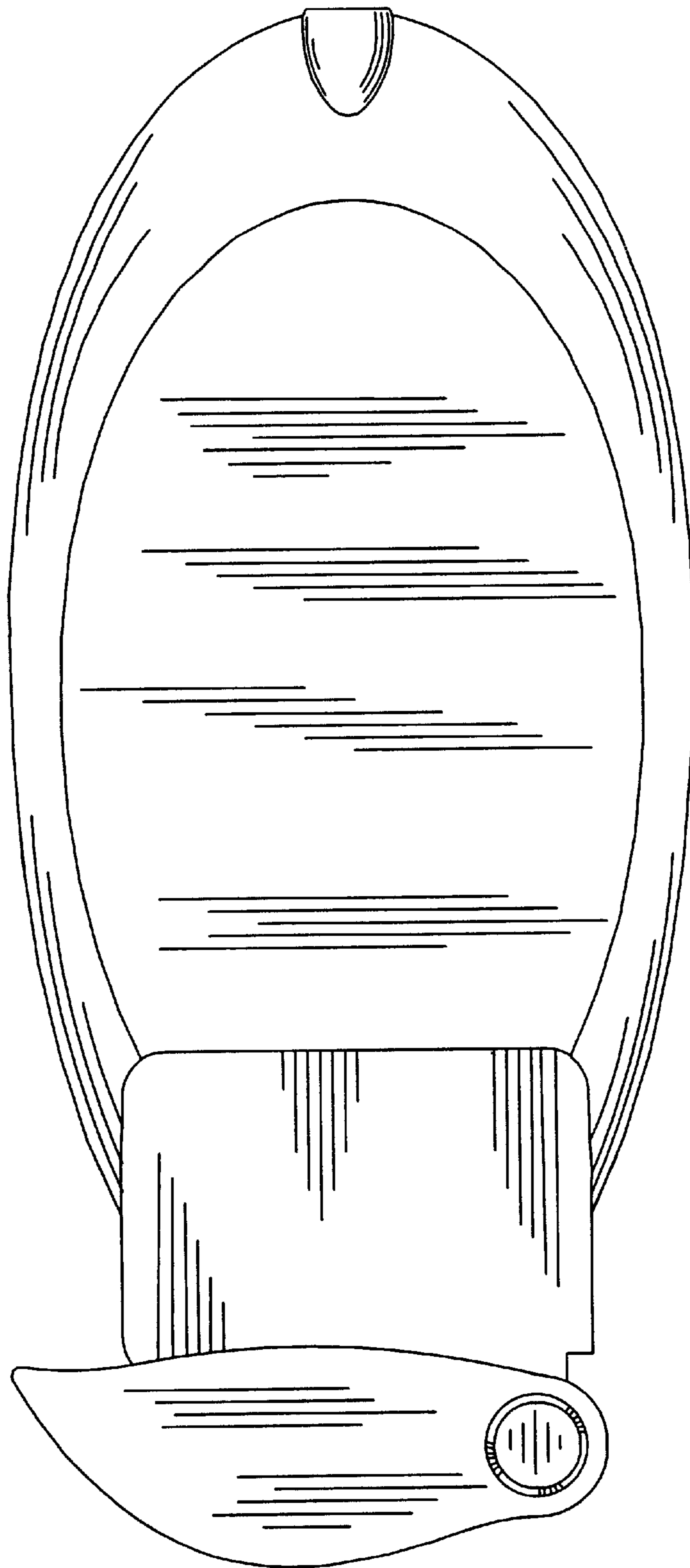
