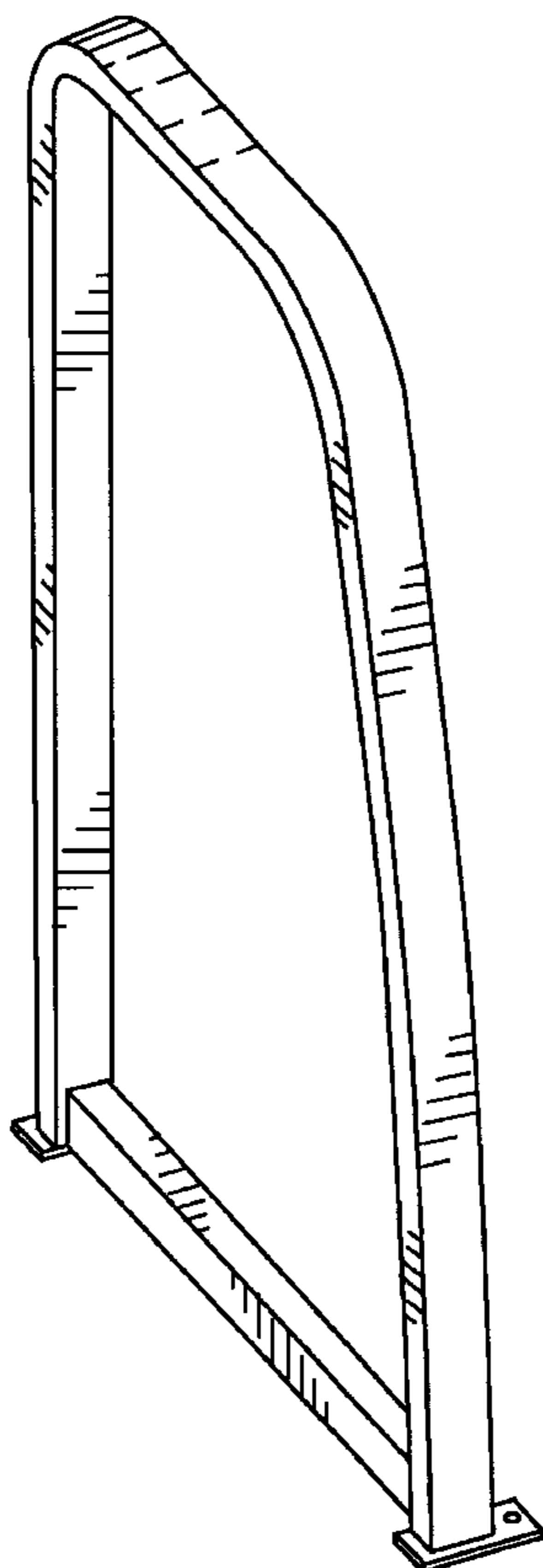

The ornamental design for a weight stack support frame, as shown.

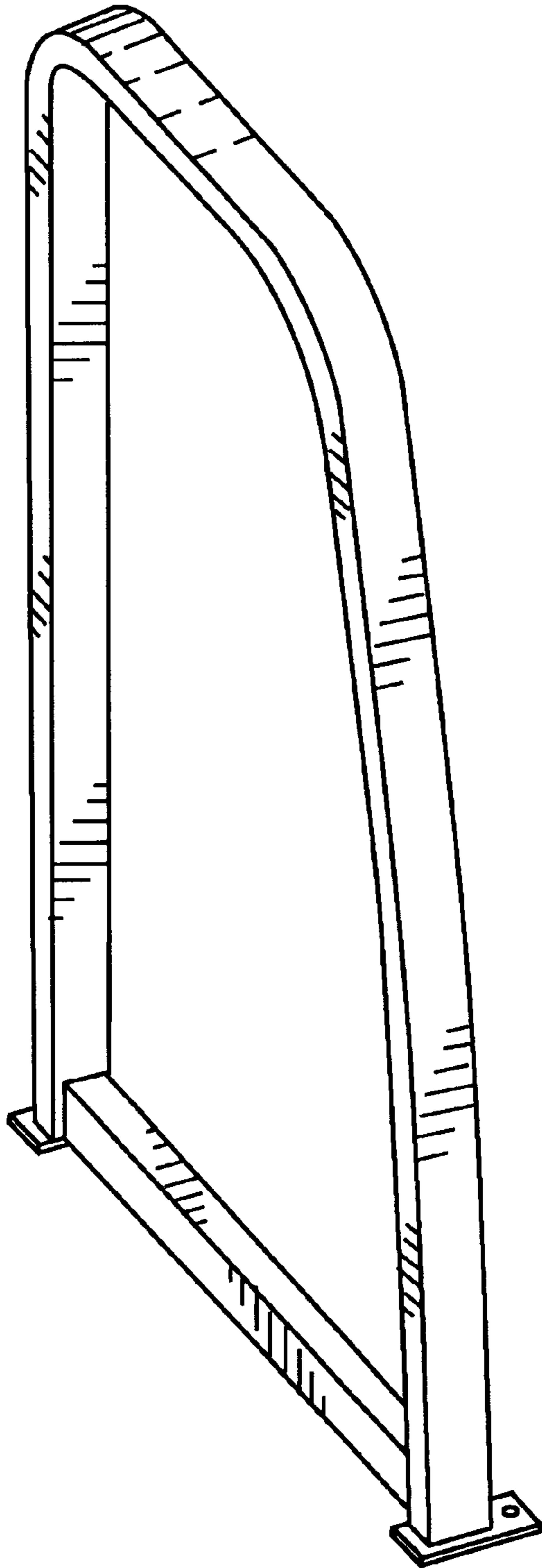
**DESCRIPTION**
