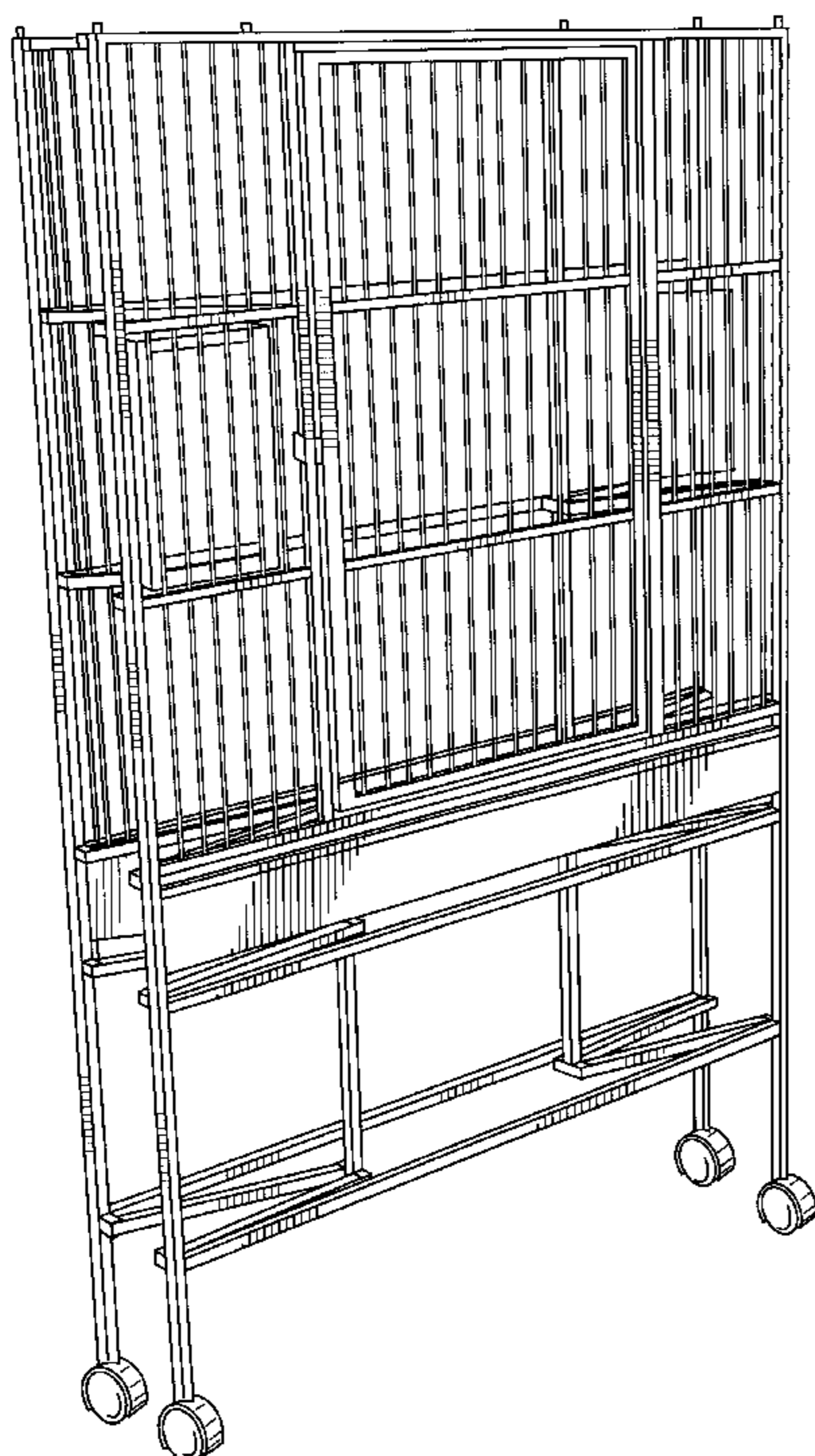
(57) **CLAIM**

I claim the ornamental design for a folding cage, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the folding cage shown in a folded position showing my new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a right side elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a left side elevational view thereof;
 FIG. 8 is another front perspective view of the folding cage shown in an unfolded position;
 FIG. 9 is a front elevational view of FIG. 8;
 FIG. 10 is a right side elevational view of FIG. 8;
 FIG. 11 is a rear elevational view of FIG. 8;
 FIG. 12 is a left side elevational view of FIG. 8;
 FIG. 13 is a top plan view of FIG. 8; and,
 FIG. 14 is a bottom plan view of FIG. 8.

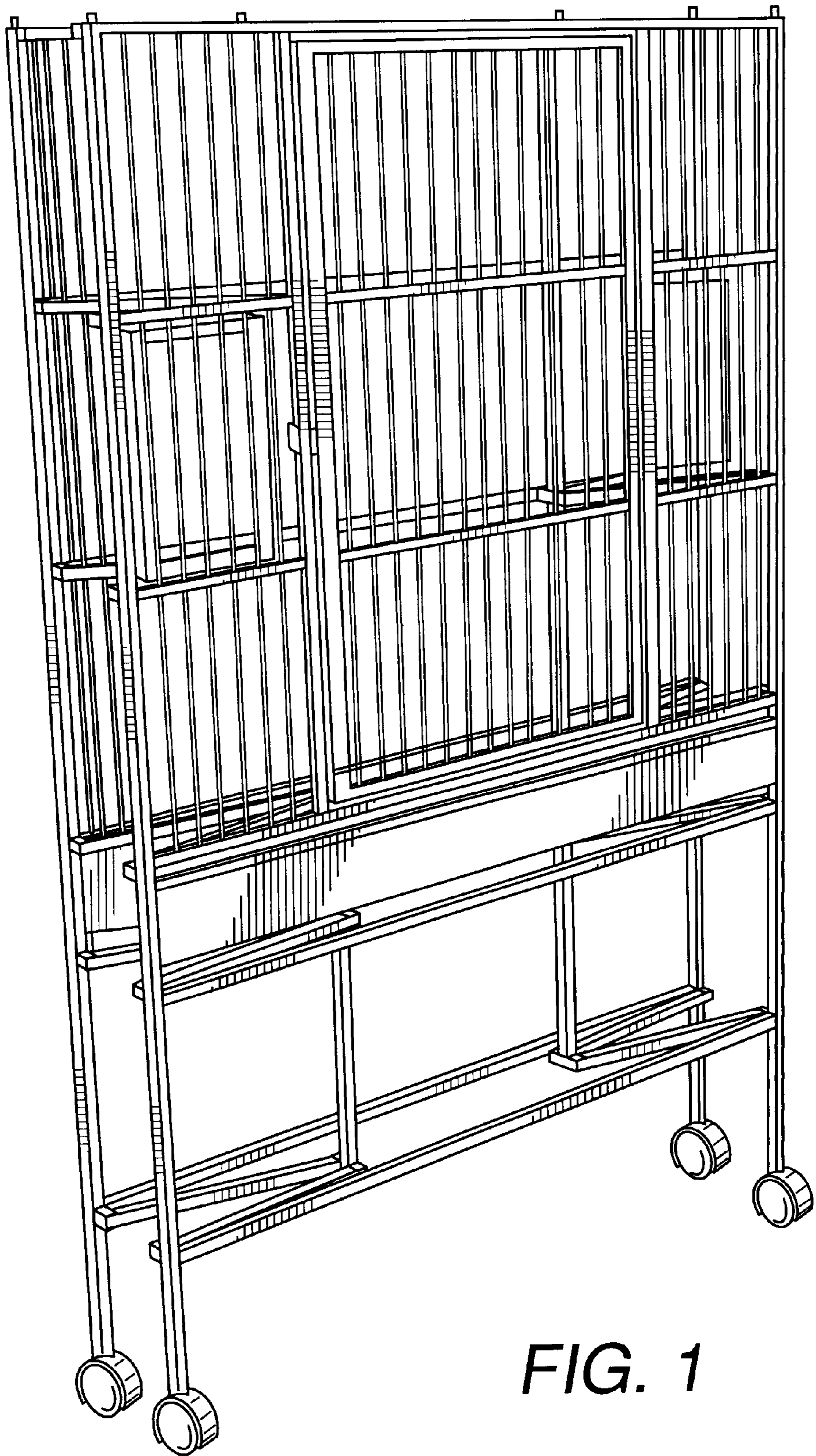

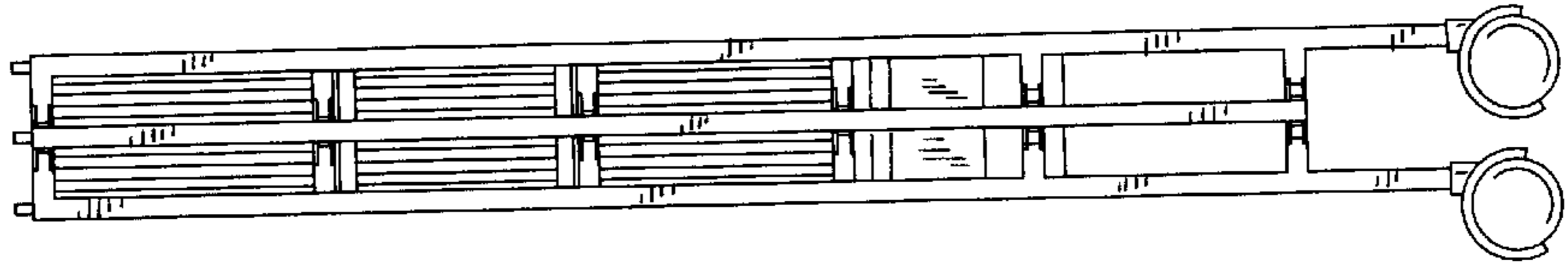

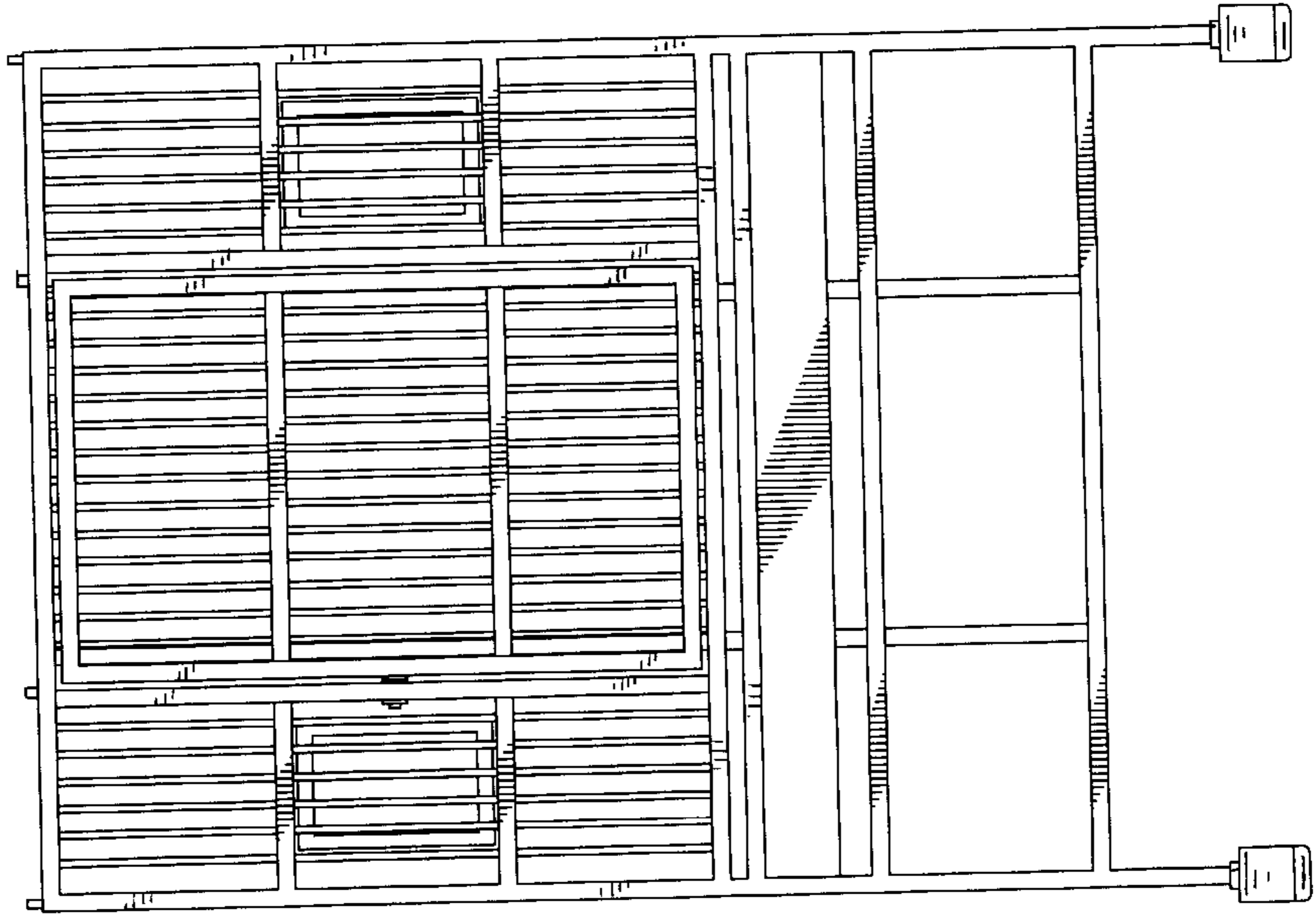

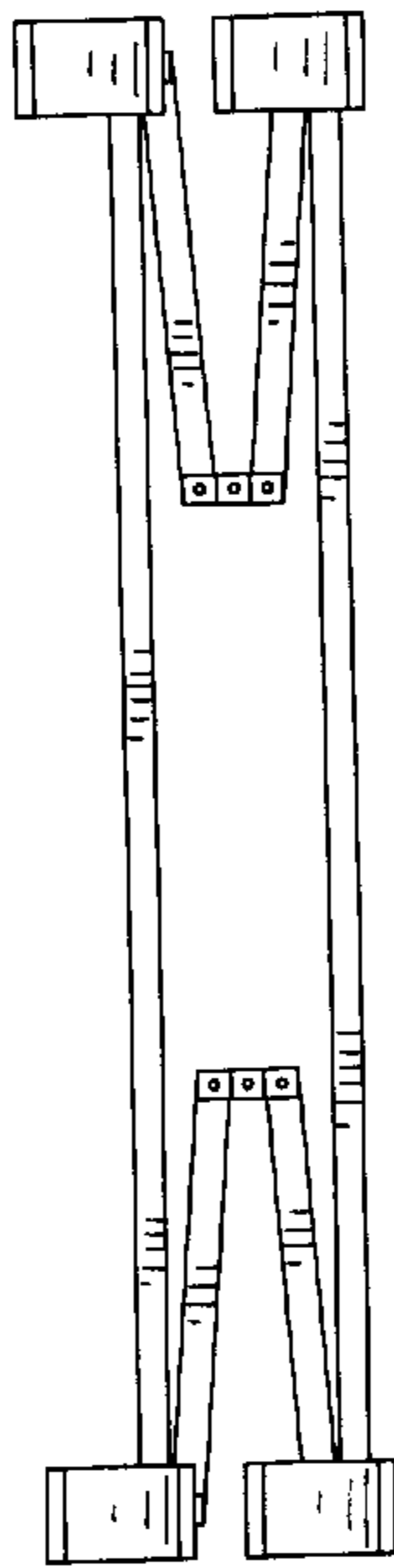

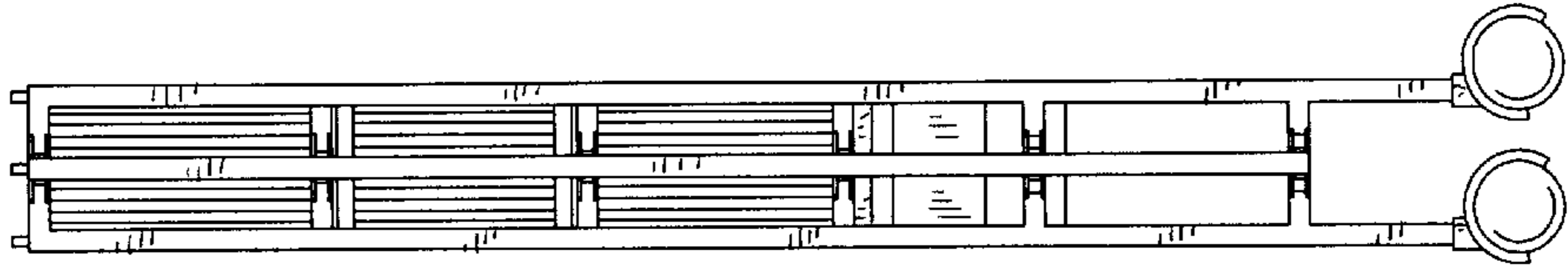

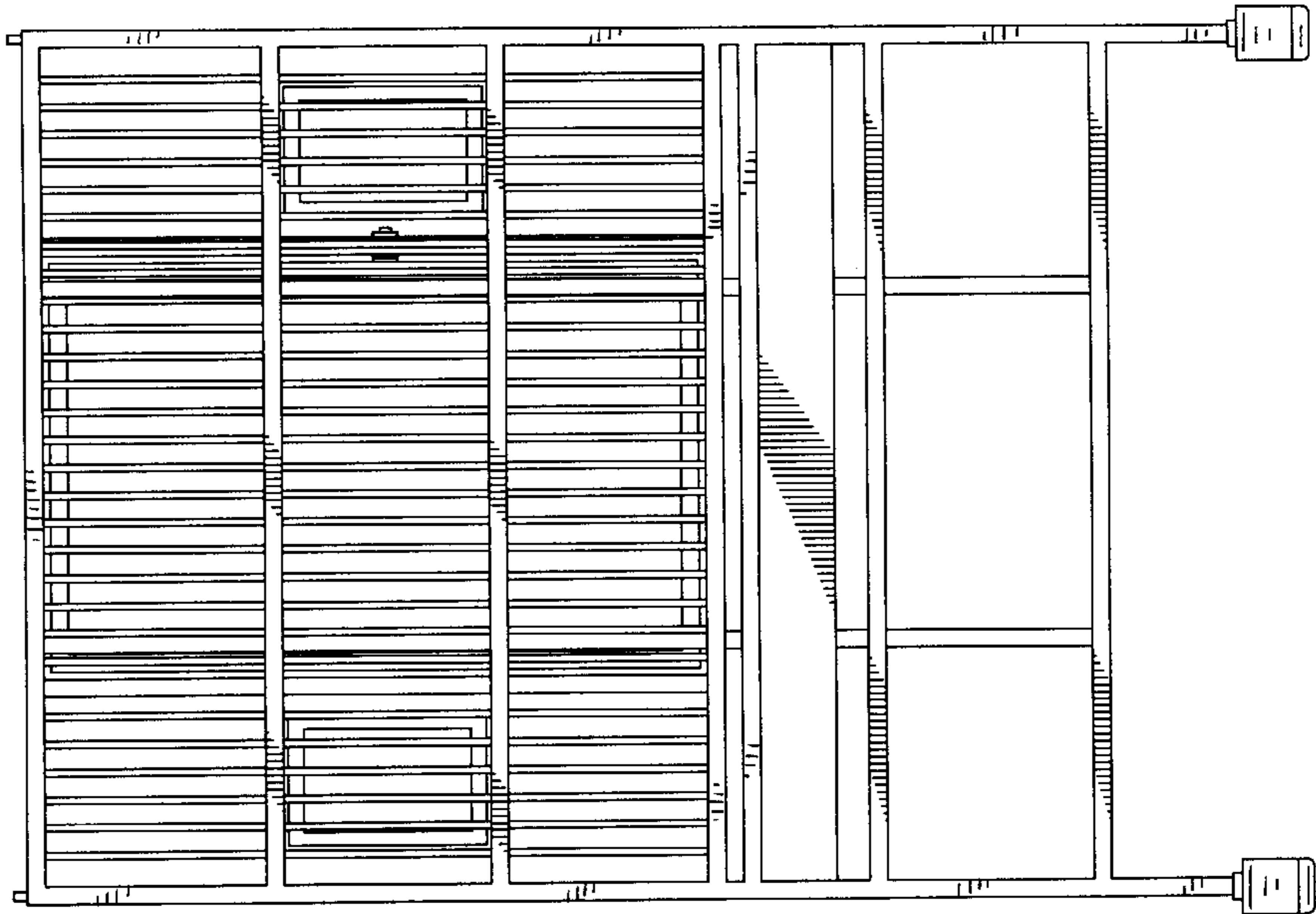

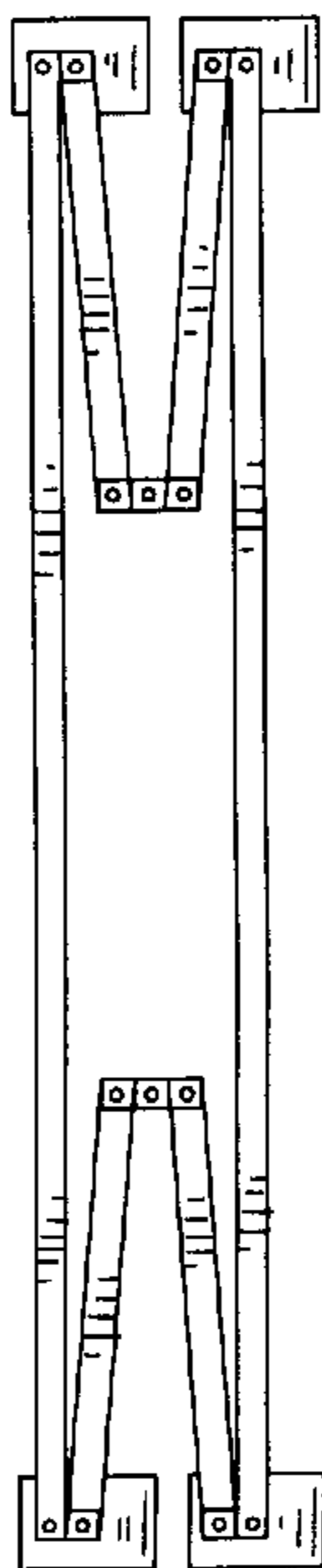

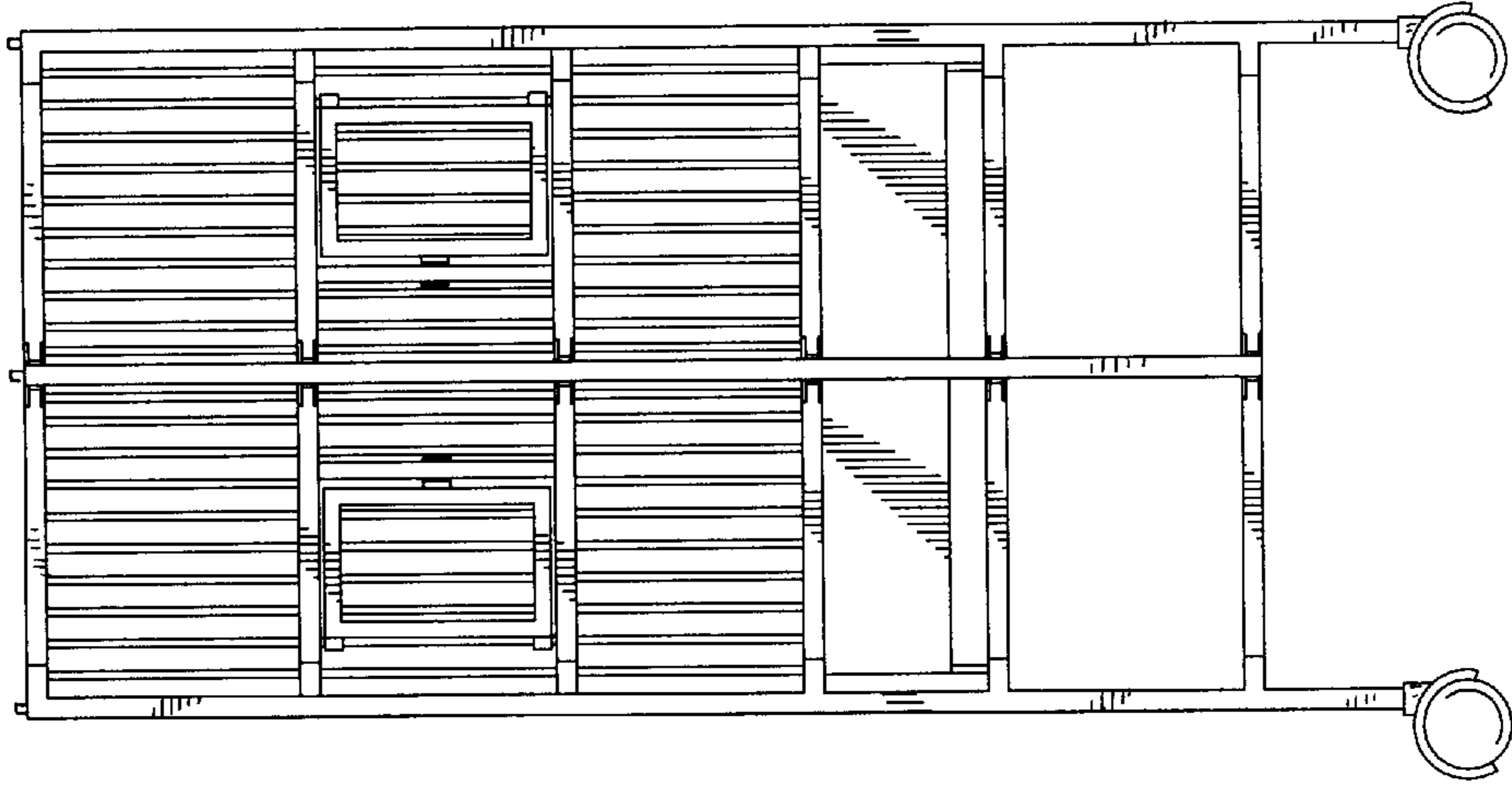

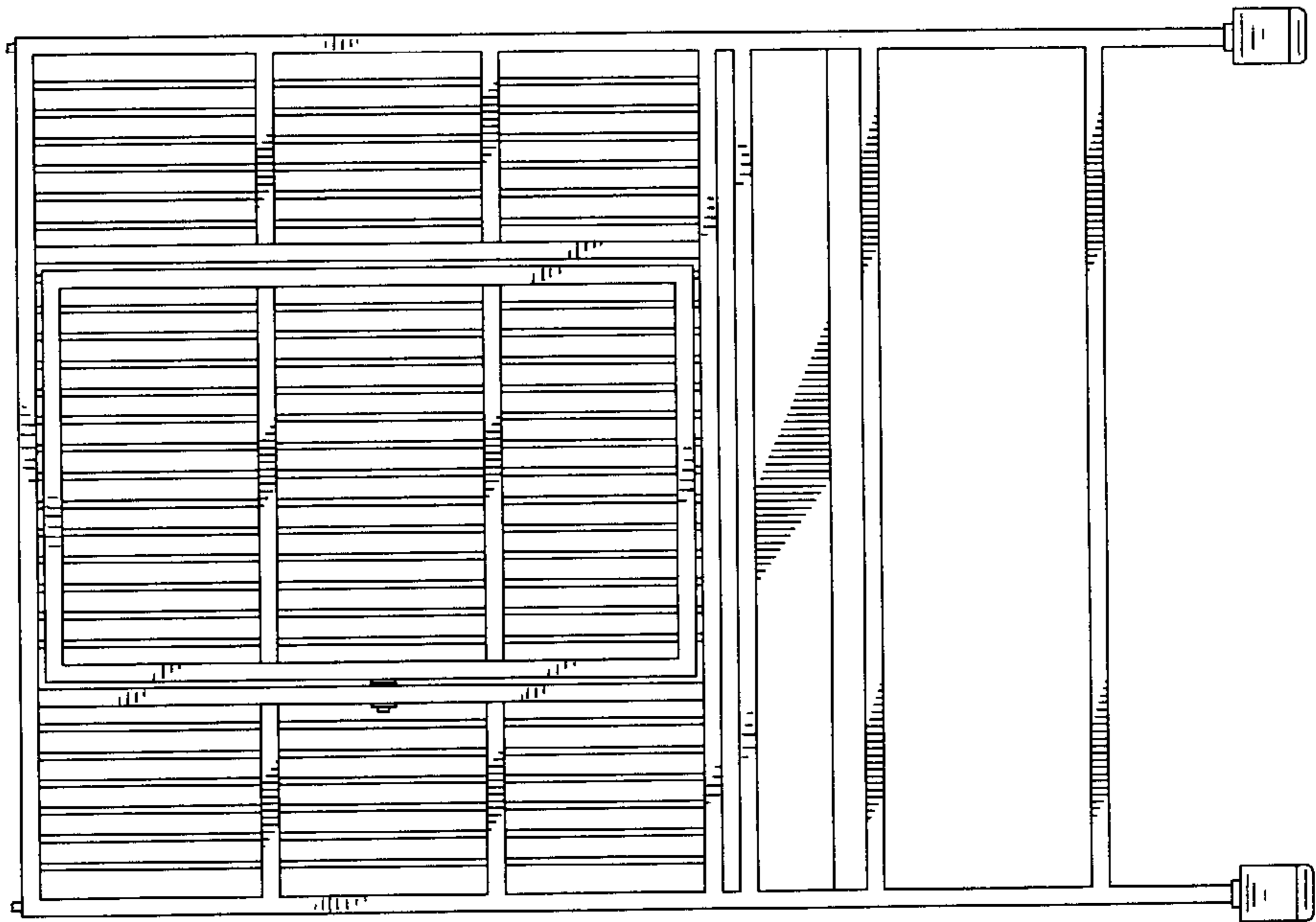

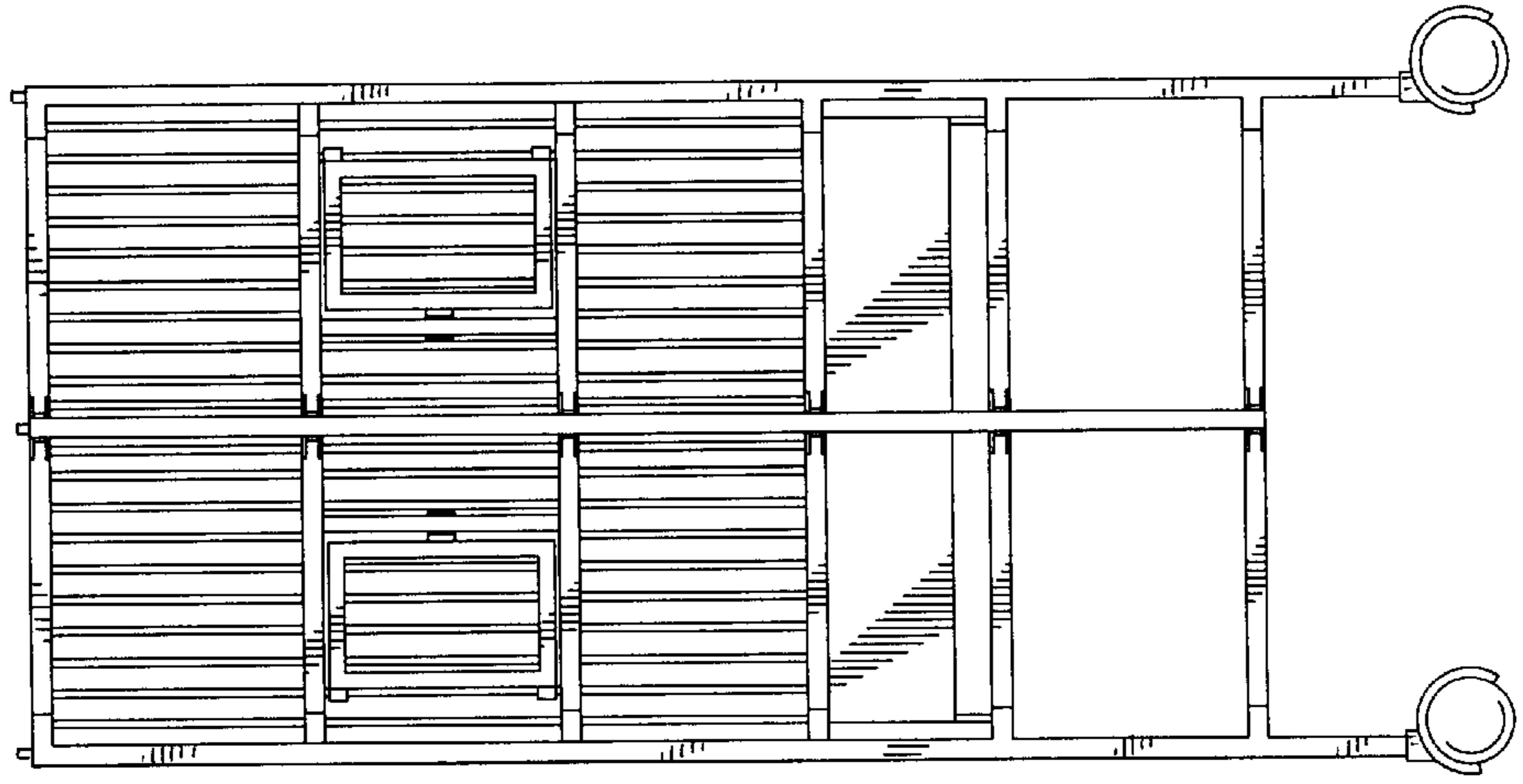
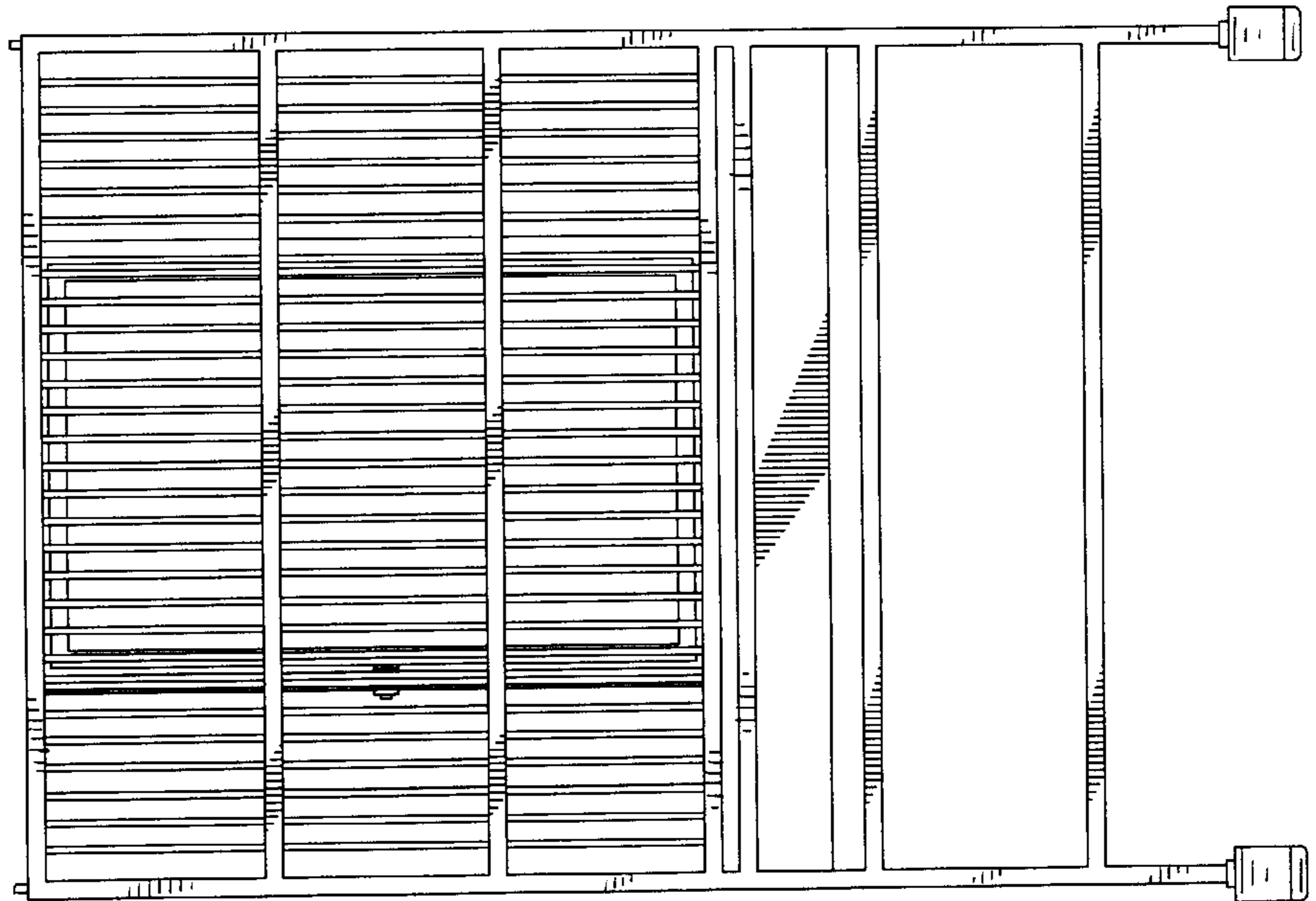

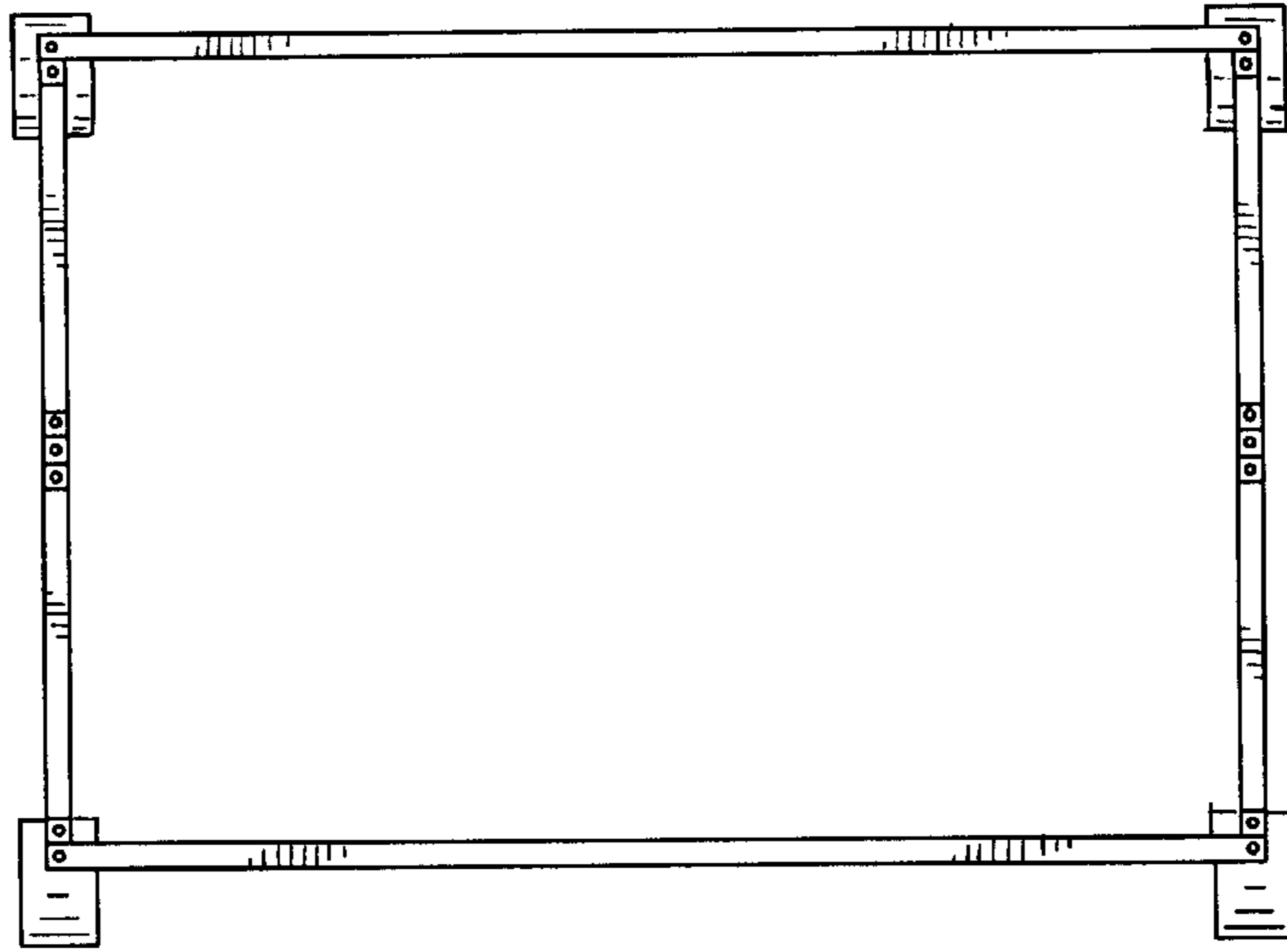

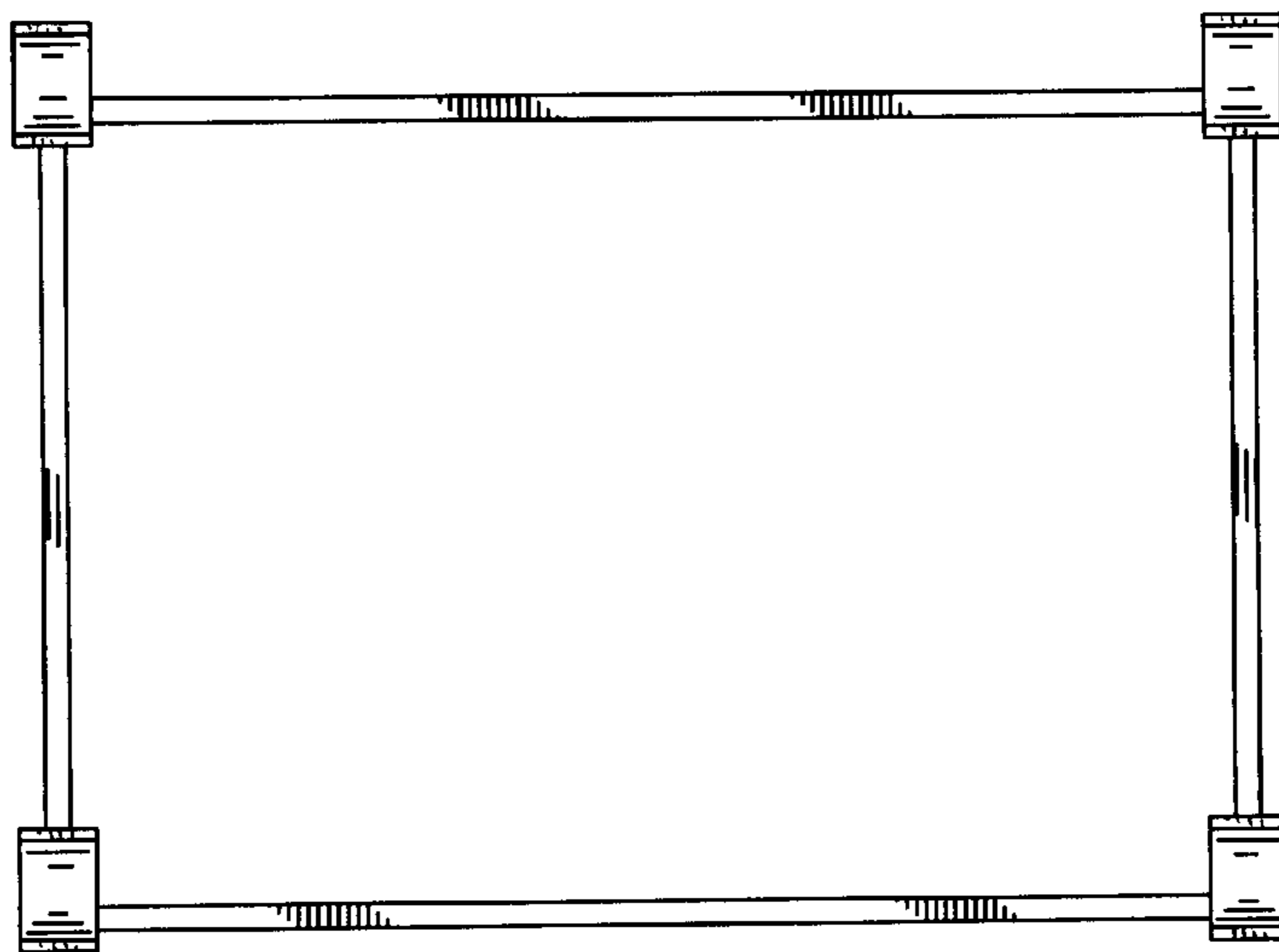
