FIG. 6 is a right side perspective view thereof, the left side perspective view being a mirror image thereof.

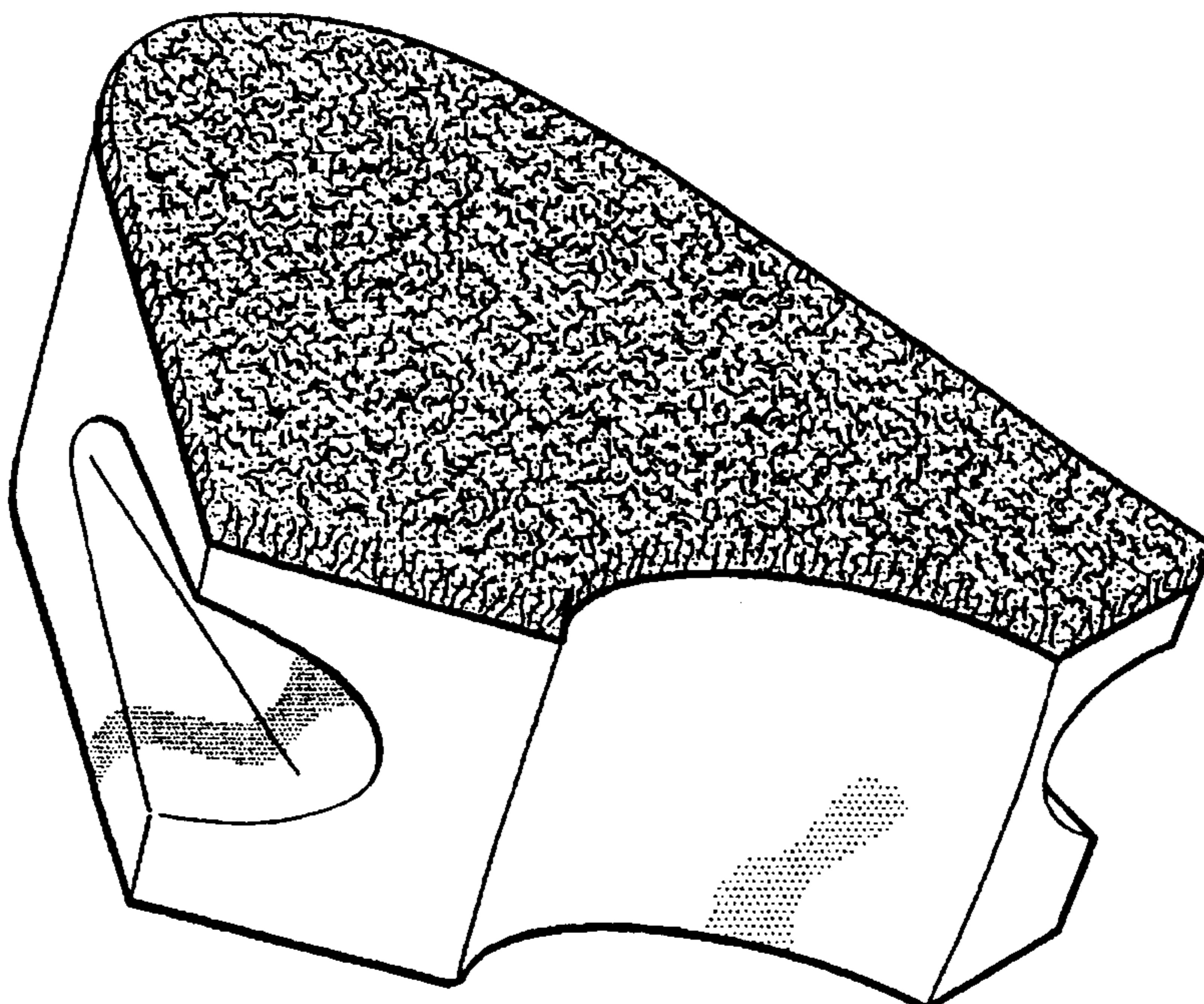

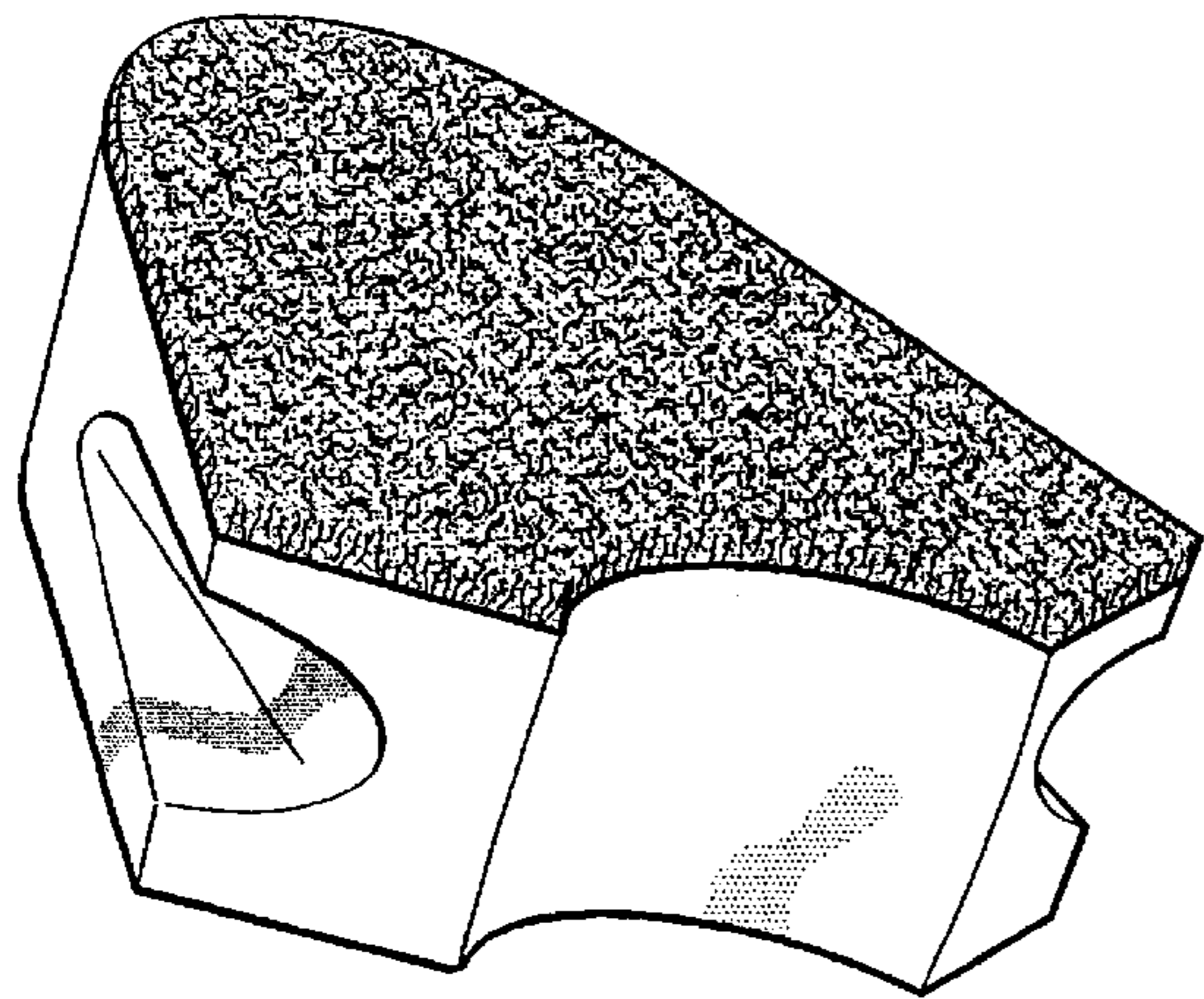

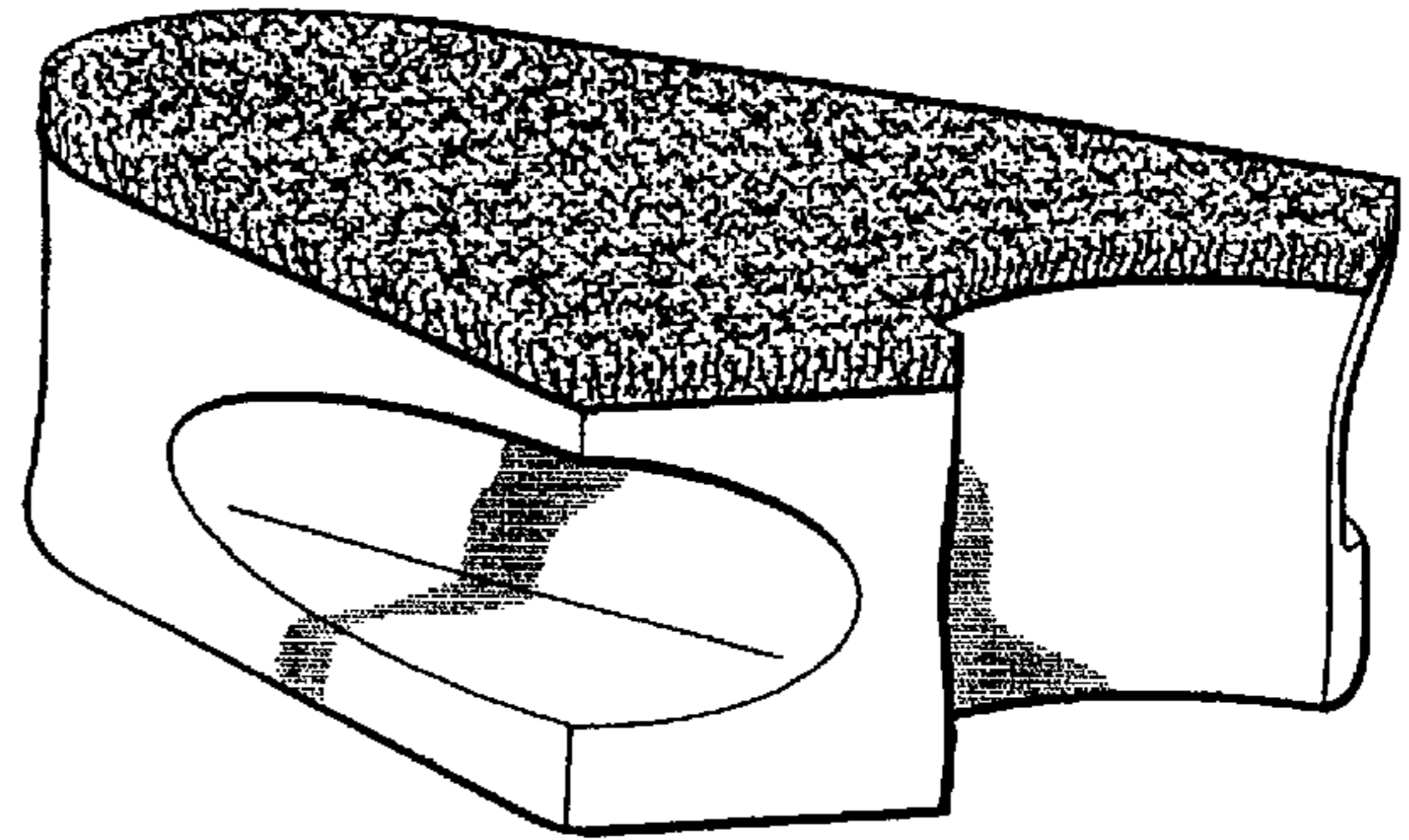

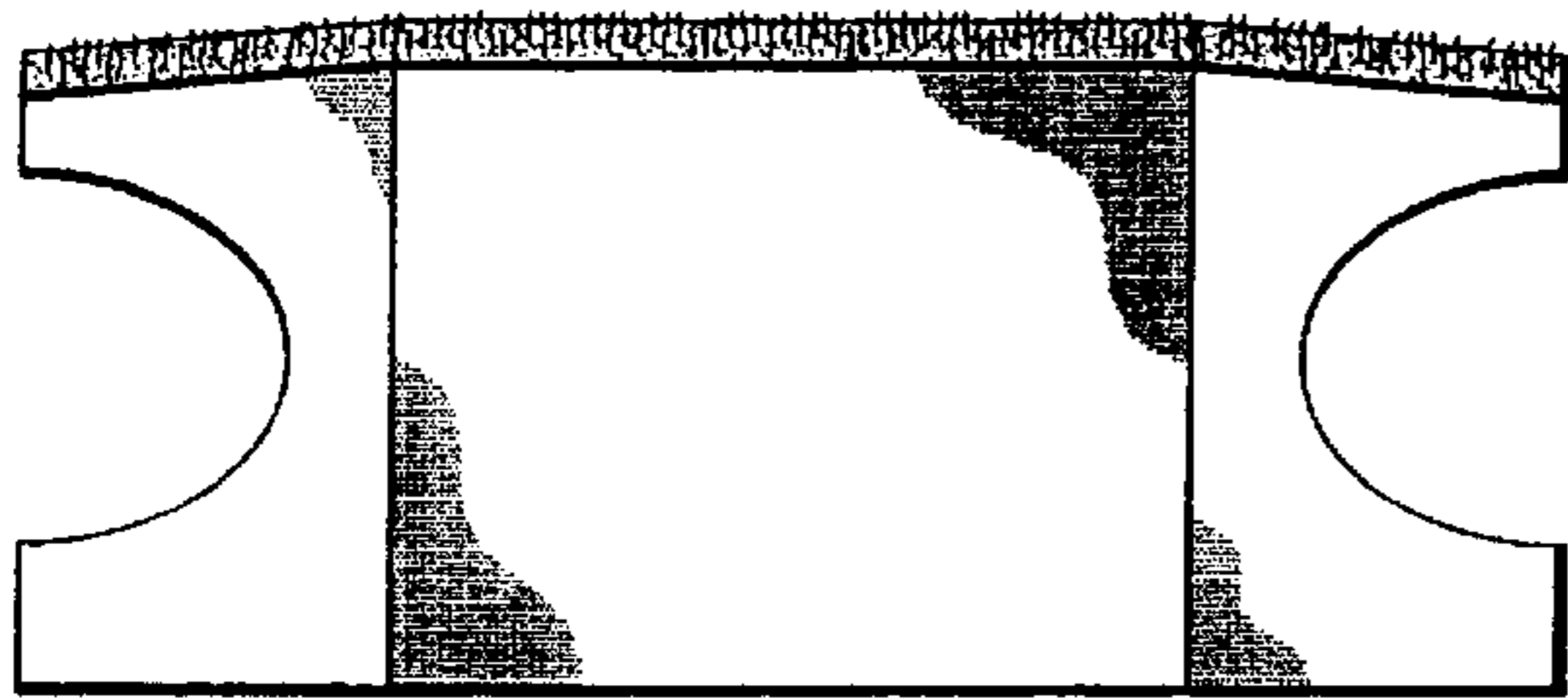

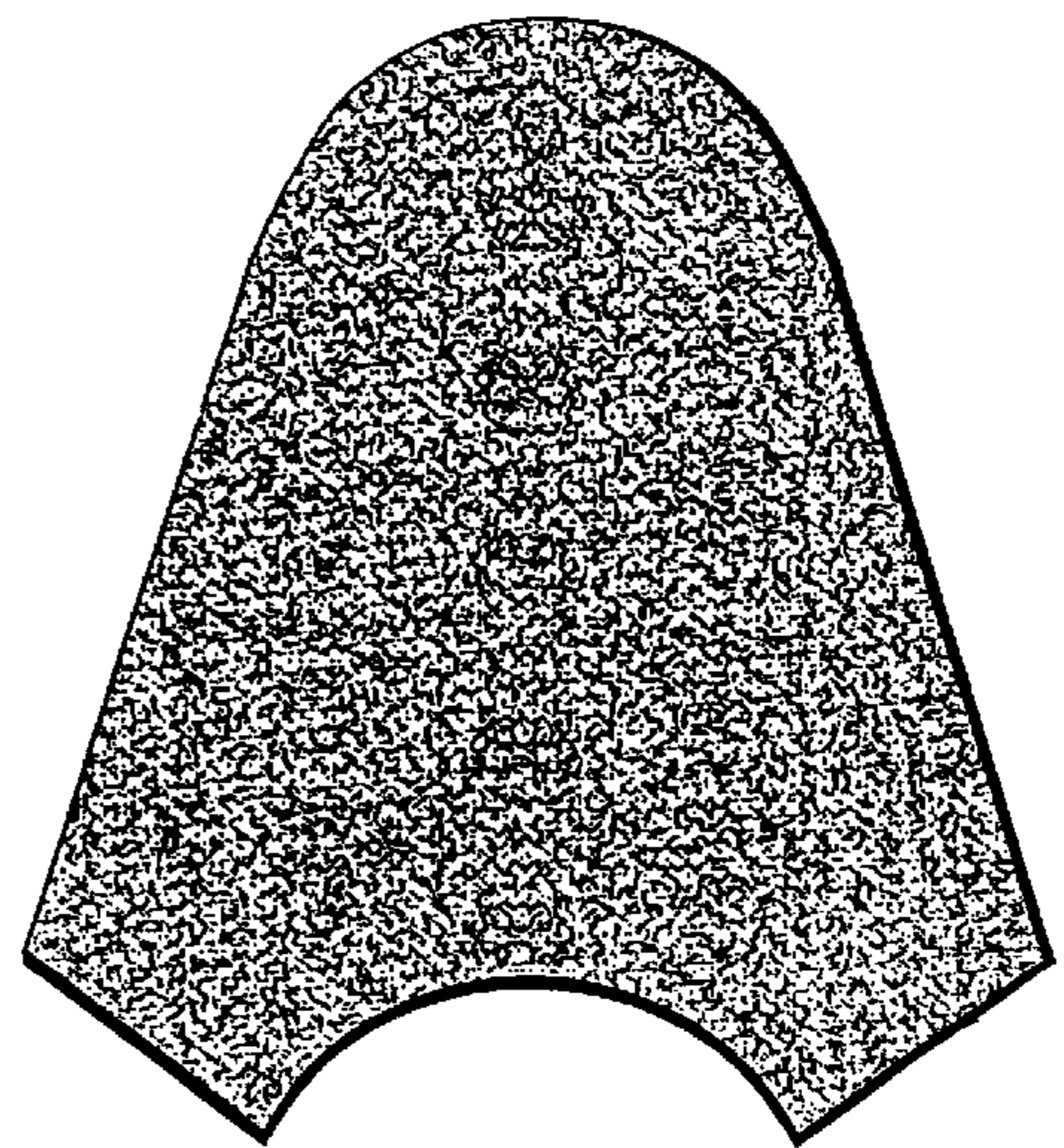

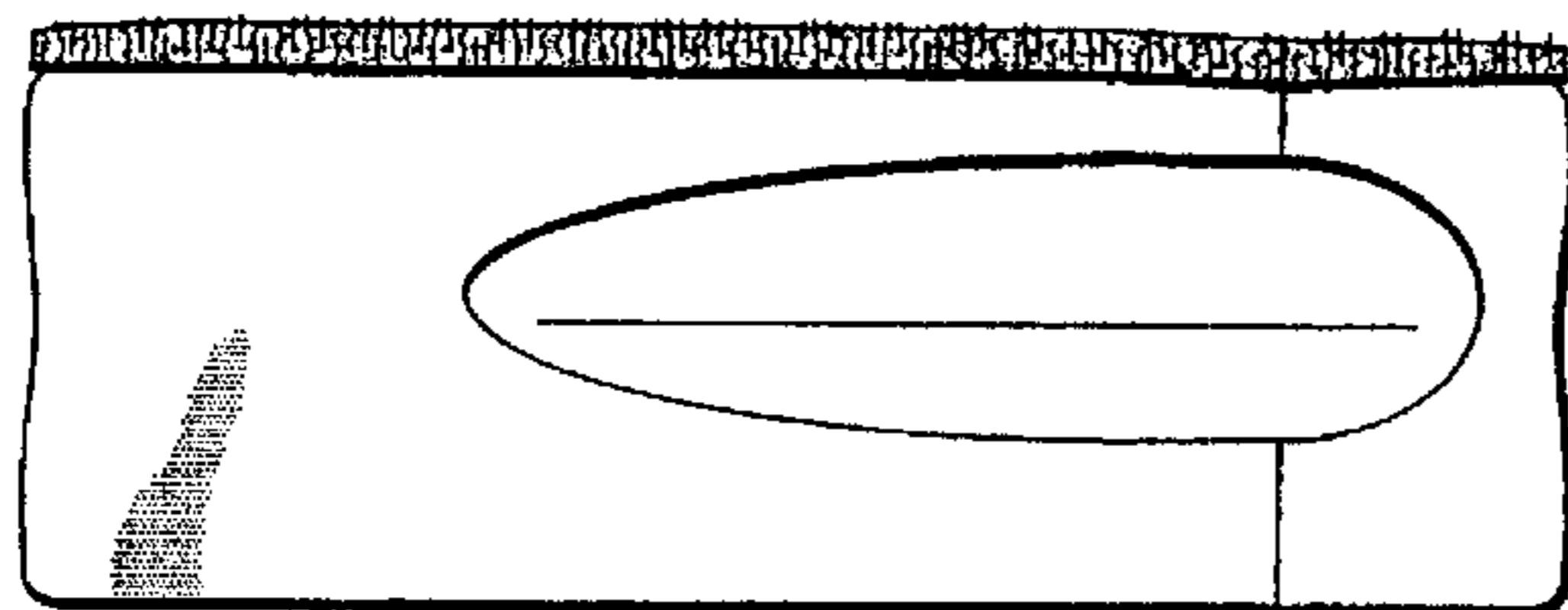

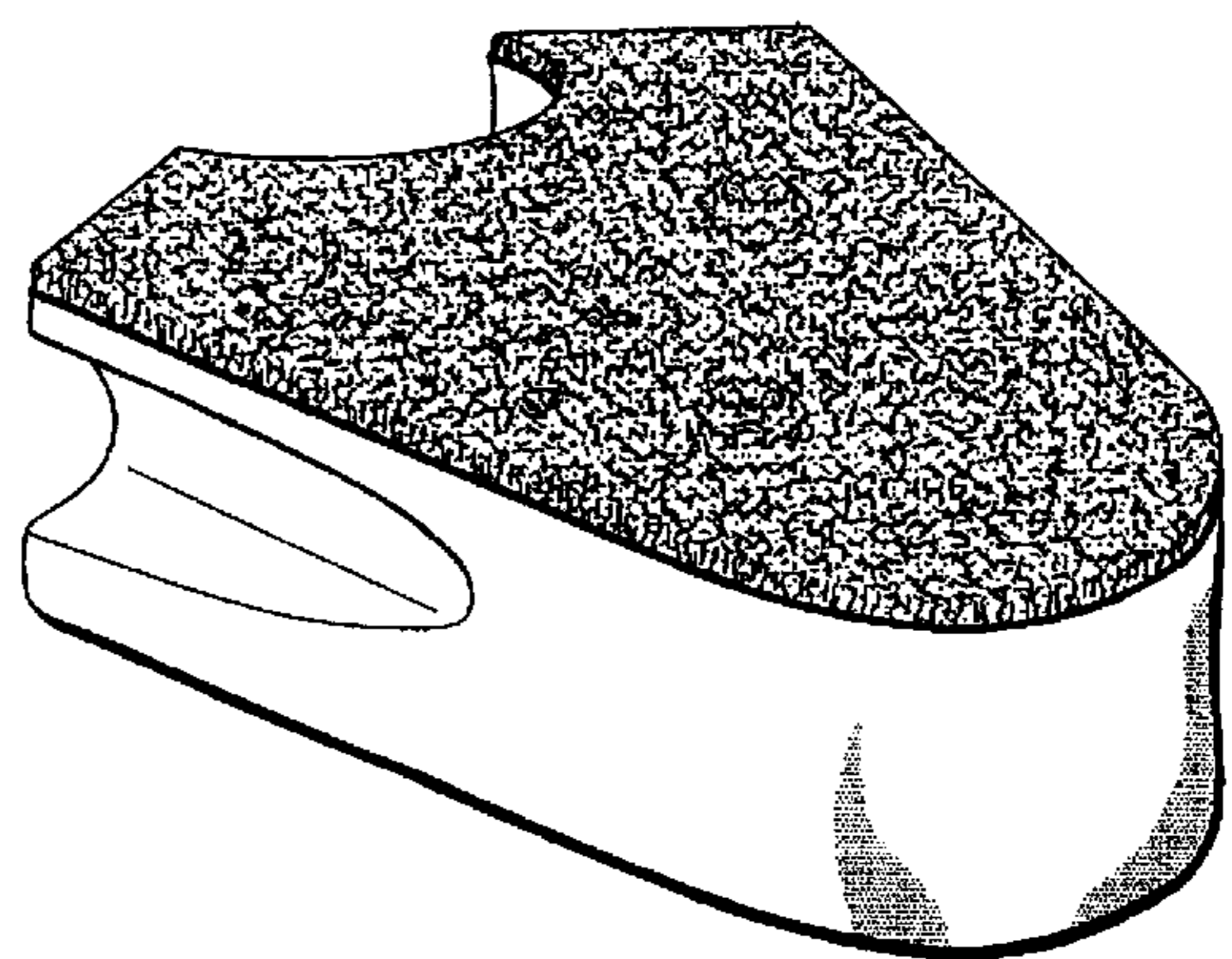
