(57) **CLAIM**

We claim the ornamental design for a golf club carrying device, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a golf club carrying device, according to the present invention; FIG. 2 is a front view of the golf club carrying device of FIG. 1; FIG. 3 is a side view of the golf club carrying device of FIG. 1; FIG. 4 is a rear view of the golf club carrying device of FIG. 1; FIG. 5 is a top view of the golf club carrying device of FIG. 1; and, FIG. 6 is a bottom view of the golf club carrying device of FIG. 1.

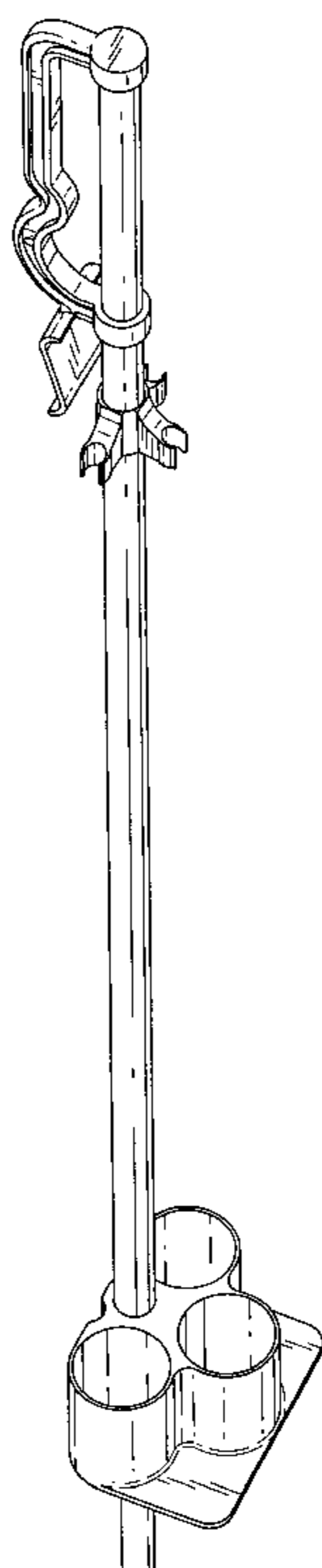

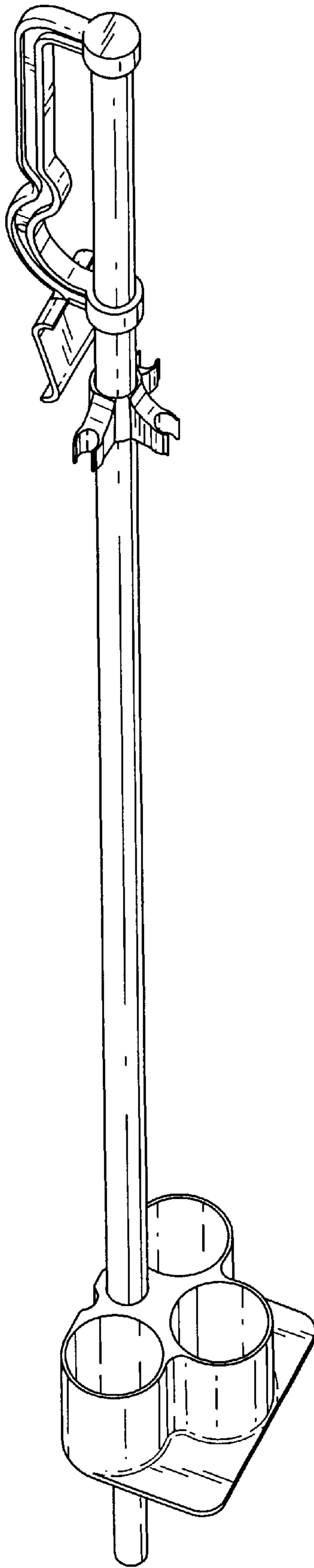

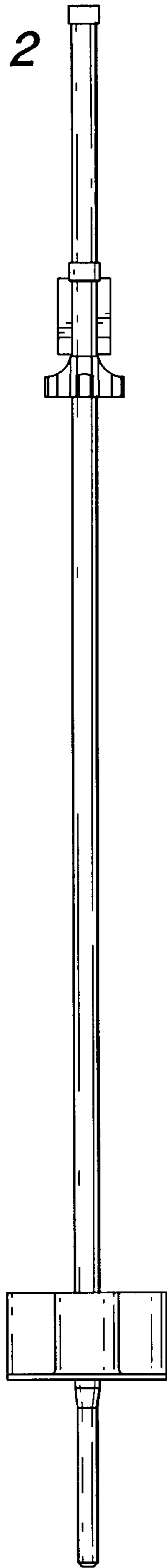

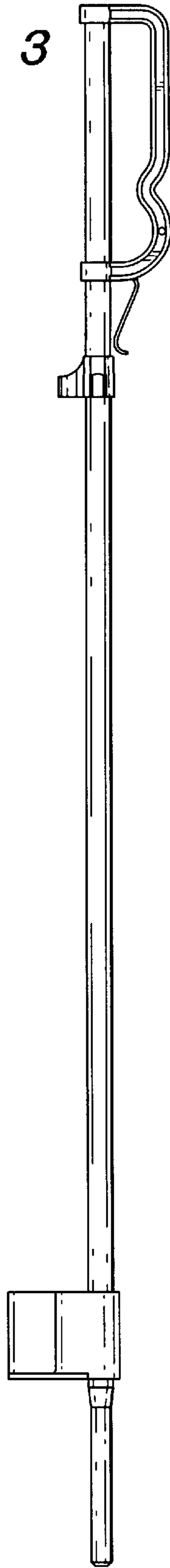

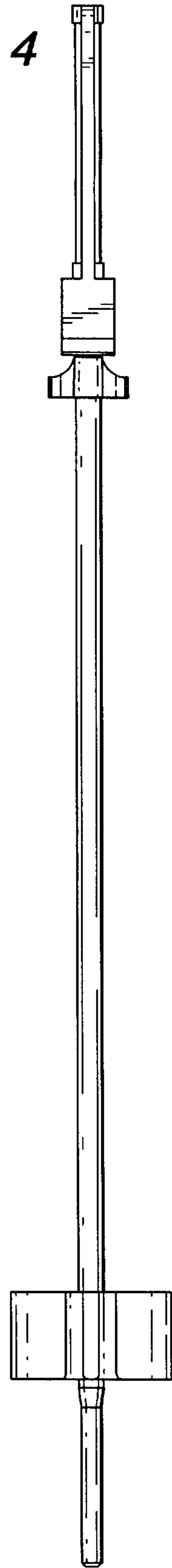

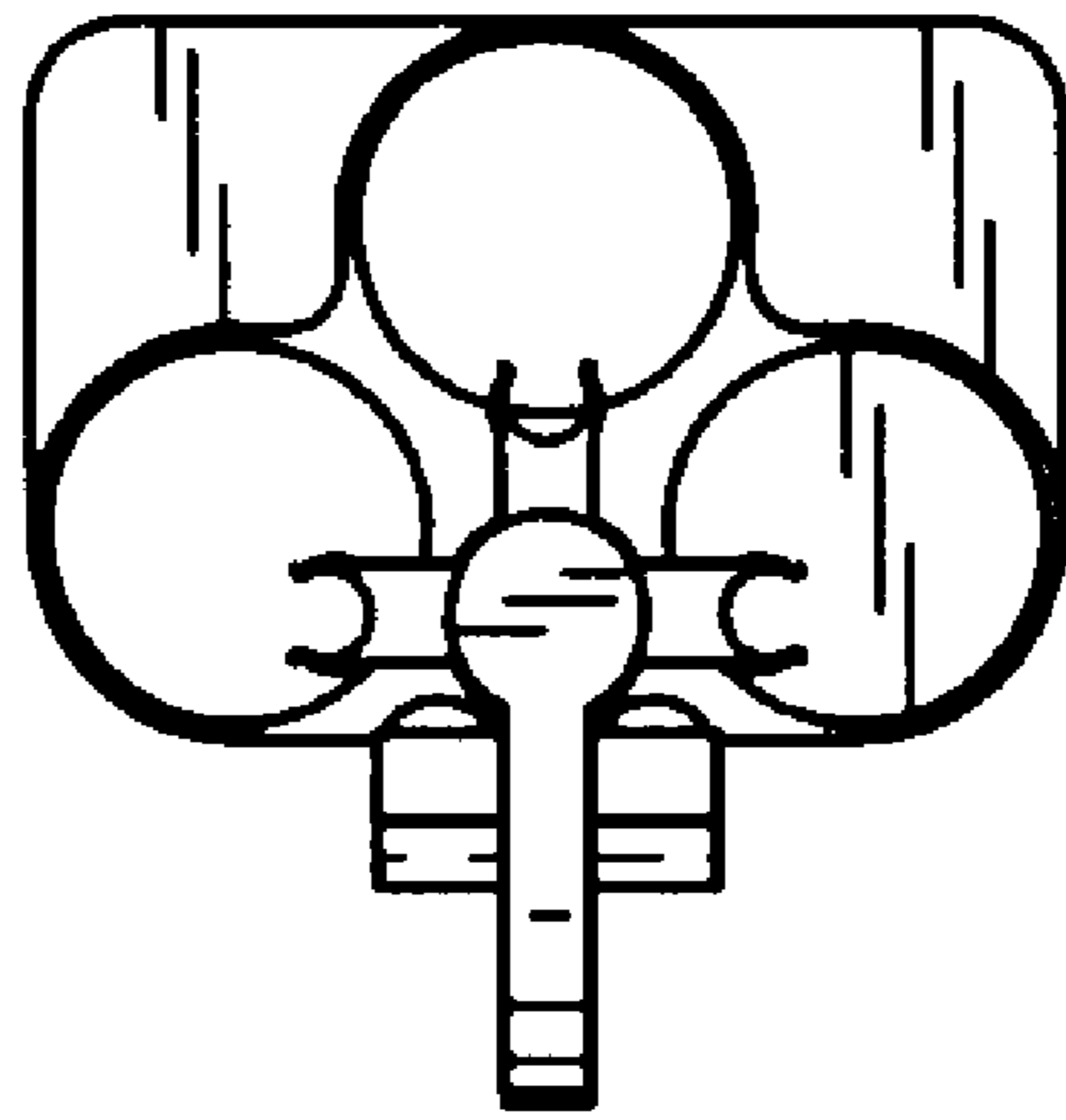
