(57) **CLAIM**

The ornamental design for a dresser, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a dresser showing my new design;

FIG. 2 is a side elevational view, the opposite side being a mirror image thereof;

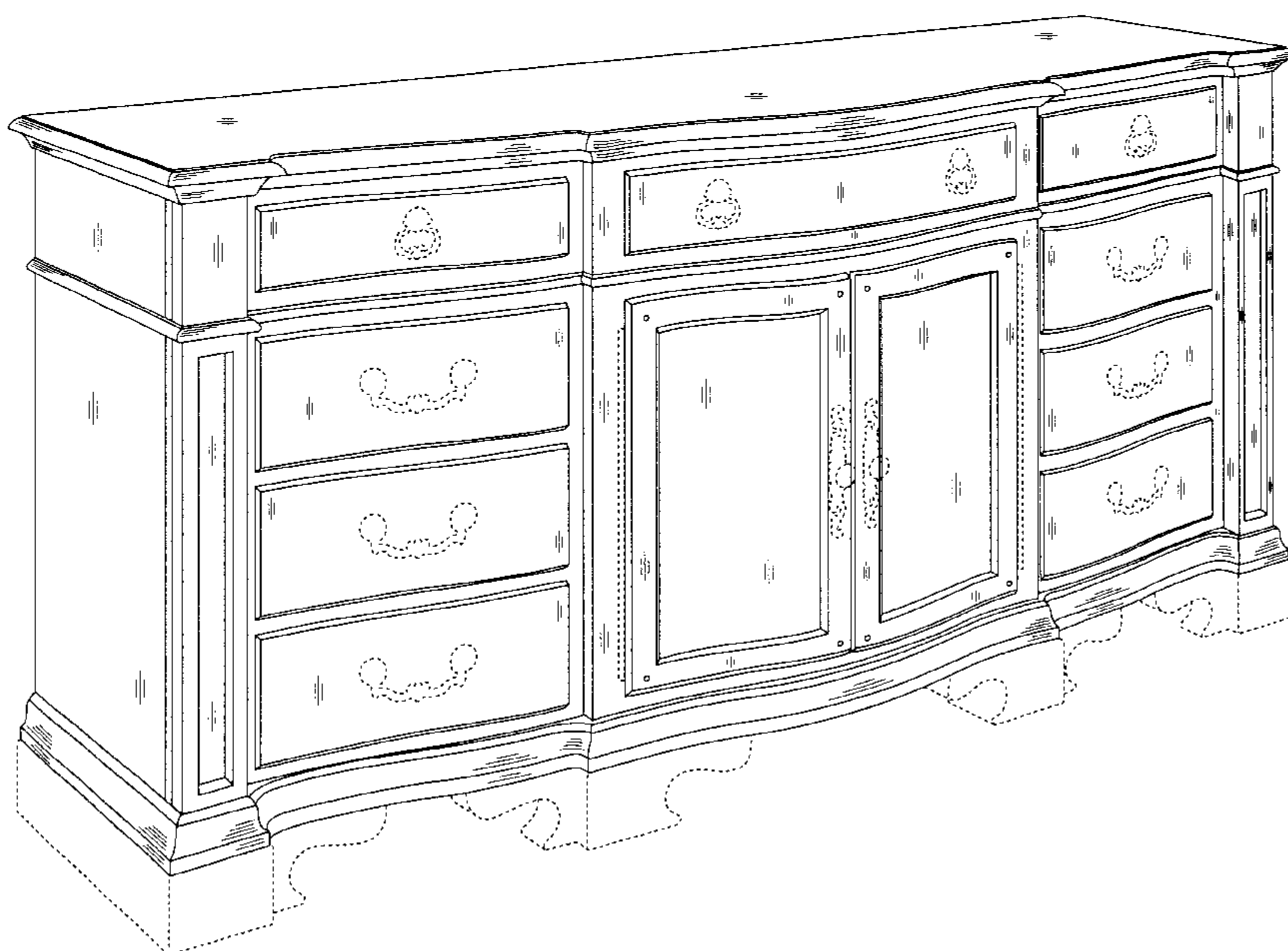
FIG. 3 is a front elevational view thereof;

FIG. 4 is a top view thereof; and,

FIG. 5 is an additional left front perspective view thereof, showing rectangular drawer ornamentation in dashed lines.

The view of the dresser not shown form no part of the claimed design. The dashed lines depicting hardware, feet, feet bar and drawer rectangular ornamentation represent environmental elements only and form no part of the claimed design.

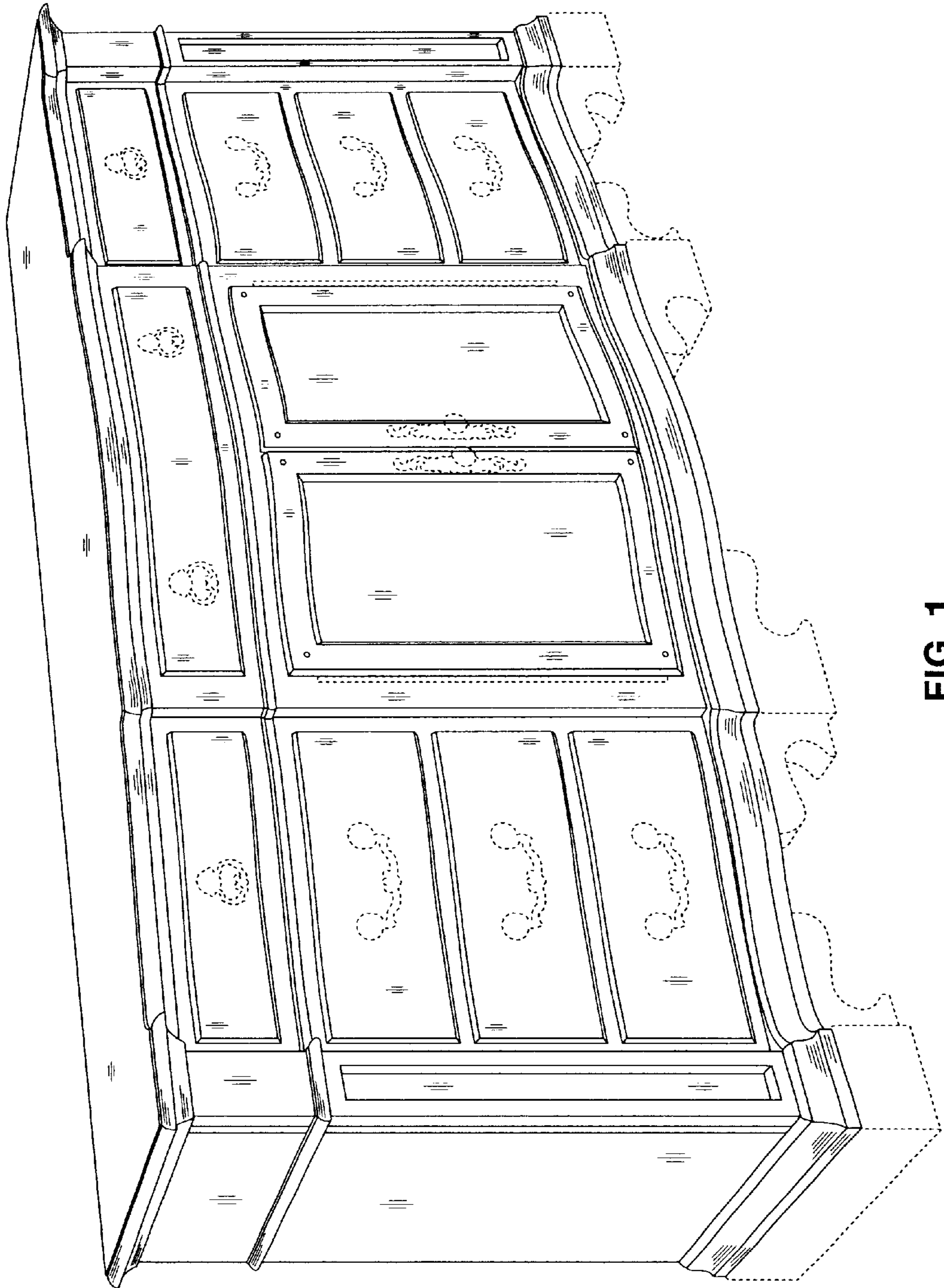

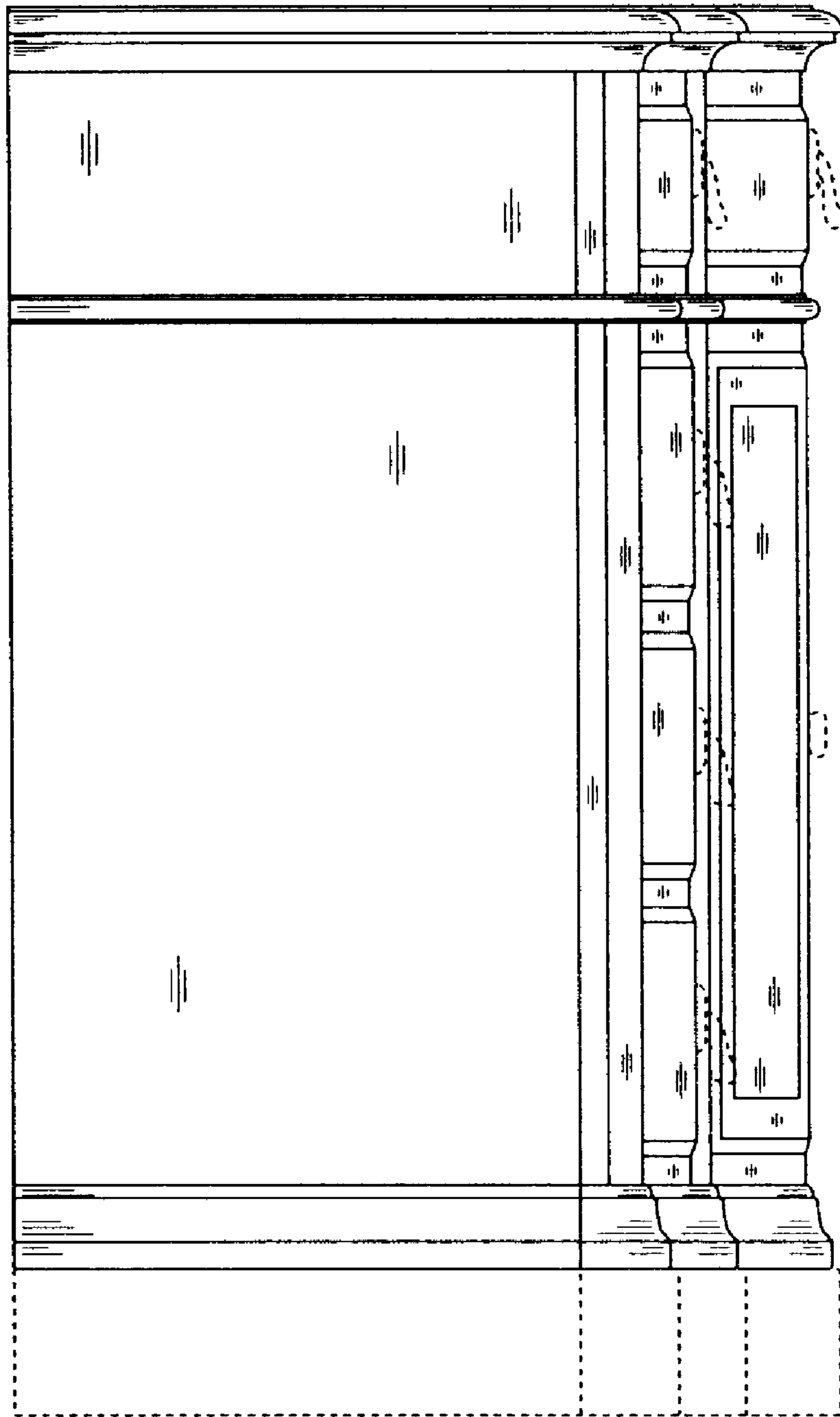

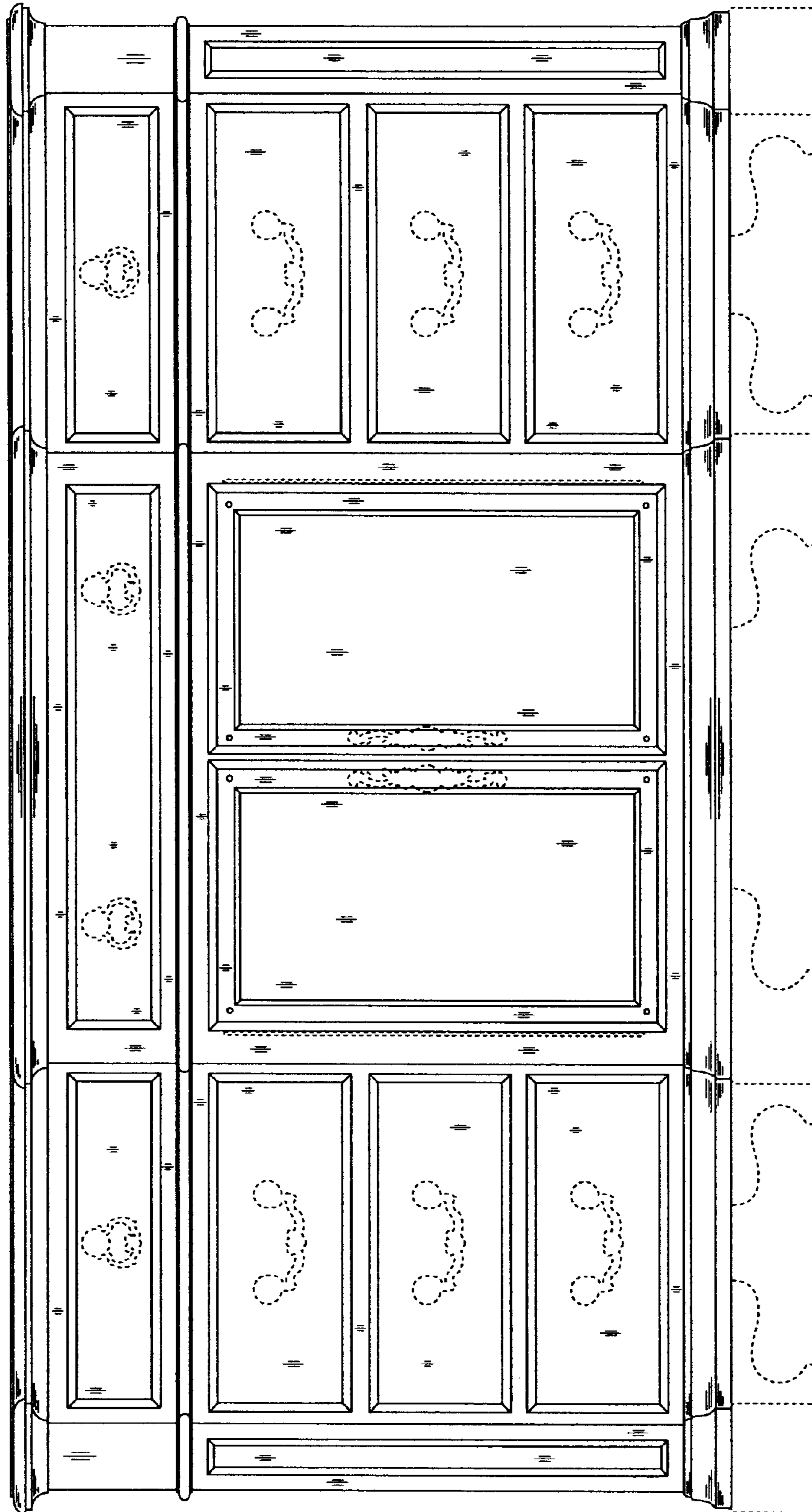

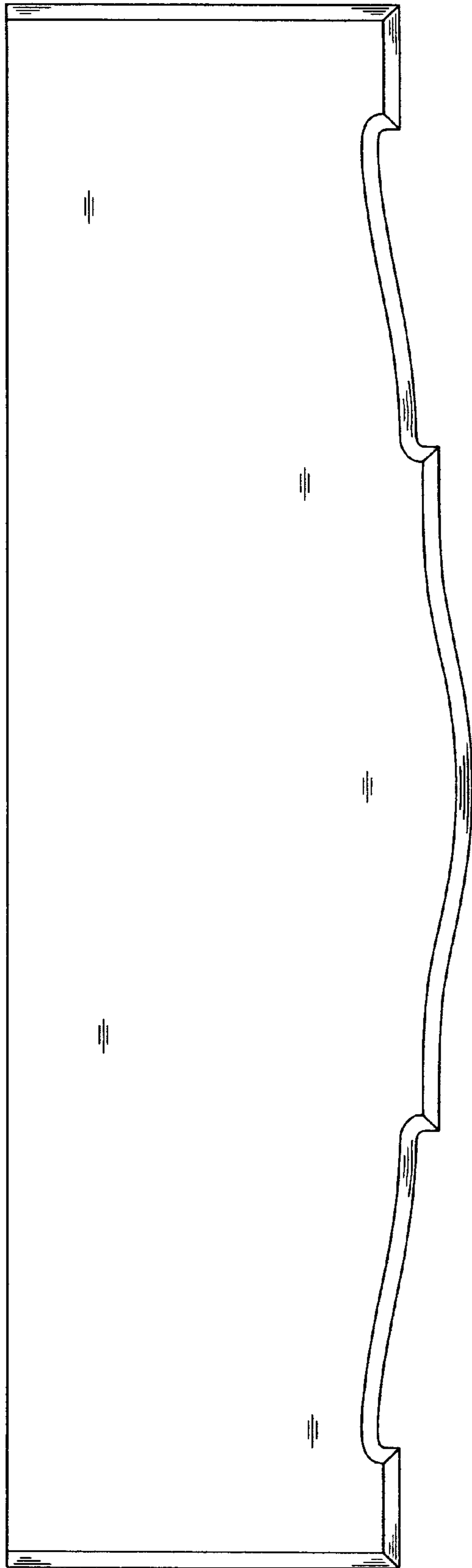

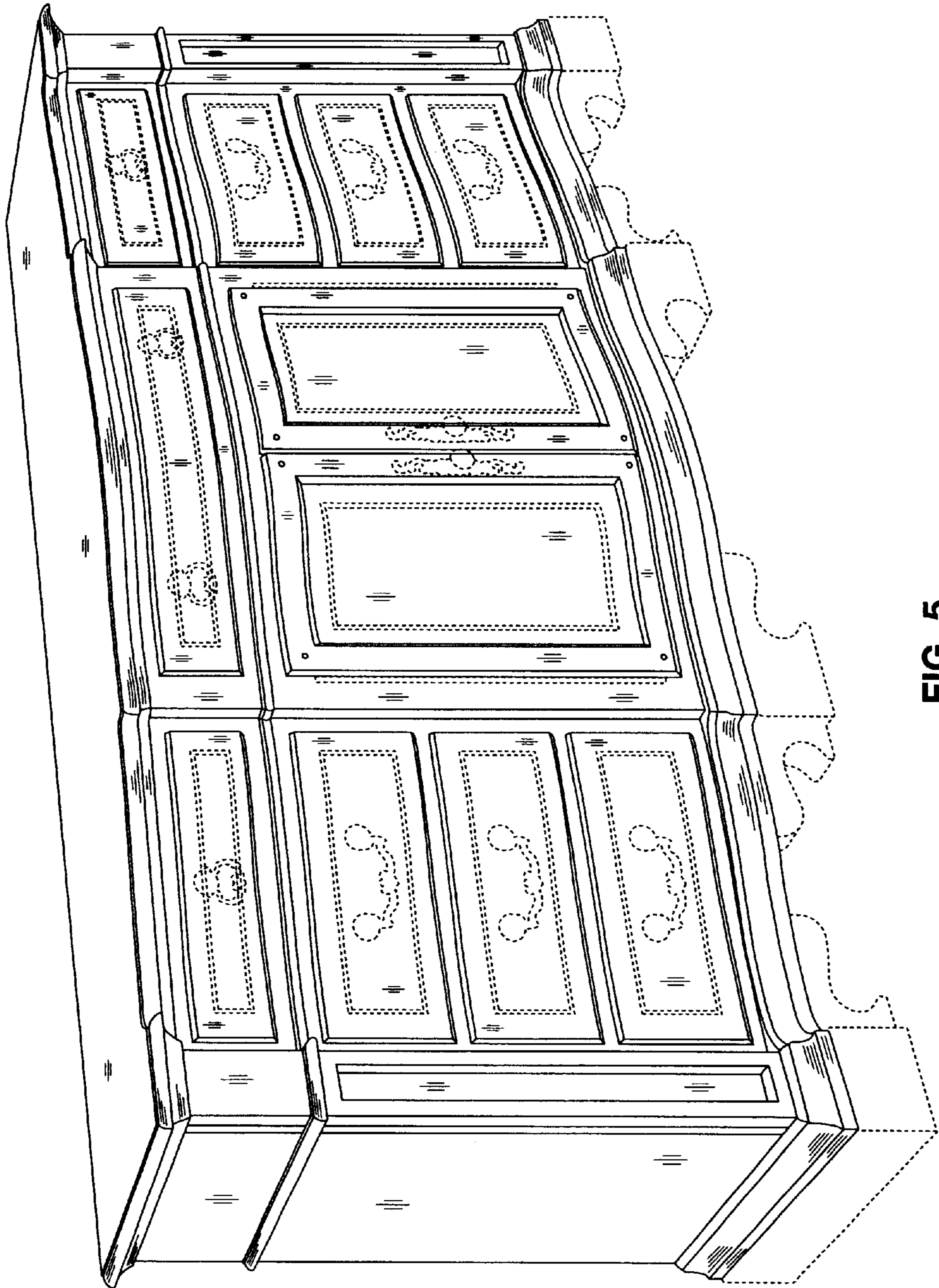
