DESCRIPTION

FIG. 1 is a front elevational view of a pitcher showing our new design;

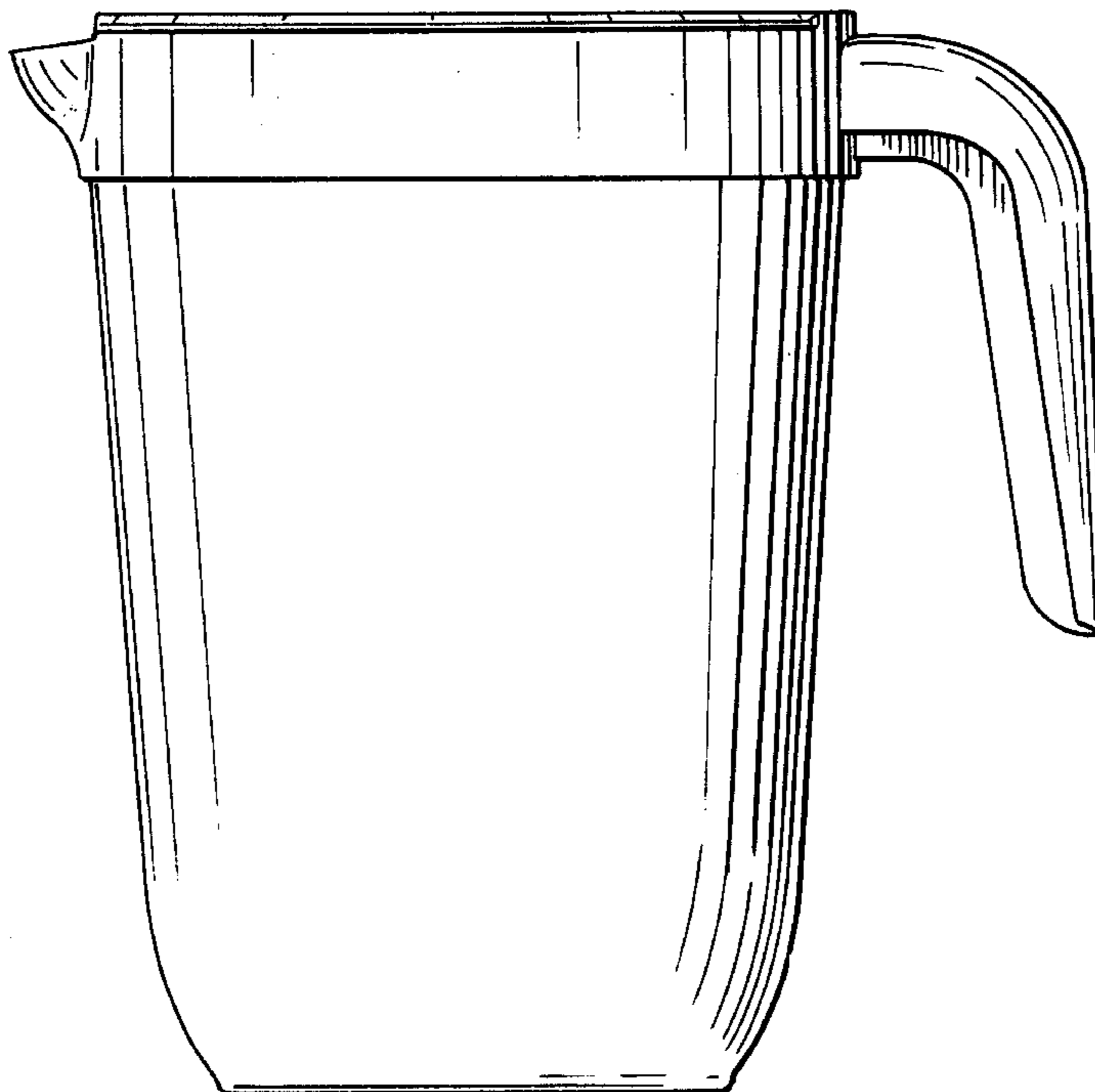
FIG. 2 is a right-side elevational view thereof, the opposite side being a mirror image thereof;

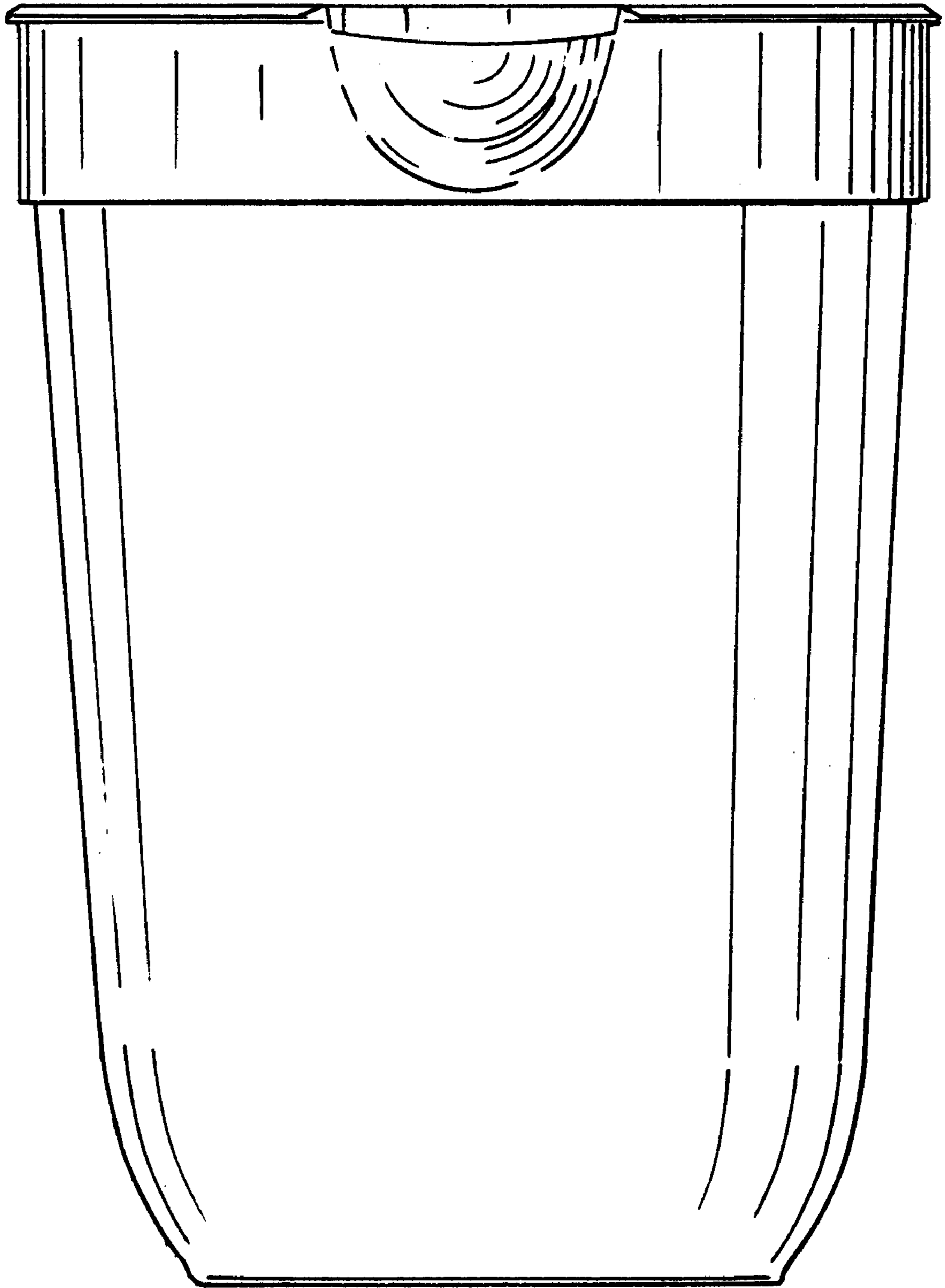

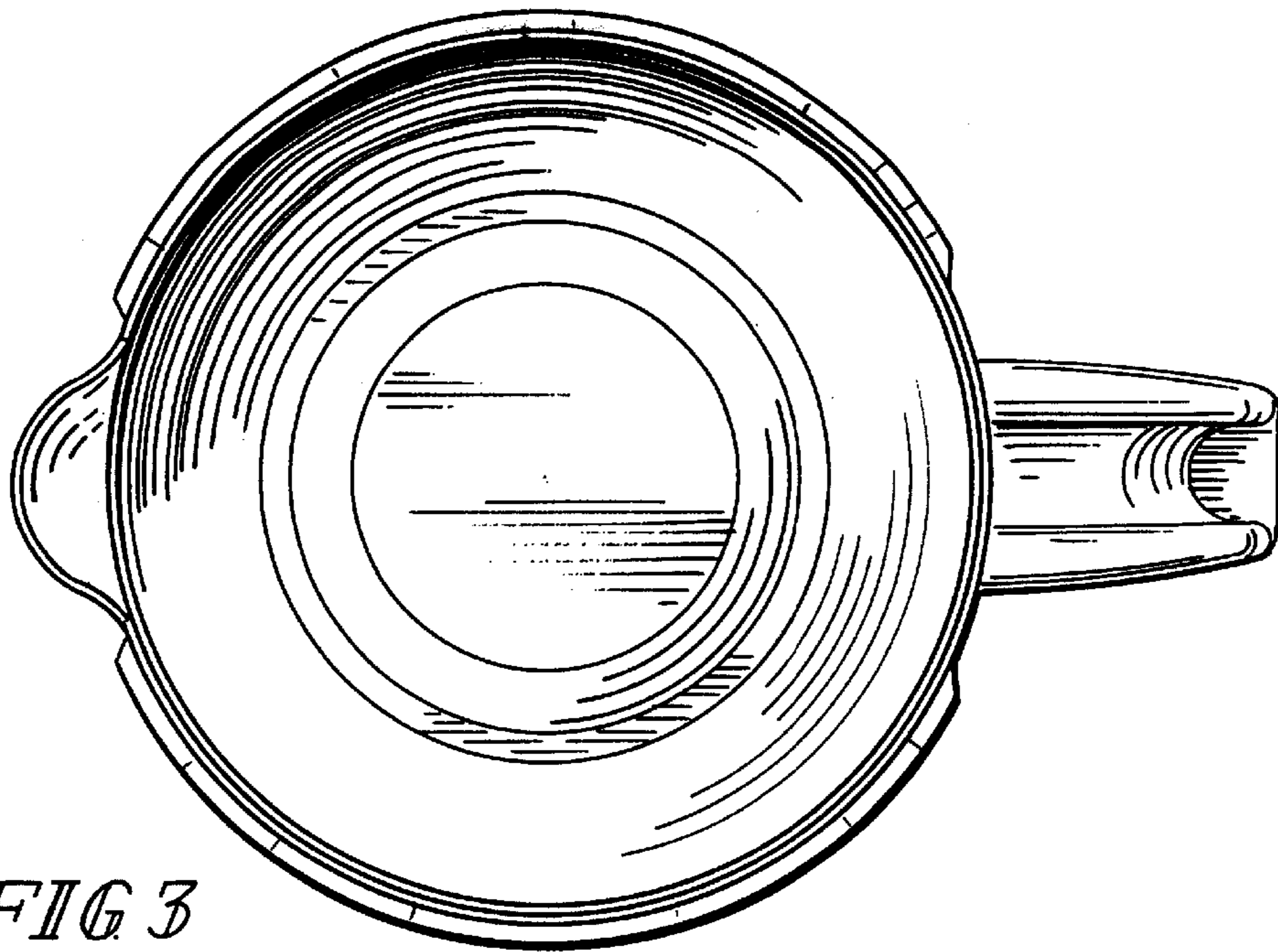

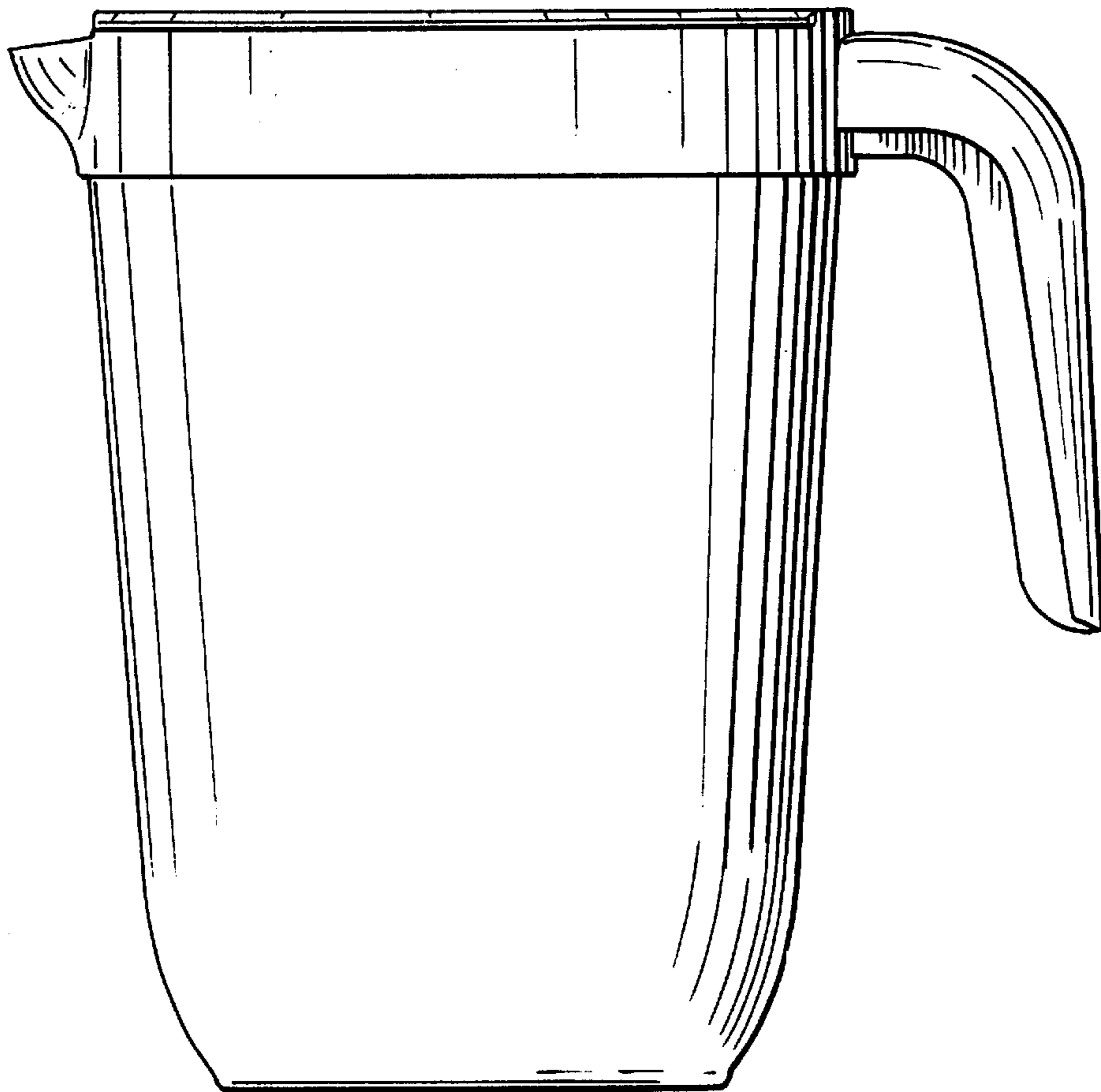

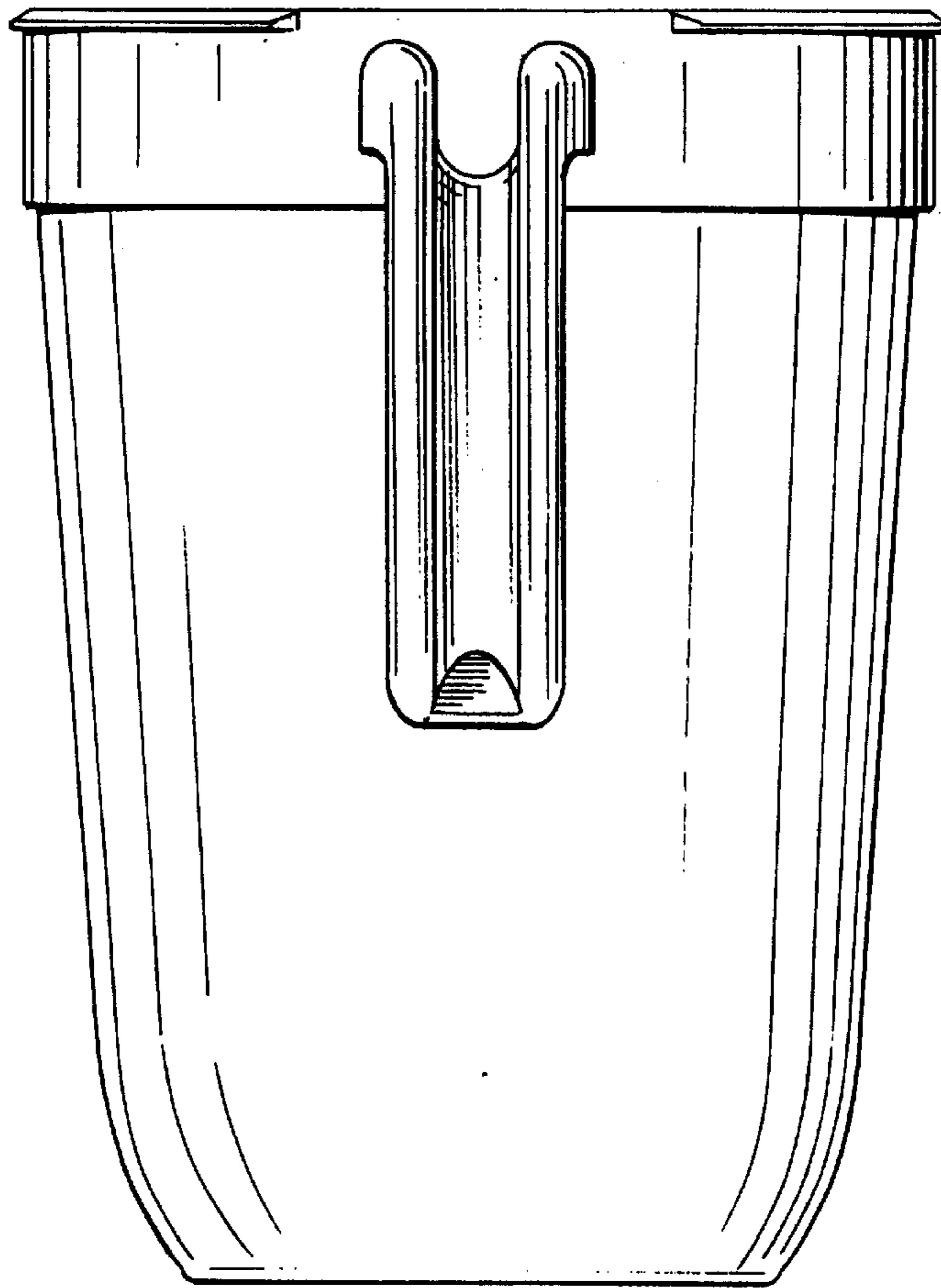

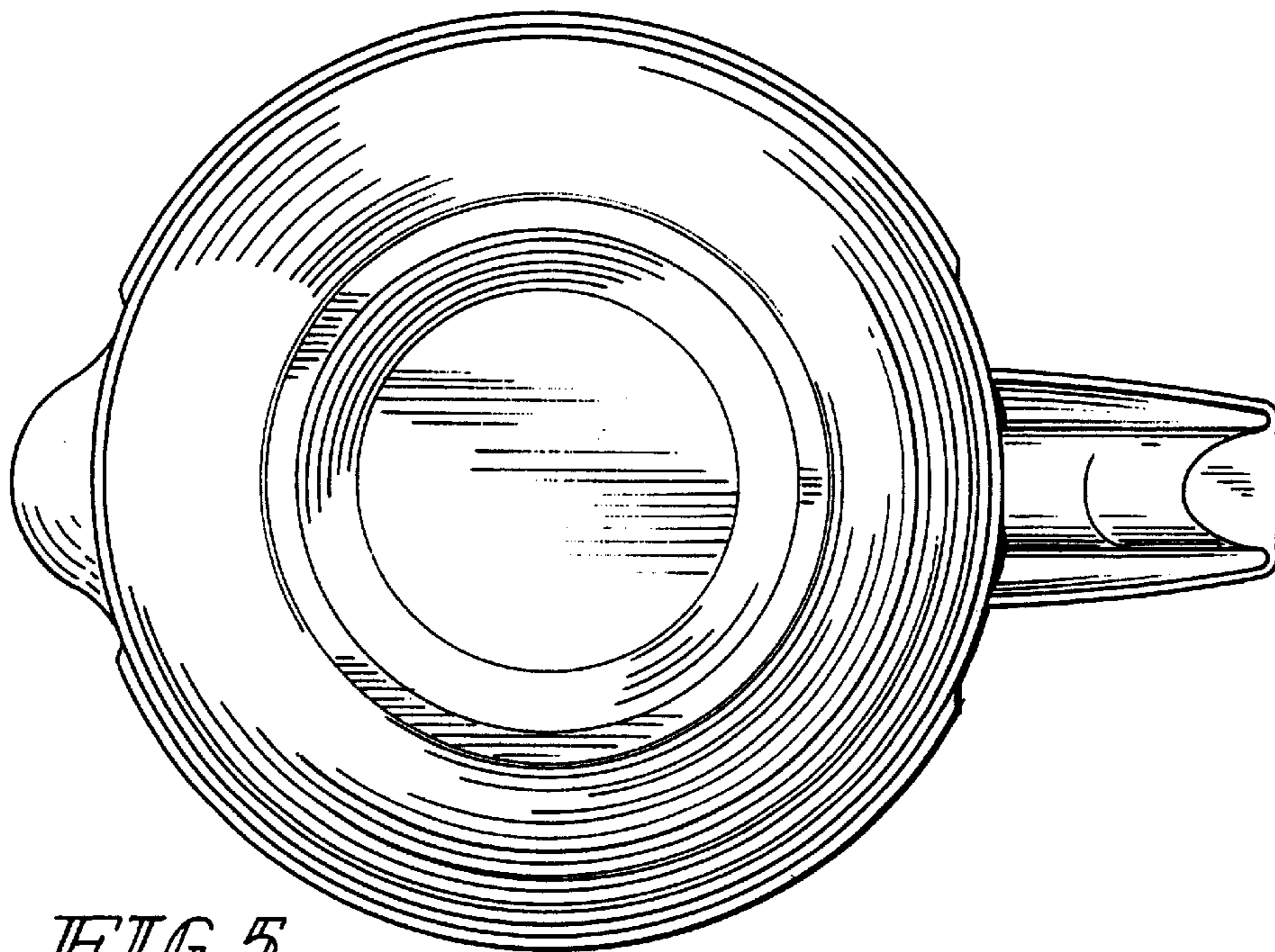
