(57) **CLAIM**

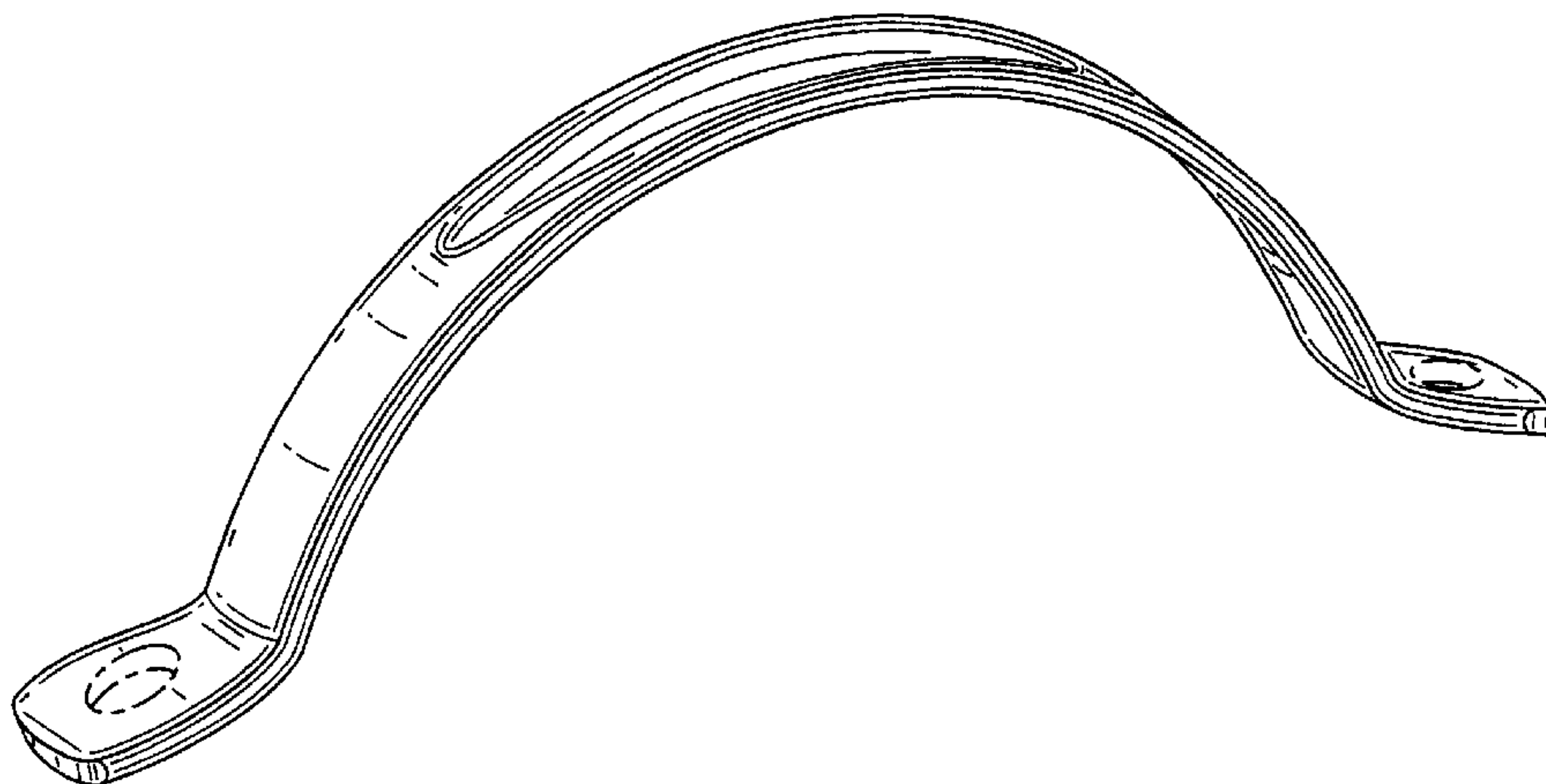
The ornamental design for the handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top, rear, and right side view of a handle showing the new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image thereof; FIG. 5 is a rear plan view thereof, the front plan view being a mirror image thereof; and, FIG. 6 is a perspective top, rear and right side view of a handle showing the new design positioned on an article of cookware.

The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

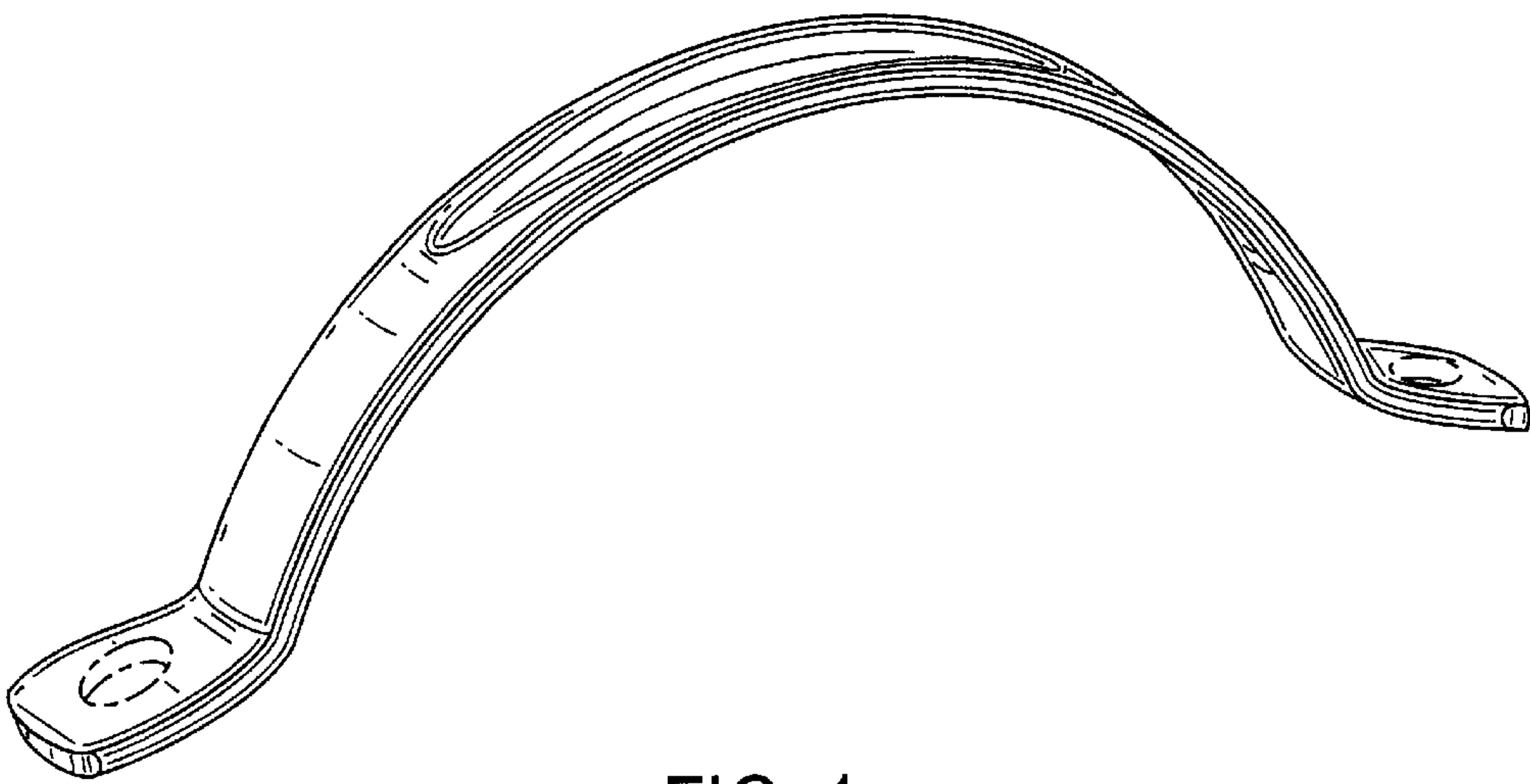

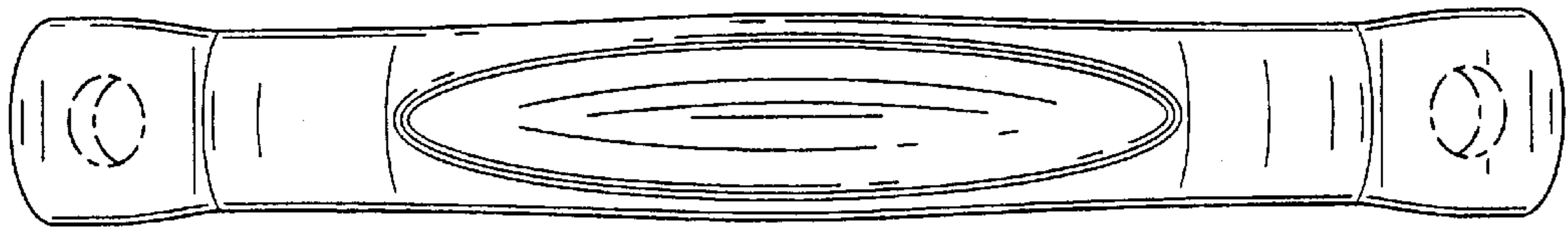

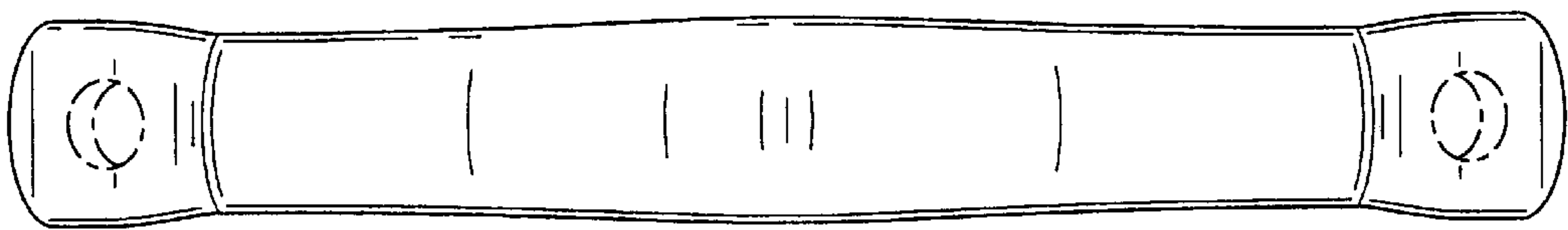

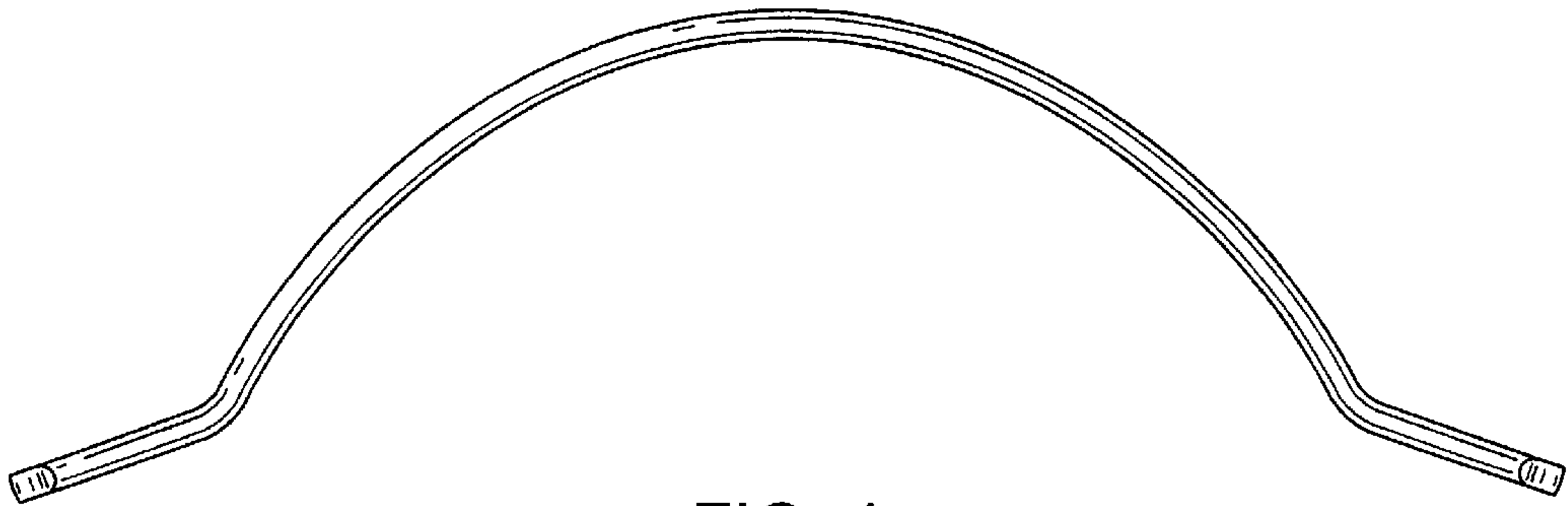

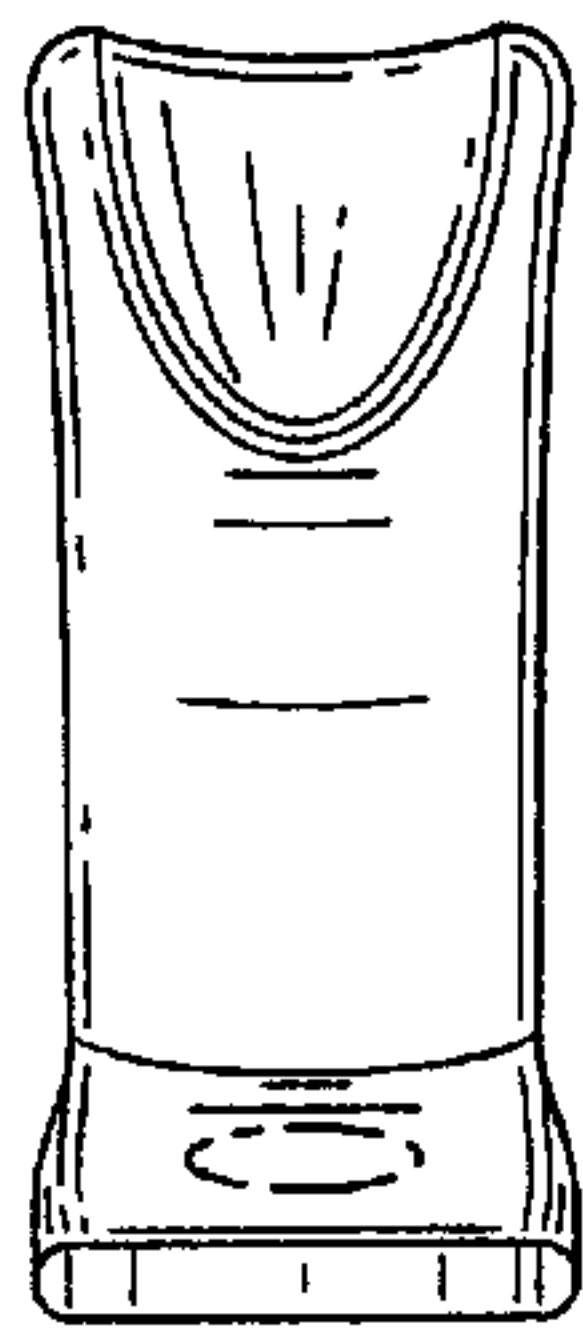

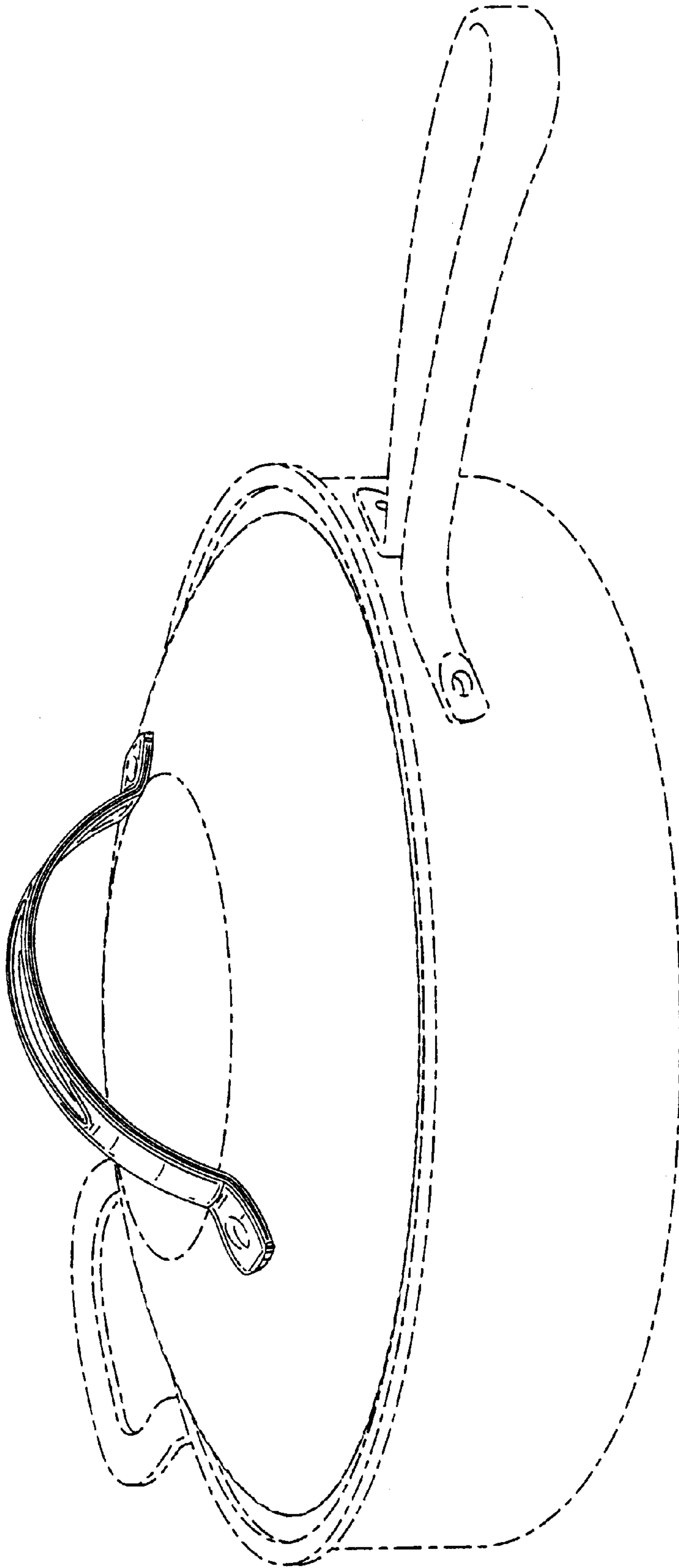
