(57) **CLAIM**

The ornamental design of a mug, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our mug design taken from the upper right;

FIG. 2 is a perspective view of our mug design taken from the lower left;

FIG. 3 is a front elevation of our mug design, it being understood that a rear elevation is a mirror image of this FIG. 3;

FIG. 4 is a side elevation of our mug design taken from the right of FIG. 3;

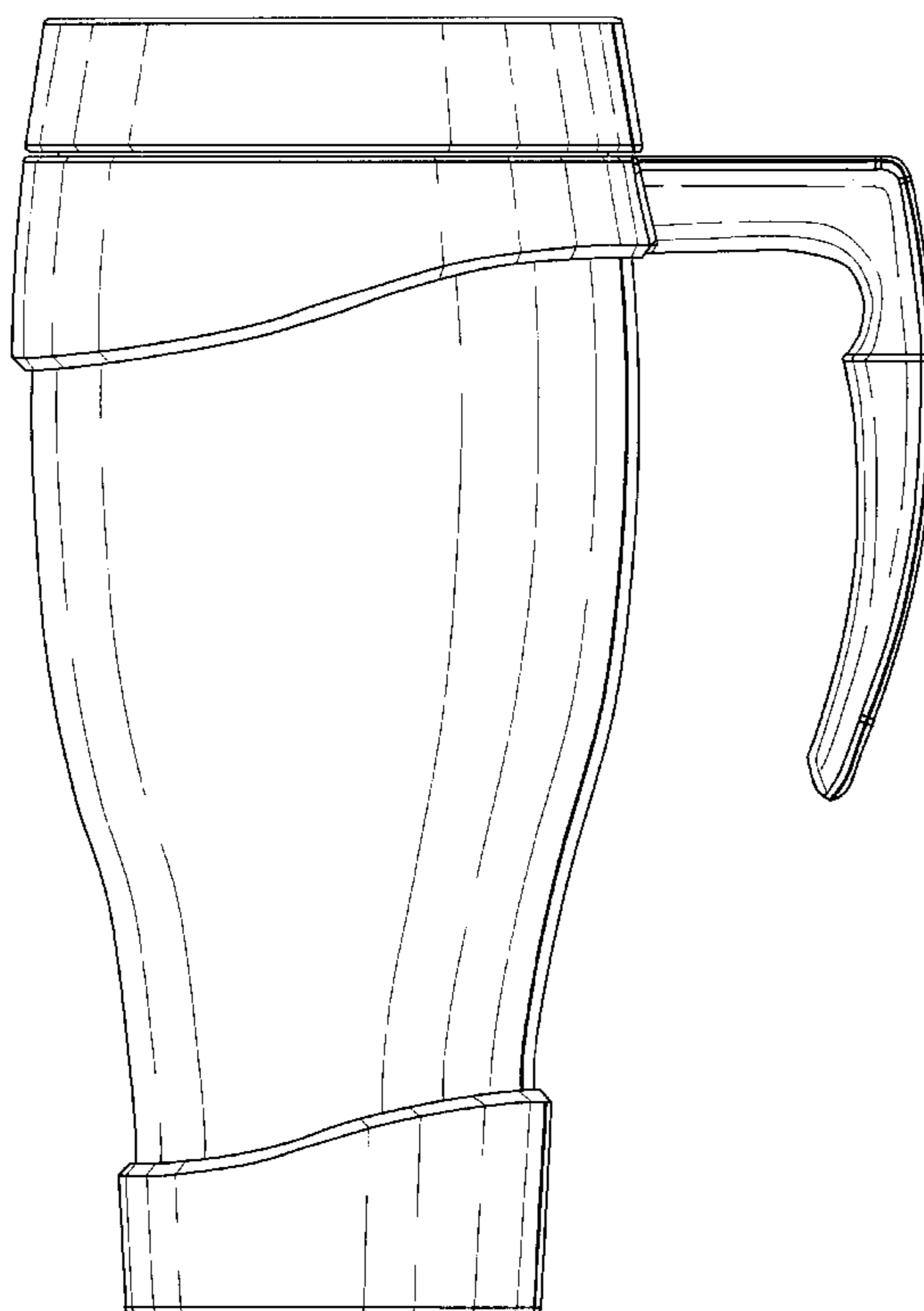
FIG. 5 is a side elevation of our mug design taken from the left of FIG. 3;

FIG. 6 is a plan view of our mug design; and,

FIG. 7 is a bottom view of our mug design.

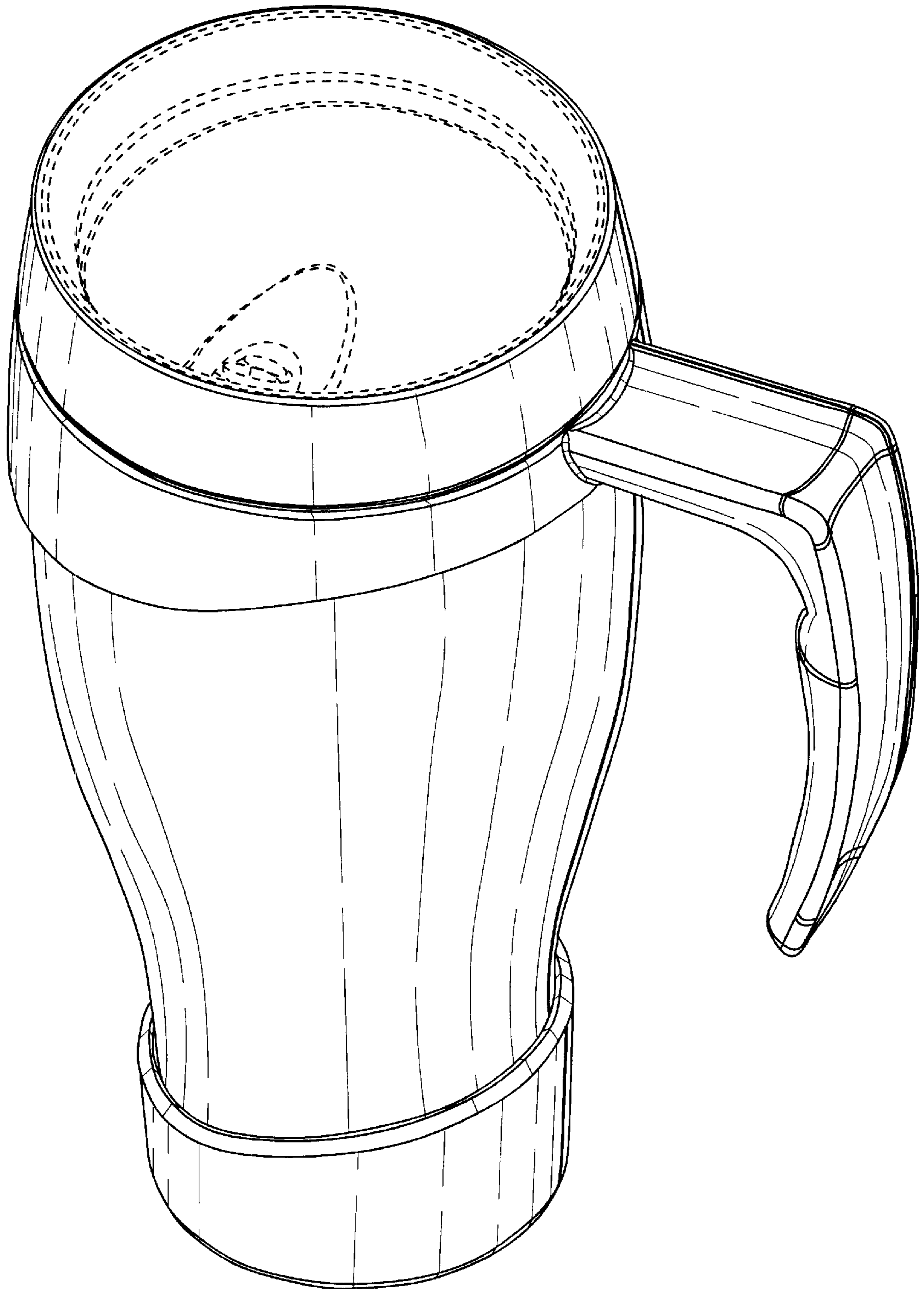

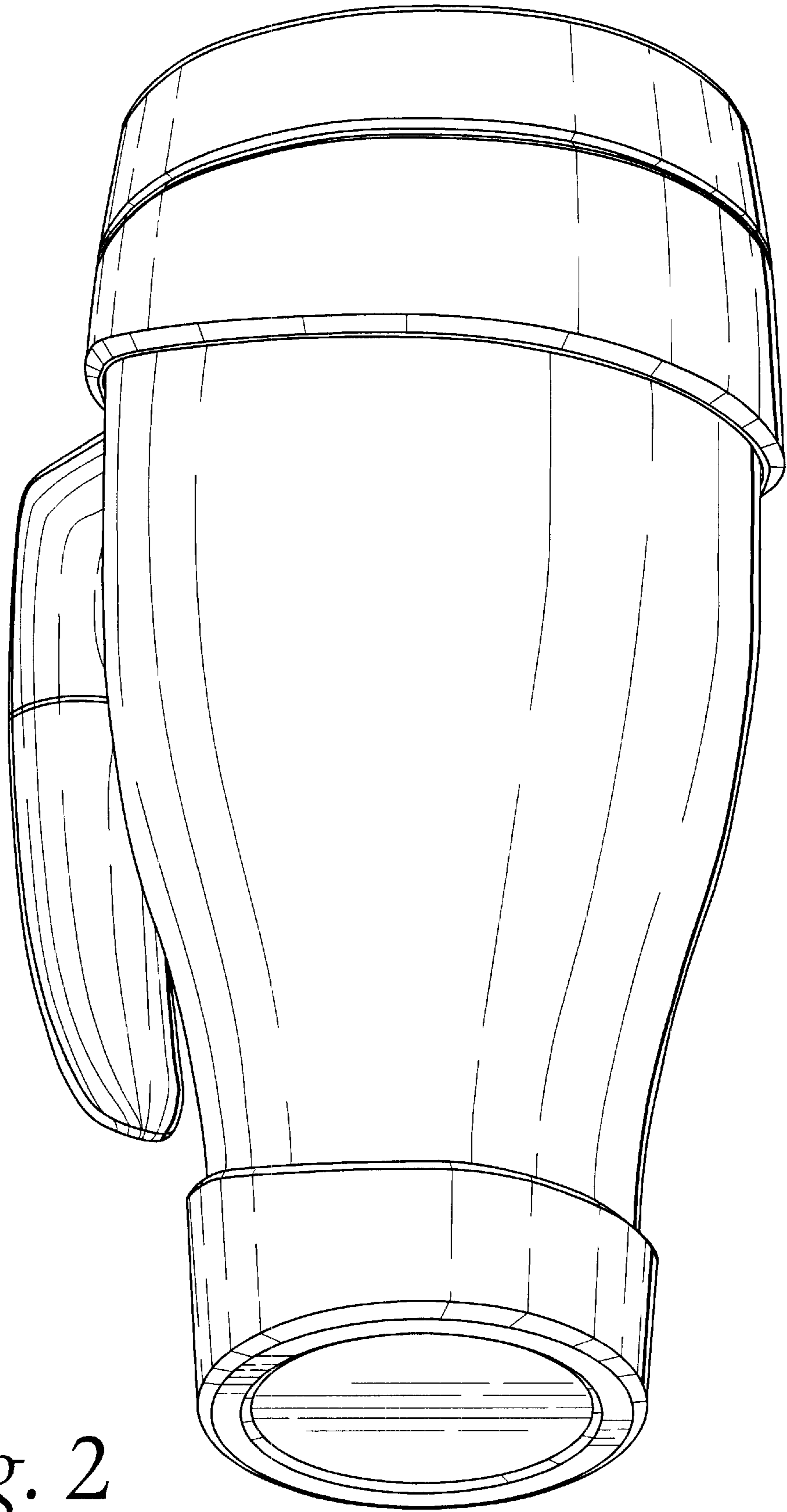

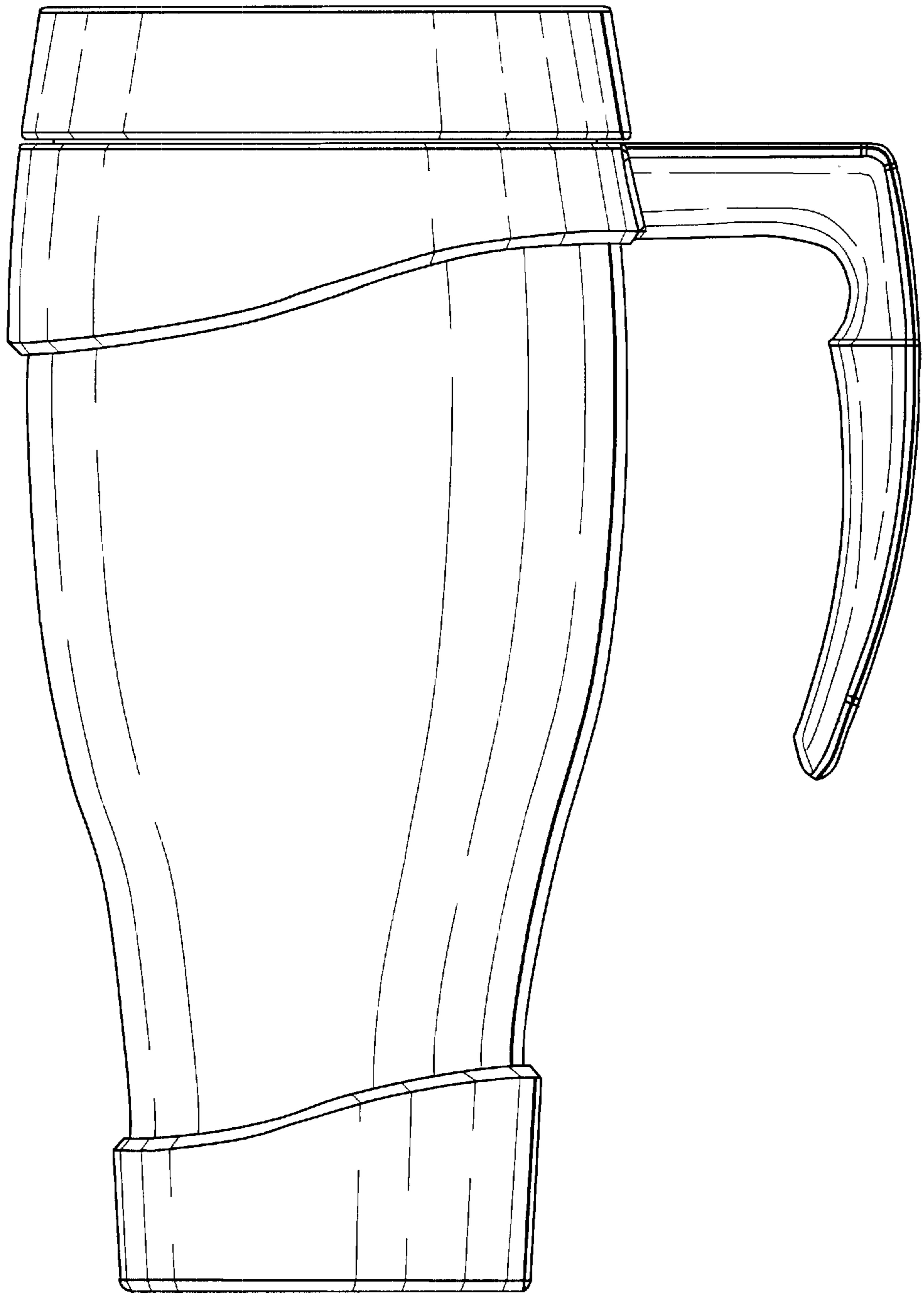

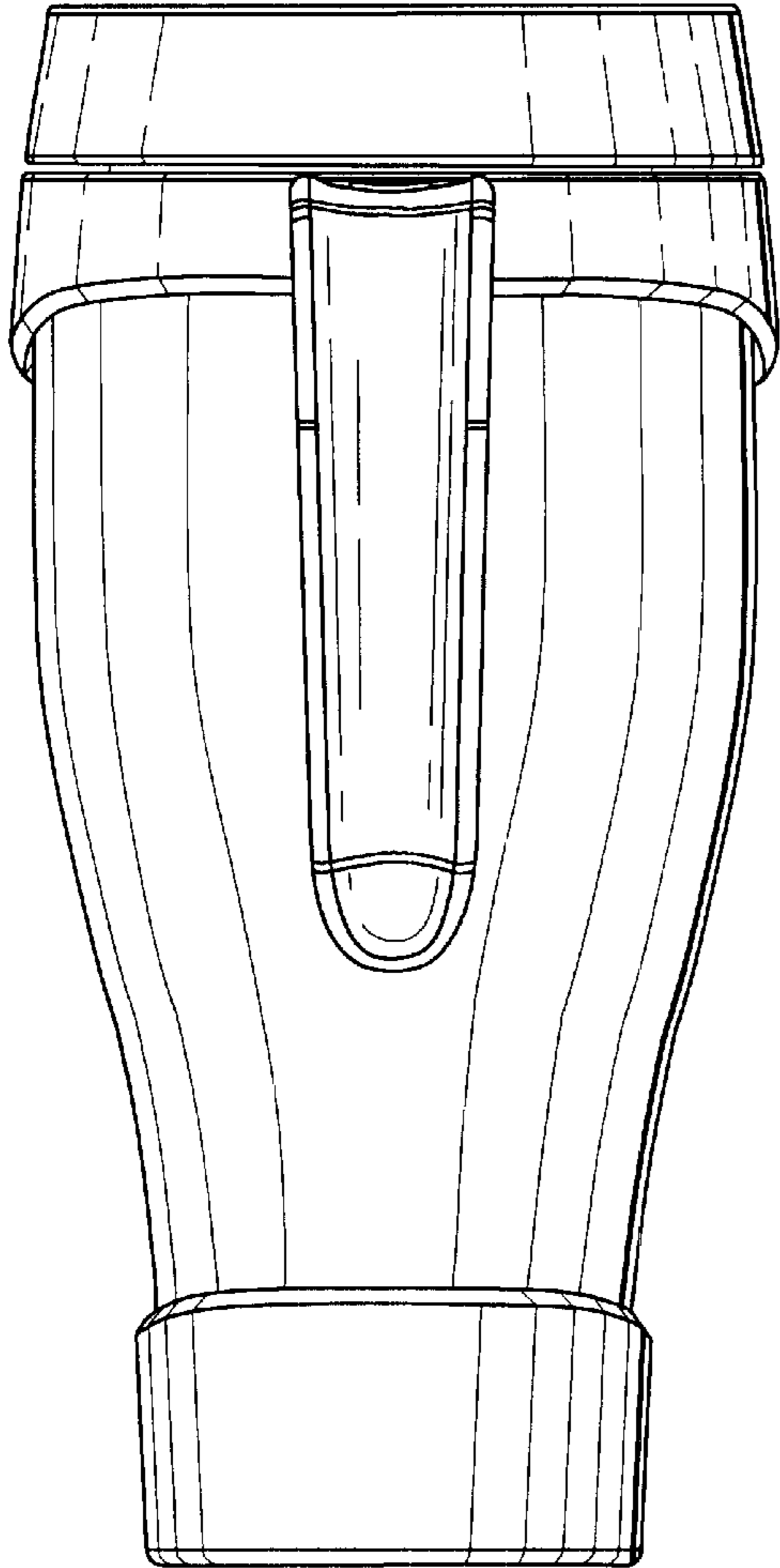

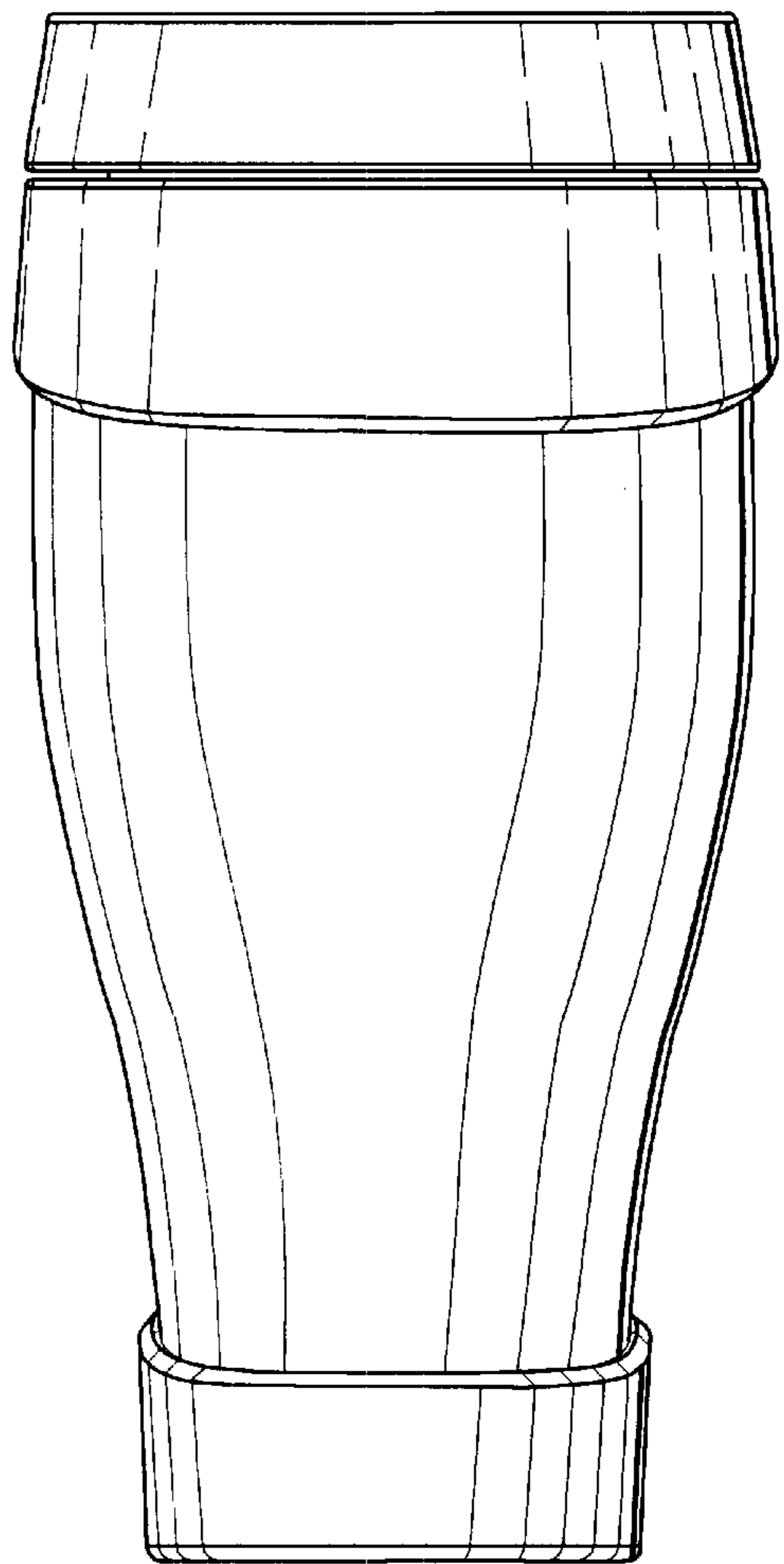

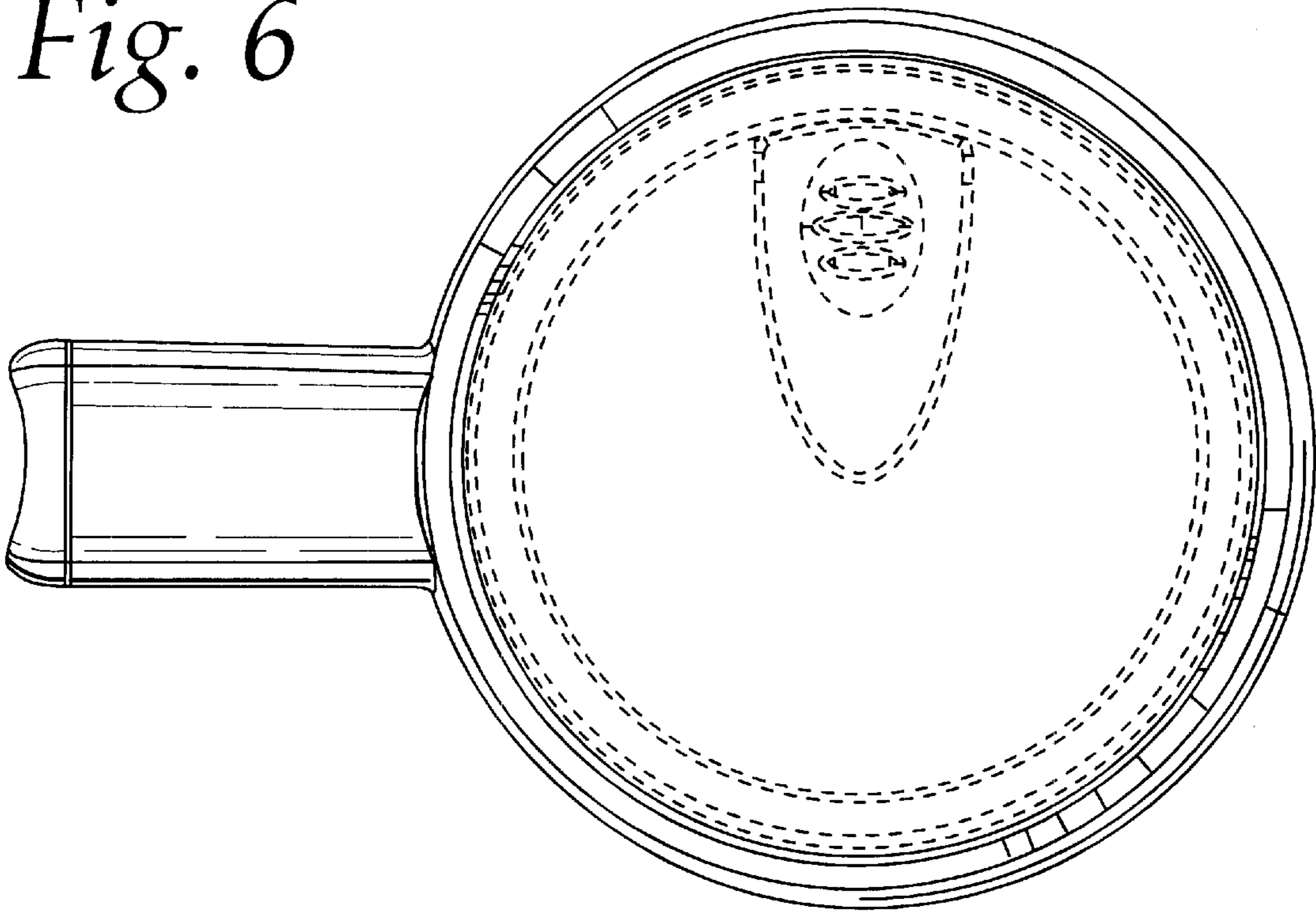
