The ornamental design for the tray, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a tray showing a first preferred embodiment of my design;
 FIG. 2 is a front side view of the tray of FIG. 1, the rear side view being a mirror image thereof;
 FIG. 3 is a right side view of the tray of FIG. 1, the left side view being a mirror image thereof;
 FIG. 4 is a top view of the tray of FIG. 1;
 FIG. 5 is a bottom view of the tray of FIG. 1;
 FIG. 6 is a top perspective view of a tray showing a further preferred embodiment of my design;
 FIG. 7 is a front side view of the tray of FIG. 6, the rear side view being a mirror image thereof;
 FIG. 8 is a right side view of the tray of FIG. 6, the left side view being a mirror image thereof;
 FIG. 9 is a top view of the tray of FIG. 6;
 FIG. 10 is a bottom view of the tray of FIG. 6;
 FIG. 11 is a top perspective view of a tray showing a still further preferred embodiment of my design;
 FIG. 12 is a front side view of the tray of FIG. 11, the rear side view being a mirror image thereof;
 FIG. 13 is a right side view of the tray of FIG. 11, the left side view being a mirror image thereof;
 FIG. 14 is a top view of the tray of FIG. 11; and,
 FIG. 15 is a bottom view of the tray of FIG. 11.

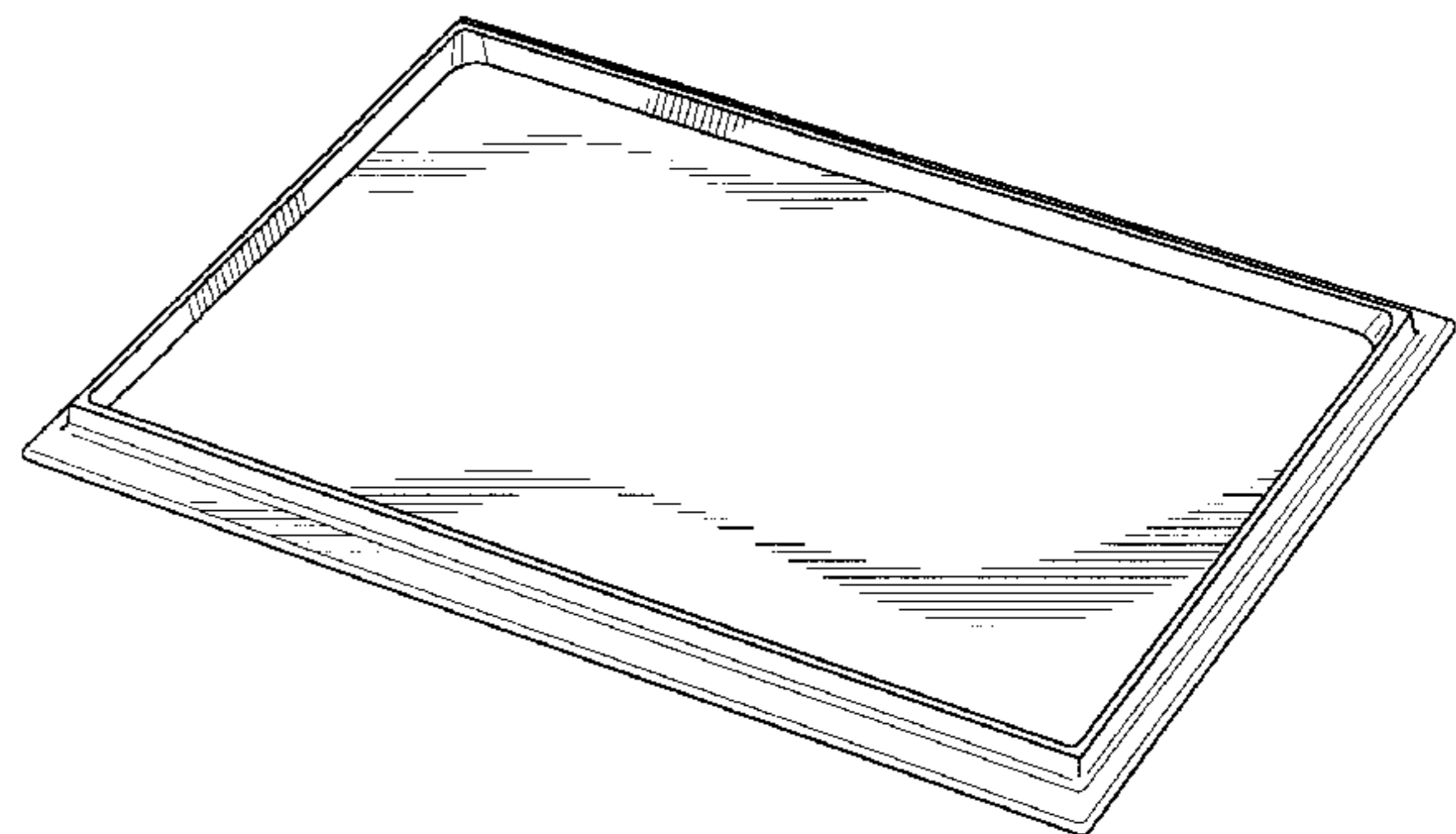
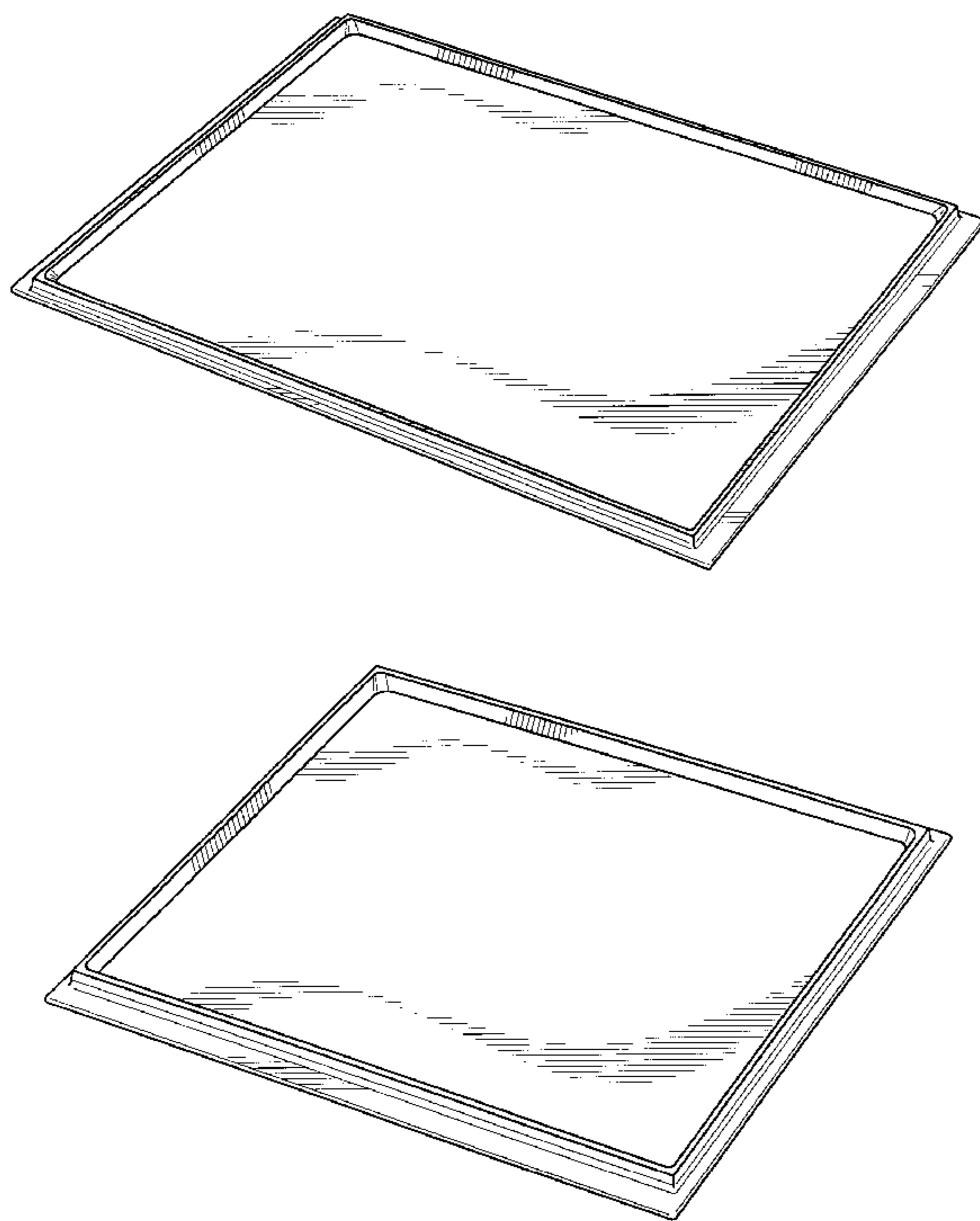

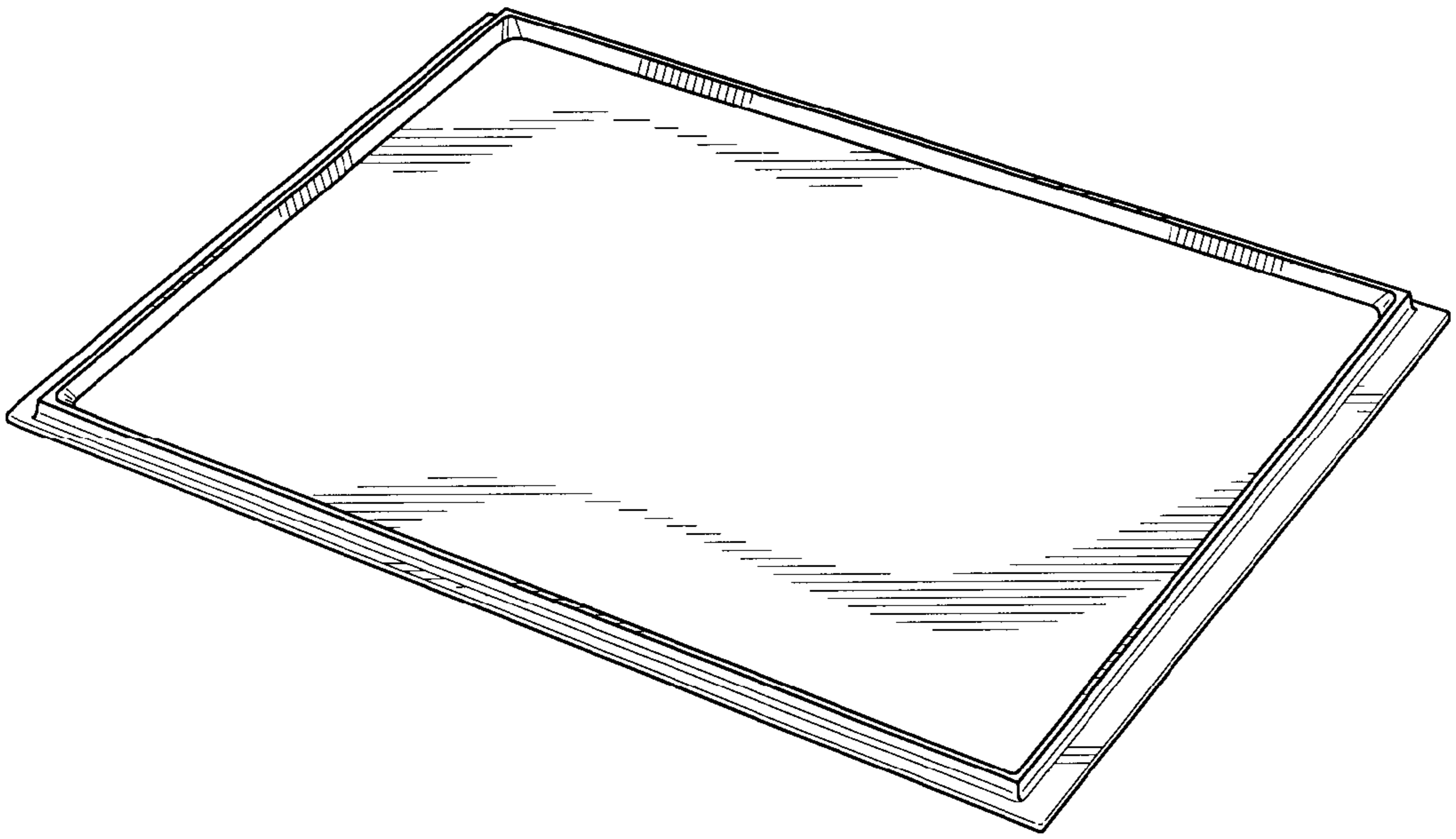
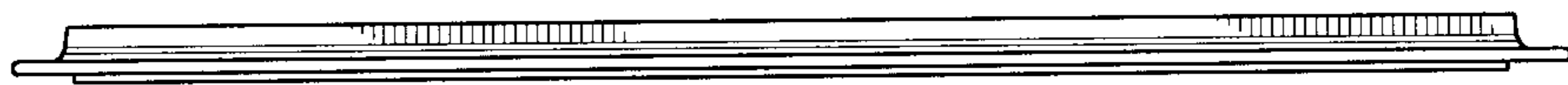

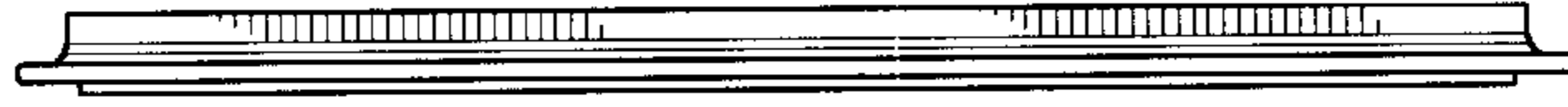

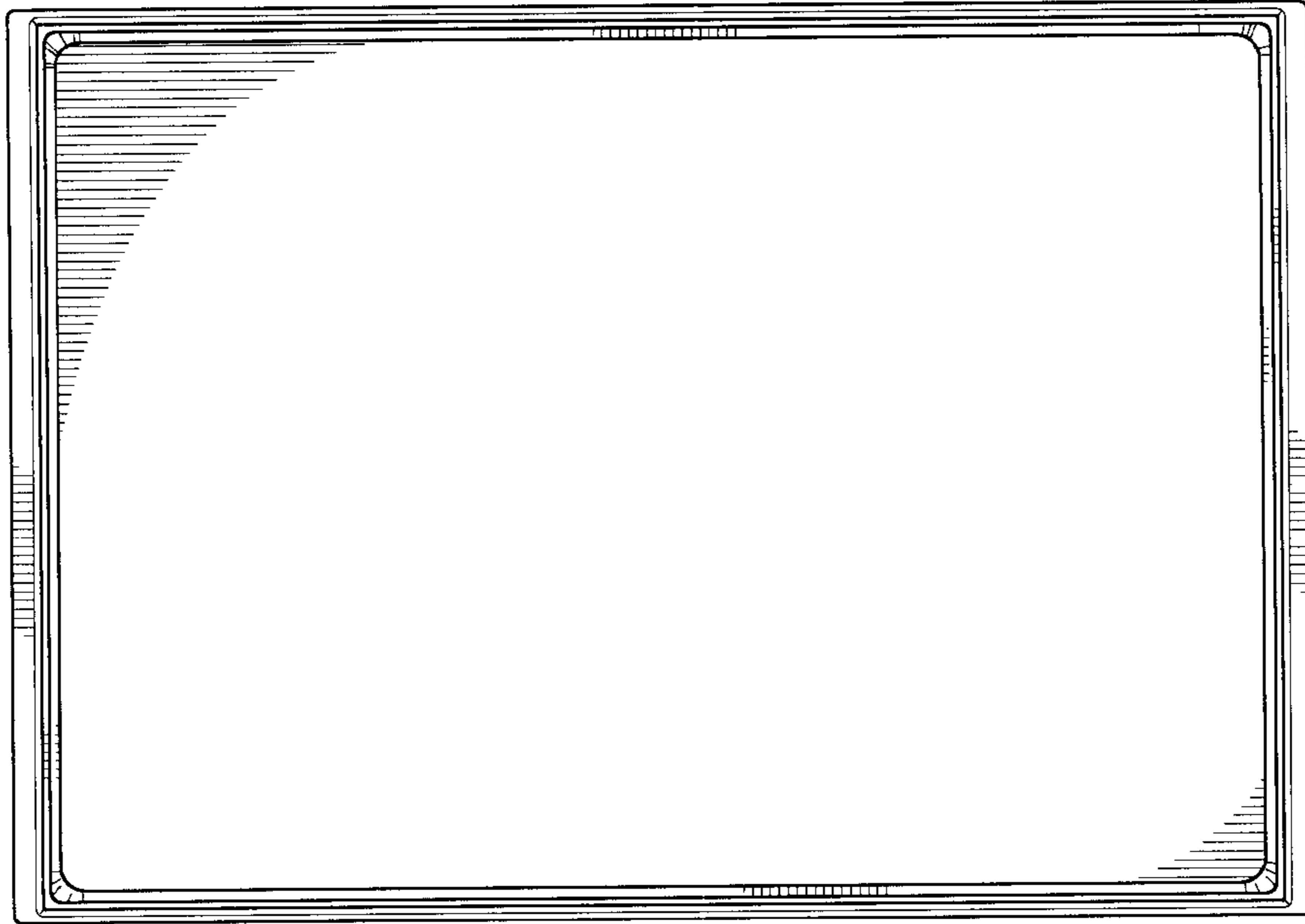

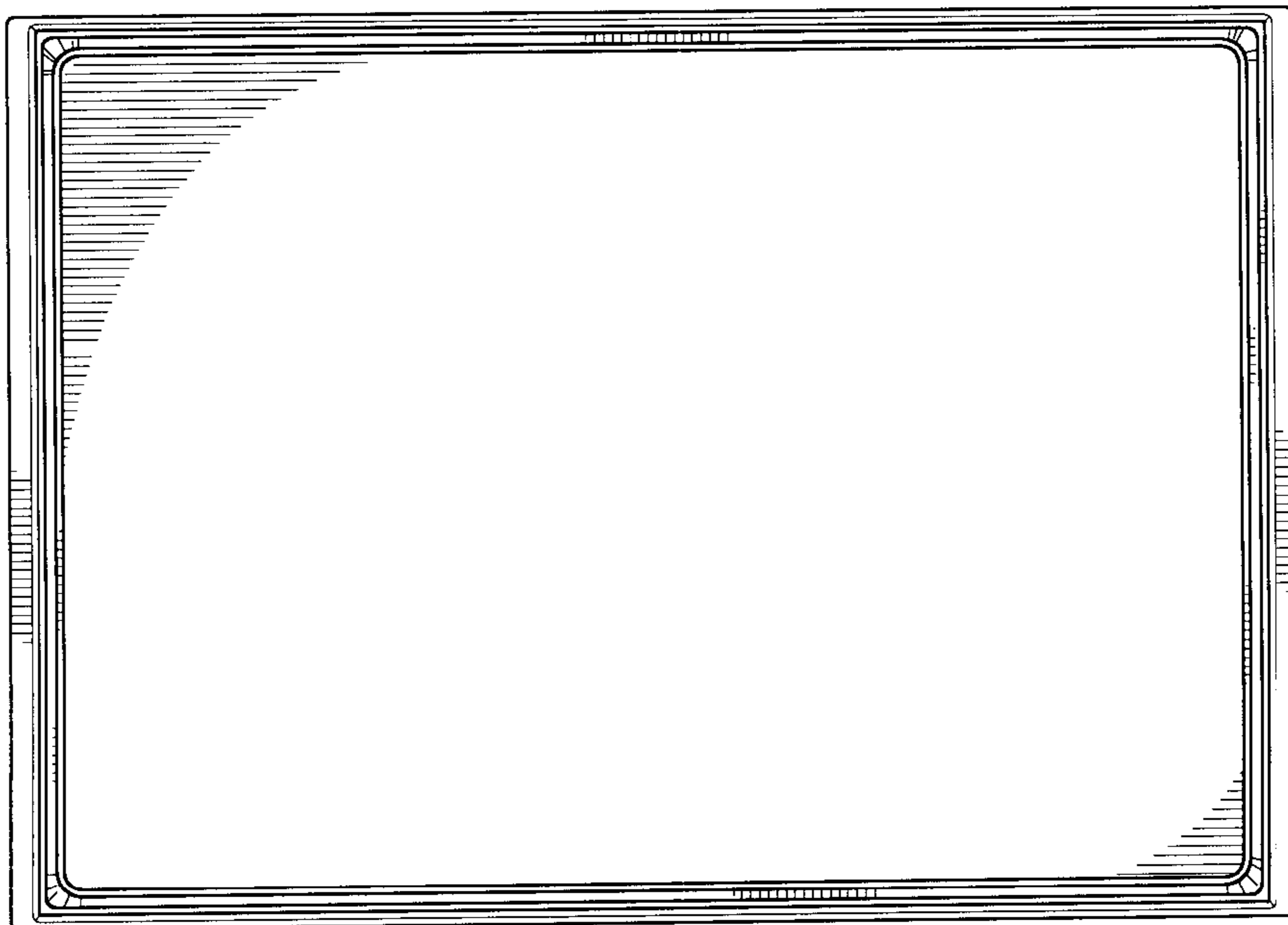

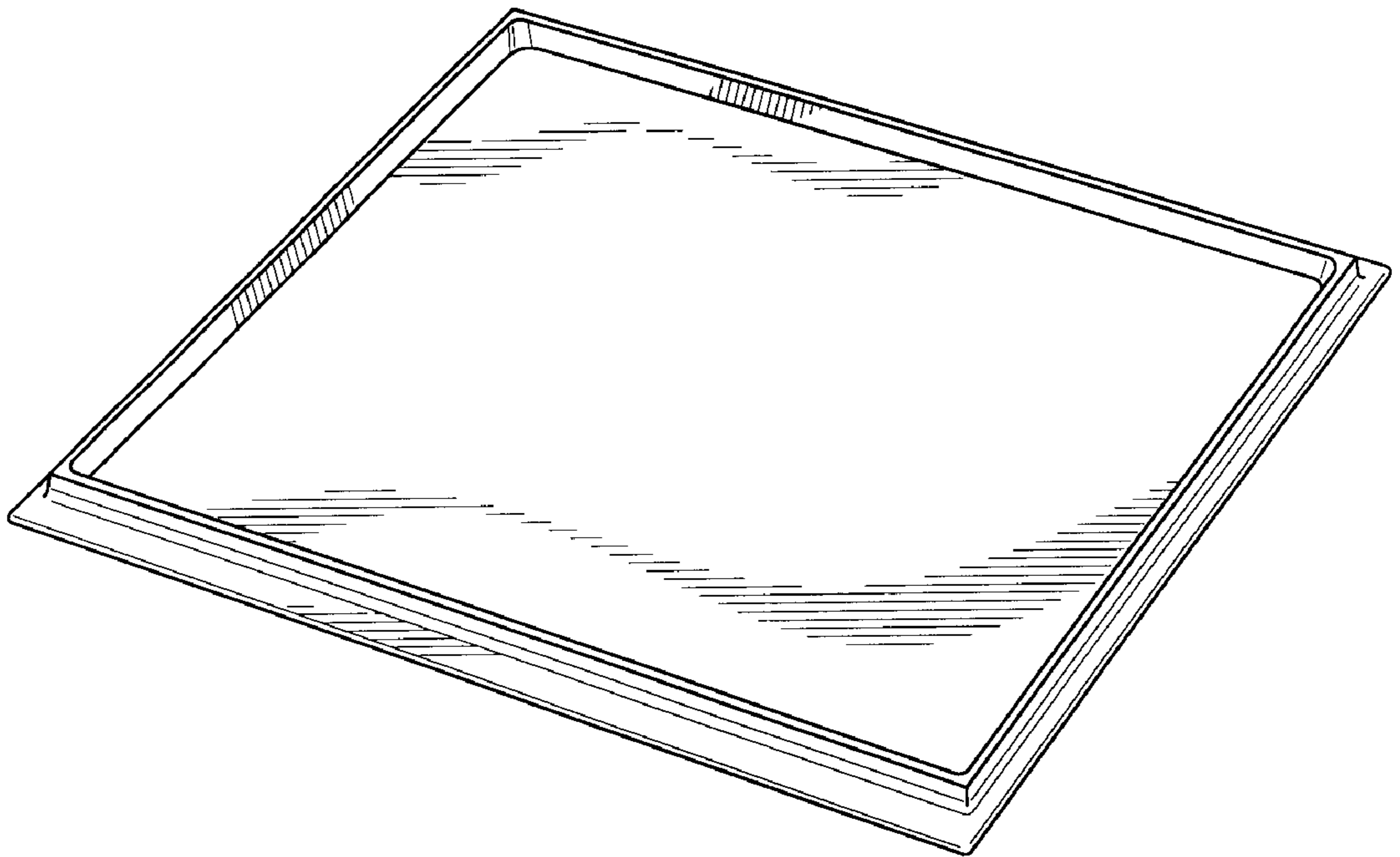
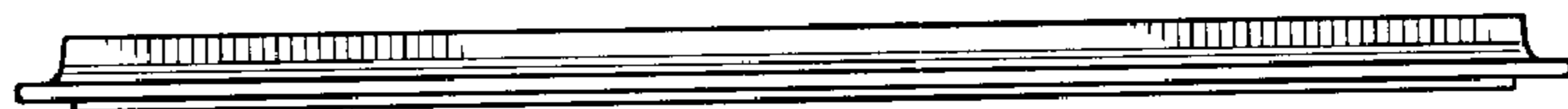

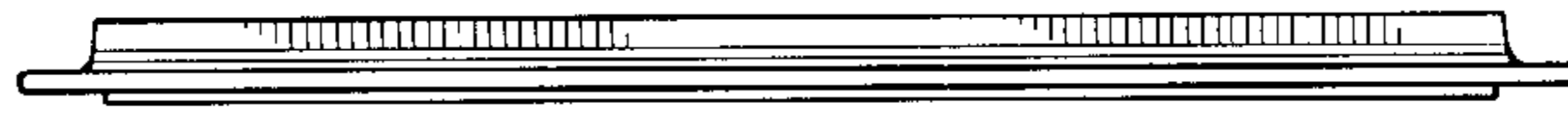

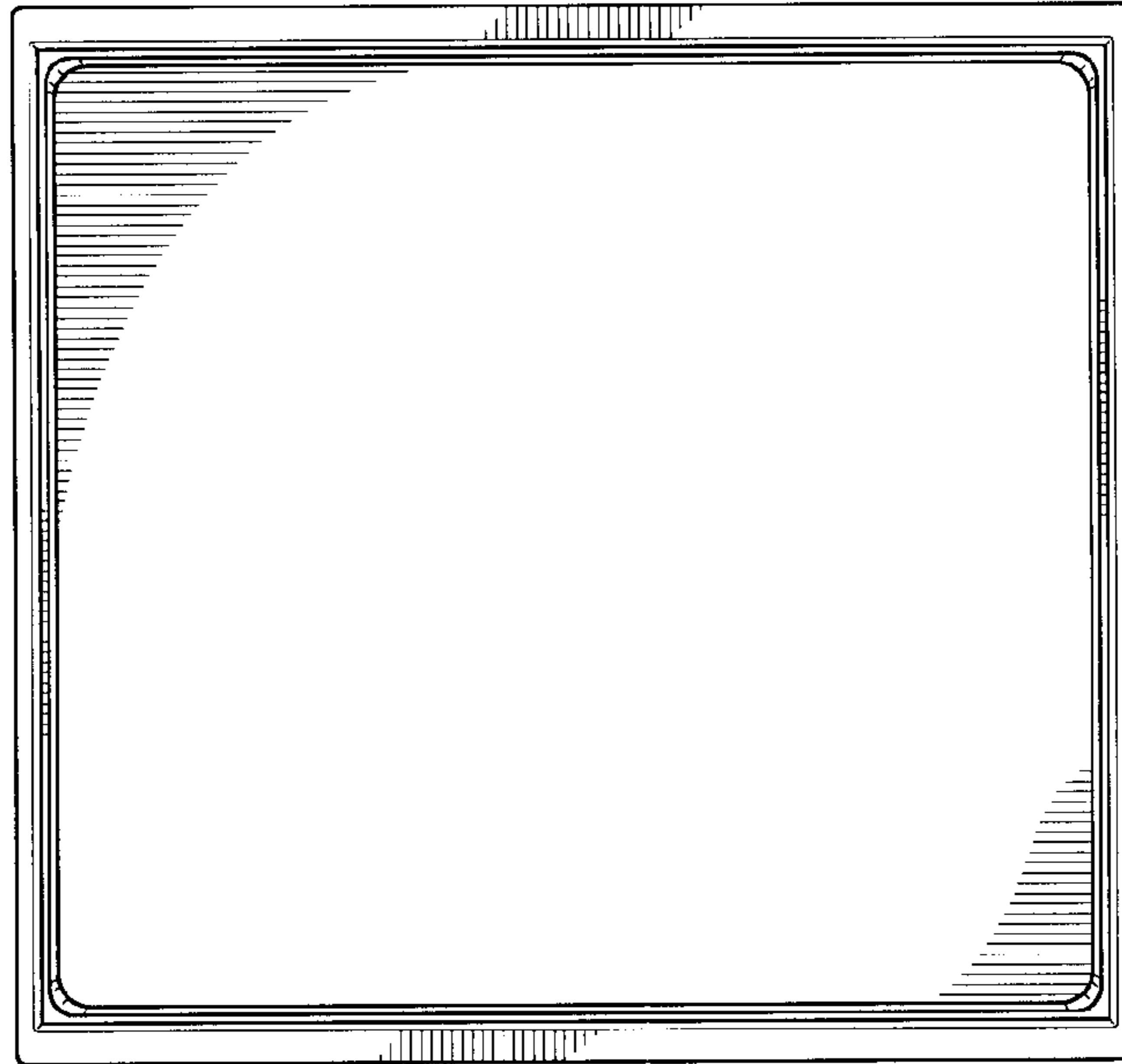

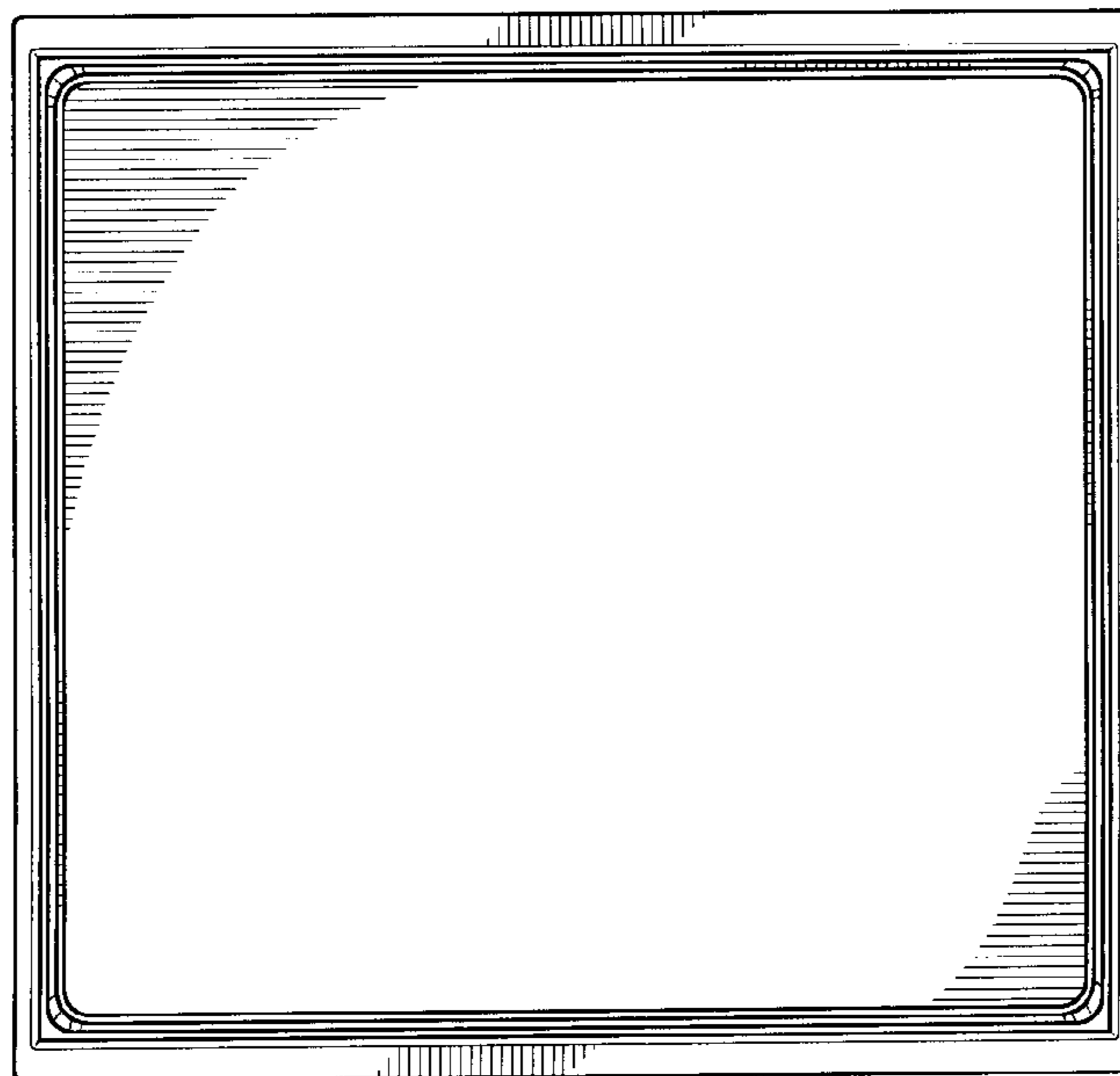

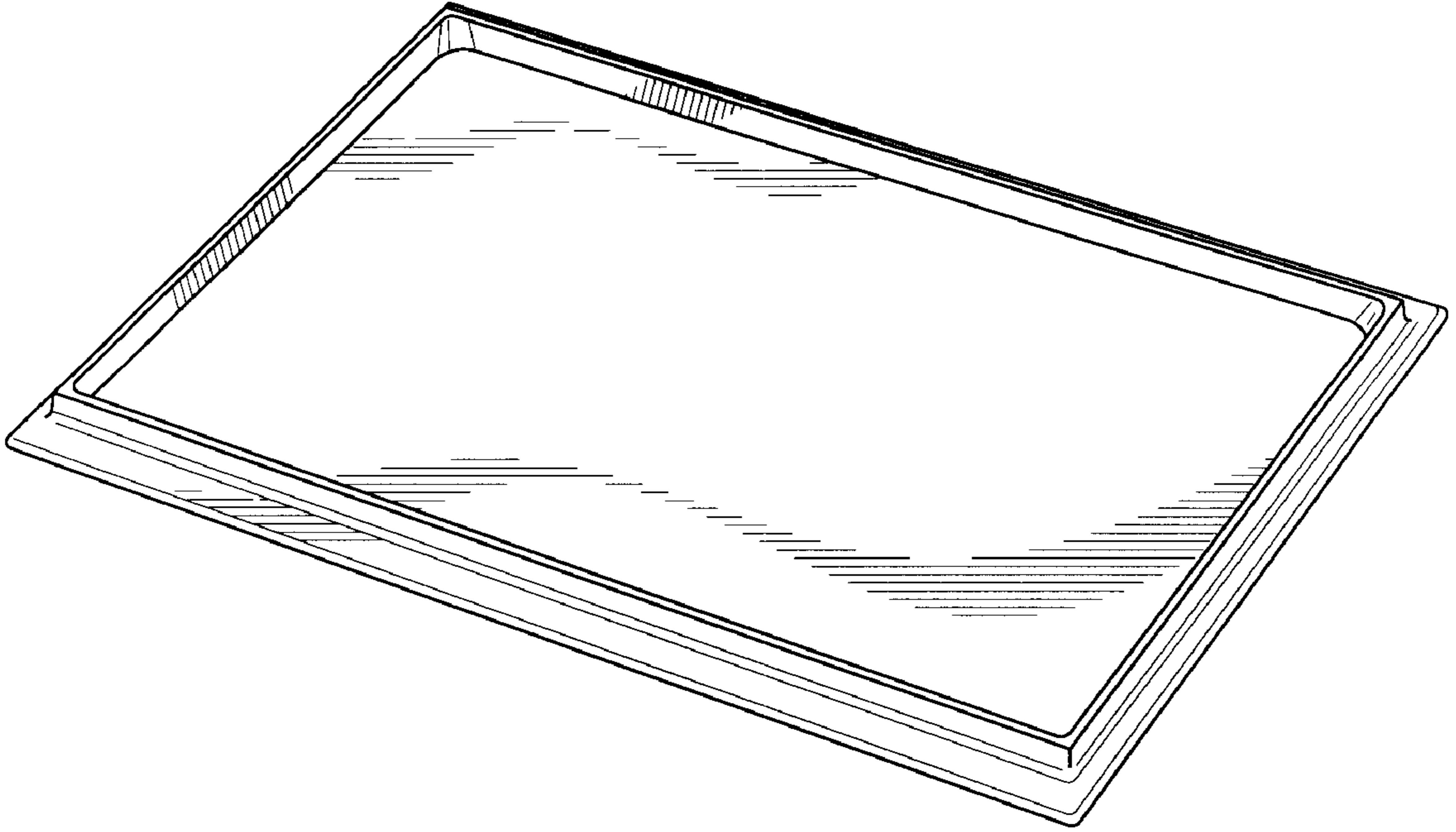
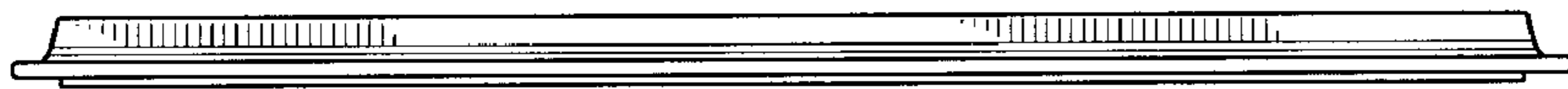

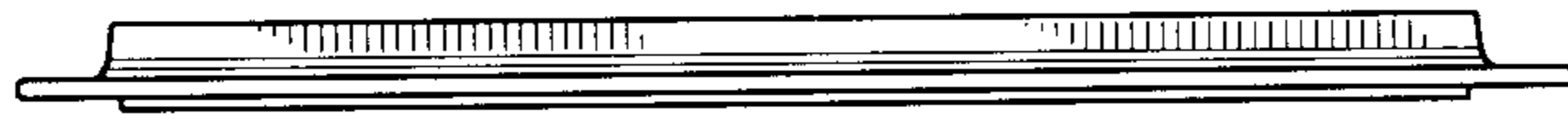

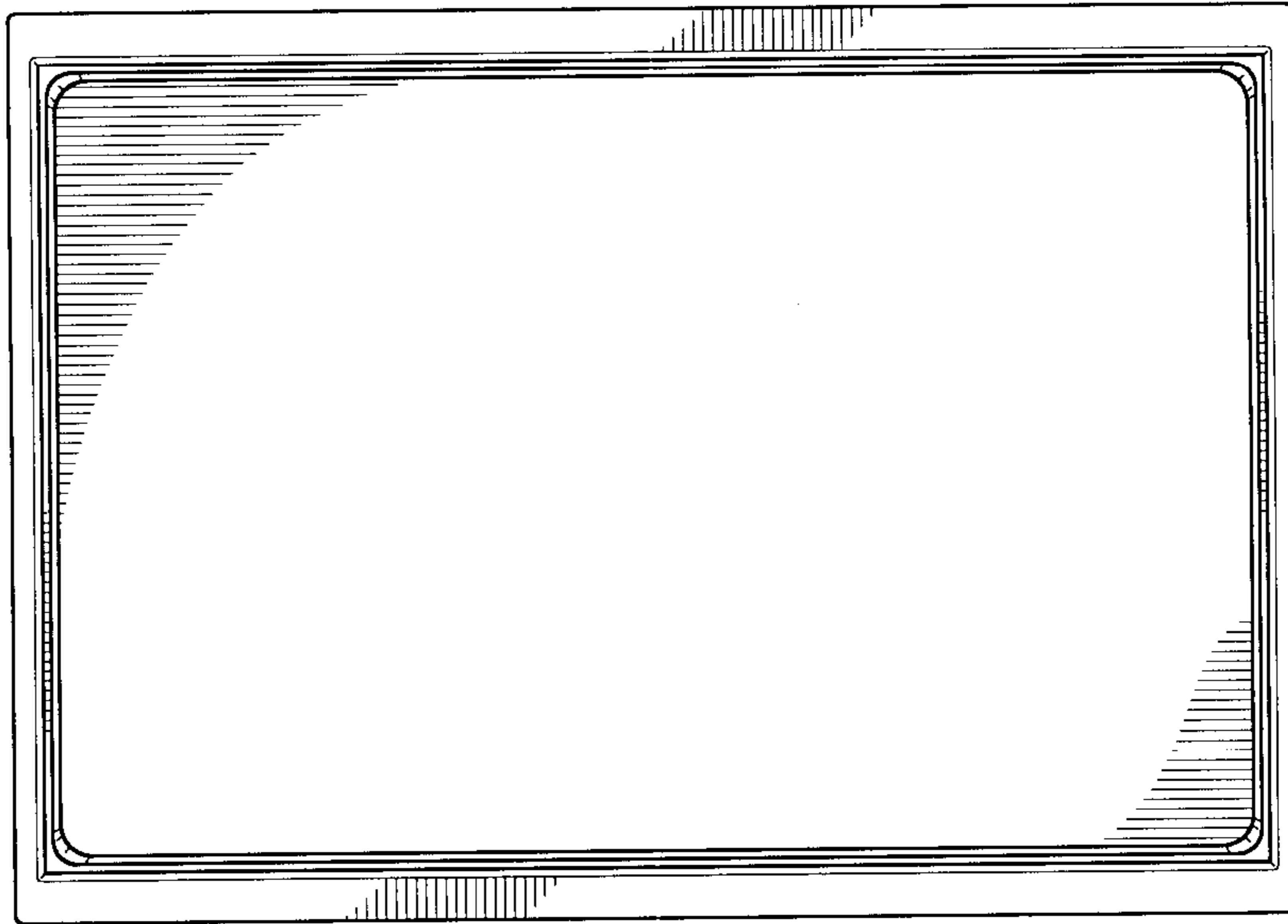

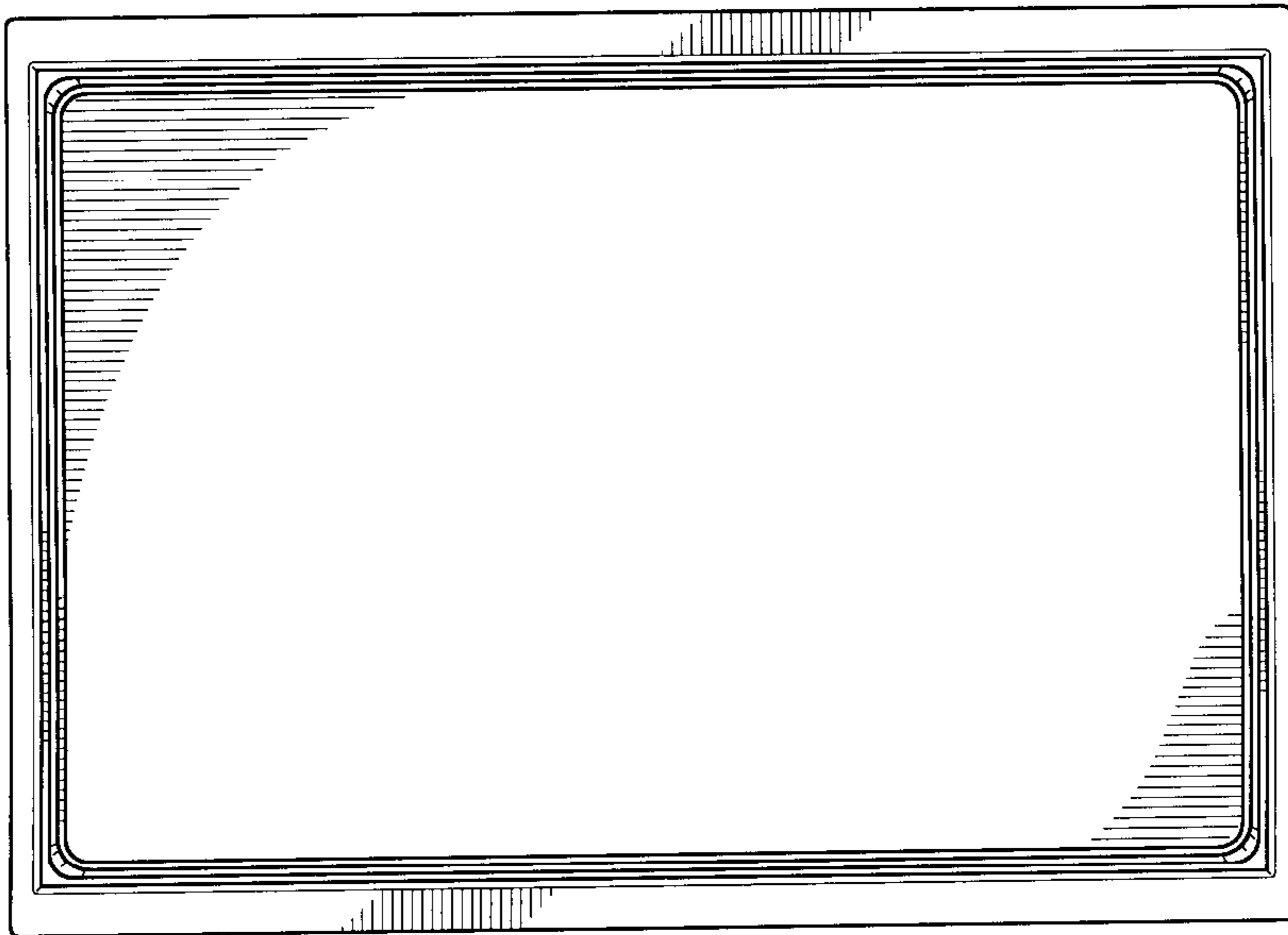
