FIG. 6 is a bottom plan view of the oscillating weight for a watch as depicted in FIG. 1; and,

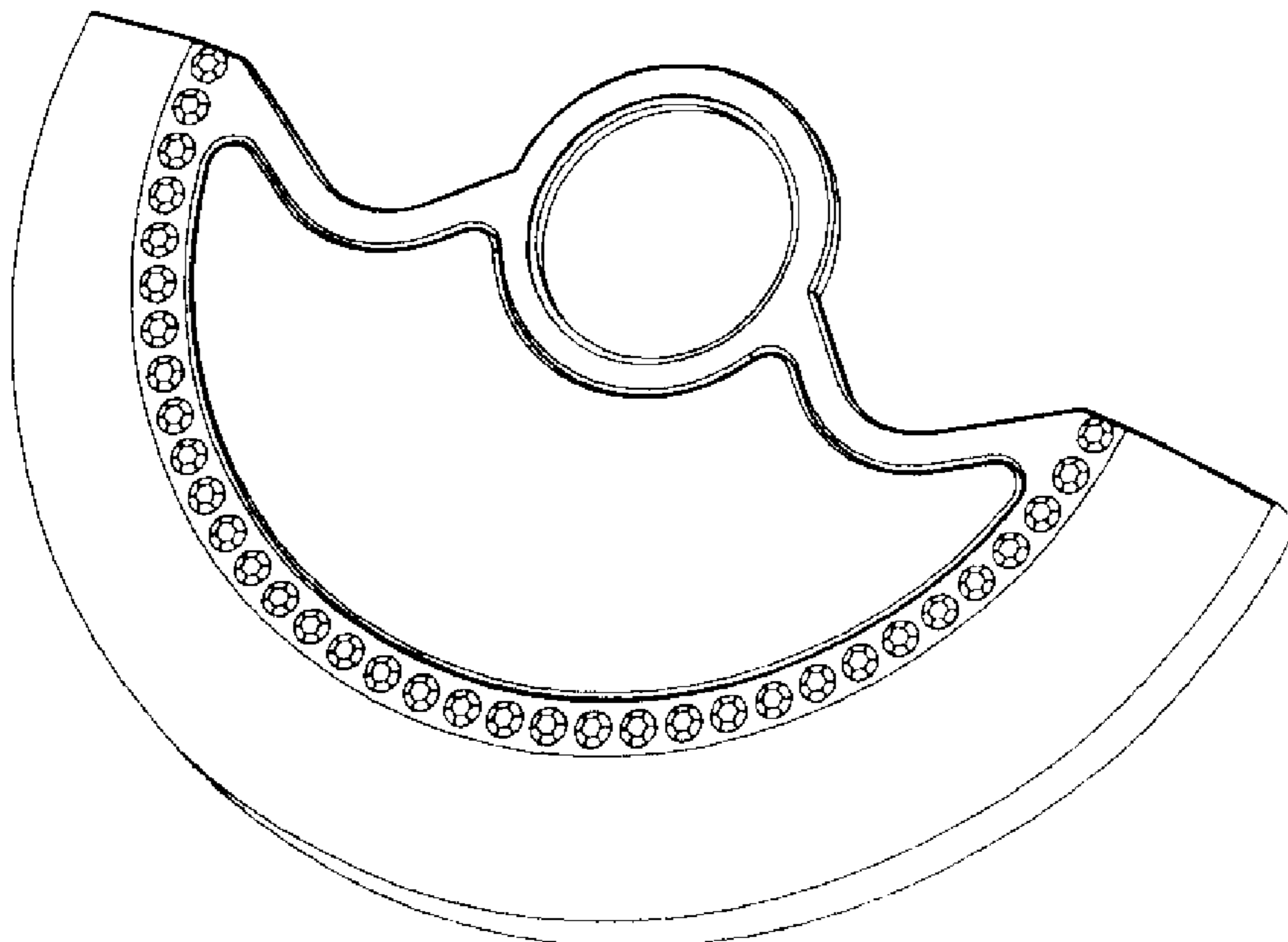
FIG. 7 is a top plan view of the oscillating weight for a watch as depicted in FIG. 1.

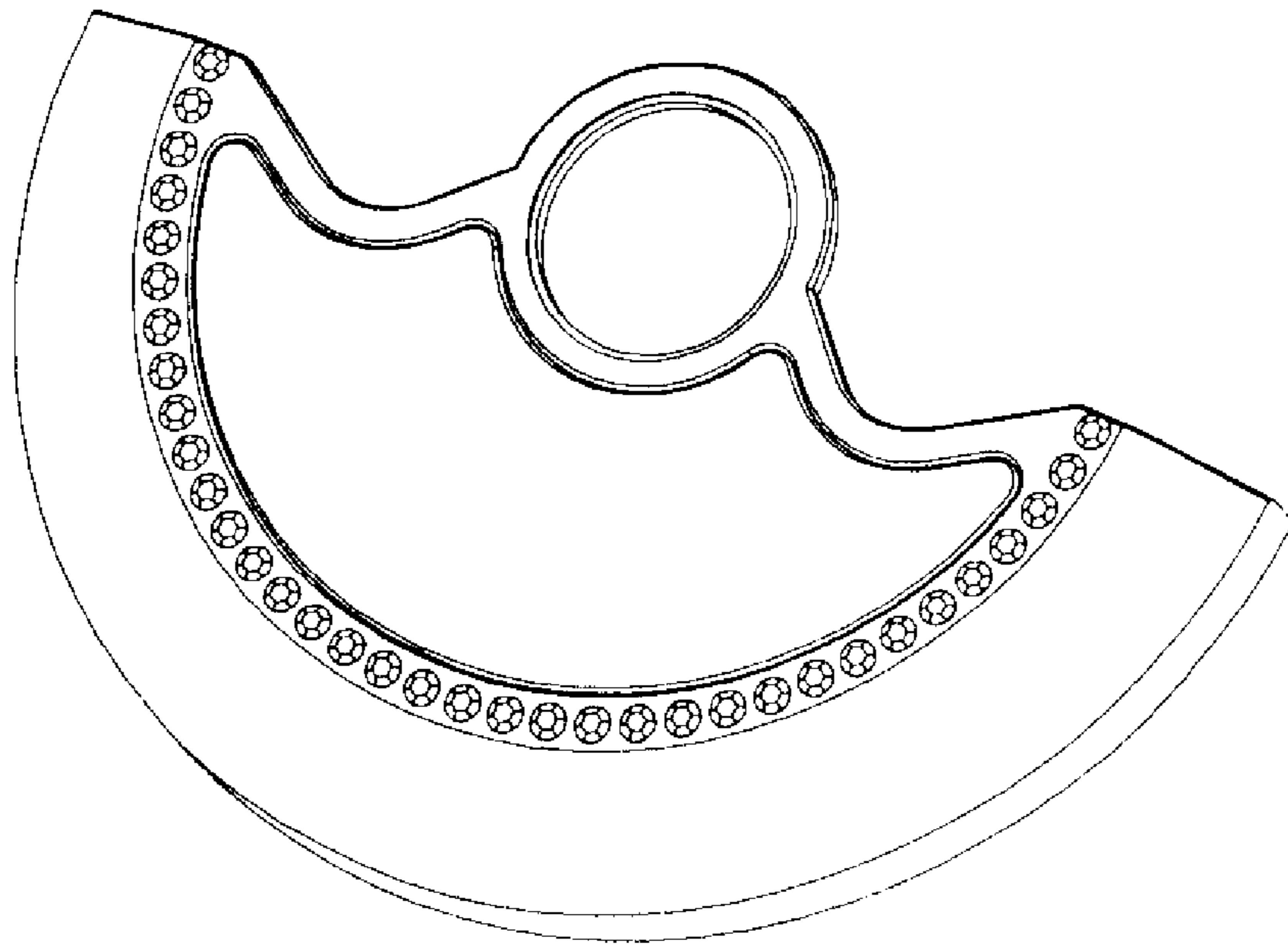

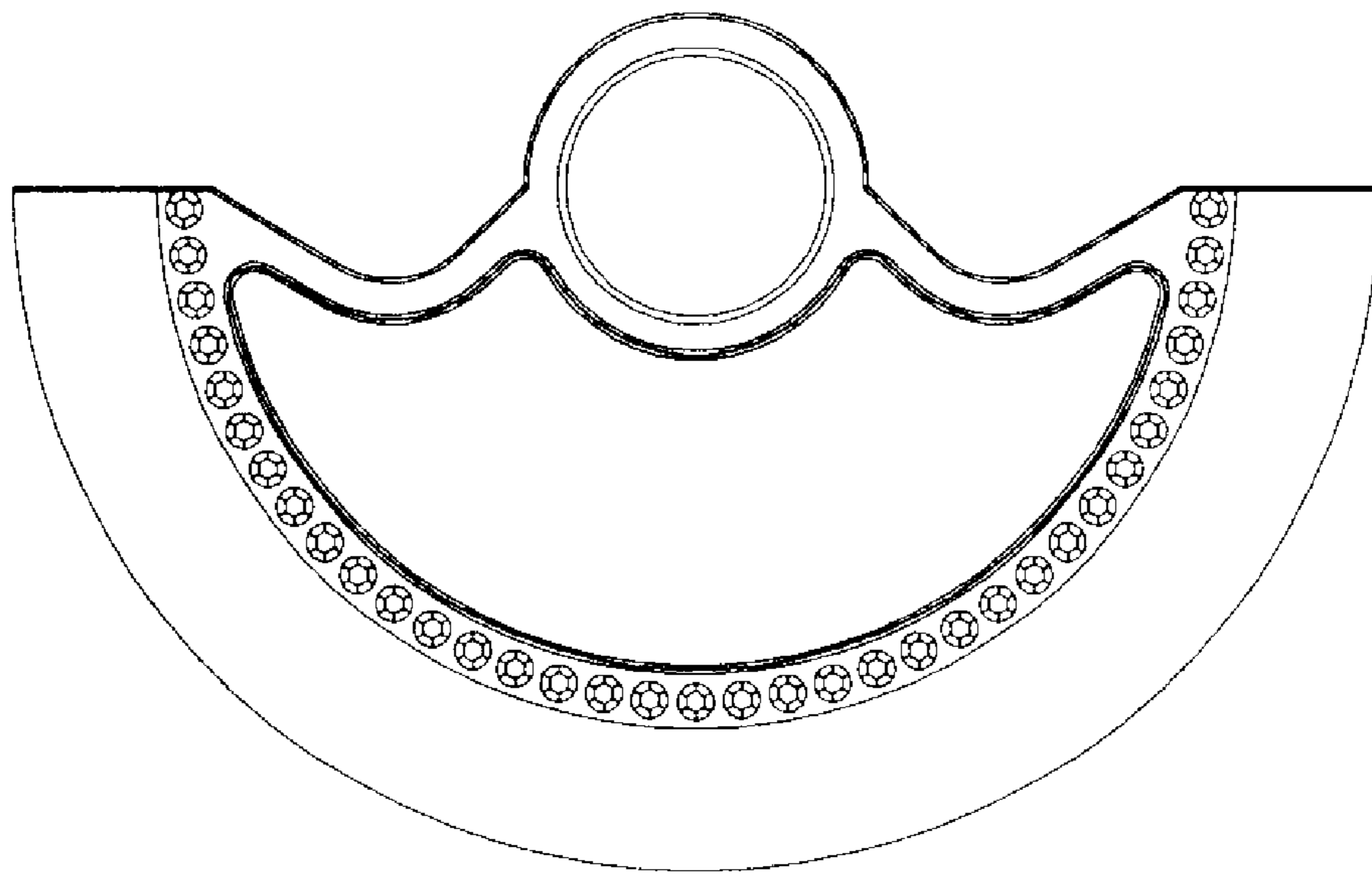

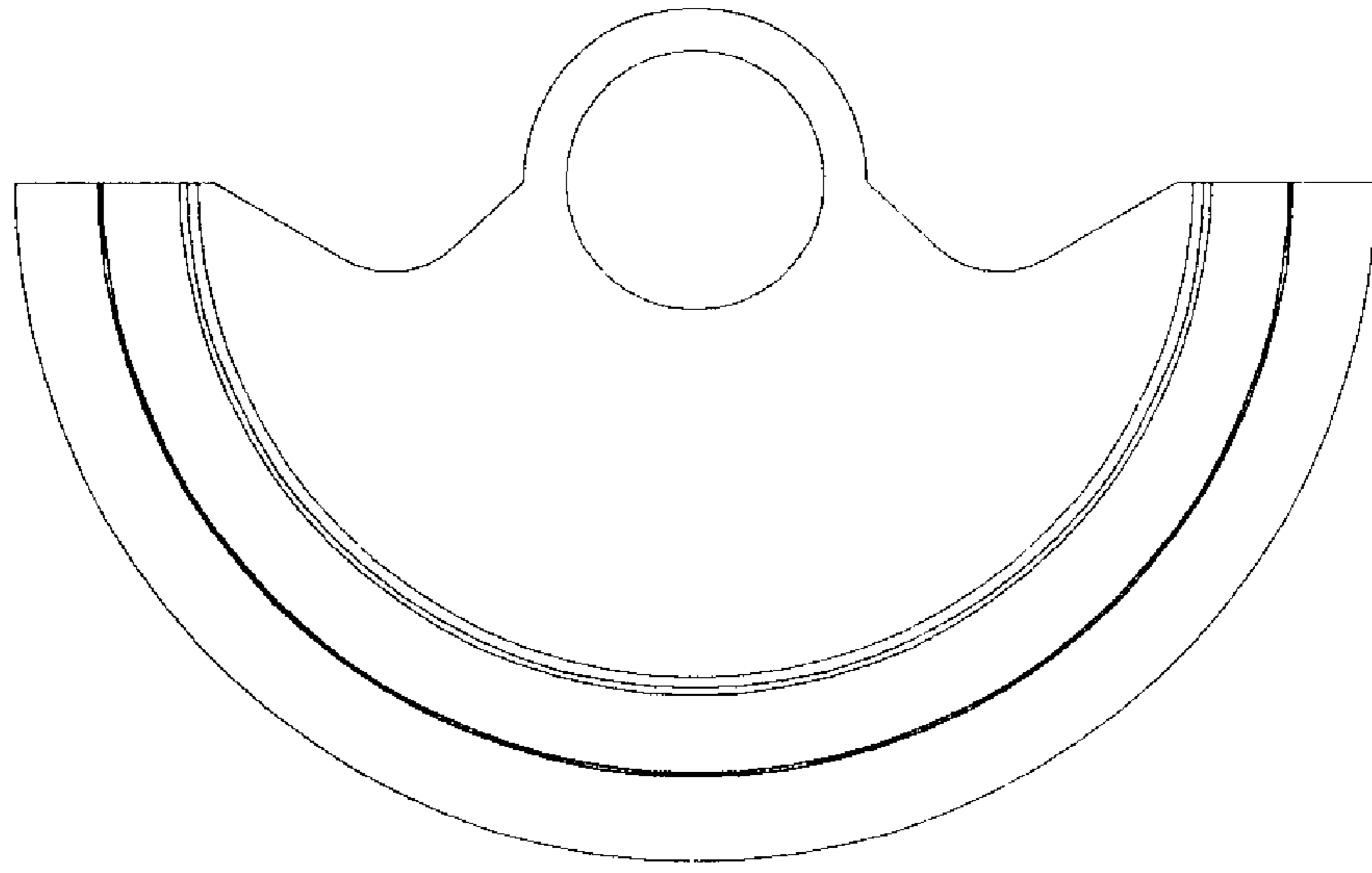

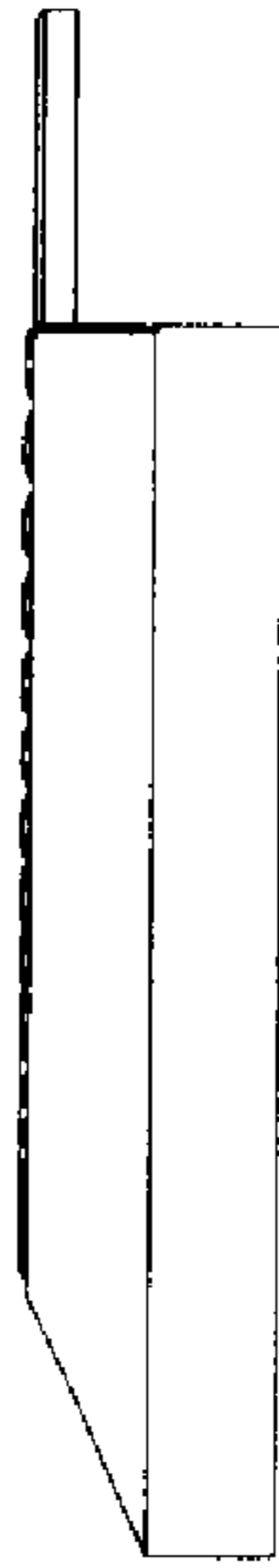

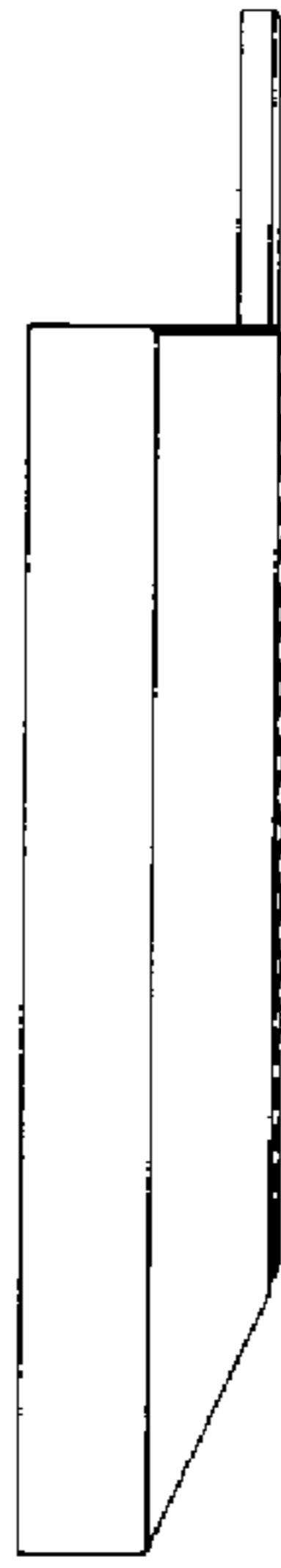

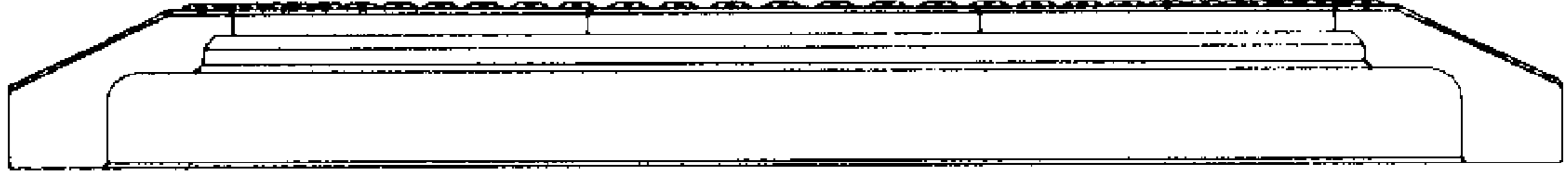

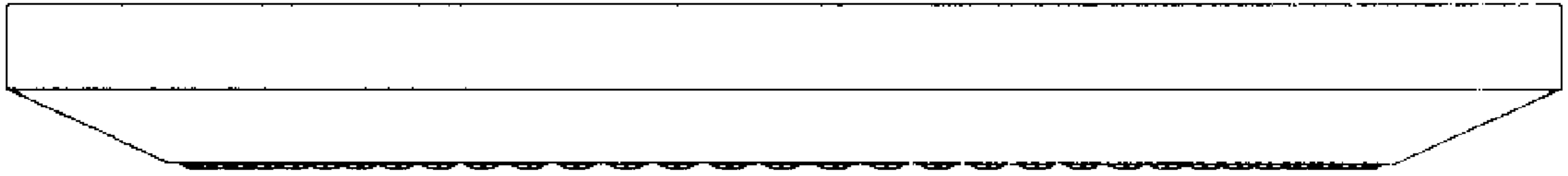
