(57)**CLAIM**

The ornamental design for an oscillating weight for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an oscillating weight for a watch in accordance with the invention, in which surfaces(s) or portion(s) of the article not shown in the drawings or described in the specification forms(s) no part of the claimed design;

FIG. 2 is a front elevational view of an oscillating weight for a watch depicted in FIG. 1;

FIG. 3 is a rear elevational view of the oscillating weight for a watch as depicted in FIG. 1;


FIG. 4 is a right side elevational view of the oscillating weight for a watch as depicted in FIG. 1;

FIG. 5 is a left side elevational view of the oscillating weight for a watch as depicted in FIG. 1;










