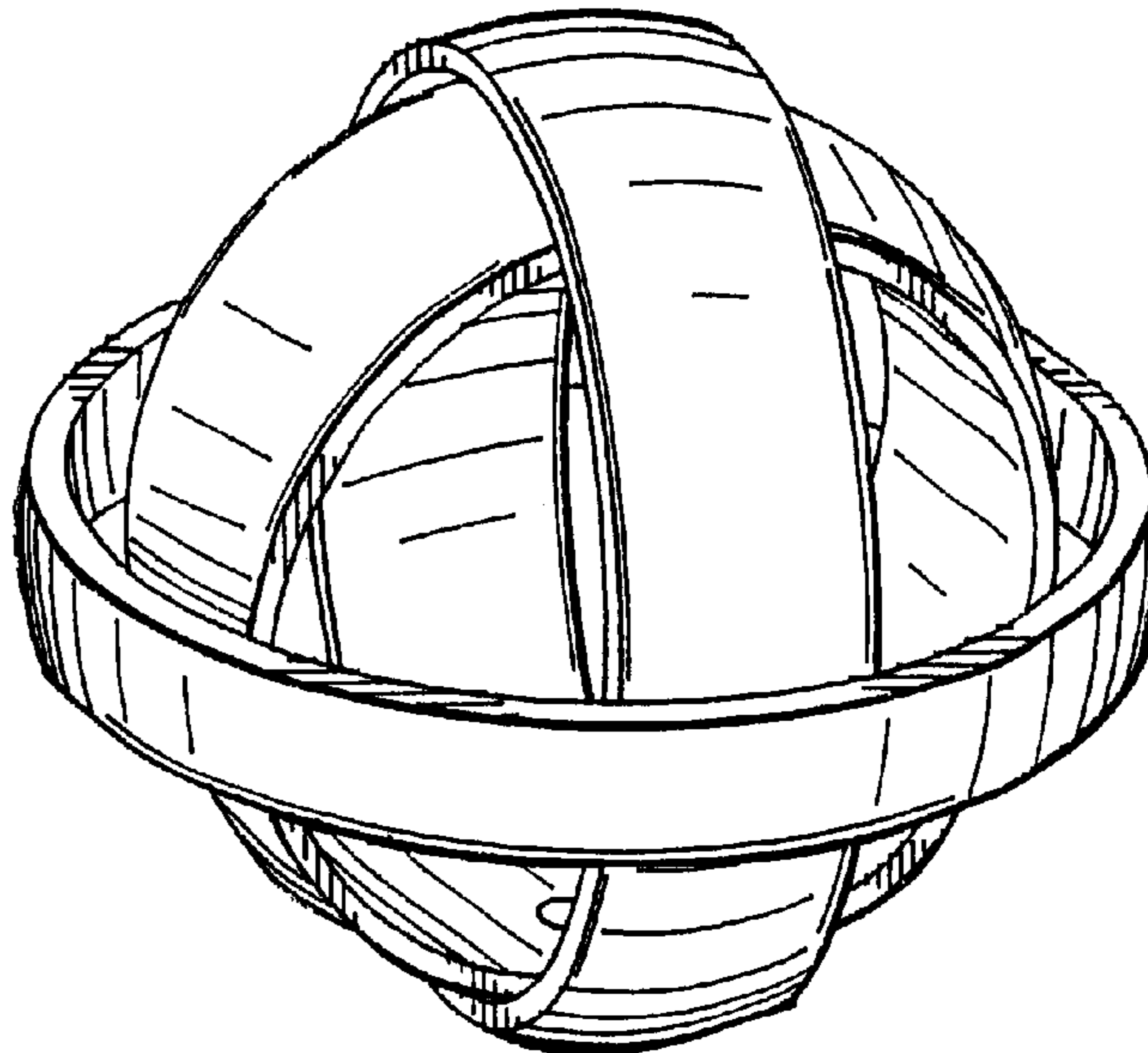
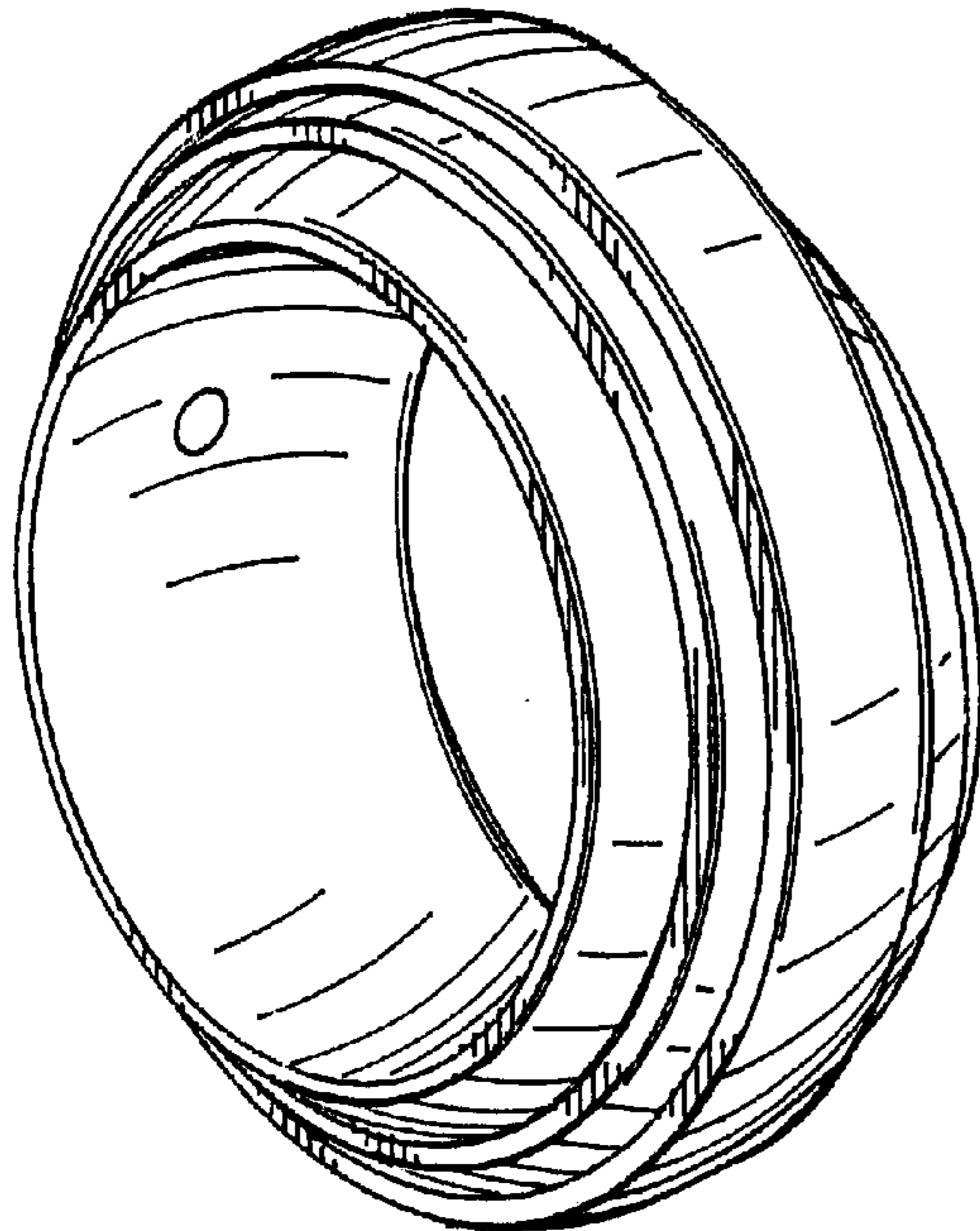
(57) **CLAIM**

The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ring in its normal wearing position, showing my new design;
FIG. 2 is a front view of the ring in its normal position;
FIG. 3 is a rear view of the ring in its normal position;
FIG. 4 is a top view of the ring in its normal position;
FIG. 5 is a left side view of the ring in its normal position;
FIG. 6 is a right side view of the ring in its normal position;
FIG. 7 is a bottom view of the ring in its normal position;
and,
FIG. 8 is a perspective view thereof showing the different parts angularly displaced by 90 degrees to each other.

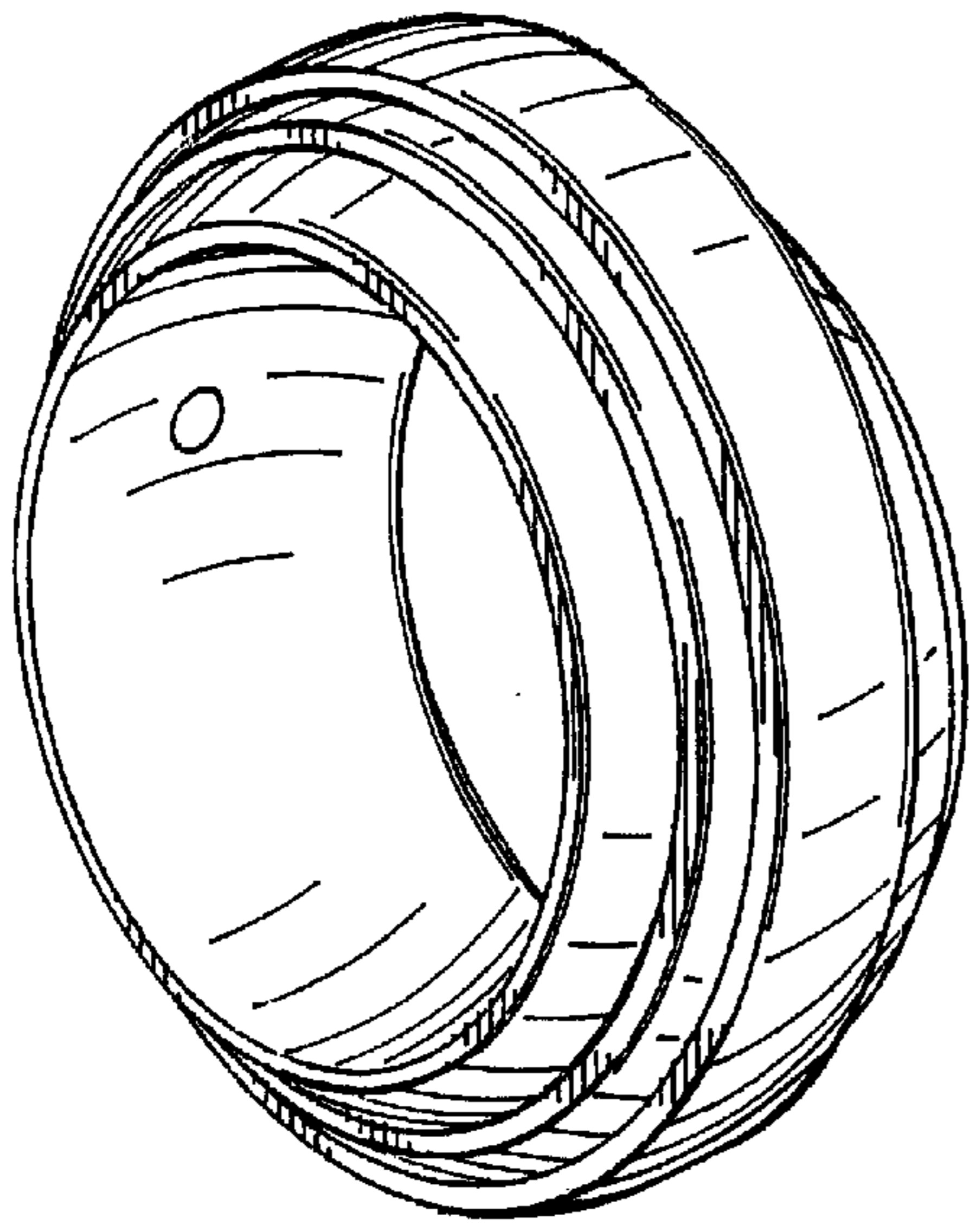

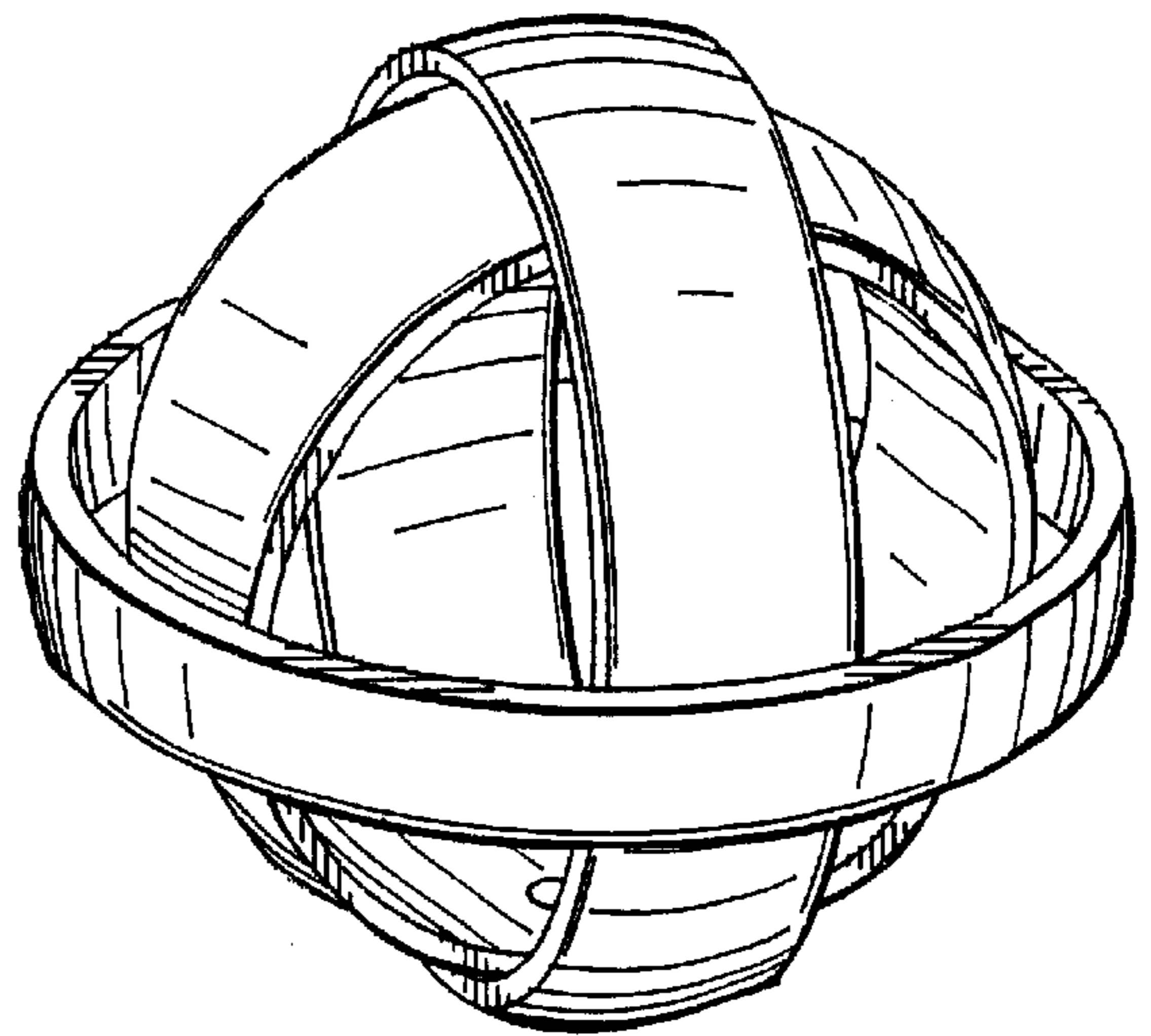

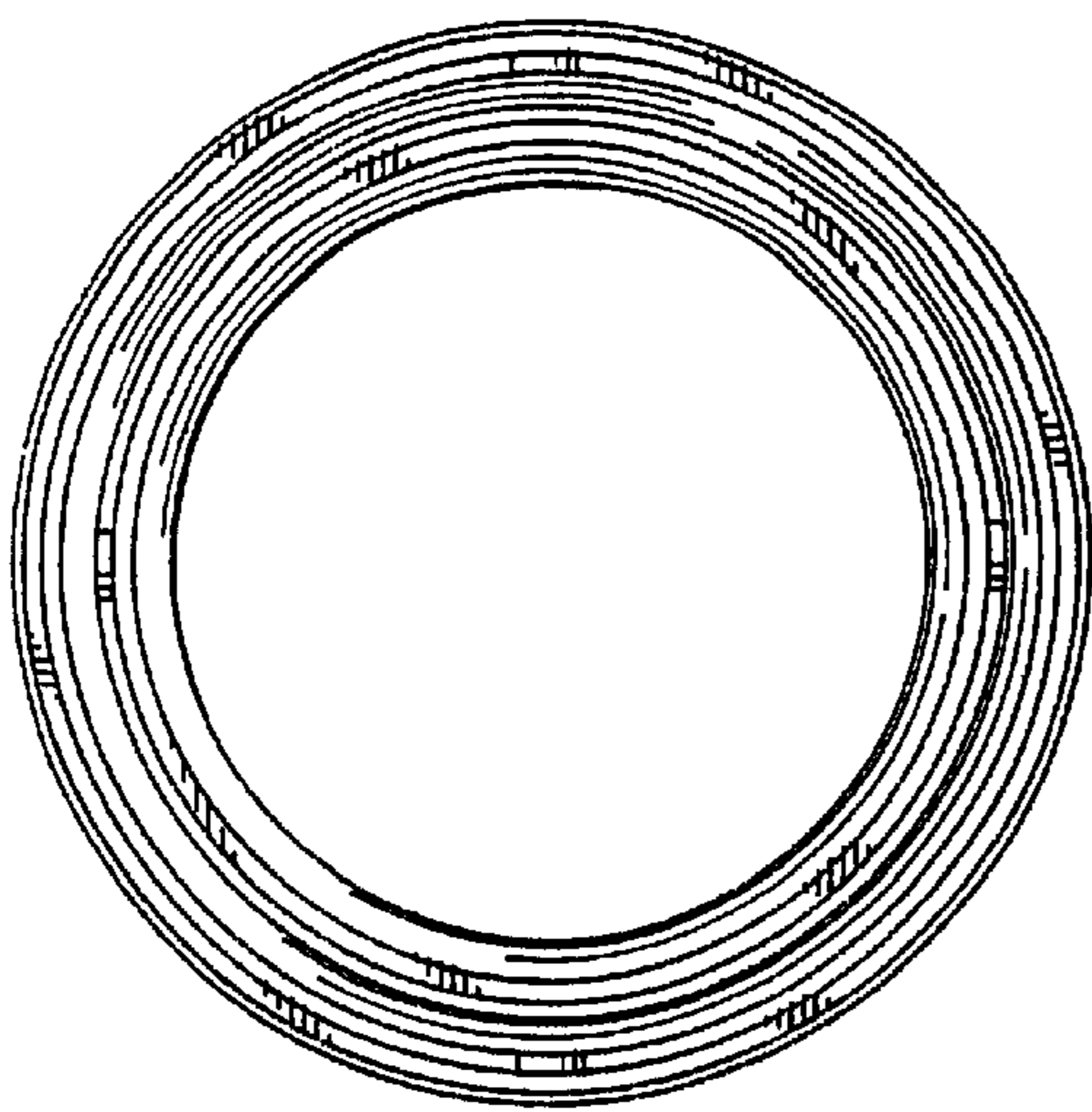

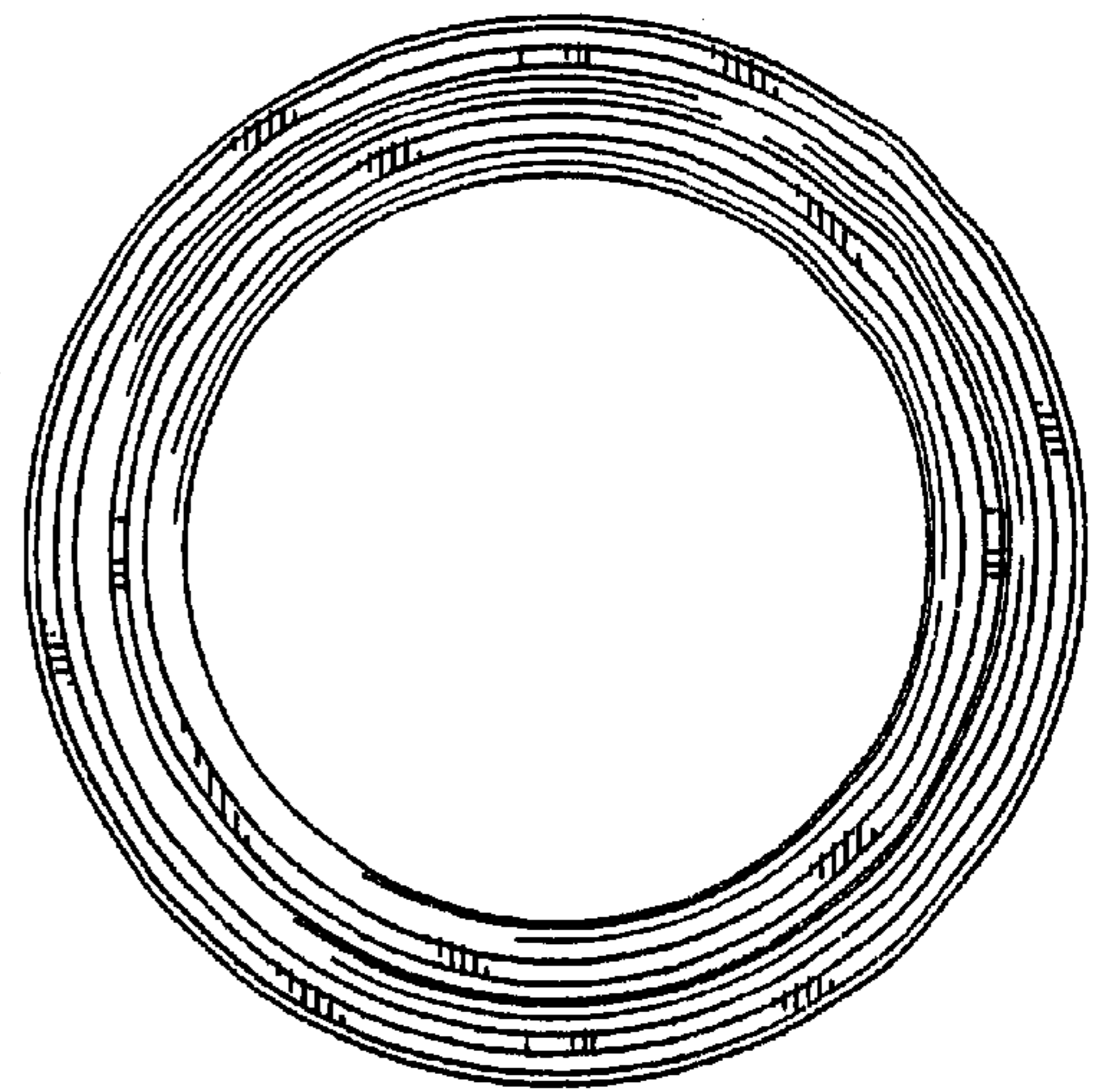

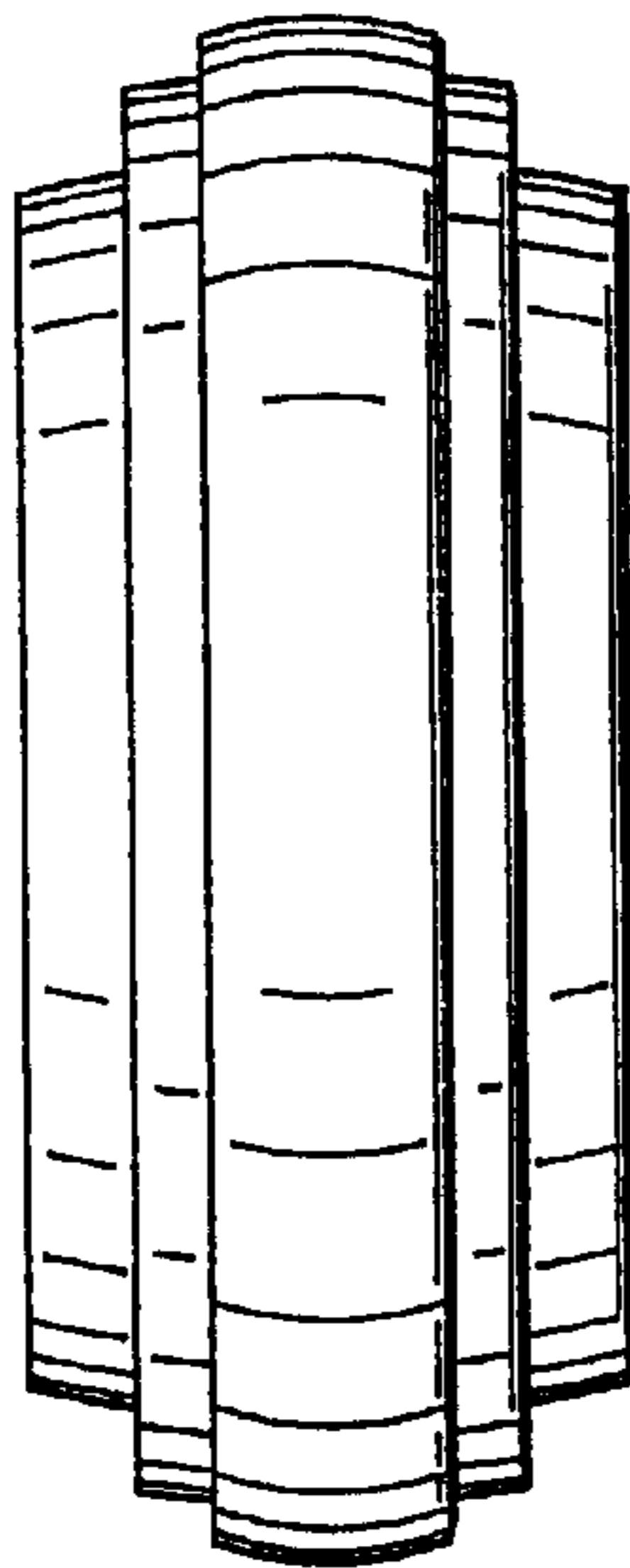
